LA City Council Votes to Move Forward with New Office of Racial Equity in Los Angeles

The Los Angeles City Council has unanimously approved an initiative calling for the creation of an in the city of Los Angeles. The Office would work to eliminate structural barriers and ensure opportunity and resources are fairly and justly distributed so all Angelenos are treated equitably, empowered, and can fully participate in the city's democratic processes. The motion was co-introduced by council president Herb Wesson, Councilmembers Mitch O'Farrell and Marqueece Harris-Dawson, and seconded by Councilmember Paul Koretz.

"When this government

was created it was not created to benefit people who looked like me," said council president Wesson. "I am proud that in one of my final acts as the first Black council president, we as a council acknowledge the city's role of structural and institutional racism and its role in righting those wrongs with an Office of Racial Eq-

uity (ORE) that looks out for all Angelenos."

The passage of this motion comes on the heels of a month-long phase of the embRACE LA initiative that has engaged community members through 150+city-wide conversations about race and racism. The initiative was developed by Wesson and O'Farrell

and led by Community Coalition, a grassroots social justice organization in South Los Angeles. This fall, dinners were held with the help of producing partners Advancement Project and Revolve Impact with the purpose of bringing together Angelenos to have conversations about racism and racial equity in the

city of Los Angeles. The information discussed in these conversations was collected with the goal of using this data to help establish the new office.

In surveys about the state of racial equity in Los Angeles, just 21.5% of participants agreed or strongly agreed that

This resulted in the company running a background check which showed the Corbin had been in prison. The com-

Democrats' impeachment charges say Trump 'betrayed' US

House Democrats announced two articles of impeachment against President Donald Trump on Tuesday, declaring he "be-





trayed the nation" with his actions toward Ukraine as they pushed toward historic proceedings that are certain to help define his presidency and shape the 2020 election.

The specific charges aimed at removing the 45th president of the U.S.: Abuse of power and obstruction of Congress.

Speaker Nancy Pelosi, flanked by the chairmen of impeachment inquiry committees at the U.S. Capitol, said they were upholding their solemn oath to defend the Constitution. Trump responded angrily on Twitter: "WITCH HUNT!"

Voting is expected in a matter of days by the Judiciary Committee, which begins deliberations Wednesday, and by Christmas in the full House. The charges, if approved, would then be

sent to the Senate, where the Republican majority would be unlikely move to convict Trump, but not without a potentially bitter trial just as voters in Iowa and other early presidential primary states begin making their choices.

In the formal articles announced Tuesday, the Democrats said Trump enlisted a foreign power in "corrupting" the U.S. election process and endangered national security by asking Ukraine to investigate his political rivals, including Democrat Joe Biden, while withholding U.S. military aid as leverage. That benefited Russia over the U.S., as America's ally

House Passes Voting Rights Measure to Restore Portions of Law Gutted in 2015

More than four years after sections of the Voting Rights Act of 1965 were taken out by the Supreme Court and following four attempts under a House led by Republicans, Rep. Terri Sewell's (R-Ala.) bill to reinstate voting protections has finally passed.

"Voting is personal to me because it was on the streets of my hometown, Selma, that foot soldiers shed their blood on the Edmund Pettus Bride so that all Americans - regardless of race – could vote," Sewell, who is African American, wrote on Twit-

"I am so proud the House voted to #RestoreTheVote," she added.

The measure, H.R. 4, passed by a 228-187 margin, with all Democrats voting in favor while Sewell and Pennsylvania Rep. Brian Fitzpatrick counted as the only Republicans to support the legislation.

Many are now calling on the Senate to take up the

Rev. Dr. William Barber, the president and senior lecturer of Repairers of the Breach and the architect of the Moral Mondays Movement in North Carolina, counts among those calling out Senate leaders.

"The U.S. House passed legislation to restore the Voting Rights Act," Barber

"If [GOP Senate Majority Leader] Mitch McCon-

nell refuses to take it up in on the Voting Rights Adthe Senate, he's confessing that he believes the GOP can't win without voter suppression."

Gerrymandering, unfair voter I.D. laws, and intimidation at the polls are among the tactics being used to prevent voters of color from casting votes, stated Marcela Howell, the founder, and president of In Our Own Voice: National Black Women's Reproductive Justice Agenda.

"Passage of the Voting Rights Advancement Act by the House is a first step toward restoring our democracy. We applaud the House of Representatives for passing the Voting Rights Advancement Act of 2019," Howell stated.

"The wholesale disenfranchisement of voters threatens our democracy. Conservative lawmakers across the country are pulling out all the stops to prevent people of color especially Black people from exercising our right to vote," she stated.

Howell continued:

"We didn't march and die fighting for our right to vote only to have that right denied us in this new Jim Crow era -fueled by the racist policies of conservative state legislators and the terrible decision in Shelby v. Holder by the Supreme Court that reinforced these oppressive laws.

"We call on Sen. Mitch McConnell to follow the leadership of House Speaker Nancy Pelosi to stop the assault on voting rights by scheduling a Senate vote vancement Act as soon as possible.

"We encourage voters across the country to unite in resistance by holding their elected representatives accountable and, most of all, by exercising their right to vote in local, state, and federal elections."

Sewell's bill initially would cover 11 states, including nine in the South, and also California and New York.

The bill would require all states to get federal approval for election changes known to disproportionately affect voters of color, like strict voter I.D. laws, tighter voter registration requirements, and polling place closures in areas with large numbers of minority

The Voting Rights Act is perhaps the most significant piece of civil rights legislation in U.S. history, Senate Minority Leader Chuck Schumer stated.

For more than 50 years, the law stood as a powerful force to prevent the type of racial discrimination in voting that marred America's history before the bill's passage, Schumer stated.

"The Supreme Court's disastrous decision in Shelby County v. Holder gutted this critical legislation and unleashed a surge of pernicious Republican-led voter suppression laws," he continued.

"The House of Representatives passed H.R. 4, the Voting Rights Advancement Act. This is a critical step towards restoring


the protections of the Voting Rights Act and beating back the scourge of voter suppression," Schumer added.

He continued:

"The right to vote is the very wellspring of our Generations democracy. have organized, protested, marched, and died to extend the franchise to all Americans. "It is incumbent upon

every member of Congress to continue to fight to increase, rather than impede, access to the ballot box and ensure that every eligible American can have their

voice heard. I urge Majority Leader Mitch McConnell to bring this legislation to the floor of the Senate. Voting rights are simply too important to be banished to Leader McConnell's legislative graveyard."

A Letter to the Community

from Phillip A. Washington, Chief Executive Officer, Metro

Dear Crenshaw and South Los Angeles Communities,

I recently attended a Sunday service at the West Angeles Church of God in Christ and had the opportunity to speak with many community residents who were happy to share their thoughts and opinions on Metro; and for that I am grateful. I also spoke to many of you at the Taste of Soul – one of my favorite events of the year. Based on those conversations, I wanted to take a moment to say thanks and to give a quick update on Metro's projects in the community — and to wish you and your families Happy Holidays.

First, I want to thank the Crenshaw Community – and all of South Los Angeles – for your patience during the construction Metro has been doing since 2014 on the Crenshaw/LAX Line. The headline news is that pretty soon you're going to have greater mobility and a lot more options for rail travel. When the Crenshaw/LAX Line opens it will connect Crenshaw and the communities of South Los Angeles to the rest of the Metro Rail system. And when Metro's new airport local businesses to house them in the station for the Crenshaw/LAX and Green Lines is completed at Aviation Boulevard and 96th St, South Los Angeles will be the gateway to LA County for travelers from across the world.

We know it feels like the construction has been going on a long time, and it has, but the Crenshaw/LAX Line is a big, bold and ambitious project with eight new rail stations, including three that are underground. We expect substantial completion to occur in 2020, and we're working with the contractor to deliver a safe, highquality and world-class project. We're pleased that early train testing on the southern part of the route has begun and that's a big step forward. In addition to greater mobility, the Crenshaw/LAX Line will also provide significant economic and employment opportunities for the community.

I'm pleased that Metro met and exceeded its hiring goals while constructing the project. 60 percent of the total hours worked on the project, for example, were by economically disadvantaged hires — our goal was 40%. We also exceeded Metro's goal of hiring 28% minorities; we actually hired 76%. Many of these hires were also people who lived near the project. Even before going into service, the Crenshaw/LAX Line has begun to confer benefits on local communities it will serve.

Another example is the Expo/Crenshaw joint development project. The development will be required to comply with the county's Local Hire Policy. That means at least 30% of total construction labor hours worked on the project must be performed by a qualified local resident (defined as someone living within five miles of

the site). In fact, the developer has publicly stated they are striving to exceed 30%, and within a three-mile radius. This project was initially slated to have 15% affordable housing units, but in response to community input, that number was increased to 20%. We are still in the exclusive negotiating period with the developer and we'll keep working to create the best project possible. The developer is also actively working with several project's commercial space.

In July, the Metro Board of Directors approved spending up to \$15 million to help create three parks near Crenshaw/LAX Line stations as part of Destination Crenshaw. This innovative project will create 1.3 miles of art along Crenshaw Boulevard that celebrates the culture, history and sense of place of the Crenshaw and African American communities. I'm very pleased to see Metro investing in the kind of infrastructure that will improve the quality of life in communities and enhance our rail line.

One more exciting development is about to get underway at the corner of Vermont and Manchester in South Los Angeles. Metro is partnering with LA County to build a state-of-the-art college preparatory academy and boarding school. The SEED School of Los Angeles County will provide students in grades 9 through 12 with a curriculum that will prepare them for careers in the global infrastructure industry.

The SEED School will be open to all youth in LA County, with a special focus and emphasis on opportunity youth - those who have had experience with local safety nets including the juvenile justice, foster care and child welfare systems. We have already secured funding for the school, acquired the land, hired a consultant and we will break ground next year.

The SEED School will be part of a larger mixed-use development project. The plans include 60,000 square feet of retail space with a grocery store, 180 units of affordable housing, and the Vermont/Manchester Training

Center to develop and train the infrastructure workforce of the future. We think the SEED School and the training center will be a game changer for preparing South Los Angeles youth and adults for careers in construction and infrastructure.

As I reflect on the past year, I am amazed by how much we've accomplished, but I know we have so much more to do – especially in the Crenshaw Corridor and South LA. We are in the home stretch of construction, and I can see the light at the end of the tunnel – literally. So again, thank you for your patience.

On behalf of Metro's 11,000 employees, I wish you and your family the joy of the holiday season.

CDU and APLA Health Host Rare 'Indoor Ground Breaking' on New Health Facility

Expanding Primary, Dental and HIV Care Services in South L.A.

Charles R. Drew University of Medicine and Science (CDU) and APLA Health (APLA) officially announced plans to move forward on a new building located on the CDU campus that would house a new CDU Wellness Center and an APLA clinic during a symbolic "indoor ground breaking" ceremony on Wednesday, December 4, 2019. Plans for the upcoming 10,000 square-foot facility were formalized with a signed agreement between the two organizations in February 2019.

Upon its completion in 2020, the University's Wellness Center will provide urgent care, mental health counseling and wellness programs to CDU students, faculty and staff, while the

APLA clinic will provide primary medical care, dental care and behavioral health services to Service Planning Area (SPA) 6 residents through a Federally Quali-Health Center ("FQHC") model.

CDU currently operates two HIV testing programs in the Drew Center for AIDS Research, Education, and Services (Drew C.A.R.E.S.) and the CDU/OASIS Clinic, the latter of which has been in existence for over 30

years. Throughout the last decade, CDU and APLA Health have developed a longstanding partnership through these programs, collaborating to ensure that HIV patients in SPA 6 and throughout South Los Angeles have access to quality dental care and food assistance. APLA Health's enhanced capacity within the upcoming clinic will create a more robust HIV prevention continuum for at-risk individuals in SPA 6, which still maintains the second highest percentage of HIV/AIDS cases in L.A. County.

"Our goal with this new health center is to reduce the number of new HIV infections in the Willowbrook, Watts and Compton communities by providing culturally competent, convenient and assessable sexual health services, along with general medical, dental and behavioral health services," said Craig E. Thompson, CEO of APLA Health. "We know that the fight to end the epidemic is about tailored local approaches to reducing the number of new infections and particularly addressing the continuing disparities and the issues that create those disparities."

"Drew C.A.R.E.S. is very excited at the prospect of sharing this building with APLA, and we look forward to working together with them to continue to provide much-needed HIV/AIDS care, education and research to this under-resourced community," said C.A.R.E.S. faculty leader Nina Harawa, PhD, MPH.

"The partnership between APLA and CDU will bring another building to our campus, and add much-needed healthcare capacity to our communisaid ty," CDU president/CEO David M. Carlisle, PhD, MD. "We are proud to stand with APLA Health in work that so clearly fits in with the mission of CDU, and that is so vital to the LA County HIV Strategic Plan, the statewide 'End the Epidemics' effort, and the National HIV/AIDS Strategy."



Inglewood Unified Receives First \$10M Installment of \$30M in School Improvement Funds from LAWA

Inglewood Unified on Nov. 14 received the first \$10 million installment from the Los Angeles World Airports (LAWA) to mitigate the impact of airplane noise on students, part of a million program launched in 2015 to improve schools along Los Angeles International Airport flight

In October, the Board of Commissioners approved a total of \$30 million to sound insulate three schools by early 2021. The money will reimburse the District for improvements underway at Woodworth-Monroe TK-8 Magnet Academy and Oak Street Elementary School in addition to upcoming projects at Morningside High School.

"This infusion of funding is a welcome addition to Inglewood Unified's multifaceted program of school

improvement," county administrator, Dr. Erika Torres said. "Inglewood Unified is investing deeply in creating high quality learning environments that will ensure our students have the tools they need to succeed. These improvements will go a long way toward achieving these goals."

Projects include replacing heating, ventilation and air condition (HVAC) systems, installing exterior windows, replacing exterior doors, upgrading ceilings with sound-reducing insulation as well as related plumbing and electrical upgrades. The work is expected to achieve interior noise levels at or below 45 decibels - the volume of a quiet conversation - boost natural light in classrooms and cut energy costs.

"Los Angeles World Airports believes our partnership with Inglewood Unified will help to ensure a positive learning environment for students and teachers, which benefits the entire community," LAWA chief environmental and sustainability officer, Samantha Bricker said. "Our soundproofing programs for residents and schools in Inglewood demonstrate LAWA's commitment to be a good neighbor and partner with adjacent communities.

Inglewood Unified's first project was at Beulah Payne Elementary School, where improvements were made to seven classrooms and a multipurpose room. LAWA and the District celebrated completion of the \$2.8 million project in

The Woodworth-Monroe project, which is set to be completed in the next few months, allots \$17.7 million for 63 classrooms, a library and a multi-purpose room. Oak Street School, which is expected to be completed in

December 2020, includes 21 classrooms and a library. Improvements are expected to cost \$4.8 million. Morningside High targets 62 classrooms, a library and an auditorium. Improvements are expected to cost \$17.4 million and be completed in early 2021.

The District is developing a timeline for a Child Development Center proiect that will span eight classrooms and cost about \$1.5 million. This project will be considered in the future based on funding availability.

Some of the projects coincide with improvements funded through Measure GG, a 2012 bond measure that generated \$90 million for Inglewood Unified facility repairs and upgrades. These include a new modular classroom building at Woodworth-Monroe, new playgrounds and planned renovation of an aging science building at Morningside High.

"Our vision for Inglewood Unified is one of steady and significant improvement – not only in our facilities, but in all our efforts to assist our students in achieving success here, in higher education and in their careers," Torres said. "These facilities improvements are an important element in achieving that

And we gather too to reaffirm our rootedness in our own culture, to reinforce the bonds between us as African people and to meditate on the expansive meaning and awesome responsibility of being African in the

world. As Kwanzaa draws to an end and the old year meets and merges with the new, we are, as always, obligated and urged by ancient custom and ongoing current concerns to sit down and seriously engage in righteous reflection on being African in the world. To speak of righteous reflection is, in an Ebonics sense of the word righteous, to talk of thought that is real, ethical and excellent. That is to say, thought that is free from the artificial, false and formulaic and comes from the heart as well as from the head. What is aimed at here is thought which is informed by an

ethical sensitivity to the subject under consideration. And this holds true whether in our concern for each other or for the health and wholeness of the world; for the loss of human life or the mutilation of historical memory; and for the deprivation of material needs or the denial of dignity and rights due everyone.

This process and practice of righteous reflection culminates on January 1, Siku ya Taamuli, the Day of Meditation. Here we are to focus even more so and think deeply and continuously about our lives and the world, about critical issues that confront us and the world and our responsibility to understand and engage them. Indeed, we are to measure ourselves in the mirror of the best of our history and culture and ask ourselves where we stand as a representative and embodiment of the best of what it means to be African and human in the fullest sense.

This cultural measurement and mirroring is achieved thru asking and answering three fundamental questions. Building on the insights of Frantz Fanon, these Kawaida rooted questions are: who am I; am I really who I am and am I all I ought to be? Now to ask who we are is both a personal and communal question which cannot be righteously separated. For we are anchored and embedded in a definite community and culture and reflect the strengths or weaknesses of that community and culture even unintentionally.

To answer the question of "who am I?," we must embrace an expansive conception of our



identity, rejecting racist conceptions that problematize, indict and distort our sense of Blackness or Africanness or diminish or limit its root understanding as an expression of excellence on every level. This means embracing a conception of African that defines our identity way beyond the given names and assigned numbers on our birth certificates, licenses or social security, insurance or other identity cards. It means understanding the personal in the context of the communal and the cultural, for inherent in the history and culture of our community is the source and answer of who we are and must be-

come and be. However else we see ourselves, our conception of who we are must include at least three foundational identities

forged in the crucible of critical periods of history and struggle. These identities are: fathers and mothers of humanity and human civilization; sons and daughters of the Holocaust of enslavement; and authors and heirs of the Reaffirmation of the 60's, i.e., Reaffirmation of our Africanness and social justice tradition. And these leave us clear lessons and legacies which pose social struggle; moral grounding; human dignity, durability and adaptive vitality; and a profound commitment to excellence and achievement as indispensable to defining the best of what it means to be African and human in

the world. Now, to ask "am I all I ought to be?" is to recognize the many ways our identity and the excellence it demands are eroded, undermined and otherwise damaged in the fire and furnace of oppression. Indeed, it is Fanon, again, who reminds us that in the belly of the beast of oppression, those less able to withstand the acidic toll it takes on the human person, often go thru four stages of psychological disintegration. Thus, they: doubt themselves; deny themselves, i.e., their identity; condemn themselves and then mutilate themselves both psychologically and physically. Fanon notes that in such a context of severe and savage oppression, they "wear the mask," desperately seeking relief from the racist reality surrounding us. And he rightly argues there is no relief or remedy except in struggle on a personal and collective level to defend one's humanity and free oneself from oppression and from the pathology it represents in the oppressor and reproduces in the

oppressed.

It is knowing who we are in the most expansive sense and reaffirming it in thought and practice that we can answer the question and honor the ethical imperative of being all we ought to be. Indeed, to be all we ought to be is to join in struggle to create a context of freedom, justice, well-being and peace in the world which aids us in realizing the fullness of our humanity and flourishing as persons and a people. To ask and answer the question "am I all I ought to be?" then, speaks to the interrelatedness of our identity as both African and human and the awesome responsibility this places on us

to repair and radically

reorder the world.

It is clear from the teachings of our ancestors and our long experience in history that how we conceive and conduct our personal lives shapes and even determines the well-being of our families and people, society and eventually the world. Our responsibility, then, is in expanding concentric circles from family to the whole of humanity and the world. It is in this understanding that the Odu Ifa teaches that "doing good worldwide is the best expression of character." And the Husia instructs us that we are morally obligated to seek and speak truth in high and low places; to demand and do justice everywhere; to protect and provide for the poor and vulnerable in every place; to do and spread goodness throughout the land; and to constantly repair and renew the world, making it more beautiful and beneficial

than we inherited it.

'Harriet' My Choice for Movie of the Year

There are lots of notable things about the city of Compton. It has a rapidly improving school system. It's a stable, multi-racial community with a long history of African American empowerment and a growing Latinx population. Above all, Compton is a city where neighbors take care of each other. That's the spirit behind a newly launched public health campaign, Compton Healthy, that aims to improve the health of the 100,000 people who call Compton home -because despite the community values which make Compton so strong, there are troubling health trends that must be addressed.

Currently, St. John's Well Child and Family Center operates four health centers in Compton, with another set to open early

community health center network serving the city of Compton, and the longest serving health provider here, St. John's has a particular connection to Compton -- and a particular investment in improving the health of its residents.

next year. As the largest

Compton Unified runs 35 schools serving approximately 23,000 students, and has seen dramatic improvement in education attainment and access in recent years. Although we are proud of the continuous improvement we are experiencing in education, equally important is the health of our community. That's why St. John's Well Child and Family Center and Compton Unified are working to create synergy through Compton Healthy, providing critical health services that will enable our community to thrive.

Together, we are working to continue improving access to health care and disease indicators through a

full-scale public health campaign that will substantially move the needle on health for Compton families. As we know, access to a doctor is only one part of what a person needs to get healthy.

Right now, life expectancy in Compton is five years below the L.A. County average. There's a lack of recreational and park space which keeps kids and adults alike from living healthy, active lives. Lung cancer deaths in Compton are 70% higher than L.A. County as a whole. Finally, Compton has higher rates of sexually transmitted infections, a higher rate of uninsured residents, and the highest asthma rates of any city in the County.

Compton Healthy aims to combat these health

issues through a number of new programs like hearing and vision checks at local preschools; education, testing and treatment for all high schoolers and college students about reproductive health; mobile clinic days at all Compton schools for students to get screenings and physicals; rotating Compton school students high through our school based health center at Dominguez High School; diabetes classes, education and sustained treatment; and more. We also hosted the 8th annual Compton Walk for a Cure, attended by thousands of people to uplift cancer survivors, provide free breast exams, and raise awareness around reducing the risk of breast cancer.

Overall, the campaign will be a way to show that

public health can be improved by community health centers partnering with other local institutions around a common commitment to population health, building deeper relationships with residents along the way.

At the end of the day, we all believe that every single person has the right to affordable, accessible health care -- and that access to health care is a necessary catalyst for justice and dignity. That's why we're excited to work with Comptonians to build a city we can all be proud of.

Arts and Cultural Workforce in L.A. County Lacks Diversity

The staff and volunteers serving arts and cultural organizations in Los Angeles County are less diverse than the general population, according to one of three related studies released today.

The Los Angeles County Department of Arts and Culture highlighted the results of three reports related to diversity, equity and inclusion in the arts:

• 2019 LA County Arts and Culture Workforce Demographics Study;

• From Words to Action: Implementation of the Organizational Grant Program's New Diversity, Equity, and Inclusion Requirement; and

• What People Talk about When They Talk

About the Arts.

The demographics

study, conducted by Southern Methodist University's National Center for Arts Research, found that the county's cultural workforce is 59% non-Hispanic white, though workers under the age of 34 tend to be more racially and ethnically diverse.

Researchers found that women comprise 63% of the arts and culture workforce.

The DEI study found that grant applicants to the county department define diversity in various ways. Some focus on the diverse makeup of their boards, staff, or artist communities, while others focus on diversity in the communities they serve.

The department's Research and Evaluation Division offered recommendations in that report for how arts organizations can strengthen their commit-

ment to DEI.

A primary focus of the new department is to ensure that every county resident has access to the arts. The final report relies on interviews with deeply committed supporters of the arts from across the county to identify themes that speak to why people participate in the arts.

The report found that people who are highly engaged with the arts do not always call or think about those experiences as "art experiences." People value art they can experience together in shared public spaces and see the benefits as material and tangible, as well as emotional and spiritual.

the city is an equitable and inclusive place to live for people of all races and ethnicities. 85% said that they supported establishing an ORE.

"This focus on fairness and equity will matter to all demographic groups that have been historically discriminated against, including Native Americans and members of our transgender community, who have also faced incredible impediments to equal opportunity and fairness in all aspects of mainstream society," said Councilmember O'Farrell. "Today, the work that Herb Wesson and I started years ago takes an important step, and the city will staff an office to keep us focused on making sure that we incorporate equity and opportunity into our overall approach as policymakers."

The ORE would formalize the city's commitment to addressing systemic racial disparities. The office would have a number of duties, including working to repair harms from previous policies that created, upheld or exacerbated racial disparities, and correcting disparate outcomes seen in areas such as education, employment, wealth, housing and health. The ORE would analyze city policy and programs for the potential effects on various communities and consult with city departments to establish plans to address racial disparities within individual departments throughout the city.

"Creating the Office of Racial Equity is a critical step towards acknowledging and remediating the ef-

fects of racial bias in Los Angeles city policies," said Councilmember Marqueece Harris-Dawson. "Disparities across housing, education, wealth, employment, and health are not accidental. They are the result of historic and systemic factors including biased and discriminatory government decisions, policies, and practices targeting racial and socioeconomic minorities. I'm proud to introduce this motion and stand with my colleagues committed to creating a more equitable city and hope the Office of Racial Equity will inspire similar endeavors from other legislators."

"Today marks a re-

newed commitment by the City of Los Angeles to proactively advance racial justice," said Alberto Retana, president & CEO of Community Coalition. "This vote is the culmination of citizens coming together throughout the city to talk with one another, share their experiences and look for viable ways to address inequity."

The motion passed with a 14-0 vote. The next step will be for the Chief Legislative Analyst and the City Administrative Officer to develop a study on the steps necessary to create the Office of Racial Equity, consulting with community partners and with the embRACE LA initiative. The report will also include an analysis of the staffing and budget required from the 2020-21 Fiscal Year Budget.

pany let him go.

Often, there are setbacks for formerly incarcerated men and women when they are trying to find work. Because of this, many people go back to their old lifestyle and end up back in prison. It is a vicious cycle. Fortunately for Corbin, he was able to find another job doing what he loves, cooking. He got a job at Locol Watts where he was again, soon promoted. Within six months he was the research and development chef of the restaurant and the director of opera-

The owners of Locol, Daniel Patterson and Roy

Choi, were very impressed with Corbin and gave him opportunities to work at their fine dining restaurants to get hands on experience on culinary development. This led to them partnering with Corbin to open Alta Adams where Corbin is currently the executive chef. In the creation of Alta Adams, Corbin wanted to make sure to give people the same opportunities that he received. He gives professional jobs and opportunity for growth to formerly incarcerated men and women.

"At ALTA we hire differently than the rest of the culinary industry. We

provide opportunity for underserved communities and the people that come from these communities. I've been to prison, our

CDC Chef has been to Federal prison and our General manager has been to prison," said Corbin. "Alta is one of the hottest new

restaurants in L.A. and is being run and operated by formally incarcerated inmates that have reformed. At any other restaurants we probably wouldn't have gotten a job any further than dishwasher. Our vibe at Alta is different."

The vibe at Alta is doing something right as Corbin was offered a chance to open his own restaurant from two diners.

"Two gentlemen came into ALTA for dinner enjoyed the food, service and ambience so much that they asked to speak with the chef," said Corbin. "When I came to their table, I was handed a business card and was asked to

reach out to them which I did. Sometime later, these two gentlemen gave me an offer that I couldn't refuse. From there Louella's Cali Soul was born."

Corbin named his restaurant after his grandmother Louella, daughter Cali, and his favorite food Soul. However, it is not the usual take on soul food. The menu will feature grain bowls, with soulfully cooked vegetables and meat. Corbin will bring in some aspects of African cuisine as well and work with local farmers. Louella's Cali Soul will open early 2020 and Corbin will remain executive chef at Alta Adams.

movie like this, the risk is great that mass audiences will retreat from slavery related issues. Still others won't be satisfied that the issues of slavery weren't addressed sufficiently. There are White folks who would like us to forget the role of their ancestors in the slave trade and African Holocaust in this country. Against these odds, "Harriet" has taken in over \$30 million in the early receipts, more than double the studio projections. Had the studios allotted a proper promotional budget, it would have done even better. This suggests there is clearly a market for more stories about African American history in this

country. I came out of the movie with an even greater respect for the legend of Harriet Tubman. I learned things I didn't know, which led me to purchase some books on Harriet Tubman to fill in other things I didn't know. I even bought books for my grandchildren. I take exception to a number of critics of the movie who claimed it was poorly made. I found the movie well-made and acted. I appreciated the dialogue and the quality of the cinematography. Clearly, there were sad depictions of Black people, but these were largely historically accurate. Slaves and free Black People of that day had to give special deference to white people. Given the need for "Black Lives Matter" today some things haven't changed! Due to extreme poverty, many Black people of the day wore ill-fitting, hand-me-down clothing and were not always well groomed. I don't know if I ever saw Ms. Tubman in the movie portrayed in a derog-

is much of her early life we are not shown in the movie. For some parts of her early life we get as flashbacks. The movie is centered in Maryland, she escapes to Philadelphia via the Underground Railroad, where she is helped by Black businessman, William Still, that's a historical fact. She is assisted by various people on her way to Philadelphia via the Underground Railroad, again historical fact. She was assisted on her travels by free Black Minister Samuel Green, historical fact. She fought for the United States in the Civil War and led the Combahee River Raid that is a historical fact.

In the Bible, Book of John 21:25 "Jesus did many other things as well. If every one of them were written down, I suppose that even the whole world would not have enough room for the books that would be written. This is a two hour movie, clearly there are events that didn't make it into the movie. Similarly, we could debate issues of her personality and how she might have approached different things. Incidents Like Gabrielle Union's 'Too Black' Hair Will Soon be Protected by New State Law

On Jan. 1, 2020, California will enact a new law, the CROWN Act or Senate Bill 188, that protects Black women and men from discrimination in the workplace for wearing natural hairstyles.

Gov. Gavin Newsom signed the law, the first of its kind in the nation, in July.

Authored by state Sen. Holly Mitchell (D-Los Angeles), who is African American, the bill expands the definition of racial discrimination to include hair.

"We believe this is just



the beginning of the end to discrimination. It's another chink in the armor of racial discrimination in this country and I'm just proud to be part of the movement,"

Mitchell said when the governor signed her bill.

Just weeks before the law takes effect, news broke that SAG-AFTRA, the Los Angeles-based labor union

representing more than 160,000 television and film industry professionals, is investigating the circumstances of popular actress Gabrielle Union's dismissal from her job as a judge on the NBC television series "America's Got Talent," partly because of her rotating natural hairstyles.

Four sources who claim to have insider information about the way decision makers at the television competition series treated Union say the actress received more than six notes describing her hairstyles as "too Black."

Union, known for her roles in more than 25 films



and as the star of the longrunning BET series "Being Mary Jane," has not made public comment about the incident. But her husband, NBA star Dwayne Wade, has tweeted about her firing.

If Union decides to sue NBC or the show's producers for hair discrimination, she will not be able to stand on the CROWN act, which stands for Create a Respectful and Open Workplace for Natural Hair, because of the timing of her case.

But the show producers have confirmed that they are speaking with Union's representatives to resolve their differences.

Millions of Dollars in Homelessness Aid May Be Coming to Your County, City

Now is the time to start checking in with your city council and county board to inquire how they will allocate millions of dollars in emergency homelessness aid Gov. Newsom has released to counties and cities across the state.

Gov. Newsom said to funnel the \$650 million aid package to counties and cities, he had to bypass roadblocks set up by the Trump administration to delay the funding. President Trump has been a vocal critic of California's homelessness

The governor announced the unprecedented \$1 billion investment in fighting homelessness when he released his budget for the 2019-20 fiscal year earlier this year. The \$650 million emergency spending is a part of it.

"California is doing more than ever before to tackle the homelessness crisis but every level of government, including the federal government, must step up and put real skin in the game," said Gov. Newsom. "California is making historic investments now to help our communities fight homelessness. But we have

work to do and we need the federal government to do its part."

California law requires local allocation of funding to be based on federallyapproved 2019 Point in Time homelessness data. Although local governments and Continuums of Care have requested this data from the feds, they have not yet received it.

The governor said coun-

ties and cities can begin applying for and spending 75 percent of the money (\$500 million) while they

The Soaring Cost of California Pensions is Hurting Employers and Taking Away Minority Contracts

Keeping up with the high cost of pensions in California is hurting public sector employers, city budgets and leading to the firing of some minority money managers at CalPERS, the California Public Employee Retirement System, which is valued at \$387 billion, according to Bloomberg News.

In its annual report, released in November,

CalPERS confirmed that it risks falling into "low funding levels." If this happens, the agency responsible for managing the health and pension benefits of more than a million public employees in California may not able to pay its bills or pay out its commitments.

The League of California Cities, which represents more than 400 municipalities across the state, is alarmed by the growing mandatory payments they have to cough up to CalPERS for employee pensions and benefits, too, according to CalMatters. Between fiscal years 2016 and 2017, that number skyrocketed by more 8 billion.

In an effort to streamline its own costs, CalPERS announced last week that it is scaling back on its "Emerging" equity fund program. Launched in 1991 to increase diversity among its portfolio managers, the program contracts external money mangers, mostly women and minority-owned firms managing assets worth less than \$2 billion who are charged with investing on behalf of the largest public pension system in the United States.

The returns those "emerging" managers were bringing in fell below the agency's targets by 126 "basis points," according to an agency spokesperson.

The Rev. Al Sharpton, president and founder of the National Action Network, said CalPERS' decision to cut the minority money mangers is "unacceptable" and comes as a surprise to him.

"Last year, the National Action Network and I met with Marci Frost and Ted Eliopoulis from CalPERS in Sacramento, both of whom committed to increasing the utilization of diverse asset managers across all asset classes by creating a level playing field," Sharpton told California Black Media. "It is clear that Ted is gone and the board has inoculated the new CIO, Ben Meng, from finding and utilizing high performing talented diverse managers that reflect the diversity of the pensioners.

In an October memo, CalPERS CEO, Marcie Frost said the agency is "restructuring" its emerging manager program, "reducing" the number of managers, and cutting the assets those investors manage from \$3.6 billion to \$500 million.

Black Law Enforcement Speaks Out on Proposed Menthol Ban

Proposed legislation will have drastic and debilitating impact on communities of color.

Several state legislatures have recently proposed laws which are being directed towards what may only be viewed as a mephitic approach to issues as they relate to youthful use of e-

cigarettes and vaping. We stress the concept that these proposed legislative acts would, in fact, be antithetical to healthy, robust and productive relationships between law enforcement and those they are sworn to protect as these new laws would presumably provide law enforcement officers with the authority, indeed the responsibility, to stop, interrogate and arrest persons on suspicion of selling or being in possession of untaxed cigarettes.

None of these legislative efforts appear to have considered the obvious detrimental impact on communities of color, where the preferred cigarette is menthol, and approximately 80% of all African Americans who do smoke prefer to smoke menthol cigarettes. They as well seem to have totally disregarded the strong recommendations of the 2009

Federal Tobacco Control Act in reaching out to subject matter experts when developing the actual language of their legislation. To date, there has been no known input from law enforcement experts, and specifically none from members of any of the nearly thirty organizations representing African American and Latino criminal justice practitioners in the Northern United States who are infinitely aware of the devastating impact of adverse law enforcement interaction in communities of color.

And we must not forget the deadly result of law enforcement interaction with Eric Garner in New York for exactly what these laws would prohibit-the illicit sale and possession of untaxed cigarettes.

We strongly urge members of the community to revert to their roots as civil rights activists and make their voices heard on this issue. And we demand that legislators reconsider their proposals and the obvious consequences it will have on a community that is now, again, being adversely targeted.

Congresswoman Bass Forewarns Press of Theories Surrounding Impeachment Hearings

Congresswoman Karen Bass held a teleconference with the press ahead of the impeachment hearings set for December 4, 2019, and 90-day government blackout. Following the near long-running investigation and multiple reports put out by various sources, the hearing will add muchneeded clarity, an effort Bass was willing to share with the press.

Bass opened the conversation detailing the importance and urgency regarding the timeline the government officials are currently against. As the representative for District 37, Bass promises to update the press with calls and town halls.

"My committee was looking at obstruction of justice volume two of the Meuller Report. The intelligence committee was looking at volume one of the Meuller Report, which is the involvement of the Russians in our election process," she begins. "As we were caring on that investigation, it was interrupted by a whistleblower who came forward and actually brought information forward to the public that said what the president is doing now is actually interfering with the next election."

As she has stated multiple times, the Mueller Report deals with the past, but recently Adam Schiff created a nearly 400-page report regarding the conduct of Trump in 2019, which

discussed two main issues -Trump's misconduct and his obstruction of the House of Representatives impeachment inquiry.

Bass compares the impeachment of President Nixon to that of Trump's, saying "There isn't anything President Nixon did that even comes close to the misconduct and obstruction of President Trump."

In Schiff's report, four points of misconduct are identified. Firstly, his request for a political favor from the president of Ukraine. Secondly, he fired Ambassador Marie Yovanovitch, who was known for fighting corruption and the U.S. Ambassador to Ukraine. Thirdly, he picked his agency, which created a shadow policy that investigated Joe Biden and lastly, froze military assistance and put a condition on meeting with him in White House based on a favor transaction.

Bass details various events where Trump implicated himself, including the infamous press conference in which he stated, "we do this all the time, get over it." With that statement, Bass says he essentially admitted to corruption, betrayal of national security in the service of foreign interest and abuse of power on live television.

The second item focused on was the obstruction of the impeachment inquiry "essentially preventing us from constitutional authority for congressional oversight an impeachment."

"Remember how repub-

licans keep saying everything is hear-say?" she asks, "but ironically, if you believe the president is innocent, then why don't you bring forward the information?"

"The whole thing that they wanted to know, if he had the information, then why wouldn't he [whistleblower] come forward; we want to see the whistleblower," she said, adding, "I don't think they care about seeing the whistleblower; I think they are doing that so they will intimidate anyone else from being a whistleblower."

Bass then opened the floor for questions, the first regarding young voters and what should be done to get them in the know and to the polls.

"We're going to have scholars constitutional basically talk about impeachment," she explains Schiff's hearing where they were called "fact witnesses". "They gave us a huge report with a ton of facts, now our job is to evaluate those facts and see if those facts warrant articles of impeachment."

"I am hoping that it will be clear and easy to understand," she says. "I frankly think the only way to deal with voters and young voters is to get out

there and do the grassroots method of reaching out and contacting them."

"I am very worried that this man who is sitting in the White House today is trying to subvert our elections, that's why we all have this sense of urgency," she says regarding President Trump. "We feel that this guy is dangerous; it's not about what he did before, it's about what he's doing now. That's the urgency, and it might result if we're successful in President [Mike] Pence."

Bass, who once believed Pence could become problematic, now says, "I don't think he's a

"I think that if we're able to remove Trump, we would see a number of Republicans jump in to run, I do not think Pence would go unchallenged."

Regarding Trump finishing his term or allowing Pence to take his position, she stated, "I think we have to move; I think we cannot wait. Even though the election is just a year away, we don't know what this guy is going to do over the next year."

"As impeachment moves forward, I'm worried that he is going to get more and more unstable and do more irrational things."

"One of the dilemmas we are facing right now is how many articles of impeachment should there be," Bass said. "We will have articles of impeachment that are the easiest to understand, the clearest and we are not going to take forever doing this."

"It is not accurate that the judiciary committee is going to do three to four articles of impeachment; we have not even had that discussion yet. But when we get to that point, it will be very clear which ones we are doing and why."

"The reason I believe we have to impeach him now and we have to impeach him quickly, is because I believe he is a clear and present danger to our nation, and I think he is going to continue to try to interfere in the 2020 election if we do not impeach him."

Trump then obstructed Congress by ordering current and former officials to defy House subpoenas for testimony and by blocking access to documents, the charges say.

By his conduct, Trump "demonstrated he will remain a threat to national security and the Constitution if allowed to remain in office, "the nine-page impeachment resolution says.

"If we did not hold him accountable, he would continue to undermine our election," Pelosi said later at a forum sponsored by Politico. "Nothing less is at stake than the central point of our democracy - a free and fair election."

Trump tweeted that to impeach a president "who has done NOTHING wrong, is sheer Political Madness."

He later headed to Pennsylvania for a reelection campaign rally, where he called the effort "impeachment lite" and promised it would lead to his reelection in 2020.

The outcome appears increasingly set as the House presses ahead toward impeachment as it has only three times in history against U.S. presidents, a test of the nation's system of checks and balances.

Democrats said they had a duty to act in what is now a strictly partisan undertaking, as Republicans stand with the president because Trump has shown a pattern of behavior that, if left unchecked, poses risks to the

democratic process. Rep. Jerrold Nadler, D-N.Y., the Judiciary chairman, said the president "holds the ultimate public trust. When he betrays that trust and puts himself before country, he endangers the Constitution; he endangers our democracy; he endangers our national security."

"No one, not even the president, is above the law," he said, announcing the charges before a portrait of George Washington.

Chairman Adam Schiff of the Intelligence Committee said, "We stand here today because the president's abuse of power leaves us with no choice."

Trump's allies immediately plunged into the fight that will extend into the new year. White House Press Secretary Stephanie Grisham said Democrats are trying to "overthrow" the administration. Campaign manager Brad Parscale said Democrats "don't have a viable candidate for 2020 and they know it." The president's son, Eric, embraced his father's penchant for namecalling, assailing Pelosi and

"her swamp creatures." Senate Majority Leader Mitch McConnell said he would be "totally surprised" if there were 67 votes in the chamber to convict Trump, and signaled options for a swift trial. He said no decision had been made whether to call witnesses.

In drafting the charges against the president, Pelosi faced a legal and political challenge of balancing the views of her majority while hitting the Constitution's bar of "treason, bribery or other high crimes and misdemeanors."

Some liberal lawmakers wanted more expansive charges encompassing the findings from special counsel Robert Mueller's probe of Russian interference in the 2016 election. Centrist Democrats preferred to keep the impeachment articles more focused on Trump's actions toward Ukraine as a clearer case.

The final resolution, slim in length yet broad in concept, attempted to find common ground by linking the Ukraine inquiry to the Mueller probe in two separate lines. It said the abuse of power was consistent with Trump's "previous invitations of foreign interference in United States elections," while the

obstruction charge was consistent with his efforts to undermine U.S. government "investigations into foreign interference."

Democratic leaders say Trump put his political interests above those of the nation when he asked Ukraine President peace talks with Ukraine. Volodymyr Zelenskiy in a July phone call to investigate his rivals, including Democrat Joe Biden, and then withheld \$400 million in military aid as the U.S. ally faced an aggressive Russia. They say he then obstructed Congress by stonewalling the House investigation.

The articles say Trump "used the powers of the presidency in a manner that compromised the national security of the United States and undermined the integrity of the United States democratic process."

The first article, on abuse of power, says Trump "corruptly" solicited Ukraine to investigate his political rivals.

The second article, Obstruction of Congress, says that Trump directed defiance of the House's ability to conduct its legal oversight like no other president "in the history of the republic."

Trump insisted in a new tweet that when he asked Ukraine's president "to do us a favor" with the investigations, "us" is a reference to USA, not me!" Democrats, however, say Trump's meaning could not have been clearer in seeking political dirt on Biden, his possible opponent in the 2020 elec-

Republicans stand with the president even if they don't fully address his actions. House GOP Leader Kevin McCarthy said, the vote would be on impeachment not "whether a call is perfect."

While the impeach-

ment is focused on the Ukraine matter, Trump's actions toward Russia continue to underlie the debate. On Tuesday, Trump met at the White House with Sergey Lavrov, the Russian foreign minister just back from Paris efforts to revive


At the same time, a top adviser to the Ukraine president, Andriy Yermak, disputed key impeachment testimony from U.S. Ambassador Gordon Sondland, telling Time magazine the two did not speak of the investigations Trump wanted during a Warsaw meeting.

The next steps are expected to come swiftly after months of investigation into

the Ukraine matter and special counsel Mueller's twoyear Russia probe.

In his report, Mueller said he could not determine that Trump's campaign conspired or coordinated with Russia in the 2016 election. But he said he could not exonerate Trump of obstructing justice and left it for Congress to determine.

Even as she pushed ahead with the impeachment proceeding, Pelosi announced an agreement with the White House on a new U.S.-Mexico-Canada trade deal, a top priority for the president as well as many centrist Democrats. It too, could get a vote next week.

Over the course of time, in the various conversations Lloyd and Mr. Rogers had together, the tables began to turn, and Mr. Rogers began to ask Lloyd questions -- making Lloyd a bit agitated

and uncomfortable. Lloyd had no desire to open up and share anything about himself or personal life, but there was something about the sincerity of the way Mr. Rogers spoke to him that made the walls of his hesitation begin to come down. Because of the genuine interest Mr. Rogers showed in Lloyd he allowed himself to become vulnerable, which ultimately began the process of healing for some of the past issues in Lloyd's life. It's amazing how people will open up when they feel someone is genuinely interested in them.

This scenario really spoke to me because Lloyd's main problem centered around his relationship with his father and some issues that were from his childhood. When Mr. Rogers was talking with Lloyd, one of the questions he asked was, "have you forgiven your father?" He shared with him how important forgiveness is and although we may never get to a place where we can forget, it is never too late to forgive someone. This is the same thing I experienced. I had to learn how to forgive both of my parents for what I experienced as a child regarding the way I was treated by both my mother and father. I've never forgotten what happened to me, but I have been able to forgive them and move forward with



Student Athlete of the Week: Troy Dye

The hard work that line-backer Troy Dye put in during the season paid off for the Oregon Ducks on Friday in their 37-15 upset of the No. 5 Utah Running Utes in the Pac-12 Championship.

The Ducks will battle the Wisconsin Badgers in the Rose Bowl on New Year's Day.

While having a cast on to protect his injured right thumb, he made one interception, eight total tackles and 1.0 tackles for loss for six yards. Although he injured his thumb in the Ducks' October 19 game against Washington state, he only missed one game since the injury.

His defensive efforts helped the Ducks to an 11-2 overall record and an 8-1 Pac-12 record. The Ducks only allowed a total of 85

rushing first downs this season. Dye noted that the Oregon defense made stopping the run a priority.

"It's a huge emphasis ... so we try to focus on that and we set up drills, watch film," he said. "We emphasize on stopping the run game, work in the box and different schemes."

Their preparation proved to be advantageous, as they held Utah to 116

rushing yards in the title

For the past three seasons, Dye had led Oregon in tackles; he is the second player to make that achievement in the history of Oregon football. He is on the verge of leading for a fourth season, as Dye made 75 total hits and 46 solo tackles.

Dye also has 9.5 tackles for loss for 26 yards. He had a season high of 10 tackles

during the Ducks' season opener against Auburn and versus Arizona State.

Last spring, Dye earned his undergraduate degree in General and Social Sciences with an Emphasis in Crime, Law, and Society. Dye credited the tutoring center at Oregon for helping him excel in his studies.

"If I had a problem with my paper and have somebody help me with my paper, somebody that's qualified that's there that's professional," he said. "I think that's a big key to being able to have that safety net to go to them and know that you're gonna be okay and that you got help."

Getting a degree was a goal for Dye, he noted how relieved and excited he was to complete the accomplishment.

"It's just a surreal moment because you know how much hard work, how

much time and dedication goes into getting a degree," he said. "How many late hours, how many times you stay up all night doing papers or doing a reading or have to wake up the next morning, go do a 6:00A.M. lift and you don't want to be there."

Dye took an interest in learning about sociology, and complemented their department at Oregon.

"I like the sociology department as a whole," he said. "I just like how the world works and how people think."

Since his freshman season at Oregon, Dye received recognition for his talent and effort. He was named on the Phil Steele All-Pac-12 second team for two consecutive years and was an ESPN True Freshman All-American in 2016.

The Los Angeles Sparks recently hosted The Purple Print: A Courtside View to tell their fans about their vision for the franchise in the 2020 season. The event comes in lieu of the Sparks winning big at the WNBA Team Business Awards.

Los Angeles won Franchise of the Year, Ticket Sales Performance of the Year, and Marketing Performance of the Year in the WNBA.

The league analyzes all 12 franchises for the awards for their ticket sales, partnership, and community engagement.

The Sparks front office wants to build on their victory; Sparks president and COO, Danita Johnson noted how the franchise

wants to focus on growth, innovation and community.

"We developed a campaign this year called 'Lead The Charge' and we're gonna take that to 2020 with us as well," Johnson said. "'Lead the Charge' is more about not just winning

on the court, but what we do off the court."

Fans were invited to take a tour of the Staples Center to learn about the prices and perks of the 24/7 Membership. The franchise also explained their various group experience packages,

allowing fans to stand with the Sparks players during the national anthem, hi-five the players as they enter the court or rent out the court to conduct activities prior to the game.

A major emphasis during the Purple Print was expanding their fan base. Movie star and L.A. Sparks ambassador, Vivica A. Fox spoke and administrated a Q&A session with head coach Derek Fisher.

Fox noted how the Purple Print is a good way for fans to understand the franchise beyond what they see during games.

"After the game, when it's been a tough fight and they're program to get more stats and things like that, you really don't get to see their sense of humor, how they are and what things makes them tick," she said.

The "Set It Off" star brought awareness of how women's sports gets four percent of media coverage and one percent of sports sponsorship dollars. She asked Fisher a myriad of questions so fans could get a guage of him and his views on the WNBA as well as the Sparks.

Fisher told the crowd that during his first season as head coach, he learned the importance of listening and being openminded. He sees the importance of gaining input from players, the front office and fans.

"As I'm moving from year one to year two, what I want to take from year one is a lot of the information I've learned, a lot of the things that I've gained," Fisher said. "But also to continue to build and connect to my basketball

instincts and the things that I know to be true in terms of playing."

The Sparks has a diverse group of partners which includes Subway, Cedars-Sinai, Model Atelier, the Vivica Fox Hair Collection, and Metro. In October the Sparks renewed their partnership with Nike.

Earlier this year, the Sparks launched the initiative "Spark the True You" a campaign to help homeless female veterans.

"The Sparks get 11,000 fans to the Staples Center, so we just have to imagine what it would be like if we can get these numbers to grow," Fox said. "I believe going into the 2020 season, we all can be successful together and we can cheer on our Sparks to a 2020 Championship."

L.A. Rams 'Level Up' to Beat the Seattle Seahawks

After scoring a road victory against the Arizona Cardinals, the Los Angeles Rams put in the effort offensively and defensively to defeat the Seattle Seahawks 28-21.

"We got the job done, so we did a better job than we did last week," said Rams running back, Todd Gurley. "Last week, we came out and put up field goals, this week we came out and put up touchdowns."

Rams quarterback, Jared Goff completed 293 passing yards, two interceptions and two touchdowns. Seahawks signal caller, Russell Wilson survived five sacks to make 245 passing yards.

During this game, Los Angeles partook in the league-wide initiative "My Cause My Cleats" where players wear customized cleats to bring awareness to a cause they support. Linebacker, Ogbonnia Okoronkwo brought awareness to the Brotherhood Cru-

"When I read up on the Brotherhood Crusade, I saw that their beliefs and things that they do align to what I believe in," he said. "I choose them and this offseason, I plan on doing work with them."

His custom cleats are purple and gold with the Brotherhood Crusade logo on the heel, the Gainsville, Texas native gave a nod to the Los Angeles Lakers with the color scheme.

"The Lakers are my secondary team, I'm a Rockets [fan] to the day I die, but I'm gonna show love to L.A.," Okoronkwo said.

The Rams defense flexed their muscles early; Ebukam sacked Wilson on the third down, forcing the Seahawks to execute a field goal in the first quarter. Goff made key advances by connecting with wide receiver, Robert Woods and tight end, Tyler Higbee.

Rams head coach, Sean McVay noted how Higbee is a "complete tight end."

"He's going to continue to be a big part of this

offense," McVay said.
"Especially when you just look at how vital he's been over the last couple of weeks."

This set up running back, Malcolm Brown to get a touchdown from one yard out. Woods made a scoring rush on the next possession.

The Rams' defense bested the Seattle offense throughout the second quarter, corner Jalen Ramsey forced an incomplete pass on a fourth down to keep the Seahawks from

The Rams had a better chance of finding first

downs, mainly relying on their passing game. Goff targeted Higbee often for successful outcomes. With 0:59 left in the second quarter, Goff slung from the 10-yard line to Kupp to

Ebukam sacked Wilson with seconds left to end the first half, the Seahawks trailed 21-3.

"We didn't play our best game," Wilson said. "There was opportunities out there that we had, it just didn't go our way."

After the half, the Seattle defense challenged the Rams. Safety, Quandre Diggs intercepted two of Goff's slings, one resulting in a pick-6. A few plays after the second pick, Aaron Donald sacked Wilson on a third down.

Wilson only secured two first downs in the third quarter. For any unsuccessful play Wilson made, the Rams house deejay D.J. Mal-Ski played hit songs of his wife, R&B star, Ciara.

Diggs interception return was the only touchdown Seattle scored. Wilson sent a 35-yard pass to wide receiver, DK Metcalf to reach the Rams' 21-yard line. However, Los Angeles only allowed Seattle one last field goal.

The Rams will travel to play the Dallas Cowboys on December 15 at 1:25

The Celebration of Black Cinema Sparks Discussion on Diversity & Inclusion in Hollywood

The Critics' Choice Association (CCA) recently held its Celebration of Black Cinema awards to honor some of the biggest names in Black Hollywood for the substantive work they've contributed to the industry and the mark they continue to leave on Black culture. The ceremony itself is inspired by the late Oscar Micheaux, penned as the world's first major Black filmmaker.

Held at the Landmark Annex Theatre in Hollywood, a slew of producers, writers, actors and Black film critics gathered for the remarkable night of celebration. Honorees included legendary actor and comedian, Eddie Murphy, cinematic sweetheart Nia Long, super director, producer and screenwriter, Kasi Lemmons and a true Brit, actor Chiwetel Ejiofor. Presenters included Academy Award-winning costume designer, Ruth E. Carter, Debra Martin Chase and Chaz Ebert. Former president of the Academy of Motion Picture Arts & Sciences, Cheryl Boone Isaacs served as the night's hostess.

Prior to the ceremonies, the Sentinel caught up with Academy Award-winning actor Chiwetel Ejiofor, known for his gut-wrenching performance in "12 Years a Slave." We asked about Ejiofor's perspective on the state of Black cinema and he affectionately stated that "Black cinema has such a rich and long history and is not often, in isolation, celebrated." "It's important going forward," he said, "but it's also important in preserving moments in history for future generations to embrace."

Honored for his performance, as well as his directori-



al and screenwriting debut in the Netflix feature film "The Boy Who Harnessed the Wind," Ejiofor says the key to storytelling in Black cinema is to "find your voice by working out who you are." "Shut out the rest of the noise and really listen to your instinct, your gut, what you think of yourself and

what you want to bring into

the conversation," he added.

Kasi Lemmons made her Rockstar entry into the world of filmmaking back in 1997 with the directorial debut of the Southern classic, "Eve's Bayou" and says continuing the legacy of Black cinema means "not taking no for an answer." As an actress who didn't hesitate to put her own vision to work on the big screen, the "Harriet" mega director and screenwriter says, "now is the time of great opportunity, to use our art as a weapon for justice and for good." Using freedom fighter

Harriet Tubman's life as a testament, Lemmons says "we have to pray we're strong enough to fight, because we have so many fights ahead. We have to fight for our country, for our planet, for our children and their children," she said.

"We have to fight against autocracy and ignorance, against bigotry and oppression in all of its forms, against those who would try to divide us because together, we have the power to change the world, like Harriet," Lemmons proclaimed.

And Lemmons isn't done yet. She'll soon be debuting a mini-series on Netflix documenting the life and works of "Madam C. J. Walker."

Nia Long, known for starring in movies dripped in Black excellence such as "Love Jones," "The Best Man," and "Soul Food," gave quite the emphatic speech about her "beautifully complicated" road as a Black actress in Hollywood. Long effectually detailed the "joy and heartbreak" of speaking truth to power when it wasn't popular just to receive the same respect as her peers on any given film production.

"I've had the audacity to challenge authority and voice strong opinions when I was expected to just be pretty and be quiet," Long said. "I've been paid far less than the men standing next to me and the women who don't look anything like me, when the success in numbers and

dollars are pretty close, more often than most of the time. I cried behind closed doors, moments before action, because of my experiences in the hair and makeup trailer, experiences which have at times, robbed me of my confidence and my peace of mind."

Long even said that for years, she traveled on sets with her own makeup and hair straightening tools to circumvent entering a production set that "wasn't designed to cater" to her beauty needs. As an actress, philanthropist and advocate who's lived her life to affect change, Long summoned all directors and producers in the industry to provide Black actresses with the tools they need to succeed. "Our day starts with hair, makeup and wardrobe. If your cast is Black, then hire a qualified Black support team instead of labeling us difficult or opinionated; we deserve a pleasant experience as we prepare to create," she said.

Also, quite befitting to receiving her honor, Long recalled some of the precious memories with late writer, actor, director and producer, John Singleton and his unwavering belief in

her talent and star power. "John saw something in me that I had yet to discover," she said. "He encouraged my drive, he saw my purpose, he saw my passion and my commitment to storytelling," Long continued. Accredited to being her "angel on earth" and now her "angel with God," Long says Singleton's impact on her life will always be cherished

Long also left the audience with words that Eddie Murphy gave to her early on in her career. "Never feel guilty about your success," she said of Murphy's advice to her.

After effortlessly slipping past a group of superfans to enter the venue at approximately 7:47pm, a very dapper Eddie Murphy arrived on the scene where he was awaited by special sentiments from his peers and understudies. In an eloquent introduction from Oscar-award winning costumer designer, Ruth E. Carter, she said, "Eddie Murphy doesn't just play African royalty impeccably on screen, he is royalty,"

referring to him as one who is "authentic and values the audience." "He's one of the few actors who has perfected the art of playing alongside himself," she continued.

Murphy, who's relished as a staple in American film and comedy, says he remembers the days, nearly 40 years ago when "there were no African American film critics." Murphy went on to say that, "actually, there was one, and that n**** was crazy; I used to always want to fight him," he said jokingly. "The Nutty Professor," "Coming to America," and "Beverly Hills Cop" actor went on to express the sparsity of Black hair, makeup and wardrobe departments on to the non-existence of Black producers at the time. "It was rough," he said.

Murphy then sidesplittingly urged the audience to "go look at an old Sidney Poitier movie," saying, "Sidney is such a great actor, he was able to act like his hair was combed." The crowd burst into laughter, but we all knew just how far Black Cinema has come, and how far we must go. Murphy was brief, quickwitted and humbly thanked everyone for their support over the years. "I want to thank you so much, it's always a wonderful thing to be honored and to hear those wonderful things said about you," he said.

Murphy recently starred in the UK released film, "Dolemite is My Name," and is preparing for the highly-anticipated release of "Coming 2 America."

As we celebrate more than 100 years of Black Cinema, let's continue, as the honorees have done, to expand the legacy of Black film and entertainment through action and lead with the unmitigated wherewithal to create change for generations to come. 



Black Lives Matter Founder Holds Jail Reform Event in Pasadena

Activist, public speaker, co-founder of Black Lives Matter Global Network and chair of Reform L.A. Jails Patrisse Cullors, joined by four candidates for L.A. County District Attorney, held a panel in Pasadena Saturday, November 9 aimed at raising awareness around mass incarceration and mental illness. During the festive evening event, the panelists/ candidates talked about the importance of redirecting the mentally ill from jail to treatment. Their mission statement has been summed up in the social media hashtags: #REFORMLAJAILS #CARENOTCAGES

#CARINGISEASY. "L.A. County's jail system is the biggest in the world and has a history of over-jailing the mentally ill," said a spokesperson for the campaign.

"Right now, there are 5,000 Angelenos in L.A. County Jails simply because they suffer from mental illness. 65% of prisoners are not receiving the mental health care and addiction support that they need. If RLJ is successful, our ballot measure will require L.A. County to invest in rehabilitation and mental health treatment."

The campaign has a goal of contacting nearly 300,000 voters in L.A. County before election day, said campaign officials.

"L.A. County has a history of dealing with mentally ill people by incarcerating them," said D.A. candidate, Richard Cabellos.

"That is not the answer. Incarcerating people doesn't make them better, it makes them worse. We have to change the mentality. We need to sit side-by-side with social workers and say, 'hey, this [mentally ill] person doesn't deserve to go to jail, let's get him into a program..."

According to a report released by California Health Policy Strategies in January of 2018:

The annual average number of incarcerated individuals receiving psymedication chotropic increased by about 25% between March 2012 and February 2017.

Individuals receiving psychotropic medications compose a large share of the total jail population. The population of individuals receiving psychotropic medication represents about 20% of annual Average Daily Population (ADP) statewide, as of February 2017.

The share of the total jail population receiving psychotropic medications is increasing. The percent of

annual ADP taking psymedications chotropic increased by 4 percentage points between March 2012 and February 2017, from 16% to 20%.

"We know the data is staggering and it's not okay," said D.A. candidate, Rachel Rossi.

"I come to this with a different perspective from having had to sit next to those people who are churned in and out of the criminal justice system on a daily basis. If I'm elected as district attorney, I would first expand access to diversion programs that already exist.

There are programs that exist to provide treatment instead of jail but there are low acceptance rates into those programs.

"What we need to do is expand the D.A's recommendations for people to get into those programs and expand their capacity."

Rossi said she would also start looking into how to prevent mentally ill patients from entering into the criminal justice system in the first place. Event organizer Cullors herself, began the movement in response to the violence her mentally ill brother suffered at the hands of law enforcement.

"Nearly two decades ago, my older brother Monte Cullors was incarcerated by Los Angeles County sheriff's deputies at the Pitchess Detention Center, a county jail complex in Castaic,' Cullors wrote in a Los Angeles Times Op Ed last year.

"He was diagnosed with schizoaffective and bipolar disorders while in jail — and he struck a deputy in the face when he was being transported after a psychiatric evaluation. Four or five more deputies showed up, Monte says, and he got a beating. (According to the deputies' account in court records, Monte attacked one deputy and lunged at another who came to the first one's aid.)"

Cullors said her brother was ultimately convicted of battery on an officer in addition to an original charge of evading police, and sentenced to 40 months in state prison.

"There are currently 17,000 people in our county jail," Cabellos said.

"5300 of them, almost a third, are people who have mental issues. Those people don't need to be in jail. They need to be in a community based program to help them. L.A. County Jail is the largest mental health facility in the county. That's not right."

Like Cullors, D.A. candidate George Gascon has a more personal reason for his fight.

"I have a brother who, for the past two years has been teetering on mental illness," Gascon explained to the crowd Saturday night.

"My family and I have been trying to help him out and he's rejected our help. And, one of the things I really dread is getting that call in the middle of the night from my mother or someone else in my family that he's been killed. I know deep down that my brother is a good guy but right now he's strug-

"I don't want to get that call. I want to do any and everything possible to avoid that call. I want him to get the help he so desperately needs. I think we can save a lot of lives if we take a different approach."

Also joining Cullors at the event were co-founder of BLD PWR Kendrick Sampson, actor and model Jason George, actress Zuri Adele known for "Good Trouble" (2019), "Under the Dome" (2013) and "The Social Worker" (2014), actress Dawn Lyen-Gardner as seen on "Queen Sugar," rising Compton rapper Boogie, medical director of the Office of Diversion and Reentry Kristen Ochoa and D.A. candidate, Joseph Iniguez.



Black News Channel In 'The Red Zone' Ready for Launch

"This has been long in the making," said BNC's Vice President of Community Affairs and former

and where they kept African people at the door of no return to never see Africa again. But we also saw clinics, doctors, the building of hospitals, lawyers, and others.

"And [Jefferson] went home and told his 90-yearold granddad that we saw doctors and lawyers and the building of hospitals. And, his 90-year-old granddad said, 'I knew there was more.

"That is the mission of the Black News Channel. There's more to the African American community than what we see," Watts stated.

During the December 3 reception, Watts participated in a fireside chat with Clarke and Waldo McMillan, the vice president of Legislative Affairs at Charter Communications.

"We don't have as many opportunities to view ourselves and to have our narratives authentically portrayed through those who have similar experiences," Clarke stated during the engaging chat before nearly

200 guests.

"What's significant about the BNC is that it will be a reflection of people of African descent. In my district. I have people from around the world, the [African] continent, the Caribbean. South and Central America.

"They're all seeking knowledge and a viewpoint and lens that speak from their experience. So, I'm excited about this," Clarke

Watts noted that the BNC would be culturally specific.

"Rarely do you hear anvone on any network today talking about Sickle Cell Disease, which is a disease that primarily impacts African Americans," Watts stated.

"And, when we talk about being culturally specific, we just had Thanksgiving. By and large, when we're talking about Thanksgiving dinner, African Americans are talking about cornbread dressing and sweet potato pie.

"By and large, white people talk about stuffing and pumpkin pie. That doesn't mean we can't interchange those dishes, but culturally specific to us would be sweet potato pie and cornbread dressing. We have different cultures, different meals.

"But, it's a lot of things like that we never hear or see in mainstream media when it comes to African American culture."

Watts also said it was important to acknowledge Charter Communications' role in the launch of the

"If someone thinks you can do this without distribution, it's a pipedream. Charter came along and bought into our vision and understood where we were going." Watts stated.

"They could have seen it as risky, and I suspect that someone sitting at the table said, 'I'm not so sure,' but they did it, and it made us real. Things have fallen into place. We have over 60 people employed in Tallahassee, and we have bureaus in New York, Atlanta, Washington, and other areas."

Watts, who was a star quarterback in college and the Canadian Football League, then used a football analogy to describe where things currently stand with the BNC.

"We're in the Red Zone," he stated. "We're about to raise our hands [signaling a touchdown] on January 6, and I would not be sitting here with Congresswoman Clarke, had it not been for Charter Communications saying, 'We believe in the Black News Channel vision."

Rep. Chu Holds Oversight Hearing on SBA's 504/CDC Program

Rep. Judy Chu (CA-27), Chairwoman of the House Small Business Subcommittee on Investigations, Oversight, and Regulations, held a hearing on the current state of the Small Administra-Business tion's (SBA) 504/Certified Development Company (CDC) lending program. The 504/CDC program facilitates small business growth by helping firms secure affordable capital for investments in land,

buildings, and fixed assets. "In Fiscal Year 2018, the number of jobs supported by 504 loans dropped slightly compared to previous years. This raised questions about the program's performance and the steps we can take to ensure that the 504/CDC program is creating jobs in our communities," said Chairwoman Chu. "We would like to know what's working, what's not, and what we can do to ensure that this program is performing at full capacity." Since 1958, the 504/CDC Loan Guaranty program has been backing longterm fixed-rate loans to

support investment in fixed

assets, like land, build-

ings, heavy equipment, and machinery. The program is administered by local CDCs, private nonprofit corporations that work with private-sector lenders to provide financing to small businesses. In 2019, the SBA approved 6.099 loans equaling \$4.96 billion. The program is also geared toward job creation and requires that borrowers create or retain a minimum of one job per \$75,000 of SBA funds received.


The hearing allowed members to hear directly from witnesses from the CDC community regarding their experience with the program. The hearing covered issues like the lingering impact of the government shutdown, expediting low-dollar loans. streamlining the loan closing process, the SBA's requested increase in the maximum loan amount, and current leasing limitations for 504 businesses.

"By solving these problems [in the 504 program], we will help our small businesses and our economy grow," said Mary Mansfield, President & CEO of Bay Colony Development Corp. in Waltham MA. "As I stated at the beginning of my testimony, 504 borrowers are statutorily required to create or retain jobs for every \$75,000 they receive. The easier it is for responsible small businesses to access this program, the more jobs our country creates."

"As we all strive to make SBA and its loan programs relevant to a dynamic, changing marketplace and business environment. I remain hopeful that we all share the same goal to better serve America's small businesses with responsive, relevant, and innovative lending solutions," said Wayne Williams, SVP & Senior Lending Officer at Business Finance Group Inc. in Fairfax, Virginia. "Reducing burdensome regulation and streamlining and modernizing program deliverv will help improve the SBA 504 Loan Program."

"Small business are the lifeblood of our economy. At the core, small businesses are not inanimate objects – they are people taking ideas and solving problems, people providing meaningful jobs and advancement opportunities to others, people paying taxes to pay for services in our communities, and much, much more," said Elaine Fairman, Executive Director of Business Expansion Funding Corporation in Charlotte, NC. "If we are willing to improve the 504 program by working together, we can expand our reach and impact."

"SBA's loan programs, including the 504 program, are designed to fill the gaps left by the private markets, providing loans to small business owners who cannot afford or obtain loans from conventional lenders," said Chairwoman Chu. "The 504 program takes this one step further by targeting small businesses with unique capital needs - the purchase of major fixed assets such as land, buildings, and equipment. Ensuring this program is effectively reaching and serving small businesses at this critical stage of growth is a priority of this Committee."


