Signs Future Act to Help HBCUs, Minority-Serving

One day after the House impeached him, President Donald Trump took decisive action to support and





empower Historically Black Colleges and Universities (HBCUs) across the country.

The President put his signature on the Future Act, legislation that for the time includes HBCUs in the federal 5-year STEM Education Plan and the National Research and Development **Budget Priorities.**

"When I took office, I promised to fight for HB-CUs, and my Administration continues to deliver," Trump stated.

"A few months ago, funding for HBCUs was in jeopardy. But the White House and Congress came together and reached a historic agreement. For the first time ever, I signed legislation to permanently fund HBCUs and other institutions that primarily



The Fostering Undergraduate Talent by Unlocking Resources for Education - or Future Act - means that, under the President's administration, investment in HBCU programs has significantly increased under Title III of the Higher Education Action of 1965.

serve first-generation and minority students. This action guarantees more than \$2.5 billion over the next 10 years, including \$850 million specifically for HBCUs," the President stated.

He continued:

"Today's achievement continues my unprecedented commitment to HBCUs. During my first weeks in office, I moved the HBCU initiative, led by Johnathan Holifield, to the White House and worked with Congress to increase funding for HBCUs by more than \$100 million. HB-CUs have never had better champions in the White House.

"The bill I signed today also reforms the Free Ap-

plication for Federal Student Aid, or FAFSA. The Internal Revenue Service will now seamlessly transfer applicants' records to the Department of Education, so that families can use a simpler, shorter application for financial aid and those with student loans do not have to complete a cumbersome income certification process year after year.

"This is a transformative change that has been talked about in Washington for more than a decade, but everyone always said it could not be done. We got it done."

HBCUs will now play an essential part in federal

Michael Wilkins at seventeen-years-old already displayed tremen-

dous determination and an extraordinary gift for leadership. She is steadfast on her mission to inspire others and grow the community spirit. Showing promise

in a successful political career, she has been involved in debate programs and a number of ambassador events. Wilkins is anticipating positive growth within her historic city; she is reigning Princess of the Pasadena Rose Royal Court. Over 1,000 women between the ages of 17-21 applied; she merely had 15 seconds to explain why she should be apart of the royal court. Michael blossomed vividly in front of the royal committee. She discloses how this experience shaped her motivation to make a difference within her community.

Michael is a senior at Maranatha High School;

she has discovered a deep love for being involved. Every time Michael joins a team or participates, she seems to have a way with her words that energetically promote action from her peers. She distinguished her power in speaking when she joined her highschool speech and debate team. Wilkins excelled and made it to the varsity

speech level. Articulating and carefully constructing her thoughts came naturally. She has been the Mistress of Ceremonies for The Hazelle Catherine Bass Institute for the ARTS Annual Concert five years in a row. Michael had to constantly sharpen her impromptu skills as a young person in the spotlight with the reasonable expectation to deliver a certain level of confidence while speaking. Little did she know she was preparing for a more extensive

role in her community. The time for Pasadena Tournament of Roses sprouted this past September, Michael being drawn to the community festivities applied along with 1,000 other young talent looking for a seat on the royal court. The first round of interviews came with the simple question of their badge number and "why do you want to be on the royal court?" Each girl only had 15 seconds to capture the

royal court's attention. According to the Tournament of Roses website, when each independent candidate met with the committee they are not informed when to start answering. The Royal Rose Queen Committee were seeking girls who would be full of the necessary confidence to follow the unspoken social que to answer to the question. Michael did not display any sign of being nervous, answered with her badge number and promptly declared, " I want to motivate others, I know my leadership skills will be beneficial to the royal court." Michael advanced

to the next round along with 249 other girls that were selected out of the 1,000 candidates that

applied. The interviews and challenges dwindled down the competition, the committee tested their public speaking ability, academics, leadership and community involvement. Twohundred & fifty potential candidates were put to the test; only 25 proceeded to the final stage. After a lengthy and rigorous process, the Royal Rose committee named the most recent royal members of the established court. Michael was properly presented a rose along with seven other girls selected out of the 25 finalists. She is now a part of community history as Princess of the 2020 Tournament of Roses. In her new role, she will accompany court members to over 100 appearances over a span of three months, and she will be on

duty as an active chaperone with coaches and mentors.

Princess Michael will be considered an official ambassador for the Tournament of Roses and the whole Pasadena community. When asked how that makes her feel, she said in full transparency, "Overwhelmed...but with happiness." Taking a few meaningful minutes to reflect on why she thinks she made it this far, Wilkins shared that she was able to willingly speak from the heart. Undoubtedly, through the pruning of becoming a rose princess has developed a deeper love for her community. Her motivation grew because of the duties she has taken on. She sees so much of herself in her city. Michael knows that being a Princess will plant the best building blocks for her humanitarian mission to help with progressive growth and change in the future.

Descendants of Harriet Tubman & Frederick Douglass Discuss the Legacy & Future of Black America

When it comes to uncovering the history of our ancestors, it's sometimes plausible to overlook the tenacity and fervor with which unprecedented trails were blazed for us. In the fast-paced world of instantgratification we live in, it can also be easy for new generations to consider the past a blur, thus neglecting the impact of our forefathers. In Black history, the plight is even more difficult, because tracing our origins starts with facing hard truths about the tragic

realities we've faced. As the nation remembers 400 years of slavery in the United States, it is important we take a deeper, honest look into who we are and the strength that's brought us thus far. Recently, Pasadena Celebrates 2020 held it's 131st Rose Parade, this time commemorating historical figures and paying homage to those who've advocated for women's rights to vote. As part of the centennial celebration of the 19th Amendment, which gave women the right to vote, the parade featured a "Bouquet of Descendants" float which included descendants of Elizabeth Candy Stanton (Coline Jenkins), Ida B. Wells (Michelle Duster), and Susan B. Anthony (Marci Magnatta).

Also apart of the float were descendants of Harriet Tubman (Ernestine Wyatt) and Frederick Douglass and Booker T. Washington (Kenneth B. Morris Jr.). In

was always about other people and how she could help others have a better life," Wyatt said. "She knew that if she could think about other people and what was good for them, that that was going to be good for her in the long

Today, Wyatt says she hopes to bring greater insight into Tubman's role in the Civil War, citing how Tubman was called upon by the governor of Massachusetts at the time to serve as scout. "They knew that she would be an asset to the Union," Wyatt said. "All the fellow abolitionists knew of her, that she could hide in plane sight, she was good at disguising, she was

good at strategizing and analysing different situations.'

Wyatt went on to say that Tubman knew the repercussions of serving as a scout with a bounty on her head, but didn't fear the costs of ensuring freedom for those she fought for. "She felt that if Lincoln would free the slaves and allow them to fight in the war, that the Union would be preserved. The Union that we see now, is the Union that Aunt Harriet helped to preserve," she continued.

As 2020 commences, Wyatt is securing additional signatures contending for Tubman's placement on the twenty-dollar bill. "I'm going to pass it onto the treasury office to let them know we have not forgotten," she proclaimed. "She deserves to be on that twenty, because she's an American patriot," she added.

recent blockbuster film "Harriet," Wyatt says she's focused on doing the groundwork, spearheading programs and events such as Harriet Tubman Day in Washington, D.C. and letting people know that "the work is never done." "Aunt Harriet was a woman of God. She stood up for her

And interestingly enough, Morris Jr. is not only the great-great-great grandson to Douglass, he's also the great-great grandson to Booker T. Washington. Morris Jr. says that his earliest memories date back to when he was five or sixyears-old spending summers at his family's Frederick Douglass beach house, where he learned all about his unique heritage. "I started to notice that they were on statues, money, postage stamps; schools were named for them, libraries, bridges; and everywhere I turned, I could feel that I was in this long, vast shadow of two of the country's greatest heroes," Morris Jr.

While Morris Jr. says he had spent the majority of his life running away from the pressures associated with his great ancestry, it was a 2005 National Geographic article called the While proud of the 21st Century Slaves that ignited his calling to end contemporary forms of slavery. Now an abolitionist, Morris Jr. fights namely against the perils of human trafficking, providing K-12 school children with age appropiate information on how to protect themsevives from falling victim to the billion dollar, black market


glass who at 22, was only two years removed from slavery and realized early on that he could use photography to "make his arguments for liberation and equality," becoming the most photographed American of the 19th Century by "design and by strategy." "When you look at a picture of me, you're never going to deny that I am a man worthy of freedom, worthy of citizenship," Morris Jr. said, recounting the revolutionary declaration made by his forefather.

It is this same zeal, Morris Jr. says, that other young people can rely upon to tell their own truths while igniting the abolitionist within. "We always want to encourage them (students) to use their talent, their passion, their creativity and their intellect to address not only this issue, but any issue that they're passionate about," he said.

As far as the continued "cyclical trauma" many Blacks still face, rooted in the remnant of slavery, Morris Jr. says we must first understand the practical depths of our history. "There was no plan for emancipation, so when the last of 4 million enslaved people were freed in June of 1865, there was no counseling," he said. "There was no Post Traumatic Stress Disorder (PTSD) designation. These were people that had been separated from their family. Many didn't know how to read or write and didn't own anything,' he continued.

"One of the first things is understanding where we come from. We don't know where we are going if we don't know where we come from. History lives in each of us, it doesn't just live in me because I extend from two people that we've heard of. We all descend from somebody that overcame, survived, endured, struggled and progressed,' Morris Jr. said.

"Imagine living in a time when the federal government says it's legal to own you, and it's illegal to teach you. I think a lot of people would run away from that challenge," Morris Jr. said,

tice, equality, she stood up for the oppressed, but when she did it, there was no malice in her heart," she stated.

For Frederick Douglass descendant Kenneth B. Morris Jr., who bears an uncanny resemblance to the famed statesman, orator and abolitionist, he is most proud of Douglass' "lifelong commitment to the fight for women's rights and women's suffrage.'

Morris Jr. says that in order to deal with modern day forms of slavery such as human sex trafficking, child labor, mass incarceration and the prison industrial complex, it is important not to be reactionary, but rather proactive in our approach toward change through education, technology and the arts.

Morris Jr. then recounted his knowedlge of Douick Douglass and many others didn't or we would be a very different country sitting here today."

Morris Jr. says we can expect to see more books, musicals, curricula and exhibitions being released in 2020 as part of the Frederick Douglass Family Initiatives (FDDI) and collective strides to extend and remember the Douglass legacy.



Resolving to be African in the World: Remembrance, Meditation and Recommitment

The New Year, as always, no doubt found many of us joining in the larger society ritual resolution-making which is more an expression of habit and hope than rightful reflection and steadfast resolve. Moreover, it is often essentially personal without proper linkage to the larger issues of community, society and the world. But for us as African people, there is an obligation rooted in our history and reaffirmed in our struggle, to take a more serious approach to this period and time of turning. As the ancestors said, this is the time when the edges of the years meet and this calls for rightful attentiveness to the health and wholeness of our people and the world and to recommitment and continuing struggle to bring, increase, and sustain good in the world.

It is a fundamental Kawaida contention that we must bear the burden and glory of our history with strength, dignity and determination. Surely, the times ahead of us will demand of us the resourcefulness, resilience and righteous resistance by which we understand and assert ourselves in history and as history, embodied and unfolding. This means, in the language of everyday people, there can be no half-steppin', no nick namin' the truth, no spittin' in the wind to see which way to go. On the contrary, we must be the storm riders and river turners Howard Thurman and Gwen Brooks calls on us to be. And like Harriet Tubman, we must reject individual escape, turn around towards our people, confront our oppressor and oppression and dare continue the difficult and demanding work and struggle to achieve freedom, justice, peace and other goods in and for the world.

Thus, as always, we were to sit down on the last day of Kwanzaa and the first day of the year, the Day of Meditation, and meditate on the awesome meaning and responsibility of being African in the world. Indeed, we are to measure ourselves in the mirror of the best of our culture and history and ask ourselves where do we stand, especially in context of our time? It is an assessment which is both personal and collective and involves asking and answering three basic questions: who am I; am I really who I am; and am I all I ought to be?

The first question is designed to remind us of our identity in the most expansive personal and collective sense, beyond vulgarly individualistic illusions and deficient and deformed group caricatures induced by severe oppression. The second question is to remind us of the need to constantly reaffirm the realness and wholeness of who we are, to reject the masks and false identities savage oppression often makes many of us wear, and to choose daily to be African in the most expansive and elevating sense. And the third question is meant to encourage us to honor our identity, as revealed in the best of our history and culture, and to strive always to bring forth in our daily practice the best of what it means to

be African and human in the fullest sense. After deep reflection on this and related points of focus, we are to recommit ourselves to our highest values and most expansive vision of being African in the world.

One way to approach this ethical obligation is to ask a series of questions about the social and moral meaning of being heirs, representatives and custodians of the awesome legacy of good and greatness left by our ancestors. There are three modal periods in our history which provide a foundation and framework for this urgent and ongoing selfquestioning. These are the periods of classical African civilization in the Nile Valley, the Holocaust of enslavement, and the Reaffirmation of the 60's. In each we are provided, not only with a source of an expansive self-understanding, but also a foundation and framework for our essential self-questioning and rightful self-asser-

tion in the world. And so we ask ourselves first, what does it mean to be the fathers and mothers of human-

ity and human civilization; to have stood up first as the elders of humanity; spoke the first human truth; organized the first family and society; imagined math, art, and astronomy; structured time into measurable components of a calendar; created the architecture of pyramid, obelisk and temple; turned imagination into art, medicine and science; and developed the beauty and challenge of daily life into an artform alphabet and a lifeenhancing literature?

Civil Rights Icon and Congressman John Lewis Announces Cancer Diagnosis

"I am going to fight it," read a statement from Rep. John Lewis on the evening of December 29.

"I may miss a few votes during this period, but with God's grace I will be back on the front lines soon," he added. Lewis announced on the last week of 2019 that he has been diagnosed with stage IV pancreatic cancer.

The news sent shock waves through the political community on the left and right and prompted many to reflect on what Lewis' life has added to American history.

"While I am clear-eyed about the prognosis, doctors

have told me that recent medical advances have made this type of cancer treatable in many cases, that treatment options are no longer as debilitating as they once were, and that I have a fighting chance," Lewis continued in his statement.

The Georgia Congressman and civil rights icon was first elected to Georgia's Fifth Congressional District in 1986.

In a year that sadly saw the end of the lives of Congressional Black Caucus cofounder, John Conyers of Michigan and revered Baltimore Congressman Elijah Cummings, Lewis' diagnosis was particularly jarring.

At a time when the country is in need of moral authority many reflected on

the diagnosis as a wake-up

California Writers, Photogs Sue State Over New Law That Chokes Freelance Journalism

When he's not studying, Aldon Thomas Stiles, 25, a senior at Cal State Bernardino, writes freelance articles to help pay his way through college and assist his parents with the bills at home in Fontana.

The Fontana Herald, Screen Rant, Westside Story News and several African-American newspapers around the state have published Stiles' articles in the past. Most of his work focuses on educating Californians about state policy or bringing light to unreported Inland Empire stories that, he says, people should know about..

"Freelancing is an incredibly convenient work opportunity," says Stiles, who is African American. "It has helped me hone my skills as a journalist at my own pace and work on stories I'm passionate about - all from home."

Stiles says the money he makes freelancing helps him keep a roof over his head while in school and that his schedule would have prevented him from working as a full-time writer while he pursued his degree in Criminal Justice.

Now, AB 5, a new California law that takes effect Jan. 1, 2020 threatens the livelihood of California free-lance journalists like Stiles, critics argue, calling the legislation "unconstitutional."

The legislation that Gov. Gavin Newsom signed in September and takes effect Jan. 1, 2020, limits the number of freelance articles journalists in California like Stiles can write for any one publication to 35 per year.

For budding writers like Stiles who can get paid, on average, about \$100 per article, that adds up to only about \$3,500 a year.

Last week, the American Society of Journalists and Authors, Inc., (ASJA), a national professional organization that represents independent non-fiction authors, filed a lawsuit in federal court against the state of California to prevent AB 5 from impacting its members.

"We have no choice but to go to court to protect the rights of independent writers and freelance journalists as a whole," said Milton C. Toby, president of ASJA. "The stakes are too high, and we cannot stand by as our members and our colleagues face ill-conceived and potentially career-ending legislation." ASJA, which represents about 1,100 freelance writers across the country – with about 120 of its members living in California – is joined by the National Press Photographers Association as a plaintiff in the lawsuit. The Pacific Legal Foundation, a libertarian non-profit with offices in Sacramento, is representing the groups pro bono.

"This law as written, even if it has good intentions, sadly, is an affront to first ammendment constitutional protections," says Regina Wilson, executive editor of California Black Media. "It's unfair and inconsistent, too. How can you allow freelancers who write marketing copy and press releases to work unrestricted while taking food off the table of freelance journalists who are writers and photographers? Their words and images contribute to our national historical record and they provide critical information to the public."

"It will no doubt hurt the bottom lines of small ethnicowned media businesses in the state. They already lag behind their mainstream counterparts," Wilson added. "We have to do something about this."

Supporters of AB 5, introduced by Assembly-member Lorena Gonzalez (D-San Diego), praise the legislation for closing loopholes, they say, employers use to underpay workers and deny them benefits like health insurance, minimum wage, paid parental leave, etc., that state law requires for full-time employees.

"Big businesses shouldn't be able to pass their costs
on to taxpayers while
depriving workers of the
labor law protections they
are rightfully entitled to,"
said Gonzalez in May when
the Assembly voted 59-15 to
pass AB 5.

AB 5 writes into law a 2018 California Supreme Court ruling that instructed businesses in the state to apply an "ABC" test to determine whether a worker is a freelancer or employee. For a worker to be classified as a freelancer, employers would have to prove that the person is (A) not under the contracting company's control, (B) is doing work that is not central to the company's business, and (C) has an independent business providing a service. If freelancers or contractors don't meet those requirements, companies would have to employ them and provide all

the pay and benefits required under California labor laws.

It's still too early to gauge exactly how AB 5 will impact freelancers in California, but some moves in the media industry, for a while now, have been sending early signals. Last week, Vox Media, parent company of popular niche websites, including Vox, SB Nation, Eater and Curbed, announced that it is laying off hundreds of freelancers in California. On the other hand, the Los Angeles Times hired 30 of its freelancers as full time employees after the Supreme Court decision last year, according to that publication.

"First, this states the company had been contemplating the switch for 2 years," Gonzalez wrote in a tweet that was widely criticized on social media for coming off as insensitive. She was responding to Vox Media's freelancer layoffs last week.

"Second, it clearly states that those contracted jobs are being converted to full & part time jobs," the Assemblymember's tweet went on. "I understand a contractor who doesn't want a job being upset, but that's certainly not all bad."

Laid-off Vox freelancers

who have spoken out publicly about their loss of work fired back at Gonzales, pointing out that the company transitioned only about 15 journalists to full-time positions while cutting hundreds of freelance gigs.

"The government cannot single out journalists," said Jim Manley, a Pacific Legal Foundation attorney, in a statement about the lawsuit.

Last week, news about the lawsuit lifted the hopes of many California-based freelancers who fear that employers outside the state might blacklist them while California-based companies might replace them with peers living in other states.

"Freelance journalism is a whole different ballgame and this law ignoring that is a travesty," said Antonio Ray Harvey, a Sacramentobased African-American writer who has, for more than 17 years now, wholly earned his living freelancing. He covers sports, politics, current events, and other beats, for the Associated Press, NBC sports Radio, California Black Media and the Sacramento Observer.

"Its not like there are a lot of journalism jobs out there nowadays," said Harvey. "We have to maintain our careers and pay our bills.

"I was disappointed that George Gascon's team decided to challenge my ballot designation when I correctly listed my former occupation on the ballot as a federal public defender," stated Rossi. "It is unfortunate that we spent Christmas Eve in court defending a baseless challenge. I am happy, however, that the judge agreed with us today and denied the petitioner's frivolous petition."

She continued, "I have

been an attorney for ten years, and have committed

almost seven and a half of those years serving as a public defender in L.A. County and the Federal Public Defender's Office, up until I resigned in February of this year. As the judge ruled today, my ballot designation describing my former job as a federal public defender is appropriate under the law. I am proud to be the first former public defender to run for L.A. County District Attorney."

Rossi's attorney, Marc

Williams with Cohen-Williams added, "We are pleased that the Court followed the law and issued the correct ruling today. Rachel Rossi's ballot designation emphasizing her experience as an Assistant Federal Public Defender is truthful, accurate and lawful."

California Elections
Code Section 13107
expressly permits candidates to use "no more than three words designating either the current principal

Professor seeks Assembly seat after making sex assault claim

A college professor who has accused the lieutenant governor of Virginia of sexual assault announced Tuesday she is running for an open California Assembly seat being sought by a dozen mostly Democratic candidates.

Vanessa Tyson, a Democrat, is seeking the seat in a district that includes her hometown of Whittier, about 20 miles (32 kilometers) southeast of Los Angeles.

In posts on her Facebook page and a campaign website, Tyson said she wants to strengthen environmental protections, increase affordable housing and push for women's rights and sexual violence prevention.

"I'm pursuing this opportunity so that I can advocate for groups who rarely have a seat at the table," she said.

The seat opened up last month when Assemblyman Ian Calderon, the Democratic majority leader, said he won't seek re-election next year, citing his growing family, which will soon include three children under 3.

The district also includes Norwalk, Hacienda Heights and La Puente.

Tyson is an associate professor of political science at Scripps College and spent the past year at Stanford University as a research fellow studying the intersection of politics and the (hash)MeToo movement.

Tyson was one of two women who accused Virginia Lt. Gov Justin Fairfax of sexual assault.

She said Fairfax forced her to perform oral sex in his hotel room at the Democratic National Convention in Boston in 2004. At the time, Fairfax was a law student serving as an aide to then-Democratic vice presidential nominee John Edwards.

Tyson said she met Fairfax while working at the convention and he suggested they get some fresh air by walking to his hotel room.

"What began as consensual kissing quickly turned into a sexual assault," she said.

The other accuser said

Fairfax raped her in 2000

when they were students at Duke University.

Fairfax denies any a wrongdoing and says both encounters were consensual. He has filed a \$400 million lawsuit against CBS, alleging the company a defamed him when it thought broadcast interviews with the two women. He has

also requested police inves-

tigations in an effort to

clear his name.

Fairfax said the women's accusations were politically motivated. They came forward as Fairfax seemed poised to succeed Virginia Gov. Ralph Northam, who faced calls to resign over a yearbook photo depicting one person in blackface and another in a Ku Klux Klan robe.

Tyson has said the incident with Fairfax left her feeling deeply humiliated and ashamed but she suppressed the memory to focus on her career as an academic.

academic.

Calderon's sudden announcement was initially thought to have ended a family tradition. He succeeded his father, Charles Calderon, in the Assembly.

His two uncles also served,

Ron Calderon in the state Senate and Tom Calderon in the Assembly. Both uncles were convicted of public corruption charges in 2016.

Ian Calderon says he's backing his stepmother, Lisa Calderon, for the seat.

Another candidate, Sylvia Rubio, is also part of a burgeoning political family. Her sisters are state Sen. Susan Rubio and Assemblywoman Blanca Rubio, both Democrats representing the Baldwin Park area.

Democrats make up 48% of registered voters in the district. Another 21% are registered Republican and 26% have no party preference. One Republican and one member of the Green Party also are running.

Controversy, which has enveloped Kanye West for a long time, raised another level when he announced his total commitment to Christ and began his Sunday Service series one year ago.

But, like the saints of old, the celebrated rapper hasn't let naysayers stop his praise. His faith was on full display on Dec. 29, as he marked the first anniversary of Sunday Service with a rousing worship experience on skid row in downtown L.A.

West, the Union Rescue Mission (URM) and Faithful Central Bible Church (FCBC) collaborated to present the service at URM, which is the site of FCBC's regular DTLA Sunday worship and its various midweek activities that minister to the homeless. The Rev. Andy Bales, URM CEO, and Bishop Kenneth C. Ulmer, FCBC pastor, were also on hand.

Armed with his band, choir and guest preacher, Pastor Kerwin Lee, West joined with homeless parishioners to lift up the name of Jesus through prayer, music and the Word of God.

"We come to sing to God, we need the Spirit of God," declared Jason White, who directed the choir in powerful renditions of gospel standards such as "Sing 'Till the Power of the Lord Comes Down," "Father, I Stretch My Hands to You" and "O Lord, How Excellent is Your Name," all featured on West's latest album, "Jesus Is Born" that dropped on Christmas Day.

After roaming through the crowd to shake hands and speak with some of the worshippers, West captivated the audience while rapping about life's distractions over the choir's chorus of "Hallelujah" and had people swaying as he delivered "Closed on Sunday" and "Follow God," both from his "Jesus Is King" album. And to those who doubt his conversion, West admonished, "Don't call me secular. I was just distracted for a while and God sent me here!"

With the congregation on a spiritual high from the music, Lee, pastor of Berean Christian Church in Stone Mountain, Georgia, ascended the stage to offer practical application of the Christian faith with the message, "The Type of Savior Everyone Needs."

Lee cited John 21:3-6 as the scripture reference for his discourse, which describes how the disciples return to their old occu-

pation of fishermen after witnessing the resurrected Christ.

Emphasizing that past behavior should be discarded once you encounter Jesus, Lee said, "You need a Savior that can locate you, even after you mess up. Whatever you try without God will not work." Pointing to verse 6, he reminded the audience that Jesus "is a Savior who can motivate you" and "a Savior who can accommodate you."

Ulmer followed Lee my issuing an invitation to Christian discipleship and after the service concluded, the expressed his appreciation that West reached out to URM and FCBC to hold the gathering. In addition, West donated new shoes and warm clothing to URM not that will be distributed to

Ulmer. "His passion is not just for the concert. His passion is that people make connection and relationship with God. So when the service goes from city-to-city, he makes sure that he's made connections with local clergy so when they go to the next city, ministries like ours will be here the next Sunday [for the people]. So, his heart is with the Gospel and the Kingdom and God is using him," he noted.

"More importantly, what concerns me is by his own admission, he's made this (Sunday Service) a re-

dedication to the Lord and if we're all born-again, we're born-again to grow. And it concerns me that people would take shots at him -you know, 'why didn't he do this, why didn't he do that?' Well, he's growing. Give Kanye a chance to grow like all of us had to grow," Ulmer said.

Sharing a similar view-point, Bales said, "The Sunday Service was awesome. It was all that I hoped it would be and more. Lifting up the name of Jesus Christ is the real deal.

"Why would anybody pass judgment on some-body who is lifting up the name of Christ? He said that from now on, I am only going to declare the risen Christ. I have no regrets about hosting this service," said Bales. "The controversy will only cause us to lift up the name of Jesus everywhere we go!"

Calif. vastly expands digital privacy. Will people use it?

Californians will soon have sweeping digital-privacy rights stronger than any seen before in the U.S., posing a significant challenge to Big Tech and the data economy it helped create.

So long as state residents don't mind shouldering much of the burden of exercising those rights, that is.

Come Wednesday, roughly one in 10 Americans will gain the power to review their personal information collected by large companies around the world, from purchase histories and location tracking to compiled "profiles" that slot people into categories such as religion, ethnicity and sexual orientation. Starting January 1, they can also force these companies — including banks, retailers and, of course, tech companies — to stop selling that information or even to delete it in bulk.

The law defines data sales so broadly that it covers almost any information sharing that provides a benefit to business, including data transfers between corporate affiliates and with third party "data brokers" — middlemen who trade in personal information.

It remains unclear how it will affect the business of targeted advertising, in which companies like Facebook amass reams of personal data and use it to direct ads to specific groups of people. Facebook says it doesn't share that personal information with advertisers.

Still, because it applies to any company that meets a threshold for interacting with state residents, the California law might end up serving as a de facto national standard. Early signs of compliance have already started cropping up in the form of "Don't sell my personal information" links at the bottom of many corporate web-

"If we do this right in California," says California attorney general Xavier Becerra, the state will "put the capital P back into privacv for all Americans."

California's law is the biggest U.S. effort yet to confront "surveillance capitalism," the business of profiting from the data that most Americans give up — often unknowingly — for access to free and often ad-supported services. The law is for anyone ever weirded out when an ad popped up for the product they were just searching on, or who wondered just how much privacy they were giving up by signing into the briefly popular face-changing tool FaceApp.

But there are catches galore. The law — formally known as the California Consumer Privacy Act, or CCPA — seems likely to draw legal challenges, some of which could raise constitutional objections over its broad scope. It's also filled with exceptions that could turn some seemingly broad protections into coarse sieves, and affects only information collected by business, not government.

For instance, if you're

alarmed after examining the data that Lyft holds on you, you can ask the company to delete it. Which it will legally have to do — unless it claims some information meets one of the law's many exceptions, among them provisions that allow companies to continue holding information needed to finish a transaction or to keep it in a way you'd "reasonably

"It's more of a 'right to request and hope for deletion," says Joseph Jerome, a policy director at privacy group Common Media/Kids Action.

A more fundamental issue, though, is that Californians are largely on their own in figuring out how to make use of their new rights. To make the law effective, they'll need to take the initiative to opt out of data sales, request their own information, and file for damages in the case of data breaches.

"If you aren't even reading privacy agreements that you are signing, are you really going to request your data?" asks Margot Kaminski, an associate professor of law at the University of Colorado who studies law and "Will technology. understand it or sift through it when you do get it?"

State residents who do make that effort, but find that companies reject their requests or offer only halting and incomplete responses, have no immediate legal recourse. The CCPA defers enforcement action to the state attorney general, who won't be empowered to act until six months after the law takes effect.

When the state does take action, though, it can fine businesses up to \$7,500 for each violation of the law charges that could quickly add up depending on how many people are affected.

The law does offer stronger protection for children, for instance by forbidding the sale of data from kids under 16 without consent. "The last thing you want is for any company to think that we're going to soft on letting you misuse kids' personal information," Becerra, the attorney general, said at a press conference in December.

Many of the CCPA's quirks trace back to the roundabout way it became law in the first place. A few years ago, San Francisco real estate developer Alastair Mactaggart asked a friend who worked at a tech company if he should be concerned about news reports on how much companies knew about him. He expected an innocuous answer.

"If you knew how much we knew about you, you'd be terrified," he says the friend told him.

With help, Mactaggart produced a ballot initiative that would let California voters implement new privacy rules. Although initially a long shot, the proposal quickly gained steam amid news of huge data breaches and privacy leaks.

That drew the attention of Silicon Valley, whose big companies considered the ballot initiative too risky. Moving the proposal into the normal legislative process would give them influence, the chance to pass amendments, and above all time to slow down what seemed to be a runaway

"I always knew I was signing up for a fight," Mactaggart says.

The developer agreed to pull the initiative off the ballot and have it introduced as a bill. In slightly changed or weakened, per critics form, it passed. Gone, for instance, was a provision that would have allowed people to sue when companies improperly declined to hand over or delete data.

The coming year will provide the first evidence of how much protection the CCPA actually offers - and

how thoroughly Californians will embrace it.

Among other limitations, the law doesn't really stop companies from collecting personal information or limit how they store it. If you ask a company to delete your data, it can start collecting it again next time you do business with it.

Mary Stone Ross, incoming associate director of the Electronic Privacy Information Center and coauthor of the original ballot initiative, worries that CCPA might just unleash a firehose of data on consumers. "A business could actually drown a consumer in information so the important pieces are lost," she says.

There's a way to avoid that by just asking for which categories of information a company holds, such as demographics, preferences or interests. But it's not clear how many will know to do

The law's biggest impact, in fact, may lie in how it requires companies to track what data they have, where they keep it, and how to get it to people when requested, says Jen King, director of consumer privacv at Stanford Law School's Center for Internet and Societv. That effort alone, which can be substantial, might cause corporations to reconsider how much data they decide to hold onto.

That may lead to some unintended consequences and even corporate attempts to discourage people from using the law. The jobsearch site Indeed.com. for instance, now explains that when anyone opts out of data sales under CCPA, it will also ask them to delete their associated accounts and all personal information.

Such people will still be able to use the website without logging in. Indeed said in a statement that it routinely transfers personal information such as job-seeker resumes to employers as part of its service. Because it believes that such transfers may qualify as "sales" under CCPA, Indeed will not hold such information for people who opt out of data sales

Horse Dies During Light Running at Santa Anita

Santa Anita's opening weekend reportedly was marred by the death of another racehorse - though the latest fatality happened on Thursday, two days before Saturday's rescheduled opening day.

"The 3-year-old gelding Truest Reward, winless in four starts and trained by Doug O'Neil, fractured his left shoulder on the training track at Santa Anita the morning of December 26, two days before the start of the winter meet," said Mike Marten of the California Horse Racing Board.

The training track - considered the safest track was closed to workouts but open for jogging and galloping, according to the Los Angeles Times.

Thursday was supposed to be Santa Anita's opening day, but forecasts of rain prompted track officials to postpone the first day of its 83rd winter meeting until

Saturday, when 11 races were Battle of Midway while run without incident.

expect" them to.

Mike Willman, Santa did not confirm or deny the report when reached Sunday by City News Service, but he did express frustration with some media coverage of Saturday's opening day, which he said focused too much on a relatively small group of animal-rights protesters outside the track and not enough on the success of the day overall, which saw an attendance of 35,085.

"Let's go with some math - 35,000 vs. 12 protesters," Willman told CNS. "We had the second-best all time pari-mutuel opening."

Saturday's pari-mutuel handle at Santa Anita was just over \$19 million.

Santa Anita – and the sport in general – have faced increasing pressure from animal-rights activists amid the death of at least 38 horses at the track over the last year, which included 2017 Breeders' Cup Dirt Mile winner

training at the track on Feb. 23 and Mongolian Groom, nita's director of publicity. who was euthanized after suffering a fatal injury in the Breeders' Cup Classic at

Santa Anita on Nov. 2. About 40 to 45 activists turned out for a "funeral" and "vigil" Saturday that included a bagpiper for the horses who have died over the past year. Heather Wilson of Horseracing Wrongs - told NBC4, "This is an inherently deadly sport. We all know it is only a matter of time before another horse is going to be killed on this track.'

Craig Fravel, CEO of Racing Operations for The Stronach Group, which owns Santa Anita, told the station, "We have incredible veterinary oversight of these animals, we also have changed medication rules and we've got vets watching in the morning and making sure that any horse that shows any signs of lameness are taken care of and looked after and I think we're confident that

everything we've done has produced positive results."

Racing Board is set to issue a report next month on the horse deaths.

The Los Angeles County District Attorney's Office concluded Dec. 19 that there was no criminal wrongdoing connected to the deaths, but offered a series of recommendations aimed improving safety at racetracks in California.

"Horse racing has inherent risks but is a legally sanctioned sport in California," District Attorney Jackie Lacey said in a statement. "Greater precautions are needed to enhance safety and protect both horses and their riders."

The district attorney called on state regulators to develop safety enhancements to reduce horse deaths, including possible enhanced penalties for rules violations, establishment of a tip line for people to report violations or animal cruelty allegations

and mandated inspections of racing and training facilities, The California Horse and reviews of necropsy and veterinary records of horses that have died.

> The report also made recommendations aimed at identifying pre-existing conditions in horses that could lead to breakdowns, establishing track-maintenance protocols - including special measures during rain or extreme weather conditions, and creation of "safety codes of conduct" for owners, trainers, jockeys, veterinarians and others who care for horses.

The report noted that officials at Santa Anita have implemented a series of safety-improvement measures that "have reduced the number of fatal racing and training incidents."

An advertisement for Santa Anita that has run in the Los Angeles Times' sports section has touted that "California racing is proud to be at the forefront of horse and rider welfare as we introduce revolutionary

safety protocols for the modern era. On our tracks every horse comes first."

Earlier this month, Santa Anita debuted a "cuttingedge" PET Scan machine to provide imaging of the fetlock or ankle joint – the most common area for injuries to occur in Thoroughbreds without horses having to undergo anesthesia, and said it will help to diagnose preexisting conditions in Thoroughbred racehorses.

"This state-of-the-art technology reflects a new standard of care within Thoroughbred racing - a standard that puts the health and safety of horses and riders first," said Belinda Stronach, The Stronach Group's chairman and president.

Truest Reward's death was first reported Saturday evening in a story in the Los Angeles Times headlined, "Santa Anita opener goes off without a hitch."

He was trained by Doug O'Neill, and was winless in four starts.

Two former prime ministers of Guinea-Bissau faced a runoff presidential

2 ex-prime ministers vie for Guinea-Bissau presidency election Sunday after the

incumbent failed to reach the second round in the tumultuous West African country once described by the United Nations as a narco-state.

President Jose Mario Vaz, in power since 2014, has vowed to respect the results in a rare gesture of political stability. Vaz is the first democratically elected president to complete a full term without being deposed or assassinated since the country's independence

from Portugal in 1974. Linica Correia, 29, said she cast her ballot for frontrunner Domingos Simoes Pereira, who finished with 40% of the first-round vote

endorsed by six of the 10 eliminated candidates.

"The Guinean people have already suffered enough," she said. "I hope that the next president recognizes this suffering and works to transform the country by giving back peace and stability to the people."

While there has not been a power grab in Guinea-Bissau since 2012, the country has had seven prime ministers appointed since August 2015. There was enough concern ahead of the Nov. 24 first-round vote that the regional bloc ECOWAS said it had a military force on standby to "re-establish order" in the

event of a coup.

The lead-up to the election was bumpy: Vaz fired his prime minister and Cabinet a month before the November vote, sparking outcry. The ousted prime minister, Aristide Gomes, refused to step aside and his designated replacement swiftly resigned as regional pressure mounted.

Pereira, the front-runner, has a long history of feuding with the president: Vaz fired him as prime minister in 2015 and refused earlier this year to choose him for the post.

Pereira has cast himself as the candidate who can create the economic conditions that would allow for development in Guinea-Bissau, one of the world's

Another former prime minister, Umaro Sissoco Embalo, received just over 27% of the first-round vote but has drawn support from four of the eliminated candidates, including outgoing president Vaz.

Guinea-Bissau, a nation of around 1.5 million people, has long been beset by corruption and drug trafficking. In the 2000s, it became known as a transit point for cocaine between Latin America and Europe as traffickers profited from corruption and weak law enforcement.

The drug trade has become less prominent with increasing enforcement. In September, the

ness dream and vision of J.C. Watts, Jr., a nationally known entrepreneur and former U.S. Congressman, representing Oklahoma's Fourth District.

Programming will include special news features on topics that most affect the quality of life of communities of color - like Sickle Cell Disease and hypertension – that generally aren't given much attention to by other news outlets. The BNC has also established a news-content alliance with the National Newspaper Publishers Association (NNPA), representing the Black Press of America, via 225 African Americanowned newspapers and digital companies throughout the United States.

The Tallahassee, Florida-based BNC counts as the brainchild of J.C. Watts, Jr., who is described by Tommy Ross, the network's director of communications, as "a father, husband, grandfather, business owner, entrepreneur, author, elected official at the state and federal level, a pastor, and a rancher who grew up in a small town in Oklahoma."

In reality, Watts appears as much more, and those who know him, understand that he's a Republican conservative whose accomplishments crosses party lines. Watts is also a former All-Star quarterback, who played college football in Oklahoma and pro ball in Canada.

His congressional accomplishments and living legacy are noteworthy, including:

"Helped Black farmers get some justice on a discrimination suit against the United States Department of Agriculture.

"Helped push through legislation for the African American Museum of History and Culture.

"Sponsored HBCU summits to establish relationships and better understanding between students and Republican policymakers.

"Sponsored anti-poverty legislation (community renewal/new markets tax

"Led Congress in highlighting minority health care disparities.

"Led on the Republican side against sentencing disparities between crack/powder cocaine.

"Led in getting funding to fight malaria in West Af-

Sponsored Africa growth and opportunity legislation.

"We've done a lot as African Americans," Watts stated before referencing a recent statue unveiling that took place in Richmond, Virginia, earlier this month. "Rumors of War," a statue by artist Kehinde Wiley, was unveiled on December 10 during a ceremony at the Virginia Museum of Fine Arts. The figure depicts an African American man dressed in contemporary clothing riding a horse, echoing the equestrian sculptures of Confederate soldiers.

"Rumors of War" was reportedly Wiley's response to the Confederate monuments that pepper the U.S. and the South in particular. The new memorial arrived amid an ongoing debate across the country about what do with Confederate imagery. "This was history," Watts said of the statue. "Because, if we talk about the slave owner, how can we ignore the

slave? African Americans contributed mightily to the United States, and you don't see enough statues of African Americans."

"Think about what Rosa Parks contributed, Harriet Tubman's sacrifice, Martin Luther King's sacrifice, and Frederick Douglass. Their contribution was to raise the conscious level of America to say that you know, we are all human and, and all created by the same God," Watts emphasized.

He said the BNC would highlight the contributions of African Americans. And, to successfully accomplish that mission, Watts said it was essential to partner with NNPA.

"NNPA already has people in the trenches that report on African American life, whether it's Chicago, Atlanta, Birmingham, Detroit or Oklahoma City, they report on African American life every day," Watts stated. "I don't know if I can put into words how important that partnership will be, and that's just in terms of content. When I

was in politics, we used a strategy where you've got people knocking on doors and leaving literature, and that's your ground game," Watts continued.

"But you also need an air attack to augment that ground game, so with NNPA being on the ground and giving us information and data, and us being able to launch an air attack, it's critical," he stated.

Watts believes that a significant component of the BNC is providing knowledge to a community that's starved for information.

"Our viewers be able to find out more about Sickle Cell and Black men and Black women's health," Watts stated. "They will also be reminded that Black history isn't just about Martin Luther King and the Civil Rights Movement, which was extremely important, but it isn't the only part of our history. We are going to take a deeper dive and have a deeper relationship with our community."

Watts's background as a Republican and a conservative has often been a topic of both his supporters and detractors. However, Watts refuses to allow stereotypes and presumptions to define him.

"Conservative means many things to different people. To me, it means living the way my grandmama taught me," Watts stated. "She taught me to treat people the way that I want to be treated. In a Black home, you rarely saw people leaving their lights on at night because grandmama taught that it was a waste of electricity. If the lights were on, you knew that something pretty serious was happening."

Watts continued: "The bottom line about being a conservative is that you treat people with respect, and you don't believe in wasting things. That's important. And, another primary place that I get my conservative values is the Bible. I was taught that I shouldn't just be concerned about Oklahoma University, my alma mater, but I should also be concerned about Morehouse. That's why I sponsored anti-poverty legislation because sometimes you have to put extra resources into different communities to give them the infrastructure to attract industry and jobs."

"My biblical principles drove me much more than the Republican party. Look, the National Football League recognized that having successful teams in every market would benefit everyone, and that's why the team with the worst record gets the top pick in the draft. They know that if the Cincinnati Bengals perform better, everybody wins because you would have more advertising and a better television contract for everyone. So, I feel the same way about underserved communities. If we can help them to be stronger and create more opportunities within those communities, then that's good for all communities."

Conservative values also sparked Watts's desire for criminal justice reform, he stated.

"When I talk about conservative principles, you know you don't waste money," Watts stated. "So, why should we spend \$28,000 a year to incarcerate someone for a low-level, nonviolent drug offense?

"You can spend significantly less on community

service. And, when you look at the facts, the sentencing disparities were big. People on Wall Street were using powder cocaine just like people on Main Street, or people in poor communities, but the sentencing disparities were off the charts. I voted my conscience on this when I was in Congress," Watts stated.

With the launch of the BNC just only weeks away, Watts hopes that viewers will get a similar feeling to what he experienced after recently taking his daughter to dinner to celebrate her birthday.

"My daughter recommended the restaurant, I'd never been there before," Watts stated, "After dinner, she asked me what did I think of the restaurant? I said, 'I'd come back tomorrow. And I think that's our mission with the BNC, not just to grab the imagination and the attention of the nation, but especially our demographic and to have them come back. I think it'll be a mission accomplished."

Dr. Benjamin F. Chavis, Jr., a progressive Democrat and president and CEO of the NNPA without any reservations asserted, "The launch of the Black News Channel (BNC) is very timely at the beginning of 2020. 2015,, there were demonstrations at The Grove. In 2016 BLMLA took over the dining room at Trump Golf Course in Rancho Palos Verdes. In 2017, there was a march in Beverly Hills. Last year there was a "Mass March for Justice," that began at the CNN Building on Sunset Boulevard, followed by demonstrations outside 24-Hour Fitness where #AlbertRamonDorsey was killed by LAPD and then inside Walgreen's where #SkyYoung was murdered by security. This year's Mass March zeroed in on an epicenter of White capitalism -Hollywood & Highland, bringing nearly 1000 protestors, including many of the families of those killed by police.

At Hollywood & Highland the massive crowd gathered, leaving security scurrying. Teams entered stores and restaurants singing justice carols, justice lyrics sung to popular Christmas tunes: "Hark the Fighting People Sing," "Dreaming of a Black Xmas," "Trump's Nuts Roasting." The crowd reassembled in the courtyard, joined by some who had initially come to shop. Three massive banners, each with a single word, were held over the balconies that read: BLACK LIVES MATTER. A speaker played "The Wobble," "Cupid Shuffle," and "Cha Cha Slide" as the crowd danced in celebration of the Spirits of slain loved ones.

As more than 20 LAPD moved in, the DJ switched to Janelle Monae's "Hell You Talm Bout," and the demonstrators marched out of the shopping center and into the intersection of Hollywood and Highland. For more than 30 minutes, people blocked traffic, held signs, chanted, and stood in their power, even as police

surrounded them, threatened them with arrest, and pulled out tear gas and bean bag guns. The demonstration closed out with a gigantic human circle holding the intersection, with families of those killed and youth organizers at the center. The entire team chanted in unison the words of exiled freedom fighter Assata Shakur, "It is our duty to fight for freedom. It is our duty to win. We must love and protect one another. We have nothing to lose but our chains."

Weather forecasts predicted heavy rain beginning at 5p.m. but somehow it was held off until the moment the circle dispersed at 6:38p.m. Black Lives Matter often invokes the power of Spirit, a practice uncommon to many contemporary radical movements. Under the chill of the winter sky, it seemed that the names chanted invoked their presence and a Divine energy that protected and powered the marchers.

The group pledged to continue their protests, their work and their commitment to #BlackXmas, a disruption of White capitalism, an honoring of the lives of those murdered by the state, and a building of Black community.

capitalism. Practically, ending White capitalism - the interlocking systems of racism and classism - begins with disruption of businessas-usual. By having a presence in spaces of White affluence, Black Lives Matter intends to compel those who have bought their way out



Kenneth Jackson, Victor Over Adversity, Passes at 74

At one point in his life, Kenneth Milton Jackson was a homeless veteran, yet he never gave up. Disconnected from his family at age five and beset with medical issues later in life, Kenneth could have plunged into self-pity and isolation, but he forged ahead and emerged as a productive individual who touched many lives in a positive way.

A resident of Ward Villas in South Los Angeles, Kenneth passed away on Dec. 17, at UCLA Hospital. His services are set for Jan. 9, at 11 a.m., at the L.A. National Military Cemetery in Westwood.

Kenneth was born on Sept. 6, 1946 in Beckley, West Virginia. His mother passed when he was fiveyears-old, and he became separated from his siblings for the next years. Yet, he still excelled and graduated from high school in 1967. Four years later, he joined the U.S. Marine Corps.

He did well in the armed forces, becoming a

tank crewman and earning a Good Conduct Medal as well as National Defense Service Medal. After being honorably discharged, Kenneth re-enlisted in the USMC Reserves.

Kenneth went on to become a body builder and physical fitness advocate; however, he encountered various hardships and medical problems over the years, which led to the amputation of his legs. Undaunted, he strived to remain on his own and in 2011; he became a resident of Ward Villas, an affordable housing community for elders able to live independently.

Initially, he was rather reserved at Ward Villas, but gradually the staff and other residents persuaded him to participate in the development's activities. Kenneth soon became a regular attendee of many gatherings such as the annual Thanksgiving dinner sponsored by Mothers In Action and Ward EDC, sitting at the balcony level nette); several nieces and while enjoying the food, music, and fellowship.


Also, he traveled almost

every day to the Greater Los Angeles Veteran's Hospital in Westwood, navigating his wheelchair to ride two Metro buses each way. Kenneth once shared with Jackie Dupont-Walker, president of Ward EDC, that he fell from his wheelchair while leaving a

He said, "Some folks uprighted my wheel chair and lifted me - all 300 pounds - back into the chair. Then someone else ran to the next bus, told the driver I was coming and they waited. I am going to be more careful, but I am so glad for those people who didn't have to help me, but did."

The V.A. staff also helped Kenneth to reconnect with his surviving siblings in 2007. His brothers united to provide a support base and links to his heritage.

Cherishing Kenneth's memory are his brothers, Albert, Andrew (Gayle), Daniel and Samuel (Annephews, and other family

A \$9 million increase in the Strengthening Historically Black Graduate Institutions (\$72.3 million);

A \$1 million increase the Strengthening HBCU Masters Programs (\$8.6 million);

Meaningful increases investments in student support like Pell Grants, Federal Work-Study, and Supplemental tional Opportunity Grant

(SEOG); and Increases in Howard University's annual appropriation by nearly \$11 million, bringing its fiscal year 2018 investment level to \$232.5 million.

The bill also increased by \$30 million in investments in the HBCU Capital Financing Program, helping eight schools experiencing financial difficulty in redesigning and restructuring to better meet student and community needs and fulfill loan obligations.

Trump also has appointed both the Chairman of the President's Board of Advisors on HBCUs and Executive Director of the White House Initiatives on HBCUs.

"What we're talking about is permanent funding for HBCUs, as well as minority-serving institutions, to the tune of \$255 million in the annual formula and competitive funding," said Ja'Ron Smith, the Deputy Assistant to the President for the White House Office of American Innovation.

"That's over ten years, so you're talking about \$2.5 billion, and we didn't just stop there. With the FAFSA (Free Application for Federal Student Aid) simplification that only allows students to answer up to 22 questions on a current basis, we eliminated the burdensome process that will allow low-income students like myself, who had to navigate a FAFSA form without having parents who ever went to college," Smith stated.

Smith added that the legislation would help put more students in the pipeline, and more resources into HBCUs and minorityserving institutions.

"It's going to help them with programming infrastructure and help the students that go to these institutions," he stated.

The President and his administration are aggressively working on other strategies to assist HBCUs

and other minority-serving institutions, Smith stated.

"During our last two presidential board of advisors meetings, the subject came up, and we're also taking a look at the money that can be leveraged into these institutions as well as community colleges," Smith said. "I think that we just need to be smarter as a government and harness our institutions. Many of these schools are located in areas where people depend on those institutions to get access to opportunity. Our commitment has always been to figure out a strategy to help these institutions throughout the 21st

The Los Angeles County Development Authority (LACDA) announced today that Executive Director Monique King-Viehland is stepping down as Executive Director, effective December 31, 2019. Emilio Salas, Deputy Executive Director, will serve as Acting Executive Director during the transition.

King-Viehland has worked for the agency since 2015. 
I have decided to begin this journey in the middle of the Eating Season. Since my last entry, I have experienced a few highs and lows. I could tell you that it has been an easy transition, going from an "eat whatever you want when you're hungry" attitude, to changing my eating habits for the better. But this time of year has made my efforts more challenging. Allow me to share some of my most recent experiences. The holidays are filled with family and friends who congregate around the kitchen. We prepare rich buttery meals in large portions. Eating heavily has been a part of my holiday celebrations for as long as I can remember. I have developed a pavlovian response to the changing of seasons. When the air gets colder and the days grow shorter, I can al-

and winter treats I usually enjoy this time of year. I do not view my family's offerings of rich food as malicious or a personal attack on my personal eating restrictions. I understand that holiday eating is a big part of our celebrations. We break bread together with little to no thought of the commitments we've made to ourselves regarding dietary restrictions. For the majority of my life, I have been a willing participant in these rituals. Needless to say, food cravings are a major part of the celebration. You may have to give more personal data to get personal loan

Would you feel comfortable disclosing your bank account information on a personal loan application? What about your work history? Your college

That's what it could take to borrow money from some loan companies that consider alternative data which can be anything that isn't in your credit report when deciding whether to approve your loan applica-

Companies that use the data say it helps them better evaluate applicants by giving them insight beyond a credit report, which usually shows things like your name, address, social security number, and current and past credit accounts.

But some consumer advocates say that while certain types of alternative data can be promising for

consumers, others have the potential to reinforce existing racial and economic disparities and limit access to money for low- and middle-income people.

DOES IT HELP OR

With the consumer's approval, using bank account information like credits and debits which can show responsible financial behavior on a loan application can be positive for those historically underserved by the credit system, savs Chi Chi Wu, an attorney with the National Consumer Law Center, a

consumer advocacy group. But incorporating educational and occupational data in a loan application "replicates existing inequality and it reinforces it," she says.

Wu referenced racial disparities in occupational and educational attainment in testimony she gave to the U.S. House Financial Services Committee about the use of alternative data in credit scoring and under-

A 2018 Bureau of Labor Statistics report shows that 41% of employed white people and 54% of Asian people work in professional or management fields, While 31% of employed Blacks and 22% of Latinos work in those

But Dave Girouard, CEO and co-founder of online lending platform Upstart, which asks for financial information, education and work history on loan applications, says the company works closely with regulators to avoid unfair bias in its application deci-

When tested against a model that uses traditional credit and application information, the combination of alternative data and machine learning that Upstart uses to assess borrowers approved applicants with 620 to 660 credit scores

bad-to-fair scores on the FICO scale about twice as often, according to a post on the Consumer Financial Protection Bureau's website summarizing the test.

Girouard says that while many of the variables Upstart considers in an application decision have a clear connection to an applicant's financials, others are considered because the algorithms the company uses have deemed them relevant to someone's ability to repay.

'Our model wouldn't care about a variable unless it had demonstrated that it's predictive," he says.

DON'T DISCOUNT **YOUR CREDIT SCORE**

Lenders and consumer advocates agree the credit scoring system is imperfect. The Federal Trade Commission reported in 2013 that 1 in 5 Americans had a mistake in at least one of their three credit reports. You can check for errors on your credit reports for free.

Wu says a credit score can also represent an economic advantage or disadvantage that's outside of a person's control.

"In terms of lending without replicating existing disparities, it's hard because even the credit score itself has racial disparities," she says.

a minimum credit score requirement for an unsecured loan, because it's still considered a strong indicator of your financial responsi-

Online lender Earnest requires borrowers have at least a 680-credit score to get a personal loan. But Chief Product Officer David Green says the company also asks applicants to link bank account information to give a more current view of how that person spends and saves.

'(Your credit score) is still a big deal because . it's a very robust dataset and it's an important part

of your financial story," Green says. "I looked at thousands and thousands of credit reports in my first couple years at Earnest, and a lot of times you can tell (the credit score) just is telling the wrong story."

LENDERS NEED **CONSENT**

An increase in the in-But many lenders have trusive nature of the data lenders consider in application decisions should be met with more transparency to the consumer about what's being used, says Brent Adams, senior vice president of policy and communication for the Chicago-based financial research and advocacy nonprofit Woodstock Institute.

> `There's another piece of this which (is) it's inevitable," Adams says. "There's no real point in digging one's heels in and opposing the use of alternative data because it's inevitable."

After a contending run with the Inglewood Sentinels football team, senior quarterback Jared Heywood will take his talents to the University of Rhode Island. He worked hard in order to graduate early while putting up a winning performance on the field.

His efforts at the quarterback position earned him 2019 Pioneer League Player of the Year. Heywood worked in the spring to build trust with the Inglewood offensive players, and the results can be seen in his passes. Heywood hit his targets with ease, completing 154 of his 195 attempts this season.

The three-star athlete made over 400 passing yards during five games and had one game where he racked up over 500 passing yards according to Max-Preps.

This season, Inglewood had a 10-0 run and clinched the Pioneer League title. The Sentinels made a run deep into the Division 13 Southern Section playoffs, coming short in a 41-42 loss against the Esperanza Aztecs in the Semifinals.

got to skip practice, you got to do what you got to do to make sure that your grades are right."

In order to graduate early, Heywood took college courses; learning about journalism, economics and communication.

"I like journalism a lot, I like when we were talking about technology and how journalists use technology to give out their own articles," Heywood said.

"Communications pretty interesting, learning the different types of how you can talk to people."

Heywood's favorite high school class is math; during the fall semester, he was taking precalculus.

"I've been a fan of math for the longest, my dad is good at math," he said. "It kinda just fell on me that math was a subject that I would always love, I've always been pretty good at it."

The teachers and counselors at Inglewood high school has helped him prepare for college by mentoring him through the SAT application process and monitoring his academic performance.

"The support from the teachers and the community of the school has been great," Heywood said. "Nothing but love from the faculty and staff from the school with the athletics side of it but also from the academic side of it."

A hobbie of Heywood's is keeping up with the latest sneakers that come out. Growing up, the Jordan Retro 11 was the shoes that made him a sneaker head. He aspires to get a pair of the Jordan Fragment 1.

'You have to learn how to balance certain stuff," Heywood said. "Balancing football, balancing school has been a challenge, so I haven't really been up to date with the latest shoes because I'm trying to get ready for college."

Williams Aces AP Female Athlete of the Decade Honors

Serena Williams dominated the decade, on the court and in conversation.

There were, to begin with, the dozen Grand Slam single titles - no other woman had more than three over the past 10 seasons - and the 3 1/2 years in a row at No. 1 in the WTA rankings.

And then there was the celebrity status that transcended tennis, making everything she did and said newsworthy, whether it was the triumphs and trophies and fashion statements or the disputes with tournament officials, the magazine covers or the Super Bowl ad with a message about women's power, the birth of her daughter or the health scare that followed.

Still winning matches and reaching Grand Slam finals into her late 30s, still mattering as much as ever, Williams was selected by The Associated Press as the Female Athlete of the Decade on Saturday after a vote by AP member sports editors and AP beat writers.

The AP Male Athlete of the Decade will be announced Sunday.

"When the history books are written, it could be that the great Serena Williams is the greatest athlete of all time. ... I like to call it the 'Serena Superpowers' - that champion's mindset. Irrespective of the adversity and the odds that are facing her, she always believes in herself," said Stacey Allaster, CEO

of the WTA from 2009-15 and now chief executive for professional tennis at the U.S. Tennis Association, which runs the U.S. Open.

"Whether it was health issues; coming back; having a child; almost dying from that - she has endured it all and she is still in championship form," Allaster said. "Her records speak for themselves.'

Gymnast Simone Biles, the 2019 AP Female Athlete of the Year, finished second to Williams in voting for the decade honor, followed by swimmer Katie Ledecky. Two ski racers were next, with Lindsey Vonn finishing fourth and

Mikaela Shiffrin fifth. Three of Williams' five AP Female Athlete of the Year awards came during the last decade, in 2013, 2015 and 2018. She also

won in 2002 and 2009.

"She's been my idol

growing up," Biles said. "She's remained humble. She's stayed true to herself and her character and I think that's really neat about an athlete," Biles said. "Once you start winning, some get cocky, but she's stayed true to herself,

win or lose." It's the defeats that seem to drive Williams, helping propel her to heights rarely reached by any athlete in any sport.

'Whenever I lose, I get more determined, and it gives me something more to work toward," Williams said in a 2013 interview with the AP.

"I don't get complacent, and I realize I need to work harder and I need to do better and I want to do better - or I wouldn't be playing the game."

With a best-in-the-game serve, powerful groundstrokes and relentless court coverage, she has won 23 Grand Slam singles titles, more than anyone else in her sport's professional era, which began in 1968.

More than half came from 2010-19: four at Wimbledon, three apiece at the U.S. Open and Australian Open, two at the French Open. That includes a run of four in a row from the U.S. Open in 2014 through Wimbledon in 2015, her second self-styled "Serena Slam."

Williams also was the runner-up another seven times at major tournaments over the past decade, including four of the seven she's entered since returning to the tour after having a baby in 2017.

In all, she made the final at 19 of the 33 majors she entered during the de-

cade, a nearly 58% rate. The decade began inauspiciously in 2010, when Williams cut her feet on broken glass at a restaurant and was hospitalized with blood clots in her lungs.

Among her many ac-

complishments, though: - reaching at least one Slam final every year, a streak that dates to 2007;

- winning gold medals in singles and doubles (with her sister, Venus) at the 2012 Olympics;

- becoming the oldest woman to win a Grand Slam singles trophy in the professional era;

- becoming the oldest No. 1 in WTA history and equaling Steffi Graf's record for most consecutive weeks atop the rankings;

- leading the tour with 37 singles titles, 11 more than anyone else in the decade.

The day she won Wimbledon in 2016, Williams discussed the way she constantly measures herself.

"I definitely feel like when I lose, I don't feel as good about myself," she said.

"But then I have to, like, remind myself that: 'You are Serena Williams!' You know? Like, 'Are you kidding me?"

Williams continued with a laugh. "And it's those moments that I have to just, like, come off and be like, 'Serena, do you know what you've done? Who you are? What you continue to do, not only in tennis (but also) off the court? Like, you're awesome."

Clemson Drops the Last Haymaker to Advance to Championship

The Ohio State running back made his presence felt, rushing for 177 yards on 18 carries and catching six passes for 54 yards. What is even more impressive is how he gutted it out with an ankle sprain in the first half. He sported a tight wrapped black spat on left ankle for the remainder of the game.

When the Buckeyes look back at the film, a big thing will be their inability to score touchdowns in the red zone in first half that could have made a hole even bigger for the Tigers. The 16-14 halftime lead was not enough to stop the

Tigers comeback.

"I just know when two great teams get together, it comes down to a few plays, and it did again tonight,' said Ohio State coach Ryan Day. "Clemson, give them credit. They have a really good team, and the defending national champs. They do a great job." The Clemson Tigers

LSU defeated No. 4 Oklahoma Sooners 63 - 28 in the other CFP semifinal match up.

FILM REVIEW: 'Les Misérables'

An itchy trigger finger shoots a gun. Someone gets hit and now there's blood on the streets...

Writer/first-time feature director Ladj Ly masterfully pays respect to the most cruelements cop/crime/thrillers. And though, in his first feature film, he respects genre norms he also exceeds expectations, using lively characters and true events from his past to create perceptive day-in-the-life observations. Something like a sociology lesson.

In his world, the unique low-income neighborhood of Montfermeil, just east of Paris, is home. It's the same setting as Victor Hugo's classic novel "Les Mis-

érables" (aka The Wretched Poor). Same place that spawned the 2005 French Riots. Ethnic immigrant groups live in low-income projects and there's a social strata based on skin color, religion, gender, age and

In his story, France wins the World Cup. There's jubilation in the streets. People of all classes and backgrounds celebrate, bringing a group euphoria as they surround the Arc de Triomphe in Paris' tony 8th arrondissement. As the crowd disperses, some head back to the slums of Montfermeil, miles away from city center, where a myriad of struggling immigrants both clash and coexist.

It's the first day on the job for Brigadier Stéphane Ruiz (Damien Bonnard), an

altruistic policeman who has

transferred into the district to be near his son. He's partnered with Chris (Alexis Manenti), a White racist cop who knows the community's lowlife players and Gwada (Djibril Zonga) an

Afro/French officer. The three, an anti-crime squad, patrol the streets. Each has a distinct approach to community relations. The new policeman is a humanist. The bigoted cop favors intimidation and violence. Chris: "Never say sorry." The middle-of-the-road cop, who looks like the citizens they serve, is torn.

Neighbors align within territorial factions and hierarchies: The school-age boys are The Bugs, headed by Issa (Issa Perica). There's the High School Girls. The Gypsies, led by Zorro (Raymond Lopez). The Muslim Brotherhood. And a community leader named The Mayor (Steve Tientcheu). On the streets, they go about their business. Behind that façade, the juvenile delinquents and scheming criminal adults cause problems.

Liaisons between the patrolmen and citizens are fragile. It isn't long before a powder keg of ill feelings explodes, ignited by a cop's blunder. A crisis ensues. The trio panics. Not out of a sense of remorse, more because a drone has filmed their movements.

Ladj Ly, a filmmaker of Mali descent, was raised in the Montfermeil (Seine-Saint-Denis) projects. As he depicts what he saw—clans, rivalries, police malfeasance, kingpins—those memories become a strong foundation for his compelling script (cowritten with Giordano Gederlini and Alexis Manenti). Under his guidance, in the shadows of Paris, with a combustible mixture of struggling ethnic groups, this engrossing urban tale brims with tension, intrigue, anger, violence and retribution. Much of it with a vibrant authenticity.

Ly's stark realism, also exemplified by his documentary-style filmmaking, is fairly evocative for 102 minutes and gives the film a soul. But it's a core that has hairline cracks: Sometimes the lighting (cinematographer Julien Poupard), especially hallway scenes, looks blaring and artificial. The cast's clothes (costume designer Marine Galliano), though modern and hip, look way too new and unworn. Also, there are moments when the pacing lags (editor Flora Volpelière).

Still, the staging, camera angles and composition are consistent. Glimpses of grim buildings, alleys, dingy apartments and police cars draw you into a life on the edge. Ly deftly guides the

adult actors through their paces as they get to say his very astute dialogue in their police banter or exchanges between the locals: "A dog barks. Why can't he bite?"

Damien Bonnard is perfectly cast as the wide-eyed cop shaken by a new assignment that challenges his values. He displays the right blend of innocence, know-how and courage. Alexis Manenti, as a onedimensional rogue cop, is demonic. By the end of the film you want to wrestle his gun away and pistol whip him. Djibril Zonga wears his character's ambivalence on his face.

Steve Tientcheu as The Mayor, an Al Sharpton-type character, knows how to lose his soul on cue. There is something almost biblical about the way he straddles

right and wrong. He's a consummate weasel. Jeanne Balibar as the Police Chief is a stroke of genius casting.

The ensemble of kids are novices. Believable sometimes. Sometimes not. When the boys stage a rebellion, it seems like their anger isn't truly lethal. Issa Perica and Al-Hassan Ly (Ladyj's son) rise above the fray, closer to the level of Fernando Ramos da Silva in the Brazilian film "Pixote."

Someday, when you look up the definition of "cinema-verité" you'll likely see a photo of Ladj Ly and his film "Les Misérables" among the better examples of this ever-evolving filmmaking style.

Lizzo's video at Southern made students feel 'Good as Hell'

As she juggled classes, dance rehearsals, a part-time job and preparations for Southern University's homecoming week, Gaybrielle Dixon squeezed in the time this fall to audition for a music video on campus.

She stood barefoot in a ballroom as the infectious voice of Lizzo echoed around her, singing a nowfamous opening line paired with a piano riff: "I do my hair toss, check my nails." Dixon let her body do what she has trained for since she was 4, improvising a dance and praying that God would give her the right movements and facial expressions to make her stand out.



earworm grow inside of them until they could repeat every refrain of "Baby, how you feeling?"

Lizzo, who grew up mostly in Houston, fell in love with black marching band culture as she played flute in middle and high school, before going on to study classical music and flute at the University of unique style," Guice said.

They reached out to Southern in the fall and university brass agreed, and a week later, Lizzo came to film amid her tour, which included two sold-out shows in New Orleans. Guice and Ferguson visited the Southern campus beforehand, embedding with the band, scouting locations, coordiamazed that someone of her caliber would be able to come to our band room and make a music video." Once she headed to

Baton Rouge, Lizzo's visit wasn't exactly a secret.

"Attention," Lizzo clapped her red-manicured hands outside of a plane in an Oct. 29 Instagram video. "This is how a bad bitch goes from San Francisco to Baton Rouge. You bitches can't even spell Baton Rouge," she laughed, jokingly spelling it in her caption Bat'in Ruch.

Southern posted an invitation the same day for students to join a "major video production featuring a (hash)1 Billboard recording artist." And a blue school bus with Lizzo's name painted across it was parked outside of Southern's campus during homecoming week, where she would later film scenes eating Flamin' Hot Cheetos and twerking alongside saxophone, tuba and trombone players.

But the details of what Lizzo was making - and how prominently some of Southern's students would be featured in it – remained under wraps until the music video dropped Dec. 9. The people making the video hoped to use students, rather than actors, to play the main roles because they wanted it to feel as authentic as possible, Guice said.

During a casting call a few days before Lizzo arrived, the director and producers knew they wanted the video to follow a storyline of women experiencing various hardships breakups, struggles to keep pace with the rest of the band, being the only female on a drumline – and to show "how music can transform you and make you feel good as hell," Guice said.

"We couldn't have cast these kids better if we tried to here in Los Angeles – they were just fantastic," she

Southern's landscape and students became the heart of the music video rather than background props. Lizzo becomes one of them, playing flute as she marches and winks with the marching band in a custom version of their blue uniform with an "L" sequined across the front.

The video opens with a label indicating it takes place at Southern University in Baton Rouge, and it closes with a thank you to the Human Jukebox and Dancing Dolls. In the meantime, the featured students go on journeys of self-love and acceptance, themes Lizzo promotes in her live shows.

Dixon's character begins the video by moping over a photo of a guy - presumably an ex-boyfriend - on her phone, while the rest of the Dancing Dolls are getting into costume. A friend pulls her up, snaps her uniform into place, swipes a makeup brush over her eyes and starts to dance with her in the locker room.

As the video goes on, Dixon is featured repeatedly, arching her back as she leaps through the air, swinging her head as she spins alone in the locker room. Those scenes - just like her audition - came from her freestyling to Lizzo's music, rather than performing given choreography, Dixon

By the end of the video, she and Lizzo exchange nods as they dance alongside each other in formation on the football field. Her exboyfriend becomes old news - as Lizzo puts it, "if he don't love you any more, walk your fine ass out the door." As the Dancing Dolls perform on the field, the ex shoots back a forlorn stare.

While Dixon and other Southern band members who are featured in the video had to take on personas, Human Jukebox drum major Tre'Von Ceasar said the guidance he got was that he simply had to be himself during filming. As drum major for the past three years, Ceasar already had his signature move down pat: the "drum major backbend" of bending over backward until his head touches the grass while keeping his hands at his side.

Taylor, the band director, also said his own role in the music video might have come a bit too easily. He's shown shaking his head at a saxophone player who can't get her steps right.

"I guess it's one of my normal faces," he laughed.

Though it's hard to tell in the music video, the Human Jukebox was playing "Good as Hell" live in the scenes alongside Lizzo in their band room, on the football field and in the stands. Ceasar was a fan of her music - especially her song "Juice" – long before she came to shoot the video, which made meeting her even more exciting for him. He and the others described her as warm and fun, hugging people rather than shaking hands.

"She's really down to Earth," he said. "It was like talking to somebody I would meet in class, but it's Lizzo."

Nobody at Southern knew when the video would be released or what the final product would look like. Most found out it had finally dropped when their friends and family started messaging them on Dec. 9 to congratulate them. They rushed to find the video and watch it on repeat.

Dixon opened Instagram after receiving a flurry of texts and found the video posted everywhere. She said it was an exciting cap to her time at Southern and her three years as a Dancing Doll; she graduated Dec. 13 with an English degree and plans to pursue a career as an actress.

"I go look at it and I'm very excited, but it was also like, 'This is your chance to work even harder to get where you want to be," said Dixon, who grew up in Orlando, Florida.

Ceasar recalled the magic of watching the Human Jukebox back when he was a high schooler in Lake Charles, and how the band's performances made him want to go to Southern. He said he hopes the video's exposure – with over 6 million views on YouTube to date - and Lizzo's embrace of the Human Jukebox will inspire other students to apply to Southern and to join the band as well.

Taylor also expects the video's release to earn the legendary band an especially warm welcome when they perform at the famous Rose Parade on New Year's Day in California.

"They'll know who we are by that video," he said.

She tried to remain calm when she found out that she'd be starring as one of the main characters in the new music video for Lizzo's No. 1 single, "Good as

"I didn't want to lose it in front of them because I had to be like a professional, but afterward, I got in my car and all I could do is scream," said Dixon, 23, who goes by "Gabby."

Dixon and several other Southern students became mini-celebrities overnight thanks to their roles in the music video for Lizzo, who has skyrocketed to fame over the past year with soulful music that crosses pop and hip-hop genres and blends messages of female empowerment with a downto-Earth persona. When she rereleased her 2016 song "Good as Hell" this year, the single topped radio charts and enticed listeners to let an Houston. After years of struggling to find success in the music industry, she's had a breakout year with eight Grammy Award nominations the most of any artist.

The 31-year-old wanted her new "Good as Hell" video to be a love letter to both marching band culture and historically black colleges and universities. 

When I was about three or four-years-old, we lived on Goddard Road, on the north end of Detroit. We had two apple trees and a grapevine in the backyard, and another apple tree in the front.

My father had once told me never to eat the apples that had fallen to the ground because there may be a worm in them. To show me, he picked one up from the ground, so I could actually see a worm hole in it.

One morning, I saw this bright shiny red apple on the ground. I looked it over; didn't see a worm hole; brushed it off, and bit into it, and a big worm slid out of it at me! I screamed and threw the apple down; and ran for my life, because I just knew this worm/snake was coming after me!

I've learned not to make rash decisions when I am exhausted. As in my story about the worm, Elijah was running from someone who was not chasing him – he had only been threatened.

Elijah's successor, named Elisha, said, "Fear not," to his servant on the following account after the massive Syrian army surrounded him (2 Kings: 6:15-17 KJV): "[And when the servant of the man of God was risen early, and gone forth, behold, an host compassed the city both with horses and chariots. And his servant said unto him, Alas, my master! how shall we do? And he answered, Fear not: for they



that be with us are more than they that be with them. And Elisha prayed, and said, Lord, I pray thee, open his eyes, that he may see. And the Lord opened the eyes of the young man; and he saw: and, behold, the mountain was full of horses and chariots of fire round about Elisha.]"

So, open your spiritual eyes and stop worrying! Mark Twain once said, "I am an old man and have known many troubles, but most of them never happened."
