Metro Public Safety Measures are Having a Real Impact

The need to improve public safety on all aspects of the Metro lines has been a major topic of conversation for several months

Several high profile and catastrophic incidents have certainly brought public safety on the city's largest transportation system into the forefront of conversation.

In dealing with these Metro CEO, Stephanie Wiggins has been relentless in ensuring that the organization does everything within its power to create community confidence in riding the Metro system.

"Nothing we are working on is more important than addressing public safety within our Metro System," Wiggins emphasized.

In responding to public safety concerns, Metro has implemented a public safety strategy that focuses on three objectives:

• Increasing the visible presence of uniformed personnel. As Wiggins "We explained, deploying more uniformed personnel throughout the system to deter crime and provide immediate assistance to riders and person-

• Enhancing access control. "We are improving access control to ensure the system is used solely for its intended purpose. By strengthening our security measures, we aim to prevent unauthorized use and maintain a safe environment for everyone," said the Metro CEO.

 Strengthening partnerships to address social issues. "We are continuing to partner with the County, the Cities and Regional Agencies to address social issues such as homelessness, untreated mental illness, and drug addiction. These partnerships are crucial to creating a comprehensive approach to safety," Wiggins noted.

Since implementing this three-phase process,



Metro has strengthened security measures to ensure a safe environment for riders and staff.

Metro has seen significant improvements. The increased visible presence of uniformed personnel has resulted in a decrease in incident reports over the past few weeks. LASD officers participating in the surge did not report any

crimes or arrest in the last week for which data was available, while LAPD reported a sizable increase in trespassing arrest and arrests related to previously issued warrants.

"We appreciate our law enforcement partners continuing to work with us to increase their visible presence on Metro to keep our riders and employees safe," stated Metro officials in a recent memorandum

Metro has also taken several physical improvement steps to address

access throughout all of the Metro stations including elevator access repairs and software updates at the El Monte Bus Station.

Elected Officials Lock Arms to Advocate for Community Hospital Funding

The financial threat facing Martin Luther King, Jr. Community Healthcare has been reduced, thanks to state supplemental funding secured after local elected officials sounded the alarm of a possible closure, which would have negatively impacted residents throughout South L.A. and surrounding neighborhoods.

The hospital's executive leadership along with local elected officials gathered at the MLK Community Hospital on July 5 to celebrate the support that helped secure a commitment of \$25 million in the California state budget signed last month by Governor Gavin Newsom.

Assemblymember Mike Gipson, State Senator Steve Bradford, and Supervisor

Holly Mitchell were recognized for their legislative efforts by health system

CEO Dr. Elaine Batchlor, hospital staff members, doctors and nurses, patients, and community leaders.

The County Board of committed Supervisors

funding in January before Gipson, Bradford and Mitchell advocated at the state level to secure \$25 million in the state budget as a temporary measure. This maintains operations while lawmakers seek a sustainable solution.

Funding ensures the hospital will at least remain open for the current fiscal year; however, the community hospital remains in a vulnerable financial position, facing potential insolvency when bridge funding from state and county sources is depleted.

Dr. Batchlor honored and thanked the three elected officials for their efforts as champions.

Mitchell Abstains from Vote to Create Ballot Measure to Expand

On July 9, the Los Angeles County Board of Supervisors, in a 3-to-2 vote, approved Chair Lindsey Horvath and Supervisor Janice Hahn's motion to put forward a charter amendment on the November 2024 ballot that, if passed by voters will expand the Board to nine members and create a new countywide elected Executive Officer position.

Supervisor Holly J. Mitchell, who authored a 2023 motion with Chair Horvath for governance reform that passed with unanimous support, calling for an independent review of the County's governance structure that would include data-informed recommendations on the number to expand the Board, abstained from voting and provided



the following statement: "I abstained from voting on the motion to present a charter amendment to the public to expand the Board to nine and to create a countywide elected officer position because these sweeping changes were not thoughtfully presented. What we were asked to vote on today lacked a focus on equity and details to support true governance reform.

"When I asked about the

breadth of outreach that led to this motion being presented, there was no proof of true community engagement that included input from Second District residents or residents throughout the County. There was no datainformed reason for why the number nine was chosen for board seats versus any other number. We have no assessment of the fiscal feasibility of these changes being implemented and what it would potentially cost the County; an honest assessment to the voters is paramount. Questions on who will be able to serve on the Governance Committee remain unanswered despite this committee being tasked with ushering in governance reform for the largest County in the nation," said {See MITCHELL

Kamlager-Dove Leads Call for Presidential Medal of Freedom for Rev. James Lawson

Congresswoman Sydnev Kamlager-Dove, alongside 12 other members of Congress, sent a letter to President Joe Biden on Thursday, July 11, urging him to posthumously award the Presidential Medal of Freedom to Rev. James Lawson.

Lawson, a pivotal figure in the civil rights movement and a longtime faith leader in Los Angeles, passed away on June 9, at the age of 95.

The letter to Biden reads as follows:

"Dear President Biden, "We write to respectfully request that you posthumously award Reverend James Lawson, a true icon of the civil rights movement, the Presidential Medal of Freedom. Reverend Lawson's lifelong commitment

to nonviolent activism and his unwavering dedication to social justice have left an indelible mark on American history. As a key strategist and organizer of the civil rights movement, Reverend Lawson played a pivotal role in advancing the cause of equality and justice for all Americans.

"Born in 1928 in Pennsylvania, Reverend Lawson spent his formative years deeply influenced by his family's commitment to social justice. While studying at Baldwin Wallace College, his convictions were shaped by his Christian faith and the teachings of Mahatma Gandhi on nonviolent resistance. Despite being drafted during the Korean War, Lawson declared himself a conscientious objector due to his beliefs against

violence, which led to his

imprisonment.

"This experience solidified his resolve to dedicate his life to social activism, particularly in civil rights. Inspired by the Montgomery Bus Boycott and the leadership of Dr. Martin Luther King Jr., Lawson found his calling in organizing nonviolent protests and training activists in the principles of {See REV. APGA is an 'Ace' In Diversity For Young Golfers

The Advocates Pro Golf Association (APGA) has created a space for more diversity within the game of golf. Founded in 2010, the organization recently held a Pro-Am golf tournament hosted by Emmy, Golden Globe, and Tony Awardwinning entertainer Debbie Allen along with her husband, NBA legend and sports commentator Norm Nixon

When asked why they chose to participate in the event, Nixon said, "I think it's important that our kids have this type of exposure. Many business deals are made on the golf course. But it costs a lot of money to play golf and the youth don't always have access, which are two issues that are extremely difficult to overcome. The APGA provides so many resources to young golfers that are trying to get on the PGA tour through events such as this. I think it's a great organization."

The event took place at the historic Chester Washington Golf Course in Los Angeles, California — one of the first public courses in Southern California to desegregate and allow peo-

ple of all races to play, and a site of advocacy for broader inclusion in golf. Allen, a renowned thespian, choreographer, and director, gave insight into barriers that still have to be overcome in sports that are similar within the arts.

"There are golf courses in this country that don't allow women - so forget Black people or other people of color. Ballet and the world of dance has always been elitist like that. And it's taken many years to break that down with Lauren and Misty Anderson

Copeland becoming prima ballerinas," said Allen.

"It's something that we have to work on, you know, because Black people are the heart and soul of America, that's who we are. So, things still need to change. And with the APGA, this is a great way to do it."

Echoing similar sentiments, Keith Houlemard, CEO of the APGA, told the Sentinel that golf's inaccessibility for many Black and brown youths is steeped in "tradition and circumstance [as well as] a lack of access."

Los Angeles has seen its first decline in homelessness in six years and the

in nine years. The Los Angeles Home-Services Authority (LAHSA) announced the results of the 2024 Homeless

first double-digit decrease

Point-In-Time Count, which hundreds of volunteers conducted across the region in late January of this year. This year's count showed a 17% increase in the amount of people moved off the streets, according to a release from Mayor Karen Bass' office.

Bass declared homelessness an unprecedented emergency in Los Angeles on her first day in office. She has taken swift and active measures to combat this crisis:

 issued an executive order which has "accelerated affordable housing timelines by 75%."

· launched Inside Safe, which "has cleared some of L.A.'s most entrenched tent and RV encampments in every corner of the city."

· spearheaded an "unprecedented effort to keep renters from losing their

· Partnered with the Mayor's Fund for Los Angeles, Children's Law Center of California and The Right-Way Foundation to help L.A. foster youth at-risk for homelessness (announced Monday, July 8).

"For so many years, the count has shown increases in homelessness, and we have all felt that in our neighborhoods. But we leaned into change. And we have changed the trajectory of this crisis and have moved L.A. in a new direction," said Bass.

"There is nothing we cannot do by taking on the status quo, putting politics aside, and rolling up our sleeves to work together. I want to thank the City Council, the County Board of Supervisors, LAHSA, our state, federal and community partners and our service provider partners for locking arms to confront this crisis with the urgency that it requires. This is not the end, it is the beginning – and we will build on this progress, together."

Officials are hopeful, but cautious and vigilant that the root causes of LA's homelessness crisis contin-

ue to persist. The California Housing Partnership's 2024 Housing

Needs Report for Los Ange-

les County stated that nearly 500,000 households do not have access to affordable housing. The report goes on to state that L.A. County renters need to earn \$48.04 per hour, or 2.9 times the City of LA's minimum wage, to afford the \$2,498 average rent of a two-bedroom home.

"This year's Homeless Count results give me hope," stated Dr. Va Lecia Adams Kellum, LAHSA CEO, in a release.

"One year is not enough to say we have turned the corner, but the numbers we are seeing are very encouraging. We must continue to work in collaboration on the life-saving efforts that are contribut-

ing to positive results." And those efforts are paying off with more interim and permanent housing placements as the LAHSA rehousing process is starting to move people more quickly from the streets to interim

housing. From 2022 to

2023, street to interim housing placements through outreach increased by 47% and the number of people moving from interim housing to permanent housing increased by 25%.

Mr. Fascinate: The Bill Nye of STEM

Born on the southside of Chicago, Justin Shaifer science communicator, TV host, producer,


STEM-ambassador, and creator of Fascinate House in L.A. - remembers being asked what made him light up as a kid.

Hampton University on a full ride scholarship as a STEM major. By graduation, Justin was student body president with the highest GPA in the depart-

Despite a full-fledged belief that he was going to become an environmental lawyer, the all-too-familiar

ward and out of Chicago, to that permeates 96% of Black-owned businesses.

> A turning point in Justin's career was deciding to become the Bill Nye of STEM. Colloquially known as Bill Nye, The Science Guy, Nye is a famous American science communicator and hosted the PBS

"Talking about fun science facts", he shared in an exclusive interview with the L.A. Sentinel. "That's what made me light up, but I feel like that voice got drowned out after years on the southside. There was a great sense of community, but not great intellectual opportunities."

While he did not perform exceptionally well in high school, his superb test scores propelled Justin for-

quarter-life crisis rattled his inner-knowing and subsequently pulled him in a different direction: entrepreneurship.

In 2017, he found himself in New York City "totally employable with no job" and decided to bet on himself. Seven years later, his successful business and personal brand thrive, employing multiple people and defying the sole-entrepreneurship pseudo-curse

"My dream was to excite kids about science and tech," Justin explained. Listed as Forbes 30 Under 30 in Education, this dream was easily within reach for

"My first job [as an entrepreneur] was an afterschool science workshop and educational program for middle school kids and high school STEM programs in the Bronx. I had one kid hack into my quiz, and I ended up doing a Ted Talk on 'How to Speak Generation Z' and I told that story. It ended up going viral with half a million views. It was the beginning of my speaking career, and that led me to think of myself as a personality in this STEM space," he said.

This defining moment for his personal brand inspired Justin to hone his speaking talents as science educator "Mr. Fascinate," resulting in over 150 keynote speeches for corporate stakeholders, students, and educations, as well as TV hosting opportunities with multiple networks, including PBS.

While he enjoyed being in front of the camera, he noticed voids that pushed him to move to Los Angeles and create his own media production company, Fascinate Media. His goal was to take control of the narrative and educate in the way he wished he was educated as a younger kid on the southside of Chica-

"When I was working on these other sets, every person behind the camera was white. They even told me to have more 'urban swagger' [onscreen]. There were no Black-owned media production companies in the science field. And that's why you didn't see a lot of Black talent [as STEM communicators]," recalled Justin.

"It trickles down to the Black community and them not knowing a lot about science. In the back of my mind, I knew I needed my own production company."

Justin's company, Fascinate Media, uses "casual, accessible lingo with hightech production" as a metaphorical antidote to this issue by elevating approachability digestibility for the audience.

Some of the topics Justin and his company have broached through speaking opportunities, animated TV, and media include AI and its future in the workforce, winning the war on information through science, phenotypic and genetic explanation for a range of Black characteristics including pigmented skin and curly hair, and myth-debunking. The purpose is to increase the understanding of STEM topics and get more Black kids interested in pursuing STEM careers.

"We have to get more Black folks in STEM. Without early exposure to these topics and terms, [Black kids] find them more intimidating later in life. Our community needs an overhaul with science. We need this literacy, because this is where the power is...some of these massive, trillion-dollar tech companies are more influential than some politicians in D.C.," he insisted.

"Even in the medical field and just looking at postpartum mortality, we don't have enough Black doctors caring for these mothers. We need Black folks in all of these STEM fields, and that starts with this type of education."

Summer Fun! The Samuel Oschin Air and Space Center

Construction is underway to build the Samuel Oschin Air and Space Center (SOASC), the future home of Endeavor, the retired orbiter from NASA's Space Shuttle program and the fifth and final operational Shuttle built.

The center will be a 200,000 square foot addition to the California Science Center's (CSC) main building in Exposition Park and will serve as a launchpad for creativity and innovation.

The Work in Progress gallery features 100 exhibits, including hands-on interactive experiences, digital touch screen interactive displays, accessible bilingual graphic displays in both English and Spanish, and viewable Center construction progress through timelapse imagery.

"This is very exciting," said Lynda Oschin, wife of the late Los Angeles businessman and philanthropist Samuel Oschin, an avid space enthusiast and namesake of the new museum.

"This is my husband's legacy and it's everything he loved. I'm happy and blessed that I was able to do this for him and for everybody," she said.

"Endeavor is the only

shuttle in launch position in the entire world not going into space," she continued.

"We have all four pieces: the shuttle, the two side rocket boosters, and the big orange tank, which is the fuel tank. We got it from NASA and brought it here through the Panama Canal, up the coast past San Diego, and into Marina del Rey. stuff," Terrific explained.

Work in Progress highlights include the SpaceXdonated Crew Dragon

cargo space capsule. The 14 ft-by-12 ft, 28,000 lb. spacecraft completed four crewed missions to the International Space Station (ISS) and was first launched into orbit atop a Falcon 9 rocket in May 2020 as part of the Crew Dragon Demo-2 mission.

"I'm so proud the Dragon capsule is here," said Jessica Jensen, Vice President of Customer Operations and Integration at SpaceX. "The Dragon was designed and built by engineers and operated by technicians right here in Hawthorne!

"Right now, the vehicle looks very charred like a marshmallow on the outside. But inside, it's like 70 or 80 degrees. Very comfortable. I want kids to come here and see it up close," she urged.

The Crew Dragon cargo space capsule was named for "Puff, The Magic Dragon" (the 1963 song by Peter, Paul and Mary), and the Falcon 9 rocket was named after the Millenium Falcon of 'Star Wars' fame.

The Work in Progress gallery contains an interactive video tour of the interior of Endeavour, the Shuttle main engine, a 60 ft. Electron Rocket donated by Rocket Lab—a small orbital-class rocket used to

orbit, and over 80 photodocumenting graphs Endeavour's final flight over California and 12-mile, 68-hour journey through the streets of South LA to the

'Our mission is to stimulate curiosity and inspire science learning in everyone," stated Jeff Rudolph, president and CEO of California Science Center.

'We do it because we think that science is important to understand, and particularly for our young people to be inspired to want to learn more.

"In the works here is a Boeing 747 Jumbo Jet flight simulator experience. That'll be iconic for our community, especially for kids who've never flown on an airplane. They'll learn The Rocket Lab Electron.

what it's like to fly and how it works!" he said.

Guests can investigate the principles of flight and the exploration of the universe in three major galleries-the Samuel Oschin Shuttle Gallery, the Korean Air Aviation Gallery, and the Kent Kresa Space Gallery.

"Admission is free. Everyone is welcome to come here," Rudolph stated. "Tons of people can be a part of this in the future of spaceflight."

improvements at the Willowbrook/Rosa Parks Station. Officials said that these steps will address much of the inappropriate activity that was happening within this facility.

where he was reunited with his sister


A system as large as Metro is not without its faults or flaws, but the effort and focus that Metro has put towards addressing public safety concerns is

Report: Black Californians Remain Top Hate Crime Victims

California Attorney General Rob Bonta released the 2023 Hate Crime in California Report on June 29, providing data resources to support ongoing efforts across the state to combat violence motivated by racial or other biases.

Overall, reported hate crime events in California decreased by 7.1% from 2,120 in 2022 to 1,970 in 2023.

Despite that general downward trend, anti-Black bias incidents in the state remained the most prevalent. Year after year, this disturbing statistic holds true despite a 20.6% decrease from 652 in 2022 to 518 in 2023. The next highest reporting of bias events was 199 Anti-Hispanic or Latino

"The California Department of Justice has a zerotolerance policy when it comes to hate, and will continue working with law enforcement, elected leaders, and community organizations across the state to

keep our communities safe through education, prevention, and enforcement," said Attorney General Robert



Anti-Black bias incidents in the state in remained the most prevalent in 2023.

Bonta in a statement after releasing the report.

"We won't let bigots and bad actors win. We will not let hate prevail," said Bonta.

The report also found that prosecutions inched up by 5% (about 32 percentage

According to the Attorney General's report, from 2022 to 2023, the number of hate crimes referred for prosecution increased from 647 in 2022 to 679 in 2023. Of the 679 hate crimes that were referred for prosecution, 463 cases were filed by district attorneys and elected city attorneys for prosecution. Of the 463 cases that were filed for prosecution, 322 were filed as hate crimes and 141 were filed as unbiased motivated crimes.

Under California law, a hate crime is a criminal act committed in whole or in part because of a victim's actual or perceived disability, gender, nationality, race or ethnicity, religion, sexual orientation, or association with someone with one or more of these characteris-

Aside from the information related to Anti-Black hate crimes, other key findings in the 2023 Hate Crime

- in California Report include: • Hate crimes fell by 7.1% to 1,970 events.
- Hate crime offenses dropped by 8.9% to 2,359.
- · Victims of hate crimes decreased by 6.9% to 2,303.
- · Hate crimes due to racial bias went down by 21.6% to 1,017. · Hate crimes due to reli-
- gious bias rose by 30% to 394. Anti-Islamic bias

events increased from 25%

to 40%. • Hate crimes due to sexual orientation bias went up by 4.1% to 405.

· Anti-transgender bias events rose by 10.2% to 65. • Anti-LGBTQ+ bias events surged by 86.4%.

The disproportionate number of hate incidents recorded in the Attorney General's report lines up with data released by the California Civil Rights Department (CRD).

Responding to a surge in hate crimes and hate incidents, in 2023, Gov. Gavin Newsom's administration launched the "California vs. Hate" initiative, which includes a hotline and online reporting platform for vic-

"CA vs Hate is about recognizing and protecting the incredible diversity of our state and sending a clear message that hate will never be tolerated," said Newsom.

"When California was confronted by an alarming increase in hate, we didn't just sit back and hope it got better," said CRD Director Kevin Kish, celebrating the one-year anniversary of the initiative in May.

"We came together and

launched an array of nationleading programs to ensure all our communities feel welcome and protected. I'm incredibly proud of our state's resilience and commitment to a California for all," added Kish. "This work is only just beginning, but it would not be possible without the advocacy of our community partners and the foresight of our state's Administration and Legislature."

To combat hate crime offenses and events, Bonta urges local partners and law enforcement to review the resources highlighted in the report and to recommit themselves to leveraging them.

"Everyone has a part to play as we continue to fight prejudice and create safer communities in California," said Bonta.

"I urge everyone to review the data resources available and recommit to standing united against hate," he continued. "The California Department of Justice has a zero-tolerance policy when it comes to hate, and will continue working with law enforcement, elected leaders, and community organizations across the state to keep our communities safe through education, prevention and enforcement."

Heat Waves Can Cause Wildfires, Health Problems and Death

It was more than a simple walk in the park for exercisers pacing and jogging around Warner Center Park in the Woodland Hills neighborhood of Los Angeles around midday on July 4.

The weather was "sweltering," according to one of the parkgoers, an African American man in his 40s who asked to remain anonymous.

"Working out around this time is a way hotter experience than a few weeks ago," the man continued, adding that this summer continues to get progressively hotter.

According to weather experts, Californians in the extreme heat any

time soon, which will force people in most areas of the state to find ways to cope and manage it.

National Oceanic and Atmospheric Administration meteorologist David Lawrence said most of the Golden State is experiencing a heat wave, which began at the beginning of the month, and could get worse in mid-July.

"The longevity of this particular event is what I'm most concerned with," he explained. "We will see daytime high temperatures for many interior areas reaching to 100 to 115 degrees each afternoon. Overnight low temperatures won't provide much relief -- only dipping into the 70s and holding into locations."

Lawrence was speaking during a July 2 news briefing focused on the current weather conditions, their dangers, and what Californians need to know to stay safe in the blistering weather this summer.

The online briefing was organized by Listos California, the state's disaster readiness program, and hosted by Ethnic Media Services and California Black Media. State emergency preparedness officials and a frontline responder spoke during the news conference.

California Black Media Executive Director Regina Wilson said heat waves can create dangerous fire conditions and catapult temperatures in inland triple digits.

"This level of heat could pose a danger to the entire population if proper heat safety is not followed," she said. "As we move into the summer season, hotter and drier conditions mean California will likely face higher risk of wildfires — wildfire smoke, heat, power outages and dangerous water conditions."

The same day as the press conference, the Thompson Fire began blazing in Northern California's Butte County. At press time, the wildfire had destroyed 25 structures and injured two firefighters. It has been 55% contained.

The French Fire, which sparked up on July 4 in the town of Mariposa should not expect a break the lower 80s for some areas of the state into the in the Sierra Nevada foothills, covered over 1.3

square miles before firefighters tamed the blaze. That same day, yet another fire, the Sharp fire in Los Angeles's Simi Valley, broke out. It has been 60% contained.

Listos California, the state office in charge of emergency preparedness, has partnered with community groups and offers a resource hub built around an educational campaign to help Californians get ready for disasters related to extreme heat.

Dr. Rita Nguyen, assistant health officer for California and director of population health at the California Department of Public Health, said people underestimate how dangerous heat waves can be.

"Heat waves kills more people directly than any other weather-related hazard," she said. A 69-yearold homeless man in San Jose died on July 3 due the extreme heat.

Nguyen added that the state doesn't have precise data on the number of health emergencies or deaths caused by heatwaves.

She said the people at most risk of experiencing heat-caused health issues include children infants, senior citizens, pregnant people, people working outdoors or indoors without air conditioning, disabled individuals, unhoused persons, and lower-income people.

"Anyone can be a victim of life-threatening heatstroke because a lot of it doesn't have to do with absolute temperature," she explained.

"Sometimes, it can be if folks are not acclimated to hot temperatures and there is a fast rise. When the temperature doesn't cool at night and when it is hot for a long period of time, all these things increase the risk of folks having healthrelated injuries and potential death from heat."

The warning signs of heat illness include confusion, vomiting, passing out, heavy sweating, muscle cramps, weakness, headache, nausea, vomiting, paleness, tiredness, irritability, and dizziness.

Staying hydrated, cool, and informed about the weather forecasts are ways to prevent heat health problems. Nguyen recommended to not drink sugary, caffeinated, or alcoholic drinks, which can dehydrate a person.

California Division of Occupational Safety and Health Program Senior Safety Engineer Charlene Gloriani said, under state law, businesses with employees who work outdoors -- such as agricultural workers -- are required to give plenty of access to free and clean water and shade to prevent heat-related illnesses.

"Shaded areas must not cause exposure to another health or safety hazard," she explained. "When temperatures exceed degrees a buddy system should be in place and employees must be monitored for signs of heat illness. They must also be encouraged to drink water. Cool down rest periods are required every two hours."

Sacramento Fire Department Captain Andrew Ramos noted that people must remember to stay safe while doing activities in waterways such as rivers and lakes when cooling off on hot days.

"We need each and every one of you to be your own safety monitor," Ramos said while suggesting people wear life jackets. "Look and make sure your family members are wearing their life jackets even if they're able to swim."

Patrice Lumumba Answering the Invitation of History: Leadership For Liberation and a Mission of Martyrdom

The real and most meaningful measure of a man and woman is not their capacity to accommodate, adjust to evil, injustice and unfreedom, and find a comfortable place in oppression; rather it is to find themselves in the ranks of resistance regardless of how overwhelming the odds and the balance of forces against them. And Nana Patrice Lumumba, in this his 99th birth year, July 2, 1925, stands firmly and rightly in the ranks of these honored self-giving and self-sacrificing soldiers and servants of our people.

Nana Lumumba, a founding father of the Democratic Republic of the Congo and its first Prime Minister, was a nationalist who worked to build a national unity beyond "tribalism" and factionalism, and narrow notions of class and ethnic interests, becoming a founding member and the leader of the Mouvement National Congolais, the Congolese National Movement (MNC), the party of independence.

He stressed that the vast Congo's wealth belonged to the people and must be regained and used to improve their lives and enhance their future. He was also a dedicated pan-Africanist who constantly consulted Nana Kwame Nkrumah, founding father and President of Ghana, and the paradigmatic pan-Africanist, and argued the indivisibility of African freedom and the indispensability of African unity to harness African human and material resources and direct them toward the liberation, upliftment and development of the people. Also, he stressed the importance of a sankofa retrieval of the best of African values to ground the liberation struggle and build a new society worthy of the name African.

Daring to be truly independent, he incurred the hatred of the Belgian colonialists and other imperialists including the US which

with Belgium fomented and supported a coup against him and assassinated him along with two of his ministers, Nana Joseph Okito, VP of the Senate and Nana Maurice Mpolo, Commander of the Army. African Americans, Africans on the continent and around the world, as well as freedomloving and struggling peoples on every continent, rose up in demonstrations against the brutal act. African Americans demonstrated at the UN outside and inside and interrupted the Security Council meeting February 15, 1961. African American intellectuals and writers spoke and wrote about the meaning of Nana Lumumba to all African people and to African liberation and condemned the US for its CIA participation with Belgians and Congolese betrayers of the liberation struggle.

This reversal of independence and the continuing savage suppression, exploitation and oppression of the Congolese people and robbery of their resources under various guises points back here and offers a lesson on the awesome costs of liberation and the self-giving soldering, sacrifice and service exemplified by Nana Patrice Lumumba in offering his life and death to the people and the liberation struggle.

Thus, when Nana Haji Malcolm condemns the US and Belgium and praises him for his audacious and uncompromising stand, he was expressing ultimate praise and appreciation of Nana Lumumba as both a man and martyr at the time in which the pain of his sacrifice was still present and profoundly felt. He is speaking also of Nana Lumumba as a martyr, who without cowering or compromise, offered his life and death in the liberation struggle of his people. Haji Malcolm's effusive praise of him speaks to the virtues of critical consciousness, moral, emotional and mental courage, and an active commitment to righteous and relentless struggle.

And this is made more evident and important in a

context in which history offers both an invitation to leadership for liberation and a mission of martyrdom given the balance of forces arrayed against him as a liberation leader and against the independence of his people oppressed and in resistance. Haji Malcolm understood this well for he, himself, offered and accepted this dual invitation of history, giving his life and death to the liberation struggle of his people.

To understand appreciate the Congolese liberation struggle, the people's choice of their leader in the liberation struggle and his view of them, the past and the future, it would be valuable to revisit his Independence Speech (translations from the French mine) which was for the imperialists further evidence that, as Nana Lumumba told them in his speech, "We, who have suffered in body and heart from colonial oppression, tell you out loud that from now on, all that is finished."

He begins addressing both "the men and women of the Congo", including all in the liberation struggle, calling them all "combatants for independence who are today victorious" who "have fought relentlessly" and together to achieve this historical moment and victory.

And understanding the importance of memory-keeping, he tells them from the outset that it is a great and sacred achievement in their history that they must remember and "keep unalterably engraved in your hearts," and "teach its significance with pride to your children so that they in turn will relate it to their children and grandchildren the glorious history of our struggle for freedom."

Continuing, Nana Lumumba tells the people of the Congo that although they are to be proud of their achievement and liberation, they must not forget the awesome cost to them and that their independence was not really granted but won through righteous and relentless struggle. He states that in spite of the ceremony for conceding independence on June 30, 1960, "No Congolese worthy of the name can ever forget that it is through struggle that it was won, a daily struggle, a fervent and idealistic struggle, a struggle in which we were not sparing in either our strengths, our deprivations, our suffering or our blood". Moreover, he stated "this struggle which was made of tears, fire and blood, ... was a struggle, noble and just, a struggle indispensable to putting an end to the humiliating enslavement imposed on us by force."

Nana Lumumba, then enumerates some of the forms of brutal injustice, oppression and exploitation imposed on the Congolese people for 80 years that cannot and must not be forgot-

ten. These included forced labor, humiliation and degradation, land seizure, segregation (apartheid) laws and practices, political and religious persecution, mass shootings, tortuous political imprisonment, forced exile, denial of self-governance and freedom, and systemimposed suffering of great and gruesome magnitude.

However, Nana Lumumba understands well that even as we remember, know and honor the past, we must engage and improve the present and imagine and dare to forge a whole new future for our people. He, thus, proposed a Congolese path forward that is linked to pan-African initiatives for the liberation and cooperation of the whole of Africa. He defines it as the beginning of "a new struggle, an aweinspiring struggle that will lead our country to peace, prosperity and greatness."

He calls on the Congolese people to work and struggle together to "establish social justice and ensure that each one receives just remuneration for their work ... to show the world what Black people can do when they work in freedom, ... and to make the Congo a center of radiance for all of Africa."

Furthermore, he tells the people that together they can and will ensure that their richness in resources benefit them and their children; that laws will be revised from their racist forms and new laws will be made that "will be just and noble."

In addition, all the freedoms and rights provided for in the Declaration of Human Rights will be enjoyed by the people, discrimination will be suppressed, and each person will be given "the rightful place that their human dignity, work and dedication to the country deserves."

And finally, he rejects the colonial peace of injustice, imposition and oppression and states that "we will establish not a peace of guns and bayonets, but a peace of the heart and of good will."

He ends with a call to the men, women and children of the Congo for unity, cooperation, sacrifice and service to ensure "the success of this great undertaking," and with a reaffirmation of his commitment to pan-Africanism and an independent and unified Africa. In his last letter to his wife, Nana Pauline Opango Lumumba, Mama wa Taifa (Mother of the Nation), co-combatant and companion in love and struggle, who was among the first members to join and help build the national liberation movement, he reaffirms his commitment to Congolese and African freedom.

He likewise reaffirms his refusal to bend or break under the cruelties and torture inflicted on him, his "unwavering faith" in his people and his country and in their inevitable liberation, and they're boldly writing, along with all other Africans, a new history of Africa and humankind.

Know that these are outward demonstrations and evidence of thoughts previously occurred. You will remember some of the indications of Daniel, some of his prophecies. What did he have that some of us have, and some do not

Some of us have and some of us hold on to it, while others let it go to the



wind. What are we talking about? Do you recall the parable of the sower? How the sower sowed seeds?

Some of the seeds were thrown to the ground. Some of the seeds were thrown into the bushes (so to speak). Some of the seeds were planted with great care and were properly cared for, nurtured, watered in that rich soil and prospered. The mustard seed in particular is profiled biblically. The mustard seed is a little seed, but it grows into a huge plant that birds and others can feast upon.

Do you recall the faith of Daniel? Remember when King Nebuchadnezzar had the most frightening dream in Daniel chapters 2 and 3. It was about time frames of things were to come. None of his "Wise Men" could interpret the dream.

Here is my point. Daniel had been endowed with great divine vision gifts to interpret dreams. The king was enraged that his "sorcerers, diviners and officials" couldn't interpret the dream. Daniel was called and interpreted the dream, which described what things would come to pass, future events, those things which were to happen at the end of days (Daniel 2::28).

Let's ask the question,

"How did Daniel manage to bring forth such dramatic prophecies?" Daniel had been raised in a household that was firm in the faith of Jehovah. Daniel, having been entrenched in the law, the prophets and writings, he did not depart from the

It was that faith which kept him whole. It was that faith that he held on to and would not forsake it. He was greatly rewarded for giving his interpretation of the dream (Daniel 2:48). He was made governor of the whole province of Babylon and chief prefect of the Wise Men of Babylon. The king also appointed Daniel's friends to administer the province of Babylon while Daniel himself was at the king's court.

High positions and promotions and great success brings its other side too. One big one is jealousy. Those around who became knowledgeable of the success set out to damage, persecute and sought the demise of Daniel and the friends. Faith heals.

year everyone said was just too hard. You brought support and funding from the county. You carried a request to the state on our behalf in the face of a budget deficit. And when the state suggested a lower amount, you said, that's not enough," said Batchlor, who described the monetary victory as a hard-fought milestone that could not have been achieved without their support on behalf of MLKCH.

Last month, she coauthored a new federal report exposing little progress towards health care equity titled, "Ending Unequal Treatment: Strategies to Achieve Equitable Health Care and Optimal Health for All," from the National Academy of Medicine stating it is time to turn data into action.

The report found that the nation's current health care

system, by its very design, delivers different outcomes for different populations and is highly influenced by external societal forces inextricably linked to disparate individual and population outcomes. According to Batchlor,

the United States must renew its commitment to ending health care inequity and specifically to eliminating the structural obstacles to care than many disadvantaged communities still face.

"The recommendations in unequal treatment address how we can achieve healthcare equity across the nation. They carry a sense of urgency. I want you to know we feel that urgency in our work here at MLKCH in South LA. Our hospital is not at the finish line. We have critical work ahead to ensure that MLKCH will survive and thrive. Now we have the support to give us

{Continued from A-1} confidence," she concluded.

In November 2023, the Los Angeles County Board of Supervisors passed Mitchell's motion directing the County's Chief Executive Office (CEO) and the Department of Health Services to identify options to help financially stabilize MLKCH's operations. The CEO identified various relief options that would have no net County cost, including using unallocated Measure B funding.

In January, the Board of Supervisors unanimously approved a motion authored by Mitchell that invested a total of \$20 million dollars of Los Angeles County's unallocated Measure B funding over the next four years to help support the hospital's operational needs. The motion authorized the County's Department of Health Services to allocate \$8 million in one-time Measure B

funding to be released to MLKCH and an additional \$4 million up until the fiscal year 2026-2027.

Mitchell, being the first African American to serve as chair of the Senate Budget and Fiscal Review Committee, persuaded her former colleagues in the state's legislature on the hospital's importance and critical need for fiscal stability.

"We have not talked enough about this hospital's future. The future is also recognizing the new players who have come on the scene and are locking arms," she said while being honored.

"It's a new generation of people in positions of power and authority that we have to bring into the fold to honor and recognize the history. We are going to work to introduce them to the amazing work [MLKCH] is doing every day so they can continue to lock arms with me, my colleagues and former colleagues in the legislature to make sure the future is as

bright as the past that brought us here.'

MLKCH serves a patient population that faces disproportionately high chronic illness and unmet needs. Before it was built, the County projected that the MLKCH emergency room would receive roughly 25,000 to 30,000 visits a year. Last year alone, the hospital had 100,000 emergency room visits.

MLKCH reported that nearly all the patients visiting the emergency room are covered by Medi-Cal, but current Medi-Cal rates do not compensate the hospital for the actual cost of care. The hospital estimates that it will run out of funding in December 2024 and is seeking other state and federal funding options.

The hospital continues to meet the high demand with excellence in service. MLKCH has earned a rare 5star rating from the Centers for Medicare and Medicaid Services, for two years in a

row and recently earned an "A' from Leapfrog - an independent national non-profit that measures quality and patient safety.

The funding for MLKCH was also contained in SB 108 (Wiener), one of the state's budget bills. The Director of Finance can increase funding for the Martin Luther King Jr. Community Hospital by up to \$25 million, including federal matching funds, if the Legislature passes a law allowing it. Any increase must be approved 30 days after notifying the Joint Legislative Budget Committee.

Critical work is ongoing by legislators and leaders to ensure a more permanent solution for the hospital's future. Legislative supporters continued to point out that the process for structural changes is a marathon, not a sprint suggesting more work is needed to close the funding methodology loophole required to sustain the hospital for future generations.



Pastor James Thomas Marks 5th Anniversary at Holy Revival Church

On July 13, the Rev. James Thomas, Sr. will celebrate his fifth anniversary as pastor of Holy Revival Baptist Church in Compton – a momentous occasion that God prepared him for decades in advance.

Interestingly, Thomas insists, "I never even wanted to be a pastor," but clearly God had other plans for him, and it all started with his longtime membership at Academy Cathedral Church in Inglewood where he lent his talents to several areas.

"I was there for 42 years and did everything at Academy - from cleaning the church to preaching on Sundays and I never knew that God was preparing me to be a pastor," recalled Thomas.

And then in 2013, the Spirit of the Lord directed him to start a telephone prayer line. Thomas called it the 7 A.M. Prayer Movement.

"God said, 'I want you to be on the line, and

pray and minister to people seven days a week. So, I have ministered to people all over the country, and even outside the country every day since October 2013," he said.

Thomas remembered that many members of the faith community, particularly preachers, were not supportive of him launching the 7 A.M. Prayer Movement and even questioned Thomas' motives in starting the phone ministry.

"A lot of people said that God wasn't in it and God didn't call me to do that. Others said that I was keeping people out of the church. But then, when the pandemic hit [in 2020] and the churches were closed, I had preachers calling to ask me, 'How do you do this thing over the phone that you're doing?'

"But, God knew the pandemic was coming, and he prepared me, so when the pandemic came, I had been ministering by phone doing it for six years. People trusted me and supported my ministry," noted the pastor.

Also, the year before in 2019, Thomas had reluctantly accepted the pastoral position at Holy Revival even though he had said, "I wasn't interested in being a pastor." But his name was submitted to the congregation, and he was overwhelmingly voted in. As the spiritual leader, Thomas focused on rebuilding Holy Revival.

"The church was in in desperate need of repair. God blessed us to raise over \$20,000 during the pandemic to do the repairs. People just listened online and on the 7 A.M. Prayer Movement, and they gave. I don't know how we could have

trated that," he declared. As pastor, one of Thomas' major emphases is on building "men and women

using the Word of God." He is also determined to improve the lives of people in the community through Holy Revival's outreach programs like their Food Ministry where groceries are distributed every week.

Because his church is located in a Black and Latino neighborhood, he added a Tuesday morning bilingual service in addition to the Sunday worship service at 11 a.m. He said that his goal is for "Holy Revival to be known as the church that changed Compton."

"I would like the Holy Revival to be known for making a difference by serving Black people, Mexican people, and white people, and that people's lives are changing because they are connected to Holy Revival," said the pastor.

As for the future, Pastor Thomas has several initiatives planned to include opening a shelter for women and operating a school to train youth and adults to be productive members of society. He also hopes to expand the church's food ministry to aid more people in L.A. County.

In preparation to achieve these goals, the pastor will be guided by his favorite scripture -Romans 8:28 – "And we know that all things work together for good to them that love God, to them who are the called according to his purpose."

"I feel like God has placed me in Compton to make a huge difference," he said. "We're not a mega-church, but we want to do mega-things and help everybody."



Hate Crimes Can – and do – Have Long-Lasting Negative Impacts on Mental Health

With July recognized as National Minority Mental Health Awareness Month. Kaiser Permanente is raising awareness about mental health issues facing underrepresented groups, including the Black community, and the importance of seeking timely treatment when needed.



Racially based traumatic stress inflicts significant psychological and emotional harm on many within the Black community.

"The tragic death of George Floyd drew attention to the pervasive and lasting impact of racial-based traumatic stress on the mental, emotional and physical wellbeing of individuals in the Black community," said Chidi Njoku, director of Psychiatry and Addiction Medicine at Kaiser Permanente South Bay Medical Center.

According to Njoku, racially based traumatic stress inflicts significant psychological and emotional harm on many within the Black community. Constant exposure to racially based discrimination and other dysfunctional behaviors

motivated by unconscious bias creates a chronic state of vigilance and hypervigilance. This prolonged stress can lead to anxiety disorders, depression, post-traumatic stress disorder (PTSD) and other mental health challenges. The burden of constantly navigating racially charged environments can take a severe toll on the overall well-being of individuals and communities.

The impact of racial trauma extends beyond mental and emotional health, Njoku noted. Research demonstrates a correlation between experiences of racial discrimination and various physical health problems, including hypertension, cardiovascular disease and overall diminished physical health. The constant strain on the mind and body resulting from racial-based traumatic stress contributes to health disparities and reduced quality of life within

the Black community. According to PEW Charitable Trusts, racism is a contributor to a public health crisis. It noted Black women are up to four times more likely to die of pregnancy-related complications than White women. Black men are more than twice as likely to be killed by police as white men. The average life expectancy of Black Americans is four years lower than the rest of the

U.S. population. "It is our social responsibility to pay attention to the impact of racial-based traumatic stress," Njoku said.

"The path to healing begins with acknowledging the existence of racial trauma and providing safe spaces for individuals to share their experiences. Culturally sensitive mental health services tailored to address racial trauma are crucial for promoting healing and resilience. Additionally, implementing systemic changes such as addressing institutional racism and promoting inclusivity can help prevent future racial trauma.'

It's important to seek help when facing mental health challenges - including those caused by racial trauma, Njoku said. If left untreated, these symptoms can worsen and cause severe problems to your overall health. A lack of trust or belief in mental health has historically been a barrier to people in the Black community. In response to this reality there has been significant work to increase access to providers that represent that community and raise cultural sensitivity of providers that are not of the Black community so as to create more inclusive spaces for those in need of treatment.

Knowing when to seek help

Njoku encourages members of the Black community to seek help if they're experiencing any of the Race-Based Trauma symptoms at a level that's affecting their ability to be effective in their life. These include work or school performance not going well. When it comes to mental health, individuals should prioritize themselves and not listen to the stigmas or any other detractors that would discourage them from getting needed support.

"If you're too anxious or depressed to advocate for yourself, it's okay to lean on someone you trust for support to get the help you Njoku noted. "Remember: As scary as it may feel, one of the most courageous things you can do is take the time to invest in yourself by seeking



Jean-Paul is the world record holder for the men's high jump T13 after his 2.17m performance in the Para Athletics Championships in 2017.

"I broke the world record not once, not twice, but three times at one event. at the Paralympic World Championships," he said.

The men's high jump T13 will not be in the 2024 Paris Games: Sean-Paul will be focusing on the long jump T13 and the 100m

In the 2020 Tokyo

games, Jean-Paul competed in the men's long jump T13 and the men's 100m T13. He earned a bronze medal in the long jump.

"In the midst of competing, I actually threw my goggles in the crowd out of frustration because everything was going wrong," Jean-Paul said. "With the grace of God at my very last jump, I was able to win the bronze medal by two centimeters."

The Paralympic Trials take place in Miramar. Florida from July 18-20. Jean-Paul has been training with West Los Angeles College track and field coach Tim Bowman to prepare.

"I think training with him is going to change a lot of things," Jean-Paul said. "I'm not saying what he can do for me as an athlete because I feel like everything is already there but bringing out a different part of me, teaching me different things."

After his historic run in the Para Athletics Championships in 2017. Jean-Paul learned about and started attending the Angel City Games. Growing up, Jean-Paul never met a para-athlete. By competing in track at The Games, he became a role model to the younger participants.

"Prior to this event, I

always as an athlete, I aspire to be like Michael Jordan, Kobe Bryant," Jean-Paul said. "When I was able to jump at Angel City Games, I became the Michael Jordan, the Kobe Bryant for them."


venue. The Sparks, founded in Year trophies, two Coach of the Year honors, and defining moments such as the first dunk in WNBA history by Lisa Leslie.



During his time overseas, Smith wrote a blog about his experiences. He also got a chance to interact with youth in different

"We had to do certain events and different things," Smith said. "It's given me more perspective on things."

Along with having basketball-related pictures, his "Coloring with book Craig" features motivational phrases and advice for youth. Smith added his tips to also help youth improve their reading skills.

"We all have something special within us we just have to find it!" Smith stated. "It's been awesome creating this book to help kids tap into their creativity."
