"We call it inclusion camp because it's for kids with special needs so, you're going to see kids here who are on the autism spectrum," said Areva Martin, Esq., founder, president and CEO of Special Needs Network, Inc.

"You may see kids with cerebral palsy and other disabilities, what we call sometimes, invisible disabilities, but you're also going to see a lot of their typical peers, so it's a great environment for learning."

Martin and the Special Needs Network recently celebrated their 15th annual Joe Patton Academy Camp (Camp JPAC) opening on the grounds of the former St. Agnes Catholic Church and School on Vermont Avenue and Adams Blvd. Expecting over 200 youth, the special event kicked off the dynamic and inclusive summer camp experience for children with special needs for the next four weeks.

"It's a place for kids to be

pushed to be able to excel at their own level, they're still being held just like a normal camp would be held," said JPAC Camp Director Phillip Pridemore.

"We have all ages, all disabilities, all parts of the spectrum."

The opening day featured a fun and engaging schedule of activities including a pep rally, performances, giveaways, and a parent orientation session. The event featured music provided by JD the DJ with a live drumming performance from Victoria Djembe, an appearance from Bailey, the L.A. Kings Mascot, and the L.A. Kings Promo Team.

"Kids with autism developmental disabilities are isolated, they're segregated, so you may go to a camp or a facility and they don't have an opportunity to integrate with and to interact with their typical peers, that was really important to us," said Martin.

"How do people learn how to get along with other folks with disabilities unless

Park Service Marks 80th Anniversary of Port Chicago Explosion That Killed 202 Black Sailors

in 1999. Meeks died at the age of 83 in Los Angeles.

The National Park Service (NPS) is set to commemorate the 80th anniversary of the Port Chicago explosion, a tragic event that claimed the lives of 202 Black sailors. The incident occurred on July 17, 1944, in Contra Costa County, when 4,606 tons of ammunition being loaded unto two U.S. Navy cargo ships detonated, instantly killing 320 men on site and injuring another 390 workers.

injuring another 390 workers. On July 20, the National Park Service (NPS) in collaboration with Friends of Port Chicago National Memorial band, the U.S. Army's 834th Transportation Battalion, will host the commemoration at the Military Ocean Terminal Concord (MOTCO) in Concord.

According to organizers, the event provides an opportunity for friends, family, journalists and others interested in the history of the disaster to honor the memory of the victims and shed light on the largest mutiny trial in U.S. naval history.

Smallwood-Cuevas Announces \$3.85M Grant to **Combat Youth Homelessness**

Senator Lola Smallwood-Cuevas (D-Los Angeles) announced on July 12 that the City of Los Angeles in her 28th District has been awarded a \$3.85 million grant aimed at addressing and preventing youth homelessness.

The Family Homelessness Challenge Grant, administered by the California Department of Housing and Community Development, is part of a statewide effort to provide housing

and supportive services to vulnerable youth as they transition into adulthood.

"No young person should have to face the harsh realities of becoming homeless," said Senator Smallwood-Cuevas. "With this grant, our city can provide critical services and vital resources that help our vouth transition to more stable and brighter futures. I'm proud of this work being done in our district, and I'm committed to advocating for services that will better protect our populations who are greatest at risk."

Through the grant, supportive services will be provided to youth who have identified themselves as experiencing homelessness, involved in the state's foster care or probation system, or have identified as LGBTQIA+. Services offered include housing support, wraparound case management, financial literacy, education and employment assistance, and financial assistance.

The Family Homelessness Challenge Grants Program provides competitive grants and technical assistance to local jurisdictions to promote rapid innovation and expand promising practices to create scalable solutions that can be shared across the state to address and ultimately end family homelessness.

Smallwood Cuevas represents the 28th Senate District, which includes the communities of South Los Angeles, Culver City, West Los Angeles, Century City and Downtown Los Angeles.

Election Propositions Cover Slavery Ban, Minimum Wage and More

The general election on Nov. 5 is less than four months away.

This year, Californians will vote yes or no on 10 propositions that have qualified for the ballot covering a range of issues from raising the minimum wage to amending the state constitution to ban involuntary servitude as punishment for

Five of those measures were placed on the ballot by the Legislature and five of them qualified through the initiative process.

Here's a list of the 10 measures Californians will be voting on in November with an overview of what each one is proposing.

Prop 2 – Issue \$10 billion in bonds to fund construction and modernization of public education facilities across the state.

• \$8.5 billion would go to elementary and secondary schools. The remaining \$1.5 billion would go to community colleges. CSU or UC systems would be excluded from the funding. To qualify for funding, the measure would require school districts to write a 5 year facilities school mas-

Prop 3 - Repeals Proposition 8 and establishes a right to marry.


• This would remove the ban on same-sex marriage from the California Constitution. The ban was added by voters in 2008. However, the United States Supreme Court has blocked the enforcement of the ban since 2013. The amendment would remove the original language in the constitution and change it to "The right to marry is a fundamental right."

Prop 4 – Issues \$10 billion in bonds to fund state and local parks, environmental protection projects, water infrastructure projects, energy projects, and flood protection projects.

• \$3.8 billion would help pay to improve drinking water systems and prepare for droughts and floods. \$1.5 billion would go to programs preparing for wildfires and \$1.2 billion would go to programs combating the rise of the sea level. The remaining funds would be divided up among parks and outdoor recreation programs and climate initiatives.

Prop 5 – Lowers the threshold from 66.67% to 55% for local bond measures to fund housing projects and public infrastructure.

rently bans involuntary servitude, or forced labor, except as a punishment for crime. It is common for people who are incarcerated to be required to work



• This would change the state constitution to make it easier for local governments to borrow money if they use the funds to build affordable housing or public infrastructure. Local governments, excluding school districts, currently need two-thirds of voters to approve before they can borrow funds.

Prop 6 - Removes involuntary servitude as punishment for a crime from the state constitution.

• This would change the California Constitution to ban forced labor in any form. The constitution curand earn less than \$1 an

Prop 32 – Increases minimum wage to \$18 an

• This would increase California's minimum wage to \$18 per hour. It is currently \$16 per hour for most people and \$20 per hour for fast food workers. Health care workers will eventually see their minimum wage reach \$25 per hour, according to a law Gov. Gavin Newsom signed last year.

Prop 33 - Repeals Costa Hawkins Rental **Housing Act.**

• This would repeal a state law prohibiting cities and counties from capping rents on single-family homes, condominiums and apartments built after 1995 in an effort to address the state's homelessness prob-

Prop 34 - Requires health care providers to spend 98% of revenues from federal discount prescription drug program on direct patient

· This would permanently allow California's Medicaid program to pay pharmacies directly for prescription drugs. California started doing this in 2019 after Gov. Newsom signed an executive order allowing the payments. This measure would make it state law. The measure would also mandate that healthcare providers spend almost all the money they get from a federal prescription drug program directly on patient care.

Prop 35 – Permanently authorizes a tax on managed care organizations to fund Medi-Cal programs.

• This would make the state pay doctors more money for treating patients

who are covered by Medicaid. Managed care organizations contract with the state to provide these health benefits. The state taxes will help pay for the Medicaid program. This measure would require the state to use a portion of that tax money to increase how much Medicaid pays doc-

Prop 36 - Increase drug crime and theft penalties and allow a new class of crime to be called treatment-mandated felony, which gives the offender the option to participate in drug and mental health treatment.

• This would make the crime of shoplifting a felony for repeat offenders and increase penalties for some drug charges, including the death penalty if someone dies as a result of the convicted person's actions. It also increases penalties for trafficking involving the synthetic opioid fentanyl. The measure would give judges the authority to order those with multiple drug charges to get treatment and to sentence people convicted of trafficking drugs to state prison rather than county

Housing Insecurity Makes Black Californians Face **Higher Rates of Psychological Distress**

A study on disparities revealed that Black people in California experiencing

unstable housing are more University of California likely to struggle with mental health at a higher rate, stated a report by the Center for Health Policy Research (CHPR) at the mental health challenges,

Los Angeles. The report details problems associated with housing insecurity and related stating that 45% of people with unstable housing experienced psychological distress including depression and anxiety.

However, only 22% of

adults with housing issues used mental health care to help manage the stress. People of color experienced the highest rates of housing insecurity, the majority of whom reported that they often worry about paying their rents or mortgages.

A total of 5.2 million people described their housing situation as unstable. Consequently, 26% of Black Californians reported that they faced housing insecurity, 44% higher than the national average. The study attributed this crisis to decades of redlining, a system of discrimination that denied people financial services including mortgages and insurance loans based on race and ethnicity.

Sean Tan, a co-author of the study and senior public administration analyst for the research center said that the state's housing crisis has become a public health concern.

"Our study reinforces what research has demonstrated for years: Access to affordable housing affects a person's health," said Tan, regarding the state's housing crisis. "It also spotlights the critical need for more affordable housing in California."

The lack of affordable housing across the state has disproportionately impacted Black people. In California, approximately 43% of Black adults reported that they often worry about being able to pay their rent or mortgage.

Joelle Wolstein, a CHPR research scientist and co-author of the study, said housing insecurity has a ripple effect that goes beyond finances and worsens existing disparities.

"Housing is the largest regular expense for the vast majority of people, so it follows that people who typically have lower wages and fewer assets would have more unstable housing and worry more about paying their bills," said Wolstein.

The CHPR study provided various recommendations for California lawmakers, including investments in creating and preserving affordable housing, connecting mental health services with housing resources, and enacting inclusive housing assistance policies.



A School Grows in Watts



After eight years in the making, "A School Grows in Watts" documentary premiered on Sunday, June 30, at the Dances with Films Festival at the TCL Chinese Theatres in Hollywood. The film is a South Central story that is unapologetically Black and Brown with a focus on tance of the learning center's lasting impact.

Now with over 800 students and alumni, The Watts Learning Center is an innovative charter elementary school fighting for a reimagined future through a community-based approach to education with the help of educators, residents, non-profit organizations, community leaders, and families.

community building through education via The Watts Learning Center.

Founders Eugene and Sandra Fisher, producers Baron Davis, O'shea Luja, Brandon Salaam-Bailey, and director Ryan Porush, dedicated nearly a decade to highlighting the perseverance and meaningful work while documenting the often-forgotten history of the Watts community.

Special guest and revered member of the U.S. House of Representatives, Maxine Waters, announced the film's premiere at the festival. Her strong introduction reminded the audience of the disparities in education for young Black students and the impor-

From 1905-1950, Watts was the cultural mecca for music, art, history and tradition. The 2.1 square mile area has birthed many famous figures like Ed Sanders. Kevin Young. Florence Griffith Joyner aka Flo-Jo, Tyrese Gibson and many more. Watts was its own city from 1907-1926 and was annexed with Los Angeles because local government feared a fully functioning Black city, resulting in Watts becoming disenfranchised by redlining, the crack epidemic, lack of resources, and the rise of gang culture.

Eugene Fisher was hired to conduct a research study to uncover the discrepancies in public edu-

his wife Sandra saw the opportunity to revive Watts with honor through proper education and resources, turning a concept into reality.

In 1997, the learning center opened its doors with two students, one administrator, and one principal. Fisher believes in developing academic excellence in more ways than one. Creating a pathway that would provide additional services like childcare, safety, and food, while building and maintaining trust in the commu-

These would be key factors in the success of the charter school with a focus and commitment to its stu-

dents. The results of the community-led educational space helped address the needs of children and their parents and were directly reflected in the documen-

Porush explained, "I love being a documentarian, trust is a necessary part of my job. I was profiling the Watts Learning Center and then at some point my vision grew to the community, and that dictated the course of the journey where I'm not only coming into the school space, but now the community space.

"Having the knowledge and the context of the history of Watts and taking ques from O'shea as my producing partner on the film as I continued to learn. We explore and debunk some of those misconceptions about South Central with the hopes that we can also do that for charter schools, they are not just binary concepts. The film was built with those themes in mind," said Porush.

The film follows the stories of young children and how their parents' maneuver living in Watts while attending the learning center. Each story is dynamically beautiful in their own way; Marlon is a high achieving student who lives with his grandmother as his mother is in prison; Alma is a single mother of two working to move out of their one-bedroom apartment while still showing up for daughters as they navigate their classes. Each story magnifies the highlights and the challenges in the everchanging neighborhood.

Fisher believes the power of purpose is within



when facing adversity. "when we use our hearts and our minds, and use them effectively for good cause, we can solve our problems. If there is nothing wrong with the children, then there must be something wrong with the system. With adequate resources and commitment and a mission to succeed and recognize that a community needs a community.

"When we work together everything we want can be accomplished and not to depend on anyone else to do it. The realization is we can chart our own destiny and develop solutions to the problem: we plan, and we implement the plan to see results. When you care vou do something."

Producer O'shea Luja aka Mr. Food4Thought, is a Watts historian, educator and poet who remained in the city to continue the conversation surrounding the city's greatness. Luja developed an anthology/ manuscript of discussions about art and culture to archive the duality Watts provides and now pro-

When asked about his hopes for the documentary, he shared "I really hope that many of the misconceptions associated with

Watts will be dispelled. We are a diverse community that loves each other. Community, by definition, is those of like minds, we are of like minds. One of my teachers, the legendary Watts Prophet Father Amde, once said 'there is nothing more beautiful than a functioning ebony community' and that's exactly what Watts is."

"My hopes for the young people in the documentary will go on and do great things and then we will continue to have more stories and morph these narratives so the world can truly see what we've known all along. This documentary shows we're competing despite all odds, we're standing even with no legs, and we're going to continue to share these stories even when our voices leave us."

"A School Grows in Watts" is genuine, profound, and inspiring.

Jalen Blot: All About Love

Love, both platonic and romantic, has fueled the most classic pieces of art, regardless of the mediumliterature, paintings, choreography, symphonies, soundtracks and films. L.A.-based filmmaker Jalen Blot finds himself heavily drawn to the virtue of love and the questions it stirs within himself as a writer and director.

"My hope is to uncover love in ways we don't always think about. How can I dissect love in a way that isn't traditional and teaches me something?



"What does it look like for two Black men to express platonic love on screen? What does it look like to love a parent that has hurt you? To love someone you're not allowed to love?," he questioned.

Much of his curiosity within writing derives from his mother. She originally

wanted to become a journalist but decided to become a nurse to provide for her fam-

"She's from Port-au-Prince, Haiti, and my culture is very rich in music and orating. I grew up in a home of many women, and I was always hearing stories," recalled Blot.

In 2016, Jalen learned a significant lesson in the power of writing and storysharing after posting his positive experience with therapy — particularly as a Black man — on Facebook.

"People were in the comments writing and sharing their experiences. I saw the power of writing, and I realized I wanted to do whatever it took to get people to share their stories," he said. This was the same year he vowed to move to Los Angeles to pursue a career in the film industry, all predicated upon whether Barry Jenkin's "Moonlight" won the Oscar for best picture.

As most people remember, that was the night of an egregious mix-up — "La-laland" initially won the award. While the team was onstage to accept the Oscar, the correct envelope was handed over and clarified that "Moonlight," in fact, had won. A man of his word, Jalen began to prepare for a cross-country move.

Since moving to L.A., Blot has created his best work to date while still having ideas germinating in preproduction. In 2019, his short film "Colors of Sanfoka" was an official selection of the 2019 Pan African Film Festival and a semifinalist in the AT&T SHAPE

competition. Within the last few years, he has completed multiple short films including "Vows," which focused on a vow-writer who excelled at love on paper but struggled in real life, and "Everything We Left Unsaid," which is a threepart series of the short films "Why We Try," "Why We Lie," and "Why We Love."

"My creative process doesn't happen in one way, but it does start with a question: 'what would it look like if," he explained. This phrase reliably propels Blot to create highly unique stories and settings. Currently in pre-production is a romcom short film born from the question: what would it look like if two 70-year-olds fell in love at a funeral?

As of summer 2024, Blot is also embarking upon a fellowship as a director within Issa Rae's company, Color Creative. With these new opportunities ahead, he is looking forward to creating stories that deeply resonate.

"My goal is to show Black and Brown people that they can do anything they set their mind to," he

DHCS: California Health Care Roadmap Will Make Medi-Cal More Accessible, Member-Driven

Although California reached its lowest uninsured rate in state history in 2022, many Californians still do not have access to timely, quality and affordable health care.

This disparity disproportionally affects Black Californians and other peofrom underserved groups, particularly lowincome individuals.

Public Health authorities say this racial gap contributes to higher rates of illness and premature death.

Services (DHCS) report. "For example, the life expectancy at birth for African American Californians is five years shorter than the state average and the lowest life expectancy of all racial and ethnic groups," the report contin-

Dr. Pamela Riley, chief health equity officer and assistant deputy director of Quality and Population Health Management at DHCS, said the disparities should not exist.

'Who you are and where you live should not determine whether you live

of race, ethnicity, where you live, age, gender, language, sexuality, income, citizenship, has a right to compassionate and comprehensive care that meets their physical and behavioral health needs," said Riley, who was speaking at a virtual press conference hosted by Ethnic Media Services (EMS) organized to inform the public about Medi-Cal's efforts to better meet the health needs of more Californians.

Over the last decade, DHCS has taken several steps to eliminate this problem including expanding Medi-Cal access to all low-income Californians, regardless of immigration status; eliminating the

iCal eligibility; expanding language access so members can receive interpretation services; and creating new community supports that provide culturally responsive and more customized care, including housing aid, nutritious meals, and substance abuse treatment.

Riley said to create meaningful change and foster genuine trust with Medi-Cal members, DHCS must work directly with members and trusted messengers particularly in Black and Indigenous communities of color who have not been historically underserved by the healthcare system.

DCHS' multi-year ini-

only income is considered The first, which concluded member feedback listening tour that began in November of 2023. It consisted of 11 virtual and in person listening sessions with members across the state that were facilitated by Medi-Cal community partners in a variety of health care fields. These tours were focused in areas of the state most impacted by health disparities including rural areas and communities with a high concentration of minorities

Overviews of all the sessions are documented on the DHCS website.

The second and current phase of the health equity initiative is a codesign phase working directly with members and com-

munity-based organizations to ensure that voices are heard and considered in identifying solutions that impact care that people need. DHCS is identifying partners to help implement the information gathered during statewide tour.

The final phase is the Health and Equity Roadmap. This report, which is scheduled to be released next year, will outline steps to reach mutual goals compiled in the first two phases to achieve a more equitable healthcare system in the state.




Amy Tatum Can Transform Your Skin

At the end of 2023, Amy decided to become a full-time entrepreneur for her business. While she did enjoy the stability and surety of being an employee, there was a lack of connection she felt with her clients through rules and policies enforced by larger corpora-

"Sometimes we had 10 minutes between clients and had to sell products. I

felt very rushed and stressed. Really, I felt like a salesperson," she recalled.

Black Being Supports Black Mental and Physical Health

According to the Depression and Bipolar Support Alliance (DBSA), Black adults are 20% more likely to experience severe mental health issues. The 2016 National Healthcare

Alli's older sister unfortunately passed away causing Ali to become incredibly numb. She felt sensations in her chest that she described as "clouded." At that moment, she only wanted to be alone because everything around her felt so chaotic.

Quality and Disparities Report stated, "Those who are from racial and ethnic minority groups are less likely to receive behavioral health services."

Economic factors, such as the increase in the cost of living, lack of insurance, transportation, and much more all play a major role in reducing the chances of Blacks receiving affordable, quality healthcare.

With the health discrepancies affecting the Black community in big numbers, it is refreshing to know that there are resources that can help mitigate the stress of not having access to affordable healthcare.

One resource is Being Black, a nonprofit wellbeing studio in downtown Inglewood. Formally founded in 2019 as South LA Wellness, Black Being encourages physical, mental and emotional wellbeing, through practices and programs anchored in culture and ancestral wisdoms. Founder and Executive Director Allison "Alli" Simon is a certified yoga and meditation facilitator and a fifth generation Angeleno from South Central L.A.

Alli grew up near 124th and San Pedro. Her family hails from Watts, California. In the 1990s, her stepfather was killed due to gun violence, so her mother moved her family out of Los Angeles to the Central Valley until she graduated high school.

She would visit the park often and lie down with nature; this was her meditation for a while. She started attending yoga afterwards. She recalls what she describes as her chest sinking into her mat and beginning to sob. She said that yoga started showing up in a way she did not expect it to. For that moment, it would take her mind off of what she was feeling. It brought her into the "reality of life."

After her many years of practicing yoga, she pondered what it would look like for people to have access to a consistent space, find silence, connect to their breath and be in the present moment. As an L.A. native, she knows what it feels like to live in a city where there is constant noise, sirens, helicopters and many other distractions. Over time, this can contribute to an immense

amount of stress. "Where do you find a moment of silence?" she asked. She says that initially in South Central L.A., yoga and meditation was not something that was transpiring.

"This community has so much trauma, that's not just an individual creating that for themselves, but there are structures that are in place that are keeping things the way that they are. It's not that folks don't want healing or don't want to be better or don't want to

find other options, but there

aren't very many places or opportunities for people to really find those things," she emphasized.

"Think about my mom who talks about the community growing up in South Central was such a vibrant beautiful way of living where people came together, and they supported one another. It just stuck with me. It reminded me like, you've got to do something. You've got to be a part of something."

The goal is to remedy the lack of representation and reflection of the Black experience in the wellbeing community. Alli has created a space that is accessible to the local community where people can prioritize their health and wellness. Those who utilize their services can also surround themselves with people who believe that wellness is a right for all of us.

"In more affluent communities, we see an abunwellness dance of resources and studios," she emphasized.

"In Black and Brown communities we see far less, which communicates that wellness is a luxury rather than a necessity."

When you walk into Black Being, you may see familiar faces or you may not know anyone, but once vou complete a class, you will feel like it is a second home. The owner chose the Inglewood area as "home" because it is a central part of the Black community. Alli hopes that the studio will touch various parts of the South L.A. area.

Black Being offers free and sliding scale classes, workshops, and events led by local teachers. It provides community care programs for parents, the LGBTQ community, older adults, and people with limited mobility, and offers a variety of daily and monthly classes and workshops. Classes include Energetic Yoga Flow (Movement), Balance + Mobility (Movement), Rest + Restore Yoga (Movement), Candlelit Yin Yoga (Movement), Virtual Meditations, and much more.

The studio consists of a group of dedicated and passionate individuals who ensure that things flow smoothly for guests, including Alli, Director of Strategic Development London Jones, Studio Coordinator, Jade Smith. and front desk Administrator, Parrish Justin.



The Liberation Psychology of Nana Frantz Fanon: Struggle as Normative and Necessary

As the country and the world experiences and resists the rise and expansion of rightist forces and their attempts to limit and deny freedom and justice, the seminal works of Nana Frantz Fanon come into sharp focus. Especially relevant here is his treatment of the psychology of liberation as both normative and necessary in the context of oppression and his insightful analysis on overcoming what he defines as "the pathology of freedom."

I read this as the pathology of unfreedom or the pathology of oppression which is a disease imposed on freedom and therefore creating a diseased and disabled freedom, i.e., a pathology of freedom. Here then in these dangerous, difficult and demanding times, I revisit the insights of Nana Fanon's liberation psychology and what I read as his insistence that the only reliable remedy for this pathology of oppression is liberational resistance.

To have read Nana Frantz Fanon (1925-1961) in the original French or the translated English, especially "The Wretched of the Earth," and to grasp and embrace his understanding of armed struggle; decipher and find useful concepts in his discussion of the interrelatedness of national consciousness, culture and struggle; uphold his commitment to the masses; and take up his challenge to create a new history of humankind and a new man and woman; was for the advocates of Us and other organizations in the Black Liberation Movement of the 60s a central set of criteria for revolutionary consciousness and commitment.

In this the month of his coming-into-being, 20th, we are especially reminded of the complex richness and current relevance of Nana Fanon's thought, but also its contribution, along with other key African activist-intellectuals, to the grounding and development of our own philosophy, Kawaida.

Fanon was born in Mar-

tinique, did his academic work for his doctorate in psychiatry in France and his professional work in Algeria, joined the Algerian Revolution, served as ambassador to Ghana for the Provisional Revolutionary Government, and traveled throughout Africa representing and building support for the Algerian Revolution and the consolidation of pan-Africanism as a real and revolutionary practice.

He wrote extensively on his experience and understanding of colonialism, crystallizing and summing up many of his most important observations and findings in his world-renowned masterpiece, "The Wretched of the Earth."

The ethical grounding of his social psychiatric theory and therapy is in a moral anthropology, a conception of the human person, in which human freedom, agency and struggle are normative and necessary and indispensable to the health, wholeness, and flourishing of persons and peoples. Within this critical understanding, he asserts as a fundamental proposition of his liberation psychology that psychopathology, the sickness of the psyche, is essentially "a pathology of freedom," i.e., a socially generated problem, as well as a behavioral and organic one, rooted in oppression and unfreedom. A pathology of freedom speaks to the denial and the deforming and destructive limitation on human freedom and therefore, on human agency central to self-understanding and self-assertion in the world.

A psychiatrist and revolutionary, Fanon challenges and discredits the notion that a person can be isolated and understood apart from his/her social context. And he argues that the conditions of oppression affect both a person's and a people's conscious and unconscious thought and practice.

Here, he evolves a second fundamental proposition that oppression, in this case colonialism, has a "totalitarian character," and involves not just the conquest and occupation of lands, but also the lives of the people "settling at the very center of the

individual" and engaging in "a sustained work" of depersonalization, deculturalization and dehumanization of the dominated people.

He speaks of a "sustained work of clean up or expulsion of self. of rationally pursued mutilation" of the African self and sense of self. Continuing, he says, "There is no occupation of territory, on the one hand, and independence of persons on the other. It is the country as a whole, its history, its daily pulsation that are contested, disfigured, in the hope of a final destruction". Indeed, he says, "under these conditions, the individual's (very) breathing is an observed, and an occupied breathing.'

Thirdly, Fanon argues that the colonized or oppressed person who is thus victimized and without the cultural resources or personal will to resist goes through several states of psychic debilitation and disintegration which I read as: including self-doubt, self-denial, self-condemnation and selfmutilation. Thus, he says, "Having judged, condemned and abandoned his cultural forms, his language, his food habits, his sexual behavior, his way of sitting down, of resting, of laughing, of enjoying himself, oppressed flings himself upon the imposed culture with the desperation of a drowning man."

This person engages in shameless apish imitation of the dominant order, seeks security in submission and self-erasure in a series of dignity-diminishing and realitydenying ways, i.e., from individual acceptance fantasies to post-racial illusions eventually becoming what Fanon calls an "obscene caricature of Europe."

Fourthly, Fanon asserts that at the heart of the prospects for rehabilitation and recovery is the concept and practice of agency, i.e., the ability and will to act in liberating and liberated ways. as this is translated in Kawaida philosophy. Therefore, he calls for both a collective responsibility of the people and a personal responsibility of each person in liberating herself and himself in the process of liberating the whole people. In a word, he says, "an authentic national liberation exists only in the precise degree to which the individual has irreversibly

begun his own liberation."

Finally, Fanon taught us the indispensability of transformative struggle on varied levels - armed, political and cultural. For Fanon, struggle is curative and transformative, empowering and liberating in a personal and social sense. It is in struggle that the people heal, renew and empower themselves by destroying the conditions of their disorientation and oppression.

And he maintains, as we did in the Sixties, that these various battlefields form an interrelated and reciprocal, overarching field of struggle. Indeed, given the totalitarian character of oppression and its commitment to domination, deprivation and degradation on every level. Nana Fanon says, "the poverty of the people, national oppression and the inhibition of culture are one and the same thing.'

Thus, the aim of the struggle is not only political, the freeing of the country, but equally important, cultural, the freeing of each person's consciousness from the ravages and restraints of colonization and oppression. In a word, the struggle is to realize "not only the disappearance of colonialism, but also the disappearance of the colonized man (and woman)." Moreover, Fanon says to create a "national consciousness is the most elaborate form of culture."

Thus, the people "gather together the various indispensable elements necessary

for the creation of a culture, those elements which can give it credibility, validity, life and creative power." It is a culture which "ordain(s) the struggle for freedom," affirms the best ideas and interests of the people and humanity and expands in and through this transformative struggle.

Nana Fanon ends where he begins, calling for a new world, a new man and woman, and a new history of humankind. This, he maintains, requires a multidimensional struggle which stresses the centrality of the masses in their own liberation, and their grounding in their own culture, which is refreshed, renewed and expanded in struggle.

And it is for him, a struggle directed toward ending the psychopathology and socio-pathology of oppression and toward advancing ourselves, humanity and history a step further and bringing the world to a whole 'nother new and different level of human freedom, flourishing and possibilities in and for the world.

PBM Reform Is A Crucial Step Towards Health Equity for Underserved Communities

At the Arming Minorities Against Addiction & Disease (AMAAD) Institute, we are deeply committed to advocating for the health and well-being of underserved communities everywhere, particularly our LGBTQ+ and African American communities.

As we work to address health disparities, we see the significant barriers that opaque Pharmacy Benefit Manager (PBM) practices create for patients seeking affordable, life-saving medications.

At the forefront of this important fight is Representative Nanette Barragán of California. We extend our heartfelt gratitude for her tireless work in pushing for PBM reform. Her efforts are crucial in addressing health equity and ensuring that the African American community and other underrepresented communities she serves has access to necessary medications and lifesaving therapies.

PBMs, initially intended to manage prescription drug programs and reduce costs, have evolved into powerful entities that control 80% of the market. This control enables them to significantly influence drug pricing and access to the detriment of underserved communities whose main challenge has been related to access.

Over the last decade, the share of PBM profits from fees charged to manufacturers, pharmacies, health insurers, and employers has increased by more than 300%. Additionally, fees that PBMs charge biopharmaceutical companies in the commercial market have doubled over the past five years, growing from \$3.8 billion in 2018 to \$7.6 billion in 2022.

These increases in fees highlight a particularly troubling trend: PBMs have been allowed to game the healthcare system to generate more profits, often at the expense of patients, employers, and

ties throughout our country.

Representative Barragán understands that health equity cannot be achieved without addressing these systemic issues. It's one of the primary reasons we've previously named her our 2023 AMAAD Champion of Health Equity. Her consistent advocacy for PBM reform has been a critical step towards ensuring that all patients, regardless of their background, socioeconomic status, and identity, can

afford the medications they need. By pushing for greater transparency and accountability in the PBM industry, she is fighting to eliminate the practices that hinder access to essential treat-

We urge Congress to enact PBM reform to stop the manipulation of our health system and instead prioritize the health and well-being of patients everywhere. It is time for Congress to act decisively to implement reforms that will create a fairer, more transparent pharmaceutical landscape. This includes regulating the fees that PBMs can charge, ensuring fair reimbursement practices for pharmacies, and promoting competition to drive down drug prices for the communities we represent.

For too long, PBMs have operated with little oversight, allowing them to maximize profits while patients struggle with rising costs and limited access to care. Reforming this system is not just a policy issue; it is a moral imperative that will help bridge the gap in health disparities affecting African American, LGBTQIA+ and other underserved communities.

ragán's continued leadership in this fight is vital. Her efforts represent a beacon of hope for those who have been marginalized by the current system. We call on her and her colleagues in Congress to push forward with meaningful PBM reform legislation that will protect patients and ensure that pharmacists can continue to serve their communities effectively.

The time for action is now. Underserved communities everywhere are watching. And historic reform can take place to ensure adequate access to life saving medications and therapies for all. Reform efforts can create a healthcare system that truly serves the needs of all Americans. The AMAAD Institute stands ready to support these efforts and will continue to advocate for policies that ensure affordable, accessible, and transparent healthcare for all.

I made a conscious decision to stop and think about what that person may be going through or the constitution of their personality. Then the principle that Stephen Covey often speaks of came to my mind - that we should first, "seek to understand, then to



be understood."

This thought restored the joy that I had lost in that moment. I realized the relationship was worth me stepping back and not letting my feelings destroy something bigger.

There are many benefits of trying to see something from the perspective of others. I personally feel that it helps us to take our eyes off ourselves and focus on the needs of others. Most of the time people do not mean to be rude or dismissive, they just feel like what they have

to say is important.

There are different ways to work with personalities that have these characteristics. Listening and seeking to understand them can help build and improve communication. When we are calm and in control, we can work on solving the issue, improve communication, and build up the relationship.

Remember I previously mentioned that I did not want to let my feelings destroy something bigger? That something bigger was the relationship. Think about how important the relationship is to you and evaluate is it worth winning the battle or the war. For me, especially if it is with family, friends, or close associates, I would rather for us to come out stronger in the end even if it means I must bite my tongue a bit.

Another thing to consider is put yourself in the shoes of the person you are dealing with. They may have insecurities that God

has placed you in their life to help build them up and help them become a better person. All of us at one time or another have needed people to be patient with us and sow into our lives in a positive way.

If we are not able to take this type of response or action, it may be that we need to look into the mirror and see if we are doing the same things to others. It has been said what ruffles our feathers the most tends to be the very same things we need to work on in our own lives. Is it time for us to look in the mirror?

Years ago, I remember a counselor telling me that someone must be willing to take the first step, or sacrifice for the bigger good and why should it not be me. At the time that bothered me because first. I was much younger and immature, but I thought, "why does it always have to be me?"

What time and life have taught me is that usually

when we stop and really listen to others, they just need to be heard and when they realize you care about them and you respect what they have to say, they will listen to you and consider your point of view. Trust will begin to be built between the two of and it can be a winwin situation

The next time you are in a conversation with someone, or in a meeting and they talk over you for some reason or just fail to listen to what you have to say, smile to yourself and understand they need to be heard and for you to understand them. You will eventually be understood, and they will probably pay more attention to what you have to say in the future.

Becoming a homeowner, it's the American dream for most, but for some, especially people of color, it can be elusive.

According to a 2021 UCLA report, Afro-Latinos have lower homeownership rates compared to other groups, 40.6% for Afro-Latinos versus 54% for non-Black Latinos, those who do own have higher home values than non-Black Latinos and the U.S. population overall — \$210,000 versus \$200,000.

Wells Fargo is out to

change those numbers by educating people of color through their Advancing Homeownership Fair on Saturday, July 20, from 10 a.m. to 1 p.m., at Santa Ana College, located at 1520 W. 17th St. in Santa Ana.

According to a recent report by the National Association of Realtors, despite fast-rising mortgage rates, minority increased homeownership rates in 2022. Among Asians (63.3%) and Hispanics (51.1%), homeownership rates registered at all-time highs. homeownership rate experienced a modest uptick to 44.1%, but remains substantially lower than Asian, Hispanic and White (72.3%) Americans.

"Homeownership provides families stability and an opportunity to build generational wealth," said Esparza-Chavez. She shared some of the issues that block potential homeowners from realizing their dreams.

"Don't assume that myths about purchasing a home are true," said Esparza-Chavez. "You don't necessarily need a high downpayment or perfect credit to make your homeownership dreams a reality. Many lenders have programs that are aimed at assisting low- and moderateincome buyers. Educate yourself and ask questions to explore your options."

In August 2023, Wells Fargo launched its Homebuyer Access grants that provides \$10,000 to be applied toward the down payment for eligible homebuyers, who currently live in or are purchasing homes in certain underserved communities in eight metropolitan areas.

"This offering under the SPCP adds another key component to Wells Fargo's efforts to help drive economic growth, sustainable homeownership, and neighborhood stability in minority communities," said Esparza-Chavez.



Third Baptist Church of San Francisco, says he continues to seek justice for the men who died in the blast and survivors who later were accused of rebellion.

"It was nothing but another instance of forces in America being perpetrators of hate, harm, and hardship of Black folks," Brown said of tragedy and the injustice that followed. These Black men who died in that blowup several miles from San Francisco should never be forgotten."

Jake Sloan, an Oakland resident with extensive knowledge of San Francisco Bay shipyards that attracted many African American men from the South seeking employment during the World War II, attended the 75th commemoration of Port Chicago at MOTCO.

Sloan, the author of "Standing Tall: Willie Long vs. U.S. Government at Mare Island Naval Shipyard," said standing on the grounds where the explosion occurred

was a surreal feeling.

"It was quite an event. It was exciting in a way and sad in another way," Sloan told California Black Media (CBM) of his experience at the monument site. "I actually walked through the site in addition to attending the ceremony. If you're an African American, and if you know the story, you can almost feel it."

Located 35 miles northeast of San Francisco, the Port Chicago pier was built in 1942 and expanded within two years to accommodate space for the loading of naval cargo ships.

According to the Naval History and Heritage Command (NNHC), around 10:18 p.m., a "seismic shock wave" that started at Port Chicago shook the entire San Francisco Bay and "was felt as far away as Boulder City, Nevada. The explosion was so powerful that it decimated both ships, sent debris flying for miles over the Suisun

Bay, and left a large crater in

place of the pier.

Brown also said the African American sailors were unfairly blamed for the explosion, which was later determined to have been an accident likely caused by unsafe working conditions and lack of proper training.

What ensued after the explosion highlighted the racial disparities in the Navy's policies at the time.

"In the aftermath, surviving sailors were ordered to resume the same dangerous tasks without any changes to safety protocols," NPS described on its webpage dedicated to Port Chicago Naval Magazine, which was converted into a National Memorial Park.

"On Aug. 9, 1944, 258 African American sailors refused to work, leading to 50 being charged with mutiny."

The men were dishonorably discharged for refusing to follow a racially motivated order to clear debris from the area and retrieve sailors' appendages, many of them who were the survivors' friends and fellow servicemembers. White officers were given hardship and time off following the accident.

U.S. Representatives John Garamendi (D-CA-08) and Mark DeSaulnier (D-CA-10) have been working to seek justice for victims and their families.

"The Port Chicago 50 were ordered to their deaths in the summer of 1944, nearly four years before President Truman signed the executive order formally banning racial segregation in the American military," Garamendi said in 2023.

"Now, almost eight decades later and even after President Clinton's 1999 pardon for Freddie Meeks, the families of the Port Chicago 50 convicted for mutinying against an order that should never have been given are

still waiting for justice." The court hearings and trials were conducted at Treasure Island Naval Base

in San Francisco and Mare Island Naval Shipyard in Vallejo.

In an Aug. 24, 1980 interview for the University of California Berkeley's Port Chicago Oral History Project, Meeks said it was reported that the explosion was a "sabotage" mission. He countered that argument, saying that some of the bombs were handled "lackadaisically" by the soldiers. Many of the bombs had to be rolled on and off the ships, causing them to bump against each other if the sailors on the other end didn't adequately retrieve them, Meeks said from his perspective.

On Feb. 23, 2023, Garamendi, DeSaulnier and U.S. 12), presented a House Resolution recognizing the victims of the Port Chicago explosion and the clearing the court martial charges against the African American sailors. "These 50 courageous

sailors have suffered the impact of racial discrimination throughout their service in World War II, and their names have been tainted for 73 years," Lee said in a February 2023 statement. "In today's political cli-

mate, we must come together against discrimination and inequality. It is imperative that we rectify this wrongdoing and bring justice to those sailors who made great sacrifices for our nation."



Tarell Alvin McCraney Brings 'The Brothers Size' to Geffen Playhouse

"The Brothers Size," is a contemporary stage play that blends West African mythology with music, dance and poetry. Set in the Louisiana bayou, it is the tale of two brothers, Ogun and Oshoosi Size.

Ogun is the hardworking and stable older brother, while his younger brother, Oshoosi, is a recently released convict. Oshoosi is trying to rediscover himself as a free man, but his journey is complicated by the appearance of his old prison mate, Elegba.


"The Brothers Size" is written by the Oscar awardwinning screenwriter of the film "Moonlight," Tarell Alvin McCraney, who is also the co-creator of the fondly received OWN drama TV series "David Makes Man."

With a rising number of television and film credits, McCraney's entertainment roots began in the theatre, and he is the current artistic director of the Geffen Playhouse.

In fact, "The Brothers Size," will be the first production of the Geffen's upcoming season and the play is scheduled to run Aug. 14 through Sept. 8.

McCraney said although he was raised as a Baptist Christian, he was exposed to many different cultural understandings, which are rooted in his Afro Caribbean background. It is an identity and experience he said is common with many people from his hometown of Miami, Florida.

"I learned it in music. I learned it in dance, and

parades... and seeing voodoo and Santeria ceremonies as a young person," said McCraney.

"You learned everything that we were taught had some other context to it had some other nuance to it, so you never took things at face value."

McCraney said "The Brothers Size," is the first play he wrote as an adult 20 years ago. He described it as a combination of his culturally rich childhood experiences with his later training as a student of multiple disciplines in the

performing arts.

which was this hybridity of these older West African stories being presented through a more contemporary lens," said McCraney.

McCraney said even in his film and television work you will see those African West and Caribbean influences in the content he creates. "All those references are alive in my work," he said.

"The Brothers Size" covers themes of self-discovery, brotherhood and family.

believes McCraney people can be biologically born into families, but they can also choose their families. Either way, he said those relationships should be nourishing and when they stop being nutritious, they may evolve into something else.

"It doesn't mean that folks have to disconnect," said McCraney. "It just may mean they are not engaged in each other, anymore. In 'The Brothers Size,' I think these are three men who will always be bound together."

He continued, "In the Yoruba tradition, Ogun, Oshoosi and Elegba come to you together. They are three warriors, and in this

story of these three men named after these three ancestors - they'll always be connected."

Ogun, Oshoosi and Elegba are an alliance of three warriors in Yoruba folklore. They all live together as brothers and a team. Strength through unity is an overarching message behind the tale.

"This is a play about an archetype – about how big does your brother need to be," said McCraney. "I'm the big brother of four. I have [two little brothers], who are both bigger than me, and there's something about that I've always been thinking about."

"How big do I need to be to be your brother? How strong do I need to be? What size of a brother do I need to be in order to maintain you, and literally to protect you from harm," he continued. "I had to get bigger to do that and I had to make more capacity in my heart, my mind, and in my spirit to do that."

Elaine also remembered Howard professors constantly reminding students about the school's historic and cultural importance, she took her classes very seriously.

"I loved being at an HBCU. I loved learning about the craft and learning about myself as an artist with Black folks," said

She said it was challenging but also rewarding. "It gives me a certain pride and responsibility," said Elaine.

Subsequently, Elaine has appeared in many stage productions, including two of her favorites "Clyde's" and "Sweat."

In addition to her work on stage, Elaine also appeared in the period drama TV show "The Underground." Elaine cowrites, produces and stars in a YouTube web series called "Cast Me Dammit," which centers around a Black actress struggling to

find work. When it comes to "Clue," Elaine reminisced back to seeing the 1985 film and loving it. "I remembered seeing that movie over and over again," she said.

"I hadn't really known there was a board game until like 2013, and I played it with my in-laws in L.A., and I had absolutely no idea what I was doing," Elaine shared. "I still don't know how to play that game."

Elaine said she auditioned for a 2022 Alley Theatre production of "Clue," but that production was cancelled due to the coronavirus pandemic. "When they were producing it again, they [the producers] asked me to do the role," said Elaine.

Elaine is in love with "Clue," because she finds the play ridiculously funny.

Nickolas is currently ranked the highest American athlete in the sport and second overall in the world for the 176pound weight class. Additionally, Nickolas is the only American ranked in


