President Biden drops out of 2024 race and endorses VP Kamala Harris for President

On July 21, President Joe Biden announced in a letter posted on social media that he is ending his candidacy for a second term and throwing his support behind Vice President, Kamala Harris.

"It has been the greatest honor of my life to serve as your President. And while it has been my intention to seek reelection, I believe it is in the best interest of my party and the country for me to stand down and to focus solely on fulfilling my duties as President for the remainder of my term," Biden, 81, addressed the nation in a statement.

Shortly after Biden's announcement, political and civil leaders from across California reacted to the President's decision.

Gov. Gavin Newsom hailed Biden's leadership as President.

"President Biden has been an extraordinary, history-making president — a leader who has fought hard for working people and delivered astonishing results for all Americans," Newsom said. "He will go down in history as one of the most impactful and selfless presidents."

Lori Wilson, the chairperson for the California Legislative Black Caucus (CLBC), released a statement wishing Biden well and endorsing Vice President Kamala Harris as Biden's democratic nominee successor.

"As chair of the California Legislative Black Caucus, I would like to express our gratitude to President Biden and thank him for his many years of service and support of policies uplifting

Antonio Villaraigosa Running for California Governor

Former Los Angeles Mayor Antonio Villaraigosa launched his campaign for governor of California this week to succeed current governor Gavin Newsom, who cannot seek another term due to term limits.

Building on his record of results as a civil rights and labor leader, Speaker of the California State Assembly, and Mayor of Los Angeles, Villaraigosa touts his experience as a "proven problem solver who will focus on balancing the budget, make sure neighborhoods are safe and kids have great schools, and bring down costs so California is more affordable for families and seniors."

Raised by a single mom East Los Angeles, Villaraigosa experienced domestic violence as a young child and dropped out of high school. With the support of his mother and teachers, he re-enrolled in high school and took night classes to graduate, then attended community college and

Summit Highlights Challenges and Triumphs of Black Immigrants in L.A.

The recently concluded 5th Immigration Summit held on July 11-12 at the Los Angeles Trade-Technical College provided a critical platform for addressing the unique challenges and triumphs of Black immigrants within the broader Black American community.

Hosted in the heart of the city, the summit attracted a diverse array of participants including policymakers, community leaders, advocates and immigrants themselves, all united by a common goal: to foster understanding and devise solutions for the multifaceted issues faced by Black immigrants.

Mayor Karen Bass, an advocate for immigrant

rights, provided insight into the work being done from Los Angeles during a fireside chat. Part of her discussion emphasized the importance of unity and solidarity with the immigrant community, regardless of place of origin.

"One area that we need to work on statewide is that in the same way that we fought over the years for undocumented people to have access to healthcare and education, regardless of what was happening in DC, we need to do the same thing around housing because we can move people into interim housing and we can pay for that, but we can't move them into permanent housing because then we get into federal programs," said Bass

L.A. Care Provides 1,500 Free Backpacks to School Kids

L.A. Care Health Plan will provide up to 1,500 free backpacks to school kids on Thursday, Aug. 1, from 9 a.m. to 1 p.m., for its annual Back-to-School event at its Metro L.A. Community Resource Center (CRC), 1233 S. Western Ave. near Pico Boulevard. The new backpacks are filled with basic supplies like notebooks, pens and pencils to help better prepare students for a successful school year.

"As a health plan that understands the link between social needs and overall health and wellbeing," said L.A. Care CEO John Baackes, "we are thrilled to provide backpacks and essential school supplies to countless families who continue to feel the pinch from the ever-growing cost of living. When students are better prepared for school, they are more confident and more likely to succeed, and that's a big win for everyone."

L.A. Care collects data from its members to track and assess a community's health needs and leverages that data to communicate with their regular resource

center visitors about the communities they live in. The CRC also looks at community health needs assessments conducted by the County Department of Public Health and local hospitals.

"We want children across L.A. County to have the tools they need for a successful school year," stated Penny Griego, media

relations specialist at L.A. Care Health Plan.

"Something as simple as a backpack and a few school supplies to start a school year can give students the confidence they need to have a much better learning experience.

"For some families, especially those with multiple children, the cost of a backpack and school supplies can place a serious financial challenge on the family, and we would like to help relieve them of that burden," she said.

L.A. Care operates its CRCs with Blue Shield of California Promise. The community healthcare partners are in the process of giving away up to 18,000 backpacks this summer at their annual Back-to-School events that began on July 2 and will continue through August 17. There are 16 events scheduled across Los Angeles County, which are free and open to the entire community.

"This year marks five years of our collaboration with L.A. Care to improve health and social outcomes through our 12 community resource centers across L.A. County," said Jennifer Schirmer, Blue Shield Promise vice president of Growth.

"We're proud of the impact we're making, like offering fitness classes, mental health workshops, food pantries and resource

fairs to local communities, including our holiday resource fairs where we connect families to local social services. Our L.A. Care and Blue Shield

Promise CRCs are an inclusive and safe space where community members can gather to improve their physical and mental well-being," she stated.

Families can enjoy activities at the Metro L.A. event on August 1 and learn about community resources, like children's health screenings and vaccinations. The event is a cost-saving resource for many families who struggle to make ends meet due to the high cost of consumer goods.

"We expect to distribute 1,500 backpacks at the Metro L.A. event on August 1 and approximately 18,000 backpacks at our events across the county by August 17," Griego concluded.

People's Garden in Compton Hosts National Women in Agriculture Conference

The National Women in Agriculture Association teaches local residents how to eradicate food desert issues and increase the number of Black farmers.

"The count for minority farmers, specifically women farmers and women of color, is low," said Dr. Tammy Steele. "If there are no farmers, there is no food."

Steele is the founder and director of the National Women in Agriculture (NWIAA). Association Founded in 2008 and based in Oklahoma City, Oklahoma, NWIAA is one of the largest non-profit organizations for Black women in agriculture globally and features a wide range of programs catered to youth, young women, veterans and people with disabilities, among others. The organization comprises approximately 45,000 members across its 70 national and 14 international chapters.

The NWIAA recently held the "National Women

in Agriculture," a two-day conference at the People's Garden in Compton to highlight agriculture techniques and financial grants for farmers and eliminate food deserts.

farmers, activists and allies gathered to discuss minority agriculture and the sustainable life skill opportunities for at-risk youth that other

groups have been receiving for over 100 years.

Steele wanted to bring the initiative and the opportunities to Compton, a community known to face challenges that could be A diverse coalition of solved with agricultural opportunities made available with proper funding. The conference highlighted the challenges faced by Black women in agriculture, promoted equity and inclusion within the agricultural sector and sought support for NWIAA to become the first Black congressionally chartered nonprofit in the U.S.

"I was actually born and raised on a farm," said Steele. "I am a descendent of the 40 acres and a mule."

Steele said she left Oklahoma to work on Wall Street and obtain a law degree from New York University. When she returned to her ancestral home, her family members still owned farmland. Collectively, her family owned about 1,000 acres, but the historic landowners were struggling.

In addition, Steele observed two major inequities - female farmers didn't have a voice much of the subsidy programs benefitted White men.

"I wanted to do something to help women farmers and specifically women farmers, because again, as Michelle Obama says, 'White America acts as if

According to Steele, the United States Department of Agriculture (USDA) has excluded female minority farmers from the American Rescue Plan Funding, the Inflation Act and other equity & inclusion resources. The NWIAA has been building support for the Women in Agriculture Act, authored by Congresswoman Sheila McCormick, and is in the

final draft at the U.S. Capitol. As food insecurity and shortages emerge as a global problem, Steele's message on urban and rural farming to build a sustainable food source is resonating. The USDA and the Natural Resource Conservation Service (NRCS) are sponsoring her organization.

"So, in a nutshell, that's why I do it is for women, Black women farmers, minority women, farmers and children. And then ultimately it's for the children to save their lives and give them the same sustainable life-skill opportunities as white children have been receiving in our research," said Steele.







Anthony D. Mays

Anthony D. Mays is a software engineer, speaker, DEI consultant, tech career coach and the founder of Morgan Latimer Consulting. He sat down with the Sentinel for an exclusive interview on his path from Compton to Google to owning a company that ensures a legacy for his children to succeed further--and faster--

"Growing up in Compton in the late 80s, early 90s, everyone's priority is how to get out," he explained.

"I wasn't terribly athletic and I couldn't rap, but I

did happen to notice that computers were this magical tool that people could use to do amazing things. I thought, this might be my ticket out. Now, of course, it's important for me to come back and give to the community. I've never lived far from Compton. But that's how it all started."

As a student of Emerson Middle School, Anthony was thrilled when Magic Johnson funded their new computer lab. It afforded him the opportunity to teach himself basic programming and coding in third grade.

"I didn't realize the significance of what I was learning at the time. This is an important thing for me because having gone through the foster care system, [I felt] a loss of control. Combine that with bullying, I think I was grappling with not being able to control much. With coding, I could craft something that I owned and could create my future from that," he said.

After a brief enrollment

in Roosevelt Middle School next door, Anthony was privileged to attend an NFL YET (Youth Education Town), a charter middle school with state-of-the-art facilities partially funded by Michael Jackson and Garth Brooks.

"That's where I really grew in my understanding of the internet and how to install software. But these charter school programs were always fighting for their existence, so they would have students represent the school to the City Council. I would show off my computer skills to them...so it was interesting starting to develop in the public eye," he admitted.

With this, Anthony began understanding how storytelling and public speaking could enhance his career. During high school at CAMS (California Academy of Math and Science on the campus of CSU-Dominguez Hills), Anthony faced the doubt incurred by imposter syndrome.

"I started feeling like, maybe I don't belong at this level." This feeling carried through to UC Irvine, despite Anthony excelling both in and outside of school. By the time he was 26, he had crossed almost every single to-do on his career bucket list.

"I had a degree, was raising a family and bought a home, made more than my parents were ever able to," he recalled. "But there was one more thing - to become a software engineer Google." In perfect kismet fashion, a Google recruiter reached out to Anthony on LinkedIn and he began preparing for an interview.

"I studied hard for two weeks, went into the interview, and bombed it. They still reached back two or three times, but I was afraid of failing again. My church had prayed before my interview. The feeling of carrying a community on your shoulders, it's a real thing,"

After being coached by the first Black woman software engineer at Google, he went in for a second interview. Toward the end of the interview, the employee was astonished Anthony that wasn't accepted the first time.

During his time at Google, Anthony was able to better understand the need for diversity and equity inclusion (DEI).

"It's not always about tech, it's about people and being able to communicate. DEI is not an abstract concept. There are tangible experiences I've had that have shaped who I am because I could be inspired by someone who understood me and where I come from," said Anthony.

The culmination of his experiences led him to create his own company, Morgan Latimer

Consulting, to increase Black representation within multiple industries, including tech. Named after Garrett A. Morgan and Lewis H. Latimer, Morgan Latimer Consulting pays homage to the two Black entrepreneurs who inspired his business

"America has often neglected and minimized the contribution of Black folks in this country, not just across tech. Instead of needing to look far and wide for talent, it's time that America invested into us," he argued.

"It's an opportunity for Black folks to transform their fortunes by positively contributing to society in ways that we always have. My children will be able to go farther than me, faster."

raised in a neighborhood that is the envy of any welltaught, well-studied musician.

Within a few blocks radius in Athens Park of South Los Angeles, Jackson grew up next to a plethora of artists including Gerald Albright and Etta James.

It is unsurprising, then,

how his natural inclination leaned toward music. He began studying and playing music in adolescence, ultimately deciding at 15 years old to pursue a full-fledged career dedicated to the sonic phenomenon. This commitment has resulted in an esteemed and Grammy-riddled career as an arranger, composer, guitarist, and producer.

"My upbringing was directly responsible for my career in music," said Jackson. "Music is about relationships. Everything is about relationships."

Similar to many other job climates, who you know (and who knows you) easily counts for over half of any artists' opportunities. Luckily for Jackson, he was both well-known and talented.

These two gifts coa-

lesced to create an abundance of kismet experiences leading to collaborations with Michael Jackson, Quincy Jones, Whitney Houston, Patti LaBelle, The Temptations, Phil Collins, Luther Vandross, and more recently, Daft Punk, Zendaya, and The Weeknd.

A full-time professor at USC's Thornton School of Music, Jackson divides his time between creating music away from USC and disseminating its intricacies to his students. Some of his pupils have blossomed to become the musical director for Demi Lovato, opening act for Imagine Dragons on tour, and a playback engineer for Lucky Daye.

A crucial aspect of Jackson's life experience when teaching others is his perspective of the music industry. He's been able to maintain an active role as a creator while watching the industry evolve from the label-led world in the 1970s and 1980s to the modernday environment that benefits an independent artist.

"Streaming is not a bad thing; the bad thing is that artists don't get paid what

Bridging the Divide: How Affordable and Reliable Internet Connects Our Communities

Imagine a world where opportunity is just a click away - where education, healthcare, staying in touch with family, and a brighter future

are within reach for everyone. For far too many Angelenos, this world remains out of reach due to a lack of affordable, reliable internet access.

In Los Angeles County, a staggering 325,015 households (nearly 10%) lack reliable internet access and 156,060 (nearly 5%) don't have a computer at home, according to estimates from the U.S. Census Bureau. This isn't just an inconvenience; it's a critical issue that disproportionately impacts low-income communities and communities of color.

The internet is no longer a luxury; it's a lifeline. It is a gateway to education, allowing students to learn remotely and access a world of knowledge. It is a pathway to healthcare, enabling residents to connect with doctors and


manage their health. It is a virtual embrace, keeping families connected despite distance. It is a launchpad for economic opportunity, empowering individuals to find jobs, start businesses, and participate in the digital economy.

L.A. County is committed to bridging the digital divide and empowering residents in our most under-resourced neighborhoods. In August of 2021, the Board of Supervisors unanimously adopted a motion to assess options for the County to facilitate residential access to reliable broadband service in low-income communities that lack affordable, high-speed internet service. This effort became the County's Community Broadband Networks initiative.

Supported by major funding from the American Rescue Plan Act, L.A. Through Delete The Divide, a broader initiative led by Internal Services, we partner with various organizations to empower residents with the skills and knowledge to navigate the digital world because it's not enough to give access, we must also demonstrate what is possible. Delete The Divide has distributed thousands of free laptops to households without a suitable computer to access the internet and will provide thousands more.

WeLink's groundbreaking low-cost internet plan, starting at just \$25 per month, will connect 50,000 qualified households. The company will also offer plans starting at \$65 per month to households without qualification requirements, no promotional rates, excluding government fees or taxes, and at rates fixed until at least September 2027. The service will feature multilingual support and consumer-friendly terms.

Several success stories were criminal justice. Many Black highlighted, showcasing individuals who have overcome significant obstacles to achieve their dreams and make a positive impact on their communities.

The summit concluded with a call to action, urging attendees to continue advocating for the rights and well-being of immigrants. Several concrete steps were proposed, including increased funding for community-based organizations, policy reforms to protect immigrant rights, and public awareness campaigns to combat discrimination and xenophobia.

transferred to UCLA.

A labor and civil rights leader, Villaraigosa served as president of the American Civil Liberties Union (ACLU) of Southern California, and spent years in the labor movement working for United Teachers Los Angeles (UTLA), Service Employees International Union (SEIU), and as president of American Federation of Government Employees (AFGE), enforcing our civil rights laws at the Equal Employment

Opportunity Commission before running for the California State Assembly.

When Villaraigosa, a lifelong democrat, entered his first term in the Legislature, Republicans controlled the State Assembly and Republican Pete Wilson was in the Governor's office. In 1996, he helped Democrats take control of the Assembly, and rose in the ranks from Assembly Majority Leader to Speaker of the California Assembly.

During his time in the Legislature, Villaraigosa worked with Democrats and Republicans to balance the state budget, making record investments in public schools and colleges, while delivering a \$13 billion budget surplus.

An education champion, Villaraigosa authored and passed Proposition 1A, the largest in California history, to repair and build new neighborhood schools throughout the state.

In the Assembly, Villaraigosa also led efforts to win higher wages for workers, including healthcare workers and teachers, environmental protections for our air and water, and created the Healthy Families Program that provided health coverage for over a million uninsured children.

Villaraigosa's leadership on gun safety and years of standing up to the NRA was profiled by Sacramento Bee newspaper columnist Dan Morain, touting Viltrailblazing laraigosa's record passing stronger gun control measures in the Assembly, including California's landmark assault weapons ban and "a farreaching ban on the sale of cheap handguns, so-called Saturday night specials" that resulted in closing down several gun factories in California.

After serving in the Legislature, Villaraigosa was elected to the Los Angeles City Council then mayor of Los Angeles, becoming L.A.'s first Latino mayor since 1872. As mayor, Villaraigosa

helped turn around failing schools at LAUSD, increasing graduation rates by 60%.

He diversified city agencies, appointing African Americans to leadership positions, city commissioners, and department heads. Villaraigosa appointed the city's first, second, and third African American

fire chiefs, and launched the city's minority-owned small business program, delivering \$200 million in contracts to minority firms.

Villaraigosa was tapped by President Obama to serve as local, state, and national leader for Obama's economic recovery plan, served on the President's Transition Economic Advisory Board and led efforts for America Fast Forward, delivering billions in federal economic investment and hundreds of thousands of good-paying jobs through-

out the Los Angeles region. During 2012 Presidential Election, Villaraigosa served as national co-chair for President Obama's campaign and was asked by President Obama to serve as Chair of the Democratic National Convention in 2012 - which became known as one of the most successful in Democratic Party history.

The San Francisco Chronicle wrote that Antonio Villaraigosa "relished his role aggressively defending President Obama," and that Villaraigosa was "nothing short of a political whirlwind for the Barack Obama campaign... the campaign's tireless 'go-to guy.'"

A leader in tackling climate change, Villaraigosa led historic efforts to make Los Angeles a global leader in reducing greenhouse gasses and carbon emissions, and he led the historic expansion of public transportation in Los Angeles, building more light rail than

any other city in America. As mayor, Villaraigosa reduced violent crime in Los Angeles by 48%, took 12,000 illegal guns off the street, spearheaded gang prevention and intervention programs that became a national model, and led critical reforms to crack down on racism and abuse in the LAPD - making Los Angeles one of the safest big cities in America.

Raphael J. Sonenshein, author of "Politics in Black and White: Race and Power in Los Angeles said Villaraigosa "really maintained the momentum of police reform, and that's no

easy thing." During his last year in office as Mayor, President Obama called Villaraigosa "one of the finest leaders we have in our country."

Now running for governor, Villaraigosa said, "California needs a proven problem solver, that's who I am and exactly what I'll do as governor.

"I will bring a resultsdriven approach that's focused on solutions investing in what works while fixing what's broken - so we can tackle inflation and bring down high costs of living in California, making sure everyone has access to good-paying jobs, affordable homes in safe neighborhoods, with quality schools for our kids."



Teens from Jordan Downs Community Getting Paid to Learn Skilled Trades this Summer

Starting July 22, teenage residents at Jordan Downs, one of L.A.'s largest public housing communities, will earn a paycheck while learning hands-on skills like carpentry and welding, launching them on pathways to careers in industries facing strong demand and a critical lack of qualified workers.

The program is made possible by the joint efforts of Harbor Freight Tools for Schools, the flagship program of The Smidt Foundation, and BRIDGE Housing. BRIDGE Housing is a nonprofit housing developer participating in the \$1 billion redevelopment effort of Jordan Downs.


First built in the 1940s, Jordan Downs is now going through a physical transformation that includes a doubling of the number of residential units, the addition of retail and community spaces, and new parks and open space for residents.

"The City of Los Angeles is committed to providing opportunity to all Angelenos. The launch of this program will equip young Angelenos with hands-on experience and essential skills that can help them succeed now and in the future," said Los Angeles Mayor Karen Bass.

"I want to recognize

Operating like a construction workplace, the program

uses the "earn and learn" model where students are paid while developing meaningful skills that can lead to future employment. The 15 high school-aged residents participating in the summer's pilot program at Jordan Downs were recruited by community-based service providers to participate.

Students will complete 40 hours of hands-on project work to practice foundational trade skills, such as plumbing, electrical wiring, welding and framing a mini house. Students will also master basic skills that apply to a variety of construction disciplines,

"We jumped at the opportunity to partner with Harbor Freight Tools for Schools because we're literally putting tools in young people's hands to help them prepare for careers."

The hope is that students who complete this introductory program will enroll in more comprehensive skilled trades training programs that will result in them earning highvalue industry certifications.

Jordan Downs is one of eight program sites in communities stretching from San Pedro to La Mirada to Canoga Park that are taking part in L.A. County Skilled Trades Summers, an initiative of Harbor Freight Tools for Schools that aims to introduce teens to meaningful skilled trades careers and give them foundational skills for success well before they graduate.

Depending on the site, students may receive handson instruction in advanced manufacturing, automotive technology, carpentry, construction, electrical, solar installation or welding. Some programs will include jobsite projects where they use the hands-on skills they've mastered. Some program participants will earn advanced industry credentials that can lead to entrylevel employment. Others will earn college credits.

"The Skilled Trades Summers programs are giving teens a chance to discover a world of options for their future that they may have never known existed," said Belen Vargas, Senior Director of L.A. County Programs at Harbor Freight Tools for Schools.

"For some students it may uncover new talents and interests. And for others it could be the first step towards a financially stable and fulfilling career."

The summer programs reflect growing interest in skilled trades education among both students and parents. In fact, recent research found supermajorities of L.A.

Young people learn hands-on skills such as carpentry and

County parents would encourage their child to take a skilled trades class, regardless of whether their child was college-bound.

The research, conducted by L.A.-based public opinion research firm EVITARUS, included a survey of more than 1,000 respondents across L.A. County as well as focus groups of parents in South L.A. held in partnership with Community Coalition and Brotherhood Crusade.

Today, fewer than 1 in 5 public high schools in L.A. County offer any type of skilled trades education, despite nationwide labor shortages in these highpaying fields.

To support the Jordan Downs community redevelopment, many residents have been hired as construction workers, among other jobs, and no residents have been displaced from their homes.

The decades-long project led by the Housing Authority of the City of Los Angeles (HACLA), alongside partners like BRIDGE Housing, aspires to be a model of how large-scale redevelopment can be done right.

"At HACLA we are investing in the properties at Jordan Downs and the people who live here," said Doug Guthrie, president and CEO of HACLA.

"This program is providing teen residents with workforce education and skills training that is directly connected to hiring needs that exist right now in their community and can lead to well-paying, quality jobs."





In the four decades since its founding, the LA84 Foundation has supported nearly 4 million youth, 2,500 nonprofits organizations, built or refurbished 400 fields of play, courts or fields, and trained 200,000 coaches.

Casey Wasserman, chairman of

Ceremonies for Paris 2024 less than two weeks away. "1984 was such an

incredibly special moment in this city in every regard," Wasserman said. "The people in L.A. loved the Olympics, and they embraced having the Olympics. So, coming back has created an opportunity to build on that. The second thing is as the Mayor said, we're going to bring the whole world to Los Angeles, and let's show how great L.A. is in every regard."

More than 30 Olympians from multiple Games joined the celebratory event, and track and field icon Carl Lewis and basketball legend Cheryl Miller provided remembrances from the 1984 Games in a panel discussion on the athlete's perspective, moderated by NBC4 Anchor Colleen Williams.

Lewis won four gold medals during the 1984 Olympics, equaling the feat by Jesse Owens in the 1936 Olympics by winning the 100 meter sprint, 200 meter, long jump and 4x100 relay.

"I will always feel this and say this about winning an Olympic gold medal," Lewis said. "You don't realize that when you finally get there, you've been doing this your whole life. I started looking back. I was a paper boy, and I used to run between the houses on Sundays. I was a really late bloomer. That was my moment, that 100 meter lap, seeing my parents in the stands, the stadium is cheering, and for that one moment, you are the center of the world. And it was incredible."

Miller led Team USA to its first Olympic gold in Women's Basketball in 1984 in the middle of her career at USC, where she was voted a four-time All-American.

"One thing that stood out, was it the first jersey I

ever wore that everybody loved," Miller said. "I had a country that I was representing, the USA. The National Anthem never sounded better. It invoked such a passion and respect, and humbleness. California Black Health Network's New Campaign Zooms in on Patient Rights, Empowerment By Edward Henderson

California Black Media

California Black Health Network (CBHN) recently launched its "Health 4 Life: Healthy Black People Campaign."

The campaign aims to empower and educate all Black Californians with "How do I..." (HDI) information and resources needed to effectively navigate the health care system. It also provides tips for advocating for friends, family, and themselves when undergoing medical treatment.

In addition, the campaign advises Black patients on how to respond when faced with discrimination.

"We are working to ignite a Black Health Movement here in California and create a more empowered community of individuals and patients to become proactive about their overall health and well-being, focus more on prevention, and take ownership of their health and healthcare," said Smith. "We need to know that there is such a thing as a patient bill of rights, and we need to know how we can exercise our rights as a patient to get the healthcare we deserve and to make the healthcare system work better for us and be responsive to our needs."

On July 18, CBHN launched a 5-part webinar series titled "Making the Healthcare System Work Better for You," to help the African American communities in the Golden State understand how to make more informed healthcare decisions and how to make the healthcare system work better for them.

The series featured speaker is Dr. Glenda F. Newell-Harris, M.D., a physician, author, speaker, and patient advocate.

Newell-Harris has been at the forefront of addressing health disparities and championing equal access to high-quality healthcare for all. Her passion, she says, even prompted her to write a book on the subject along with a colleague, Dr. Brenda Springs.

"It's very important that you need to understand you have rights as a patient. You may feel when you are in a medical situation that you're at the mercy of everybody that is there. But even in that process, you do have rights," Newell-Harris added. "Patients of color are often the ones who are disenfranchised."

An example of some 'How do I' questions the campaign answers are; How do I take action to protect my health? How do I find the right healthcare provider

for me? How do I know what my plan covers? How do I prepare for my visits? How do I speak up for my and my family's health?

Through the HDI Campaign, CBHN is working to create a more empowered community of individuals who are proactive about their overall health and well-being, focus more on ment decisions, respect and nondiscrimination, patient responsibilities.

"From a standpoint of goals and objectives, patient rights were created to build trust and confidence within the healthcare system, to strengthen the bond between you and your healthcare provider, and also to empower you to take

tal, and the right to report concerns or issues with the care you received.

In terms of respect and discrimination. Newell-Haris emphasized importance of cultivating a relationship with your primary care doctor that is

rooted in respect. is a partnership. There are "We must demand some things your doctor respect in our visits. The first webinar focused on patient rights: "Part 1: Know Your Patient Newell-Harris Rights. delivered a presentation that highlighted patient rights surrounding information, disclosure, insurance coverage, choice of providers, emergency services, treatcharge of your health," said Newell-Harris.

While patient rights are not legally enforceable, they present a guideline as individuals travel along their medical journeys, so people feel empowered as to when and where to ask the right questions. For example, Newell-Harris stressed the importance of the patient's right to ask about how many times a doctor has performed a certain procedure, the health record of a hospiyou're in a medical encounter and you don't feel like you're being respected, you don't hear what the doctor says to you, you don't listen, and you defiantly will have questions if you are going to follow his or her instructions. If you don't feel like you're respected, there are a lot of things you can do with your primary care relationship." Lastly, Newell-Harris

spoke about the responsibility that individual patients

Kamala Harris, High Hopes and Hard Choices: Words to the Wise, Woke and Wondering

There is a huge and understandable sigh and feeling of relief that President Joe Biden has decided not to run for president again and most likely lose to Donald Trump whose mind is amazingly meanspirited and small and whose flaws are uncontestably numerous and negative to the health and welfare of the country.

There is also praise for Biden for an uncommon act of those in power, putting his country's and party's interests above his own, and equally for endorsing Vice President Kamala Harris as his successor.

And there is a mighty surge of energy, interest and high hopes for VP Harris' campaign, victory and presidency. For it is constantly said that it is vital to defeat Donald Trump who poses "an existential threat to our democracy."

Party leaders, politicians in general and a wide range of organizations and persons have also endorsed Harris and raised for her more money in one single first day, \$81 million, than any other presidential candidate in history. Moreover, 44,000 women, especially Black women, crowded on a zoom call on that day to discuss strategies and make commitments. And on Monday, the organization WinwithBlackmen.org held a similar meeting to mobilize and organize for Harris and the Democratic ticket.

On the first day of announcement, 28,000 volunteers stepped up to commit to serve in the campaign. Certainly, this marks a radical change in the fate and fortunes of the Democratic Party, strengthening its aspiration and will to

And yet, although there is great celebration and interest in working to win with and for Harris, there are also understandable concerns, as was with President Barack Obama, about her safety, the low-life tendencies and talk of her opponent, Trump, racist and sexist attacks in general, and the toll it will take on her. Furthermore, there are apprehensions that the donor class not only didn't want Biden, but also didn't want Harris and would try to negate the will of the people expressed in the primaries and endorsed by Biden by calling for an open convention and engaging in a self-destructive struggle.


However, the surge of support has muted such calls, if not fully ended them. Indeed, it is common knowledge, spoken loudly and clearly, that if Harris is denied what she has rightfully earned in the primaries, in service as VP and through endorsements by Biden and others, the Democratic ticket cannot count on Black people's vote and the vote of others with similar commitments, and would surely lose this coming election.

It is important that we realize this will be no easy victory and will take all the support Harris can muster. Thus, one can give credit to Democrat donors and politicians for getting Biden to step down, but we cannot in all honesty deny or diminish the role young people and other activists on campus and in community played, condemning and resisting Biden's unconditional support for Israel's genocidal war in Gaza Palestine.

For it is these struggles and the resultant uncommitted vote that offered unavoidable evidence Biden could not win the coming election and thus, opened the way for Harris to step up and offer a new way forward in both national and international policy whether in Palestine. Haiti, Africa or elsewhere.

Clearly, again Black people, Black women and Black men, will play a decisive role in this elec-

tion as always. And as they are committed to support Harris for president and the Democratic ticket, they

must also work to ensure that she and the party reciprocate and support domestic and international policies they hold as vital and important.

This is especially true for Vice President Harris, herself, who has from the beginning been uniquely embraced by Black women as well as Black people as a whole and must return the appreciation in an equal and similar manner. This calling for reciprocity in relationship is called cherishing and challenging those we care about and who are committed to, particularly in the collective struggle for substantive and secure freedom, racial and social justice, and a shared and inclusive good in this country and the world.

It is said that the election is about saving democracy which is a kind of rephrasing of saving the soul of America and related salvational national projects. But there has been overfocus on ideas and declarations of aspirations rather than putting in place policies and practices that concretely serve and satisfy the interests of the people. We all are interested in saving democracy, but not in its old form as simply a procedural democracy rather than a substantive one, by claiming justice can be achieved in an unjust system simply by going through procedures and letting the process play itself out.

Nor do we want a democracy which literally means "rule of the people," but translates in life as "rule of the rich" who buy elections, deny decent wages and workers' and other rights, and horde the wealth of the world leaving the majority of the world to suffer and eke out a living as well as they can. Thus, saying democracy must mean saving the people, all the people, especially the most vulnerable, creating conditions and capacities for them to live dignity-affirming, good and meaningful lives and flourish.

Yes, it is good to talk about saving democracy and even the rule of law, but not the law of the rightwing zealots who use the law to deny human and civil rights, i.e., the right to life, the security of life, food, water, income, healthcare, housing, quality education, voting and reproductive rights and other life essentials. Indeed, already a platform has been created and most likely one not fully in the image and interests of the people and certainly not in recognition of the new realities shaping this election and the history of this

The need, then, is to engage in a serious and sustained effort to craft and share an agenda that justifies the people's happiness and high hopes at the turn of events and the possibilities now open for a new way forward. It is not enough to appeal to fear of Trump and Project 2025 or even to simply be against evil, injustice and oppression or planned and promised fascism. We must also have policies, practices and proposals for alternative ways of governing, living, relating, working, respecting the environment and sharing and enjoying an inclusive good.

We have no illusions about the compromises and deals made to win, to build coalitions, to secure donations and to avoid vulnerabilities of all kinds that can be exploited by the opposition or misunderstood by the masses. We know too about the conversations of facing selective facts. counsels to wait until, to consider timing and be realistic. But as we said in the 60s, "as for reality, we have come to change it."

Thus, even if the platform cannot take all the hard lines needed, it must lay moral, political and policy ground that envisions and points toward an ultimate inclusive good indispensable for a just society and the well-being of the world. It cannot be overstressed that these issues must be voiced and these commitments gained in honest and frank negotiations before the victory is won and voters and satisfying their needs become a less urgent concern.

Indeed, we must know at the beginning where we are headed, what are the central commitments and concerns and benchmarks to measure progress. For as our honored ancestors taught, "if you know the beginning well, the end will not trouble you".

Finally, no one should minimize the awesome responsibility placed on Vice President Harris in this difficult and demanding situation and the shared responsibility which must be embraced by all who support her and the possibility of reimagining and reconstructing this country in more dignity-affirming, life-enhancing and worldpreserving ways.

The hour is late, the tasks are many and the burden is great. And our people, above all, who have served as a critical moral and social vanguard for this country since our arrival. must understand this election, not as a total solution, but as another ground of struggle to expand the realm of freedom, justice and good in the world.

For if we fail to understand the election as a means rather than an end, even if we win the election, we could lose the struggle for a truly just society, one irreversibly committed to inclusive human good and the well-being of the world and all in it.

New Bill Needs Governor's Signature to Ease Black Job Crisis

As a pastor and community activist in South Los Angeles, I'm daily reminded of how much poverty has affected the financial and spiritual wellbeing of our Black communities. With rising inflation, from food to gas prices, Black folks are being outpriced in their own communities. And because of historic discrimination, Black people face disproportionately high unemployment rates, leaving them unable to take care of their families and vulnerable to chronic poverty. homelessness and incarcer-

That's why I felt hopeful when I learned about SB 1340, a new bill introduced by Senator Lola Smallwood-Cuevas (D-Los Angeles), a worker rights and racial equity advocate. The bill would require state-funded contractors to comply to equitable hiring programs to ensure that good paying jobs are going to workers who need them most. These contractors include those overseeing the state's large-scale projects. development including \$180 billion in federally funded green infrastructure projects planned for California over the next decade.

These equitable hiring programs would establish local "disadvantaged worker" demographics across California and require contractors to prioritize hiring these workers. This bill signals hope to our communities, as it gives Black workers access to wage-paying jobs and put them on a pathway out of poverty.

SB 1340 would also require contractors to regularly track and report workers hired on these projects,

essentially proving that they are both hiring and retaining these disadvantaged workers. That's critical, since Black people are typically the last hired, first fired in this industry.

Equitable hiring programs like these are not just pipe dreams. They actually have strong track records of putting low-income people of color to work. Case in point: In 2014, when LA Metro launched a project labor agreement that aimed to hire local disadvantaged residents for their Crenshaw/LAX rail line, Black worker representation on the project increased astronomically - from 2% to

When we see new infrastructure projects built in our cities, we should be able to see everyone working at these sites. But historically, Black people have been excluded from these development projects, even those built in our own communities. This is unacceptable. The State of California should do all it can to create job opportunities for Black workers who have been systemically overlooked by our work-

In recent weeks, I was encouraged to hear that SB 1340 was passed by the State Senate and Assembly Labor Committee. But it won't become a law without Governor Newsom's signature and commitment to funding it. This is no time for our governor to back down from a bill that can help lift us out of California's Black job crisis. SB 1340 is an opportunity for our governor to look out for Black communities who are in need of a step up. After all, this bill investment won't just benefit Black communities, but California as a whole.

"Critical Decisions"

I wrote my last article, "BulletProof," on July 12, the day before the attempted assassination of former President Trump! Some said, it's luck! Others who were more in tune with reality of what is in the purview of "the divine" said, "It had to be God!"

If you're a leader, you speak to those you trust and get their opinions about what you want to do. It was common for the kings to call in their advisors.

In this case, the false prophets are called in and as was common practice, they would all agree with whatever the king wanted to do. If they don't agree, there would most likely be death or dire consequences. This was one of those occasions.

Now, let's you and I think this through. What would your most loyal ones say or do? Do you want truth, or do you just want to go headlong and do what you want to do with the presumptuous attitude that you cannot fail, because whatever you have done most of the time been successful?

Obviously, Ahab didn't learn his lesson from before because he lost that property to Syria. At another time, Ahab had his way because he wanted the vineyard of Naboth (1 Kings 21) which was the inheritance of Naboth: so, his father had left him this inheritance. Since Naboth didn't sell Ahab his vineyard, his evil wife, Jezebel arranged a scheme for the death of Naboth and had Naboth killed so that Ahab could have his own way through his greed and covetousness.

Going back to the repossession of the territory taken by Syria, Ahab made a false presumption that he could just go in and take back Ramoth-Gilead. Nope. Not as simple as that. After Ahab called in his (400) false prophets none of whom worshipped the one and only true God, they all agreed with Ahab.

Jehoshaphat, who was a believer in Jehovah, suggested to Ahab to call in the prophet who believed in true prophecy made by Jehovah. Ahab agreed but also disagreed. He professed that he hated the true prophet, Michaiah; because he would only prophecy against what he wanted, and the false prophets would say whatever Ahab wanted.

When Michaiah came and repeated just what the false prophets wanted him to say, Ahab knew he was not telling the prophetic truth; because he knew Michaiah would only tell the divine truth what Jehovah had given to him to say. (To be continued next week)

Betty Gabriel Wants More Black Projects

"No" is one of the first 10 words that a baby learns. Unfortunately, it is also a word most actors become accustomed to hearing, too.

But Betty Gabriel is an actress who rose to stardom for hauntingly saying the word over and over and over again in the awardwinning Jordan Peele feature "Get Out."

Prior to "Get Out," Gabriel had roles in the action-horror film "The

HBO sci-fi drama series "Westworld" and has starred in the wildly popular Netflix crime-drama "Clickbait." miniseries Most recently, she was one of the stars in the Amazon action-thriller series "Tom Clancy's Jack Ryan."

Gabriel can also be seen in the Apple TV conspiracy fiction series "Manhunt," where she plays historical figure Elizabeth "Lizzie" Keckley along with numerous other film and television appear-

Gabriel just returned from working on a bankheist-themed project in South Africa.

However, as a Black woman, Gabriel said it is also hard to ignore the injustices inflicted on Black people by some of these officials when she is portraying these roles.

"Bringing those characters to life is challenging, given even most recent history," said Gabriel. "What I do is lean into the fact that there are a lot of actual, real-world Black officers and Black CIA operatives and FBI members - that is a reality."

Gabriel said she hopes to one day soon be a part of new stories that explore the complications and internal struggles of Black law enforcers who work within

racist organizations.

"These stories that I'm a part of [and] bringing those characters to life it's more so for entertainment, so that's a couple of steps removed from that real world trauma that I've certainly experienced with law enforcement... personally and from a distance," said Gabriel.

For Gabriel, the scripted aspects of these stories facilitate escapism, which she enjoys. "I like leaning into the cool, sophisticated aspects of being the truthseekers," she said.

When thinking back to her breakout role as Georgina in "Get Out," Gabriel said booking the film was serendipitous because Hollywood can be a tough place for actors.

"I'm grateful to be a part of it," said Gabriel. "There's no guaranteed track [to more opportunithe confines of classically ties]. It's all about the right

place, and the right time... it's definitely a crapshoot."

Gabriel reiterated that opportunities like "Get Out" are scarce for Black actors, which means that actors often don't have a lot of discretion when it comes to whether they should accept an acting job.

that point where I'm pretty good as far as working with predominately white characters and white creatives," Gabriel continued. "I'm grateful for the work that I've gotten and the people I've gotten to work with. But my experiences - I don't always feel fed."

Gabriel said no other group is going to tell Black stories like Black people.

"It is kind of discouraging when people are buying into this narrative that only white male leads will sell overseas," she said.

Consequentially, Gabriel believes this commonly accepted fallacy controls which projects are made, and that Black creatives must continue to discover new ways to prove this narrative wrong.

"There's ground to stand on when that happens. There's air to breathe when that happens, and therefore the

'Unprisoned' Season 2 is 'Healing Black Families'

Tracy McMillian and Marque Richardson discuss rehabilitation and mental health awareness.

In season 2 of the Hulu series "Unprisoned," the therapist becomes the patient as Paige, played by Kerry Washington begins family counseling with her father Edwin (Delroy Lindo), and son Finn (Faly Rakotohavana).

After realizing she misses her father and wants him to continue living with her, Paige has to self-reflect, take accountability, and even apologize to her father and son upon accepting that she isn't always right.

Series creator, writer, and executive producer Tracy McMillian describes Paige's disposition at the beginning of season 2 as, "I know the most about everything around here because I'm the therapist. I'm fine and everybody else needs to change."

She adds, "What I love about [family therapist] Murphy Collins (played by John Stamos) is that he confronts Paige within the first episode and says, 'Actually, it's time for you to look at you."

Many may recognize McMillian from her hit OWN series, "Family or Fiancé," currently in its third season. McMillian has previously shared that several episodes of "Unprisoned" were inspired by real-life couples that she counseled on "Family or Fiancé."

When asked if there will

be a fourth season of the OWN series, McMillian revealed that there are 10 unaired episodes with an unknown release date.

"But I would love to get another season of that show too, because it's about healing the Black family. And

that's what both shows, 'Family or Fiancé' and 'Unprisoned,' have in common," said McMillian.

While Paige is being proactive in trying to create a healthier relationship dynamic with Edwin and Finn, she's unwilling to admit that she sabotaged her relationship with her most compatible partner, Mal (Marque Richardson). Instead, the pair are trying to forge a platonic friendship which leads to a series of awkward, tension-filled interactions including Paige having dinner with Mal and his new girlfriend,

Richardson described Mal as, "A confident and grounded force for both Paige and Edwin. He's perfectly imperfect yet in tune with his feelings and emotions that he's taught me how to be in tune with mine."

What makes "Unprisoned" must-see TV for the whole family, especially teens, is the way Finn vocalizes his feelings to his mother as well as not shying away from talking about various mental health issues including anxiety disorder.

Actor Faly Rakotohavana told the Sentinel, "The

interesting thing about this season is even Paige, as a therapist, is going to therapy because even the therapists need therapy. It's not a bad thing and it shouldn't have any sort of negative connotation to it. It's just a space where you can finally be given the freedom to let everything out because when you hold it in, you're going to feel it everywhere." said Rakotohavana.

"So you need a space where you can allow yourself to be free and to feel the things that you feel because human emotions are valid and they're real. And you're not feeling it for no reason. You were meant to align with those feelings and figure out what they mean."

As a writer and executive producer of the series, McMillian shares that she was cognizant about making sure a younger generation was represented in the mental health conversation.

"I feel like post-pandemic, so many young people in America are suffering from anxiety. So, I always want to give the young people the maximum dignity and respect. It's easy to be dismissive of a younger generation and say, 'You don't know anything yet.' But in fact, they know things that we don't know," she said.

"And that's one thing we want to show in our intergenerational story is everyone can learn from everyone else. This is not a

top-down patriarchal family. That's not a good family system. Everyone has gifts that they're bringing to a family so we're looking for what those are and celebrat-

ing them." With one of the central themes of "Unprisoned" being Edwin's rehabilitation into society after prison, the Sentinel asked Richardson and McMillian about the call to action in regard to how audiences can support formerly incarcerated peo-

Richardson shared, "After season 1, I started working with this national currently in place."

McMillian added, "If you're the family member of someone who's a returning citizen, I hope that this show helps you bring more compassion and openmindedness to it. I also hope that it helps vou be more honest about how that family member's choices have impacted you, not in a shaming way, but in a loving way.

"So I feel like the call to action is whatever is on your heart, and for me, in all of the things that I've been through my offering is an honest telling of the feelings

"Even so, I realized that when you speak your vocal cords move, there's a dance happening. Even breathing is a dance of



Leadership is second nature for Williams; she is the oldest in her family and her sisters Tiffany and Kaitlyn are also on the track and field team. They talk about the sport frequently.

"Literally almost every-

day we talk about track, watching videos," Williams said. "We'd be in the living room, watching track meets, screaming and yelling like it's a football game."

Black Rodeo Matters in Los Angeles

Known as the "GREAT-EST SHOW ON DIRT." the Bill Pickett Invitational Rodeo celebrated its 40th anniversary by performing to a sold-out audience on July 20-21, at the Industry Hills Expo Center in the City of Industry.

Often coined as the Black Rodeo, the show offered attendees a chance to experience the excitement and excellence of Black cowboy and cowgirl culture, including food trucks and beverages, fashion, music, and thrilling rodeo competitions.

The event provided local Black horseback rid-

ing and rodeo organizations an opportunity to participate in aspects of the program, which include bareback riding/ranch bronc riding, bull riding, bull dogging, calf roping, Jr. and ladies breakaway roping, Pee Wee. Jr./ladies barrel racing, and ladies steer undercorating.

According to the organization, the BPIR is a 40year-old family event that celebrates its global popularity and the stories behind a sub-culture that is still strong today. The mostly African American crowd dressed to impress in their favorite cowboy and cowgirl outfits, and often singing in unison to old-school songs played by the DJ. The energy was electric and reflected in the crowd's enthusiasm.


During the Bill 1800s, Pickett was the

most famous African American rodeo performer, and the first Black cowboy movie star. He invented a way of controlling steers called "bulldogging," and became a star attraction of the wild west shows.

"This event is an important thing to do because it rearranges the misconception that was taught in history, that [Black cowboys] didn't exist," said Obba Babatundé, Emmy Award-winning actor and loyal Black rodeo advocate/horseback rider.







