In the dugout with L.A. Dodgers manager Dave Roberts

Roberts opens up about life, legacy, family and faith.

In a sport that has historically marginalized Black players, African American baseball fans have taken great pride in the accomplishments of legendary ball-players like Jackie Robinson, Larry Doby and Willie Mays. When Dave Roberts was named manager of the Los Angeles Dodgers in 2015, he understood that he too would carry a similar legacy.

"It's hard for me to put into words what it means to be named manager of the Los Angeles Dodgers," Roberts told MLB.com in 2015. "This is truly the opportunity of a lifetime. The Dodgers are the ground-breaking franchise of Jackie Robinson, Roy Campanella, Sandy Koufax, Maury Wills, Fernando Valenzuela and Hideo Nomo."


"I feel that I have now come full circle in my career and there is plenty of unfinished business left in L.A.," said the former Dodger outfielder, who went on to be named 2018 National League Manager

of the Year.

As the first African-American manager of the Dodgers, Roberts walks in the footsteps of many Black trailblazers in baseball at a time when the African-American population in the MLB is at a low with about eight percent of African American players. According to USA Today Sports, there are 11 teams that don't have more than a single African American player on their 25-man roster, including three teams that don't have one. There are only three African American players on active rosters in the entire National League

Roberts was born in Okinawa, Japan to an African American father, a U.S. Marine, who met his Japanese mother while stationed in Japan. Growing up in San Diego, CA, Roberts says he was fortunate to have a dual heritage. He always embraced both facets of his ethnicity and now he stands as a role model for both Asian American and African American baseball fans.

MLK Community Hospital Launches 'Man Up!' Program

gan at Just Showin' Off, in L.A., The Place to Be in Carson and VIP Barber Shop in Compton. It will continue at six more barbershops the first Saturday of every month until December 1.

Though the program is geared toward men, all are welcome to get their vitals including blood pressure, blood glucose and BMI checked, according to Nicole Fredericks, who is a member of MLK's personnel.

"[If problems are detected] we'll have you talk to the doctor who will give medical advice.

Members of the California Complete Count Committee met in Sacramento June 4, to discuss their statewide outreach and communication strategy for 2020, keeping

with their mission of getting everyone counted and connected to appropriate resources. The official Census count will begin April 1 of next year, and the committee wants to ensure they reach everyone, especially those who are "hard to count," they said. Those include immigrant renters, children under five and those living below the poverty line.

Those that are considered hard-to-count (HTC) are least likely to respond to the Census question-{See CENSUS A-8}

Governor Newsom Announces Appointment of Alva Johnson



Voting Centers on the Horizon for 2020 Elections

Changes are coming for L.A. County voters starting with the 2020 elections. According to the Registrar-Recorder/County Clerk's office, their new program makes the process easier and more user friendly and accessible for residents.

Laura Herrera, County Clerk project assistant, outlined the new system - Voting Solutions for All People or VSAP - during a community meeting hosted by First AME Church and Alpha Kappa Alpha Sorority on June 8. Explaining some of the changes, she noted that voters would no longer be limited to casting their ballots at an assigned polling place.

"Our new model will offer 42 potential centers throughout the county and people can vote at any of them," said Herrera, who added that full language services will be available at the sites. Also, voting will be expanded to an 11-day period, with centers accepting ballots beginning Feb. 22, 2020, for the March 3, 2020 elections.

Other improvements include E-Pollbooks, which will verify registration eligibility and allow for same day voting; a secure Ballot Marking Device (BMD), which produces a verifiable paper ballot and decreases unauthorized access or hacking; an Interactive Sample Ballot that lets voters pre-mark selections on a computer or personal device and then transfer their choices to the BMD; a redesigned. easy-tounderstand Vote by Mail ballot, which can be

150 locations; and a new tally system that incorporates image processing technology to ensure that voting results are accurately reported

"In addition, there will be mobile and pop-up BMD units that will be available for disabled, nursing home and homeless residents," Herrera said. In-depth training for poll workers is underway as well.

The new voting information was well-received by the 60+ people in attendance, along with FAME Pastor J. Edgar Boyd, who had started a campaign about 18 months ago that focused on increasing voting in the Black community. The committee includes FAME members, faith leaders and neighborhood advocates.

"We organized a group called African American Get

Out the Vote to get our people ready for the 2020 election. The good thing about this new voting procedure is that you can go and register on the same day that you vote. That makes it easier for everybody. Nobody has

the excuse 'I didn't know

where to register.' This voting center allows for all of that," said Boyd.

"Voting is one of the tools and powers that the African American community has to engage in that bring an increased quality of life," he continued. "Often-

times, we're disallowed participation in so many ways and our vote – our power at the ballot box – engages us to participate in the process with equity."

just felt like the music helped us appreciate how good everything is if we take the time to work together and celebrate together," he said.





Softball Gold Medalist Gives Back with Summer Program

The Natasha Watley Softball League is back, kicking off opening day in South Los Angeles.

Olympic Gold Medalist for Team USA and Former National Champion with the UCLA Bruins, Natasha Watley, hosted opening day for the 11th year of her youth softball league on Saturday, June 8, at St. Andrews Recreation Center.

Over 100 girls from South Los Angeles came out to start off the 8-week summer program that will teach them the ins and outs of softball, along with life lessons on teamwork and dedication. As a former softball player for UCLA, Watley also gives college softball players an opportunity of mentorship as the coaches of the 27 teams. Partnered with the Los

Angeles. A student asked her what softball was and Watley knew then that there needed to be more exposure of softball in Black and Brown communities. In 2009, the Natasha Watley

"We started the league to give opportunities to young girls in L.A. to learn how to play softball," said Watley. "Most of them, when they start, they've never even heard of softball so we're

also got a chance to meet their teammates and coaches that will guide them through these eight weeks. The teams are based on different recreation centers including St. Andrews, Jim Gilliam, Baldwin Hills, Martin Luther King, Jr., and more. During the first half of opening day, the girls mingled and played name games with their new teammates and coaches. They spent the latter half of the day on the field learning about softball basics, including how to do different stances, how to pitch a ball, and how to use

can potentially go on to join their high school team and eventually a college team. This was the path for Janell Brown, who is now the first NWSL league player to receive a full-ride collegiate softball scholarship. She will be attending South Carolina HBCU, Claflin University, in the Fall and is also a coach for NWSL this summer. Along with teaching young girls how to play softball, Watley also hopes to inspire the girls to come back and coach.

"The older you get the more willing you are to help someone on the field so it's a good transition to go from playing on the field to

coaching," said Brown. 'The girls are full of energy and I want them to learn how beneficial and fun softball can be."

Coach mentorship is a unique aspect of NWSL. The coaches are all college athletes, including some heavy hitters, like Kinsley Washington, who made the championship winning hit for UCLA at the Women's College World Series last week. Watley gives these up-and-coming athletes the opportunity to learn about coaching and giving back through coaching the youth league players, attending workshops, and participating in programs overseas. The coaches are also an inspiration to the girls showing them that someone who looks like them is successful in softball.

For the next eight weeks, the 27 teams will play each other at parks around South Los Angeles and learn about softball, healthy lifestyle choices, leadership, and sportsmanship. When the Sentinel last spoke to 12-year-old Jhala Angelique, she had performed her rendition of Andra Day's "Rise Up" on the Hyundai Soundstage during the 13th annual Taste of Soul Family Festival. Her vocals blew the judges away and she became the winner of the 7th annual StarQuest 4 Kids Singing Competition.

Since winning the competition, Jhala has begun making a name for herself throughout the Greater Los Angeles area as a rising artist. Recently the Sentinel caught up with the child prodigy to discuss her life after StarQuest.

"My experience with Taste of Soul and participating in the entire competition was amazing. I really felt the love that everyone was sharing around and it

was just really, really exciting for me," said the singer.

To date, Jhala has performed at countless youth rallies, churches, Riverside's Got Talent, Brentwood's Got Talent, Martin Luther King celebrations, as well as other events.

Jhala is also set to appear on the ABC talk show "Strahan & Sara," TCT Network's "The Dorinda Show," hosted by gospel singer, Dorinda Clark-Cole, ABC News' "Good Morning America," and Niecy T's Kids Biz event.

The rising performer has also had the opportunity to try her hand at acting, recently appearing in

a national Ford commercial which aired during the 2019 NBA Finals during a Golden State Warriors vs. Toronto Raptors game.

However, she is overjoyed by the release of her debut single "Kaleidoscope," which was penned by Jackie Hendon and produced by Donald Lyle, who has also worked with her on four other songs on the "Kaleidoscope" album.

"Donnie Lyle introduced me to the song. As soon as I heard the song I said, 'that's the one!' The song, I feel like, really represents me and it represents the beautiful colors that are inside of us," said Jhala. "When people hear thing song, I want them to feel inspired, uplifted, powerful, and I want them to feel a change inside of them. I want them to know who they are and empower and encourage others and as Nipsey Hussle would say, 'let the marathon continue."

The song "Kaleido-scope" also coincides with the singer's I Am antibullying campaign and her "I Am" book series. Both the campaign and the book series were inspired by Jhala's own experiences of verbal and physical abuse from her peers at school.

According to the singer, the bullying began when she was 7-years-old. During recess, girls would take turns hitting her because of the color of her skin. Her mother finally made the decision to homeschool her.

Although the singer was able to overcome this obstacle in her life, she understands that some students are unable to do the same and end up committing suicide.

"That really inspired me to help them, push them, and to be a voice for those who feel like they don't have a voice and to help those who don't feel like they have meaning," she said.

As part of her I Am campaign, Jhala travels from school-to-school speaking to students about the harmful effects of bullying and provides her audience with words of encouragement.

"I usually sing two songs and I speak to the students and tell them about what happened to me. Then I encourage them to rise up and I help them to understand that they do have meaning, that they do have a voice, and they do have a purpose on this earth," she said.

"I also speak to the bullies as well because they have hurt inside of them. It may be something going on in their lives and they need encouragement to help them get through. They bully because they need to see someone else beneath them."

Currently, her dreams can be summed up in two words, international supering the reach of her anti-bullying campaign, Jhala also plans to continue modeling, acting, and singing, and eventually launch her very own clothing line.



It has been just over two months and the murals of the late, great Nipsey Hussle are still appearing over Los Angeles. With his family, friends, and fans keeping his legacy alive, many are still living off the energy he shared amongst the world.

Demi Lauren, artist and creative entrepreneur, is one of the many artists to use her talent to pay her respects.

A Los Angeles native, Lauren grew up in the Crenshaw area finding few people to look up to, but Hussle, however, stood out.

"I always studied him," she says, adding, "it amazed

me everything he was doing, investing and how he wanted to give back to his community." The rapper, entrepreneur and community leader was also a familiar face to Lauren and many more. "He always came around; he wasn't a celebrity," she affirms.

Leaving L.A. for school, Lauren graduated from Howard University in 2014, making a return to L.A. in 2017. From there, she began creating art and producing events to let people of Los Angeles know just exactly whom she had become.

"Another thing I got from Nipsey was to be fearless, stop overthinking things and just put yourself

out there," she expressed; which is exactly what she did. That confidence inspired her to take her career into her own hands and make something of herself as an entreprenuer.

This mindset ultimately led Lauren to host and throw events to display her art. At one event, in particular, she met Duane and Cary Earle, brothers and owners of Earle's on Crenshaw. They grew to love her work and commissioned her to create a piece for their business.

Lauren and the owners of Earle's had prior intentions for the mural, working on a collaboration that would best fit the restaurant aesthetic. However, once the incident occurred, Lauren stepped up and asked to change the direction of the mural in honor of the late rapper and community leader.

Once she gained the approval, it took nearly a week to come up with a new concept and redesign the original plan set in place. Located on the left side of Earle's on Crenshaw, Lauren's mural includes a portrait of Hussle depicting a colorful theme, palm trees and "Crenshaw" across the

"I wanted to do something different. I wanted something you look at and see something that he represents, something happy," she says of the inspiration behind her concept.

Her familiarity with both Hussle and Crenshaw made this opportunity all the more special.

"I did this because it means so much to L.A., my city, everybody, everybody was hurt, everybody's touched by it," she states, going on to say, "I still think of him every single day."

The mural was revealed and celebrated on April 20, 2019, at Earle's. The event included an art exhibition and auctions, music, food, and games.

This opportunity has opened doors for the freelance artist to expand her artistry and share her talents with the masses. Her drive and commitment have led her to throw events, as well as partner with businesses tailored to the arts and the Los Angeles culture. As host for Trap x Paint, a day party being held June 15, 2019, from 3 PM to 6 PM, Lauren is excited for her expansion as artist and brand.

Ethical Insights from Odu Ifa: Choosing to be Chosen

Nowhere is the profundity and beauty of African spirituality more apparent than in the Odu Ifa, the sacred text of the spiritual and ethical tradition of Ifa, which is one of the greatest sacred texts of the world and a classic of African and world literature. Its central message revolves around the teachings of the Goodness of and in the world; the chosen status of humans in the world; the criteria of a good world; and the requirements for a good world. Although these themes are throughout the Odu Ifa, nowhere are they more explicit than in Odu 78:1. The Odu (chapter) begins by declaring "Let's do things with joy..." For it is understood that the world was created in goodness and that we are to find good in the world, embrace it, increase it, and not let any good be lost. It is obvious here that all is not well with the world, given the poverty, oppression, exploitation and general suffering of people. But inherent in this firm belief in the good that is found in the Odu Ifa is the faith that in the midst of the worst of situations there are good people, good will and possibilities for creating good, increasing good and thus constantly expanding the realm of good.

The chosen status of humans is a second major tenet of Ifa. Odu 78:1 says we should do things with "for surely humans have been divinely chosen (yan) to bring good into the world" and that this is the fundamental mission and meaning of human life. And we are chosen not over and against anyone, but chosen with everyone to bring good in the world. Thus, all of us are equally chosen. In fact, the word for human being is eniyan which literally means chosen one, and we are divinely chosen without distinction of nation, race, gender, special religious relationship or promise. Surely this poses an ideal many other world religions are still striving to establish as a central moral doctrine.

But even as we're chosen, we must also choose to be chosen by doing good in the world. Thus, Odu 78:1 also says that no one can reach their highest level of spirituality or rest in heaven until we all achieve the good world "that Olodumare, God, has ordained for every human being." This establishes a divinely ordained right to a good life for every human being. But joined to this human right is the obligation of shared responsibility of humans to make the world good so that everyone can enjoy a good life. The important contribution this makes here to theological and social ethics is that it teaches that transcendence in the spiritual and social sense can never be individualistic, but must always include the happiness and well-being of others. The Odu Ifa says all deserve a good life and good world; ultimate transcendence is impossible without it, and it is a shared task of all humans to achieve it.

The question is, then, posed to the sage and master teacher, Orunmila, of what is a good life and the conditions for the good world. Orunmila answers by saying that the achieving of a good life or good world is defined by several essential things: full knowledge of things; happiness everywhere; freedom from anxiety and fear of hostile others; the end of antagonism with other beings on earth, i.e., animals, reptiles and the like; wellbeing and the end of forces that threaten it; and finally, freedom from poverty and misery. Now, it is of great significance that the first criteria for good life and

good world is knowledge. In fact, Orunmila also says that knowledge or rather wisdom is the first requirement for achieving the good. This points to knowledge or education as a basic human right, necessary not only for our understanding our humanity in its most expansive forms, but also to realize it in the most meaningful and flourishing ways.

But again the good world will not come into being by itself. Thus, five requirements are necessary to bring it into being. The first requirement Orunmila

lists for achieving a good world, as noted above is wisdom. The text says we must develop "wisdom adequate to govern the world." This reaffirms human responsibility for the world and the need to obtain adequate wisdom to carry out this responsibility effectively. The core wisdom here is of necessity moral and spiritual wisdom which conceives the world in its interrelated wholeness, respects its integrity and works constantly to save, renew and expand the good in it.

Orunmila also taught that humans must move beyond moralities of convenience to a morality of sacrifice, i.e., self-giving in a real, meaningful and sustained way. The Odu Ifa says that "one who makes a small sacrifice will have a small result" (Odu, 45:1). It says to us "be able to suffer without surrendering and persevere in what you do" (Odu, 150). Also, a central moral quest in the Ifa spiritual and ethical tradition is to achieve iwapele, a gentle

character or iwarere, good character which are often interchangeable. Orunmila cites this as the third requirement to achieving a good world. "It is gentle character which enables the rope of life to remain strong in our hands" according to Odu 119:1.

Orunmila teaches that

another one of the main requirements for achieving the good world is "the love of doing good for all people, especially for those who are in need and those who seek assistance from us." This requirement seeks to create a moral community based not on cold calculation of rule and duty, but on the love of doing good and the joy and benefit it brings to the doer and the recipient of the good. Odu 141:1 says, "Ofun is giving out goodness everywhere. (But) Ofun does not make noise about it." Indeed, to do things coldly and/or loudly is to diminish the good done.

The last requirement Orunmila cites as a requirement for creating a

good world returns us to the fundamental meaning and mission in human life. He says what is required is "the eagerness and struggle to increase good in the world and not let any good be lost." Again, Orunmila calls for a profound commitment to the good world, and an ongoing, intense, liberating and uplifting struggle for it until it is achieved. And the Odu suggests that we must stay ever-ready and engaged, for it says in the pursuit of good, "a constant soldier is never unready, not even once" (Odu, 159:1).



Study Finds Most of the World Failing at **Gender Equality**

Nearly 40 percent of the world's girls and women live in countries that are failing on gender equality, according to information compiled by Equal Measures 2030 and its partners.

According to the website for the project, "The 2019 SDG Gender Index measures the state of gender equality aligned to 14 of the 17 Sustainable Development Goals (SDGs) in 129 countries and 51 issues ranging from health, gender-based violence, climate change, decent work and others. The 2019 SDG Gender Index provides a snapshot of where the world stands, right now, linked to the vision of gender equality set forth by the 2030 Agenda."

The index reveals that 1.4 billion girls and women are living in countries that get a "very poor" or failing grade on gender equality.

The SDG Gender Index is considered the most comprehensive tool available to measure the state of gender equality when compared to defined SDGs.

The average score across the 129 countries - which represent 95 percent of the world's girls and women – is 65.7 out of 100, which transupon the index's scoring sys-

No single country is the world's best performer - or even among the world's top ten performers - across all goals or all issues.

In 2015, world leaders from the participating countries committed to achieve gender equality by 2030 for every girl and every woman when they signed on to the ambitious goals and targets of the SDGs.

"With just 11 years to go, our index finds that not a single one of the 129 countries is fully transforming their laws, policies or public budget decisions on the scale needed to reach gender equality by 2030," Alison Holder, the director of Equal Measures 2030 said in a news release.

"We are failing to deliver on the promises of gender equality for literally billions of girls and women," Holder

Overall, the world is furthest behind on gender equality issues related to public finance and better gender data (SDG 17), climate change (SDG 13), gender equality in industry and innovation (SDG 9) and worryingly – the standalone 'gender equality' goal (SDG

Denmark tops the index,

lates to a "poor" rating based followed closely by Finland, Sweden, Norway, and the Netherlands.

> The countries with the lowest scores in the index – Niger, Yemen, Congo, Democratic Republic of Congo, and Chad - have all faced conflict and fragility in recent years.

Altogether, 2.8 billion girls and women live in countries that get either a "very poor" (59 and below) or "poor" score (60-69) on gender equality.

Just eight percent of the world's population of girls and women live in countries that received a "good" gender equality score (80 - 89)and no country achieved an "excellent" overall score of 90 or above.

The 129 countries featured in the index cover five regions - Asia and the Pacific, Europe and North America, Latin America and the Caribbean, Middle East and North Africa and Sub-Saharan Africa.

"It's clear that even the most gender-equal countries need to improve on issues like climate change, gender budgeting and public services, equal representation in powerful positions, gender pay gaps, and gender-based violence," Holder said.

The index also shows that countries with far fewer resources are still able to

tackle key gender inequali-

Senegal, for example, has a higher percentage of women in parliament (42 percent) than Denmark (37 percent), despite Denmark's GDP per capita being 56 times higher than that of Senegal.

Kenya has very high rates of women who use digital banking (75 percent) higher rates than three quarters of the world's countries.

Colombia has better coverage of social assistance (81 percent) amongst its poorest people than the United States (65 percent), a higherincome country.

"This report should serve as a wakeup call to the world. We won't meet the SDGs with 40 percent of girls and women living in countries that are failing on gender equality," said Melinda Gates, Co-chair of the Bill & Melinda Gates Foundation.

"But the SDG Gender Index also shows that progress is possible. Many countries with the most limited resources are making huge strides in removing the barriers for girls and women across economies, politics and society - demonstrating that when it comes to gender equality, governments shouldn't have excuses for inaction," Gates said.

Altogether, 2.8 billion girls and women live in countries that get either a "very poor" (59

and below) or "poor" score (60 - 69) on gender equality.

Officials said it's also imperative that the global community provides investment and support to fragile and conflict-affected countries - those with the lowest scores in the Index, such as Yemen, Congo, Democratic Republic of Congo and Chad.

"As advocates for gender equality in Africa, we can no longer operate on presumptions and approximations," said Memory Kachambwa, the executive director of the African Women's Development and Communication Network or FEMNET.

"Gaps of inequalities must be marked, counted and recorded so that the trail of implementation is clear and decision makers are held to account. The SDG Gender Index will help to ensure that

Africa's girls and women are counted and accounted for," Kachambwa said.

While some issues are lagging far behind, dedicated international efforts appear to have made a difference on other issues.

Overall, countries have performed best on issues where coordinated and concerted policy focus and funding has been directed over the past 10-20 years, including on hunger and nutrition (SDG 2), water and sanitation (SDG 6), health (SDG 3) and education (SDG 4).

"With 8,000 decisionmakers, advocates, and influencers gathered in Vancouver as part of the Women Deliver Conference, and over 100,000 participating around the world, we have the collective power to drive real progress on these gender equality scores and create real impact for girls and women," said Katja Iversen, the president and CEO of Women Deliver.

Gov. Newsom signs charter school transparency bill March 5.

In February, Gov. Newsom asked Tony Thurmond, Superintendent of Public Instruction, to set up a task force charged with looking at the impact public charter school funding has on districtrun public school finances.

The team submitted its report to the governor last

The 10-page document is expected to inform legislators' votes on two contested charter school bills the Senate is reviewing. Their report could also influence whether or not the governor signs them.

If passed, those bills would encode major changes California's Charter Schools Act of 1992. That regulation governs more than 1,300 independent, taxpayerfinanced schools in the state, which enroll more than 50,000 African-American students.

"The public deserves a transparent report, one that also reflects honestly that there is more work to be done," said Thurmond."We will continue working with legislators and stakeholders, as well as welcome the opportunity for public input."

The 11-member panel limited the scope of its inquiry to only two issues: charter schools' impact on the financial health of traditional school districts and inconsistencies in the ways county boards authorize

What's Next for California's Charter Schools? Much Awaited Task Force Report is Heavy on Advice - But Falls Short on Data cult decisions and lacked the

In the report – heavy with suggestions but light on data - the task force did not quantify the extent to which charter schools impact traditional district school finances. The document also did not share any findings of an inquiry into approval disparities.

Also missing is comment on another issue driving much of the public debate on charter schools in California. That is the huge gap between the academic performance of African-American students and all others sub-groups in

Many charter schools have found themselves on the leading edge of working to close that discrepancy, frequently dubbed "the African-American achievement Gap." A concentration of charters are located in neighborhoods up and down the state where some of the lowest-performing traditional public schools have operated for decades without making significant improvements to their academic outcomes for Black students. On state tests, the average scores of African-American students consistently fall below those of all other sub-groups, accept students with disabilities.

In 1996, Californians voted to pass Prop 209 prohibiting the state from considering race in public education policy.

Charter school representatives as well as Labor union members supporting district-run traditional schools served on Thurmond's task force. They teamed up with local school board officials and administrators to hash out ideas to

share with the governor. Their report, submitted ahead of their June 30 deadline, recommends that the state gives school districts more discretion in the authorization process by adding two additional criteria: "saturation" of schools and the "need for new schools." That "saturation" and "need," the report says, would factor in the number of schools in a

district, the number of students attending them, their performance and curricula.

The report also proposes extending the charter school approval timeframe from 60 to 90 days and limiting the appeal process to county school boards. Under current law, the State Board of Education has the final say.

Another recommendation proposes setting up agencies tasked with developing statewide oversight guidelines and providing standardized training for authorizers.

Finally, the task force recommends changing the state's education code to allow tuition payments to district-run public schools to continue for one year after students leave traditional public schools for charters. The report puts the cost for

that effort at \$96 million. California's largest concentrations of charter schools operate in clusters around Oakland, Inglewood and San Diego, also home to some of the largest populations of African Americans in California. Therefore, many Black legislators and educators, as well as African-American charter school parents, anticipated the report's release.

In fact, when the Assembly education committee voted to pass four charter school bills earlier this year, Assemblymember Shirley Weber (D-San Diego), chair of the legislative Black Caucus, withheld her vote. Weber said she was looking forward to seeing the findings of the task force before making a final decision.

"There are correlations. Areas with the most charter schools also happen to be tracts of the state where the census has historically undercounted African Americans. Undercounts result in under-funding for critical services - from education to health," Walter said Hawkins, a senior research associate at NewHawk, a southern California-based data collection firm. He recently conducted a study commissioned by California Black Media called "Counting Black California." The report offers a county-bycounty breakdown of demographic information on African Americans.

On one side of the charter school debate in California, you have large teacher unions, the NAACP and other public education advocates who have organized and supported protests and strikes - the last major one shut down the LA Unified School District in January. They are demanding more accountability and oversight of charter schools, saying they siphon critical resources away from traditional public

On the other hand, there are concerned parents of more than 600,000 charter

school students across the state, charter school operators and other advocates like the National Action Network and the National Urban League. They highlight how the independence of the schools have enabled administrators and teachers to develop specialized curricula that have turned the academic performance around for large numbers of students who district-run public schools previously failed.

In a statement, the California Teachers Association (CTA) praised the majority of the recommendations and urged the legislature to pass the charter school bills currently before them.

"Our marginalized school communities have been deeply impacted when districts are forced to make diffidiscretion they needed," said Erika Jones, a Los Angelesarea teacher who represented the CTA on the task force.

The governor's press office said he is still reviewing the report.

Myrna Castrejón, president and CEO of the California Charter Schools Association, says the task force report is a step forward but there's more to do.

"There are elements that are deeply concerning and require more work ahead," she said. "These are polarizing times, and Superintendent Thurmond had the difficult task of pulling together education stakeholders who have passionately disparate views about the vision for California's public school





"The whole goal is to make sure people know their numbers and know what to do with them."

"South L.A. has some of the worst health statistics in the nation," said Gwendolyn Driscol, MLK director of communications.

"African American men have some of the highest rates of prostate cancer and heart disease and diabetes. Latino men have high rates of obesity compared to other racial/ ethnic groups and are three times more likely to be uninsured."

The Man Up program is a response to those facts, she said. The barbers in the nine shops have been trained to encourage their clients to get screened and to take home health information.

Co-creator of the program, Jorge Reyno said he is surprised at the number of patrons who come to these types of events who have concerning numbers and don't know it.

"When I get a chance, I talk to them about why

it's important to know, especially for Black men. And, if you don't have access to resources, we have a lot of resource guides."

One of the co-founders of the program, MLK's Community Benefit coordinator Lauren Espy said they chose the barber shop because it is a place where a lot of men find their comfort level.

"This creates an environment of trust," she

"So, the difference between our programs and others is that a lot of them are research-based. We are community-based. So, our goal is not so much to collect data but to provide resources and to provide information for these men about their numbers and about how they can get

"In my community, neonle are afraid of doctors because they have nothing but bad news," said Darryl Jones of The Place to Be barbers shop in Carson, one of the Man Up's kickoff sites.

"And they have bad news because it takes people 10 years to go

see them. So of course there's going to be bad news. So there's a disconnect between how people feel about doctors and how they should feel about doctors.

"And then when you go to a doctor it's so rushed. You get 10 minutes to tell you what happened in the last year. You don't get a whole lot of time. If you don't tell them within that time, the doctor will just tell you to come back in six months. But the patient doesn't come back because the doc didn't do anything. The patient still feels the same. So they say: "Why go back?'

"That's what it's ultimately about: trust. Because if you trust somebody you'll do what they say or you'll trust what they say. You'll be more apt to do it because you trust them. naire without specialized

outreach and assistance. That puts California at risk, they said, of being undercounted for vital resources like public health and education programs, roads and housing. It will also pose the risk of California being underrepresented in the House Representatives. The CCCC is trying to mitigate these risks before the count begins.

"A lot of Californians have a fear of the government and that's what makes them difficult to count," said Diana Crofts-Pelayo, communications chief for the California Complete Count Committee (CCCC). "That's why state leaders have invested in doing everything possible to help Californians understand what the Census is, understanding the importance of the Census and how it benefits the community."

According to CCCC, California leaders have invested \$100.3 million toward its campaign efforts. In total this is a proposed \$154.3 million investment for the 2020 Census.

A large part of the committee's efforts will include meetings, a variety of events, webinars, consultations and convenings.

"As chair of the Complete Count Committee, I'm calling for all hands on deck for the 2020 Census," said Secretary of State Padilla, who Governor Gavin New-

some appointed in April. "The 2020 Census will help define California for the next decade. Our voice in Congress and presidential elections is on the line. Billions of dollars—for our schools, roads, and health services—are on the line. Participating in the census directly matters for our communities. We will need everyone - including the state legislature, state departments, businesses, and community organizations - to work together to reach hardto-count communities."

According to an interactive map on CCCC's website, Los Angeles alone has a hard to count index of 86, compared to a state wide average of 37. The variables most correlated with this tract's CA-HTC Index, committee members said are:



Harris, Colleagues Demand McDonald's Improve Sexual Harassment Policies at Locations Across the Country

U.S. Senators Kamala D. Harris (D-CA), Tammy Duckworth (D-IL), Richard Blumenthal (D-CT), Sherrod Brown (D-OH), Bernie Sanders (I-VT), and Elizabeth Warren (D-MA) on June 11, called on McDonald's to improve its protections against sexual harassment at locations across the country and do more to address allegations of workplace harassment, abuse and retaliation suffered by McDonald's workers. In a letter to Mc-Donald's CEO Steve Easterbrook, the senators emphasized how the updated company policies McDonald's recently announced are insufficient if franchisees – who own the vast majority of McDonald's

locations – are not required to implement and enforce

"The McDonald's Cor-

poration must do more to combat workplace harassment, abuse and retaliation suffered by McDonald's

workers across the country," the senators wrote. "After carefully reviewing your public statements and documents, we remain troubled that the procedures, policies and activities outlined fall short of providing a safe and respectful work environment for all workers who wear the McDonald's uniform."

"Since independently owned operations make up the vast majority of the over 14,000 McDonald's locations across the U.S., it is imperative that the McDonald's Corporation require all franchise locations to adopt the updated policies to guarantee that all workers will be covered by the new protections and support services," the senators continued.

Senators

asked a series of questions regarding how McDonald's Corporation will promote workplaces that are safe and respectful at corporate and franchisee locations and how it plans to investigate reports of harassment and abuse.

In addition, the senators requested more details on the feedback McDonald's received from workers and other stakeholders while working on its updated policies.

"For three years, we've been speaking out, filing charges and even going on strike to get McDonald's to confront its sexual harassment problem," said Tanya Harrell, a McDonald's worker and Fight for \$15 and a Union leader from Gretna, La., who filed an EEOC charge alleging a co-worker attempted to rape her in a bathroom stall. "With Sen. Duckworth joining with us to hold McDonald's accountable, our voices are even louder. We're grateful she's asking the tough questions and pushing the company to take responsibility to make sure all of its workers are safe on the job."

"McDonald's track record on tackling sexual harassment is dreadful," said Fatima Goss Graves, president and CEO of the National Women's Law Center. "As the world's second largest private sector employer, McDonald's is perfectly positioned - if it chooses - to take a meaningful lead in an industry that's rampant with abuse. And it can start by listening to its workers and acting."

Two New Reports Chop Up the Data and Make It Easy to Connect with Black California

A little over 2.2 million African Americans call California home.

Of that number, 72 percent lives in southern California with the greatest concentration (about 36 percent) in Los Angeles County, followed by the Inland Empire, and then, the San Diego area.

The other 28 percent lives in the northern part of the state with the densest clusters of African Americans in and around the Bay Area, and a little bit east, centered around Sacramento and Central Valley.

California also has the fifth highest number of Blacks in the United States.

But when you look at percentages, California's Black population compared to the total state population, makes up a little over 6.6 percent of the almost 40 million people living in the Golden State - ranking it 31st in the nation.

Two new reports, "Counting Black California" and "The State of Blacks In California" provided most of those numbers above and they dissect them in interesting ways, too. Created to instruct and support the work media publications, public affairs

and others will do to educate Californians about participating in the 2020 Census, the surveys provide hyper-localized data on where Blacks live, who they are and a gives a scale of the areas of the state that census workers have had the hardest time counting with accuracy in the past.

"We approached this project thinking, 'which data will be most useful to our network and partners when they are creating content to get the word out about the 2020 Census?,"" said Regina Wilson, Executive Director of California Black Media which commissioned the "Counting Black California" report.

"We're equipping our network. We have a combined reach of more than one million people in the state - through print, digital and broadcast media," Wilson said. "Now, they have the info they will need to develop super-targeted content for every segment of Black Californians living in every corner of the state."

The "Counting Black California" report offers a county-by-county breakdown of demographic details and other data, including inflows of federal dollars into California and

firms, community groups how many Blacks in the state are foreign born. It also identifies 8,057 census tracts in the state and ranks them on a scale from 1 to 9 - from the least to the most likely to respond to next year's census survey. A number of social and economic factors are used to determine that rating.

> "Now editors and journalists can look at a specific neighborhood or even a region, maybe, and find out who lives there, and where, and how difficult that place would be for census workers to count. Then, build a relevant informational campaign based on that knowledge," said Walter Hawkins, a senior research associate at NewHawk, a southern California-based data collection firm. He conducted the research for the "Counting Black California" report.

> "The State of Blacks in California" report provides "quality of life" data like income, marital status, poverty rates, levels of education, etc., that can be layered on top of the information in "Counting Black California" to gain a sense of the psychographics of Black California.

"Our report provides a deeper snapshot of the communities that have the largest Black populations in the state as well as the factors that need to be considered when engaging Black Californians," said Kellie Todd, who authored the report. She is the founder of Sistallect, Inc., a statewide organization created to empower women of

color. "Although the Black community in California is concentrated in 10 counties, connecting with residents can be difficult without understanding that there are geographical and cultural differences from region to region, city to city, and even from neigh-

borhood to neighborhood," said Todd.

"Using a coalition approach has proven to be the most effective way, as well as partnering with local Black media outlets, to have maximum impact."

"The State of Blacks in California" report is packed with stats that reveal pertinent tidbits about different communities. For example, African Americans in Contra Costa, Orange and Solano counties have the highest average income in the state – all three at \$53k - but Orange County has the lowest Black poverty

rate at 15 percent. Orange County also has the most African Americans with college degrees (37 percent) followed by Contra Costa County (25 percent).

"There are so many exciting ways the end user can slice and dice the information in both reports," said Wilson. "It arms us with everything we need to know to run a strong Census 2020 education campaign. It gives us really actionable data that allows us to effectively followthrough, check how well we're doing and change course if we need to."

Mistrial declared on remaining counts against ex-NFL player

A California judge declared a mistrial June 11, on the remaining charges against former NFL player Kellen Winslow Jr. after a jury convicted him of raping a 58-year-old homeless woman but could not break a deadlock over two counts of rape involving a 54-year-old hitchhiker and an unconscious teen.

Prosecutors did not immediately say whether they would retry the eight undecided charges but agreed to return to court to discuss that option and possibly set a new trial date.

Winslow, who played for Cleveland, Tampa Bay, New England and the New York Jets, currently faces up to nine years in prison and must register as a sex offender.

The jury on June 10, found him guilty of an attack last year on the homeless woman in his picturesque beach community of Encinitas, north of San Diego. Jurors also convicted him of two misdemeanors - indecent exposure and

a lewd act in public — involving two other women.

The 35-year-old former tight end — at one point one of the highest paid in the NFL — could face up to life in prison if he is retried and convicted of raping all three women.

After the San Diego County Superior Court sent the jury home, prosecutor Dan Owens told reporters the majority of the 12 jurors believed Winslow was guilty of raping more than one woman.

"Ten jurors did feel very strongly that he had committed forcible sexual offenses against more than one victim," he said. "That would lead to a lifetime prison term and that would be another factor

very strongly in determining how to proceed with the case."

Winslow's attorneys indicated they want him to be sentenced after the case is retried and that they plan to appeal the convictions handed down on June 10.


Defense lawyer Emily Bahr said Winslow was "shocked by that verdict" as was his family, including his father, former Chargers icon and Hall of Famer Kellen Winslow, who sat behind his son every day of the trial.

"They're upset of course, disappointed by that outcome but they know that the team is going to move forward and continue to fight the case," she said.

The jury found him not guilty of one count of a lewd act.

The jury of eight men and four women told the judge they were hopelessly deadlocked on the other eight charges after they de-

liberated for four days. All five women testified during the trial. Winslow did not take the stand.

Beyond the social responsibility that comes along with being a sports figure, comes the laborintensive job itself. Roberts came on as manager to one of the top-five highest-paid franchises in the MLB. After losing in last year's World Series, Roberts faced criticism from frustrated fans, including Presiwin a baseball game. dent Donald Trump, who took to his Twitter account to complain about Roberts' decisions during Game 4 of

the World Series. Still, Roberts' leadership led the team to compete in two consecutive World Series and the team is well on their way to the third.

"It's something I really believe in because I think as a young coach or manager, it's natural to chase results and understand that you're being judged on results," Roberts told ESPN. "But to really trust in the process, and getting people to do things the right way, and betting on the results in the back end, I think, is a more attainable goal."

Following some roster changes this season, the Dodgers are currently in first place and hold a 10 ½ game lead in the National League West.

As a player, Roberts most defining moment came in 2004, known as "the most famous steal in Boston Red Sox history," boosting the team into a comeback against the New York Yankees that won them their first World Series in 86 years. Now what defines Roberts' career is his philosophy as a leader, his faith in God, the love for his family, and of course, his love for base-

ball. It was a sunny Los Angeles afternoon when Roberts sat down with the Sentinel. We met in his office — the L.A. Dodgers' dugout — just hours before he led his team to beat the Washington Nationals 0-5.





We are told that our first impressions of ourselves comes from our parents. Much of our confidence in what we can or cannot do stems from what is poured into us as children. You must have seen this video. A father speaking with his pre-verbal son about the season finale of Empire. The video went viral at warp speed and DJ Pryor-the father-was overwhelmed by the outpouring of emotion that the interaction with his son evoked.

I have watched the video several times and love it. What especially struck me, and continues to, is that Pryor does not speak "baby talk" to his son, Kingston Jierre. He is holding a conversation and his son is attempting to do likewise. The son looks back and forth between the television and his father, moves his hands around and offers commentary. It does not matter whether his words make no sense. This was just the sort of interaction that needs to happen with a child at that age.

This video stands in contrast to what I frequently see with parents who ignore their children in favor of a cell phone call or listening to music, on the one hand, or yelling at their children on the other hand.

When my daughter was about the age of Pryor's son I distinctly remember being out of town and calling home. I would always make a point of asking my wife to put my daughter on the phone so that she could hear my voice and so that I could hear hers. One evening I called, and my daughter got on the phone. It was remarkable. It was just like the Pryor video. My daughter held a conversation with me... in gibberish! But she did it so well with changing intonation, chuckling and seemingly asking me questions. I realized in that moment that she was on the verge of talking.

It is not just that the Pryor video is adorable. It reminds the viewer of the components of love that must exist between a parent and child. Pryor was

not holding his son in any particular manner; in fact, he was not holding him at all. The two of them were looking back and forth between each other and the television. Pryor was taking his son very seriously and you could tell that the son felt that in a very deep manner.

The sort of interaction between father and child as seen in the Pryor video should remind us that our work to raise our children is communicated through actions, words, gestures and the look in one's eyes.

Pryor and his son, Kingston Jierre, are lucky to have one another. And, although she is not in the video, I am sure that the child's mother contributed immensely to a situation whereby the son was ready to engage his dad.

County Officials OK Juvenile Hall CCTV, Study Long-Term Fixes

Still struggling to find ways to better serve youthful offenders with mental illness and keep probation officers safe, the Los Angeles County Board of Supervisors called for one more report and approved \$7.4 million for the installation of closed-circuit cameras in Central Juvenile Hall.

Supervisors Ridley-Thomas and Janice Hahn co-authored a motion calling for several county departments and law enforcement agencies to come up with a plan to increase options for treating mentally ill minors out of detention.

This is not a new problem," Ridley-Thomas said. "The county's failure to meet the mental health

needs of the youth in our juvenile halls and camps was well documented by the U.S. Department of Justice in 2003. Yet over 15 years later, the county continues to struggle with this issue."

Probation Chief, Terri McDonald said the department has teams that work with the courts, prosecutors and public defenders to try to place minors in community-based settings when possible.

'Our preference is home on probation if it's safe to do that," McDonald told the board. "And we do work with (the Department of Mental Health) and others to provide wraparound care."

However, as with adult offenders suffering from mental illness or substance abuse, resources are limited, she added.

As the population of juvenile offenders in the county system has dropped by 80 percent over the last 15 years, the minors that remain are more likely to have high rates of trauma -- such as abuse, homelessness and sexual exploitation -- and need mental health care, according to an April report by the Department of Mental Health.

Roughly 90 percent of youth in juvenile halls in 2018 had an open mental health case, according to the report. That represents a 38 percent increase since 2015, although the report also speculated that improved screening may have contributed to the rise.

The use of psychotropic medication by youth has ticked up from 2018 to 2019, indicating a more severely mentally ill population, according to a DMH

Hiring a director to coordinate care across agencies, expanding on- site coverage by mental health clinicians and clinical staff, setting up crisis outreach and response teams, and integrating data and health records across departments are all anticipated to be part of the proposal to improve care.

'We believe in care for kids whose lives have been turned upside down by trauma and are in need of treatment, not punishment," said DMH Director Dr. Jonathan Sherin. "Unfortunately, our current systems are not only incompatible with care delivery but also reinforce unhealthy narratives."

The cameras are a shorter term practical solution to safety concerns raised by juveniles and

Concern about staffers' use of pepper spray to control minors led to the board's vote in February to phase out its use in juvenile halls and camps altogether. In May, six probation officers were arraigned on felony assault charges stemming from their use of the chemical.

However, the discussion around use of force also prompted complaints by union representatives and staffers who don't feel safe in an environment where youth-on-youth assaults were up 66 percent and youth-on-staff assaults were up 58 percent from 2016-17.

Probation officers say dealing with rival gang members eager to attack one another and severely mentally ill youth whose drastic mood swings make

their behavior unpredictable means tools like pepper spray are necessary to maintain control.

Juvenile justice advocates say what's needed is more training on descalating potentially dangerous situations.

In the meantime, cameras that can be monitored from Probation Department headquarters may

Installation of the cameras is estimated to take 21 months to complete. The relatively long-time frame is related to security considerations and the need to move minors from building-to-building construction, according to board documents.

An interim report on improvements to mental health services for justiceinvolved youth is expected in 60 days.

Udochukwu Senior, Ebiriekwe has become a prominent figure at Crenshaw High School. Along with being a multi-sport athlete, he is the ASB Vice President and a member of the sports injury prevention pro-

gram, Team Heal.

During this past season, Ebiriekwe became Coliseum League MVP and was named on the division I All-City First Team. His efforts gave him the opportunity to play in the SoCal Buzz Beach City Hoops All Star Game and in the L.A. Classic All Star Game. He mentioned how the teacher's strike break helped him with his leadership skills.

"It helped me take some time off and just really focus on myself and what I needed

to do," Ebiriekwe said. "After the strike break, it was about me leading my team and helping to win our League.'

David Ortiz Back in Boston After Shooting in Dominican Bar

David Ortiz was back in Boston for medical care after authorities said the former Red Sox slugger affectionately known as Big Papi was ambushed by a gunman at a bar in his native Dominican Republic.

A plane carrying the 43vear-old retired athlete landed Monday night after a flight from the Dominican, the team

Ortiz had been in stable condition in intensive care at a Santo Domingo hospital after doctors removed his gallbladder and part of his intestine, according to his spokesman, Leo López. He said Ortiz's liver was also damaged in the shooting Sunday night.

Ortiz is one of the most beloved figures in sports history in the Dominican Republic and Boston, a fearsome power hitter with a ready smile. He led the Red Sox to three World Series championships, was a 10-time All-

Star and hit 541 home runs.

Dozens of fans crowded the hospital Monday, causing a traffic jam. In the U.S., fans prayed for his recovery and wished him well, with New England Patriots star, Julian Edelman assuring him on Instagram: "Papi, all of New England has your back."

The Red Sox offered "all available resources" and sent an air ambulance to bring him

back to Boston.

"He's on the Mount Rushmore of Boston sports," said Eddie Romero, the team's assistant general man-

The club asked fans to observe a moment of reflection shortly before playing the Texas Rangers at Fenway Park and posted on the videoboard: "We send our love to David Ortiz."

Ortiz was at the Dial Bar and Lounge in Santo Domingo on Sunday night when a gunman approached from behind and shot him at close range in the torso, authorities

The gunman was not immediately identified or arrested and the motive for the shooting was under investigation, with authorities trying to determine whether Ortiz was the target.

The operator of the motorcycle that was carrying the gunman was captured and beaten by a crowd of people at the bar, authorities said.

Eliezer Salvador, who was at the scene, said the gunman said nothing, just fired once. Salvador then drove a wounded Ortiz to the hospital, telling reporters they had a brief conversation in the car as he urged the baseball great to stay calm and breathe.

"Do you have any problems with anyone?" Salvador recalled asking him, to which Ortiz replied: "No, my brother, I've never wronged any-

Salvador held up Ortiz's bloody belongings for reporters, along with some of his jewelry. He also apologized for hitting several cars while rushing to the hospital: "That wrongdoing was justi-

Ortiz's father, Leo, said he had no idea why someone would have shot at his son.

"He is resting," the elder Ortiz said. "Big Papi will be around for a long time."

He added that he is pleased with the medical attention Ortiz has received but that he will be transferred to Boston so he can be with his wife and the Red Sox medical team.

Two other people were wounded, including Jhoel López, a Dominican TV host who was with Ortiz. Police believe López was wounded by the same bullet, said National Police Director Ney Aldrin Bautista Almonte. López was shot in the leg, and his injuries were not lifethreatening, said his wife, Liza Blanco, who is also a TV host.

Police did not identify the third person or detail that person's injuries.

The bar is in a bustling nightlife district packed with dance clubs and expensive bars that Ortiz is known to frequent.

Chicago White Sox pitcher, Ivan Nova, who's from the Dominican, said the shooting rattled him.

"The way that everything is going right now back in my country, I've got to be honest, I'm not very happy to say what is going on right now over there," Nova said. "A lot

Ortiz, who retired after the 2016 season and lives at least part of the year in the Dominican Republic, is often seen getting his cars washed and hanging out with friends, including other baseball players, artists and entertainers.

The Red Sox retired his number, 34, in 2017, and Boston renamed a bridge and a stretch of road outside Fenway Park in his honor. He maintains a home in Weston, on the outskirts of Boston.

Ortiz galvanized the city in the aftermath of the 2013 Boston Marathon bombing that left three people dead, bellowing through a megaphone at Fenway Park: "This is our (expletive) city!"

"In 2013, when we needed David Ortiz the most, he was there for us," Red Sox president and CEO Sam Kennedy said Monday. "Our focus is on his health and on getting him back here for treatment."



Tony Parker Says He's Retiring From NBA After 18 Seasons

Four-time NBA champion, Tony Parker's impressive career is over.

Parker announced Monday he's retiring from basketball after 18 seasons in the NBA. The 37-year-old guard said on Twitter it was an emotional decision.

"It's with a lot of emotion that I retire from basketball, it was an incredible journey!" Parker tweeted. "Even in my wildest dreams, I never thought I would live all those unbelievable moments with the NBA and the French National Team. Thank you for everything!'

Parker played 17 seasons for the San Antonio Spurs and made the postseason every year of his career before joining the Charlotte Hornets last season and missing the playoffs. He was selected to the All-Star team six times and was named second-team All-NBA three times.

Spurs coach, Gregg Popovich said he's loved Parker for a long time and praised him for an "amazing career."

"It has been a blessing to be with him since he was 19-years-old," Popovich said on a USA Basketball conference call Monday. "I have watched him develop as a player and human being and as a business man."

Parker started 1,151 regular-season games and averaged 15.5 points and 5.6 assists per game. He also played in 226 playoffs games, averaging 17.9 points and 5.1 assists.

He won NBA titles with the Spurs in 2003, 2005, 2007 and 2014. He was named NBA Finals MVP in

Parker had one year left on his contract with the Hornets but was not a major part of Charlotte's rotation late last season. He hinted after the season that he might be done playing, so the retirement announcement did not come as a sur-

Hornets general manager, Mitch Kupchak congratulated Parker on a "remarkable career."



For the Toronto Raptors, it's a second shot at a first championship.

For the Golden State Warriors, it'll be a night to play for a fallen teammate and the fans they're leaving

Game 6 is Thursday and the stakes could hardly be higher.

"We owe our fans one more game in Oracle," Warriors guard, Klay Thompson said.

There have been so many already during Golden State's stretch of five straight trips to the NBA Finals, the second-longest run in NBA history. But few had all the drama and emotion that will fill the Oakland air Thursday.

Toronto will bring a 3-2 lead into the building and try again to win a title that seemed so close in Game 5. The Raptors had a six-point to do things a little bit bet-

They can't worry about that now.

"It's not like we're the only team battling," Draymond Green said. "They're battling as well. Everybody is facing fatigue at this point. No one cares who is tired or if you're facing a little fatigue. You've got to do what you came here to do anyway.'

The Warriors are trying to become the 12th team to come back from a 3-1 deficit and only the second in the NBA Finals, after the Cleveland Cavaliers did it against them in 2016. Being back home Thursday is a luxury but certainly no guarantee, not after Toronto won Games 3 and 4 at Oracle Arena to go along with its victory there in the regular season.

So the Raptors won't be

rattled by having to go back there, even though they nearly avoided it.

"We came into this series expecting a long series and we put ourselves in a good position," guard Fred VanVleet said.

A loss Thursday sends the Warriors into a summer they won't be eager to face. Durant can become a free agent and will have to decide where he wants to play — whenever he can play. Thompson's contract also expires, so these could be the final days of a dynasty.

But until then, the Warriors are showing they can win with skill or will. They've beaten teams for so long just because of their talent advantages, but getting this title would require much more than that.

"We made a lot of different statements over the course of these five years," Curry said. "Win or lose, I don't feel like we need to prove anything anymore. It's just about can we get the job done or not."

For years, Datari Turner has been working in the entertainment industry producing films and television shows with no stop in sight.

The independent producer has upward of 30 films nominated for nearly 100 festival awards, founded Datari Turner Productions in 2010, and worked with many TV and films newcomers and legends.


The Oakland native began his career modeling in New York City prior to stepping into screenwriting and production. Turner sites the tragic plane crash of 9/11 and actually seeing the second plane demolish the tower, as a turning point in his life; the beginning of his search for a deeper meaning.

"I had a really great career at the time, but I didn't see myself. I wasn't having fun, and it wasn't my passion," Turner expressed. He spent a month soul searching, tracing back to his childhood hobbies to determine what was most true to his spirit. Ultimately leading him back

His first television show, "Ultimate Hustler" premiered on BET in 2005, marking the beginning of his running career as a producer. Since then Turner has produced upward of 30 films and TV series. Including the hit shows "Growing Up Hip-Hop (Hollywood)," "Growing Up Hip-Hop: Atlanta" and "Shut Up And Dribble." His films include "A Boy. A Girl. A Dream." and "LUV" and more under his 20-year career journey.

"I just try to run my own race; I know what my mission statement is in life and why I'm doing this. I just try to stay focused on that," he says of his determination to continue to create. Elaborating on his mission statement and mantra, "give more than [I] receive," Turner is also driven by the ability to open doors for young screenwriters, producers, and actors to have a shot at Hollywood.

Furthermore, understanding the responsibility as a Black man in the industry, the role, and privilege he owns being able to control much of what he produces and who is involved.

"The imagery that people see on television shapes how people think and shape what they believe in," Turner says, explaining, "I just want to be behind producing conversation pieces and putting out content that is going to portray people looking like me in a positive light. I want to bring attention to things that more awareness brought to them."

After facing much opposition of his own, he values the ability to be able to produce images highlighting positive and truthful viewpoints on some of America's most trying issues. With goals of changing the narrative and restoring the culture he represents.

En suite of his mission, Turner's most recent films depict various forms of the Black experience and will show during the 23rd annual American Black Film Festival (ABFF) in Miami Beach. Films showing are: "If Not Now, When?", focusing on family bonds and forgiveness and "Same Difference" which focuses on mental health. Not only will his films debut at the festival, but Turner will also host a master class detailing the role of the producer in film and television.

American Black Film Festival, is known as the nation's largest gathering of Black film and television enthusiasts. Founded by Jeff Friday, it was created to empower Black artists and showcase quality content by and about people of African descent in 1997.

"I'm excited about it," he says of the four-day festival, further explaining, "I think people of color are having a really great time in business right now, especially women and women of color." Being one of Turner's favorite festivals, detailing events such as ABFF, Sundance Film Festival and South by Southwest Music Festival (SXSW) gives him an opportunity to scout young talent in efforts to fur-

ther his mission. As for the future, Turner is looking forward to giving back, finding young talent to mentor and producing more TV series and films. With an upcoming Netflix film starring Niecy Nash and Courtney B. Vance, "Uncorked," which follows the life of a young Black wine sommelier, Turner just looks forward to continuing in his craft.

"I just want to still be doing this and still having fun when I'm in my sixties and seventies."

Catering. "Á La Carte" centers around an ambitious fashion



Only one African American won a Tony Award despite a slew of nominations that included a historic double-nomination for actor Jeremy Pope ("Choir Boy," and "Ain't Too Proud: The Life and Times of the Temptations") but it was only André De Shields that took home the Tony for Best Performance by an Actor in a Featured Role in a Musical, "Hadestown."





It's a family affair as his other cousin, La'Myia Good, is an actress in the series, playing the crazy boss, and her husband Grammy Award Winner, Eric Bellinger is the music supervisor of the show.

"I wanted to direct 'A

La Carte' because it's a good story. It's a story about human beings and how we're all flawed but still nuanced, graceful, and beautiful in the midst of it," said Talton. "And then my family and friends all get to be part of it, so it became a labor of love."

The entire cast and crew have become friends and family through this Blackowned production.

While the production of the "A La Carte" pilot was almost entirely made up of people of color, the cast and crew show the diaspora through people of multiple Black backgrounds around the world. This was pointed out during the Q&A by Amanda Frezar, who plays Mahogany.


"To have the opportunity to work with this wide spectrum of Black individuals is amazing. I'm Ethiopian and there are a ton of different nationalities working on this show," said Frezar. "I notice, especially in this country, that we encapsulate what Black is when it is a wide spectrum. We need to embrace every single type of Blackness because we all come from Africa. Systemic division is real, but we are all one."


During the Q&A, Meagan Good also led the cast and production team into discussions on their dating lives, social media, and the faith that it takes to work in the entertainment industry.

Health Benefits of California's Paid Leave Policy Out of Reach for Black Women

When you type "maternity leave" into Google images, White women dominate the search results. That is not a mistake. The algorithm is a reflection of who has been centered in policy conversations and benefited from paid family leave policies. We know personally: Black women in California are most in need of an inclusive paid family leave program, but least likely to have it. We come from different backgrounds. Tina worked for Department of Social Services as a data entry operator when she got pregnant. They pinched pennies to get by like many young Black couples. Ashley earned a comfortable wage as a Behavior Analyst while she and her husband tried for a baby. Tina had her son before the state passed the nation's first paid family leave policy. Ashley had her daughter just recently. Yet both of our birthing experiences, 30 years apart, and recent research by Paid Leave for the U.S. (PL+US) highlight that not enough has in California, despite the introduction of policies like paid family leave. For Tina, she was only seven months pregnant when she started having labor pains. Her doctor put her on mandatory bedrest, forcing her to use her 30 days of paid sick days after which she was fired. Then when Tina dilated and started to push, her doctor told her she needed to be rushed to an emergency C-section - he said her son's umbilical cord was wrapped around his neck from the stress of the pregnancy. After a scary 18 hours, Tina's son was born alive and miraculously healthy. Ashley's pregnancy was also difficult from the start. She experienced daily migraines and achy joints, but had to push through grueling commutes to work each day in order to be eligible for state disability and maternity leave through her job. Starting at 31 weeks she went into preterm labor with strong contractions for which she was placed on bedrest. At 34.5 weeks, Ashley was rushed to the hospital for an emergency c-section - she was in lawas in breach. Ashley was able to take three months off work using a combination of partially paid maternity leave and state disability. But it was not nearly enough time for herself or her premie baby. With great hesitation, Ashley returned to work when her daughter was just 14 -weeks-old and still so tiny. Both our experiences are far too common among Black mothers. As a community, we have higher rates of morbidity such as preeclampsia, fibroids, and chronic toxic stress which can put us and our infants in danger. While both our babies survived, Black women and their infants in California - not to mention nationwide - are more than three to four times as likely to die from pregnancy related complication than our White counterparts, as a new report from Paid Leave for the U.S. highlights. Our community's health inequities are a direct result of racism, which has no silver bullet. However, when policies specifically address Black women's inequities, it can contribute to closing these gaps. Just

paid family leave policy: because Black women have a higher rate of dangerous pregnancy complications, we need more time to heal and recover. An expansion of the state's policy to what doctor's overwhelmingly recommend - six months for both infant and parent would be life changing for us, our families, and our community. FISHER AND GREATER ZION ATTRACT ALL GENERATIONS BY 'KEEPING IT REAL'

The Rev. Dr. Michael J. Fisher has been a young pastor throughout his ministry at Greater Zion Church Family in Comp-

As a young adult, he became the spiritual leader of the oldest Black church in the city, following in the footsteps of his father, Pastor Emeritus W. Jerome Fisher. While almost 20 years have passed, he's still a young man, but his youth hasn't stopped him from drawing people of all ages to hear the Word of God.

According to Fisher, his enduring success can be traced to three factors. "Number one, first and foremost, it's all God. It really is. I think God's hand has been very merciful and gracious towards me and my ministry and the church," he said.

Another reason, said Fisher, lies in the legacy built by his father, who served as the pastor for more than four decades. During his tenure, the elder Fisher oversaw tremendous spiritual and numerical church growth, established tangible community outreach programs, expanded the physical campus and emerged as a leading advocate for social and racial justice.

The third component that has aided the Fisher's ministry comes from adhering to the advice of his father. "At the beginning of my ministry, my dad told me, 'don't dress up Jesus. Just preach naked Jesus. Don't try to modernize

Him. Just stick to the Word and the Bible. The Bible works for all generations," recalled Fisher. "So, I don't try to find something cool to do. I think I just keep it real and relevant and speak from the Bible."

Explaining how he applies that philosophy, he cited the various challenges that people face at every stage of life where they seek answers to their dilemmas.

"If you point them to the Word, all of a sudden your ministry becomes relevant to them, whether they are 13-years-old stressed out about bullying or whether they are 85-years-old worried about health insurance," insisted Fisher. "All generations want to feel that there is a God who loves them, there is a God who can redeem them and there is a God who can save them."

With Greater Zion's large, multigenerational congregation, Fisher also emphasizes understanding and respect between the different age groups. To older members, he offers gentle reminders that they once were young and may have conducted themselves in manner viewed as radical at the time. His aim, with this strategy, is to guide older people towards appreciating the cultureshifting ways of the youth.

His message to young people stresses extending honor, respect and involvement to older members because "one day, you will be

where they are." Fisher also encourages youth to learn

from the principles espoused by elder parishioners and consider incorporating those values into their lives. "So, we have

expressing their love for building upon. God," noted Fisher.

"And we have young people who know how to lift up hymns and lead the devotion in

"It's about understanding and teaching each generation to understand one another's approach and bringing it back to the fact that it's all about Jesus. If the message stays the same and you're not compromising the message, you can embrace the style," he said.

boys transitioning to men. The Pray Provide #PUSH100 Initiative has received notable acclaim as well. The initiative is comprised of several projects such as hiring events to match formerly incarcerated people with companies seeking employees.


"We make agreements with certain companies that we will vet the people in advance and the company will, in turn, to hire anybody that comes, even if they are a felon or have a record, just to give them a chance. They've been through our new members program, we have a relationship with them and we can hold them accountable," Fisher said.

"That's exactly what Jesus does for us with God. He serves as our representative, so the church tries to serves as the formerly incarcerated person's representative and it works. In the last two years, we've actually been able to help over 600 people get jobs, who otherwise never would have been employed."

Looking towards the future, Fisher aims for Greater Zion to achieve even more for the cause of Christ. He envisions the church as "a hub center for worship on Sunday and Wednesdays" and also purchasing another facility to operate a charter school, dance academy and a range of community programs during the week.

Praying that his plans are "God's will," he added, "I believe that the church shines bright in the midst of darkness, so my message to everybody would be don't allow what we're seeing on the news to cause us to become discouraged. Actually, allow what we're seeing in our culture to motivate us to shine the light of Jesus Christ more now than ever!"
