District Attorney Files Charges Against Councilman Curren Price

Price Vows to Fight to Clear His Name Against Unwarranted Charges


Angeles City Councilman Curren Price was charged Tuesday, June 13, by the Los Angeles County District Attorney with multiple counts of embezzlement, perjury and conflict of interest, according to a press release sent out by the District Attorney's Office.

Price faces five counts embezzlement government funds, three counts of perjury and two counts of conflict of interest, according to a statement from the District Attorney's office.

Council President Paul Krekorian, in a statement released Tuesday afternoon, announced that had made the decision to step down as council president pro tem, and was surrendering all of his committee assignments. Price, however, did not state if he would be resigning from the council.

"While I navigate through the judicial system to defend my name against unwarranted charges filed against me, the last thing I want to do is be a distraction to the people's business," Price stated in a letter.

Price ended letter by writing that he looks "forward to having the opportunity to

continue to be a strong voice for our culturally rich South Central, a part of our city that has long disenfranchised, overlooked and forgotten."

Price was charged for having a financial interest in projects that he voted on as a council member, and having the city pay nearly \$34,000 in medical benefits for his now-wife while he was still married to another woman, Los Angeles County District Attorney George Gascón said in a statement.

Between 2019 and 2021, Price's wife allegedly received payments totaling than \$150,000 from developers before Price voted to approve the projects, according to Gascón's statement. He also is accused of failing to report the income that his wife received on government disclosure forms.

"This alleged conduct undermines the integrity of our government and erodes the public's trust in our elected officials," Gascón said.

spokesperson, Price's Valencia-Angelina said in a Dumarot, statement: "We have not seen the charges filed Councilmember Curren Price. It's highly unusual for charges like this to be brought up against a

sitting City Councilmember without any prior notice or discussion.

"Curren Price is a longstanding a public servant who has given his life to the City of Los Angeles. He looks forward to defending himself once he's had an opportunity to address these charges."

Zach Seidl, spokesperson for L.A. Mayor Karen Bass, issued a statement saying, "The mayor has yet to review the charges filed earlier today but she is saddened by this news."

Price has represented the 9th District, which includes most of South Los Angeles and Exposition Park, since 2013. He previously served in the state Assembly, state Senate and the Inglewood City Council.

The charges against Price, 72, are the latest political scandal to rock City Hall. Former City Councilman Mark Ridley Thomas was convicted earlier this year on federal corruption charges in a scheme in which prosecutors said he promised to help steer a multimillion-dollar government to USC if his son got a scholarship and a teaching job. Ridley Thomas is fighting the conviction and is scheduled for a hearing on June 26 to contest the



Southers Embraces Role as Vice President of Los Angeles Police Commission

Southers joins fraternity brothers William Briggs and Brian Williams as part of Mayor Bass' public safety team.


Dr. Erroll Southers, an internationally recognized law enforcement expert, was recently elected as vice president of the Los Angeles Police Commission, bringing his years of expertise to Mayor Karen Bass' public safety team.

Currently the associate senior vice president of Safety and Risk Assurance at USC, Southers has experience in the field on the local, state, and federal levels. Also, he has maintained a 40-year relationship with LAPD and police departments across the world, all of which makes him imminently qualified for his new role.

Explaining his reasoning for accepting the volunteer assignment, Southers said, "First of all, I am a huge supporter of Mayor Bass. I have known her for more than 15 years and worked very closely with her when she was in Congress."

As for his credentials, he noted, "I have a national security, homeland security and law enforcement back-

ground. Also, I have testified before Congress and the Senate and before the Congressional Black Caucus."

Southers' extensive qualifications stem from previously serving as an FBI SWAT agent, deputy director for critical infrastructure under Governor Arnold Schwarzenegger, assistant chief of homeland security at Los Angeles World Airports, and on the Commission of the State of Hate appointed by Governor Gavin Newsom.

Also, he was President Obama's first nominee for TSA assistant secretary, served as assistant vice president/chief of protection services at the L.A. County Museum of Art, and taught classes in national and homeland security at USC. The combination of his experiences will be an asset as a police commissioner, according to Southers.

"I'm engaged right now in a listing tour in the department, and I hope to be engaged in the same listening tour in the community," said Southers, who earned Master's and Doctoral degrees in public policy from USC.

"I'd like to be more engaged, listen to people. We all talk about building trust. We all talk about transparency, but now I'm in a position to implement that and see that it happens. So now it really is about walking the walk. I'd like to have people look back on my tenure and say there was some real changes."

The vice president also plans to interact with the LAPD workforce to learn about employee issues and concerns. Having been a police officer in Santa Monica. Southers said it was important to "have the buyin of the rank and file."

"One of the things I've heard so far is they (LAPD staff) believe that I'm a Commissioner who knows what they go through. I've been a police officer and an assistant chief, so I understand what it's like," he

"I connected with Brian when he was at the Sheriff's Department," said Southers, referring to Williams' prior job as executive director of the Sheriff Civilian Oversight Commission.

"One day at the Commission, I'm having a conversation in William's (Briggs) office, and I just happen to say, 'you know, Brian and I are brothers – Alpha Phi Alpha.'

"William started laughing and that's how we found out. So, for me, I was appointed by the mayor to join two other family members. There's an automatic level of trust and respect," he insisted.

Southers plans to convey equal trust and respect to the public and employees during his term on the Police Commission. Also, he intends to be guided by his mantra, which is a saying that his father quoted to him - you can't change the castle from outside the moat.

"That's been my mantra throughout my career. I've been inside the 'castle' of several law enforcement agencies and now I'm in a position to actually impact the work, the policies and the strategies that are in place in the department," he said.

"And I just look forward to working with people and hearing the views and opinions of others."

GRID LA and Chase Bank join forces in celebrating Behind the Walls Solar Workforce Training Program

On Thursday, June 8, GRID LA and Chase Bank held a press conference at the Crenshaw Branch of Chase, celebrating the \$500,000 award that GRID was given from JP Morgan Chase Bank in support of their Behind the Walls Solar workforce training program. GRID LA states that they are a 501(c)3 not-for-profit organization established in

2007 and serving Los Angeles, Orange and Ventura Counties, with their innovative approach they combine learning with industry where their solar installation trainees receive a no-cost education while installing solar electric systems for families in underserved communities who are receiving no-cost cool roofs, solar systems, and battery storage.

GRID LA explains that their Behind the Walls train-

ing program will "prepare women who were formerly incarcerated in LA County Lynwood Women's Jail for career opportunities in solar and renewable energy. The 13-week, paid program will provide hands-on training for solar panel installation, along with job placement support for those who successfully complete the program. Grid LA won this award as a part of JPMorgan Chase's Annual Challenge

2018 and sources innovative and sustainable ideas to advance equity in the United States. This year's competition called for projects focused on supporting women of color, and GRID GLA is one of just eight winners selected nationwide from more than 200 applications received."

Solar panel installers have a wide range of duties including selecting mechanical designs, diagramming layouts and locations for photovoltaic arrays, as well managing operating systems for the equipment. With such technical work, two graduates of this training program gave attendees a demonstration on the process of installing a solar panel to give a broader vision of the work they do.

Shameka Dixon, Director of Workforce Development at GRID Alternatives Greater Los Angeles discussed the journey towards being accepted for this award "everything came full circle, and at first I didn't think we were going to get it; I was nine months pregnant, I only had one other person to write this grant with and we put all of our effort in. We partnered with CEOs at Behind the Walls and we looked to our team and the work we have done. We are honored that we are able to do this work, especially in South LA, Pacoima, and the Greater Los Angeles area and we are so grateful."

Chase also continues to do their part in supporting formerly incarcerated individuals by implementing their own policies to eliminate discrimination including their "ban the box" which removes questions about criminal backgrounds on job applications. They have implemented community hiring models nationwide to ensure they are working with their communities to employ individuals that may have a criminal record. With the influence of their Second Chance Policy Agenda, they have fostered success from the many policies and clean

state legislation.

Congresswoman Sydney Kamalger-Dove hosts **Environmental Funding Roundtable**

On Friday June 9, Congresswoman Sydney Kamalger-Dove in collaboration with U.S Environmental Protection Agency Regional Administrator Martha Guzman hosted an environmental funding roundtable to discuss issues surrounding climate change and environmental justice at the Beehive in Los Angeles.

Opening with welcoming remarks by Kamalger-Dove and Guzman, participants then separated into three breakout sessions on Environmental Justice Block Grants, the Brownfields Program, and the Greenhouse Gas Reduction Fund with focus on Ports and Clean Heavy-Duty Vehicles. Participants were able to learn about these

new initiatives and ask questions to EPA representatives.

With many participants being representatives of many community groups and non-profit organizations, questions were raised to the EPA regarding these grants, and how the EPA can ensure that every organization is getting equal opportunities to get funding and support during the application process.

Kamalger-Dove discussed the Inflation Reduction Act (IRA) which was created to provide action towards reducing U.S. emissions by 40% by 2030 with support from the EPA six new programs to provide funding to disadvantaged communities and non-profit organizations. The EPA states that they received \$41.5 billion dollars in appropriated funds from the IRA to support 24 new and existing programs.

Among these new programs are the Greenhouse Gas Reduction Fund which is a program that aims to reduce greenhouse gas emissions and air pollution, in turn providing more clean energy resources to lowincome communities from the support of their local non-profits and community leaders. The Climate Pollution Reduction Grants will also be supporting greenhouse gas emissions and air pollution reduction but will provide grants to states, territories, tribes, agencies and local governments. The last of these programs is the Environmental and Climate Justice Change Program which will provide funding under the activities involving financial and technical assistance for communitybased nonprofits, tribes, and local governments.

The biggest of these breakouts was the session on the Environmental Justice Grants where many nonprofit leaders asked questions for guidance and input on how to make this process even better. While many of the applications are now closed, the Environmental Justice Thriving Communities Grantmaking Program is still open and will be funding up to 11 grant makers nationwide to provide subgrants to community-based nonprofits to reduce the barriers that community-based non-profits face when going through the grant's application processes, in turn increasing efficiency and lowering stress on applicants. Recipients of this grant will receive \$50 million per award, and the grantmakers will sub-

award grants to CBOs. The application deadline is June 30, 2023.

Congresswoman Kamalger-Dove encourages local non-profits to apply, and shared this, "we want to hear the input from these leaders about how to make sure we can formalize the process of getting this money into the community within such a small amount of time. We are so happy to have had this event to be able to hear from the source about how we can make this work."

With so much money being given to these communities, under the IRA, all of the money must be used by 2026 and the EPA as well as Kamalger-Dove and Guzman encourage organizations to apply, and participate in roundtables like this to make their voices be heard, and get this money out into the community as quickly and efficiently as possible.



Juneteenth 2023: California Celebrates Black Freedom

Juneteenth officially became a federal holiday in 2021 when President Joe Biden signed the Juneteenth National Independence Day Act into law.

Even before that national proclamation, Juneteenth had been recognized as a holiday in California.

California Black Media spoke with Ronald Preston Clark, a writer and educator in San Diego. He shared his perspective on the holiday and how, even though he grew up in a family connected to Black culture, he did not really appreciate the full significance of the Juneteenth until he was a student at Hampton University, a Historically Black College and University (HBCU) in Virginia.

"I didn't start to look into celebrating it until being surrounded by the excellence at Hampton. As I've gotten older, and further into my teaching career, I have been more intentional with my celebration and understanding of Juneteenth. I am now sure to educate others on its significance," he said.

Clark is not alone in his experience. For many Americans – including some Black Americans --Juneteenth was not celebrated in their families or taught in schools. It wasn't until activists and historians led grassroots movements for decades that the holiday became more widely recog-

While Clark says he is happy to celebrate Juneteenth with his family and to see the holiday gain national recognition, he doesn't want it to turn into a commercialized event like other cultural holidays.

"We should always remember that the reason for the holiday is that our ancestors were set free - two years after they should have already been free. And then the years that followed were still filled with violence, hatred and bigotry towards

History of Juneteenth

Juneteenth marks the anniversary of June 19th, 1865, when enslaved African Americans Galveston, Texas, were notified by Union soldiers that they were free under the Emancipation Proclamation.

Two and a half years earlier, on December 31st, 1862, enslaved and free African Americans gathered in churches and private homes across the country to celebrate what was known as "Freedom's Eve."

They were anticipating news that President Abraham Lincoln's proclamation that ended slavery in Confederate States had become official on January 1,1863.

However, not everyone in Confederate territory would immediately be free. Even though the Emancipation Proclamation took effect in 1863, it could not be implemented in some places in the deep south still under Confederate

As a result, in Texas, the westernmost Confederate state, enslaved people would not be free until approximately 2,000 Union troops led by Major Gen. Gordon Granger arrived in Galveston Bay on June 19, 1865. and announced that the more than 250,000 enslaved

The California Black Women's Collective is joining GirlTrek, a national Black women's health movement, to celebrate Juneteenth with a walk in solidarity with others across the country.

How Four California Cities are Approaching Reparations for Black Residents

The California Reparations Task Force to Study and Develop Reparation Proposals for African Americans will hold its last in-person meeting on June 29, in Sacramento. The meeting will take place in the First Floor Auditorium months, while the state of the March Fong Eu Secretary of State Building, located at 1500 11th Street.

The task force will submit its final report to the California legislature. If approved, California could become the first state to provide reparations to the descendants of enslaved Black Americans.

Task force vice-chairperson Rev. Amos Brown said the state legislature must "do the right thing" before leaving San Francisco for a speaking engagement in Jackson, Miss., to recognize the 60th year since NAACP field secretary Medgar Evers was killed on June 12, 1963.

"It's now time for some deliberate action," said

Brown, the pastor of Third Street Baptist Church in San Francisco. "If they don't provide support, action, or forms of reparations in this nation, and in this state, they will be giving credence to bigotry, racism, and inhumanity towards Black folks."

During the past 24 reparations task force held justice

In June 2021, the city of Los Angeles established the Reparations Advisory Commission (RAC), a seven-member task force comprised of activists, academicians, attorneys, racial

The committee is committed to reducing violence, addressing health disparities and preventing over-criminalization African Americans.



The chief economist for the American Federation of Labor and Congress of Industrial Organizations (AFL-CIO) and a former chairperson of the Economics Department at Howard University, Spriggs, 68, held several economic policy positions in the federal government, spanning two presidential administrations.

Among those mourning his passing is U.S. President Joe Biden. "I am deeply saddened by the passing of Bill Spriggs, a man who brought as much join him in the pursuit of economic justice."

In March, Spriggs was among four economists who developed formulas estimating that the amount California owes Black residents who are descendants of enslaved people in the United States is likely to exceed \$800 billion.

California State Library **Expands to Provide Free Books to Children Across**

California Last week, the Califor-State Library announced the expansion of its resources and services partnership with Imagination Library. This program, started by the Dolly Parton Foundation, provides free books monthly to all children in the state under the age of five. Gov. Gavin Newsom's office collaborated on this effort. To date, Imagination Library has distributed 200 million books to children in five different countries.

"Reading is a team sport," said California Librarian Greg Lucas. "The more that you engage a community and get people to understand

the value of creating stronger readers, the more successful the program will be and the stronger and more resilient the community is going to be."

First Partner Jennifer Siebel Newsom attended the launch ceremony and stated that "reading to kids early and often is good for their literacy and a great way to begin to cultivate a lifelong love and appreciation for reading.

The program's expansion was driven by bipartisan legislation signed last year by Gov. Newsom. The bill -- authored by Senate President pro Tempore Toni Atkins (D-San Diego) and Senator Shannon Grove (R-Bakersfield) -- provides a dollar-fordollar match from the State Library to help local organizations that partner with the Imagination Library to sign up more children to receive books.

Newly Released Census Data: Most Californians Are Renters and They Are Not Doing Well

Last week, a new report based on census data was released showing the impact of California's high cost of living on people who earn the lowest incomes in the state.

According to census data, 45.5% of homes in California are occupied by renters, second only to New York at 49.7%. Nationwide, the rate of renter-occupied housing units is 36.9%, the highest it's been since 1970.

United Ways of California uses data such as the costs of food, health care, childcare, transportation and other basic needs to compile its "Real Cost Measures of Living in California" report.

According to the study, African American and Latino household seem to be struggling the most.

51% of Latino households fall below the Real Cost Measure compared to 45% of African American households, 30% of Asian American households, and 23% of White households.

Factors contributing to California's high renting percentage are housing prices and having a larger immigrant community that the rest of the United

Last week, some California lawmakers held a rally to raise awareness about a proposed amendment, authored by Assemblymembers Isaac Bryan (D-Los Angeles) and Ash Kalra (D-San Jose), that would make adequate housing a constitutional right.

Governor Gavin Newsom Announces the Launch of **Gun Safety Website**

On June 5, Gov. Gavin Newsom announced the launch GunSaftey.ca.gov, a website that provides information on how Californians can obtain and use Gun Violence Restraining Orders (GVRO) to protect their loved ones.

A GVRO, is a temporary action taken by a local court when someone is at risk or causing harm to themselves or others. The individual in crisis cannot purchase or possess firearms or ammunition while the order is in place.

"California is taking aggressive and relentless action to end the unbearable tragedy of gun violence," said Newsom at the launch event. "While other states remain complacent in the face of recurring, gut-wrenching tragedy, California is making it easier than ever to access commonsense tools like Gun Orders to protect our communities."

Republican Lawmakers Hold Anti-Fentanyl Rally

On June 6, Republican lawmakers held an antifentanyl rally in Sacramento to announce the introduction of Assembly Constitutional Amendment 12. The amendment, also known as "Alexandra's Law," would require the state to issue a warning to convicted fentanyl dealers advising them that continuing to sell fentanyl is extremely dangerous. The warning would empower prosecutors to file homicide charges if the dealer continues to sell fentanyl and causes a death.

"Alexandra's Law is a simple and reasonable approach to holding drug dealers accountable when they knowingly murder Californians with fentanyl," said Matt Capelouto, whose daughter Alexandra died in 2019 from fentanyl poisoning and inspired the law. "It will give law enforcement the ability to stop someone who continues to sell a drug that results in instant death."

The California Department of Public Health reports that about 6,000 Californians died in 2021 from fentanyl-related overdose. The Republican Caucus noted that this was an average of 110 people a week.

"I have been clear that we must take a multipronged approach to fully tackle the fentanyl crisis," said Assemblymember Joe Patterson (R-Rocklin). "We cannot rely on education and treatment alone. It is critical that we give our law enforcement the tools necessary to hold dealers and sellers accountable."

Bill Proposes Teaching Media Literacy at Each Grade Level in California

Two bills aimed at equipping K-12 students with the ability to discern between accurate and false news -- and teach them media literacy, more broadly – are currently progressing through the California legislature.

acy, develops students' critical thinking skills around all types of media platforms and instructs students to evaluate online information that affects them, their communities, and the world.

AB 873 intends to direct the Instructional Quality Commission (IQC) to incorporate media literacy con-



AB 873 intends to incorporate media literacy content into the English language curriculum.

Assembly Bill (AB) 873, authored by Assemblymember Marc Berman (D-Menlo Park), and AB 787 by Assemblymember Jesse Gabriel (D-Woodland) would mandate that schools in California offer instruction at every grade level to promote a more informed and civically engaged society.

As of June 7, both AB 873 and AB 787 are pending review on the Senate floor and have been referred to the Education Committee.

"Children today are being inundated by misinformation and disinformation on social media networks and digital platforms," Berman said in a May statement. "The last few years have been a terrifying wake-up call to the insidious nature of online misinformation, from jeopardizing public health, to threatening the foundation of our democracy, to dangerously rewriting history. Anyone who spends much time on social media could greatly benefit from media literacy training."

Media literacy, also known as information litertent into the English language arts/English language development, science, mathematics, and history-social science curriculum frameworks when those frameworks are next revised.

A growing number of states are now requiring schools to educate students in media and information literacy, including New Jersey, Illinois, Delaware.

"This bill is an important step to help ensure young people are equipped with the relevant media and informational literacy skills so critical in the 21st century," said Nicholas Harvey, K-12 Policy Director for Generation Up.

AB 787 would require, on or before January 1, 2025, the State Superintendent of Public Instruction (SPI) Tony Thurmond, in consultation with the State Board of Education, to survey teacher librarians, principals, and technology directors to monitor how they are currently integrating digital citizenship and media literacy education into their cur-

AB 787 would also

require Thurmond to share the results of the survey with an advisory committee consisting of specified representatives.


A 2022 Pew Research Report found that the number of teens who use the internet at least once a day has increased by 5% since 2014-2015. Many of these teens are active on popular social media platforms such as Twitter, Tik Tok, Snapchat, Facebook, and Instagram. Currently, 97% of teens report using the internet daily, compared with 92% in 2014-15.

Pew Research Center reports from 2018 and 2022 also found that 95% of teens have access to smartphones, and 45% are online more frequently. In addition, the reports stated that 56% of Black teens are online, compared to 55% Latinos, and 37% of White

"If these practices are important and salient to our youth, then it is critically relevant for educators to acknowledge this insight as they teach, and for researchers to write about studies in humanizing ways," according to a January 2023 International Literacy report titled, "Normalizing Black Students/Youth and their Families' Digital STEAM Literacies."

Common Sense Media's California policy manager Kami Peer, a nonprofit focused on youth and media, told the Napa Valley Register that Berman's and Gabriel's legislation would change the way student's use the media to obtain information and handle ever-changing digital tools.

"We believe these two bills, if signed into law, would bring California to the forefront of this important policy area and ensure our students are wellequipped to face the rapidly evolving digital, online landscape," Peer said.



conviction.

"I have immense respect for Curren Price. He's been a strong colleague on so many issues," Councilwoman Nithya Raman told Eyewitness News. "I'm saddened by the news and looking forward to reading what is in these documents.

"I don't want to say anything beyond that, but I will say as somebody who goes out there every day and is really trying to build trust in the city, and the work of the city during a moment of real crisis, every time there's a news story like this I feel it makes it a little harder for us to go out

there and do that, and that's tough."

On Wednesday, June 14, Krekorian introduced a motion to suspend Price, pursuant to Section 211 of the City Charter. The council's Rules, Elections Intergovernmental Relations Committee will hold a hearing on the motion, then the motion



will be taken up by the full council for a vote.

This action is similar to against former Councilman Ridley-Thomas following indictment charges, however, the council had reinstated his salary until he was convicted in late March.

The belief is that even if Price is suspended, his pay would remain intact the steps that were taken until such time as he is either found innocent or convicted.

> If the council ultimately makes the decision to suspend Price, Krekorian said he would "immediately appoint a caretaker" to

ensure that the work of the Ninth District office continues. Krekorian said the caretaker could be a temporary voting member.

Price was not taken into custody and the District Attorney's office said that "arraignment will be scheduled for a later date."



Former President Trump Arrested, Booked, and Pleads Not Guilty to 37 Charges

With crowds filling the area around the courthouse, the unprecedented scene unfolded as a symbolic embodiment of remarkable knack for theatricality, further punctuating his notorious legacy as the first President twice impeached, to face civil sex harassment charges resulting in a lawsuit loss, and to be indicted on state criminal charges.

Now. another dark this milestone joins extensive list, as he becomes the first President to face federal charges, including allegations connected to the Espionage Act, leaving his supporters stunned and angry.

Trump made his first appearance Tuesday, June 13, entering a plea of not guilty to 37 charges related to the alleged mishandling of classified documents.

As he went through the booking process with deputy marshals, authorities took electronic copies of Trump's fingerprints but omitted taking a mugshot due to his notoriety as exPresident. The hearing marked the escalation of legal jeopardy for the 2024 GOP front-runner, with special counsel Jack Smith in attendance.

The charges brought forth by the Justice Department's classified documents case against Trump include 37 felony counts.

The allegations illegal involve retention national defense information the concealment of documents violating witness-tampering laws in the Justice Department's ongoing investigation into these materials.

Trump's close aide, Walt Nauta, was also indicted and faces charges related to a conspiracy to obstruct the federal investigation. Nauta was also booked and

A bystander reportedly asked the former President about his emotions as they left his Doral resort in a motorcade with Nauta in a different vehicle. Trump responded with a confident wave, stating that he was feeling "great."

However, before the

court appearance, Trump took to social media, expressing his belief that it was "ONE OF THE SADDEST DAYS IN THE history OF OUR COUNTRY. WE ARE A NATION IN DECLINE!!!"

The hearing presided over by magistrate judge Jonathan Goodman, both operated as initial appearance and an arraignment. Aileen Cannon was randomly selected as the trial judge in the case, but Goodman filled in for the arraignment.

Cannon, a nominee who received criticism in the past for her decision to order a thirdparty review of an FBI search at Mar-a-Lago, saw that decision overturned by a conservative appeals

Many legal experts have suggested Cannon recuse herself. So far, there's no indication she will step

Goodman ordered Trump not to discuss the case with Nauta.

The case began an anticipated lengthy and dramatic judicial process involving criminal proceedings and potential appeals that could unfold over several years.

Notably, Trump already faces separate criminal charges from New York City's local prosecutors, stemming from an alleged hush money scheme during

the 2016 campaign that included accusations of falsifying business records.

Last month, a civil jury found Trump liable for the sexual harassment of writer E. Jean Carroll in New York.

The former President, who lost his 2020 reelection bid to Joe Biden, could also face more indictments including in Atlanta and in Washington.

Respectively, those cases are related to his allegedly tampering with the presidential election in Georgia, and his role in the January 6 riot at the U.S.

The DOJ documents case potentially carries a prison sentence that could stretch for decades.

Among the counts, 31 pertain to the willful retention of national defense information, irrespective of classification.

In addition to the obstruction conspiracy charge, Trump faces four counts related to document concealment and a false statements charge.

prodigal wastes the wealth on wild wayward living. The son placed no value on what the father went through to accumulate the wealth to give an inheritance.

We live in a day and age where good Black fathers are criticized, condemned, criminalized. not talking about sperm donors and absentee baby daddies who don't take responsibility for the babies they made. I'm talking about Black fathers who go to work every day to provide for their families, care for their children and scold their children when wrong and forgive them for their mistakes.

often fail to remember the racism, discrimination, and oppression that Black fathers have faced for over four hundred years - lest we forget the first 20 Black slaves brought


to Jamestown, Virginia in 1619. Have we forgotten that slavery was abolished in 1865, but Jim Crowism started the same year.

Jim Crowism gave birth to the "Black Codes" that restricted Black fathers' ability to earn money to provide for their families.

Jim Crowism relegated Black people universally Black fathers specifically to segregated seating on bus and trains, as well as waiting rooms, water fountains, bathrooms, building entrances, elevators, cemeteries, swimming pools and amusement parks. (Plessy v. Ferguson in May 18,

While the police arrested and incarcerated Black fathers, the Ku Klux Klan beat, lynched, and struck fear by terror showing that Black Lives Don't Matter.

Lest we forget that the local laws forbade Black fathers from purchasing and renting homes in White neighborhoods.

fathers incarcerated at twice or three times the rate of white fathers. Black fathers have the lowest employment and second unemployment rate in America.

Black fathers have the highest mortality rate in America. Black fathers suffer from prostate cancer, heart attacks, and lung cancer at a higher rate.

The truth is, Yes, some Black fathers are absent. Yes, some Black fathers are complicated. Yes, some Black fathers have dropped the ball. But we must investigate the rest of the story.

I was the prodigal son. I benefited from my father's wisdom and income as a child. I did not value my father's contribution to the family. I did not value the challenges he went through as a Black man in America. I do now!

I joined church at 27, but I started valuing the resurrection at 34. When I discovered he had lung and prostate cancer, I prayed for the Lord to forgive me for holding on to so much

God told me to seek my father's forgiveness. I obeyed. My father forgave me. We reconciled. My father accepted Christ. When he earned heavenly wings, I rejoiced knowing we will meet again.

Forgiveness may be the hardest thing you do, but it will also be the most rewarding. Forgiveness is not a sign of weakness, but a sign of strength and love. Forgiveness is a powerful act of love and grace God has given us.

Thank you, God, for forgiveness!

Our work on diversity, equity, and inclusion is a long-term commitment, and I am proud to be leading a dedicated team that is committed to driving positive outcomes for our employees, customers, and communities.

What part of your work are you most passionate about?

I'm most passionate about helping people achieve their financial goals, one of which would be homeownership. Homeownership is still the single largest financial purchase that most people will ever make, and it creates independence, stability, and generational wealth. As the new head of DSRI, I am excited about two primary opportunities: 1) Helping to identify opportunities and programs that address the inequities in our financial system for underserved communities; and 2) Helping to inspire a culture that allows people to bring their whole selves to work to contribute to our business objectives.

One of the first things you did when you assumed your role was schedule a listening tour. Why was this important to you?

It was important to me to create excitement and engagement around this work. I wanted to hear employees' and community partners' voices and give them a chance to share their experiences and perspectives on how we are doing as an organization in the DE&I space. It gave me a chance to listen and learn and will help inform our go-forward strategy for building a more diverse and inclusive culture at Wells Fargo and to improve our relationships and outcomes for our customers and in the community.

Why is it important to create an inclusive culture in the workplace?

What is one piece of career advice you can give to our readers?

My advice is to be your authentic self. Throughout my career, I have often been the only Black woman in the room. I learned that being who I am and offering my point of view no matter what room I was

in, allowed me to stand out because my perspective was often different than anyone else. Not to mention, I'm more comfortable being me than doing anything else so I show up fully congruent in my words and actions. Never be afraid to be who you are, put your opinions out there and be bold. When you're in the room, bring your authentic voice, be intentional, and don't play it safe.

you've spoken about the importance of authentic leadership. How do you embody this every day?

I am typically the "double only" (Black woman) in the room. I feel as if it's my obligation to bring the voice of others into the room and to offer a different perspective. If I don't speak up, authentically, I've missed the opportunity to challenge thinking.

We understand you have deep ties to Southern California. Tell us how that shaped your life.

I was born in Compton, California. Both sides of my family are there and my parents went to rival high schools in South Central Los Angeles. My father has the distinction of being the first Black head coach at a Division I university. He was the track coach of the University of Arizona. South Central Los Angeles was 99.9% Black and then we moved to Tucson, Arizona, where it was 99.9% white. My upbringing was traversing both worlds. I grew up never being Black enough for Black kids and not white enough for white kids, so I just learned to be authentically me.

After graduating from the University of Southern California, what were your career aspirations?

I always dreamed of going into business and wanted to work on Wall Street, but the stock market crashed right before my graduation and I thought about other career options. My first job out of college was selling hospital supplies, then I soon transitioned to a role in Human Resources. I spent 15 years in Human Resources, and it wasn't until I joined Fannie Mae, that I engaged with Mortgage Back Securities and got the interaction working with Wall Street. It's amazing how life always seems to come full circle.

As someone with so much responsibility, what do you do to unwind?

I'm the daughter of a track coach so of course my "go to" is to run! I also enjoy dinner with friends because it is a great way to connect, to experience fellowship, and to affirm each other.

What is one of the most memorable highlights of your career?

In October 2021, I was sworn in as the chairman of the Mortgage Bankers Association. As the first Black and only fourth woman in the 109-year history of the organization to hold that role, this was among my proudest moments. College's Pan African Alliance organizes culturally-specific event to highlight the achievements of SMC's 405 Black graduates

A joyous event held on Friday, June 9, emphasized the persistence and achievement of the 405 Black students who are graduating this year from Santa Monica College (SMC).

The event, held at John Adams Middle School (JAMS) auditorium in Santa Monica, was organized by the SMC Pan African Alliance. A dinner reception for graduates and their families/guests followed the graduation ceremony.

The culturally-specific ceremony featured, among other highlights, a performance of the Black national anthem "Lift Every Voice and Sing" by SMC English professor Clay Barham, pouring of libation by Sherri Bradford and Cameron Terry, an address by student speaker Jasmine Christmas, and a keynote address by SMC psychology department chair, scholar and educator Dr. Chanté DeLoach.

SMC Superintendent/ President Dr. Kathryn E. Jeffery also had a message for the graduates: "You are shining stars and all of us at SMC celebrate and congratulate you."

"Knowing where these students come

from, knowing what they've had to go through ... to be able to complete their studies and be celebrated this way with our first African-American ceremony is just a joy," said SMC Board of Trustees Chair Barry Snell. "I feel warm all over, and I'm just excited for what we're bringing out of Santa Monica Col-

The SMC Pan African Alliance leadership Communication Media Studies professor Dr. Jermaine Junius, president; math professor Kristin Ross, vice president; and Black Collegians Student Services Specialist Jocelyn Winn, secretary/treasurer had a special message for the graduates, printed in the program.

The message read: "We see your beauty and brilliance and understand the unique value that you bring to the college and the world," they wrote.

"So, as you go out into the world and continue to pursue your educational endeavors, keep striving. As the inaugural class of SMC's 1st Annual Black Student Graduation Ceremony, you are already ambassadors of change."

SMC Black Collegians Umoja Community faculty leader and long-

time counselor Sherri Bradford stated that "it [was] so amazing to be able to be in a space where we are able to honor our Black students . . . how powerful it is to have everybody in the space to honor [them]!"

Among the graduates were a couple: Taylor Kennedy Dannon Gary Mitchell and her husband Jeyde Mitchell. By sheer chance, they are also transferring to the same university: Cal State Los Angeles.

Taylor is graduating with an Associate's Degree for Transfer in Business Administration and Jeyde is graduating with an Associate's in Studio Arts. Taylor is "beyond thrilled . . . blessed . . . elated!" about all of this.

How did they make happen? "Hard work," Taylor said, "and we were both on the

same page about wanting to be successful in life. Graduating college was really important to us because we are [both] first generation graduates in each of our families."

Jeyde added that college was difficult, but "with a lot of organization [by] my wife, keeping me on track and having a set schedule and just understanding where we can fit certain aspects of school and knowing our limit," they were able to balance college

Keisha Hammond previously graduated from SMC with an Associate's in Health & Behavioral Sciences. She came back to take some science classes needed in order to apply for a Master's in Public Health and registered dietitian program, and in the process earned another Associate's degree, with honors.

"It was beautiful to be surrounded by professors that look like us and students that have had the same struggles," Hammond said. "I really want to give a special thank you to SMC's Black Collegians program because they gave us a sense of community and belonging."

Cree Kawa, who is grad-

uating with an Associate's degree in Liberal Arts says he chose Santa Monica College to "get away from the Valley."

Are you ready for the funk? According to Dawn Silva a singer and now author of the new book, "The Funk Queen," Silva states, "Funk is timeless and very much alive." The book is published by New Rising Publishing.

The book is a brilliant autobiography that describes Silva's musical background, which included her dad who Silva says had a beautiful voice, and her mother who was a dancer and performer. Silva also mentions her great grandfather, who played acoustic guitar.

spent Dawn also time performing in talent shows, but she soon outgrew talent shows and she became professional. One night, Silva went with her father to see Sly and the Family Stone, which inspired Silva to vow, "One day, I'll be up there performing."

In 1974, Silva had her first introduction to Sly and the Family Stone when she did a recording session with Sly Stone and his female vocalists at the Record Plant studio in Sausalito, California.

Dawn would go on to perform with Parliament, the Gap Band, and Ice Cube on the song "How to Survive in South Central" from the movie, "Boyz in the Hood." George Clinton created Brides of Funkenstein, which featured Silva and Lynn Mabry.

we were female funk warriors, that gave Parliament/Funkadelic its thrust, its velocity, the sweetening and its aggressive yet feminine wall of sound," she said.

The book also documents some of Silva's favorite concerts, which she recalled was a sold-out capacity Madison Square in New York with the Brides of Funkenstein. Another memorable concert was when Silva performed as a solo artist and headliner at The North Sea Jazz Festival in Den Haag, Holland. Also appearing on the lineup were Herbie Hancock, Chaka Khan and the Yellow Jackets.

"The first few years touring on stage, and with Parliament was like nothing else on earth. It was exciting, and fun. However, it was a boy's club, and it was my first-time experience with a Black owned management company that saw their rising female artists as problems and preceded to slow their growth," Silva said.

The book is also a cautionary tale of how women get abused mentally and physically in the music industry. Although it was

well documented about Tina Turner, abuse that artists like Silva endured is not as well know.

When asked advice what she would give women entering the music field, Silva responded,

"First, know your worth. Independence is the key word. Learn to read music and play an instrument, so you won't have to depend on someone else taking a percentage of your music."

The singer noted that regarding the abuse that she suffered, she was ashamed at the time so she didn't come forward. She added that without a strong support system, prayer, and professional help, many people will suffer dire consequences.

Silva stated, "Yes, I wrote a book! 'The Funk Queen,' an autobiography by Dawn Silva. It is a 544page limited edition hardcover coffee table book with 300 classic funk photos and 51 chapters."

This writer gives the book an outstanding review that keeps one's attention from beginning to end - a shocking and absolute masterpiece. The book and Silva's

first solo album entitled "All My Funky Friends," are available at www. DawnSilva.com. The book will soon be available on all social platforms.



As Juneteenth, now federalized as Juneteenth National Independence Day, takes its place as the main focus among the many emancipation celebrations in this country, it is good to reflect on it and reaffirm constantly its central and sustaining meaning and message for us.

Let us reaffirm at the outset that it is good to celebrate and sing ourselves and our freedom songs. As our Black National Anthem urges us, we must "lift ev'ry voice and sing, till earth and heaven ring, ring with the harmonies of liberty," i.e., freedom.

And in that celebration and commemoration, we must tell our own sacred narrative, raise and reflect on our long, difficult, demanding and toll-taking struggle for freedom and recommit ourselves to continue the struggle that will ultimately determine the course and content of our lives and our ultimate victory for freedom and good in the world.

Likewise, we must safeguard ourselves and all things dear to us, even our holidays, protecting ourselves and things we value from the ruthless and imperious appropriation and distorted interpretations of others, especially our oppressor. Indeed, one of the greatest challenges of any meaningful holiday in U.S. society is to safeguard it from trivia and trash, from its being reduced to simply and safely fun and games and the addictive consumption of things, from mindless and imitational Americana and Americanism, and from the normalized process and pressure to allow the dominant society to define the holiday in its own image and interest through funding and favors granted, withheld or denied.

And Juneteenth is no exception, having no immunity or exemption from these social processes and common and confusioninducing practices, and thus we must self-consciously define and defend it on every needed and necessary

Our celebration of freedom as a people is a serious and sacred practice, rooted in the memory and reaffirmation of righteous and relentless struggle against the radical evil of unfreedom, especially the Holocaust of enslavement, but also, the savagery of segregation, and the sustained, pervasive and violent oppression of systemic racism.

And it must always be joined with a self-conscious commemoration of the great suffering, sacrifice and loss of lives of our people and a sincere spoken and unspoken commitment to continue the struggle, keep the faith and hold the line until full freedom is an achieved, experienced and lived reality. Thus, if Juneteenth is to truly be such a celebration of freedom, then we must be rightfully attentive to how it is conceived, interpreted and practiced.

As a celebration of our freedom, Juneteenth should and must put our people at the very center of the celebration and commemoration, rightfully raising them up and praising them for their service, sacrifice and struggle in the interest and advancement of our freedom. It must not be reduced to receiving late news on a specific day, but about the history of struggle that brought us to that day and the continuing struggle afterwards.

In a word, Juneteenth must be placed and celebrated, not in isolation, but in the midst of the larger freedom struggle before

and after June 19, 1865. Only then can it do honor to the people who lived, served and died on the various battlefields for freedom we were compelled to enter and remain on even today.

And it is in this context of a continuing struggle, an unfinished fight for a stillto-be-realized freedom that we are able to rightfully recognize and find common cause with those who continue the struggle in the honor of our ancestors and in the interest of our own good and the good of future generations.

Moreover, to celebrate Juneteenth rightfully is to have and teach an accurate, agency-respecting and dignity-affirming understanding of the circumstances surrounding the holiday itself. It means rethinking and rejecting the idea that we did not know that Lincoln had issued the Emancipation Proclamation, Janunot see and hear about over 150,000 enslaved Africans being brought to Texas to escape the Union army and the freedom however limited that came with it.

It also means rejecting the idea that Galveston, which was a seaport city and a site of constantly bringing and sharing of news and literature by Black sailors, was unaware of the momentous events happening in the country or even of the Union and Confederate battles being waged in and over Galveston since October 1862.

Accepting such a version denies Black consciousness of the changing world and civil war around them, of their enslavers' increasing desperation, and of their own efforts and eagerness for freedom. In such a reductive conception of our agency, we become absentees of our own history, spectators who read and reference the words and ways of others, and deny, diminish and erase ourselves.

Let us also be able to concede that the arriving general was late not the news and that he declared a freedom that was not real or realized in the simple announcing that all enslaved Africans "are free." Indeed, the late-coming and limited freedom-announcing general told enslaved Africans that they were "advised to remain quietly at their preswages" in an imaginary new labor system of "employer and hired labor." Moreover, he told them, "They are informed that they will not be allowed to collect at military posts and that they will not be supported in idleness there or elsewhere."

Clearly, it was an announcement of a change of status, from enslaved to emancipated, but it was also a questionable gain when we were at the same time advised to remain quietly where we were before the announcement, not to seek sanctuary or support from the army, and not to be "idle," unemployed or practice freedom by walking off the plantation and seeking a new life and new form of labor elsewhere.

Such a narrative is deficient, denies our agency and minimal awareness and leaves us with others, i.e., White people, as our central reference and remembrance in our own historical narrative. The need, then, is for us to ask ourselves and our scholars where are we and what did we do in our own history and struggle for freedom, regardless of who else and what else we might add to the narrative and notions of Juneteenth, and then, as always, we must place the celebration and commemoration in the context and critical consideration of our larger liberathat freedom and emancipation are two different realities and responsibilities. Emancipation is being freed by others; freedom as a practice is a self-liberating activity. Emancipation is granted, but as Nana A. Philip Randolph teaches us, "Freedom is not granted it's won. Justice is not given it's extracted."

Thus, emancipation is received and rightly remembered, but freedom is self-consciously achieved through righteous and relentless struggle of a people who know themselves as ultimately their own liberators, who know the fight for freedom is still not finished, and who understand, teach, celebrate, commemorate and advance the liberating truth and struggle of their own lives and history.

Unpacking the Healing Power of Black Music

We all love June because it's the beginning of summer, which means backyard cookouts, warm weather, and vacations. It is also Men's Health Month and Black Music Month, marking the perfect time and way for Black men to go above and beyond yearly checkups, regular exercise, and improved eating habits.

Black music is more than entertainment; it is art, social commentary, and therapy. It's a powerful tool for mental health that helps us recognize, express and deal with emotions we didn't know we had. I want our brothers to address their health holistically and not just focus on their physical care but also on preserving their mental health.

According to the American Psychological Association, about 26% of Black men ages 18 to 44 who experienced daily feelings of anxiety or depression were likely to have used mental health services, compared with 45.4% of non-Hispanic White men with the same feelings. While there is no substitute for professional care in addressing more serious mental health issues, there are simple self-care solutions to dealing with the everyday struggles of moodiness, lack of motivation, and sadness.

And music can be one of those ways. It is a part of our DNA and our culture. We have all heard about the positive effects of exercise and enjoying time with friends and family to boost our mental well-being, and the connecting thread for these activities is usually music.

Raise your hand if you remember Club Quarantine with DJ Derrick "D-Nice" Jones during the early days of the pandemic. Broadcasted through Instagram Live, D-Nice played nonstop from his LA home old-school hip-hop, grownfolks R&B, and soul, with a dash of salsa or Afrobeat for good measure.

contributes to healthier re-

sponses to stress by lowering cortisol levels, slowing heart rate and reducing blood pressure. Boosts Motivation: Music can strengthen social

connections and enhance your workout by diverting focus from the challenges of exercise and reducing the perception of fatigue. Combats Depression:

Music therapy has been found to decrease depressive scores significantly by providing a positive distraction and improving mood. Improve Well-being:

Participating in group musical activities, like dancing, singing in a choir or playing in a band, can improve self-esteem, promote social bonding, and reduce feelings of loneliness.

As we continue to celebrate Men's Health Month and Black Music Month, let's use this summer to promote the importance of mental health and the role music can play in our wellness journeys and the lives of Black men.

Biden signed a bill making Juneteenth one of 12 federal holidays. The sad reality is that many Americans have never really learned about the holiday because in most American classrooms Juneteenth is never taught. Many K-12 educational curriculums ignore, refuse, or lightly refer to slavery and its devastating and damaging effect on Black people.

Last year, President Joe years and we have only experienced freedom 150 years. for about President Abraham Lincoln issued the Emancipation Proclamation on January 1, 1863, which declared that all persons held as slaves shall be free.

The Proclamation allowed Black men into military service and almost 200,000 Black soldiers fought for the Union. Unfortunately, it would take two additional years before that proclamation the enslaved who were in states under Confederate control.

Some enslaved places and people did not receive word of their freedom until June 19, 1865, when 2,000 Union troops under the command of Major General Gordon Granger arrived in Galveston, Texas on June 19, 1865. This was the final place to be notified, proclaiming that 250,000 Black Americans enslaved in Texas were

finally free because slavery had been abolished.

We need more of our schools to make the effort to instruct students about Juneteenth as well as the country's legacy of slavery. Many politicians are actively fighting against any curriculum that deals with slavery, racism, or parts of American history that make white people uncomfortable.

The 13th Amendment may have legally put an end to slavery, but it did not put an end to racial oppression. The chains and shackles have been removed but they have been replaced by the income gap, the wealth gap, and the education gap between Black and white America. Some of the challenges we still face today are issues dealing with health care, affordable housing, attack on voting rights and police brutality.

My paternal family is from East Texas and Juneteenth has been celebrated and mentioned over the years as something we need to acknowledge and pass down through the generations. I am a family historian and so I have felt it is part of my mission or job to keep this legacy alive in our family and our community.

We must make it personal to keep our history alive and continue to pass it down to future generations, even if they refuse to teach it in our schools.

This coming Monday Juneteenth, nonprofit Forgiving For Living, Inc., will partner with the Black Business Association, and Comerica Bank with a virtual presentation on the history of Juneteenth and the importance of us sharing our stories.

Our theme will be, "Living and Doing Business in the Land of the Free." The question we must ask ourselves is are we truly free and

emancipated and have we done with our freedom.

Dr. Martin Luther King, Jr. said, "the arc of the moral universe is long, but it bends toward justice." To make this a reality we must be willing to take a stand for equality, justice, and human rights.

We must take a stand and not take a seat when it comes to fighting for justice and not get weary in well doing when it comes to fighting for civil rights that our ancestors fought and died for. Happy Juneteenth!

Having a Picnic or Barbecue? Beware of Foodborne Bacteria

As summer approaches and the weather gets warmer, the arrival of picnic and barbecue season provide residents across Southern California with many opportunities to enjoy tasty food along with outdoor fun with family and friends.

At the same time, it's important to know that warm weather fun under the sun may result in foodborne bacteria that can quickly turn a family picnic or barbecue into avoidable stomach ailments for a simple reason: as food heats up in warm temperatures, bacteria will multiply rapidly.

"That's why it's so important for us to protect ourselves and our loved from foodborne illness during warmweather months," said Roohe Ahmed, a registered dietitian/nutritionist with Kaiser Permanente Southern California. "It's critically important to handle your food safely when eating outdoors."

Pack and Transport Food Safely

The Food and Drug

Administration recommends that you keep your food safe - from the refrigerator/freezer to the picnic table. It offers the following recommendation to protect your health:

Keep cold food cold. Place cold food in a cooler with ice or frozen gel packs. Store cold food at 40°F or below to prevent bacterial growth. Pack meat, poultry, and seafood while frozen so that they stay colder longer.

Organize contents. Consider packing beverages in one cooler with perishable foods in another. That way, as picnickers open and reopen the beverage cooler to replenish their drinks, the perishable foods won't be exposed to warm outdoor air temperatures.

Keep coolers closed: once at the picnic site, limit the number of times the cooler is opened as much as you can. This helps to keep the contents cold longer.

Don't contaminate. Be sure to keep raw meat, poultry and seafood securely wrapped. This keeps their juices from contaminating prepared/ cooked foods or foods that will be eaten raw, such as

fruits and vegetables.

Clean your produce. Rinse fresh fruits and vegetables under running tap water before packing them in the cooler including those with skins and rinds that are not eaten. Rub firm-skinned fruits and vegetables under running tap water or scrub with a clean vegetable brush while rinsing with running tap water. Wipe fruits and vegetables dry with a clean cloth towel or paper

towel. Packaged fruits and vegetables that are labeled "ready-to-eat," "washed" or "triple washed" need not be washed.

"If you follow these tips, you're more likely to prevent illness caused by foodborne bacteria," said Roohe, who's stationed at Baldwin Park Medical Center. "It's important for all of us to make sure that when eating or grilling outdoors, applying food safety precautions will help

you avoid getting sick and spoiling enjoyment with family and friends."

Safe Grilling Tips

According to the FDA, grilling and picnicking often go hand-in-hand. And just as with cooking indoors, follow important guidelines to ensure that your grilled food reaches the table safely. The FDA recommends the following:

Marinate foods in the refrigerator — never on the kitchen counter or outdoors.

In addition, if you plan to use some of the marinade as a sauce on the cooked food, reserve a portion separately before adding the raw meat, poultry, or seafood. Don't reuse marinade.

Keep "ready" food hot. Grilled food can be kept hot until served by moving it to the side of the grill rack. This keeps it hot but prevents overcooking.

Don't reuse platters or utensils. Using the same platter or utensils that previously held raw meat, poultry, or seafood allows bacteria from the raw food's juices to spread to the cooked food. Instead, have a clean platter and utensils ready at the grillside to serve your food.

Check for foreign objects in food. If you clean your grill using a bristle brush, make sure that no detached bristles have made their way into grilled food.

"As the weather gets warmer, more and more people will enjoy eating outdoors," Roohe said. "The secret is to make sure you don't compromise food safety, as that can quickly spoil your fun."

Apollo Theater CEO Jonelle Procope to leave the historic landmark on safe financial ground

Jonelle Procope's 20year tenure as president and CEO of The Apollo Theater evolved into an era of prosperity and expansion, markedly different from the tumultuous, cash-strapped decades that preceded it.

Sure, the early years were a struggle, as the New York City landmark, where music legends from Billie Holiday and Stevie Wonder to D'Angelo and countless rappers graced the stage, dealt with financial difficulties and a shifting business model. And she had to navigate the COVID-19 pandemic when the hub of its Harlem neighborhood was closed for two years.

However, when Procope steps down at the end of June, she will leave her successor Michelle Ebanks the Essence Communications executive who was named her replacement last week – with the proceeds of a nearly \$80 million campaign raised to complete a

the historic theater by 2025. Though the bulk of that money came from donations, it also includes \$15.7 million in support from the city of New York and a \$10 million grant from the state.

On Monday night, Procope will be honored, alongside hip-hop mogul Sean "Diddy" Combs and basketball superstar Kareem Abdul-Jabbar, at The Apollo's Spring Benefit for her

"It's been a privilege and an honor," Procope told The Associated Press in an interview. "In many respects, I think I take more away than what I gave. It really has made me a whole person."

That said, she admits protecting The Apollo and building it into what it is now - the largest African American performing arts presenting organization in the country – has basically been her life throughout her tenure.

"It's been 20 years of 24/7 Apollo," said Procope, 72. "Frankly, I haven't had space in my brain to really think about 'What do you

excited to have a moment to be reflective and to think about the things that turn me on, what I am passionate about, what are things that I'm curious about."

Charles E. Phillips, chairman of the Apollo's just started on the Apollo Theater board with opera legend Beverly Sills, then the chairwoman of Lincoln Center, when Sills referred to the Apollo as "the Lincoln Center of Uptown."

"I remember thinking,

board, has said Procope turned around the oncebankrupt theater almost single-handedly. "Jonelle has led the Apollo through an unparalleled period of growth," Phillips said in a statement, adding that she also "forged partnerships globally, strengthened the Apollo's finances, broadened a uniquely diverse audience, and navigated the institution through a challenging pandemic."

John Goerke, director of guest experience at the Rock and Roll Hall of Fame and Museum, said the preservation of The Apollo Theater has been among the top priorities in American music history. The Apollo - especially through its still-running Amateur Night, captured on the TV series "Showtime at The Apollo" – has launched the careers of legendary performers ranging from Ella Fitzgerald to Lauryn Hill.

"The venue is history you can see in real time," he said. "You can literally go there and experience history with all the artists who have performed at The Apollo. They are telling the story of America."

Procope said she had

'Oh, that sounds a little hokey," Procope said. "But we all understood what she meant. And the question was: Why shouldn't there be a performing arts center for Harlem and the Uptown community? So that was always a vision."

That vision of creating the Apollo Performing Arts Center is becoming reality, with the first phase opening last year with two new small theaters, meant for small concerts and theater work-

However, that was only possible after The Apollo fixed its finances. Once America became less segregated, the 1,500-seat main theater was no longer able to economically compete for concerts from major Black stars who were able to fill large arenas like Madison Square Garden.

That competition led to The Apollo losing millions each year and eventually going bankrupt in 1984. Though the theater became a nonprofit in 1991, run by The Apollo Theater Foundation, as recently as 2002, it struggled with financing for its ambitious shows.

When Procope took over in 2003, the former corporate lawyer methodically began The Apollo's turn-

She credits the Upper Manhattan Empowerment Zone for providing The Apollo with one of its first major grants, which allowed her to hire a team to create a new business plan that balanced high arts entertainment and commercial pro-

"We were able to gain the confidence of the public and the philanthropic community," she said. 

"I am a pioneer woman official, the only woman to referee international men and women and was drafted by the NFL in 2012,"


Nichols said. "Flag football is a very important thing because a woman needs to belong to some type of sports and I think this is excellent for them."


