April Verrett Unanimously Elected as Secretary Treasurer of SEIU International Board

Treasurer. Joseph Bryant also approved as Executive Vice President

The Service Employees International Union's International Executive Board voted unanimously June 24, to elect April Verrett as secretarytreasurer and Joseph Bryant as executive vice president, adding two dynamic young leaders to President Mary Kay Henry's leadership team as SEIU intensifies its growing "Unions for All" effort.

In their new posts, Verrett and Bryant, both presidents of large SEIU locals in California, will be key drivers of the union's push to make sure every worker has the right to join a union, no matter where they work or what ZIP code they live in. Both leaders have been at the forefront of major SEIU initiatives to help workers organize at scale in the healthcare and public sectors in California and beyond. They replace Gerry Hudson and Valarie respectively, Long, announced retirements earlier this month after a combined

reached a moment of great reckoning in our country, where our communities are under constant attack from white supremacist violence, jobs that don't pay us enough to live, healthcare we can't access and can't afford, underfunded schools, and unaffordable housing," Henry said.

"April and Joseph's rich life and professional experiences provide them with the foundation to be the next generation of leaders that help SEIU meet this moment and ensure we rewrite the rules that have been rigged against workers and against people of color, while billionaires and giant corporations do whatever they want."

Verrett, 47, was raised by her grandmother, an SEIU member, after her mother died as a result of complications from childbirth. Her grandmother taught her to work hard, be resilient and to both have pride and be humble, and Verrett spent her adult life bringing those qualities to

her work building SEIU - in Chicago at SEIU Healthcare Illinois Indiana and its predecessor SEIU Local 20 and more recently in California, leading the 385,000-member Local 2015, the nation's largest long-term care workers' union.

Verrett chairs SEIU's National Home Care Council, co-chairs the National Organizing Committee, and is a member of the Finance Committee. Through her leadership at SEIU, Verrett has been a prominent advocate for care workers during the pandemic, emerging as one of the leading voices in the country for home care workers and chief strategist in SEIU members' fight to reimagine the future of care work in our country through federal investment in good, union, living-wage home care jobs.



Children's Institute Celebrates New Watts Campus with Ribbon-Cutting Ceremony

On Saturday, June 25, the Children's Institute invited the community out for a ribbon cutting ceremony for a day of celebration for their new Watts campus. Designed pro-bono by renowned architect Frank Gehry, the new CII Watts campus will provide an array of therapeutic services and free programs including workshops, individual and group counseling, socialization opportunities for Head Start families, employment support, Project Fatherhood and youth groups.

CII operates out of five main campuses, and offers programs in 32 locations. This new 20,000 squarefoot campus is the 116-yearold nonprofit's first everpurpose built home in the Watt's community.

President and CEO Martine Singer told the Sentinel that Frank Gehry would be at the top of anyone's wish list for an architect. She explained how CII is fortunate that Gelila Assefa Puck, a long-term trustee of CII and a friend of Frank's, approached him about the project.

"Since we are located across from single family houses, we were mindful of the need to fit into a quiet, residential setting, so the facade has lots of articulation and a variety of colors and materials that make it feel appropriately scaled," Singer added.

This new office space will hold 150 Children's Institute staff members allowing teams to manage the various programs for the community.

Alzheimer's Association Reaches Out to **Underserved Communities**

As Alzheimer's Awareness Month comes to a

close, members of the California Southland Chapter of the Alzheimer's Association are urging African Americans and Latinos to get edu-

cated on the warning signs of Alzheimer's disease something they say is critical in addressing the disparities in health care among

the two communities. They are also letting them know that staff and volunteers are available to help.

Carl V. Hill, Ph.D, MPH, who is the chief diversity, equity and inclusion officer for the organization, said the campaign is important because often, residents in underserved communities are diagnosed when it is too late to receive adequate care and support for both patients and caregivers.

Hill, a Morehouse College alum, said he developed a passion for social justice in healthcare there, where the legacy of the Rev. Dr. Martin Luther King, Jr., and the Civil Rights Era was rooted.

For Alzheimer's in particular, it was his work with the National Institute of Aging that shed light on the need for education among African Americans who make up almost 20 percent (compared to 14% of Hispanic adults age 65 and older and 10% of White

older adults.) This higher risk, or incidence, of Alzheimer's and other dementias, according to the group's website, "appears to stem from variations in medical conditions, health-related behaviors and socioeconomic risk factors across racial groups.

"Chronic health conditions associated with higher dementia risk, such as cardiovascular disease and diabetes, disproportionately affect Black and Hispanic populations. Social and environmental disparities including lower levels and quality of education, higher rates of poverty, and greater exposure to adversity and discrimination increase risk for these chronic conditions and risk for dementia in Black and Hispanic popula-

"Research also suggests that structural racism may also play a role. Structural racism pervades many aspects of life that may directly or indirectly alter dementia risk. Structural racism influences environmental factors such as where

people can live, the quality of schools in their communities, and exposure to

and other factors that can help with reducing risks,"

harmful toxins and pollutants. It also influences access to quality health care, employment prospects, occupational safety, the ability to pass wealth to subsequent generations, treatment by the legal system and exposure to violence..."

"Knowing the warning signs is key," Hill said. There are 10 in particular, he said, that especially those with a family history of the disease should look for:

- 1. Memory loss that disrupts daily life
- 2. Challenges in planning or solving problems
- 3. Difficulty completing familiar tasks
- 4. Confusion with time or place
- 5. Trouble understanding visual images and spatial relationships
- 6. New problems with words in speaking or writing
- 7. Misplacing things and losing the ability to retrace
- 8. Decreased or poor judgment
 - 9. Withdrawal from
- work or social activities 10. Changes in mood

"We're investigating the very important parts of lifestyle," Hill, who advocates for a whole foods diet high in fiber low in saturated fat, told the Sentinel.

Knowledge is also important for caregivers, Hill said. According to the Association:

When compared with White caregivers, Black caregivers are more likely to provide more than 40 hours of care per week (54.3% versus 38.6%) and are also more likely to care for someone with dementia (31.7% versus 11.9%).

Hispanic, Black and Asian American dementia caregivers indicate greater care demands, less outside help/formal service use and greater depression compared with White caregivers. Black dementia caregivers were found to be 69% less likely than White caregivers to use respite servic-

"We want to make sure that these groups receive resources in an equitable way," Hill said.

To conclude Bootcamp, McDonald's will be hosting the participants at its corporate headquarters in Chicago. Cohorts will tour the headquarters and Hamburger University, enjoy menu items from their Global restaurant and test kitchen, network with staff, as well as present their work to executives.

The Painted Lady LA: Grand Opening of Black-Woman Owned Tattoo Shop

The Painted Lady LA is a Black woman-owned business, The Los Angeles Sentinel had an exclusive interview with founder and owner Autumn Armstrong before the grand opening.

The Painted Lady is set up in Silverlake, located at 4220 W. Sunset Blvd. in Los Angeles. Armstrong reflected on her expansion, she stated, "Leaving my first shop almost felt like leaving an old friend behind. It was bittersweet. We didn't expect to have to find a new location 6 months after our grand opening, but God works in mysterious ways." Her former location was located on Venice Blvd.

Armstrong continued, "Our new location in Silverlake is bigger, better, and starting to feel like home. We're so excited to be a part of the community and share our art and our message of inclusivity in the tattoo industry.

The seeds of The Painted Lady LA were planted almost 12 years ago. In considering the beginning of her journey, the founder of The Painted Lady LA said, "When I first started tattoo-

ized tattoo shops weren't really a female-friendly environment."

Armstrong continued, "There was also a lack of customer service, which seems insane to me. Over the span of my career, I've helped other shop owners make their shop work better and create a more welcoming environment."

It was only a matter of time before she saw her transformative gifts within herself, "I had been working on the business plan for my shop for years, so once the right location was available, I could jump on it. The COVID pandemic was that final push for me to finally break out on my own."

Armstrong created a space that would build loyal clients. She stated, "At The Painted Lady LA, we want our clients to keep coming back. Not only are we an allfemale staff tattoo shop, but all our tattoo artists also have solid backgrounds in art, we give certificates to first-time tattoo collectors. and offer fully detailed aftercare kits."

on her challenge in overcoming needles through her new lifestyle, she stated, "At 15, I was diagnosed type 1 diabetic (juvenile diabetes). I had to get over my fear quickly, injecting myself multiple times a day. Eventually, I started hanging out in tattoo shops; I think the industry always fascinated me. There's something very

sacred about a practice that

to admire."

Armstrong shared that she has been an artist for as long as she could remember. "I had been painting and drawing my whole life, tattooing just seemed like the best way to create and still be able to make a livable wage. I'm fortunate enough to give that opportunity to other female artists in an industry that doesn't want us

here," she said.

Her inspiration came from women who are tattoo pioneers. She stated, "I was inspired by female tattoo artists like Tatu Baby and Kat von D - feminine, talented, and badass."

Armstrong continued, "I didn't know women like me had a place in this mostly male field until I saw them. Being a queer Black woman, I think I bring something completely new and refreshing to the game."

As a Black woman tattoo artist, Armstrong faced a lot of energy that tried to snuff out her dreams. The owner of The Painted Lady stated, "I remember when I told my tattoo artist I wanted to learn to tattoo, he promptly told me not to waste my time. That one statement has kept me going through my career, because why not me?"

When pursuing the goal of her tattoo shop, she had to maneuver past many obstacles. This included finding the right location, staff, marketing, and funding. "It took time to find the right place, but I found that standing my ground and negotiating my terms got me into the right location. The best advice I got about finding a store-

front is not to settle. You want to feel proud of your space; you have to see the vision of what could be before anything is there, " Armstrong said.

The founder of The Painted Lady credited her success to her team and the new levels she had to climb as a leader. Armstrong stated, "My current team is incredible, but I've had to make some decisions as a boss that I didn't think would arise. I had to learn to set good boundaries so that everyone feels respected."

Armstrong shared the latest updates on the new location, she stated, "Our art gallery is open, and we're taking appointments for private tours until our grand opening in August!"

CBCC Opens Resource Center in Inglewood




"What sets us apart, even in a socially distanced and quarantined world, is the one-on-one service the Chamber staff has provided," Henderson said. "Members and businesses, large and small, found the Chamber to be the resource they needed."

He also noted the Chamber's efforts to diversify the membership and the Board. "The minority business initiative that we established with the Pasadena Chamber Foundation with significant funding from Chamber member Essence has helped us expand our membership among underserved communities in the greater Pasadena area. We are seeing membership growth as a result."

Henderson also noted the great diversity that the new chamber board represents. He pointed out that the current make-up of the board is comprised of Black, Hispanic, Asian Pacific Islanders and women mem-

"That is more than half of the Chamber Board of Directors," he said. "46% of our board is female. 30% are Black, Hispanic, Asian American or Pacific Islanders." Also, Henderson swore in the new and returning Pasadena Chamber Board members.

The evening also included the presentation of several scholarships for students transferring from community college to a four-year college or university. Two of the scholarship awardees were former foster youth, who each received \$2,500 scholarships from



Pasadena Chamber of Commerce Foundation.

Born and raised on the streets of Los Angeles, Simmons knows that it was his praying family that covered him while he participated in gangs, sold drugs, and maintained an \$800-a-day crack cocaine habit. And that is just what he has been doing just since his own recovery.

NNPA and Transformative Justice Coalition Announce National GOTV Campaign Targeting 10 Million More Black Voters

Ahead of the all-important 2022 midterm elections, reports show that more than 55 million Americans remain unregistered to vote - and about 10 million are African Americans who are eligible to vote but who are unregistered.

Whether the reason is because of apathy, suppression, or other means, the National Newspaper Publishers Association (NNPA) and the Transformative Justice Coalition seek to get to the bottom of why, with so much at stake, voter registration and GOTV mobilization remain lacking notably among Black Americans across the nation.

During the national convention marking the 195thanniversary celebration of the Black Press of America in New Orleans, leaders of both organizations announced a get-out-to-vote campaign aimed at registering and mobilizing GOTV for 10 million more African Americans to vote in time for the 2022 midterms.

"The NNPA has talked about the vote, and there is no better time for us to show our power," NNPA Chair Karen Carter Richards stated during the announcement

at the national convention in the Big Easy.

"Let us take the lead and not be on the tail-end so we can show the present-day

share in 2020," Arnwine remarked.

"Ninety-three percent of all eligible Black voters registered in Georgia. Yet, in the

continued Richards, who publishes the Houston Forward Times.

"This is a great opportunity for us; we've got to make this happen." Attorney Barbara Arnwine, the founder, and president of the Transformative Justice Coalition, and her board chair and fellow lawyer Daryl Jones, told a captivated panel that their organization had recorded 72 voter suppression tactics to prevent a large population from casting ballots.

Among them are strict voter laws in many Republican-led states, deceptive practices like robocalls; early voting cuts; and voter

intimidation. "Black voters did our

93 percent of all registered Black voters turned out. That's why people don't understand where the real power is."

Along with NNPA President and CEO Dr. Benjamin F. Chavis Jr., Richards, NNPA Executive Board members Janis Ware, Fran Farrer, Cheryl Smith, and Jackie Hampton, Arnwine and Jones announced that the groups would utilize a multivehicle "votercade" to get out the vote.

They said individuals riding in new and COVIDsafe tour buses would hit swing states ahead of the November elections to register and mobilize GOTV for

10 million new Black voters. Chavis said artists from Stephanie Mills also pledged to "get on the bus with the Black Press and the Transformative Justice Coalition."

Chavis said he's convinced other celebrities will also join the national GOTV campaign.

"The first form of voter suppression is self-suppression," Dr. Chavis asserted.

"This last primary election showed that some of us were keeping ourselves from voting. There are 55 million unregistered Americans eligible to vote, and 10 million are African Americans," Chavis continued.

"What if those 10 million were registered? We wouldn't have worried about Donald Trump or the craziness of

what the U.S. Supreme Court is doing now. Elections have consequences. The overturned Roe v. Wade, the overturned gun laws – are

consequences of elections." With more than 235 African American-owned newspapers and media companies serving as members, the NNPA represents the

Black Press of America. The Transformative Justice Coalition's mission includes the systematic change that achieves racial justice, gender, economic and social justice, and human rights through public education and engagement initiatives that attend equally to hearts and minds as well as the social systems and structure in which they exist.

Further, the coalition dedicates itself to informed civic engagement and equal voting rights for everyone.

They use a voting rights map of shame to inform the public of threats to America's democracy, how to protect their voting rights, and steps to take to ensure the ability to cast a ballot and make sure it's counted.

The organization also seeks the restoration of voting rights for ex-felons.

"[Anti-voting rights organizations and individuals] have trained 10,000 people to be poll disruptors to go to only Black polling sites," Arnwine declared.

"They're not sending them to white polling sites, and if you watched the [Jan. 6] hearings, this is a concentrated effort to disempower Black voters," she stated.

According to Davis, more than 18 million people are eligible to vote but don't know it.

"They are the felony disenfranchised," Davis insisted.

"They are confused. It's intentionally done in various states. For example, in some states, you never lose your right to vote, and in some states, you can run for office if you're incarcerated," he explained.

The votercade would help educate voters and explain what's legal, among other things. "We're calling on all 235 NNPA members," Dr. Chavis encouraged.

"That call and response from our brothers and sisters are vital. It's movement time, it is time Get-Out-The-Vote" he declared further.

"With the Transformative Justice Coalition, the NNPA will help move our people forward to get out this vote. In 2022, we will make the critical difference in the midterm elections in terms of increasing Black voter participation throughout the country."

She felt like Ryan and Devyn needed to grow individually and didn't want to leave her book with someone who is lost.

Staying in the Black: Millionaires in Training

After dropping 30% during the pandemic, Black businesses are making a comeback. A recent study from the University of California, Santa Cruz cited the number of Black small-business owners rose 28% higher in the third quarter of 2021 in comparison to prepandemic times.

To capitalize on this momentum, a cohort of local organizations organized a workshop series to show small business how to retain, maintain and grow into multi-million dollar entities through contracting.

"Staying in the Black" is a small business workshop series presented by City National Bank, Vermont Slauson Economic Development Corporation, Community Build, Inc. and Crenshaw Chamber of Commerce. The first workshop was held at VSEDC on June 17

"Our objective was to help some of our small local businesses graduate to the next level by providing them with vital resources," City National Bank Vice President of Community Development Brian Grant said. 

one of the top three SBA lenders in the country and number one in California. In his 30 year career in banking, Grant was often provided services to Black doctors and other high net worth individuals and businesses. He said some of them wanted to expand their business but their financial statements did not show enough profit to qualify for a loan.

"People don't want to show a profit and pay taxes, but if you don't show a profit, how are you going to grow your business?" said Grant. "A person with that mentality is destine to stay at a certain level. At the end of the day, the goal is to be profitable."

Pasadena School Board Approves Recommendations to Reduce Suspensions for Black Students

School District (PUSD) unanimously accepted a series of recommendations from the Black Student Success (BSS) Task Force to address school discipline practices that were disproportionately affecting Black students most acutely in elementary schools.

The African American Parent Council (AAPC) established the Black Student Success Task Force at the advice of Superintendent Dr. Brian McDonald after raising the issue of high rates of Black elementary school suspensions in a meeting earlier this spring.

community stakeholders to participate in this endeavor. Over the last 10 weeks, the newly formed task force met to analyze data, review current district practices, assess available district resources and develop recommendations on policy change as well as identify needed staffing, training and services to mitigate the disproportionality that currently exists. The BSS Task Force was facilitated by Patrice Marshall McKenzie, a local educator, community advocate and PUSD alumna.

The recommendations accepted by the Board results in injury or incidents that lead to mandatory expulsion, in accordance with the California Educational Code section 48915 (c).

Additionally, the recommendation also included limiting out-of-school suspensions to not more than two (2) days and provide restorative intervention and practices to students to facilitate a comprehensive return to campus experience. The primary objective of the Black

Student Success Task Force was to provide recommendations to reduce the exposure of Black students to harsh discipline practices and increase the instructional time that Black students spend in classrooms learning.

The Pasadena School Board also adopted a motion to accept the Task Force's recommendations for additional staffing and district wide training resources that will begin in the 2022-23 school year.

The Task Force's recommendations will be codified in the District's board policies and administrative regulations in August and

"We would be doing our students an injustice if we didn't get every single ablebodied employee, board member, staff person, parent to come alongside us with this and support

African American and Community Leaders Speak Out on SCOTUS Roe Reversal

African American leaders across the nation largely condemned the U.S. Supreme Court ruling issued on June 24, overturning the federal abortion protections of Roe v. Wade, with some describing the action as a "pro-policing of women's bodies" and a move to "criminalize Black women."

The 5-4 ruling overturns a 49-year-old landmark decision and puts abortion

policy at the discretion of states, many of which have restricted or outlawed the procedure in recent months.

Issuing a strong reaction to the SCOTUS ruling, Congresswoman Maxine Waters declared, "I stand in solidarity with the 36 million women being stripped of their right to decide what is best for themselves. We will keep fighting."

Waters pledged to defy and protest the Supreme Court. "You ain't seen nothing yet," she said from the steps of the court."Women are going to control their bodies no matter how they try and stop us. The hell with the Supreme Court. And if they think Black women are intimidated or afraid, they got another thought coming!

"Black women will be out in droves," she continued. "We will be out by the thousands; we will be out by the millions. We are going to make sure we fight by the right to control our own

"As a Member of Congress, I'm proud to have voted to protect abortion access. Today's SCOTUS decision makes it even more clear: we need federal protections for reproductive health. I am committed to continuing this FIGHT: in Congress, in the streets, and at the Ballot Box!"

Assemblymember Reggie Jones-Sawyer: "The ruling by the conservative fac-

tion of the U.S. Supreme Court to end decades of settled law in America, and thereby negating a woman's

"Black and brown women in this country have always struggled with obstacles to equality and with the bitter reality that, as citizens, we are "lesser than." And, as always, Black and brown

women and those struggling to get by finenaically will be hit hardest by the ruling.

"As a lawyer deeply engaged with civil rights issue, I am appalled at a ruling that claims, at its core, the justification that the right to abortion is not specifically enumerated in the constitution. The Constitution is silent on countless other rights we rely on every day in this country; it's telling that a woman's right to abortion is the one the Court has chosen to decimate today.

"The concurring opinion of Justice Thomas should be a wake-up call to everyone. Thomas calls out the rights to same-sex marriage and contraceptives as examples of others that are not enumerated in the constitution. He is laying out the game plan of the right. "The consequences of this devastating decision will fall largely on people who already face the greatest barriers to health care due to this country's legacy of racism and discrimination, including Black, Latino, and Indigenous communities, people with low incomes, LGBTQ+ people, immigrants, and people living in rural areas.

"In preparation for this ruling, PPLA has been working with the State of California, Los Angeles County and the cities of Los Angeles, Long Beach, and West Hollywood to prepare for this decision and the impacts it will have on Planned Parenthood health centers across California.

In January, Governor Gavin Newsom declared California a Haven State for abortion access and following that announcement the County Board of Supervisors declared Los Angeles County a Haven County for access to abortion and reproductive health care. This momentum continued as cities such as Long Beach, Los Angeles, and West Hollywood signaled their strong support for access to safe and legal abortion and began preparpatients who may seek care here due to hostile bans in their home state.

California Senate Gets Second Chance to Pass Prison Slavery

On June 23, the California Senate rejected a constitutional amendment to remove language in the state Constitution that allows involuntary servitude as punishment to a crime with a 21-6 vote.

A day later, the legislation's sponsors went back to the drawing board to redraft the legislation for

reconsideration.

The number of votes casted in favor of Assembly Constitutional Amendment (ACA) 3, the California Abolition Act, fell short of the two-thirds vote requirement needed to move the bill to the ballot for Californians to decide its fate in the November General Election.

The Senate is expected to hold another floor vote on the legislation this week.

Sen. Sydney Kamlager

(D-Los Angeles), who authored ACA 3 in 2021 while serving in the Assembly, said she focused the language in the bill on the slavery ban and vowed to bring it back for a vote when Sen. Steven Bradford (D-Gardena), chair of the California Legislative Black Caucus, asked her about it June 23.

"The CA State Senate just reaffirmed its commitment to keeping slavery and involuntary servitude in the state's constitution," Kamlager tweeted.

Jamilia Land, a member of the Anti-Violence Safety, and Accountability Project (ASAP), an organization that advocates for prisoners' rights, said she remains committed to making sure slavery is struck out of the California constitution.

"All we needed was 26 votes," Land said. "But we have made amendments to ACA 3 on (June 24). Now it could either go back to the Senate on (June 27) or Thursday, June 30."

Five Republicans and one Democrat, Steve Glazer (D-Orinda), voted no against the amendment.

He stated that the issue is "certainly a question worthy of debate" and "can be addressed without a constitutional amendment."

"Slavery was an evil that will forever be a stain on the history of our great country.

We eliminated it through the Civil War and the adoption of the 13th Amendment," Glazer said in a June 23 statement. "Involuntary servitude - though lesser known - also had a shameful past. ACA 3 is not even about involuntary servitude - at least of the kind that was practiced 150 years ago. The question this measure raises is whether or not California should require

Cautious Parents Weigh Decision to Give Children Under Five COVID Vaccine

Antonio and Tenaja Kizzie, a San Diego area couple, are parents of a three-year-old daughter. Although both parents are vaccinated and boosted, the Kizzies have reservations about giving their toddler the COVID-19 vaccine the Centers for Disease Control and Prevention (CDC) recommended last week for children younger than five years old.

"It's one thing to feel like her body is still developing and growing. She's been vaccinated for everything else for things that have been around for years. It's a little scary thinking about something that's new. We don't want to jump in right now," Tenaja told California Black Media. "We iust want to wait a little bit and see the side effects for other kids in her age group and reassess from there."

Her husband chimed in.

"We believe in the science, we believe vaccines works, but when it comes to the under-fives, just being a parent we're a bit more hesitant to give her the vaccine so far. We're waiting to see how it goes with other under 5 kids that get the vaccine. Even though science and logic say yes, as a new parent you're extra cautious," Antonio said.

"For those families that are hesitant and questioning, I try to understand what their fears and questions are. I try to remind them that we are in this together. I care about the health and wellbeing of their children, and I will always suggest the best possible course for them," said Dr. Jennifer Miller, a pediatrician with East Bay Pediatrics, a medical practice with offices in Berkeley and Orinda.

sion was held to offer information about vaccinating children 6 moths to 4 years old against COVID-19 to parents, caregivers and the media.

"I let them know that ultimately it is their decision to make, and I am here as a resource," Millar added. "It is normal to be afraid of the unknown and to want to protect your child. With that in mind, vaccination is the best protection around."

The US Food and Drug Administration authorized emergency use of COVID-19 vaccines made by Moderna, Pfizer and BioNTech earlier this month. The death for children younger than one.

"These are sobering statistics for all of us," said Sandy Close, EMS director and moderator of the news briefing. "Vaccination is an important tool to protect their long-term health against COVID-19 and helps achieve full family protection against this deadly virus."

Panelists said it is a myth that COVID does not affect children. The CDC reports that one in five hospitalized children end up in the ICU. And during the omicron surge, children were hospitalized five times

more than in the Delta surge. "There is definitely still

a need for vaccinations for the whole population," said Dr. Lucia Abascal, a physician and researcher at CDPH. "There is this idea that omicron is milder, but if we look at children's data in this age group, we can actually see that hospitalizations peaked as well as deaths. We have more and more evidence that kids are at an acute risk of COVID."

Abascal detailed the steps of the vaccine approval process at the state and federal levels. An independent expert panel reviewed the data that Moderna and Pfizer provided and unanimously voted that the FDA approve the vaccine. The CDC was the final step of approval for the vaccine at the federal level.

Before California recommends any COVID vaccine, it is reviewed by The Western States Scientific Safety Review Workgroup, a commission comprised of medical professionals and scientists convened by Washington, Oregon, Nevada and California.

Children three years old and above will be eligible to receive vaccines at pharmacies. However, children under three will need to get vaccinated at a pediatrician's office or a community

California has purchased enough vaccinations for every child in the state. The first shipment of 500,000 doses will arrive next week.

About 2.2 million children are eligible for vaccination in California.

The Moderna vaccine is a two-dose regimen like the adult shot, with a one-month wait between doses. The Pfizer vaccine requires three doses. The first dose is followed by the second 21 days later and the final dose comes 60 days after that.

Authorities familiar with the vaccine trials say the side effects of minor fever and pain at the injection site may be stronger for children who receive the Moderna shot.

Dr. Sarah Takekawa, an Obstetrician-Gynecologist. who is currently raising three children under age five was also a panelist.

Takekawa spoke to some of the concerns pregnant woman may have.

Takekawa said she was fully vaccinated before conceiving her third child. She received her booster while pregnant.

"I have seen firsthand what COVID-19 infection can do to otherwise extremely healthy young women during their pregnancies. Watching adults who are otherwise healthy succumb to the disease, it seems easy to us to make this decision about wanting to get vaccinated and encouraging other parents to have their children vaccinated.

Save Time, Skip the Line with DMV Driver's License Testing Options

Did you know that most DMV transactions are currently being handled online? The newest options available may allow you to complete the driver's license knowledge test from the comfort of your home before visiting a DMV office.

If you're renewing your license with a knowledge test requirement, or are an adult taking it for the first time, the DMV offers two resources – a remote version of the traditional knowledge test, and an interactive eLearning course. Eligible customers are prompted to choose the remote knowledge test or eLearning course after filling out the online driver's license application and paying the fee.

Currently, the remote knowledge test is available for the nearly 2 million tests taken by Californians renewing their license each year, the more than 1.3 million tests taken by adults getting their license for the first time who also don't have a California identification card and Californians getting a REAL ID or motorcycle license for the first time. The eLearning course is available for Californians renewing their license.

The newly offered eLearning course can be taken on a computer, laptop, tablet, or mobile device and is available 24/7. There are

seven interactive modules that must be completed, including quizzes, after each module. The eLearning course takes approximately

45 minutes and is currently only available in English.

When you choose to use an online testing resource, it significantly saves time by

eliminating the need to wait in line and take your test in a DMV office. Customers with a testing requirement for their license are still required to go to a DMV office after completing one of the online options to provide the required identity and residency documents, take a photo, provide a thumbprint, complete a vision screening, and be issued a licensing document.

The online knowledge test is available in 35 languages to customers who have an internet-enabled computer or laptop with a webcam. The test cannot be taken on a tablet or mobile device. Customers can begin the online exam between 8 a.m. and 4 p.m. Monday

through Friday, excluding state holidays.

For identity verification and as a fraud prevention measure, online test participants are required to verify their identity and agree to be monitored throughout the exam.

The test can be attempted online twice. If a customer fails to pass the test after two tries, they will be prompted to go to a DMV office to take the test a third time.

This is just one more example of how the DMV is modernizing to add more convenient services online that used to be only available in an office. Checking things off your DMV to-do list is now a lot faster. It all starts here: dmv.ca.gov.

felons in state or local jails prisons to work."

Glazer said that the Legislative Counsel's office gave him a "simple amendment" that involuntary servitude would "not include any rehabilitative activity required of an incarcerated person," including education, vocational training, or behavioral or substance abuse counseling.

The Counsel also suggested that the amendment does not include any work tasks required of an incarcerated person that "generally benefit the residents of the facility in which the person is incarcerated, such as cooking, cleaning, grounds keeping, and laundry."

"Let's adopt that amendment and then get back to work on the difficult challenge of making sure our prisons are run humanely, efficiently and in a way that leads to the rehabilitation of as many felons as possible," Glazer added.

The 13th Amendment of the United States Constitution, ratified in 1865, prohibits slavery and involun-

tary servitude with one exception: if involuntary servitude was imposed as punishment for a crime.

The state of California is one of nine states in the country that permits involuntary servitude as a criminal punishment. Article I, section 6, of the

California Constitution, describes the same prohibitions on slavery and involuntary servitude and the same exception for involuntary servitude as punishment for

Certain members of the Senate raised concerns about the financial impact ACA 3 would have on the California Department of Corrections and Rehabilitation (CDCR). Inmates earn approximately eight cents to 37 cents per hour while incarcerated.

Kamlager says "involuntary servitude is a euphemism for forced labor" and the language should be stricken from the constitu-

The state's Department of Finance (DOF) estimated that the amendment would burden California taxpayers

with \$1.5 billion annually in wages to prisoners, DOF analyst Aaron Edwards told Senate the Appropriations Committee on June 16.

"These are facts that we think would ultimately determine the outcome of future litigation and court decisions," Edwards said. "The largest potential impact is to the California Department of Corrections and Rehabilitawhich currently employs around 65,000 incarcerated persons to support central prison operations such as cooking, cleaning, and laundry services."

Right before the Juneteenth holiday weekend, the appropriations committee sent ACA 3 to the Senate floor with a 5-0 majority vote after Kamlager refuted Edwards' financial data.

This country has been having "economic discussions for hundreds of years around slavery, involuntary servitude, and indentured servants" and enslavement still exists in the prison system, Kamlager said. She also added that a conflict was fought over the moral issue of slavery.

"This bill does not talk about economics. It's a constitutional amendment," Kamlager said. "The (DOF) is not talking about any of this in this grotesque analysis ons. I think (this conversation) is what led to the Civil War."

Three states have voted to abolish slavery and involuntary servitude - Colorado, Utah, and Nebraska

about why it makes more sense for the state of California to advocate for and allow involuntary servitude in pris-

 and in all three cases, the initiative was bipartisan and placed on the ballot by a unanimous vote of legislators, according to Max Parthas, the co-director of the Abolish Slavery National Network (ASNN).

ACA 3 is already attached to a report that addresses the harms of slavery. The Task Force to Study and Develop Reparation Proposals for African Americans issued its interim report to the California Legislature on June 1.

The report included a set of preliminary recommendations for policies that the California Legislature could adopt to remedy those harms, including its support for ACA 3. It examines the ongoing and compounding harms experienced African Americans as a result of slavery and its lingering effects on American society

"One of the preliminary recommendations in our report was to support ACA 3," said Los Angeles attorney Kamilah V. Moore, chairperson of Task Force. "The Task Force saw how that type of legislation aligns perfectly with the idea of reparations for African Americans."

L.A. County Returns Bruce's Beach to Rightful Heirs of Charles and Willa Bruce

to the great grandsons of Charles and Willa Bruce.

The action marks the first time in the history of Los Angeles County that land will be returned to Black descendants whose ancestors were robbed their property and generational wealth due to unjust laws and practices rooted in systemic racism.

"Bruce's Beach has always been so much more than a scenic location to enjoy the California coast. It was a refuge for Black families who came from across the state when racist laws wouldn't allow for any other safe beach going options. It holds the memories of countless Black families, the deep pain of multi-generational loss, and the hope that comes from facing the heinous acts of our past and having the courage to do what is right today," said Mitchell, representing the

"I am deeply honored to stand with the Board completing unprecedented return of land to the descendants of Charles and Willa Bruce. Manhattan Beach which was previously part of the fourth district and is now in the second district, has a new chapter in our shared history that exemplifies how we can begin to meaningfully address longstanding injustices in this county and nation."

The transfer agreement is the culmination of years of advocacy and has taken several steps to set the county on the path to legally return the land. This included the Board of Supervisors passing Hahn's motion co-authored by Mitchell to support Senate Bill 796 - authored by Senator Steve Bradford, SB this public property back to private ownership.

"It is never too late to right a wrong. Bruce's Beach was taken nearly a century ago, but it was an injustice inflicted upon not just Willa and Charles Bruce but generations of their descendants would, almost certainly, be millionaires today if they had been allowed to keep their beachfront property" said Hahn, representing the fourth district.

"By returning this land to their great grandsons, the Bruce family will finally have the opportunity to start rebuilding the generational wealth that was denied them for decades. This will be the first land transfer of its kind, but it cannot be the last. I hope we set a precedent that governments across this nation will follow."

The land being returned to the legal heirs of the 796, codified into law the Bruce family are lots 8 County's ability to transfer and 9 of Peck's Manhattan Beach Tract, an estimated 7,000 square feet that has

been appraised at a value of \$21 million. These lots are currently being used by L.A. County Fire Department as a lifeguard training facility. The motion authorizes the County to lease back of the property its lifeguard training facility is located on to the Bruce Family, LLC annually for \$413,000.

The Bruce's family operated a thriving resort, welcoming to Black patrons when legal segregation kept Black families from accessing California public beaches up until 1929 when the City of Manhattan condemned property. Through government actions, the Bruce's family lost their land, business, their home and generational wealth. This is a historic moment for the county in its process of addressing current and historic prejudice under its Anti-Racism, Diversity, and Inclusion initiative.

"This is a day we

weren't sure would ever come, the return of our family's property happened thanks to the hard work of many, many people. It means the world to us, and we know how important this is to people across the country. But it is also bittersweet. My great-greatgrandparents, Willa and Charles Bruce sacrificed to open a business that gave Black people a place to gather and socialize, and Manhattan Beach took it from them because of the color of their skin" said Anthony Bruce, spokesman for the family.

"It destroyed them financially. It destroyed their chance at the American Dream. I wish they could see what has happened today. We hope this opens people's eyes to a part of American history that isn't talked about enough, and we think it's a step toward trying to right the wrongs of the past."

"I am extremely proud

to have authored Senate Bill 796 that allowed the County of L.A. to transfer the Bruce's Beach land back to its rightful heirs, the greatgrandsons of Charles and Willa Bruce. I commend Supervisors Janice Hahn Holly Mitchell's leadership in standing up to address racial injustice and having the courage to right historical wrongdoing," said Senator Bradford.

"The county's plan will accomplish my legislation's objective of rectifying the historic injustice that was done to the Bruce family. This will allow the Bruce family to realize the generational wealth which they have been deprived for generations, simply for being Black in America! We cannot change the injustices done to our people in the past, but we owe it to the future generations to eliminate structural and systemic racism that still exist today."

his post last year.

In an opinion issued on June 22, Bonta said, "We conclude that substantial questions of law exist as to whether Wesson's appointment to the Los Angeles City Council was lawful...Further, the public interest will be served by allowing the proposed [legal challenge] to proceed." John Sweeney, an attorney for the SCLC-SC, said he and his clients "will decide in the next day whether to file for a temporary restraining order seeking Wesson's removal."

Herb Wesson, who honorably served as the councilman of the 10th District for more than 15 years, but was excluded from running again do to term limits, was appointed unanimously by the Los Angeles City Council to serve as the interim councilmember following Ridley-Thomas' suspension from the City Council after his federal indictment.

Sweeney, who is also the attorney for Registered Voters of District 10, said, "We believe that he is illegally holding office. And that's why we wanted to keep the status quo and put no one in there until Mark

Ridley-Thomas' criminal trial came around."

Many 10th District citizens found this hard to accept, since Ridley-Thomas was originally set to go to trial in August 2022, but now the trial has been moved November 2022 and could potentially get moved

"Herb Wesson has done a good job representing the district during Mark's absence. Not having Herb in office until Mark's trial is over leaves the district with no representation and us without a voice for at least a year," observed one longtime District 10 resident.

Wesson said he had been enjoying retirement, spending time with his wife, children and grandchildren before being called back into service. "When there was a need for someone to temporarily step in and keep the district running, there was no way I could say no to my neighbors and friends that I love so much," he

Under the L.A. City Charter, council members are limited to three fouryear terms. However, they can also serve a portion of another official's unexpired term if that official steps

down ahead of schedule.

The fate of the 10th District has been in limbo Ridley-Thomas, who was elected as the district's councilmember in November of 2020, was indicted on bribery, conspiracy and charges in October 2021, for alleged crimes which occurred during his time as a member of the Los Angeles County Board of Supervisors.

Ridley-Thomas, along with his co-defendant, USC Dean Marilyn Louise Flynn, is accused of steering L.A. County funds to USC in return for favors. Ridley-Thomas has pleaded not guilty and has vowed to fight these charges to the very end to clear his name.

Registered voters of

District 10 filed an initial lawsuit to stop the Wesson appointment, have Ridley-Thomas reinstated to the City Council, and reverse City Controller's decision to suspend his pay and benefits. court ruled that the city was within their right to suspend Ridley-Thomas as well as suspend his pay and

However, Judge Strobel ruled that the decision Wesson's concerning

the city policy regarding term limits, needed to be decided by the Office of State Attorney General Rob Bonta. In their legal filings, the city's lawyers argued that any challenge to Wesson's ability to serve in public office requires a "quo warranto" action,

which requires the consent or involvement of the attorney general.

The Council voted to suspend Ridley-Thomas following his indictment and Council President Nury Martinez appointed Ridley-Thomas' of Staff Karly Katona to serve as the caretaker for the district until the end of 2021. This decision created a lot of complaints from residents of the 10th district who saw this "caretaker" title as leaving them without a voting representative to weigh in on budget decisions or re-districting matters, which were going on at the time of Ridley-Thomas's

suspension. In February, Council voted to approve Wesson as the district's voting representative until Dec. 31, 2022. Under this plan, if Ridley-Thomas is found not-guilty or the federal indictment were to be dropped, Wesson would simply step down clearing the way for Ridley-Thomas to return to his



elected office. Several residents of the

10th district believe that Wesson's appointment was the most reasonable move and provided the district with a representative who knew the district and the issues of the district better than any other possible candidate. It also ensured that whoever the appointed councilmember was could not run in the next council election either in 2024 or in a special election if the Ridley-Thomas case dragged on or if he were to be found guilty.

As of Sentinel press time, Rev. Smart and the group calling themselves Registered Voters of District 10 had not made a decision on continuing the fight against the Wesson appointment.

Council President Nury Martinez, who led the efforts to appoint Wesson as the interim councilman and was ratified by a unanimous vote of her fellow councilmembers, said she is "determined" give the representation.

Also, she has defended the council's decision on numerous occasions stressing that she had met with numerous community leaders and organization leading up to Wesson's appointment and said residents in the district "overwhelmingly suggested Herb Wesson as the most qualified person to serve the district as the interim councilmember."

Although in its 12th year, Leimert Park's "Day of the Ancestors: Festival of Masks" at the Leimert Park Artwalk so thoughtfully addresses these feelings, facts and heart knowledge that it would seem to have been conceived and established in direct response to this challenging

In the time and space it has created to enable residents to "be fully human, to be fully expressive, to cry, to holler/shout, to laugh, to move, to share news. To mourn. To celebrate."

People of all ages were invited to commune with their ancestors through mask-making and the learning of movement, rhythm and song. Local artists, culture bearers and youth apprentices led the joyful spectacle and spiritual experience that began with a blessing and libation ceremony, invoking community reflection and healing. The procession is said to symbolize the people's power and capacity to take ownership over their communities and overcome challenges.

Artistic Director Tamica Washington-Miller said, "We are exploring the conas well. Leadership team member Pastor Kelvin Sauls, former minister at Holman United Methodist Church, which is rooted in Christian principles, also believes strongly in the power of art to heal one's spirit.

In addition to further cultivating a feeling of belonging that will increase civic engagement, the focus will be on establishing enhanced connection to a holistic cultural framework aligned with an African worldview.

"[We will] promote the integration of arts and culture into the provision of wellness offerings as we partner with institutions that focus on Black community health," explains Mack, whose vision is clear and sound. "[We aim to] stabilize and ground the cultural worldview of participants as a buffer against ailments resulting from generational trauma."

A lofty aspiration, but "Day of the Ancestors: Festival of the Masks" is a formidable start.

L.A. Mission Prayer Walk Reclaiming Skid Row for Kingdom of God

With a loud shout of "Jesus is Lord, Jesus is Lord, Jesus is Lord," Elder Darin McAllister - along with a dedicated team of volunteers, ministers, and student leaders - boldly spoke words of life over the intersection of San Pedro and 5th Street in the heart of Skid Row.

On Friday, June 17, McAllister, senior vice president of Christian Ministries and Community Development for Los Angeles Mission, and the Boots on the Ground group, prayed over, encouraged, and provided hope to the men and women who live deep in the heart of Skid Row's "Hot Zone," declaring, "This is going to be a safe place, and this corner will be a place of transformation."

The group provided bottles, hygiene kits, and prayer for anyone who wanted it. "Most of the men you see out here volunteering today have been in this position before," said McAllister.

For example, Gustavo (Gus) Torres and other student leaders who were once homeless, hopeless, and addicted to drugs have now transformed their lives with the help of the L.A. Mission programs.

"Everyone here at the Mission has a powerful testimony of transformation, even our president and CEO. Pastor Trov Vaughn," said McAllister. It is often said of Pastor Troy that he has come from being a resident to the president.

One young man that McAllister and his team ministered to said, "I don't know how to get off this." McAllister encouraged the young man, and asked the group

of about five men that were with him, "How many of vou have been in his situation before?"

Everyone raised their hands and McAllister said to the young man, "You see how these men are clean now, you can be clean too. We are here to help you."

That young man's name is Dell, McAllister shared, and he urged others to pray for Dell. "When you mention someone's name, you're not just arbitrarily praying, but you are giving someone an identity when you call their name," he said.

According to McAllister, people with good intentions often think that a person's situation will improve once the person is off the street. "Although that is a noble idea, and it should be the goal, the problem is much deeper than that," he noted

"Homelessness is not just a social issue. It is not iust about housing - but it's a spiritual issue and it takes an embracement and undergirding of the entire person to transform the heart, mind, and spirit of individuals," explained McAllister.

"People on the streets often connect with those on the streets out here because of what they have in com-

mon," he said, citing as an example individuals who are addicted to drugs believe others afflicted with that disease will not judge them as harshly. The Mission staff applies a similar philosophy to assist people and persuade individuals to participate in one of the facility's programs to obtain a sense of community.

For example, McAllister said, "He loves God, I love God. I go to church. he goes to church, he supports me, I'm encouraging him, she's encouraging me, girl, we're going to make it together, etc. Now they can process and love and have a sense of community that is healthy for them."

He described the prayer walks as "intentional active engagement. Prayer and intercession are vital, but we're putting feet to those prayers, getting out on the streets, and taking this to another level. When we take those same prayers, from our churches and our homes to the community, and then engage, it's just like what Jesus and his disciples did, and therefore it's effective," he insisted.

On Friday, July 8, the Los Angeles Mission Ministry Team will engage the Skid Row community through prayer, encouragement, hygiene kits, fellowship, and the love of Christ.

Volunteers with a heart for the homeless, and who have the strength and energy to walk four-to-six blocks are invited to get their "boots on the ground" to reclaim Skid Row for the kingdom of God.

Anyone who desires to volunteer must show proof of vaccination and sign up in advance by the QRC code on the flyer or by visiting www.lamission.org.

Volunteers will meet for a brief orientation in the newly renovated Holsinger Chapel at 8:30 a.m., where they will receive instructions before going out to bless the people of Skid Row in downtown Los Angeles.

Nana Patrice Lumumba's Legacy: Living and Dying in Liberating Resistance

dangerous and demanding struggles to liberate ourselves African as peoples, to regain our freedom we had at birth and enjoyed for thousands of years before Europe, colonialism, imperialism, racism and the resultant rot and retardation of human relations, there are countless men and women whose lives and deaths offer libraries of lessons, models and mirrors of living and dying in rightful and righteous ways.

And such a man and African is Nana Patrice Lumumba (July 2, 1925 -January 17, 1961). Leading the Democratic Republic of the Congo to independence 30, 1960, assassinated and martyred at 35. Nana Patrice, in his brief life, leaves an awesome and enduring legacy of work and struggle to regain African freedom and in the process, he offers vital lessons of how to live and die in dignity-affirming, life-enhancing and worldpreserving ways.

Speaking of this honored Congolese independence leader, liberator, freedom fighter, Prime Minister and martyr, Nana Patrice Lumumba, Nana Haji Malcolm X, freedom fighter, moral teacher and martyr himself, described him as one of the greatest African leaders that ever walked the African continent.

Indeed, Haji Malcolm constantly raised up his life and the liberation struggle of the Congolese people, praising him and their righteous and relentless liberation struggle, citing the Simba, (the namesake of our youth organization, the Simba Wachanga, the Young Lions) as a model of revolutionary resistance by young people. He also condemned the brutal and savage role of the U.S. in the assassination of Nana Lumumba and the reversal of the independence victory the Congolese people had achieved at great cost.

Haji Malcolm rightly recognized and appreciated Nana Patrice's level of dedication. discipline, sacrifice and achievement, as we say in Kawaida, especially his courage and commitment in the face of death, his refusal under the penalty of death to buck, bow or be the caricature of a man, the colonialists and imperialists wanted him to be. Indeed, like Haji Malcolm would later do himself, Nana Lumumba chose to be a martyr in the liberation struggle of his people rather than compromise on what he called sacred principles of life and struggle.

In his last letter to his beloved wife, co-worker and co-combatant, Nana Pauline Lumumba, while in captivity and about to be murdered, he says, "Neither brutalities, cruelties, nor torture have ever led me to ask for mercy, for I prefer to die with my head high, with unshakable faith and profound confidence in the destiny of my country rather than live in submission and in contempt for sacred principles."

A critical source of the valuable expressions of these qualities and practices can be found in the collection of his writings, interviews, press conferences and letters in the book "La Pensée Politique de Patrice Lumumba (The Political Thought of Patrice Lumumba) published by Présence Africaine."

Nana Lumumba spoke of and upheld in practice the sacred principles of

love of and faith in the people, unity of the people in the Democratic Republic of the Congo and a Pan-African unity, especially as a continental project, an unbreakable faith in victory and a willingness to live and die in the pursuit and achievement of freedom. He constantly expresses his love of and commitment to the people and his belief in their capacity to regain their freedom interrupted by a savage genocidal colonialism imposed by Belgium and its European

allies, including America. Among his last words in his letter to his beloved wife, Nana Pauline, he expressed faith and certainty in their eventual triumph in securing their independence. He says, "As for me, I know that my country which has suffered so much, will know how to defend its independence and its freedom." And this faith is still unfolding as the Congolese continue their righteous resistance.

Key to liberation, he taught as all other liberation leaders, was the unity and common struggle of the people in all their diversity. In his speech to the First All African Peoples Conference held in Accra, Ghana, by Nana Osagyefo Kwame Nkrumah, President of Ghana, in 1958, he stresses that the National Congolese Movement (M.N.C.), the

liberation party he led, was committed to an inclusive unity and struggle for the Congo and the African

Thus, he strove for an "operational unity," a unity in diversity, but an active, principled, purposeful and productive unity. His intention which was shared by the Accra conference participants was overcome, avoid and resist that regularly used tactic of the oppressor to divide and conquer, divide and rule.

He states that "this tactic, which in the face of the coming into consciousness of the African peoples, adapts itself, taking subtle roundabout means to strike more than ever, to break the will for unity and for liberation of autonomous peoples and to impose economic dependence which is the basis of international imperialism."

Therefore, he said of the M.N.C., "We call upon all our compatriots of all conditions, no matter what their tendencies or their current or past differences, to put in common our energies and our courage to realize our necessary and indispensable joining together without which we cannot be able to affirm ourselves nor make our voices heard, that is to say, the voice of the Congolese people." In this practice, we say to and show the world "we are united for one same and just cause": liberation.

It is important to note here that Nana Lumumba rightly reasons that freedom "is a fundamental, natural and sacred right that no doctrine can dispute and no power can extract" from a people or person. And it is of equal importance to bring into focus his position that the Congolese people and all African people are not gaining a freedom given or granted, but are regaining a freedom lost, interrupted and denied by conquest, colonialism, imperialism and the Holocaust of enslavement.

Thus, what was lost was not the right of freedom, which is inalienable, but freedom itself must be regained through righteous and relentless struggle. Here he reaffirms the ancient African Maatian teaching that all humans are born free and that they are endowed by the Creator with certain inalienable rights found in the Husia in the Four Good Deeds of Ra.

Thus, he says, "The current dream of Africa, all of Africa, including the Congo, is coming into being as a free continent, independent, in the same way that all other continents of the world, for the Creator has willed that all humans and all peoples be free and equal."

He tells the oppressor that he must not try to play victim by wrongfully and maliciously labeling "as an anti-White, xenophobic agitator all Africans who condemn the injustices and abuses of which their people are a victim." For it is the victimizer, the colonialist who has proved himself anti-Black, xenophobic, racist and ultimately antihuman in his oppressive, imperialist and genocidal practices.

In fact, he calls the oppressor out, exposing and condemning both his practices and pretensions of being just, civilized and Christian. He says that "Africa in its entirety is irresistibly engaged in a struggle without mercy against colonialism and imperialism." For oppressor is using all the savage methods he can devise against us.

But we continue to struggle for "We wish to say good-bye to this regime of subjugation and degeneracy which has inflicted so

lives is forever changed.

he declares defiantly that "A people who oppresses another is not a people who is civilized or Christian" regardless of its claims to the contrary.

Finally, Nana Lumumba urges the Congolese leaders and people to stop the internecine conflict and wars, to stop letting the imperialists manipulate them reverse the people's hardwon independence. The overwhelming need, he says, is to remember the central objective which is to free ourselves, harness our resources "in a common effort to create a national economy which allows us to rapidly improve the life conditions for all the people."

This means the oppressor cannot be our teacher, tutor, sponsor or manipulator. For as Nana Lumumba defiantly declares, "We are Africans and wish to remain so. We have our own philosophy, our own customs, our own traditions which are as noble as those of other nations."

And thus, as always, we must draw from these our own distinct ways to practice freedom, serve our people, engage the world, and make our own unique contribution to the forward flow of human history and the achievement of an expansive and inclusive good in the world.

this disaster. How can LAPD blow up a neighborhood with zero accountability?


While we have made progress to make our community whole again, continue to face an uphill battle and

Neighbors living through the nightmare of the 27th Street fireworks explosion have been presented with a myriad of challenges no one could ever have prepared for. The destructive and unprecedented nature of this incident required my Office to think creatively in how we supported residents. Standard operating procedures for recovery of an event like this simply did not exist so we created a CD9 playbook from scratch. Although the City has a claims process in place by which residents get reimbursed, our residents do not have the time or the money to spare. On a daily basis my Office has been trying to find answers and some sort of resolution for

the various households affectedall predatory lawyers attempt to hijack any potential progress.

I remember the day like it was yesterday. It was one of our longest nights. Without hesitation, Team Price went to work setting up a triage to assist displaced neighbors with their most pressing needs. From providing emergency housing to ensuring our friends and families had food to eat and clothes to wear. Others asked for our help to get important documents from their homes, their medicine, arrange for an oxygen tank, a hospital bed and even help locate beloved family

Dr. Willie Morrow, Black Media Pioneer and Creator of the 'Afro-Pick,' Passes at 82


Dr. Willie Morrow, publisher emeritus of the San Diego Monitor and creator of one of the most well-known symbols of Black pride, the Afro Pick, passed away at his home surrounded by family on Wednesday, June 22.

Morrow is also the creator of "California Curl," a once-popular hair texturizer many call the forerunner to the Jheri Curl.

Born in Tuscaloosa, Alabama, to a family of sharecroppers, Morrow taught himself the basics of barbering and chemistry, tools that served as the foundation to his hair care

From the 1960's to the mid-1990's, Dr. Morrow set up his headquarters at 4165 Market Street in San Diego. The two-story building housed his barbershop, and publication

married the print and radio components together (with 92.5). It became the most powerful tool in the Black community."

In the 70s, as his popularity grew within the beauty industry, the Department of Defense enlisted Morrow to teach and cut hair on military bases and in war zones, which led to him writing several hair styling and barbering technique books.

In 2016, the Museum at California Center for the Arts in Escondido curated an exhibit honoring Morrow and his accomplishments. exhibit featured than 250 objects, from paintings to vintage hair styling equipment. Most of the objects were part of Morrow's own private collection.

The exhibit included a diorama of Morrow's Market Street barbershop, featuring the

barber chair he used for years. The red velvet chair hosted local Black leaders including the first Black judge in San Diego County, Judge Earl Gilliam, and even basketball hall of famer Michael Jordan as

Following his death, Morrow's daughter, Cheryl Morrow, will take over the newspaper and oversee her father's California Curl Company

"He had the foresight not just to create the style but the service so it can enrich an industry," said Morrow to ABC 10 News in San Diego. "Prior to 1962, you couldn't buy a comb exclusively for your cultural affinity," Morrow. "While that whole era was going on, San Diego Black panthers had the best afros."

Assemblymember Akilah Weber (D-San Diego) tweeted about the impact Morrow had on the city he called home.

"Our community is rocked by the news of the passing of Dr. Willie Morrow. He was a true San Diego success story; having built several businesses from hair care products to publishing. His legacy as an entrepreneur and community educator will continue to touch and inspire many."

Shane Harris, a San Diego-based activist and founder of the People's Association of Justice Advocates, expressed his grief about Morrow's death.

"Lost for words. To a man I called Dad, mentor, and confidant. Rest in Peace. Dr. Willie Morrow was one of a kind and was an innovator. San Diego has lost a tremendous leader. The creator of the California Curl and so much more has now left his earthen vessel," he tweeted.

Working alongside trusted partners, including healthcare organizations like St. John's Community connected Health. we victims to service providers who assessed and met their various needs and continue to do so until this day.

For a year now, my Office has been the center of disaster relief efforts. Aside from housing and ongoing home repairs, my Office has paid for everyday things like furniture, appliances, gift cards and other necessities to help our neighbors get by.

At my direction, CRCD

Enterprises has led efforts to clear-up debris, boardup windows and make repairs across 17 homes that were damaged. This includes everything from the installation of new windows, to painting, fixing stucco, repairing damaged



wood, ironwork, plumbing work, updating kitchen and bathroom cabinets and so much more.

As time progressed, I presented two motions in City Council totalling \$6 million in aid to pour resources and bring immediate relief into our impacted neighborhood. The funding allowed my Office to provide longer-



term, first-class corporate housing displaced to neighbors, continue to make home repairs across 27th Street and disburse financial assistance in the amount of \$10,000 for 26 of the most severely impacted households. It also made it possible for the opening earlier this month of the Trinity Neighborhood Center, operated by All Peoples Community Center which has provided case management to impacted households



since the beginning of the devastation.

At this community hub inside Walker Temple AME Church in District 9, local neighbors have direct access to a wide range of free services five days a week, including continued management, resources such as food, diapers, rental or utility assistance, employment and immigration services, financial literacy, tutoring services, parenting classes. licensed mental health therapist is onsite and the center will collaborate with mental health providers in the area, including Kedren Community Health Center. The Trinity Neighborhood Center also puts City departments under one roof to assist residents with their longer-term needs. To get in touch with the Neighborhood Center call: (213) 300-0784 or (213) 536-5030. Help is available in both English and Spanish.

As we move forward, we will need a long-term recovery plan for 27th Street and the surrounding area; one that is going to help bring stability to the lives of those affected, revitalize and uplift our neighborhood. I'm especially concerned about potential gentrification and my Office will do everything in its power to prevent this from occurring. We are far from where we need to be, as a neighborhood and as a City. But we are starting to see a silver lining thanks in part to allies like the City of LA's Community Investment for Families Department (CIFD) and All Peoples Community

Some of the highlights include: a total of 70 individuals served, 164 different social services provided, 87 percent of affected individuals have been linked to mental health services, nearly \$320,000 in direct financial assistance distributed and 25 percent of families were rehoused. We're currently assisting households relocation. Unfortunately, there are several tenants and property owners that have been somewhat hesitant to relocation and/ or home repair services. While I appreciate their trauma, we will continue to assist them.

It's a long road to recovery, but I remain committed to seeing this tragedy through until every last person is back on their feet. Mark my words, 27th Street will regain its full strength!

Elisha had told him to dip in river Jordan seven times and your flesh shall come again to you and you will be clean."

Naaman followed instructions from a little young maiden who had faith. He set aside his bold ego and arrogance. He heard the voice of reason from his own servants! Follow the voice that hears with great wisdom.

'All Rise' for Actress Simone Missick

The star of the OWN series on stepping into her new role as an Executive Producer

In the opening scene for the third season of "All Rise," we believe Lola Carmichael (played by Simone Missick) has lost her election and her seat as a judge only to reveal that she actually won.

The series initially had a similar fate, canceled by CBS to later be picked up and renewed by OWN (The Oprah Winfrey Network). In an exclusive interview with the LA Sentinel, Simone Missick shares the importance of using her voice as an executive producer to create an inspiring and culturally relevant narrative.

L.A. Sentinel: In addition to starring in the show, it's exciting to also see you credited as an executive producer. Can you share what that role entails?

Simone Missick: I came into season three knowing I wanted to be an executive producer. I have three fellow coproducers, Denitria Harris-Lawrence who is our showrunner as well as Michael Robin and Len Goldstein who have been with the show since the beginning. I was stepping into this [role] knowing that I was going to be partnered with people that I trusted creatively and professionally to tell impactful stories while also being timely and culturally relevant.

As an executive producer, there's a level of joy I have

going to work everyday being the lead on the show and then being able to help to tell it in a stronger, more culturally specific way. [For example] I said

Lola has to go to Howard University. She was supposed to have gone a school in California for undergrad and I said, 'Oh no! She had

to have gone to Howard. Those things are important. I remember growing up and watching 'The Cosby Show' and seeing all those [college] sweatshirts that Cliff Huxtable wore and asking, 'Where's that school?' As an HBCU (Historically Black Colleges & Universities) alumna, I know how important those images are for young Black students and it was important for me to share that with the 'All Rise' audience.

LAS: Having watched several episodes from season 3, it seems as if some of the

storylines are inspired by current events. Can you share what type of cases we can expect this season and how Lola will navigate these issues in her courtroom?

SM: The show tries to illuminate that people are in charge of our criminal justice system and yes we have written laws but those laws are manipulated, changed and stretched to fit whatever narrative that a person may have consciously or subconsciously about an individual or a group of people.

This season we'll see how difficult it is to get a wrongfully convicted man exonerated. Then we find ourselves dealing with a serial killer that's been targeting black women in Los Angeles for decades.

Another episode that I'm really excited about is whether teaching Black History should be allowed in schools. There's a moment when one of our characters can't understand how this debate is happening in California. They say, 'I know it's happening down south, I know it's happening in the midwest, but in Los Angeles?' and Lola's response to that is very much in line with my [own] awareness of where we are as a nation and the need for people in power to hold on to that power by trying to shape a narrative about the history of this country.

Those are just some of the examples of the cases we have coming up. Some of which, as you said are 'ripped

some have been a part of the criminal justice system forever. I think ['All Rise'] does it in a way that feels fresh and exciting for our audiences while also asking them to question their own biases and their own judgements of who's guilty, who isn't, who deserves rehabilitation and who doesn't. Who deserves a second chance and who's irreparably damaged and thus needs to be put away for life.

LAS: Can you share advice for fellow creatives who may feel as if they've been hard at work for years but have yet to experience their big break? How do you remain resilient during the toughest times?

SM: I thank God for my husband who's my prayer partner, my biggest supporter and someone who's also in the industry so he understands the highs and lows. He's encouraged me for years before it happened. I also have a strong prayer group of women, we study the word together, we lift each other up in prayer for auditions and meetings and also encourage one another because there are peaks and valleys.

As artists we have these ideas of the way it should go but for me, I thank God for every 'no' that I ever received that led me to 'Luke Cage' because they weren't looking for somebody who we had seen everywhere. It had to be me, one, because that's how I





Along with excelling on the hardwood, Pippen Jr. excelled in the classroom and was on the 2022 SEC Academic Honor Roll. As a sophomore, Pippen Jr. scored a career-high of 36

Injuries plague Shareef's college years, from the heart surgery he had while at UCLA to foot issues at LSU. However, his college career had some highlights; with the Bruins, Shareef made a career-high of 11 rebounds.

Although his scoring average was around two points per game throughout his college career, Shareef scored eight points against Missouri as a junior. His heart issues kept him from showing all the nuances of his gameplay, according to Shareef.

"I feel like I haven't gotten a real chance to show what I used to do back in high school," he said. "I feel

Pippen Jr. put on a strong performance at the NBA Combine in May, showing off his keen offensive skills and effective

defensive gameplay. During one scrimmage, he scored 21 points. Sources said that the scouts who attended admired his basketball IQ.

Shareef participated in Pre-Draft workouts with the Lakers and the Washington Wizards.

Both Shareef and Pippen Jr were invited to compete in the NBA G League Elite Camp. Shareef scored a double-double (11points and 10 rebounds) during the second day of the Camp.

Pippen Jr. competed in the Elite Camp last year before withdrawing from the 2021 NBA Draft to return to Vanderbilt.

Shareef choosing to head to pro basketball came with opposition from his father, who wanted him to stay in school. During his Pre-Draft workout with the Lakers, he admitted that he has not talked to Shaq regarding his pre-draft process.

"Me and him bump

heads about this process, he knows I'm working out for teams," Shareef said. "He didn't do any pre-draft workouts, he just got straight on a team, so it's a different grind."

Pippen Jr. and Shareef played high school basketball in Southern California. Pippen Jr. competed for Sierra Canyon where he averaged 16.3 points, 3.6 rebounds and 4.6 assists per game as a senior. He also competed for the Nike EYBL's Oakland Soldiers where he averaged 15 points, 3.6 rebounds, and 2.6 assists.

Shareef helped the Crossroads Roadrunners win the CIF Division II state championship as a senior. During that year, he averaged 27.6 points and 17.3 rebounds per game.

Pippen Jr. and Shareef will be competing during the 2022 NBA Summer League from July 7 to July 17.


