The U.S. Senate voted on Wednesday to confirm Rep. Marcia Fudge as Secretary of the Department of Housing and Urban Development.

The confirmation was met with applause from women's and other groups.

"We applaud the confirmation of Rep. Fudge as secretary of the Department of Housing and Ur-

ban Development (HUD)," Marcela Howell, president and CEO of In Our Own Voice: National Black Women's Reproductive Justice Agenda, responded in a statement.

"Her appointment comes at a pivotal time when her leadership is sorely needed. The U.S. faces a severe housing crisis as millions of residents struggle to pay their rent and mortgages due

The previous town hall Bass conducted was preceded during the aftermath of the infamous 2021 Breach at the United States Capitol—early January. In retrospect, the right-wing attack against members of congress ended with 5 people dead, and 2 related suicides.

Despite politics obvious contentions, the American Rescue Plan Act of 2021 (ARP), persisted as the primary focus of the Thursday evening town hall. Speakers such as, California State Senator Sydney Kamlager and District Director of SBA Los Angeles District Office Ben Raju compressed the relatively tall piece of legislature to key "highlights," as well as announced notable "changes and provisions some good news due to the changes in the Child Tax Credit. Under the American Rescue Plan, taxpayers can claim a credit of up to \$3,600 per child under the age of 6 and up to \$3,000 for children ages 6 to 17. The Child Tax Credit has the potential "to cut child poverty in half," said Congresswoman Bass. "One of the reasons we did this is because we would love to make it permanent."

California's newest State Senator, Sydney Kamlager-Dove announced that the "[The] Employexemption for the first \$10,200 of unemployment benefits received in 2020.

Before long, the APR will provide a third round of stimulus payments, which up to \$1400 will be directly deposited in the bank accounts of adults or any dependents. However, "be careful" when filing taxes due to potential ineligibility issues regarding stimulus checks. Congressmember Bass advised, "If your 2020 tax data is going to make you ineligible for

these payments, be careful [and] wait to file [taxes] until April, and the IRS will look at your data based on 2019 [tax return]."

The Small Business Administration (SBA) is currently offering PPP loans until March 31, 2021, and this includes expanding eligibility to nonprofits and digital needs services, which was not available before. Since funding closed in August, according to Ben Raju, "Over \$7.25 billion [will be added to the] Paycheck Protection Program (PPP)," as well as an additional \$15 billion for Targeted Economic Disaster Loan Injury

Californians will also receive additional economic benefits from the newly passed a budget called the "Golden State Stimulus," which will act "very similar to what's happening at the federal level," according to Senator Kamlager-Dove. Your 2021 Stimulus Cash: Differences Between Your Federal and State Checks

Direct cash relief is coming to Californians soon. Both the state and federal government have begun issuing stimulus checks to Americans.

The American Rescue Plan, which includes the third and largest round of federal COVID-19 stimulus of the pandemic so far, was signed into law by President Biden on March 12. According to several reports direct deposits began hitting peoples' bank accounts as soon as March 14, with paper checks and pre-paid debit cards expected to follow soon.

Low-income Californians can also expect a statespecific Golden State Stimulus check, which will be distributed over the course of 2021. Though both stimulus payments are dispensed automatically, they do have big differences when it comes to qualifica-

For the federal stimulus payment, the full \$1,400 amount will be distributed to individuals with an adjusted gross income less than \$75,000, heads of households earning less than \$112,500 and married couples earning less than \$150,000. Payments will gradually lower for people earning more than those amounts, with the cutoffs payments \$80,000 for individuals, \$120,000 for heads of households and \$160,000 for married couples.

This stimulus round will also include an addi-



tional \$1,400 payment per dependent. Unlike previous rounds, this round will also include payments for dependents age 17 and above. The maximum amount possible is \$5,600, for a couple with two adult children.

The income thresholds for this federal stimulus round are based on the most recent tax return filed. Like the previous rounds, the money will be automatically distributed to people who have their tax information filed with the IRS. All eligible recipients, including those who don't typically file taxes, can use the IRS' "Get My Payment" website to request a payment or check its status.

California's Golden State Stimulus relief package was signed into law by Governor Gavin Newsom on Feb. 23. The package includes one-time stimulus payments for Californians 18 years or over who receive the California Income Tax Credit (CalEITC) or file with an Individual Taxpayer Identification Number (ITIN). An individual who is claimed as a dependent on another person's tax filing is ineligible to receive a


payment.

The California stimulus payment will be either \$600 or \$1,200, based on the recipient's eligibility. Californians who either receive the CalEITC, meaning they make under \$30,000 in taxable income along with other qualifications, or file with an ITIN and earn \$75,000 or less will receive \$600. Californians who meet both of these conditions will receive \$1,200. For couples filing jointly, the ITIN requirement will count if at least one person in the couple files with an ITIN.

The biggest difference between the Golden State Stimulus and the rounds of federal stimulus checks that have been issued so far is that eligibility in California is based on 2020 tax returns. The payments will be determined by tax returns filed by October 15, 2021, which is the deadline for filers who request an extension on the original Apr. 15 deadline. The payment itself expires on November 15, 2021. The Golden State Stimulus will go out automatically after 2020 tax returns are filed.

The \$1400 federal stimulus checks are based either on 2019 or 2020 tax returns.

Two African Americans on Team Advising Gov. Newsom on 'Inclusive' Reopening

Last week, Gov. Newsom appointed former Stockton Mayor Michael D. Tubbs, who is African American, as his special advisor for Mobility and Opportunity. In this role, Tubbs becomes one of two African Americans on the governor's Council of Economic Advisors (CEA) -- a group Newsom has charged to help California recover from the economic downturn the coronavirus pandemic has caused.

The other Black gubernatorial advisor is Renee Bowen, an associate professor of economics at the University of California San Diego. Tubbs and Brown are serving along with 11 other experts Newsom says will help offer guidance on how to rebuild a state economy that is more sustainable and inclusive.

The CEA team will help to build political will, championing policy changes that aim to promote equitable economic opportunities and fight poverty for all Californians, according to the governor's office.

"As we fight the dual pandemics of COVID-19 and economic insecurity, I am honored to work with

the Newsom Administration to bring forward innovative solutions that will lead to inclusive economic recovery for all Californians," said Tubbs.

On Friday, President Biden signed Congressional Democrats' \$1.9 trillion American Rescue Plan. The federal economic package includes \$1,400 stimulus checks for individuals nationwide. In his third State of the State Address, Gov. Newsom recapped the state's plans to support small businesses, reopen schools, promote equitable vaccine distribution, and provide state stimulus funds. The recently appointed CEA will advise California lawmakers on directing state and federal funds toward programs and investments that soften the pandemic's economic blow.

Although the advisers are not compensated for their roles, they will leverage their areas of expertise as well as their familiarity with business and industry in California to ensure that California families "have the opportunity to not just survive but thrive," during the pandemic, state officials said.

As a special advisor, Tubbs plans to recommend

best-practices gleaned from various external stakeholders, including economic experts and business leaders to reform state policies that will benefit all Califor-

"As I always say, poverty is a choice: a policy one," Tubbs said. "I can think of no greater calling than to build upon my work with Mayors and community leaders across our state and nation to help advance big, bold policy solutions that are rooted in economic fairness, racial equity, and recognize the dignity of all people."

Gov. Newsom said Tubbs has proved himself as a leader who cares deeply about his community and economic fairness.

"I can think of no one more dedicated or better equipped to make recom-

mendations to my team and help lead outreach efforts to increase opportunity and entrepreneurship to reduce poverty in California," said Newsom.

During his time as Mayor of Stockton, Tubbs implemented the first mayor-led Universal Basic Income pilot program in the country, and he launched the Stockton Scholars, a program that helps Stockton's youth pursue higher education.

"Tubbs expanded opportunity and hope in his hometown," Newsom continued.

According to state officials, California experienced record-low unemployment before the pandemic -- a rate of 3.9 %. Gov. Newsom plans to resolve California's fiscal problems, strengthen the ic," Gov. Newsom said. "All state's economy, and drive unemployment back down from just below 10 %, according to numbers the Employment Development Department released in December.

"We need to invest for the future, adapt to a changing climate, and keep our budget balanced," Gov. Newsom said. "This Council will keep its pulse on what's happening in our economy while making policy recommendations to prepare us for what's to come."

Biden-Harris Administration's \$1.9 trillion **American Rescue Plan** Act and vaccine expansion

Biden-Harris The Administration announced the passage \$1.9 trillion in federal aid Friday, includ-\$1,400 stimulus checks, to help people affected by the pandemic nationwide.

California legislators continue efforts to boost small businesses as well as support K-12 and higher education as they wait for directives from the federal government on how to allocate the funds.

"The American Rescue Plan will help California roar back from this pandemof these pandemic responses add up to a brighter future for California."

State officials said they plan to use the funds on equity, housing affordability, education, and infrastructure to ensure that people come out of the pandemic, "as a stronger and more inclusive California."

In addition to stimulating the economy, the Biden-Harris Administration announced plans to increase access to coronavirus vaccines to all adults by the beginning of May this year. Newsom said President Joe Biden's announcement indicates that "the light at the end of the tunnel is getting brighter," a sign, he says, that vaccinating everyone will be a reality soon.

Despite the limited vaccine supply, Newsom says California's distribution efforts are guided by equity.

The state has prioritized those who are most exposed and at risk of contracting the coronavirus since it is, "the right thing to do, and the fastest way to end the pandemic," said Newsom.

What the \$1.9 Trillion American Rescue Plan Means for Californians

Last Friday, President Joe Biden signed the latest round of federal COVID-19 relief, the \$1.9 trillion American Rescue Plan, into law.

The broad scope of this

stimulus package covers a wider range of national and state priorities as compared to previous federal government relief efforts. This one is aims to both prepare the country logistically to emerge from the pandemic and to recover from the economic strife of the past year.

"This historic legislation is about rebuilding the backbone of this country and giving people in this nation, working people, middle-class folks, the people who built this country, a fighting chance," President Biden said March 12.

Lawmakers and policy analysts alike have shared their thoughts about the legislation, and how it will affect multiple areas of need for Californians.

In his statement, Gov. Gavin Newsom focused on the aid that the state will receive from the legislation. Together, California state and local governments are set to receive over \$40 billion dollars.

"With this infusion of federal stimulus, California can make faster progress on responding to COVID, supporting small businesses, putting money in people's pockets, and bolstering K-12 and higher education. All of these pandemic responses add up to a brighter future for

California," said Newsom. The governor says he looks forward to working with partners in the Legislature to identify "key shared priorities" such as equity, housing affordability, education, and infrastructure, and to chart a path for the state to come "out of this pandemic as a stronger and more inclusive California."

Direct aid to Californians includes one-time \$1,400 stimulus payments for people earning less than \$75,000 and \$300 supplemental weekly unemployment benefits through Sept. 6. The first \$10,200 in unemployment benefits will also be nontaxable for households that earn under \$150,000.

The American Rescue Plan also provides aid for families with children through an expansion of the child tax credit. The one-year expansion increases the credit to up to \$3,600 per child, distributed in monthly installments. According to projections by the Urban Institute, the child credit tax expansion will cut child poverty in half.

"It is unacceptable that in the richest country in the world, millions of children continue to go to bed hungry and are deprived of basic resources they need to succeed. As Co-Chair of the Majority Leader's Task Force on Poverty and Opportunity, I applaud this long overdue effort to dismantle the systemic inequality that keeps kids and families at the bottom of the economic ladder," says U.S. Congresswoman Barbara Lee (CA-13).

The American Rescue Plan also includes nearly \$130 billion in grants to state and local educational agencies, along with \$39 billion in grants to higher education institutions and \$15 billion to childcare facilities, to assist with safe school reopening.

The package also provides increased funding for programs that help lowincome earners. \$25 billion will go to emergency rental assistance, with \$5 billion set aside for emergency housing vouchers for unhoused people and survivors of domestic violence. Also, a provision in the package increases the value of cash vouchers for the Special Supplemental Nutrition Program for Woman, Infants and Children (WIC).

For business owners, the Small Business Administration (SBA) will receive \$25 billion for a new grant program for restaurants, bars and other food and drinking establishments," with \$5 billion targeted for businesses with lower revenue. Also, an extra \$1.25 billion is set for the SBA's Shuttered Venue Operators Grant, which supports live music and performance venues.

In an online briefing held by Ethnic Media Services on Mar. 13, the panelists spoke about how the legislation could serve as a blueprint for future permanent legislation.

"I should emphasize that all of the almost all of these are short term provisions, they are not permanent. But they provide guidance about the kinds of policies we might want to be enacting going forward on a permanent basis," said Chad Stone, Chief Economist at the nonprofit Center on Budget and Policy Priorities.

Leadership, Family, and Lessons Learned: Four Generations of Women Navigate the Pandemic Together

Navigating a pandemic with a four-generation family bubble has its ups and downs. Kimberley Goode, senior vice president of External Affairs at Blue Shield of California, has experienced it first-hand while sheltering at home with her mother, her grandmother and her college-age daughter, along with her husband.

At the start of the COVID-19 pandemic, the biggest adjustment came when Goode's employer shifted all but essential office workers to work from home full time in March of 2020. When that shift began, Goode started working at her dining room table, competing with family members for WiFi and trying to keep the home quiet while navigating video calls with coworkers.

She also had to take on caregiving duties, assisting her 75-year-old mother and her 95-year-old grandmother to avoid the risks of having home-health worker visits. That meant squeezing in meal planning and medication distribution between work meetings and taking on responsibility for helping her grandmother get dressed and ready for the day.

"Becoming a hands-on elder caregiver required me to coordinate my calendar to manage both home and responsibilities," work Goode says. "It meant planning for quick breaks throughout the day to step away from work to do what was needed at home."

After a few months, it became clear that she would not be returning to the office any time soon, and home and work were don't. Business leaders colliding.

To get her arms around everything on her plate, Goode needed to establish a more permanent workspace with separation from home life and more organizing tools. She ordered a whiteboard to keep track of projects, borrowed her grandmother's antique desk and set it up in the corner of the living room. Her new workspace is flanked by two windows that provide natural light and a bird's eye view of package deliveries, now that most shopping is being done online.

Goode believes that managing through the pan-

should consider these unique differences, as we set expectations for productivity and success."

Personal self-care is important at any time in your life, Goode emphasizes, but never more so than now. Listen to your body, she says. "I take micro-breaks during the workday. I walk down the driveway to pick up the mail or enjoy a few minutes of sunshine in my backyard. After work, I unwind mentally by riding my bike, walking, gardening, or watching movies."

Goode acknowledges that her family has been

demic has made her a better family member and corporate leader. "I'm more empathetic, and more conscious of what's important and what's not," she explains. "I understand how dynamics in every household can impact what colleagues may need from me. For instance, parents who transport young children to and from day care or school have very different schedule needs than people who

"We trust our doctors, made appointments and both are now vaccinated with no issues at all."

On a personal and professional level, Goode hopes that others in the African American community will also jump at the opportunity to be vaccinated when it's Blue Shield in its role as the third-party administrator for the state of California's vaccine program. "The disproportionate

As Stimulus Checks Go Out, Beware Scammers, Says FTC

New COVID-19 stimulus checks are either incoming or have already reached the pockets of eligible Californians -- either through the federal American Rescue Plan or the Golden State Stimulus. With the cash

"There are definitely pretending to be a government agency or your family member or somebody that you're in love with. They sometimes have just enough information about you to make it feel like it's real, or they try to threaten you and make it feel really urgent. They say that you're

coming in, the U.S. Federal Trade Commission (FTC) is warning the general public about an expected wave of fraud targeting peoples' stimulus cash.

Reports of fraud have risen throughout the country over the last year since the onset of the COVID-19 pandemic. While fraudsters target the public at-large, a 2016 FTC report found that African Americans and Latinos are more likely to become victims of fraud than Whites. The same report emphasized the importance of consumer education in Black and Brown communities, so that people can recognize fraud schemes before they lose money.

The types of fraud are wide ranging, according to Jennifer Leach, director of the Division of Consumer and Business Education at the U.S. Federal Trade Commission.

going to lose your social security number if you don't pay them, which is not going to happen, or that someone that you love is going to be in trouble," says Leach.

The pandemic may have also caused the general public to become more susceptible to fraud, according to Leach, possibly due to heightened lev-

els of stress and anxiety. "It's hard to get the message about fraud across to people when they're feeling alone or worried or just anxious about people they care about or their own financial security. People who are worried about their income or jobs, or how they're going to make rent, may be at greater risk for scams simply because they are worried, and so scammers who get hold of them and threaten them with things have a bigger impact

on them," says Leach.

to the upcoming federal stimulus checks, which the IRS began distributing last weekend after President Biden signed the American Rescue Plan into law on Mar 12.

"We're seeing that scammers are calling and texting, emailing and even messaging people on social media, to try to get people to pay to get their stimulus check. You don't have to pay to get the stimulus check, and you don't have to give your information to anybody. It's all happening automatically," Leach.

Non-stimulus specific fraud has also been on the rise during COVID, including fake COVID-related treatments, counterfeit personal protective equipment and fake work-from-home According to offers. Leach, one warning sign is

the method of payment. "I think the other thing that's really important for people to know is that no one legitimate will ever demand that you pay by gift card, by cryptocurrency, or by wiring money. It's always a scam. No matter what the story is, if they're saying you have to pay one of those ways, it's a scam,"

says Leach. Consumers who want to stay updated about fraud that has been reported and confirmed by the FTC can find information on the agency's consumer website. As for people who have already fallen for fraud, Leach recommends both reporting the scammer to the FTC and talking with members of their community about the scheme.

represented; contributing to the navigation of the directive as it develops over a 10-year span. Gold Sachs is planning to collaborate with Historically Black Colleges and Universities and the Hope Enterprise Corporation.

Morial continued to break down the significance of Black women in the workforce, quoting his statement from the previous mentioned source, "...Black women are emerging in a place of power in American life that is long overdue. So to focus on an initiative like this, against the backdrop of facing double barriers of race and gender, is timely, critical and necessary."

Co-founder of Bake Me Happy, Letha Pugh has felt the benefits of one of Goldman's small businessfocused initiatives; her business grew significantly; she credited the success in working under the guidance of Goldman's 10,000 Small Business Program. Pugh stated to Essence, "...I believe because I had assistance from Goldman Sachs that I didn't go into panic mode. I just went into, Okay. I remember in a specific module, we talked about all the different ways our businesses could be successful."

The One Million Black Women directive is derived from social research demonstrating that Black women are a solid investment, Gizelle George-Joseph, global chief operating officer of the Global Investment Research Division for Goldman Sachs told the previous mentioned source, "If we equalize Black women's positions, because Black women are one of the most marginalized groups in this country, then it's an economy that's working for everybody. What we found from our analysis was that reducing the gaps that Black women experience would actually increase U.S. GDP by at least \$300 billion a year..."

The financial institution found through their previous partnerships with entrepreneurs, that the initial business grew, in addition to creating jobs and overall growth within diverse communities. The \$10 billion dollars in support in Black women will nourish the idea of racial equity by providing more resources, driving economic progress for the U.S. as a whole.

Margaret Anadu, global head of sustainability and impact for Asset Management explained to Essence why there is a focus on the growth of Black women in Business, "How we hire women, how we retain women, how we promote women, how we invest in their companies—this is a massive cultural issue with deep roots." Anadu acknowledge the opportunity that is seen in society and it is a shared responsibility to be inclusive.

According to the official press release, Solomon stated, "Our newly published research, 'Black Womenomics,' suggests that no investment could have a bigger impact than unlocking the economic potential of Black women." Transparency is going to be a vital measurement in tracking the investments and the results will be shared publicly.

Solomon continued, "In the face of significant disparities, they've shown admirable resilience, especially as they're starting businesses faster than anyone else in the U.S. Building on our 20-year history of investing in female entrepreneurs and underserved communities--we are now proud to partner with Black female-led organizations and an outstanding advisory council to invest in opportunities to unlock their economic and leadership potential."

Come July, California Will Swap Juvenile Jails for Reform-Minded Rehab Centers

Starting in July, California's youth prisons will no longer be accepting new inmates, with a few exceptions. The state is moving most of the estimated 750 children it currently houses in its three remaining detention centers to rehabilitation facilities.

In California, the percentage of Black youth among incarcerated juveniles in California is nearly six times the percentage of African American children in the state. Children serving time in juvenile prisons are 30% Black and about 60% Latino even though African Americans account for nearly 6 % of California's total population of about 40 million people. Latinos make up about 39 %.

Once the state shuts down the juvenile prisons it currently operates, youth convicted of violating California law will be subject to the local county rehabilitation rules that will be set up in the jurisdiction where the young person commits the crime. The newly formed California Office of Youth and Community Restoration is sending hundreds of millions of dollars in grants to the state's 58 counties to fund the creation of the programs that are replacing youth detention centers.

"We have learned a great deal about what youth rehabilitation may truly look like; this includes trauma informed programmental ming, health resources, ways to address issues like substance abuse, de-escalation, stronger academic supports, family

counseling, and so on," Assemblymember Mike Gipson (D-Carson) told California Black Media.

"This approach is reimagining of care needed to eliminate the school-toprison pipeline," continued Gipson, who is chair of the Assembly Democratic Caucus and represents a district that covers parts of Los Angeles County, including Compton, Dominguez Hills, Watts and sections of Long Beach.

California's current push decarerate youth was preceded by widespread calls for criminal justice reform in the state and several pieces of corresponding legislation proposed by several lawmakers. California Legislative Black Caucus members Sen. Steven Bradford (D-Inglewood), Assemblymember Kevin McCarty (D- Sacramento) and Gipson were among the legislators championed who reforms.

Gov. Newsom signed the bills into law last year.

"We heard those calls for action loud and clear and today are advancing reforms to improve policing practices by ending the carotid hold and requiring independent investigations in officer-involved shootings," Newsom said in September of 2020 as he signed the bills. The carotid hold is a maneuver that restricts blood flow to the brain, causing a victim to become unconscious or even die.

Newsom also made it a point to mention that stakeholders on all sides of the youth imprisonment problem are involved in rethinking what juvenile justice should look like in

California. "Working with our youth, faith and community leaders, law enforcement, the legislature and countless others demanding change, my Administration remains committed to the important work ahead to make our criminal and juvenile justice systems fairer and safer for all Californians," Newsom said.

Jamilia Land is a Sacramento resident, member of the Abolish Slavery National Network (ASNN) and founder of A.S.A.P., an organization focused on assisting children who have run-ins with the criminal system. justice described the minors she encounters through her program's outreach.

"The majority of the youth that we work with come from lower income, impoverished communities," Land said. "Oftentimes, these youths have experienced being in foster care, being raised by a thirdparty adult -- not a biologi-



cal mother or father. A lot of these children are being raised by extended family."

Land says youth imprisonment is not a coincidence or unfortunate consequence, but an essential function built into the structure of a flawed juvenile justice system.

"It was designed to incarcerate anyone who's impoverished or of color in this country. We often hear that the system is broken, it's not. It's doing exactly what it was meant to do," Land said.

Over the years, many California-based organizations have worked to remedy the problem of youth incarceration. One of them is the Ella Baker Center for Human Rights. The national organization, headquartered in Oakland, celebrated the state's decision to replace juvenile prisons with rehab centers.

"Since 2001, the Ella Baker Center has highlighted the abuses of the Division of Juvenile Justice (DJJ) to young people and their communities through the Books Not Bars campaign which successfully fought to close five of the eight California youth prisons, resulting in an 85% reduction in the youth prison population," reads the organization's website.

Gipson was sure to note the importance of organizations like the Ella Baker Center.

"The value of grassroots initiatives and organizations often behind them is critical from an effective advocacy lens gathering interests of our communities," Gipson stated. "Those who practice in these spaces are boots on the ground and play a key role as change agents when

change is needed." But however historic and radical this change might seem to many, youth advocates like Land remain cautious. She says "half measures" may not be enough to solve deeply entrenched problems.

"There is no redesigning the system. There is deconstructing it and reconstructing components that actually promote safety and overall community wealth," warns Land. "The prison industrial complex is now being reshaped and refashioned to look like rehabilitation. Don't be deceived, it is still the same thing."

Gipson, on the other hand, remains optimistic about the future of the juvenile justice system.

"Yes, of course I am optimistic moving these youth out of the Department of Corrections and Rehabilitation (CDCR) and into the Department of Health Care Services (DHCS) and the Department of Social Service (DSS) because they will have a better understanding of what Justice Involved Youth need. They will be able to provide them with a well-rounded approach to focus on rehabilitation and less on punishment," Gipson said.

The voice of South L.A. was amplified by community leaders on March 10, at the "Making Los Angeles Whole" round table discussion. They spoke candidly about the means of a financial arrangement for the anticipated \$1 billion dollars coming from federal assistance. Public leadership from diversified organizations dissected the needs of each community and presented an investment plan to address issues impacting impoverished and working-class families.

The conversation was geared towards re-imagining life in the wake of a global pandemic, and the opportunities in growing a more connected Los Angeles. Southern and Eastern parts of L.A. have seen an extremely disproportionate impact due to COVID-19; as the viral pandemic changed the way Los Angeles operates, many who were below the poverty fell deeper in harsher conditions.

According to the Making Los Angeles Whole press release, they conducta study through Advancement Project CA that concluded, "African Americans and Latinos, who are the primary demographic of South L.A., East San Fernando Valley, and East L.A.--have among the highest COVID-19 death rates, and East L.A. ZIP codes rank among the highest in the state for risks of infection, deaths, and a longer economic recovery."

Making Los Angeles Whole is a radical recovery plan for all Angelenos, looking to resolve pre-existing problems that are now exasperated. The most vulnerable residents are feeling the hardships and trauma in various ways; Angelenos

They formed the multi-layered directive, allocating a well calculated budget to aid the South Los Angeles community.

The mission of the meeting was to provide a clear understanding of an equitable spending plan. Making Los Angeles Whole believes "the city must be intentional in directing this investment towards poor communities and working-class families across the city, which have been hardest hit by the COVID-19 pandemic.

Alberto Retana, presi-

dent & CEO, Community Coalition was joined by Charisse Bremond-Weaver, president & CEO, Brotherhood Crusade, Maria Brenes, executive director, Innercity Struggle and April Verrett, president, SEIU Local 2015 to discuss the history of inequality found within Black and Brown communities. They dissected discriminatory encryption found within current zoning and planning decisions.

South Los Angeles leaders spoke with sincerity as they outlined the funding needed for different issues. Making Los Angeles Whole covered a variety of issues stemming from diverse demographics. They are looking for the city to allocate appropriate funding to assist residents who are barely surviving the COVID-19 outbreak.

The benefit of non-profit organizations collaborating is that each taking a magnified look in various issues; to promote better quality of life for all Angelenos. The Innercity struggle (ICS) mission is to create an influential movement among the Eastside of L.A.; they look to build up neighborhoods such as Boyle Heights, unincorporated East Los Angeles, El Sereno, and Lincoln Heights.

The SEIU local 2015 represented California's Long Term Care workers; it's an organization that harnesses the power of collective support and technology to bring on long-standing transformational change for a more just society. During the pandemic, SEIU local 2015 donated \$500,000 to organizations throughout California.

Initiated through the Biden American Rescue Act, the city could receive a direct infusion of \$1.3 billion. Making Los Angeles Whole addressed the budget gaps across various impacted communities in L.A. The conversation was an "official call for help, for the families and communities." The non-profit organization leaders are presented budgets that would cover a resident for two years.

Collectively, the nonprofit organizations are asking for \$1 billion to be invested into working-class families that have been hit the hardest; the formula developed is targeting the aide to improve resources for those most vulnerable.

The funds are looking to be distributed through family care, creating a budget of \$250 million for child and elderly assistance. Adjusted within the plan is to encourage more community engagement as the result of increased funds.

The second part of the requested budget plan is tethered to resources that would increase equity for women. The unified groups

requested, "no less than \$100 million to support women for training, finding employment, and supporting women-owned small businesses and women-led non-profit organizations." Bremond-Weaver, representing the presence of the Brotherhood Crusade organization, stated, "As a Black woman, Brotherhood Crusade has been working this entire time through this pandemic. We were fortunate to get PPE support but we know in our city, that we cannot move forward unless women get back to work."

Another major angle of the budget plan is allocating \$250 million to launch a comprehensive "local housing stability program" that looks to cancel rent debt, suspend rent payments for qualifying families, and strengthen mortgage protections, in addition to providing support to vulnerable landlords.

Brenes, from ICS stated, "The impact of the pandemic has exasperated the housing burden on lowincome families in the most impacted communities." She continued, "The new funding we are stating should be used to establish a local fund to provide financial relief to certain qualifying households."

Los Angeles has worked as an example for progressive thinking; the unified non-profit organizations are looking to keep the city accountable to create refuge for all Angeleno residents during this state of crisis. The strategy they propose insinuates bold solutions and provides a space for severe levels of inequity to be addressed.



family obligations.

How are we facing these challenges?

How can we help? I think about this question every day. After students are enrolled, how do we support students so they can be successful and complete their studies? For the past year, we have created plans and programs that enhance academic and student services, such as online tutoring, counseling, and workshops. Our support extends outside the boundaries of schoolwork, with the goal of eliminating barriers to their education. This past fall, we registered 288 new students for laptop loans, serving a total of 574 students in this program. Our Wi-Fi hot spot loan program logged

similar numbers. Students

rely on this technology to participate in virtual classrooms and to complete their coursework. We also provided free food delivery to students, including over 5,150 Everytable meals and 510 UberEats vouchers.

More than 80 students accessed Edguity emergency grants this past fall, and 711 students received Coronavirus Aid, Relief, and Economic Security (CARES) Act emergency grants. In total, for the past year, we have distributed \$1.3 million in emergency

As we begin to receive the additional funding from the Higher Education Emergency Relief Fund (HEERF) II and the American Rescue Plan Act of 2021, we will utilize half of those funds to provide emergency grants and additional support to address our students' housing and food insecurities. We anticipate disbursing \$8 million in emergency aid to Compton College students through September 30, 2023.

COVID and vaccines in our community

In the news and numerous research studies, we also see how our Compton community faces a higher risk of COVID-19 infections and complications from the disease. A recent report further highlights the deep inequities in Los Angeles County's COVID-19 vaccine rollout and shows Compton among the very lowest rate of those vaccinated. In Compton, records showed that only 5% of residents had received the first dose of the vaccine compared to 25% in areas such as Beverly Hills.

How are we responding

to COVID and vaccines in our community?

In response to the CO-VID-19 pandemic and distribution of vaccines, we are providing a safe and healthy environment, from offering ongoing COV-ID-19 testing for employees and students to making the COVID-19 vaccine available to community members. This opportunity was provided in partnership with Jim Mangia, President & CEO, St. John's Well Child & Family Center, and Holly J. Mitchell, Los Angeles County Supervisor for the Second District. St. John's Well Child & Family Center is using our on-campus health center as a vaccination pod, offering 2,000 doses of the COVID-19 vaccine each week to all groups in Phase 1A, as well as all groups, Phase 1B, Tier 1, according to Los Angeles Country COVID-19 vaccination distribution guidelines. We are sharing vaccine information to the mailboxes of all district residents via postcards that also promote our spring 2021 secondeight-week session, which begins on Saturday, April 17, 2021. By providing the COVID-19 vaccine at our on-campus health center to our community, we are ad-

dressing the inequities. How can you help?

Academy Award winner Jamie Foxx has joined Stand Up To Cancer for a public service campaign launched today to raise awareness about colorectal cancer screenings, early detection and prevention, with a focus on reaching underrepresented communities.

Stand Up To Cancer and Exact Sciences, a provider of cancer screening and diagnostic tests, timed the release of a public service announcement starring Foxx to coincide with Colorectal Cancer Awareness Month. The PSA, in both English and Spanish, will be placed across print, broadcast, radio and digital outlets.

Cancer affects everyone. I've lost good friends -- young friends -- to this deadly disease," Foxx said.

`We need to make sure that we are taking care of our bodies, paying attention to certain things, that you didn't necessarily think about when

you were younger," the actor said. "Medical issues come up and you may not know what's at your disposal, so that is why I am proud to shine a light on the importance of getting screened for colon cancer early and bring awareness to the options that are available with this PSA campaign."

In 2020, nearly 148,000 Americans received a new diagnosis of colon or rectal cancer, according to Stand Up To Cancer, which notes that Black people have the highest colorectal cancer rates of any ethnic group in

United States. are 20% more likely to get colorectal cancer and 40% more likely to die from it than any other population. And research has shown that colorectal cancer screening rates are the lowest in Hispanic communities, with Black and Hispanic people typically being diagnosed at a later stage in the disease when it is more difficult to

``We are so thankful to Jamie Foxx for lending his voice to this campaign. We have seen a sharp drop in screenings as a result of COVID-19, and this compounds an already significant screening disparity in minority communities," said Sung Poblete, CEO of Stand Up To Cancer.

'With routine screening, colorectal cancer is one of the most preventable cancers," Poblete said. ``It's beatable in 90% of cases when detected

early, and lives can be saved with just one simple step. People must get screened!"

Kevin Conroy, chairman and CEO of Exact Sciences, said: "Providing personalized outreach and making it easier to get people screened is vital, especially in minority communities."

The PSA campaign is part of a larger initiative between SU2C and Exact Sciences, which provided a \$10 million grant to enable the nonprofit to create a colorectal cancer "Dream Team" of researchers that will identify communities near anchor institutions serving medically underserved communities.

The team will help pinpoint unique local needs of those areas and will provide free colorectal cancer testing in the identified zones and study samples collected via approved tests for colorectal cancer, including colonoscopy, CT

colonography, flexible sigmoidoscopy and at-home stool tests that analyze fecal DNA and/or blood. The research will aim to develop better approaches to colorectal cancer interception, according to SU2C.

Biden: States Should Open Vaccinations to All Adults by May 1

Just hours after signing into law his massive \$1.9 trillion American Rescue Plan, President Joe Biden addressed the nation and announced the implementation of his next phase of a national strategy to put the pandemic in the country's rear-view mirror.

The President declared that he would direct states, tribes, and territories to make all adults eligible for the coronavirus vaccine by May 1.

In his first prime-time address since taking over the Oval Office, President Biden proclaimed a goal of getting the nation closer to normal by the July 4 holi-

"If we do our part, if we do this together, by July 4, there's a good chance you, your families, and friends will be able to get together in your backyard or in your neighborhood and have a cookout and a barbecue and celebrate Independence Day," he noted as he stared

firmly into the television camera.

Speaking from the East Room of the White House, President Biden said returning to normal requires everyone to continue wearing face coverings, social distancing, and getting vaccinated.

More than 529,000 Americans have died since the pandemic began, and nearly 30 million have contracted the virus.

"We all lost something." the President declared.

"A collective suffering, a collective sacrifice, a year filled with the loss of life. In the loss, we saw how much there was to gain. An appreciation, respect and gratitude," he uttered.

Within his first hours in office, President Biden launched a comprehensive strategy to defeat the pandemic. He noted that in the seven weeks since, the Administration has delivered more than 81 million vaccinations and more people can visit their loved ones

There is more work to do," the President reminded

He promised that the White House COVID-19 Response Team has concluded that the accelerated vaccination efforts will enable prioritized vaccinations that will prove far enough along by the end of April that officials could lift all eligibility restrictions at that time.

The President outlined a "ramped-up effort" to create more places for people to get vaccinated, enabling officials to reach those hardest hit and most challenging to reach.

Over the next six weeks, the Administration will deliver vaccines directly to up to an additional 700 community health centers that reach underserved communities, increasing the total number of participating community health centers across the country to 950. White House officials said.

"Finding light in the darkness is a very American thing to do," President Biden said.

He also used the national platform to denounce racism and hate crimes against Asian Americans, whom the previous Administration targeted as the cause of the pandemic.

vicious hate crimes against Asian Americans who've been attacked, harassed, blamed, and scapegoated,' President Biden remarked.

"At this very moment, so many of them, our fellow Americans, are on the front lines of this pandemic trying to save lives and still are forced to live in fear for their lives just walking down streets in America. "It's wrong, it's un-American, and it must stop."

With her new Senate appointments, Kamlager will be serving on six standing committees. They are Appropriations; Budget and Fiscal Review: Governmental Organization; Human Services; Public Safety; and Rules. Atkins also assigned Kamlager to the Budget Subcommittee #4 on State Administration and General Government and to the Joint Committee on Rules.

"As I move forward to the Senate. I take with me the valuable perspectives of my Assembly colleagues & their districts," Kamlager tweeted. And I promise to continue to be a partner in equity, fairness, discussion, & debate, without judgement or polarization. for all Californians."

Kamlager also thanked her former Assembly colleagues for their support over the last two years and for welcoming her when she was first elected to serve in the lower house of the State Legislature in 2018.

California Senate leader Major Bob Hertzberg (D-Van Nuys) congratulated Kamlager and welcomed his newest colleague.

"Looking forward to seeing more of this dynamic leader in action," he said.

"Representation matters," Kamlager said earlier this month when she won a special election to become a state senator. "We know what happens when we don't have a seat at the



Governor Newsom Sets Date for 54th Assembly District Special Election

Former State Director to Vice President Kamala Harris, Heather Hutt Considered Favorite

Holly Mitchell, won the seat to replace outgoing Supervisor Mark Ridley-Thomas. Following Mitchell's historic election onto the now all female Board of Supervisors, the California Senate seat she previously held, became vacant. Shortly after Mitchell resigned and transitioned into the Supervisors seat, Assemblymember Kamlager-Dove announced her bid to fill Mitchell's vacated Senate seat. Kamlager-Dove easily cruised to victory in the March 2 election, with almost 70% of the district's votes in the special election. By winning the special election, Kamlager-Dove became the only African American woman in the California Senate, where she joined Senator Steve Bradford as one of only two African Americans in the California Senate. With Kamlager-Dove's move to the Senate, her 54th Assembly seat is now vacant and could now possibly be filled in the May 18 election, if any of the current candidates running can garner over 50% of the votes. If none of the candidates can garner 50% of the vote, a runoff would occur sometime in the Summer of 2020.

With Sydney Kamlager-Dove now moving over to the California Senate and with the appointment of former Assembly Member Shirley Weber to Secretary of State, Autumn Burke is the only African American woman now in the California Assembly. Governor Gavin Newsom's decision



not to appoint an African American woman to fulfill Vice President Kamala Harris Senate seat, leaves only one African American woman in the California State Senate and only one African American woman in the California Assembly. Several community residents, as well as political, labor, and community leaders see filling the vacated 54th Assembly seat with another African American woman as a mandate-inorder to keep the balance of representation somewhat equal (there are currently eight African Americans in the California Legislature, six men and two women).

"The strides that woman have made in securing a voice in politics, both locally and nationally, has been few years. But we cannot rest on our laurels; we cannot afford to go backwards. The perspective, the voices, and the issues that Black women like former Senator Holly Mitchell and former Assemblymember Sydney Kamlager-Dove brought to the forefront, cannot be diminished. We still need that voice in Sacramento;

we still need that voice to help address the issues of working moms, of working families, of quality affordable health care, quality affordable childcare, or how to address homelessness and how to recover from the devastation of the pandemic. All of these issues can easily get lost if we don't have that voice and that perspective back at the table," stated Tracy Mitchell President of Mothers Action, a community-based organization servicing children and families in South Los Angeles.

Heather Hutt is the former State Director for Vice President Kamala Harris, back when she was in the U.S. Senate. Hutt was the first African American woman to hold this top exunprecedented in the past ecutive staff position in the of women throughout the history of California. She declared she would seek to fill the 54th Assembly seat even before Senator Kamlager-Dove won her bid to move to the Senate. Now that Sydney has officially vacated the seat, Hutt has garnered an impressive list of supporters who have signed on in favor of Hutt for the 54th Assembly,

across the state. The two main organizations spearheading the recall effort, RescueCalifornia.org and RecallGavin2020.com, announced last week that they had collected the signatures of more than 2 million Californians for the petition they expect will soon trigger a recall election.

To begin the process of removing Newsom from office, the governors' opponents must collect 1.5 million signatures – or 12 % of the total number of people that voted in the last gubernatorial election. They must also submit the signatures to registrars in all 58 counties by close of business on March 17.

"This is the beginning. Let's hope this is the last time we come together to talk about this. But mark my words, if this recall does qualify, we will crush it because we will be united. We will not fall for a trick," said U.S. Congresswoman Karen Bass (D-CA-37), pointing out that Gov. Newsom has done nothing that should

warrant him being removed from office.

Bass said based on the price tag of past attempts to recall California governors, most recently Gov. Gray Davis in 2002, an election to remove Newsom from office would cost taxpayers over \$100 million.

A total of 9.4 million voters cast ballots in the special election that ended Davis' governorship.

Because the state, will hold a gubernatorial election next year, Bass says, it not fiscally responsible to hold one this year.

California's highestranking Black elected official U.S. Congresswoman Barbara Lee (D-CA-13) said there is "no reason to recall the governor of the state of California."

"There will be an election in June 2022 and people will have a chance to vote. So, I urge everyone to join us in this unfair recall against Governor Newsom,"

Sen. Steve Bradford (D-Gardena) said Gov. Newsom has been a "friend of the African American com-

"This governor has stood with us on criminal justice reform. He has eliminated and paused executions because he realized the majority of people of death row are minorities - Black and Brown individuals who are over-sentenced and overprosecuted all the time and many times are innocent," said Bradford. "So, we stand with this governor. He has stood with us."

So far, recall supporters say they have over 2 million signatures – well over the minimum required by the state. The Secretary of State's office has until April 29 to verify the signatures.

Many supporters of the recall effort say their plan to oust Newsom has been motivated largely by frustration over the strict coronavirus lockdown the governor imposed on the state. Some of the leading supporters are the California Republican Party, 2018 Republican gubernatorial candidate John Cox, former San Diego Mayor Kevin Faulconer and the Republican National Committee. Both Cox and

Faulconer have put their names forward to replace Newsom, if he's removed from office.

"We've proven we can win. And I did it twice in San Diego. San Diego's registration mirrors that of California — 24 % Republican — it's the same in San Diego as it was statewide," Faulconer said in an interview with the conservative magazine National Review. "So, I know how to build coalitions and win and get results. I know how to use the power of the bully pulpit to go out and win the argument publicly and then win the vote. That's what you have to do to be successful in California and you have to get not just Republicans but independents and a portion of Democrats as well."

But according to Ballotpedia, Republicans have had it in for Newsom for a while. This is the sixth recall attempt against Newsom since 2019. But the previous five weren't successful.

In addition to Bass, Lee and Bradford, the other African American California elected officials who joined

the media briefing to express their support for Newsom are: State Sen. Sydney Kamlager (D-Los Angeles); Assemblymembers Autumn Burke (D Inglewood), Reggie Jones-Sawyer (D-Los Angeles) and Mike Gipson (D-Carson); San Francisco Mayor London Breed; Los Angeles County Supervisor Holly J. Mitchell; California State Superintendent of Public Instruction Tony Thurmond; California Board of Equalization Member Malia Cohen; Antioch Mayor Lamar Thorpe; Los Angeles City Councilmember Ridley-Thomas; and Los Angeles City Councilmember Marqueece Harris-Dawson.

Gov. Newsom, who has said very little publicly about the recall, spoke up in an email to supporters Monday. "I am not going to take

this recall attempt lying down," Newsom said. "I'm going to fight because there's too much at stake in this moment."

The governor also took to Twitter.

"I won't be distracted by this partisan, Republican recall — but I will fight it," he tweeted. Getting Californians vaccinated, our economy safely reopened, and our kids back in school are simply too important to risk."

Breed said Newsom had led the state through a difficult time. She said Newsom showed more leadership than former President Donald Trump. According to Breed, Trump had abandoned San Francisco during the early days of the coronavirus pandemic. She dismissed the recall effort as a "right-wing attack."

In Washington, Sens. Elizabeth Warren (D-MA), Bernie Sanders (D-VT), Alex Padilla (D-CA) and Cory Booker (D-NJ) all came out in full-throated support of Newsom the same afternoon. Shortly after, Georgia Democrat Stacey Abrams also voiced her support for California's governor.

"This governor was duly elected and deserves to serve his full term," said Cohen. "A recall is the ultimate statement of voter suppression. Citizens of California came together and voted disproportionately to support Gov. Newsom. It is our duty to fight this baseless, senseless recall."

Los Angeles County Looks to Return Black-Owned Beach Front Land to Descendants of Original Owners

Bruce's Beach has a historical past, one that is similar to other dark chapters found in the context of the American story. The ocean wave plot was named after the original owners, Willa and Charles Bruce;

properties happened routinely during the Jim Crow era. The goal was to drive Black people out of these areas and have them sell their land. City officials would gradually obtain the Bruce's beach, and other Black-owned coastal plots through an ordinant known as eminent domain.

they were the first Black landowners in Manhattan Beach. They purchased a couple coastal lots in 1912.


However, the city of Manhattan found a way to take ownership of their property. Nearly a century later, Los Angeles County is revisiting the prospects of returning proper ownership of the beachfront to the descendants of the Bruce

Located on 2600 Highland Ave. in Manhattan Beach, CA, Bruce's Beach served as an oasis for people of color looking to enjoy the scenic coast during times of segregation. According to L.A. Times, Willa and Charles Bruce purchased a piece of paradise for \$1,225 (\$33,034), and eventually bought another lot as well. Other Black families followed suit buying estates alongside them, and a Black community of beachfront property owners was creat-



\$120,000 (\$3,203,044) for loss of property and damages. The Bruces received \$14,000, which is \$300,000 in present day, and other families received far less than that.

L.A. County Supervisor Janice Hahn stated, "The property that was once the Bruce's is now owned by the County and I want L.A. County to be part of righting this wrong." She continued, "I am looking at everything from repurposing the property in a way that tells the history of Bruce's Beach to actually giving the property back to the descendants of Charles and Willa Bruce."

One of the direct descendants of the original owners of Bruce's Beach, Anthony Bruce, told L.A. Times, "The first thing we need to get right is the information about the




Charles and Willa Bruce's wedding photo. The couple start-

plaque. We need to make sure the plaque tells the exact story about what happened." He continued, "That was our property. And they removed it with eminent domain, which was pretty much like using the law to pretty much commit a crime."

sounds, the story of Bruce's Beach is tainted below its depths. The county has recognized the biased decisions that were passed in 1924 by the city of Manhat-

As beautiful as the surface tan Beach, and now they are seeing through a new lens of awareness, and want to work on righting a longstanding wrong.

This pain in deception has weighed on the Bruce

awareness of the truth behind the beach's covered up history. However, there has been critiques on the organization's diversity level

and lack of working directly

with the Bruce family. The goal for everyone involved is to make sure the authentic story of Bruce's Beach is told, and the justice is projected over the rights of ownership. The taskforce is looking to present a course of action later this year to community leadership.

The overturn of this land would bring in a new light of equality, seen over the horizon of the California coast. Its past transgression cannot be re-written, but the correction of the injustice will create a new future for the Bruce family. for generations to come.

The story of Willa and Charles paints a wider picture of wealth that lived in the Black community, one that is not often talked about. Their pain of that legacy being taken away has lived with the Bruce family through their name's sake. A century later and the recognition that is instrumental to the healing has finally come.





LEIMERT PARK ALTERCATION HALTS FILM PRODUCTION

A physical altercation between safety personnel and members of a South Los Angeles grassroots coalition on February 25 in Leimert Park Village cut short a film

production and threatens future filming revenue in an area that has struggled economically, first from construction of the Metro Crenshaw/LAX Line and more recently from the Coronavirus pandemic.

Members of Africa Town Coalition and the Safe Passage Public Safety Ambassadors employed by Community Build, Inc., (CBI) clashed at the end of the second day of filming for the Apple TV+ series "Truth be Told." CBI is the nonprofit organization that manages the Greater Leimert Park Village/Crenshaw Corridor Business Improvement District (GLPVCC BID). The mini-series "Truth Be Told" debuted in 2019 on Apple + and stars Octavia Spencer ("Hidden Figures." "The Help") and Aaron Paul ("Breaking Bad").

The day after the altercation, Truth be Told's producSleeping, relocated the film set to Pasadena.

The dispute once again raises the long debated issues of gentrification, employment and who decides what's best for Leimert Park Village.

Representatives from Africa Town and CBI differ on how the dispute started.

According to Africa Town leader, Kevin Wharton Price, who hosted a Facebook Live event to air his grievances against Community Build President and CEO Robert Sausedo and his man-

agement of the GLPVCC BID. Price claims Sausedo instigated the conflict.

"Robert Sausedo and his goons approached us in the middle of the street and viciously attacked us," said Price. "We came to talk peace and this is what happened." A two minute video posted on Africa Town's Instagram account shows several men engaged in a brawl on the sidewalk in Leimert Park Village.

Sausedo denies the allegations. "I wasn't even outside when the fight occurred," said Sausedo. "Kevin and African Town was extorting money from the film crew.

tion company Are You The safety ambassadors were not going to let that happen. Now Kevin is trying to redefine the narrative and redirect the blame."

> Price said on Facebook Live that Africa Town's objective was to confront Are You Sleeping Productions about their relocation of 75 homeless people in a "violent" manner in downtown Los Angeles during a previous Truth be Told film shoot in December.

> "He took our grievances and he said he would go talk to his head people and we would be back with them," Price said on Facebook Live.

> Are You Sleeping Location manager Tim Hillman denied that any homeless people had been displaced during previous film productions for the Apple TV+ series. "We did not disrupt any homeless people in Leimert Park or downtown. It was all fiction to get headlines," Hillman said. "The businesses in Leimert Park were very welcoming and open to our filming and unfortunately the group that came in was very disruptive and we had to stop filming and go away and that was very unfortunate."

Marvin, a CBI Safe Passage public safety ambassador who requested his last name not be used, was part of the altercation and also disputed Price's version of events. He said the security team responded when a member of the film crew alleged that a group of men approached them demanding compensation for the disruption caused by the filming.

"We went out there to check it out. Turns out, these

guys from Africa Town weren't merchants in the village," said Marvin. "They said they were vendors, but they weren't selling anything that day, so they weren't directly impacted." Marvin said.


Marvin said the situation escalated as he explained to African Town representatives that affected businesses were notified of the film shoot weeks in advance and payments had already been negotiated. Marvin said the exchange turned physical after he told the group, "Nobody is going to pay you, just to pay you, man."

Chase Johnson, owner of Harun Coffee and James Burks, former City of Los Angeles director of special projects, negotiated the logistics and compensation

Park Village Merchants Association and the balance will be proportionately distributed to the businesses

based on their daily sales. Burks said this is not the first time Africa Town and other disgruntled groups have disrupted commerce in Leimert Park Village. He recalled two years ago when a group of protesters interrupted a performance of Barbara Morrison's annual jazz festival.

"They were unhappy because White people were coming in," Burks said.

Sausedo recalls seeing Price and Africa Town members on television shouting, "I hope they (expletive) die!" outside the hospital where two Los Angeles County sheriff deputies were taken after being critically injured during an ambush in Compton while sitting in their patrol car on September 13, 2020.

"I believe in individuals and organizations being able to freely participate in public protests as an American right. However, I cannot condone how Africa Town continues to extort and perpetuate urban terrorism and discord within the community and then distort the truth."

Leimert Park Village Merchants Association President Aminah Muhammad, owner of Queen Aminah, an Islamic attire boutique, said that the different factions of Leimert Park Village should work out their difference because film shoots increase revenue and make the area a tourist destination.

"When there's a movie shoot in Leimert Park that airs nationally, you'd be surprised at how many people come to Leimert just because they saw it on television. Filming in Leimert Park is good for business and we need that right

for the film production on behalf of the Leimert Park Village Merchants Association and CBI.

According to Burks, the production company was contracted to pay \$38,000 for the three-day film shoot. According to CBI's records, this amount is substantially more than the filming revenue received for all of 2020. A portion of the money was allocated for the Leimert

Sausedo also said he suspects race played a part in Africa Town's demands. "We know if it was a White group putting a shake down on Black producers, it would be a whole different conversation. Also,

Fannie Lou Hamer Walking Off the Plantation: Questioning and Transforming America

It is our foremother, Mrs. Fannie Lou Hamer, who taught us the morality of remembrance, saying: "There are two things we should all care about. Never to forget where we came from and always praise the bridges that carried us over." In this month of recognizing and raising up the sacred meaning and magnitude of Black women in the world, her life and teachings become a legacy worthy of the most careful consideration. And thus, I offer again these considered insights on the life she lived, the work she did, and the righteous struggle she waged for African and human good and the

well-being of the world. Fannie Lou Hamer was born 1917 October 6 in Mississippi in the midst of the racial madness and social mayhem called White supremacy in which walls of brutal separation were built in life and law to imprison and suppress a whole people, and in spite of this, she lifted herself up to look over and beyond those walls, imagining freedom and dared to begin the lifelong and heavy task of tearing down those walls and working and struggling for freedom. And in this she has lifted up a light that lasts, left us timeless lessons and a name that endures as an eternal monument for the struggling and freedomloving peoples of the world.

The lessons of her life are not exhausted in her audacious and uncompromising struggle and defiance at the Democratic National Convention in 1964, but rather expressed in the wholeness of her life, the ordinary and extraordinary, the simple and the complex. And so, although there are numerous lessons to learn from the sacred text of her life, I choose three overarching and essential ones, given added significance in the context of a current election that cries out for remembrance and recognition of the path paved by Black people in this historic struggle. Mrs. Hamer comes into

self-conscious being and begins her journey on the road to world recognition when she decides to walk away from the plantation that imprisoned her. She says, "In 1962 nobody knew I existed. . .and I hadn't heard of them either. Then one day, the thirtyfirst of August, I walked off the plantation". This is her first lesson then—that the will to be free must come from within and that to be free we must walk off the plantation, that is to say, away from the physical and psychological sites that imprison and oppress us. SNCC, the Student Non-Violent Coordinating Committee, had come to launch a campaign for voter registration and Mrs. Hamer had gone to a meeting to hear them speak of freedom. But no matter what they said or did, she had to embrace the idea and possibilities of freedom herself and commit herself to the awesome work and struggle to achieve it. And she had to make up her mind to stay steadfast on the way to freedom in spite of a rough and rocky road, full of signs and sites of casualties and costs of every kind, including the possibility of losing one's life in the cause of freedom. Indeed, she said death is a daily threat and "I may be killed, but I'll be standing up for God and my race until my time comes". But she said, if she falls in battle, it will be "forward in the fight Hamer taught us to question America in order to relieve it of its cherished illusions and reconceive and reconstruct it in the interest of a more expansive freedom and human flourishing. For her, this meant questioning the whole country, not just Mississippi, but the North and South, East and West of it. She said, "I question America", in its claim to be "the land of the free and the home of the brave", when people are threatened with death daily because they "want to live as decent human beings", want to exercise the right to vote, dare to imagine themselves equal and believe freedom is the natural and undeniable right of everyone.

For her, ourselves, history and humanity, we also must constantly question America, question its involvement in wanton waste and war and the human wreckage left in their wake. We must question continuing inequities in wealth, power and status, the privatization of social wealth and the socialization of private debt and the violation of civil and human rights in the name of security defined in a context of manufactured fear. And we must question the peddling of a parasitic patriotism that sucks human sensitiv-

ity from its hosts and feeds on the false and deforming fears it creates.

But to question America is also to question ourselves and what society has made of us, how we relate to each other and the world, how so many of us are caught in the madness of a consumerist society, finding freedom in our capacity to buy, and assembling countless reasons why we are comfortable in oppression, don't want to help the hungry and homeless, hate the Palestinians and the people whose countries we invade and whose oil, water and lives we claim as our own, and don't do more for Darfur or feel a grossly twisted need to humiliate, starve and dominate a small Black country called Haiti. And we must ask why we think Barack is a funny name and not Baruch, Obama and not Tabitha, Chang and Chun and not Chatterley and Cheney, Rain Cloud and not McCloud, Vilakazi and not Van Buren, and Srinivasa and not Schwarzenegger?

To walk away from the plantation, regardless of how comfortable and comforting and to constantly question ourselves and society, leads us to dare to transform ourselves, society and ultimately the world. And this means, Mrs. Hamer taught us, that "every step of the way you've got to fight" and that "people have got to get together and work together". It is, she stated, in our interests, for "nobody's free until everybody's free". And only by working and struggling together, can those who suffer—Africans, Native Americans, Latinos, Asians and Europeans-end their personal and collective suffering, "make this country what it has to be" and "live

as decent human beings". This last lesson on transformative struggle teaches us that this current election and others must not be simply symbolic, but approached as vital areas of engagement and struggle for serious social change. Mrs. Hamer says about the significance of one election, "There was nothing symbolic about this election.

O'Reilly, Takisha and not I'm sick of symbolic things; we're fighting for our lives". Thus, for Obama's election to be more than a useful symbol for a country unable to criticize and seriously change itself, it must be part and parcel of our struggle to save and expand lives. And if "we are fighting for our lives", we must do as Mrs. Hamer, lift ourselves above the walls and ways of self and social imprisonment, walk away from the various plantations of social pain and consumer pleasure, constantly question ourselves and society, imagine a new world and in the process of self and social transformation, open the way for a new history and humanity to emerge".

By now, all of America, and Blacks in particular, are aware of the "Voter Suppression" legislation introduced in more than 28 states with more than 108 and legislative proposals introduced to restrict voter participation aimed at African Americans in particular. Momentum builds in State Capitols and in DC to rein in predatory payday lending

As the nation and much of the world continue to suffer from the rippling effects of COVID-19, the ability of consumers to remain current on bills and expenses is steadily waning - if not already gone.

According to the Census Bureau's Household Pulse Survey taken in early February, more than a third (34.9%) adults live in households where it has been somewhat or very difficult to pay usual household expenses during the coronavirus pandemic; and 30% expect eviction or foreclosure is likely in the next two months.

For low and moderateincome families, these are the kinds of financial pressures that can make them vulnerable to high-cost, predatory lending. The irony is that while consumers using these products usually need a small amount of money, the fees that accompany these loans are really a debt trap that worsens, not improves, family finances.

Access to this "quick cash" is tied to direct access to borrower bank accounts or the likelihood of car repossession from an autotitle loan. Besides owing more money for fees than for the loan itself, borrowers also experience other financial harms including delinquency on other bills, overdraft fees, involuntary loss of bank accounts, and bankruptcy.

To date, 17 states and the District of Columbia have enacted rate cap legislation, limiting interest charged to 36% or less. But there are hopeful signs that the number of consumers protected could soon increase.

For example, This January, Illinois' Predatory Loan Prevention Act, won bipartisan legislative passage in both chambers in January. Led by the state's Legislative Black Caucus and aided by support of a broad coalition including clergy, industry and governmental officials, the bill will cap consumer loan interest rates at 36 percent interest and affect payday, car title, and high-cost installment loans.

Currently, Illinois borrowers pay payday and title loan fees in excess of half a billion each year. Nearly half of payday loan borrowers on the state earn less than \$30,000 per year. In Chicago, the state's largest city and home to millions of consumers of color who comprise 47% of the city's population, zip codes in communities of color incur 72% of the Windy City's payday loans.

According to the Woodstock Institute, an Illinois nonprofit consumer advocacy organization and coalition member, a resident of Chicago's Austin neighborhood, where the median income of residents is \$35,855 and home to mostly consumers of color, is 13 times more likely to have a payday loan than that of a Lincoln Park resident, where median incomes surpass \$200,000, more than double that of the entire city's \$61,811, and real estate prices frequently reach seven figures.

If signed by the state's governor, the bill's enactment will end what Wood-

stock calculates is a 297% state average annual percentage rate (APR) on payday loans as well as the 179% average APR on auto title loans.

Additional hopeful signs are found in several state capitols. A bill to cap loan rates at 36% APR has been advancing in New Mexico and bills have been introduced in both Minnesota and Rhode Island.

"The current economic crisis has added crushing debt onto the backs of Americans who can least afford it, which is disproportionately Black, Latino, and Native American communities," observed Lisa Stifler, the Center for Responsible Lending's Director of State Policy. "Payday and other high-cost, predatory loans make this situation even worse. Strong loan interest rate caps on the state and federal levels are essential to lifting the burden of debt that so many people have been forced to live with."

Driving home this point is a newly-updated map

from CRL that shows the interest rate on a typical \$300 payday loan. It sheds light on the financial misery of triple-digit interest rates where they are legal. Many states with large numbers of consumers of color have many of the highest rates: Texas at 664%, Missouri at 527%, and Mississippi with 521%.

At the federal level, lawmakers are expected to re-introduce a payday lending bill that would give both consumers and military veterans the same 36% rate protection as the Military Lending Act (MLA). Named the Veterans and Consumers Fair Credit Act, the measure is hoped to secure the same broad and bipartisan support that MLA received.

Readers may recall that years ago, following extensive research and hearings, the Consumer Financial Protection Bureau (CFPB) under the Obama Administration released an administrative rule to stop payday loan debt traps.

However, under the Trump Administration, the rule was gutted by eliminating its ability-to-repay standard. This underwriting practiced by mortgage lenders, credit card companies, and other lenders, prevents lenders from extending more new debt than they can afford.

Last year, a consumer coalition wrote Congressional leaders about their opposition to removing this key underwriting, particularly when the pandemic imposed severe financial stress on consumers with the fewest financial resources. In a March 2020 letter the advocates wrote in part:

"Predatory lenders are known to prey on the most vulnerable including seniors, veterans, lowincome, African American, and Latinx communities. Many in these communities were already struggling before this crisis and will fall deeper into economic instability because of it. Efforts by Congress to help Americans should not be undermined by predatory lenders trapping consumers into loans of 100% or even 300% APR. We want to ensure that relief that Congress is providing to our families is going to cover food, shelter, and other necessities, not to pay back exorbitant interest rate loans."

With a new President and a new nominee to serve a five-year term as CFPB Director, federal action on payday reform could come quickly.

Rohit Chopra, President Biden's nominee, previously served at CFPB under Director Cordray and as the agency's student loan ombudsman. His March 2 nomination hearing by the Senate's Committee on Banking, Housing, and Urban Affairs, was the second time in three years that Chopra faced Senate confirmation. Three years ago, he was unanimously confirmed to serve on the Federal Trade Commission. That bipartisan endorsement should favor CFPB confirmation.

In his remarks to Senate Banking, Chopra noted, "[D]ue to the economic devastation stemming from COVID-19, millions face the prospect of losing their home, with communities of color particularly at risk. Many have seen their jobs disappear and will not be able to easily resume their mortgage payments."

"While there are some hopeful signs that the tide is turning," continued Chopra, "we must not forget that the financial lives of millions of Americans are in ruin. Experts expect distress across a number of consumer credit markets, including an avalanche of loan defaults and auto repossessions."

"Congress has entrusted the Consumer Financial Protection Bureau," continued Chopra, "with carefully monitoring markets to spot risks, ensuring compliance with existing law, educating consumers, and promoting competition. This not only helps to protect Americans from fraud and other unlawful conduct, it also ensures that law-abiding businesses, regardless of size, can compete."

Here's hoping that CFPB will soon return to its mission.

Why South LA's Mental Health Matters Now More Than Ever

South Central, also known as Black Los Anfeatures, dialects, beliefs, and stories - especially stories colored by the multitudes of resilience. It is when we peel back the layers of these parables illuminating the cyclical patterns of plight, triumph, trauma, and victory, we arrive at the core issue of systemic oppression. Historically, South Los Angeles has been a focal point in the fight against social injustice, racial discrimination, police brutality, socioeconomic inequalities, and health disparities. Resilience embedded in the DNA of the Black community seems to also have inadvertently perpetuated a stigma around mental health and its validity, though mental health is now marginally becoming a topic of discussion. With the pandemic acclivity in 2020 resulting in higher rates of underemployment,

displacement, and health inequities for African-Americacy for mental health programs in South Los Angeles become a priority. Opening mental health facilities in South Central is a solution for closing the health gap and redefining the meaning of resilience outside the scope of trauma caused by systemic oppression.

In 2020, Coronavirus was not the only public health crisis. Racism was declared an official public health crisis as Blacks contracting the virus died at twice the rate of white counterparts without the distribution of resources at their aid. The overcrowded geography of South Los Angeles - with citizens still counting on public transportation to provide for their families, living in congested housing - accounted for the disproportionate number of COVID-19 cases compared to the richer, whiter neigh-

mental health resources such as telehealth or online information of available emergency funding. CO-VID-19's traumatic events that exposed the horrors of systemic racism will have a lasting effect on the psyche and souls of Black folk; it is only an honest and fair prediction to proclaim the need for mental health facilities and access to mental health

Reports show that a \$3 billion budget for the Los Angeles County Department of Mental Health in 2020 can elicit programmatic interventions alleviating mental health disparities for South Los Angeles as a means to recover from the impact of COVID-19. There are still billions of dollars left unspent from the inception of Proposition 63 - the Mental Health Services Act - nearly fifteen years ago. Funding from the Los Angeles County Department of Mental Health can grant social workers and mental health advocates the financial resources to build an environment that is dedicated to the healing,

By esbeing of Black Angelenos. tablishing an ecosystem ment around mental health in the Black community provide an opportunity for community leaders to create relatable, palatable, and easily accessible safe spaces of resource. Programs dedicated to mental health, such as group therapy, wellness-centered curriculums, trauma-informed modalities, and mindfulness courses can all be used to destigmatize and destabilize the bias surrounding mental health resources.

South Los Angeles is an ecosystem of tones, textures, features, dialects, beliefs, and stories - especially stories colored by the multitudes of resilience. Catastrophic effects of COVID-19 prove that now is a critical time to close the health gap with mental health facilities to advocate for the well-being of Black cultivate the normalization of telling Black people that their mental health is a priority. Self-actualization and economic progress for Black communities is contingent upon the health of individual persons. 'Women Take The Lead' 'Resurrecting Revival' 'The Mothers of Gynecology' part 1

Revival: A time of awakened interest; reviving what belonged to an earlier time, but now, coming into new importance and significance previously denied for such a time as this.

Michelle Browder passed through Los Angeles this past week-end. She was picking up the sculpture's steel armature from a fabricator in Las Vegas, then heading to San Francisco, where she will build out the work. The free event was this past Saturday morning. It is free at North Venice Little League parking lot and inviting all Angelenos to meet her and bring metal objects: brass candlesticks, copper

pots and more: spare bicycle parts. They will be melted down as material for the 15-foot figurative sculpture commemorating the "Mothers of Gynecology." Michelle Browder is a Montgomery based artist and activist, building awareness for the forgotten "Mothers of gynecology and has erected a large scale sculptural monument to the women to be installed in Montgomery. She needs our help! None of these enslaved women gave consent to be operated on. Their suffering has been largely forgotten...and overshadowed by Sims' (so-called) medical achievements. Discarded objects represent how Black women have been treated in the United States and represents beauty, talent, dignity and what all else...discarded. That is how I have come up with the name of this article. Their lives are being resurrected and revived through the imagination and artistry of Michelle Browder.

A statue of surgeon J. Marion Sims has been taken down from its pedestal in Central Park on Tuesday. A New York City panel decided to move the controversial statue after outcry, because many of Sims' medical breakthroughs came from experimenting on enslaved black women without anesthesia. New York City has removed a statue of J. Marion Sims from a pedestal in Central Park (a 19th-century gynecologist who experimented on enslaved black women). The statue will be moved to a cemetery in Brooklyn where Sims, sometimes called the "father of gy-



Tiger Woods Released from Hospital, Recovering at Home from RPV Crash

Golfer Tiger Woods said today he has been released from Cedars-Sinai Medical Center is recuperating at home from severe leg injuries suffered in a rollover crash in Rancho Palos Verdes.

Happy to report that I am back home and continuing my recovery," Woods wrote in a message on his Twitter page. "I am so

grateful for the outpouring of support and encouragement that I have received over the past few weeks.

`Thank you to the incredible surgeons, doctors, nurses and staff at Harbor-UCLA Medical Center and Cedars-Sinai Medical Center. You have all taken such great care of me and I cannot thank you enough. I will be recovering at home and working on getting stronger every day."

Woods lives in Florida but was in the Southland at the time of the crash after hosting the Genesis Invitational golf tournament at The Riviera Country Club.

The crash occurred at 7:12 a.m. Feb. 23 on northbound Hawthorne Boulevard at Blackhorse Road. The Genesis GV80 SUV Woods was driving struck the center median on Hawthorne Boulevard, careened across the southbound lanes, sheered off a tree and flipped over before coming to rest on its side about 30 yards off the side of the road.

No other vehicles were involved in the crash and no other injuries were reported. The first person to arrive at the scene told sheriff's officials Woods was unconscious inside the vehicle. The first sheriff's deputy to respond found the 45-year-old golfing great awake and responsive, but suffering from severe leg injuries.

He was taken to Harbor-UCLA Medical Center, where he underwent surgery for multiple fractures to his right leg and ankle. He was later transferred to Cedars-Sinai Medical Center for follow-up work.

No further information about his medical recovery has been released, and it was unclear if or when Woods might be able to return to the golf course.

An investigation into the cause of the crash is continuing, but Sheriff Alex Villanueva has said Woods

is not expected to face any criminal charges, insisting the crash was nothing more than an accident.

IN MEMORIAM: Boxing Great 'Marvelous' Marvin Hagler Dies at 66

Marvelous Marvin Hagler, who ruled the middleweight boxing division in the 1980s, yet never received the recognition he deserved as an all-time great, has died.

Hagler was 66. Before Hagler's death, former boxer Thomas "Hit Man" Hearns posted on Instagram that the legend had "taken ill."

"A real true warrior," Hearns wrote.

Later, Hagler's wife appeared to confirm his death in a post to the boxer's Facebook fan club page.

"I am sorry to make a very sad announcement," Kay Hagler wrote.

"Today, unfortunately, my beloved husband Marvelous Marvin passed away unexpectedly at his home here in New Hampshire. Our family requests that you respect our privacy during this difficult time."

A member of the boxing hall of fame, Hagler had a career record of 63-2 with 52 knockouts – many of them of the devastating variety.

He turned pro in 1973 and was arguably the most

feared fighter in the 160pound middleweight division. Although the media and fans showered much love on fighters like Hearns, Sugar Ray Leonard, Roberto Duran, and others, Hagler was largely ignored.

Even inside the ring, judges appeared to view Hagler with a skewed eye.

That was no more apparent than his bouts with Vito Antuofermo.

Despite Hagler brutalizing the then-champion in their first bout at the old Boston Garden in 1979, judges declared the lopsided contest a draw.

The decision allowed Antuofermo to retain his WBC and WBA Middleweight titles.

Antuofermo subsequently lost the titles to Alan Minter, whom Hagler destroyed in a September 1980s bout.

In the 1981 rematch with Antuofermo, Hagler punished his foe, scoring a fifth-round TKO.

Still, Hearns, Leonard and Duran – each a welterweight that would ultimately move up in weight class to challenge Hagler – were the media darlings and the sport's favorites.

Hagler agreed to a 1983 bout with Duran, who was coming off his infamous

"No Mas" loss to Leonard. Duran went the distance with Hagler, who won the decision, but the media still scolded him.

"Hey, how about giving me some credit?" Hagler pleaded after beating Duran. "I beat a legend. I thought I did a good job. I have to give myself a pat on the back."

The 1983 Ring Fighter of the Year, Hagler had little competition in his division and contenders too afraid to offer up a challenge.

Then came the fight that finally earned Hagler the recognition he rightly deserved.

Hearns, the tall and powerful puncher from the Motor City, challenged Hagler for the Middleweight Championship on April 5, 1987.

It was billed as "The Fight," but in boxing lore, it remains known as "The War."

Although the match lasted only three rounds, it was arguably one of the most violent fights in boxing history.

Hearns and Hagler traded vicious blows, never taking a break.

Both fighters were bloodied and, after an accidental head-butt that caused the ring referee Richard Steele to consider stopping the fight in Hearns' favor, Hagler unleashed a nonstop flurry to finish his foe.

After several more title defenses, Hagler sought the biggest of paydays, and

there was just one name that could fulfill that desire for the Broxton, Mass.-based warrior, and to quench his thirst for acceptance as the sport's premiere superstar.

That person was 'Sugar' Ray Leonard, who had retired in 1982 after suffering a detached retina.

Always calculating, Leonard had intently watched and even served as a commentator for HBO during several of Hagler's bouts.

Last year, Leonard told NNPA Newswire that he spotted Hagler's weakness and wanted to fight him.

"I called my business partner, Mike Trainer, and told him I wanted to fight Marvin Hagler, and he asked me had I been drinking," Leonard reminisced about the time leading up to his April 6, 1987 bout with Hagler.

"When I told my brothers that I wanted to fight Hagler, they couldn't believe I would even think of it," Leonard recalled.

"They asked, 'Who would be my tune-up (for Hagler)?' and I told them, 'Hagler.' I fought Kevin Howard before fighting Hagler, and he knocked me down, and people thought Hagler would kill me. Back then, I was on the wrong

side of the street, doing cocaine and drinking heavily," Leonard revealed.

Hagler was regarded as a brawler with incredible power and the sport's most dominant slugger. Leonard needed Hagler to believe that he had to prove to the world that he could also box

However, Leonard went on to win a 12-round decision over Hagler and claim the world middleweight championship.

Hagler, who never fought again after the Leonard loss, was still named the Boxer of the Decade.

In retirement, he finally received a measure of acclaim that escaped him during his memorable career.

Hagler is survived by his five children, Charelle, Celeste, James, Marvin Jr., and Gentry. He and his widow, Kay, met in Hagler's adopted hometown of Milan, Italy.

"Marvelous Marvin Hagler has gone, a true great, a chin made from granite, the winner of the greatest fight of all time. RIP Champ," Hagler fan Robert Kelly posted in a Twitter tribute that featured a video of Hagler's demolition of Thomas Hearns.

Cynthia Cooper-Dyke is a WNBA legend who has left her mark on Los Angeles Basketball history as a player and as a coach. Although she was born in Chicago, Cooper-Dyke was raised in Watts and attended Locke High School.

At Locke, she competed in basketball and track and field. She averaged 31 points per game, which helped the Locke Saints reach the Division 4A state championship. Cooper-Dyke became Los Angeles Player of the Year and took her talents to the University of Southern California.

"[USC] opened up a whole new world for me," Cooper-Dyke said in the documentary "Women of Troy." "It was a constant tug-of-war for me, like I was a fish out of water."

With Cheryl Miller, Paula McGee, and Pamela McGee as teammates, Cooper-Dyke helped the Women of Troy be one of the highest-ranking programs in the United States. They went to the NCAA tournament all four years Cooper-Dyke

competed there and went to the Final Four three times.

In 1983 and 1984, Cooper-Dyke helped the Women of Troy win two National Championship titles. She ultimately became a four-year letter winner. Cooper-Dyke's final USC game as a player was the 1986 NCAA Championship game.

Her 265 steals are ranked third all-time in program history, Cooper-Dyke is also ranked fifth in all-time assists with 381. She is also the eighth all-time leading scorer with 1,559 career points.

There was no professional basketball league for women in the United States at the time, forcing Cooper-Dyke to take her talents overseas. She signed a one-year, \$20,000 contract to the team Samoa Bétera in Valen-

cia, Spain. Cooper-Dyke averaged 37 points per game with the team, helping her get a contract with Parma in the Italian league the following year.

Cooper-Dyke competed in Italy and Spain for 10 seasons, winning eight scoring titles. She learned to speak fluent Italian and would converse with Laker's legend Kobe Bryant in the language.

In 1988, Cooper-Dyke helped the U.S. national team win a gold medal for the Seoul Olympics and returned to help the national team win a bronze in the 1992 Barcelona Olympics.

In 1997, the WNBA had their inaugural season and Cooper-Dyke built a dynasty with the Houston Comets. With hall of famers Tina Thompson and Sheryl Swoopes as teammates,

Cooper-Dyke led the Comets to the first four WNBA championship titles.

For three consecutive seasons, Cooper-Dyke led the WNBA in scoring. Because of her efforts, she became the first league MVP and won WNBA Finals MVP honors three times. In 1998, Cooper-Dyke won her second WNBA MVP award. She retired from the WNBA but returned in 2003 and retired again in 2004.

During her WNBA career, Cooper-Dyke averaged 21 points, 3.3 rebounds and 4.9 assists per game. The Comets retired her no. 14 jersey. In 2009, Cooper-Dyke was inducted into the Women's Basketball Hall of Fame. The next year, she became the first WNBA player to be inducted in the Naismith Memorial Basket-

After having stints of head coaching at UNC Wilmington and Texas Southern University, Cooper-Dyke returned to USC to become head coach of the women's basketball team in April 2013. She guided the Women of Troy to the Pac-12 championship game in the 2013-14 season.

In April 2019, Cooper-Dyke returned to Texas Southern and is currently the head coach of the Tigers women's basketball team.

Free Agency Creates A New Era for the L.A. Sparks

The free agency this offseason brought on a new core of players for the Los Angeles Sparks. Forward Nneka Ogwumike as well as Head Coach and General Manager Derek Fisher are embracing certain changes as well.

For the first time in her career, Ogwumike did not compete overseas during the offseason. She also is a member of the USA National women's basketball team for the Tokyo Olympics. She has been working out "intensely" during the offseason.

"I've been working with a strength coach that I

had since college and she keeps me on my toes and a team of people that really cater to my physical needs and also enhance my performance," Ogwumike said.

Although the Sparks gave Ogwumike the core designation, which gives the franchise exclusive negotiating rights over her, the six-time WNBA All-Star met with other teams. Ogwumike wanted to "honor the process" of free agency in the wake of the league's new collective bargaining agreement.

"It wasn't as though the Sparks were feeling this core necessarily in conversation to me and it wasn't that I was strategizing and talking to other teams," she said. "We have a coach who gets it, he gets what free agency is about."

Fisher is adjusting to his dual role, learning how to be more available to his players. He took on the role as general manager because he wanted to invest in the players and the success of the 25-year-old franchise.

"It really is a 24/7 commitment, 365 days of the year," Fisher said. "I anticipated that, I just didn't know what the experience would be like in terms of the amount of discussions and conversations and sharing ideas and pushing each other forward."

The style of basketball that Fisher wants is that of

physical and mental toughness, passion, athleticism, and humility.

"The amount of opportunities and situations that you have to be able to switch the intensity that you have to get into rotation, that you got to be able to trap the pick and roll," he said. "We feel like we added players and continue to invest in players that check these boxes."

I don't think it surprised anyone that late actor Chadwick Boseman would be nominated for an Academy Award for his performance as an ambitious jazz trumpeter in "Ma Rainey's Black Bottom" (https://www.netflix.com/title /81100780) despite never being nominated before, for his astonishing performances as James Brown in 2014's "Get on Up", Jackie Robinson in 2013's "42" and his most iconic role as the African superhero T'Challa in 2018's "Black Panther."

Mr. Boseman, crossedover in August, at the age of 43 from a long battle with colon cancer.

Although the nomination was expected one must admit that it's a touching category: the posthumous acting nominee. It's not uncommon. To date, there has been 79 in total before.

Mr. Boseman's nomination and only seven actors had ever earned Academy Award nominations after their death. Win or lose, he's already earned his place in Academy Awards history.

Now to the crazy year, thank you-not COVID-19—which forced most movie theaters to shut down and extended the Oscars voting window by two months

The 93rd annual Academy Awards nominations held very few surprises with "Mank," (Netflix) leading with 10 nominations. The Oscar votes spread their vote, as six films received six nominations: "The Father," "Judas and the Black Messiah," "Minari," "Nomadland," "Sound of Metal" and "The Trial of the Chicago 7."

Nine actors of color earned Academy Award nominations setting an Oscar record for diversity in key categories. This is important to note since there's been a very directed effort by the Academy to diversify its membership after the wakeup call of all-White acting nominees for the 2015 and 2016 ceremonies.

"Minari" star Steven Yeun became the first Asian American ever nominated for best actor; in the same category, "Sound of Metal" star

Riz Ahmed became the first person of Pakistani descent ever nominated for any acting Oscar.

Oscar history was made with two women directors Emerald Fennell ("Promising Young Woman") and Chloe Zhao ("Nomadland") — who were nominated together in the same category. Both films received best picture nods. the second time two femalehelmed titles have been recognized in the top category.

Oscar-winning actress Viola Davis is nominated for her astounding performance

"Ma Rainey's Black Bottom." A history maker already Davis is the African-American woman with the most acting nominations (with four) and the first to be nominated in best actress


Sadly, this year also marks only the second time African American women were nominated for best actress, with a nomination for Andra Day's brilliant work in "The United States Vs. Billie Holiday."

Overlooked is director Regina King ("One Night in Miami") she would have been if nominated, the first African-American woman to be nominated for best director but that didn't happen. There was early buzz that actor Delroy Lindo ("Da 5 Bloods") would earn a nomination but the category was just too competitive.

Now to Shaka King's powerful film which landed in big categories like the best picture and original screenplay and a true surprise nomination for LaKeith Stanfield in supporting (alongside his co-star, Daniel Kaluuya). There is a powerful producing team behind King's film, of which he is one, — which also includes director/producer Ryan Coogler ("Black Panther") and Macro's Charles King.

Now to the scorecard. Netflix the streaming giant dominated the nominations for the 93rd Academy Awards leading with 35 nom-

Hulu scored a nomination for actress Andra Day ("The United States Vs. Billie Holiday") and Disney Plus received its first Oscar nominations since they picked up best-animated feature nods for "Onward" and "Soul," the



nominations for best score and sound. "Mulan," another Disney Plus release, received nominations for costumes and visual effects, as did the company's "The One and Only Ivan." "Nomadland." which was produced by the Disney-owned Searchlight, is currently streaming on Hulu.

Apple earned its first nominations, picking up a best-animated feature nod for "Wolfwalkers" and best sound nod for "Greyhound."

I read everything I could and watched every documentary, but I was bothered by the fact that there was no film about Emmett Till to bring the story to life. After numerous trips to Mississippi, I thought, 'Hey, why not me! to tell that story?!' and finally bring Emmett's story to life in a way that is accessible to everybody.

LAS: What do you want the viewer/audience to take away from this film?

DP: I hope the audience learns something that they didn't know about the Emmett Till story and clears up some of the many misconceptions many of us thought were true for so long. I love that the film has ignited a curiosity to research more about Emmett Till and have discussions with others about him and the film.

I hope the viewer is moved by emotions, feels the story, and has a reaction to what they see. If that reaction is a fraction of the same reaction people had in 1955 that sparked the Civil Rights Movement, maybe those same feelings can propel the movement further today. The fact that the world has to continually repeat the fight against injustice is dis-

heartening as things haven't

I hope the audience watches 'Killing of Emmett Till' and can't tell the difference between our film with an all-volunteer cast and crew filmed with no budget in the Detroit area versus a Hollywood film with a large budget shot on location in

Former Watts Business Owner Turns 105, Defeats Two Pandemics

Two pandemics have hit the United States and Lucia DeClerck survived them both. In 1918, at the age of two, DeClerck caught the Spanish Flu, yet she overcame and lived. More than 100 years later, at age 105, she tested positive for COVID-19, and she's defeated that virus, too.

Red Tier Designation Allows Angelenos More Freedom, Public Health Officials Urge to Proceed with Caution

Los Angeles County residents are allowed to leave the house for amusement again, but asked to keep health guidelines firmly in place.

Angelenos are seeing red-red tier that is, with Los Angeles County in the less restrictive zone, residents once again have a choice of where they spend their time. As restaurants, movie theaters and other businesses open to the public with some protocols in place, this Spring is looking different from last year. Public health officials are adamant that safety guide-

lines remain a top priority

for everyone. "Tomorrow, March 16, will mark the one-year anniversary of the first COVID-19-related Health Officer Order here in L.A. County and for the first time since the state created the Blueprint for a Safer Economy last summer, L.A. County has moved from the most restrictive purple tier to the red tier," said Barbara Ferrer, PhD, MPH, MEd, Director of Public Health. "That we are here today is not a miracle; our recovery represents the deep commitment by hundreds of thousands of individuals and many thousands of businesses to adhering to safety measures and making sacrifices to keep each other safe.

I thank you L.A. County."

As of Monday, March 15, the following are now permitted to open with required safety protocols for masking, distancing and infection control:

*Museums, Zoos and Aquariums can open indoors at 25% capacity

*Gyms, Fitness Centers,

indoors at 25% max capacity under the following conditions: can open indoors at 25% max capacity under the following conditions: eight feet distancing between tables: one household per indoor table with a limit of six people; the HVAC sys-

tem is in good working



Now in the red tier, Los Angeles County opens up a little closer to normal.

Yoga and Dance Studios can open indoors at 10% capacity with masking requirement for all indoor activities

*Movie Theatres can open indoors at 25% capacity with reserved seating only where each group is seated with at least 6 feet of distance in all directions between any other groups

*Retail and Personal Care Services can increase capacity to 50% with masking required at all times and for all services

*Restaurants can open

order and has been evaluated, and to the maximum extent possible ventilation has been increased; public health strongly recommends that all restaurant employees interacting with customers indoors are provided with additional masking protection (above the currently required face shield over face masks); this can be fit tested N95 masks, KN95 masks, or double masks, in addition to the required face shield: public health also strongly recommends that

all employees working indoors are informed about and offered opportunities to against vaccinated COVID-19. Outdoor dining can accommodate up to six people per table from three different households

*Indoor Shopping Malls can increase capacity to 50% with common areas remaining closed; food courts can open at 25% capacity adhering to the restaurant guidance for indoor dining

*Institutes of Higher Education can re-open all permitted activities with required safety modifications except for residential housing which remains under current restrictions for the Spring semester

*Schools are permitted to re-open for in-person instruction for students in grades 7-12 adhering to all state and county directives

*Private gatherings can occur indoors with up to three separate households, with masking and distancing required at all times. People who are fully vaccinated can gather in small numbers indoors with other people who are fully vaccinated without required masking

and distancing. Public health officials are urging the public to continue following these core

practices:

*Go outdoors. Outdoor activities are far safer than indoor ones

*Stay masked. Consistent and correct use of masks, especially doublemasking, both indoors and outdoors, is very effective at preventing the spread of COVID-19

*Maintain at least a 6foot distance from others. Physical distancing from those who do not live with you also helps to keep the virus away

*Avoid crowds. The fewer people you encounter and the fewer interactions you have, the smaller the chance the virus will spread

*Get vaccinated when it's your turn. All federally authorized vaccines work well and will help protect you, your family, and your friends against COVID-19

As of Monday, March 15, the L.A. County Dept. of Public Health confirmed 6 new deaths and 422 new cases of COVID-19. There were 893 people with COVID-19 hospitalized with of 28% these people in the ICU.

Public Health identified 1,210,663 positive cases of COVID-19 across all areas of L.A. County and a total of 22,475 deaths. Cases across the Southland: Los Angeles

County shows 1,148,011 cases, Long Beach with 51,621 cases and Pasadena with 11,031. According to race and ethnicity, COVID-19 statistics show: American Indian/Alaska Native with 1,927; Asian with 52,451; Black with 41,886; Hispanic/Latino with 570,327; Native Hawaiian/Pacific Islander with 4,148; White with 118,694; those of other race and ethnicity with 105,847 and 252,731 under investigation.

"As we move forward, let's remember that our reopenings are happening alongside holidays and spring break," said Ferrer. "Holiday traveling, gatherings indoors and large parties have in the past wrecked our recovery jour-

"Let's not repeat past mistakes and let's pledge to keep everyone alive until it is their turn to get vaccinat-

BLACK RELEASES 'A.S.K.' FOR THOSE SEEKING GOD'S HELP


Many people may have heard the popular lament, "God is not answering my prayers." If you or someone you know are in that category, consider reading "A.S.K. - Ask, Seek, Knock" by Pastor Audrey Black.

The book, which Black released earlier this year, aims to help those who think that God is refusing to answer their petition. In Black's opinion, many people are under that impression, but she says it is simply not true.

"God wants us to have the things we desire as much as we do, but there is a pattern and there are principles that we may not be aware of," insists Black, who co-pastors Canaan Inheritance Worship Center with her husband, the Rev. Owen Black.

"Becoming aware of these principles will provide strategies of success and assist us in identifying the ways of God so there is no misunderstanding on whether He hears us. I believe this book will bring encouragement and inspiration, to the point, where we can continue to believe God," says Black with ear-

"A.S.K." is an easy read of 101 pages and it's full of practical guidance to teach believers how to communicate with God through prayer. The chapters include "Askto emphasize that God "provides for your wants" and Philippians 4:13 - "I can do all things through Christ who strengthens me" to remind readers that the Lord will "assist you in accomplishing those im-



ing Amiss," "Mix It With Faith," "Change the Way You Think," and "Understand His Ways." Black also uses everyday examples that readers can relate to along with scriptures that reveal God's love for His children.

In addition, she cites Bible verses such as Psalm 23:1 - "The Lord is my shepherd; I shall nor want"

possible things while you give Him glory."

Explaining that there is a three-step process to obtaining God's promises, Black says, "There is a process to everything in life and that includes prayer. 'A.S.K.' shows us what the process looks like and guides us on how to mix it with faith. It points out ways we could be asking

incorrectly in prayer and how to avoid missteps.

"The book also covers how we must change the way we think in order to understand the ways of God so we may be able to come into agreement with Him when obtaining our desires," she adds as she encourages believers and skeptics to read "A.S.K." because "it answers many questions we as believers and non-believers have regarding prayer."

Even before she wrote the book, Black was practicing the doctrines she espoused in "A.S.K." by teaching the principles during her church's Bible Study. As a result, she said the students responded with enthusiasm and began to increase their faith as well as invited others to attend the classes.

"I believe 'A.S.K.' has information that will give us a head start to seeing all the possibilities God has planned for us," says Black. "And when followed, it will cause us to experience the word of God, not only to have life as He promises, but to have it in abundance."

Mrs. Marietta Webb -**Christian Science Healer**

In 1950, Ebony profiled Mrs. Marietta Webb, a long-time Los Angeles resident. Mrs. Webb was featured because for decades, she had been a Christian Science prayer-based healer and member of the Christian Science church.

Christian Science was discovered by another remarkable woman, Mary Baker Eddy, who wrote "Science and Health with Key to the Scriptures."

The last chapter of "Science and Health," entitled "Fruitage," contains 100 pages of testimonies of healing, which resulted from the study of and inspiration gained from Eddy's book.

This chapter also contains a testimony by Marietta Thomas Webb (1864-1951) of Los Angeles, one of the first African Americans listed in The Christian Science Journal as a practitioner of healing.

In it, she states in part, "Nine years ago my only child was...pronounced... incurable, saving that if he lived, he would always be an invalid and a cripple.... It was while...I was in the darkest despair that I first heard of Christian Science. The bearer of the joyful tidings could only tell me to come and hear of the won-

derful things that Christian Science was doing.

"I accepted the invitation...and that night I realized from the testimonies given that Christian Science was the religion for which I had been searching for years.... On my way home I thought of some of the testimonies — of people being healed by simply reading 'Science and Health.'

"I resolved at once to borrow a copy, and....I read it silently and audibly, and although I could not seem to understand it, yet the healing commenced to take place at once.

"The little mouth which had been twisted by spasms grew natural and the child was soon able to be up, playing and romping about the house as any child should... I was healed of all my complaints whilst seeking the truth for my child, and many of them have never returned. ... All of this is, however, nothing to compare with the spiritual uplifting which I have received, and I have everything to be thankful for."

FAITH ICON FREDERICK K.C. PRICE REMEMBERED

Hundreds emerged to pay homage to the memory of Apostle Frederick K.C. Price, founder of South Los Angeles' Crenshaw Christian Center. The public view-

held on March 4 5, was both somand celebratory as mourners from across nation participated. A 29-minute video

montage of Price's decadeslong teachings played on a loop, while a commemorative keepsake book of ministry moments and photos were handed out.

On March 6, an intimate memorial service was held with family and close family friends. Over 64,000 tuned in via live stream as several elected officials, faith leaders, and sons in the faith remembered Price as a highly disciplined, teacher and scholar whose practical unpacking and application of the Bible resonated with in-person congregants and viewers of his television

program, "Ever Increasing Faith Ministries." To date, the service has been viewed over 309,000 times.

As a Black pastor whose ministry was coming of age in the 1970s, the TV broadcast enabled him to reach viewers across the globe. Price's demeanor was controlled, resolute and authoritative, devoid of high emotion. This decided approach was clear, precise and swiftly embraced.

The 89-year-old innovator was the author of over 50 books on Christian living and served as the original example of Black Excellence with his signature put together look, including an Afro with every hair in place and Bible in hand.

As part of the remembrance, Los Angeles Mayor Eric Garcetti sent a touching video tribute. Also, Congresswoman Maxine Waters, L.A. County Supervisor Janice Hahn and L.A. Council President Emeritus Herb Wesson attended to address the in-person and virtual audience. In addition, remarks were given by Angela M. Evans, Price's eldest daughter and president/CEO of Crenshaw Christian Center; Dr. William M. Wilson, president of Oral Roberts University where Mrs. Evans serves as a board member; martial artist Billy Blanks, Dr. Kenneth W. Hagin, Dr. Jerry Savelle, Dr. Creflo A. Dollar and Apostle Michael A. Freeman, who gave the eulogy.

Beyond the public way Price was known, central to his life was his unique devotion to his family. He was an unapologetic doting husband and father, who served as a positive role model for countless others.

Price's widow, Dr. Betty R. Price, and the entire Price Family expressed gratefulness for the outpouring of expressions of love, prayers and support. "While our hearts are heavy, we are comforted by these kind gestures," said Evans. Additional activities to commemorate Price's legacy for the community's benefit will be announced in the future.
