Cecilia Marshall never imagined that the battle for equal rights in schools and

elsewhere would still be as vital today as it was six decades ago when her husband, United States Supreme Court Justice Thurgood Marshall, fought to end legal segregation as a civil rights lawyer with the NAACP Legal Defense Fund.

"We haven't made too much progress," said Cecilia Marshall, 88. "Sixty-three years later, we're still fighting in the courts for equal treatment and that's not what my husband, nor I would have imagined would be going

Eugene Mitchell, the corporate vice president and market manager in the African-American Market Unit for the New York Life Insurance Company, said that investing in life insurance policies can increase wealth in the Black community.

If Black lives matter, then Black wealth should certainly matter, too.

That's the motto that Eugene Mitchell, a corporate vice president and market manager in the African-American Market Unit for the New York Life Insurance Company, often

Since 2011, Mitchell has been on a mission to create wealth—\$50 billion to be exact—in the Black community through an innovative and well-thought out insurance program backed by his employers and the 1,200 African-American insurance agents the company employs.

"We are on mission to create \$50 billion of taxfree future income in the Black community," Mitchell said. "I believe the issues in the Black community are not crime [or] drugs; those are symptoms of a greater and deeper rooted issue, which is about economics.

Mitchell continued: "Without economics, without college saving plans in place, without down payments for new homes, folks struggle to move to the next level. What we've put together is a community empowerment plan that's about financial literacy."

Mitchell said that leveraging financial tools to really make a difference is what's important.

The equation is quite simple: multiply 200,000 families by \$250,000 in life insurance and that creates \$50 billion of tax-free income.

Instead of thinking of life insurance as just a means to cover funeral expenses, Mitchell urges Black families to consider life insurance as protection and an investment for future generations.

Mitchell based his plan on four principles: Protect what you own and those you love; prioritize financial goals: plan for major said. life events; and pass on assets to individuals and institutions you care about.

"We're not only trying to create wealth, but to spend it in the right place; to build upon it and protect it and leverage it for the future and pass it on, so that money is never an issue," said Mitchell. "Knowing collectively that we've created \$50 billion and changed the financial future of our community shows that Black wealth matters."

Each generation of African-Americans stands proudly on the legacy of everyday heroes and civil rights leaders, just as Mitchell said he happily stands on the legacy of Cirilo A. McSween, an African-American trailblazer in the insurance business who dedicated his life to strengthening the Black community.

McSween, who served as the treasurer of the Southern Christian Leadership Conference and was a close confidant of Martin Luther King, Jr., was adamant about helping his clients create estates and leave legacies to financially empower the next generation, using life insurance as the foundation, Mitchell said.

"I tell my agents that we have the responsibility to live up to the legacy of those who came before us by doing all that we can to help those who will come after us," said Mitchell, who holds a degree in finance from Florida International University and an MBA in finance from New

York University.

Loving Her Man Through Alzheimer's

Publisher Willa Robinson talks about her new book, taking care of her husband and adjusting to new challenges

"For the last year, I've been driving him because he can't drive anymore," said Willa Robinson about her husband, Vernon. "That is the only thing he looks forward to every Thursday-rain or shine."

Robinson has been driving her husband on his distribution route ever since he was diagnosed with Alzheimer's disease. Robinson was the L.A. Watts Times advertising director for nine-and-a-half years and Vernon has distributed the paper throughout the San Fernando Valley and Pasadena for the past 16 years. Now she makes sure he keeps his distribution duties, a job he is still devoted to.

"Maybe nine months before the diagnosis... I started seeing little signs," said Robinson.

These signs were familiar to Robinson, who had experienced them with her mother who also had Alzheimer's. The disease also runs in Vernon's family, as his father also had Alzheimer's disease. She told their family doctor that her husband needed to be tested for the disease, as all the warning signs were

"Usually what goes first is the short-term memory and repeating the same questions," said Robinson. "It's just repeating the same thing over and over again because he's forgotten that he asked that same question a few minutes

ago."

Robinson also said that a deterioration of understanding comes later along with the misplacement of things. Even though his memory may be fading, Robinson says some things remain.

"My husband is still, at this point, he is very knowledgeable of what's going on but

A book inspired her to write down all the good things about her husband. In 1993, for Christmas, she wrote "10 Good Things

About Vernon Robinson," which she had framed for him. On the eve of their 51st wedding anniversary, Robinson wanted to do a similar tribute to her husband, this time asking family and friends to contribute. Vernon would be diagnosed with Alzheimer's soon after.

"It took me a while to get back to writing, so I had it completed for the 52 anniversary," said Robinson.

"52 Ways to Love My Man" is a romantic love story consisting of 26 good things Robinson adores about Vernon and 26 good things his family and close friends love about him.

Having been married for 52 years, Robinson is frequently asked to share their secret to longevity with their marriage. She included within the book successful marriage tips from couples married twentyfive years or longer. Also, included is a section about Alzheimer's

disease, with a percentage of the proceeds from the book being donated to the Alzheimer's Asso-

ciation to help find a cure for this malicious disease.

Robinson shared that one of the important things to remember about taking care of someone with Alzheimer's is to not take things personal, because in many ways, you're dealing with a stranger. She also stressed taking personal time for yourself and getting away from the situation once and while. Finally, Robinson stated the importance of getting as much information as possible.


"First-of-all, learn as much about the disease as you possibly can because it's so different from anything else," said Robinson. "You're losing that person right there in front of you daily."

She continued, "Getting into a support group and I'm helping to raise funds for Alzheimer's disease, for the studies... [and] the medications.

Robinson added, "That's another thing, being knowledgeable about the different medications and like with anything else, the side effects as well and supporting others that are suffering with it too."

Robinson also suggested to those dealing with a loved one with Alzheimer's to learn how to become a caretaker. She said the key is to be supportive and to learn how to handle the situation while adjusting to a new normal.

Slavery's History and Legacy Must Be Unchained

First of two parts

Quentin Tarantino's DJANGO-Unchained (2012) and subsequently a series of Hollywood films on slavery, have stirred up strong emotions among Blacks, both pro and con. However, there's been little follow up, one way or the Most Blacks have internalized the white majority's values and tend to view these movies through substantially the same lens as whites, even though their experience differs light years from their oppressors.'

Given that films about slavery trigger a strong response, today's column provides the perspective of John Henrick Carke, one of the 20th century's preeminent Black scholars. His book, Slavery and the Slave Trade, is a seminal work that offers a much needed non-European historical backdrop to slavery in America. It gives a much broader context for assessing "slavery films" and slavery its self's devastating effect on Black life. Dr. Clarke's afro-centric assessment of the full impact of slavery is beyond Tarantino's, and Hollywood's, experiential and emotional sensibilities.

"The discovery of Africa by the Europeans was a fortunate incident in the history of the European and a most tragic occurrence in the history of the African. These two peoples were at the crossroads of history at a time when they could have complimented each other; they could have changed the world by forming a partnership. Instead, one chose to subdue the other and traffic them as slaves. The results of this decision reverberate throughout the world until

Between 1400 and 1600, Europeans made the decision that the world would European-dominated, politically, economically and culturally. This decision was made despite the fact that Europe and the Europeans were just emerging from what they called their Middle Ages, from the aftermath of the Crusades. which was a drain on their economy and from the famine and plagues, a drain on their population. The main



unifying factor in Europe at that time was a uniquely organized political organization, better known as the Catholic Church. Without its sanction, arguably, the Europeans would not have gone into African slave trade.

Arab slave trade in North and East Africa had been a well-established institution long before the Arabs accepted Islam. With the rise of Islam in the seventh century, they used this new religion as further justification for their involvement in the slave trade. Islam, like Christianity, declared war on all forms of African religion and culture and later denied that Africans had anything worthy of being called a religion or a culture. The Africans

were totally unprepared to deal with this kind of mentality at the time of its initial emergence and they are totally unprepared to deal with it now.

Eric Williams' book,

Capitalism and Slavery, starts with information that reflects the temper and temperature of this period in history. "When in 1492, Columbus discovered the New World he set in motion the long and bitter international rivalry over colonial possessions for which no solution has yet been found. Portugal, which had initiated the movement of international expansion, claimed the new territories on the ground they fell within the scope of a papal bull of 1455 authorizing her (sic) to reduce to servitude all infidel peoples. The two powers, to avoid controversy, sought arbitration and Catholics turned to the Pope when the universal claims of the Papacy were still unchallenged by individuals or governments. In 1493, a series of papal bulls established a line of demarcation between the colonial possessions of the two states; the East went

Spain."

The above accounting reflects the extreme arrogance of the Europeans of that day in assuming that they could arbitrarily take what did not belong to them and make decisions about the lives of millions of people without consulting a single one of them. This arrogance has not changed to this day, regardless of European religion and politics or lack of same. This is the essence of worldwide racism.

Dr. A. Adu Boahen's book, The Horizon History of Africa, summarizes the impact of the European coming to the West Coast of Africa and the establishment of the West African slave trade. Prior to this time, Europeans had b been mainly at war with each other over territory, sometimes for religious reasons and other times for reasons that made no sense to anyone except themselves.

When Europeans started looking outside of Europe for ways to satisfy their needs, they were not looking for Africa. They were searching for trade routes

to Portugal and the West to to the sweets and spices of Asia. They stopped in Africa in hopes of soliciting the help of the Christian African King, Prestor Juan, hoping he would help in their fight against what they called the infidel Arabs. While they called Arabs infidels, Arabs, likewise, called them infidels.

Much of the maritime information coming out of China, then the leading maritime nation in the world, had been preserved by the Africans and the Arabs, who had been militarily and intellectually in control of Spain and parts of the Iberian peninsula since 711 A.D. What the Europeans learned from this information renewed their interest in shipbuilding and the skills of the sea. Whether the earth was round or flat was not settled during this period, what was settled was that whatever the shape, Europeans wanted to control it. The years between 1400 and 1600 were a major turning point in human history."

Garden? Surely, we can only make sense of this senseless and immoral conception of victory and celebration, if we realize Trump and his cohorts and the society in which they do their dances and deeds of death are carriers and perpetrators of pre-existing conditions themselves, diseases of heart and mind that diminish and distort their sense of humanity, morality and fellow-feeling. It is pre-existing conditions of racism, classism, sexism and other forms of oppression and an accompanying moral numbness of others' death, disease and suffering established at the very founding of the country. Trump alone, for nobody and nothing comes into being by itself. Everyone and everything is rooted in a history and current condition that grounds them. So



Trump could not be Trump without the sanction and support of the society that provided "the swamp", to use his words, from which he and his mean-spiritedness, ruthlessness, and irrational and amoral proposals, plans and policies emerge. Thus, if we are to sur-

vive and end this coming Ice Age of Trumpism unfolding in full blast in front of us, we must quickly admit the problem is not Trump himself, but his openly out-of-control supporters and his complicit enablers of various kinds and commitments and the pre-existing conditions that existed and brought him into being as president. The man, himself, though regularly offering a monstrous display of real ignorance and illusionary arrogance, did not elect himself, create the racism, classism, sexism, xenophobia, immigrant-bashing, religious chauvinism, Islamophobia, and all the other morally repugnant and humanly disastrous policies, proposals and practices with which his administration is infected and seeks to impose.

It is the context and the wide spectrum of Americans who have elected him, and that have given him the sanction and support that allows him to make claims without evidence, ramble on without reason and do his speech and acts of evil and injustice, and peddle them as worthy all-day news. And only a relentless and righteous resistance can halt the spread of

the cold and callous things

planned and reverse all those evil and ugly things already put in place.

The media never tires of

vainly trying to give importance to Trump and those who follow him. Often they try to explain him away and his coarseness, callousness and abysmal lack of knowledge about almost anything relevant to the office he occupies or to the problems he proposes and pretends he's going to solve. Tied to the philosophy of the media owners, these journalists justify Trump and his practices, refusing to seriously criticize and condemn the sick, insane, inane and other disordered words and actions emanating from his mouth and mind. And likewise, they don't report or discuss the massive resistance to Trump in any meaningful and extended way. Nor do they speak assertively and critically of issues of poverty, suffering and social pain caused by structured social and racial injustice he proposes and practices or the real and destructive impact it will have on the lives and future of the people, the country or

the world. And so, it is up to us to refuse to be cowered or concede to the normalization of human coldness, callousness, evil and injustice that now so pervades the climate of this country. It is up to us to take responsibility for ensuring a righteous and relentless resistance in the coming Ice Age. This means we must remember Malcolm's teachings that we must be responsible in our people's eyes and assessment, not in our oppressors'. And it means that we must act responsibly for our people and outrageously toward the oppressor, interrupting and disrupting his planned business-as-usual, and putting another agenda on the table—an agenda more humane, dignity-affirming, just and contributive to the health, well-being and rightful flourishing of all.

We must stand up in the midst of the social madness and moral numbness around us and embrace our mission of serving as a moral and social vanguard which our ancestors, heaven and history have assigned us. We must fulfill the sacred mission of working and struggling to bring an inclusive and shared good in the

world, creating places and spaces where freedom for all is a lived reality rather than an empty and hypocritical claim of a dominant race or class, and where justice is a normal process and product of our daily practice and exchange. And moral sensitivity, empathy and caring are understood and embraced as both normal and necessary to any real claim to being human.

To live is to choose and to act in ways that will day by day determine the course and quality of our lives and form the contours of our future. Therefore, in the face and context of oppression, we cannot honorably or responsibly choose other than struggle, righteous and relentless struggle. As our ancestors instruct us, we must defiantly and boldly "bear witness to truth and set the scales of justice in their proper place, especially among those who have no voice", little visibility or ultimately less value in the eyes of the icemen, huddling in air-conditioned caves to deny them the rights and well-being they deserve. Indeed, we must, as the

ancestors teach us, bear witness to their poverty and pain, their suffering and suppression, their hunger and homelessness, and condemn and resist the bitter cold and bone-breaking callousness that defines the coming Ice Age in which we already and in great part live and struggle. And even when the icemen and women criminalize our criticism, prosecute our practice of active and defiant dissent, demonize and ostracize us and capture us and put us in prison on "Trumped-up" charges, we must still dare to struggle and dare to win, opening up the way to a new world and history of African people and humanity as a whole.

Famine in Africa: Will Trump Act?

Famine Is Threatening Three African Nations. What Will Trump Do?

As you read this, our world stands at a crossroads. As you read this, 20 million people stand at risk of starvation at the hands of what has the potential to become the worst humanitarian crisis since World War II; famine in South Sudan and impending famine in Northeast Nigeria, Somalia, and Yemen. Our country has a moral responsibility to address this issue head on.

For famine to be declared, two children younger than five years old in every 10,000 people have to die due to malnutrition and one in five families have to have insufficient food to sustain themselves. Waiting for famine to be declared to act means you're already too

Famine has already been declared in South Sudan, where hunger is expected to spread to 40 percent of the country's population in the absence of humanitarian aid. The country's man-made famine is a result of violent conflict in vast swaths of the country. Despite promises of access for relief efforts to these areas by the South Sudanese government, humanitarian organizations remain unable to gain access to provide urgent vital assistance in the form of food, water and shelter in many locations.

Somalia, Nigeria, and Yemen are all on the brink of having famine declared. More than half of Somalia's total population of 12.3 million are experiencing acute food insecurity and are on the brink of death from starvation as a result of drought. Due to conflict with Al-Shabaab terrorists, humanitarian access remains an obstacle in providing the country's 6.2 million people experiencing acute food

insecurity with the aid that they desperately need.

In Northeast Nigeria, terrorism by Boko Haram has resulted in widespread displacement and a growing humanitarian crisis. Over 50,000 people in the region are at risk of famine. In addition, counter-insurgency operations against Boko Haram by the Armed Forces of the Federal Republic of Nigeria in Adamawa, Yobe and Borno states have led to population displacement, limited access for relief efforts and have prevented farmers from accessing their fields, leading to significantly below-average harvests.

In Yemen, agriculture production has drastically declined due to conflict, insecurity, high costs, and sporadic availability of agricultural inputs. Two years of escalating conflict have left 18.8 million Yemenis in need of some kind of humanitarian or protection support. Seven million women, children, and men could risk famine in 2017.

In each country, whether it's existing famine in South Sudan or the brink of famine in Somalia, Nigeria, or Yemen, the particularly disastrous characteristic is that these situations are either caused or exacerbated by man-made crisis.

You wouldn't know that this was occurring though other than a largely lackluster statement about South Sudan on "Face the Nation" in early April by Ambassador to the United Nations Nikki Haley, the Administration has been quiet about the impending disaster in Africa and Yemen. When asked about the implications of the Administration's budget proposal, Ambassador Haley called for "smarter spending" when it comes to foreign and humanitarian aid.

Smarter spending is, of course, necessary, but, in the face of the president proposing cuts of nearly 30 percent to foreign aid and diplomacy efforts, it's hard to imagine that the appropriate amount of aid and assistance will be provided to the four countries. At a fundamental level. President Trump's Americafirst budget would forego international diplomatic leadership and ignore the impending crisis. Foreign aid is an investment, and it makes our country and those overseas fighting for us, dramatically safer. With leadership comes responsibility. Providing aid is a moral imperative.

Despite the lack of coverage in TV media on the issue, we are at a crossroads. Congress has the decision before them to either continue America's legacy in ending famine now, or forgo our diplomatic leadership in the area entirely.

President Donald Trump succeeds in trashing civil rights

The reviews of Donald Trump's first 100 days have generally focused on his failures, flip-flops and follies. We've heard a lot about what he's failed to achieve, but far too little about what he is intent on doing.

Trump's time in office so far has been a systematic and vicious assault on civil rights. The progress that was won with struggle, sacrifice and legislation is being subverted by ink and administrative actions and deregulation. Trump is intent on rolling back the legacy of Dr. Martin Luther King, and in his first 100 days the damage has already begun.

He appointed Neil Gorsuch to the Supreme Court, a judge with a record of rulings undermining the rights workers, women, LGBTQ community, and protections of the environment and democracy.

Gorsuch, selected from a list provided by the farright Federalist Society and Heritage Foundation, is so extreme that he was confirmed only after Republicans overturned the Senate's long-established rules to get him confirmed with a mere majority. Gorsuch's accession to the court now



reconstitutes a five-person activist right-wing majority that will continue to undermine voting rights, worker rights and civil rights.

Trump appointed Jefferson Beauregard Sessions as his attorney general, a man who derides the Voting Rights Act as "intrusive" and celebrates the Shelby decision that undermined it. Sessions reversed the Justice Department's position on Texas' racially discriminatory voter ID law. He has reversed the commitment to phase out private for-profit prisons, and has moved to abandon vital police accountability measures that had bipartisan support. He's threatening sanctuary cities while gearing up for mass deportations that would break up families and separate mothers from chil-

dren. Trump issued his Muslim travel ban, an executive order barring citizens of selected Muslim-majority nations from visiting the

United States, although fed-

eral courts blocked it as an unconstitutional violation of religious freedom. Trump's toxic rhetoric has been followed by an increase in hate crimes across the country.

To head the Department Education, Trump appointed billionaire Betsy DeVos, who for years has devoted herself to undermining public schools and who defends deep cuts in everything from support for schools in poor neighborhoods to Pell grants that help the children of working families afford college.

Trump has given his economic policy over to former Sachs bankers, including Treasury Secretary Steven Mnuchin and White House Economic Council head Gary Cohn, and they have rolled out plans to give the very rich deep tax cuts that they will use to justify slashing programs vital to working people, including Medicaid, education and even Meals

Trump has stacked his cabinet with committed opponents of the missions of the very departments they head: Scott Pruitt at EPA, Ben Carson at Housing and Urban Development, Rick Perry at Energy, Alex Acosta at Labor.

Trump has signed 13 under the Congressional Review Act overturning Obama-era regulations, including the Fair Pay and Safe Workplaces executive order that required federal

As the flight attendant always says before wheels up, put your oxygen mask on first before you try to help someone else and that's exactly what I plan to

My mother is a horrible woman. It took some time but I've accepted that and work everyday not to be like her. But the day will come when she will have to answer for all of her past transgressions—as I will, as we all will. Believe that.

For those of you with sorry lowlifes for relatives who you find yourself always having to clean up behind, stand strong. Don't make excuses for their bad behavior. Don't be complicit in their bad behavior. Don't blame yourself for their bad behavior. Do what you can do and pray to the God of your understanding to deliver them from their trifling ways and live your life. Just hold on, you're not alone. They say God never gives you more than you can handle. At least that's what they say.

We all weren't blessed with mothers like Clair Huxtable and because of that Mother's Day can be especially hard. From the advice of a co-worker. Harmon used an app called Next Door, a free private social network for your neighborhood (allows the user to know what's going on in their community). The app revealed that parking had been re-routed to Inglewood Park Cemetery. "I was in absolute disbelief. There were pictures of littering after an event that happened. Jack Daniels bottle, panda containers, paper cups. The entire grounds where the cars were parked was covered with litter. I was so frustrated and angry I took all the pictures and posted them on my Facebook page to let my entire Facebook community know what was happening. My husband is buried at Inglewood Park Cemetery," she said.

Overflow parking for the Great Western Forum was located on the empty lot across the street. Since the construction of the new NFL stadium that parking is no longer available. Many construction pains are being felt by Inglewood residents and now from many who have loved ones buried at the cemetery.

Mayor Butts released the following statement; "The city of Inglewood gives our appreciation to Inglewood Park Cemetery for helping out in this time of transition while overflow parking is unavailable due to the construction of the new NFL arena. On approximately 5 occasions over the past 3 months, the Forum was allowed to park overflow vehicles on the property. The Forum provided security and lighting and clean up services to ensure the parking areas were left clean and unblemished. The parking fees generated for IPC allow the Cemetery to accelerate grounds maintenance.

"My parents rest in

Inglewood Park Cemetery and I empathize with the concerns of family members. The city has opened its parking structure on Locust Street, its structure adjacent to City Hall for Forum's 300 employees and the school district has made lots available for patron parking. Mc-Cormick's Ambulance has helped out as well. Effective June 15, 2017, overflow parking will once again be available adjacent to the site of the football stadium. I again salute all the community partners who have stepped forward and ask for patience as the city rebuilds and progresses," Mayor Butts stated

who was directed to park at the cemetery when attending a concert at the Forum. "I really applaud that the city of Inglewood would allow this to happen and Inglewood cemetery itself. No it's not in the contract but just to have a visual of what happens in parking lots at concerts and to think that that would be taking place. My parents are buried on Los Flores situated off the main road of Inglewood Park Cemetery. The optics of it looks horrible coming down Manchester at night. Do I think these people are parking on graves? No ... however if security is not in place like they should you never know what people might do when they are intoxicated or high, so that's the problem I have with it! Inglewood Park cemetery insists that through the arrangement made with the city security and lighting is well in place," said Finley

Mixed emotions and communications have begun to spread. With some believing that the forum and cemetery made arrangements for the parking. The Sentinel spoke to executive assistant to

Rick J. Miller, CEO, Joan Francis who stated, "the city of Inglewood asked Inglewood Park Cemetery, along with some other establishments around the city, the Hollywood Park Casino and local schools. The city itself is allowing their parking structures; everyone's chipping in, Inglewood Cemetery is one of the establishments. They asked if we could, on a limited basis for a temporary time, participate in this service to the community to allow parking on our grounds after hours. We agreed to allow them to park some of their overflow on our roads. I know there has been an emotional response to this. We understand their concerns about the graves; they're not affected at all, the

Mausoleums are not affected at all. The parking is restricted to the streets the people are walking on the streets." said Butts.

In response to pictures that have circulated after concerts with alcohol bottles and cups, Francis responded, "The forum provides clean up, parking attendants and security. The cemetery also provides security. Even after a funeral service we have to pick up trash."

The photos circulating of bottles and cups, were taken by Steve Hawkins who has many family members and friends buried at Inglewood Park Cemetery. He stated, "that has nothing to do with what our problem is, our problem is the after hour parking and the trash that's left. I felt disrespect for my loved ones," he said.

Francis of Inglewood Park Cemetery continued, "The Forum gives us something to pay our security guards and any other clean up and things like that that we may have to do. When asked the amount replied, "Oh I have no idea. You can ask the Forum ... see if they'll tell you. I have no

idea. My understanding ... it's very minimal. We're just trying to be good neighbors."

Madison Square Garden, which owns the Forum has yet to respond.

When asked how long this parking agreement will last, Francis replied, "I've heard everything from two months to five years."

Not all cemeteries are exclusively for burials and love one's remains. For example, Hollywood Forever is a landmark burial ground for Hollywood VIPs and an entertainment venue for outdoor movies and concerts.

Forest Lawn Cemetary was recently named one of the Top 10 free museums in the country by Yahoo Travel. Forest Lawn Museum is committed to enriching the community through the educational presentation of artwork that focuses on history, culture and religion. The exhibit is open 10am-5pm. They are also hosting the David Bowie: Among the Mexican Masters a unique archive which captures intimate moments between the legendary musician and the cultural heritage of Mexico, made during Bowie's only visit to Mexico City 20 years ago.

Regardless, Inglewood citizens have begun to congregate on an app called Next Door where Inglewood Cemetery has been a hot topic. We spoke to one Next Door app member who prefers to be named in this interview as Paris-N-Morningside, which is her screen name. "A cemetery is a sacred place not a parking garage. That's the last sacred place where you would think people had some decorum. People have a very emotional connection to a cemetery. This is supposed to be a peaceful resting place, not a place where people park to go partying and stomping through it." she said.

What Charter Amendment C will do is allow police officers who are found guilty of misconduct to essentially choose their "jury." Currently, officer misconduct charges are handled by the Chief, who determines the merits and imposes discipline. Officers found guilty can appeal the Chief's decision to a Board of Rights, which consists of two command-staff officers and one non-police professional (usually a retired judge, arbitrator, attorney, or even a former officer). In every single instance, the non-police professional has been more lenient on guilty officers than commandstaff. The ballot measure would keep the current system in place and add an ad-

ditional option that allows for all three members of the appeals body to be nonpolice professionals who are paid \$1000 per day and can be hand-picked from a list by the officer who has already been found guilty of misconduct. At a time when tensions continue to rise between community and police, when LAPD continues to lead the nation in the killing of its residents, when nearly 60% of Angelenos believe that another massuprising is inevitable, we must not weaken police discipline, yet that is precisely what Charter Amendment C

would do.

Nearly 100 organizations, community leaders, and media outlets have come out in vocal opposition to Charter Amendment C. Everyone from Pastor John Cager, to Black Lives Matter, to classroom teachers (UTLA), to the Los Angeles Sentinel oppose, recognizing that we must hold police who are found guilty of misconduct accountable. Those who placed the item on the ballot expect communities of color and working class people - those most impacted by police misconduct – to stay home, but this is one that we cannot afford to sit out. We implore everyone to get out and vote #NoOnC on May 16th and tell everyone vou know to "hold the line against police misconduct."

tion Committee, and his attorney Dermot Givens, announced the suit during a press conference in front of LAPD Headquarters on May 9.

LAPD officers "De La Torres" and "Hernandez" are also defendants in the lawsuit, which stems from Akili's participation in a Black Lives Matter protest at the L.A. Police Commission meeting on Feb. 9, 2016.

Akili, 68, is also suing for unlawful detention, excessive force, and false imprisonment.

He was arrested and tried on one count of battery on a police officer. The court dismissed the charge after a jury, comprised of no Blacks, deadlocked.

"They were seeking to put him in jail based on trumped up charges," Givens said. "We went through a two-week trial, and the jury said, Mr. Akili, we believe you and not the lying LAPD officers, who came to this trial," he continued.

Since the trial, the District Attorney and the City Attorney have been comfortably silent, as has been Mayor Eric Garcetti, the City Council, and Police Commission, Givens told reporters.

"They've done nothing to discipline the lying LAPD personnel, who were put on the stand by the City Attorney at Akili's trial," he said.

He added, "They told four bald-faced, absolute lies when they took the stand to swear to tell the truth."

According to Givens,

Ofc. Gebro lied when she said Akili grabbed her, going for her gun. "Then, she changed her story, after the City Attorney figured out that the jury didn't look like they were buying that story, and she came back and said he grabbed her breast," Givens said.

Givens said the other lies were that Akili left a red bruise on Gebro's side; that Ofc. Russell said he saw Akili push Gebro; and that Tefank said he saw Akili "BEAR HUG" Ge-

The jury disbelieved them, and now his client is seeking \$1million for each of the four lies that the LAPD has told against him, Givens said.

"We filed this lawsuit, seeking to make the city uncomfortable in accepting the lies of the LAPD ... We're calling on this city to stand together, to stand for justice, and recognize that Black Lives Matter," Givens said.

"This was a political trial," Akili told the Sentinel. City Attorney Mike Feuer could have dropped the charges, he said.

Akili said he has the distinction of being the only Black man in L.A., who was in the grasp of the LAPD, walked to the door, and then let go.

"Then, they arrested me! They lied on the stand, repeatedly. They accused me of doing stuff that no reasonable person would do in a room full of police officers. And, the worst part of it was, because my hands were occupied - I had a hat in one hand and a notebook in the other - I couldn't do anything to anybody," Akili stated.

"They didn't prove their case, because they didn't have a case. They were doing this in an effort to silence Black Lives Matter,"

he added Akili. "I feel much better now. I gotta tell you, those two days, which wound up being 10 days, were full of anxiety for me. It was nerve-wracking to sit there and be characterized as a loud, Black, angry man, who wouldn't wait his turn, and who, in a room full of police chose to batter an-

other police," Akili said. Neither of the arresting officers testified during

trial, Givens said. The complaint alleged, "While plaintiff was being escorted out of the meeting, Tefank, who was seated on the dais next to LAPD Chief Charlie Beck, told Chief Beck that plaintiff should be arrested."

Akili had been escorted out of the auditorium and was walking away, when Tefank, who is not a peace officer, exited the meeting room and ordered De La Torres and Hernandez to arrest him, according to the complaint.

"No comment on any pending litigation," wrote Tefank, in response to the Sentinel's request for a phone interview or statement via email.

Akili thanked his attorney for being his legal guide, and about a dozen activists and others who attended his 10-day trial, which he called an anxietyfilled process. It was supposed to last only two days, and without their support, it would have been much more difficult, he acknowl-

For years, Black Lives Matter, along with other organizations, have attended Police Commission meetings, seeking to hold the LAPD accountable for shootings, among other things, said Dr. Melina Abdullah, an organizer with BLM-LA.

She said Akili has been among them, lifting up his community, but the LAPD and the system have been criminalizing their actions.

Akili's arrest wasn't the first arrest, and it won't be the last, but the activists/organizations will continue to respond with repercussions in the form of lawsuits, said Abdullah, who is also chair of the Pan African Studies Department and a member of the Black Community, Clergy and Labor Alliance's (BCCLA) Steering Committee.

"We are demanding Tefank's immediate termination, and we are also saying that we are going to hold our systems accountable in whatever way we must," Abdullah said.

"Black Lives We Matter Here," Akili, Abdullah, and activists chanted several times throughout the press conference.



"I think he was railroaded," said Larry Aubry, cochair of the BCCLA, who also stood with Akili (also a BCCLA member) at the press conference.

"The jury deadlocked ... I think the police officers lied on the stand. I really do believe that. There's no real indication ... I think really it's one of these things that should never have been filed, and I think he's perfectly right in trying to go to court and clear his name behind this travesty," Aubry stated.

Intersection: Dementia, Poverty, Homelessness

How Three Key Social Ills Combine to Leave Elders with Skilled Care Needs Unmet

Part 2 of 3: Poverty

Finding out as a young college student that his estranged father had been crippled by dementia was hard enough for Bryan Gaines.

The decline in Melvin Gaines' mental ability was one thing to grapple with, but having to provide around the clock long-term care for a man he barely knew, heightened that challenge.

"The first thing I said was there's no way in the world that I could deal with this. I felt like this is my father, but I'm in school, and all these scenarios went through my mind," Gaines stated.

Gaines reluctantly accepted the fact that he would have to take the lead. "I thought about how he wasn't ever there for me, and I never had a father to talk to," he said. According to Gaines, he endured a horrible, young life of pain, which included molestation and loneliness. He blamed his father for not being around, he lamented.

His Grandmother's Advice

Gaines said the news was further exacerbated by the reality his father had no resources to help provide the quality of care he needed. His father would eventually get Medi-Cal, but died very shortly after.

died very shortly after According to Gaines,

it was the counseling of his grandmother, a huge influence in his life, that inspired him to step up to the plate to take care of his father until his last breath.

While dementia had reunited the father and son, it also caused their spiral into poverty, particularly Gaines, Sr.

"I used everything he had plus what I had to take care of him, to make all of this work. I lost so much behind this. I mean, I am almost poverty-stricken behind trying to take care of him, taking my savings and my money that I earned on my job, all the things that I had to take care of because he ran out of money," Gaines stated.

Worried About Mother's Care

Eileen Thompson has cared at home for her mother who is over 70-years-old. Her mother has congestive heart failure, hypertension, and diabetes, which all exacerbate her health and financial situation. However, living at home is important to her, Thompson shared last fall during a national conference on aging.

Thompson expressed concern about maintaining her mother's quality of life and about receiving resources she needs in the new political climate under President Donald Trump. She was especially worried about attempts to repeal the Affordable Care Act (ACA).

Former President Barack Obama signed the ACA in March, 2010. A key benefit for seniors is that the law provides help with prescription drug costs.

"We're going to be prayerful, and be vigilant. I think advocacy is important, because we're at the point now where my mother, fortunately, has private insurance, but that's also coupled with Medicare, so most of her visits are at

zero out-of-pocket for her," Thompson stated. According to Thompson, her mother has Medi-gap insurance, which pays copayments and other charges not covered by Medicare.

"Without that additional Medicare component, that could probably change, so we are watching. We are being mindful. We are trying to speak with our representatives and see exactly what's going to happen with that," Thompson continued.

The organization Alzheimer's Greater Los Angeles (alzgla.org) recommends putting financial plans in place as soon as a diagnosis has been determined. But what does that mean for people like Bryan Gaines?

An estimated 44 million people in the United States provide unpaid family care, and 75 percent of them are employed, indicates the National Alliance for Caregiving (caregiving. org). According to NAC and AARP, nearly 70 percent of working caregivers must make workplace accommodations, such as modifying hours, taking a leave of absence, choosing early retirement or turning down a promotion to a more demanding job.

37 Billion Unpaid Care Hours

AARP and the nonprofit Respect a Caregiver's Time, or ReACT (a coalition that addresses caregiving challenges facing both employees and employers) have been encouraging employers to provide caregiver benefits.

Their 2016 joint report (respectcaregivers. org) titled, "Determining the Return on Investment: Supportive Policies for Employee Caregivers," stressed that family caregivers create substantial economic value for society.

Also, a 2015 study estimated that in 2013 alone, approximately 40 million family caregivers in the United States provided 37 billion hours of care to an adult with limitations in daily activities, translating into approximately \$470 billion of unpaid contributions

Research suggests that
45 percent of employed
family caregivers provide
often-complicated care
previously provided only
by formal medical and
nursing care. This includes
managing multiple medications, caring for wounds,
preparing special diets,
using medical monitors,
operating medical equip-

ment, conducting care coordination, and hiring other paid help for family members with multiple chronic physical, cognitive, and behavioral conditions, the document continued.

According to the Alzheimer's Association, while costs may vary depending on geographic location, some common care costs include ongoing medical treatment for Alzheimer's related symptoms, diagnosis and follow-up visits; treatment or medical equipment for other medical conditions; and safetyrelated expenses, such as home safety modifications or safety services for a person who wanders.

The group adds that costs also include prescription drugs, personal care supplies, adult day care services, in-home care services, and full-time residential care services.

A data snapshot of the average costs for long-term care services in the United States posted on the association's website (alz.org) stems from Genworth Financial's 2016 Cost of Care Survey, which included statistics from home care providers, adult day healthcare facilities, assisted living facilities and nursing homes:

- \$225 per day or \$82,125 per year for a semi-private room in a nursing home;

- \$253 per day or \$92,378 per year for a private room in a nursing

- \$3,628 per month or \$43,539 per year for basic services in an assisted living facility;

- \$20 per hour for a home health aide;\$68 per day for adult day services.

"When we talk about poverty, you can start off with dealing with this disease and end up going through property as a direct result of trying to care for

someone," Gaines said.
"You're trying to juggle
and work your job. I know
many people that have lost
their jobs as a result of trying to be a caregiver, and
that's just part of it. I know
people that have gotten rid
of their homes to move in
with their mom," he stated.

According to Gaines, many working, first-time caregivers initially hire home care services, which depletes their resources, eventually forcing them to take on caregiving duties themselves. Some may qualify for home and community based care, such as the In-Home Supportive Services (IHSS) program, if they qualify the low-income Medi-Cal program.

Depending on income, AECRO the cost of services may

AECRO.

Service providers assist with daily living activities, such as bathing, dressing and transferring, house-keeping, laundry, meal preparation, personal care, shopping assistance for essential items, supervision, and transportation assistance.

"Everything is expensive, from the insurance to the Depends [adult incontinence underwear], and if you don't have access to these services and the person doesn't necessarily

qualify for it, if they get \$1 more than they're supposed to -- it's a struggle. It puts people in poverty," Gaines argued.

He added, "When you're dealing with poverty, and you're struggling, trying to figure out whether you're going to buy medicine or buy food, there's no quality of life there. Everybody's frustrated."


The system's practice is to have caregivers who live with loved ones they are caring for to just double the task, Gaines said For example, he went

"When the social

worker comes out, and sits there, and looks at the time that's going to be allocated, they say, 'Okay ... you have breakfast, too, right? So you can fix her breakfast when you fix your breakfast ... You can wash her clothes when you wash your clothes,' so all that time, that's all cut off because you are already doing some of that work," he said.

"Therefore the amount of money that's allocated to you is substantially less than what you're used to getting, so many people end up losing their cars, losing their homes, and all kinds of things trying to provide care for a family member," Gaines added.

Healthcare workers push for dialysis treatment regulations

Nurses, patients, and other health care workers outlined proposed legislation to regulate dialysis treatment during a briefing hosted by New America Media at SEIU-United Healthcare Workers West on May 4.

Dialysis is a life-saving treatment for people with end stage renal disease, according to health experts.

Senate Bill 349 (the "Dialysis Patient Safety Act") aims to improve safety and care for all patients receiving treatment at outpatient clinics in three ways. It will mandate staffing to safe levels, increase inspection frequencies, and require companies to allow workers adequate time between patients to clean the dialysis machines, as well as allow patients sufficient rest time after treatments, according to a United Healthcare Workers (UHW) fact sheet, entitled "More Than Numbers".

The requirements are long overdue, said several dialysis nurses and patients who briefed reporters.

According to statistics, Blacks are nearly four times as likely to need dialysis as Whites, and in California, almost 10,000 Blacks receive dialysis in the state's 562 clinics.

In addition, in 2014, an average of 13 dialysis patients died per clinic, and one in eight of those were due to infections, the fact sheet further indicated.

Several dialysis nurses and staff said they have worked extended hours with imbalanced nurse-to-

patient ratios.

According to Cass Gualvez, organizing director, SEIU-UHW, dialysis workers from the multinational corporation Fresenius Medical Care North America approached them about a year ago. They concerned about their working conditions, and interested in forming their union with UHW, she

Workers talked about being rushed, working six days a week for 12 hours, and people being timed if they took too long to get the next patient into a chair, Gualvez stated. She added, "I was floored when I was told that people were encouraged to get the next patient in the chair within

15 minutes." Megallan Handford is a retired police officer, and has been a caregiver and dialysis nurse for 15 years. He stated that day in and out, he and colleagues are rushed to work within policies and procedures that are set up for them to fail.

"When you look at all of this, let's be clear about this. It's all about profit. It's all about money," charged Handford.

"When you see patients dying for reasons that they should not be dying for, as an individual, you have to stand up for what's right," he said.

According to Hanford, most doctors spend about an hour or two, doing rounds in clinics, and then they leave. They do not see when a patient is crashing, is coded, or the trauma they experience, he continued.

If a patient dies in a chair, Handford said workers place them in a back room until an ambulance or coroner picks them up, but they then have to go back to work with other patients, who just witnessed it all.

"As a police officer, if I got into a shooting, I at least was given the courtesy of having to be off

of work for 3-4 days after a traumatic incident like that, but we're expected, as caregivers, to go back into that environment at that same time, and put on a face, and do our work," Handford said.

Much of the workers' ire targeted DaVita, Inc. and Fresenius, the two leading kidney care and dialysis treatment centers in the United States, according to Gualvez. The healthcare workers stated DaVita's conditions are the most horrendous.

According to Sherry Yatts, who has also been a dialysis nurse for 15 years, she and a co-worker were fired from DaVita, because the company failed to take responsibility for equipment failure.

"I kept telling them that there is a problem with the system, which they failed to look at, so a patient got sick. I was like, you guys need to check this out! Every time I put a patient on this, they get sick at this port," Yatts said.

"They failed to investigate, so instead of it falling on them, it fell on me and the bio med guy, so we had to be terminated," she continued.

DaVita had not replied to the Sentinel's requests for interviews at press

"Fresenius Medical Care opposes SB 349," stated Jon Stone of Fresenius' Public Relations and Corporate Communications office. Stone did not address

the healthcare workers' claims about poor working and treatment conditions, and practices, but stated that the company is part of California Coalition, a group of patient advocacy groups, providers, and others opposed to the bill.

A California Coalition press release dated April 19 countered the bill proposes rigid dialysis clinic staffing mandates, which put politics before patients. It would jeopardize access to dialysis care for thousands of patients, the document went on.

The coalition, which also includes nurses, physicians and clinics specializing in dialysis care, are against, among other things, a specified 45-minute transition time between patient shifts.

"... SB 349 would harm patients by reducing access to care while increasing costs to the Medi-Cal program and the overall health system in California," the release read.

Dr. Randall Maxey, past president of the National Medical Association, said he feels SB 349, in a sense, its misdirected. The target should be the federal government through the U.S. Congress, and Medicare, to affect dialysis companies, he told reporters during the May 4 briefing.

He said one of his fears in passing legislation that means more regulations is that it won't hurt the big companies at all. "They'll just pay the fine. It'll hurt small people - companies like me, doctors like me - trying to do the right thing, and making it simply harder. So, it's not thought out," Maxey argued.

Maxey said the issue is very important to him, because Blacks are less than 15 percent of the U.S. population, but make up more than 40 percent of the dialysis population.

"So all of these millions and billions of dollars that are being made are being made on the backs of people who look like me,'

According to Maxey, his father was and his brother is a dialysis patient. He has worked for both DaVita and Fresenius. Now, he owns 18 dialysis centers in Puerto Rico.

Latinos and Blacks don't get care in time, which results in catheters, he said. That increases chances of infections, which increases probabilities of death, he said. By the time many people got to dialysis centers, they only had about three-to-four months to live because they couldn't get care ahead of time, he explained.

"If you're going to solve a problem, it's not just that we need more staff. We need a better system," Maxey said. What doesn't work is looking at the problem as a silo, he

Maxey said a key solution is to develop a relationship between the workers and nurses, and care technicians and doctors. He said frankly, he doesn't trust the motivation of the unions to do that.

"We know what's happening with the patient. I would say that the motivation of most of the health care workers are pure, but they're being used," he said.

Youth Lobby State Lawmakers for Prison Reform

L.A. area youth traveled to the State Capitol to advocate with approximately 300 other activists for formerly incarcerated people and their families.

The approximately dozen members of the Youth Justice Coalition who participated in Quest for Democracy on May 8 advocated for lawmakers to pass 10 bills to protect and uplift California's youth.

They include:

- Assembly Bill (AB) 90 - place a moratorium on the use of shared gang databases until issues exposed by state audit are ad-

- Senate Bill (SB) 190 - end billing of families for time youth are in juvenile hall, and camps, as well as mandatory court fees such as ankle monitoring and public defender fees;

- SB 394 - end life sentences without the possibility of parole for youth under 18;

SB 395 - grant Miran-

rogation; - SB 439 - end juvenile court prosecution of children under age 12; refer such cases to child protective services, eradicate children's criminal records, and, they would no longer have criminal records or experience detention in juvenile hall and incarcera-

tion; and,

da rights for youth under

18; guarantee the opportu-

nity to consult with an at-

torney before police inter-

- SB 607, which would end K-12 out-of-school suspensions for willful defiance. According to its authors, 90 percent of California youth in juvenile halls and county youth prisons (probation camps and ranches) were suspended or expelled from school before their incarceration.

"For decades, local, state and federal governments have created policies to criminalize, incarcerate and deport millions of people - predominantly targeting Black, Brown and indigenous communities. Quest for Democracy is an opportunity to promote the experiences and solutions of formerly incarcerated people and our families," said Kim McGill of the Youth Justice Coalition and Free L.A. High School.

According to McGill, SB 607 (willful defiance suspensions) passed out of the Senate with only nine "no" votes.

In all, the Youth Justice Coalition delegation held more than 70 meetings with legislators to push their focused bills, plus those championed by their allies.

In addition, the Alliance for Boys and Men of Color was at the capitol the same day to redefine public safety and reclaim justice. Their day of action, themed "Free Our Dreams," actually began on May 6.

They held legislative do's and don'ts training,

legislative preparation sessions, and youth and adult orientations.

Their aim is to use their voices and power to build a "CaliforALL" where the state's most vulnerable young people feel safe and protected in schools and communities, notes the alliance's website.

Quest for Democracy was spearheaded by Legal Services for Prisoners with Children. Dorsey Nunn, executive director, said the day of action allows the formerly incarcerated to advocate as experts from first hand knowledge.

"As people who have been directly impacted by the realities of reentry and the devastating effects of the criminal justice system, we're able to use our experience to craft and support legislation that humanizes us, and helps our families and communities," Nunn stated.

First 100 Days of Resistance: What's Next for Immigrant Rights

Activists briefed reporters from ethnic media on a conference call about their resistance to President Donald Trump's first 100 days in office, and what's

next for immigrant rights. The approximately onehour telephonic press briefing was hosted by New America Media (NAM), a nationwide association of over 3,000 ethnic media organizations (representing the development of a more inclusive journalism) and Ready California, a coalition of legal services providers, community-based organizations, unions, faith-based organizing groups, ethnic media, foreign consulates, and more, who provide legal support to immigrant communities.

Odette Alcazaren-Keeley, NAM's National Media Network director, facilitated the call. Speakers were Angelica Salas, executive director, Coalition for Humane Immigrant Rights (CHIRLA), Adriana Guzman, outreach coordinator, Faith in Action Bay Area, and Melissa Lim Chua immigration director, International Rescue Committee.

The activists also briefed reporters on recent major wins and losses of the immigrant rights movement and gave an update on raids, and who is being targeted.

"How do immigrants, civil rights, and refugee rights advocates view the first 100 days of the Trump Administration? How bad are things? ... Where do you see the signs of hope," Alcazaren-Keeley asked

Chua, as she began the ses-

First, Chua expressed that it's worth noting that since January, the Trump Administration has undertaken sweeping changes in immigration policy.

Those changes include signing a number of executive orders; two focusing on increasing enforcement at the southern border and in the interior United States, Chua said.

She highlighted a third, known as the travel ban, which was issued on Jan. 27. The ban is aimed to curtail travel from certain predominantly Muslim countries, and lower the amount of refugees allowed admission into the U.S., Chua said.

"Finally, a fourth executive order signed in April called in federal agencies to enforce laws to protect the interests of U.S. workers, and for those agencies to suggest reforms to reduce fraud and abuse in the H1B Visa (a temporary work visa) System, "she continued.

Some of the orders have had immediate effects on immigrants, Chua said. For instance, arrests of non-citizens arose in the U.S. more than 30 percent from Jan. 20 to March 13, compared to the same time frame in 2016, she said.

"And, despite the injunction by courts on the travel ban, the rate of admission of refugees has been low, since the (Trump) administration took office, endangering tens of thousands of refugees who have already been vetted by the U.S. Government," she

stated. However, many of the proposed changes face real, significant hurdles, such as a lack of funding and blockage by courts, and Chua continued.

The speakers also gave updates in proposed changes to immigration policy.

During Q&A, Henrietta Burroughs of East Palo Alto Today, asked the panelists how they defined "immigrant community".

Burroughs said she sought to know which immigrants the panelists were discussing, because immigrants from Southern Africa are five times more likely to be deported than

any other immigrants. "When we think of immigrants in this country, we think of those south of the border, where the emphasis Trump has on building a wall, but those are not the immigrants who are most likely to be deported," Burroughs further explained.

CHIRLA works with all communities, from Latin America, Asia, and Africa, especially the most impacted, Salas stated.

"I believe that the statistic that you talk about is that African immigrants who have any kind of connection or any kind of engagement with law enforcement are five times more likely to be deported," Salas replied.

She continued, saying African immigrant communities are extremely vulnerable around racial profiling.

"The other thing that I think is important for you to know is that 98 percent of the deportations that happen in this country are from people from Mexico and Central America," Salas added.

Road Elementary School. Bradford graduated from Dorsey High School in 1973 and studied at West


working for 42nd Street School Audubon Middle School at that time.

There's little argument that one of the greatest achievements in the long and illustrious career of the late-Justice Thurgood Marshall, who died in 1993 at the age of 84, was the landmark decision in the 1954 Supreme Court case Brown v. Board of Education.

According to the NAACP Legal Defense Fund, in 1940, "Marshall became the key strategist in the effort to end racial segregation, in particular, meticulously challenging Plessy v. Ferguson, the Court-sanctioned legal doctrine that called for 'separate but equal' structures for Whites and Blacks."

The Brown v. Board of Education lawsuit began as five separate cases filed in South Carolina, Delaware, Virginia, Washington, D.C. and Kansas. The plaintiffs in all of the cases alleged that the civil rights of their children under the 14th Amendment had been violated.

A biography about Justice Marshall that appears on The Legal Defense Fund's website said that, "Marshall won a series of court decisions that gradually struck down ['separate, but

equal'], ultimately leading to Brown v. Board of Education, which he argued before the Supreme Court in 1952 and 1953," finally overturning the doctrine and acknowledging that segregation greatly diminished students' self-esteem."

On May 17, 1954, the Supreme Court unanimously ruled that separate educational facilities were "inherently unequal" and that racial segregation of public schools violated the equal protection clause of the 14th Amendment of the U.S. Constitution.

The Brown v. Board of Education decision came more than a decade before Marshall's appointment to the Supreme Court. The decision has been credited with inspiring the Civil Rights Movement that unfolded over the next decade and it also led to Marshall being recognized as one of the most successful lawyers in

"He accomplished so much and worked so hard, but I thought by now we would have come so much further. He would have thought that, too," said Marshall, whom loved ones and others affectionately call "Cissy."

Her work continues in her husband's memory.

On the 63rd anniversary of Brown v. Board of Education, Marshall and the Thurgood Marshall Center Trust plan to host a fundraising gala to observe the historic decision and to announce a call to action, which she's titled, "Equal Education for All Based on the Brown Decision."

The event will be held at the Thurgood Marshall Center for Service and Heritage in Northwest, Washington, D.C.

"The problems remain and this event, this anniversary, comes against the backdrop of a significantly troubling retrenchment of access to education for African-Americans, Latinos and other children," Marshall said.

She cited a Leadership Conference on Civil and Human Rights report that said there are numerous factors that appear to have combined to cause the rapid re-segregation of schools since 1991, the year her husband retired from the bench.

The courts began turning against desegregation plans in the 1980s—denying new petitions to desegregate schools, ending previous court imposed plans and even striking down voluntary plans created by local school districts, according to the Leadership Conference on Civil and Human Rights, a diverse collective of more than 200 national civil and human rights groups.

Further, executive branch agencies topped the aggressive campaign to enforce the Brown decision and the Civil Rights Act that proved successful in the 1960s and 1970s, the Leadership Conference reported.

In a statement about the report, the Leadership Conference said that the rapid growth of the Hispanic and African-American populations and growing income disparities have increased the concentration of minorities living in high poverty districts.

Leaders from the National Newspaper Publishers Association (NNPA) and others plan to join Marshall at the historic event to celebrate the life and legacy of Justice Thurgood Marshall.

"The NNPA reaffirms the living legacy of U.S. Supreme Court Justice Thurgood Marshall," said Dr. Benjamin F. Chavis, Jr., the president and CEO of the NNPA. "We note this month the 63rd anniversary of the landmark 1954

Supreme Court decision. Marshall utilized his legal genius and courage to win that case."

Chavis continued: "Today, it's important to reassert the critical importance of continuing to demand equal, high-quality education for Black American students and all students across the na-

Marshall, she said that, she still gathers with the wives of former and current Supreme Court

"We're a big family, we call ourselves 'sisters,'" she said.

Those get-togethers, as well as the success of her two sons-Thurgood, Jr., and John W. serve to further validate her husband's legacy.

"Seeing his sons grow up to become adults-Thurgood, Jr. a lawyer; and John serving in civil service—has been a great joy," said Marshall. "My husband gave me and all of us a great life and his favorite slogan was something we've always lived by and I still live by today, especially when I think of the state of things in this

That same month, Trump tweeted a warning to Chicago's political establishment: "If Chicago doesn't fix the horrible 'carnage' going on...I will send in the Feds!"

In February, during a meeting with sheriffs, Trump claimed that the murder rate in the U.S. was the highest it's been in 47

"Did you know that? Forty-seven years," said Trump, according to the Chicago Tribune. "I used to use that—I'd say that in a speech and everybody was surprised. Because the press doesn't tell it like it is. It wasn't to their advantage to say that."

That statement from

like what's happening in many others, was inaccu-

"The most recent annual FBI statistics available show the national rate for murder and non-negligent manslaughter in 2015 was 4.9 per 100,000 people," the Chicago Tribune reported. "That was lower than every year between 1996 and 2009, when the rate fell from 7.4 killings per 100,000 people to five for the same population."

Whether Trump can pivot away from his "law and order" rhetoric and inaccurate statements about crime in urban communities and towards policies that involve economic development and neighborhood revitalization remains unclear.

After backpedaling from claims he made in February, that gang leaders committed to "lower the body count" in Chicago in exchange for "some social programs," Pastor Darrell Scott recently hosted a meeting in Washington, D.C. to discuss a range of issues affecting the Black community.

The "gang summit," as it was dubbed by reporters, was held at the St. Regis hotel, a few blocks from the White House. The discussion went on for over three hours. Even though, Scott of Cleveland Heights, Ohio, convened the discussion, he spent most of the multi-hour conversation as a facilitator.

During his opening statement at the summit, Scott said that, "We know President Trump is unpopular in the Black community."

Everyone in attendance appeared to understand the painfully obvious: that one meeting won't solve Chicago's complex issues around poverty, violence and the school to prison pipeline. The summit was just a first step that placed key players on these issues in the same room for the first time during Trump's presidency.

Xavier Williams, a former gang member who spent 16 years in prison and who earned a degree in community redevelopment, spoke to the group of assembled business leaders, Trump Administration officials, clergy and community stakeholders.

Williams ran down statistics pointing out that there were five neighborhoods in Chicago that were

By Lauren Victoria Burke ground zero for an endless Kareem Lanier as well as NNPA Newswire Contributor cycle of unemployment, about twenty others. Some poverty and violence.

Williams noted that the unemployment rate in five of the most violent neighborhoods in Chicago was extremely high and those same neighborhoods also suffered the majority of school closures since 2013, a decision that was criticized by local and national education advocates.

"In 2013, the city's mayor, Rahm Emanuel, closed 49 schools — a move that was met with widespread resistance and disproportionately impacted minority communities," according to The Huffington Post.

Williams also said that there was no oversight over funds allocated to assist residents returning from prison.

"There needs to be an accountability system or an audit," said Williams.

There was also an indepth discussion about the role of church pastors in Chicago and whether or not they were helping to improve the situation. That topic would have been taboo at most roundtable discussions.

"I've heard this complaint," said Scott. "That the money goes into the church and doesn't go into the community...they see how the pastor is living and they wonder," Scott added to nods of recognition around the room.

Sitting around a large rectangular set of connected tables as lunch was served, were Trump HUD official Richard Youngblood, James Holland of the NRA, Pastor Dean Nelson of the Frederick Douglass Foundation and Cleveland activist

who attended were from the business community, some were leaders of community groups and others were deep-pocketed investors who wanted to know how they could help Chicago.


"We believe [President Donald Trump] will be the one to help the Black community on housing renovation and neighborhood revitalization," said Lanier during the session.

According to a 2017 report on crime rates by the Brennan Center for Justice at New York University School of Law, "While murder rates have increased in some cities, this report finds no evidence that the hardwon public safety gains of the last two and a half decades are being reversed."

The report continued: "With violence at historic lows, modest increases in the murder rate may appear large in percentage terms. Similarly, murder rates in the 30 largest cities increased by 13.2 percent in 2015 and an estimated 14 percent in 2016. These increases were highly concentrated. More than half of the 2015 urban increase (51.8 percent) was caused by just three cities, Baltimore, Chicago, and Washington, D.C. And Chicago alone was responsible for 43.7 percent of the rise in urban murders in 2016."

Even though, "Today's crime rate is less than half of what it was in 1991," according to the Brennan Center, President Trump ratcheted up the "law and order" rhetoric during the first 100 days of his presi-

Full Five Month Closure of 6th Street between Flower and Hope in Downtown Los Angeles Begins June 3 for work on the Regional Connector Transit Project

Regional Connector Constructors (RCC) work crews under contract to the Los Angeles County Metropolitan Transportation Authority (Metro) will begin a five month full closure of 6th Street in downtown Los Angeles between Flower and Hope streets to perform roadway removal, utility relocation and beam installation work required for the Regional Connector Transit Project.

The five month closure, beginning Saturday, June 3, will also close down the 6th Street off-ramp from the southbound I-110 Harbor Freeway and reduce the northbound 6th Street offramp from two lanes to one. Southbound freeway traffic will be detoured to the 4th Street off-ramp, to Grand Avenue and then back to 6th Street. Northbound traffic from the I-110 Harbor Freeway off-ramp to eastbound 6th Street will be limited to iust one lane between Figueroa and Flower streets. Northbound I-110 motorists are advised to use the 9th Street off-ramp as an alternative to avoid long delays.

Eastbound 6th Street thru traffic will be detoured to southbound Bixel Street and Eastbound 7th Street to Olive Street and then back to 6th Street. Local access will be maintained on 6th Street from Hope Street to the AON Center, Pegasus Garage and The Standard Hotel

The Standard Hotel.

Sidewalks at the intersection of 6th Street and Flower

will be modified with at least three crosswalks to remain open and construction flaggers

onsite to facilitate access. The public is encouraged to plan ahead and allow for extra time when commuting into downtown Los Angeles from the Harbor Freeway and consider carpool options or alternative routes. Several Metro bus lines will also be impacted with service delays and detours. Those lines are the 16/17/316, 18, 442, 460, 720 and 910/950. In addition, bus lines operated by Foothill Transit, Santa Monica Big Blue Bus, Montebello, Torrance and LADOT will be detoured.

Eastbound Lines 16, 17, 18, 316 and 720 buses will operate via Wilshire Boulevard between Valencia and Hope Street and return to their regular route at 6th Street. Stops will be established on Wilshire at Witmer Street, Lucas Avenue and St. Paul Avenue. Return service and stops will remain unchanged.

Westbound Line 460 and Northbound Lines 442, 910 and 950 will operate via Hope Street between Olympic Boulevard and 6th Street. Stops will be established on eastbound Olympic at Figueroa Street and on northbound Hope Street at Wilshire and then return to their regular route at 6th Street. Return service and stops remain unchanged.

The closure will begin on Saturday, June 3, and will remain in effect through November 4. Anticipated work hours are from 7 a.m. to

midnight, seven days a week, weather permitting. The work to be done will also include drilling, excavation and the relocation and protection of three underground utility vaults. The street will be paved and restored at the end

of the five month closure. The \$1.755-billion Regional Connector Transit Project is a 1.9-mile underground light-rail extension that will connect the Blue, Expo and Gold Lines in downtown Los Angeles and will include three new stations at 1st Street/Central Avenue, 2nd Street/Broadway and 2nd Place/Hope Street. The rail line is expected to serve 88,000 riders daily – including 17,000 new riders - and save commuters up to 20 minutes by reducing the need to transfer. The connector will provide a one-seat, one fare ride for commuters from Azusa to Long Beach and from East Los Angeles to Santa Monica. The project is scheduled to be completed in 2021.


The new Metro rail extension will offer an alternative transportation option to congested roadways, provide significant environmental benefits and spur economic development throughout the county. Through improved connectivity, riders will be better able to use the entire Metro Rail system, municipal bus lines and other regional transportation services.





Big Sky Teams Acquire Dorsey Football Players

Dorsey seniors Gregory Jordan jr. and Antwone Williams earned a chance to pursue football on the Division 1 college level. Both players will be competing in the Big Sky conference with Jordan signing with Northern Arizona University and Williams committing to Portland state.

Jordan is a defensive tackle for Dorsey High School. He noted how coaches from NAU contacted him on Twitter, telling Jordan that his film impressed them.

"I've always seen Dorsey walk from [campus] to the (Jackie Robinson) stadium every time," Jordan said. "It was just nice and I was young, so I was pumped up.'

During the 2016 season, Jordan accumulated stats on both sides of the ball with 26 rushing yards, one rushing touchdown and

1.5 sacks, according to Maxpreps.

Jordan can aide NAU's defense, while Portland State will benefit from running back Williams' offensive abilities.

Portland State running backs coach Nick Whitworth had visited Williams at Dorsey to talk to him about the university.

"He just told me that it was a good place," Williams said. "Portland State was gonna be a good fit for me than all the other schools I had and they showed more love.'

Williams had a season high of 19 carries for 113 yards when Dorsey lost to Serra last September. He totaled stats of 84 carries, 572 yards, and seven touchdowns last season,

according to Maxpreps.

Both players considered the city championship game against Narbonne as the highlight of their senior year. Although trailing 29-7 at halftime, the Dons retaliated in the second half, chopping the deficit to two points.


CBS is making another change to its cast for the "NFL Today" show on Sundays, replacing Bart Scott with Nate Burleson.

Issa Rae says goodbye to anonymity after Insecure' success

Issa Rae is just starting to feel the side effects of having a hit show.

The creator, writer and star of HBO's "Insecure" is getting more and more opportunities — and she's also getting recognized on the streets of her suburban Los Angeles neighborhood.

"The true test for me was Inglewood. I live in Inglewood, and I walk in Inglewood all the time. I do a morning walk, and nobody

seizing the opportunities that have come with such success, though, with at least two film projects in the works: one as writer, another as actress.

"I'm taking it all in stride," Rae said. "The show, 'Insecure,' occupies like eight or nine months out of the year. But I'm happy to be in this position. It's a good problem to have."

Rae plays a fictionalized version of herself on the show, a comedy about a young professional woman named Issa navigating her life As for "Insecure's" second season, which starts July 23, Rae says it picks up right where the first season left off: with Issa's relationship in shambles.

"We're exploring the question: what does it mean to be doing what you're supposed to be doing," she said. "You're supposed to break up; you're supposed to be growing up with your friends; you're supposed to be moving on. So in your 30s, what does it look like when you're doing what you're supposed to be doing?"



As an altar boy as well, Adams recalled, "I liked to serve at funerals because I got out of class for the whole day."

In speaking to others, the tone of speech and sentence structure of words can determine the feedback we receive. Consider this: Words can take on a different meaning based on how they are said. "You better organize that now!"-OR- "It sounds like something that can be looked at closely." Try this.. "I told him ten times not to do that!" OR-"Let's sit down and go over this so that we are on the same page." Life is a learning, experience process. Life is a teacher. Words are conditioning. What we want to have happen is that when anyone says negative, look at it closely and see if it is something which can help us grow. If we are hurried, feel rushed or agitated we may say something which may injure others. Words can be a weapon or a gift.

Words spoken can be harsh, jarring, discordant and taken the wrong way, when in fact you said it, but did not mean it in the way it was said; the receiver heard it and received it based on what they were going through at the time and what they heard. The person may not have meant what was said to be interpreted according to what the person heard. Not everything a person says is going to come off in the way you think it ought to come off. The recipient's interpretation may be miles away from the intended message. It's important in listening not just to hear, but to understand and ask, "Was what was said to me really meant how I interpreted it? Strokes affects nearly 800,000 people ever year! Stroke are the #1 cause of disability in the United States. It also is the 5th leading cause of death among men and the 3rd

among women. you or a loved one suffers from a stroke, people's lives change dramatically. leading cause of death Knowing what a stroke is, what to do when it happens, and how to prevent it can help prepare you for this eventuality.

What is a stroke?

A stroke is when the circulation of blood in your brain is not right, either because a blood clot is blocking a blood vessel or a blood vessel bursts. A blood clot can form when cholesterol or sugar build up in your blood vessels over time. Clots also can form in the heart when it does not beat regularly, namely in a condition called atrial fibrillation. Blood vessels burst usually due to high blood pressure. When a stroke happens, the brain cannot get the oxygen and nutrients it needs to survive. Part of the brain dies and will never grow back. Depending on what part of the brain is affected, people can become paralyzed, numb, cannot speak, or cannot see for the rest of

The first thing that is very important is knowing the signs of a stroke. Time is critical when someone is having a stroke. A stroke is an emergency! Use the F.A.S.T. acronym to help you recognize if you or someone you know is hav-

There are many things that can increase the risk of stroke. Some we can change and some we cannot. Things that we cannot change are age, race,

> family history, gender. and For example, African Americans have been found to have increased risk of stroke compared non-African

Americans, as much as one and a half times the risk compared to Caucasians.

While part of this disparity could be due to genetic makeup, there is a lot that we can do to help lower this high risk of stroke. Hypertension, diabetes, high cholesterol, and depression are examples of stroke risk factors that we can do something about. This is especially true for African Americans, as there is higher prevalence of stroke risk factors among African Americans. Seven out of every ten Black adults have hypertension compared to only five out of every ten White adults. This disparity is greater among African American women in their mid 40s and early 50s. They are almost twice as likely to have hypertension compared to White women of the same age! This disparity is also found in diabetes. The risk of diabetes is one and a half to two times higher in Blacks than

What can you do prevent a stroke?

in Whites.

Take charge of your health by eating a healthy diet that is low in salt, sugar, and fat to reduce your risk of high blood pressure, diabetes, and high cholesterol. High blood pressure generally goes up with age, and this is even more notable among women. Most women over the age of 60 have high blood pressure. If we are able to control high blood pressure, the risk of stroke can be cut by a third! So, know your blood pressure, and follow up closely with your primary care physician. Also, start exercising 30 to 40 minutes a day, five days per week. Stop smoking! Because depression is associated with an increased risk

Effort to prevent food insecurity in low – income households underway in LA county

The Los Angeles County Department of Public Social Services (DPSS) and its community partners have launched activities for the May "CalFresh Awareness Month." This annual public awareness campaign collaboration is to increase access to food assistance for low-income families and individuals in the county.

The month-long effort highlights the critical role that CalFresh, the federally-funded supplemental food benefit, plays in eliminating the threat of "food insecurity," or the lack of reliable access to a sufficient quantity of affordable, nutritious food. The Department of Public Health's (DPH) most recent report on hunger, Rising Food Insecurity in

Los Angeles County, described the problem as a

"major public health issue that has reached crisis proportions" in the county.

Studies suggest that household hunger negatively impacts the intellectual, physical and emotional development of children, placing them at greater risk for obesity, diabetes and other diseases. Many families experiencing food insecurity in Los Angeles County are unaware that they may qualify for Cal-Fresh.

"Hunger is an issue that affects us all. This collaboration represents an intense effort to serve those most vulnerable in the county," said DPSS Director Sheryl L. Spiller. "We all know someone who is experiencing difficulties purchasing food for themselves or their family."

To meet this challenge, DPSS has enlisted the support of DPH, local farmers' markets and food banks, school districts, community

and faith-based organizations and the 88 cities that operate within the county. The pre-campaign planning provides an opportunity for the department and community stakeholders to develop and implement creative strategies to address food insecurity in the county.

Events to publicize the effort will take place at various locations throughout the county, including the May 3rd CalFresh Awareness Month Community Kick-Off Event and Resource Fair at the Hubert Humphrey Comprehensive Health Center in South


Another challenge the collaboration has addressed over the years is the issue of residents not enrolling for CalFresh, due to a misunderstanding that applying will hurt their opportunity to become a permanent U.S. citizen.

Local immigration rights advocates agree that "public charge," a term used to describe an individual who is likely to become primarily dependent on the government for subsistence for either public cash assistance or long-term care at the government's expense, is one of the leading reasons why those in desperate need of food assistance for themselves and their children do not apply. According to the U.S. Citizens and Immigration Services, public charge has been part of immigration law for more than 100 years as grounds for inadmissibility and deportation.


