April Verrett Elected 1st Black President of SEIU

History was made on May 20 with the election of April Verrett as the first Black president of the Service Employees International Union, which represents nearly 2 million workers in health care, property service and government service.

election Verrett's occurred during the opening of the SEIU convention in Philadelphia. She succeeds Mary Kay Henry, who retired after serving as the first woman to head the 103-year-old union.

"I am honored and humbled to step into the pivotal role as SEIU's new president," Verrett wrote of X (formerly Twitter). "Together, "This Union is launching a new era of worker power!"

Labor leaders throughout the Southland applauded Verrett's ascension to the new position. Previously, she served two years as SEIU international secretary-treasurer and as president of SEIU 2015, the nation's largest long-term care union.

"April Verrett's historic election as the first Black Woman to serve as SEIU International President heralds a pivotal moment in leadership, charting a course for progress within the labor movement," declared Yvonne Wheeler. president of the L.A. County Federation of Labor.

"A stalwart for justice, she tirelessly champions improved wages, fair work-

ing conditions, and the dismantling of systemic injustices. Through her leadership, a new era emerges where unions stand as guardians against generational poverty and racial inequality, fostering a more robust democracy and empowered communities,"

Arnulfo De La Cruz, president of SEIU Local 2015, offered similar remarks in a statement celebrating Verret's election. On behalf of caregivers across California, he forcefully stated that Verrett will "lead our union boldly into the future."

"Having worked alongside April here at SEIU 2015, I know she will continue her commitment to building an anti-racist worker organization that will powerfully resist corporate greed and structural racism. April knows that we will never win economic justice without racial justice," De La Cruz said.

"April Verrett's career has been a testament of her commitment to empowering, mobilizing, and uplifting workers. Her leadership

is fueled by the belief that unions are not just a means to secure better wages, benefits, and working conditions, but a powerful platform for advocacy to win all forms of justice-economic, racial, environmental, gender, disability, generational, social, housing," he added.

Charisse Bremond Weaver, president/CEO of the Brotherhood Crusade and a longtime friend of Verrett's, attended the SEIU convention and witnessed the historic election.

Describing the moment as "truly a blessing," Bremond Weaver said, "And to know she will be this year's Brotherhood Crusade Bremond/Bakewell Pioneer of African American Achievement awardee makes her

"We're here today because California allows vou to register to vote if you're 16-years-old," said Weber to an auditorium of youth. "You can pre-register to vote and we will follow you and send you messages along the way to say, 'Hey, don't forget, elections are coming up, don't

forget, you need to vote.""

It was noted, Manual Arts High School is the third high school that was built in the Los Angeles Unified School District and the oldest high school on its original campus in the District. Weber, a former Toiler, graduated from Manual Arts High School in 1966.

Ashanti Blaize-Hopkins Leads Society of Professional Journalists

The first Black woman president of the SPJ says, "We have to be our own superheroes."

Virginia native Ashanti Blaize-Hopkins grew up watching her mother work as a television news anchor, but it never dawned on her her footsteps.

The summer before her fourth year at Columbia University as a sociology major, she received an internship through a women's media nonprofit

that she'd one day follow in that placed her at ABC News. This internship inspired her to pursue her master's in journalism at

the University of Miami. Blaize-Hopkins is an Emmy Award-winning journalist, author, speaker, journalism professor, higher education equity consultant, public relations and marketing expert, and content producer. In September 2023, she became the first Black woman ever elected national president of the Society of Professional Journalists (SPJ).

"I think we are at a time in history where journalists don't have the luxury to just put their heads down and do their work. We have to be our own advocates for journalism. Because if we're not, Superman is not coming. We have to be our own superheroes. Our fight is really the fight to save democracy. I just really want journalists, especially journalists of color, to understand what's at stake at this moment. To understand that advocacy is no longer an option, we have to be advocates for our own industry so that we can save democracy," Blaize-Hopkins said.

After gaining her master's in journalism, Blaize-Hopkins sent out around 150 VHS tapes to TV news stations nationwide until she finally got a call from the Fox station in El Paso, Texas. They interviewed her over the phone for a morning reporter position and she took the job sight unseen.

"When I was in Dallas, I was a weekend evening anchor and reporter at the NBC station in Dallas, Fort Worth. At a certain point, I decided that I didn't want to be in the business anymore. I had made a promise to myself that the day that I went to work feeling bitter was the day that I needed to find something else to do,"

Blaize-Hopkins said. "I was starting to feel that, and I said, 'Okay, I think I need to transition out,' so I ended up adjunct teaching at Richland College in Dallas and then starting my own PR firm and video production company with a business partner."

Bradford Announces Run for Lieutenant Governor

California State Sen. Steven Bradford (D-Ingle-wood), 64, says the "time is right" and he is "up to the challenge" of becoming the next Lieutenant Governor of California.

Bradford, who serves as the vice chair of the California Legislative Black Caucus (CLBC), announced his bid for the second highest office in the state on April 22. The election will be held in 2026

"I think it's time we need someone in that office who is committed to doing the work. It's not a glamorous job. It's an inthe-weeds job but it's a job that impacts us every day," Bradford told California Black Media (CBM).

"I want to do the work that is in front of me," said Bradford, who has served in the Legislature for 15 years as an Assemblymember and State Senator and will be term out at the end of this year.

"That's what my career has been about: doing the work of the position I've been elected to do." In the Legislature, Bradford represents Senate District 35. It is home to nearly one million residents, and it includes the communities of Inglewood, Compton, Gardena, Torrance, Carson, Harbor Gateway, San Pedro, Hawthorne, and Lawndale in Los Angeles County.

Under California's Constitution, the Lieutenant Governor serves as Acting Governor whenever the Governor is absent from the state, and automatically becomes Governor if a vacancy occurs. The Lieutenant Governor is the President of the California Senate and votes in case of a tie. Currently, Eleni Kounalakis is the Lieutenant Governor.

However, her term in office is set to expire in 2026 due to term limits.

California State Treasurer Fiona Ma has also declared her candidacy for the Lieutenant Governor's office and has launched her campaign.

Bradford told CBM that he intends to visit every corner of the state to make the case that he is the person for the job.

"I have two years to


touch all 58 counties. It's not going to be an easy task, but I am up for it," Bradford said. "We have to let the people know what I've done and what I plan to do as Lt. Governor. I am excited about the opportunity."

Bradford said he is following in the footsteps of Mervyn M. Dymally, his mentor. Dymally was a trailblazing federal and state elected official representing Southern California. In 1974, Dymally made history by becoming California's first Black Lieutenant Governor.

A member of the Democratic party and the CLBC, Dymally served in the U.S. House of Representatives and both houses of the State Legislature. He passed away in October 2021 at the age of 86.

"More importantly, that's why I am running," Bradford said of Dymally. "I want the challenge and I want to pay homage to the individual who got me involved in politics — that's the state's first and only African American Lt. Governor, Mervyn Dymally," Bradford said.

Over the years, Brad-

ford has championed legislation aimed at addressing racial disparities and advocated for justice in housing and property rights, police reform, as well as making the case for reparations for the descendants of enslaved Black Americans.

In 2021, Gov. Gavin Newsom signed Senate Bill (SB) 796 authored by Bradford. It authorized the County of Los Angeles to return the beachfront property known as Bruce's Beach to the family of the African American couple Willa and Charles Bruce, who purchased the Manhattan Beach site in 1912. However, the property was

confiscated in the late

1920s through eminent domain.

Newsom also signed Bradford's SB 2 into law. Also known as the Kenneth Ross Jr. Police Decertification Act of 2021, SB 2 was designed to increase law enforcement's accountability that corrodes public respect and enforcement officers who commit serious misconduct

and illegally violate a

person's civil rights.

SB 2 created a statewide decertification system to withdraw the certification of a peace officer in California following the conviction of serious crimes or termination from employment due to misconduct.

Bradford served two years on the first-in-thenation Task Force to Study and Develop Reparation Proposals for African Americans.

Bradford and eight other members of the task force analyzed the institution of slavery and its continuous effects on the Black Americans.

Another bill Bradford authored, SB 1403 (formerly SB 490), proposes

the establishment of a new state agency called the California American Freedman Affairs Agency (CAFAA). The agency, a direct recommendation of the reparations task force, would be responsible for setting up the infrastructure required to manage reparations activities as directed by the Legislature and Governor.

On May 16, the Senate Appropriations Committee voted 5-2 to approve the SB 1403. It now moves to the Senate Floor for a consideration.

"Our state is experienc-

ing a significant economic downturn. People across California are struggling. Housing costs are out of reach, homelessness is at crisis levels, the global threat of climate change, underfunded schools, and debt-inducing higher education costs," Bradford said in an April 15 statement announcing his candidacy for lieutenant governor. "While California has led the nation on enacting smart, forward-thinking policies, the reality is that we must do more to solve our many challenges."

Bank of America Report Outlook Is Positive Among **Certain Business Owners**

The recent report shows small and mid-size businesses anticipate better times ahead.

The economy currently has many in a quandary, but it seems light is starting to gleam for business owners. According to the 2024 Bank of America Business Owner Report, which was conducted in partnership with Bank of America Institute, small and midsize business owners have a more optimistic outlook on their future.

"The majority of what our business report found, the majority of our businesses expect revenue growth and owners say recession worries have resided, but that outlook did seem to vary by the size of the company," said Gwendolyn Givens-Jones, a senior vice president and senior relationship manager of Bank of America here in Los Angeles.

"So, when you look, mid-size companies were very confident on growth, hiring, revenues, they were very optimistic, while smaller sized companies reported taking more of a cautious approach for the remainder of the year."

Although business owners remain mindful of inflation and interest rates, according to the report,

their concerns have lessened since Spring 2023. The 2024 Bank of America Business Owner Report includes input from more than 1,400 small and mid- Executive sized business owners Council help provide busi-(defined as businesses ness owners with education with \$100,000 to \$5 mil- through seminars and lion and \$5 million to \$50 million in annual revenues, respectively). The report explores the viewpoints, goals, concerns and outlooks of business owners nationwide.

Givens-Jones has been with Bank of America 44 years as a relationship manager and in business banking for 18 years. The businesses Givens-Jones works with have generated a revenue stream from \$5

to \$15,000,000. She spoke about what the survey had to say and how Bank of America helps small and BIPOC businesses of color.

"I'm thinking, in working with our business clients here in L.A., there's a few reasons for this confidence," said Givens-Jones. "I think coming out of the pandemic, businesses are more resilient now."

She continued, "The economy is so vibrant and it's stronger here with incredible resources like GLAAACC [Greater Los Angeles Chamber of Commerce].

"We have the Black Executive Leadership

Council, which is made-up of a variety of businesses."

Bank of America working with organizations like GLAAACC and the Black Leadership more, which will help them grow their businesses.

"I have spent over 30 years championing for small businesses, many of whom face significant barriers to growth and scale," said GLAAACC Chairman Gene Hale. "Despite recent disruptions, my outlook on small businesses remains positive."

He continued, "A recent federal report found that even though the number of firms they own has grown by 35%, the average gross receipts for those firms dropped by 16%.

"Forty percent of all small businesses failed during the pandemic, and banks would only lend to well-established existing clients, leaving many unable to qualify for PPP funds due to a lack of generational wealth to bridge the gap.

"Since George Floyd's death, many companies have either downsized or their DEI eliminated offices."

"We adopt what we call our own 90/10 rule which is 90% of all the brands that we carry, beauty and wellness brands that we carry, are created by Black and Brown founders from around the globe, who create beauty products for everyone and 10% are dedicated to fostering allyship," said Thirteen Lune co-owner, Nyakio Grieco.

Thirteen Lune was founded in December of 2020 and has performed

well in spite of the pan-

"We have grown exponentially over the course of the last three years," said Grieco. "In our first year of business, we did a million \$15 million in revenue and in our third year of business, we did \$25 million in revenue and expect to go

up about 15% this year." Thirteen Lume is looking to make more hires as well as expand their business and brands. Grieco stated she personally feels optimistic in going forward as Black, female entrepreneurs are a growing segment in the United States.



Bryant, who is chair of the Mamba and Mambacita Sports Foundation, thanked the L.A. Housing Authority and the community of Nickerson Gardens for being supportive during the project. She shared a few words about what the gym and court renovations mean to her.

"The site is a special location for my family," said Bryant. "[Kobe] used basketball to teach life lessons to young boys and girls."

Bryant continued, "It serves as a reminder to all the boys and girls who play here—they are supported and loved.

"I also want to thank Brian Peterson for this "This is so fantastic, I am remarkable mural."

Peterson, who is originally from Miami, Florida, shared he was a big fan of Kobe and how this was him living out his 14-year-old dream. Thanking God for this opportunity, he talked about how doing murals is a spiritual experience for him and the inspiration behind the murals in the gym or as he calls it, a "Court-thedral".

"I consider this worship, this is the way I worship, I worship with a spray can," said Peterson.

"The moment I walked through those two doors, I had this overwhelming sense that the architecture of this space felt like a cathedral.

"Anyone on the planet can walk into a cathedral, and in that moment, feel reverence, a seriousness, a respect.

"We wanted people, we wanted kids, we wanted community members, to walk through those doors

and feel the same thing." Nickerson Gardens, which is managed by the Housing Authority of Los Angeles, was chosen for the refurbishment by Bryant and the Lakers as it is the former location of the Boys and Girls Club, where Kobe Bryant hosted his youth basketball program, "Mamba League," which designed to empower girls and boys on the court and in life. The Lakers were also inspired by the local community support from Top Dawg Entertainment.

"It feels really special, I've been coming to Nickerson Gardens for a long time," said Guthrie. "This gym is a heart and soul of the community; it means a lot for a lot of different reasons."

Guthrie continued, "To see the spectacular work that they've done out here, it really is special, it's something



Sentinel with an exclusive conversation on her background, inspirations, and intentions as a 26-year-old Black artist from Los Angeles, CA.

Peyton hails from a household where creativity was cultivated. Her father is an architect and painter, and Peyton acknowledged, "My dad taught me how to draw what I saw and express what I felt." Being that truth and introspection are values riddled throughout her collections, learning to put her heart and mind onto the can-

Despite an application with week's worth of blood, sweat, and tears, Peyton was not accepted into Marist College's (in Poughkeepsie, NY) fashion department, one of the top 10 collegiate fashion programs in America. However, she was admitted to the college as an undecided major.

Peyton believes it was

her rather immediate and astronomical growth as a fine artist, surpassing her own expectations after countless all-nighters and early mornings fine-tuning her craft. She ultimately graduated with a major in Fine Art and a double minor in business and fashion design, even creating her first clothing collection under her company, The Code Studios upon graduation in Spring 2020.

Since then, Peyton has been on path to mastery and refuses to slow her progress. In 2023, Peyton invested into her own solo exhibit and was soon invited to showcase her work in New York City, Atlanta, Miami's Art Basel, Athens, and Tokyo. She also won Best New Artist at the Beverly Hills Art Show (2023), collaborated with Ralph Lauren on a solo exhibition (2024, and received honors from Compton and the Republic of Chad in Africa.

One of Peyton's greatest inspirations is travel. Having been to over 30 countries, Peyton said, "When I travel out of the country, it ignites a peaceful flame in my heart."

karat Venetian gold foil has become a quintessential material included in her pieces. To this day, Peyton orders both her Venetian gold foil and natural pigments from the same small businesses she supported while living in Venice.

Although traveling is an inspiration that fuels her art, Peyton knows God is her source. "I have so much respect for the God that I believe in and serve. I fast when I paint, I'm so zoned in and locked into what I'm doing and nothing else can distract me. I believe that God uses that focus and discipline to speak to me because He has my atten-

tion. So I know for a fact that it oozes from me and speaks to people through my artwork."

"I want to lead people back to God and themselves when they look at my artwork. I want them to ask the hard questions they've been avoiding."

Firmly believing that it's the artist's duty to create, Peyton urges, "Even if you don't feel confident in yourself and your craft, God is confident in you."

Hyyer Creative is a Black-owned, L.A.-based creative agency that generates, strategizes, and executes the ideas of their

clients. Malachi Fuller (executive producer, head of Production) and Nëither (executive producer, head of Creative) co-founded the company in July 2018 to provide a working solution to an industry-wide imbalance between impactful storytelling and cultural relevance. Their vision and purpose with Hyyer Creative is to "work with creative entrepreneurs, brands, and businesses across various industries to reach and amplify the voices of BIPOC communities through storytelling."

It's clear that Malachi and Nëither filled voids

within the marketing and advertising industries: nearing the company's sixth anniversary, they have already worked on over 600 projects with clients including ESPN, HBO MAX, Essence, Warner Music Group, Sephora, Spotify, and Disney. With such vast offerings and clientele, the question becomes: what does Hyyer Creative do?

The short answer? Ideation, strategy, and production.

The long answer can be provided by a real-life example. When global entertainment company Live Nation hired Hyyer Creative to create a compelling five-minute documentary on Wu-Tang's, Nas', and Busta Rhymes' New York State of Mind Tour, Malachi and Nëither strategized three main components.

Malachi and Nëither acknowledge their profound success has largely been the result of their compatibility as business partners.

"[Nëither] is the creative, the right side of the brain...and I'm the more logistical, left side of the brain," Malachi opined.

Nëither quickly agreed and added, "It helps because we don't have to go through this alone. I know at the end of the day I have somebody I can depend on...we complement each other. Business brain, creative brain...but that's not to say either one of us is solely stuck...but we play to our strengths."

As two men from the DMV area, they boast an "east coast hustle with a west coast demeanor." Malachi and Nëither are no stranger to the road less traveled: from majors in Criminal Justice and Applied Physics/Civil Engineering (respectively), both men pivoted toward the entertainment industry and leapt into the daring life of an entrepreneur.

They carried this east coast grit west, and it has saved their company during numerous obstacles, including the pandemic and competition from larger companies with similar offerings.

To date, Malachi and Nëither hold team meetings to ensure their business is growing in alignment with their vision, making enhancements as they see fit: in 2022, they opened Hyyer Studios, a multidisciplinary content studio in Downtown Los Angeles.

Now a creative agency with a physical space for photography, videography, and events, they are able to bring to fruition their vision to help others "achieve, fulfill, find, and understand their own purpose." By hosting weekly events, these founders continue to facilitate opportunities for people to connect and create in a BIPOC-centric space.

The success of Hyyer Creative places Malachi and Nëither in the fortunate position to expand their horizons. Looking forward and creating new visions requires looking back and reflecting,

and each founder remembers the impact that culturally relevant storytelling had on them as young men.

It has aided the team in solidifying and executing the overarching vision for Hyyer Creative: "to have a positive impact on the next generation of creators."



Columbia, Morehouse and the Morality of Resistance: Continuing Struggle, Keeping Faith and Holding the Line

It is good and right to rebel and revolt against unfreedom and morally imperative to resist evil, injustice and oppression wherever we find it, in this country and around the world. And it is good to know our past and honor it; to engage the present and improve it; and to imagine a whole new future and forge it in the most ethical, effective and expansive ways.

We are a world encompassing people and take seriously the teachings of our honored foremother, Nana Dr. Mary McLeod Bethune, who told us that in the interest of African and human good and the well-being of the world, "We must remake the world. The task is nothing less than that."

The students of all ethnicities with Palestinians at the center who righteously rage and resist across the stage of human history in this powerful and pivotal moment in support of Palestinian and human lives, freedom and justice at Columbia and more than 60 other universities and colleges, honor a shared history, rightfully resist the present state of things and fight for a future of shared good for all the peoples of the world. It is a history of campus and community linked struggles we, as a people, know well and we honor it by continuing the struggle, keeping the faith and holding the line.

We, as African people, know this history of resistance to the hell and horror of genocide well, the holocausts and genocides in Native America, Africa, Australia, and elsewhere. And we know how it was and continues to be carried out in the name of false gods and fictitious claims of civilization, society, and the problematic concept of progress all deeply rooted in racism, colonialism, capitalism and the will and wish of White supremacy in various forms on a global scale.

We remember that during the height of the Black Freedom Movement, we stood up in righteous and the police on them, to pum-

relentless struggle in community and on campus and in the larger society to rightfully expose and radically alter the established order. It meant building unity and sustaining alliances and resisting the university as the brain of an oppressive society, its collaborator and consigliere. It involved struggling to shut it down until essential concessions and changes were made.

Today, as then, the students know genocidal war and its immoral justification or deceptive denial when they see it. And they can smell the combined rancid and reeking odor of murder-covering mendacity and mass murder and refuse to accept or collaborate. Indeed, they have raised up and rallied, demonstrated, occupied buildings and grounds, and set up encampments of resistance across the country and the world, expressing righteous anger and opposition against Israel's genocidal campaign against the Palestinian People in Gaza and the West Bank Palestine.

Moreover, they have called for and demanded an immediate and permanent ceasefire to end the genocide; disclosure and divestment by their universities and schools from companies linked to and complicit in the genocide and brutal occupation of Palestine; full resumption of humanitarian aid; and a free, self-determining, sovereign and secure Palestine.

Now their universities,

colleges and schools have declared the students deceived, misdirected and delinquent, and are denouncing the freedom of thought, speech and assembly; and ethical agency they once taught were at the center of education and enlightenment of being human and rightfully sensitive and responsive to human suffering and savagery against others. Indeed, these highly rated and raved-about educational institutions have called

mel, pound and arrest them, to teach them the hidden and hard lessons of a hypocritical society and educational system.

It is a society masquerading as an open society and democracy, a democracy which, Haji Malcolm taught, is "nothing but disguised hypocrisy." Also, they have dragged presidents and principals to congressional hearings held by unlearned, unleashed and hypocritical inquisitors neck-and-knee deep in sleazy pretentious and selfserving posturing.

They have expelled, doxxed, and blacklisted to disrupt and destroy their opportunities and aspirations for jobs and careers. But the students refuse to bow or back down, leaving less-than-brave administrators and posturing and pandering politicians to wait and impiously pray for semester's end and summer break

The students also know

and the world knows enough history to realize that the war in Gaza, Palestine and against the Palestinian people did not begin on Oct. 7, 2023, but started in 1948. It has gone on unabated in various sinister and massively destructive ways ever since, including: occupation, siege, starvation, death-dealing denial of water, destruction of infrastructure, apartheid and genocide. And the students know the difference between self-defense and genocidal savagery.

Likewise, they reject the false right to rule, ruin and take the lives, land, property and freedom and future of others with false racist and religious claims. And they will not accept, in silence, the cold-blooded mass murder of children, women, men, the elderly, ill, infirm, and even the unborn in hospitals, homes, religious sanctuaries, universities, schools, heritage sites, and with no place exempt with the military amorality of artificial intelligence by an artificial humanity that programs it and sends it on its genocidal path throughout Palestine.

In the midst of active support of Israel's genocidal war and with a self-medicating and disorienting dose of Orwellian double-speak, dishonesty, forked tongue and bad faith, Joe Biden went to Morehouse, claiming a less whitish, wanton

and wicked image and interest than the moral tragedy called Trump, and hoping to repair his image and hide his real interest among Black people. He was seeking a sign of support and perhaps some reflected minimal moral status among a people with many of their members being known to be exceptionally forgiving, setting aside atrocities inflicted on them, and giving comforting hugs to the fallen and forlorn.

So, there were calls for him not to come to give a commencement speech or be awarded an honorary degree. For there was concern that his complicity in genocide against the Palestinian people would not only dishonor the African American ethical tradition of concern for the vulnerable and freedom and justice in the world, but also that he would use the occasion as just another campaign platform, seeking undeserved sanctuary and support.

Indeed, they referenced Morehouse's most famous alumnus, Nana Dr. Martin Luther King, and his teachings and stance on the war against the Vietnamese people. All agreed Biden's presence would be problematic, but a consensus to reject him actively and openly could not be achieved. Thus, those committed to using Dr. King as a moral resource rather than a mere reference decided to resist in various other ways for

equally various reasons.

They wrote open letters and published position statements condemning Israel's genocide against the Palestinian people and calling for an immediate and permanent ceasefire; refused to stand to welcome or honor Biden; did not clap; wore the Palestinian flag and keffiyeh, a symbol of solidarity and resistance; raised the flag of Congo, another site of colonial legacy and plunder; turned their backs, raised a resistance fist, and walked out when the vulgarly hypocritical performance began.

This reflects the unbreakable will to resist in any and every way possible, regardless of restraints and restrictions. For only in righteous and relentless resistance can we open the way for the making and emergence of a new world of shared freedom, justice and other dignity-affirming, life-enhancing and worldpreserving good.

Support Early Detection Technology to Save the Lives of Black Cancer Patients

In 2008, I received news no one ever wants to hear. I was diagnosed with Stage I breast cancer, with an ER/PR positive tumor type.

The road to recovery was tough, taking more than a physical toll on my body. I grappled with the emotional and mental strain of navigating a health care system that too often fails to address the unique needs of Black women. There was no manual to guide me through this journey, no prescription to ease the burden, and no roadmap to help me navigate the challenges ahead.

The stark reality that Black women are 41% more likely to die from breast cancer than White women is a grim reminder of the systemic inequities that pervade our health care system. According to the American Cancer Society, Black Americans have the highest death rate and shortest survival rate of any racial or ethnic group in the country. This disparity extends beyond breast cancer, impacting colorectal, prostate, and lung cancers, among others.

To help overcome these inequities, we need to attack cancer at its roots; we must catch it early, and we must ensure the means to catch cancer early are accessible to the communities most at risk. I consider myself fortunate to have received a Stage 1 diagnosis. Yet, it pains me to know that for many others, their breast cancer is often detected in later, more advanced stages. It is a sobering reality – one that underscores the need for action.

Fortunately, there is hope on the horizon. Some California congressmembers -- particularly U.S. Rep. Raul Ruiz (D-CA-25) -- are taking decisive action. Ruiz is a lead sponsor of a bill to dramatically expand access to cutting-edge early detection tools for Medicare beneficiaries, including millions of Black Americans in underserved communities. With bipartisan support from a strong majority of his colleagues in Congress, as



well as many of our state's representatives, this bill is closer than ever to passage.

Named in honor of Nancy Gardner Sewell, a civil rights leader and passionate advocate for health justice, the Nancy Gardner Sewell Medicare Multi-Cancer Early Detection Screening Coverage Act would ensure Medicare has the latitude it needs to cover an exciting new class of cancer detection tests as soon as they're cleared by the FDA.

These tests utilize the latest scientific achievements to identify cancer signals in a patient's blood stream. They can pinpoint many different types of cancer from a single blood draw, dramatically improving doctors' ability to detect cancers early and at stages where they are most treat-

The importance of early detection in improving cancer outcomes cannot be understated, especially for African Americans, who often face later stage diagnoses and poorer prognoses.

A recent study estimates that preventive cancer screenings in the past 25 years have given Americans at least 12 million more years of life, translating to a remarkable \$6.5 trillion saved in health care costs. Too many cases are diagnosed after the cancer has spread and treatments, no matter how advanced, are less effective. And even for those forms of the disease, like breast cancer, for which there are screenings, patients can remain asymptomatic until the cancer has metastasized.

That's why MCED tests are such a game changer, especially when it comes to cancers we currently can't

Any health care provider that can draw blood already has the tools to administer an MCED test. One of the largest obstacles to the widespread adoption of these tests isn't technical - it's the fact that Medicare has no pathway to cover new cancer screenings like MCED in a timely manner, even though people over the age of 65 are at the greatest risk of developing cancer. Without the possibility of Medicare coverage, MCED tests won't be available for


the underserved and older adults who would benefit the most.

The next phase of our fight against cancer - and the disproportionate toll it takes on Black Americans starts by urging Congress to pass the Nancy Gardner Sewell Medicare Multi-Cancer Early Detection Screening Coverage Act and ensuring the benefits of this legislation reach all corners of our communities.

I don't advocate for change for myself, but for every Black woman who has faced, or will face, a similar battle. Please heed my words – for yourself and your health. Ask for the necessary tests or screenings. If you're unsatisfied with their response, don't hesitate to seek a second opinion. We've got the power to take control of our health.

Together, we can rewrite the narrative of health care, catch and treat cancer early, and ensure that every woman has the opportunity to thrive, regardless of her race or background.

But, whether you're going swimming, grilling, hiking, camping, road tripping or boating, it's always prudent to keep safety at the top of your mind as you venture out this weekend.

Dr. Branden Turner, a family practice physician with Kaiser Permanente Baldwin Hills-Crenshaw, offers some simple advice on how to enjoy the long weekend without jeopar-



Day weekend to protect your health and safety.

dizing your health.

"One of the most important things to remember is to stay hydrated while you're out in the sun," Dr. Turner said.

'The risk of heat stress can come on unex-

pectedly and, if not realized, can turn into a heat stroke pretty quickly." Dr. Turner urges you to pay attention to your body for signs of heat exhaustion.

"If you experience lightheadedheadaches,

ness, nausea, confusion, irritability or an upset stomach, try to cool off, get out of the sun, drink more water, and if you're not improving, please seek medical attention," he said.

If you're planning a day at the beach or being part of other outdoor activities such as sports, Dr. Turner encourages you to take the following precautions:

Bring all of the necessities for the day in the sun — plenty of water, sunscreen, a hat and maybe even a hand-held fan if it is hot outside.

Take breaks in a cool, shady place instead of spending all of your time in

If you're going swimming, keep an eye on your kids and avoid distractions

like texting, reading or socializing.

If you're on a beach or pool, make sure there's a lifeguard on duty or designate someone to keep an

If you or your children aren't the best swimmers, there's no shame in that; wear those life vests or floaties (for the kids).

If you'll be drinking alcohol, although it may feel like you're hydrating, it actually does the opposite, so drink in moderation and make sure you're balancing it with plenty of water intake too.

If you love hiking, consider avoiding hiking during the hottest time of the day (noon to 3 p.m.) and instead, get an early start.

Wear light colors that

reflect the sun's rays rather than absorb them by dark colored clothes.

Wear sturdy shoesplease don't go barefoot or

with flip flops. Wearing hats or bandana that can be dunked in water to cool your head and neck are also great accessories to the hiking wardrobe.

And although rare, snakes do exist on our hiking trails in Los Angeles, so keep an eye out for them, especially rattle snakes, Dr. Turner said. Carry a little backpack to hold your cellphone in case of an emergency like that unexpected bite, and of course, for that hydration.

"Enjoy Memorial Day weekend and avoid a trip to the emergency room," said Dr. Turner.







One man's realization of building a bigger boat to serve others is captured by South LA Recap — a digital documentary project dedicated to unraveling the immense history, secrets and stories of South Los Angeles.

The legendary man who left an indelible mark worldwide is Apostle Frederick K.C. Price, Founder of Crenshaw Christian Center (CCC) and Ever-Increasing Faith Ministries. To understand the origin of the FaithDome, one must get to know the man behind its existence.

The 52-minute documentary commanded more than 30,000 views within three days of its May 10th release. It is an intimate and very transparent look

Price, and daughter and CCC President and CEO, Mrs. Angela Evans.

Their comments are straightforward and an honest look back, through and inward as a resetting for the ministry's next iteration.

Its campus includes a thriving nursery and K-12 school, with a solid track record of 100% graduation and 100% college acceptance. With a robust alumnus of over 10,000, whip

smart and skilled changemakers are shaping a vibrant world in all sectors of society.

When asked why the story of the FaithDome

should be told, South LA Recap creator, Eric Craig, offered heartfelt thoughts, "Just before I started this documentary, I hit a lull, and didn't know what I'd

like to explore for my next project. I remember talking with my mom one day about The Recap, and she told me something that sparked this whole journey."

She said, "You know, I remember I would take your grandmother to the FaithDome for Sunday Service, and she would walk on the campus and look at the manicured lot, the buildings, and the larger-than-life FaithDome in amazement saying, 'A Black man did all of this?' "That imagery of think-

ing about my grandmother who came to Los Angeles by train via Shreveport, and seeing what was possible on the West Coast for Black people was incredible. That struck a chord with the Recap. And it struck a chord with me."

Craig asserts extensive

search for this work, which spanned just over seven months, he got a glimpse of why so many other people are moved by the story. Crenshaw Christian Center, which is now 50 years old, "has members who can recount its past in their own personal memories, thinking about their own contributions that made it

happen," Craig states.

He continues, "There is much admiration for Apostle Frederick K.C. Price. He touched many lives. He guided many people who needed it. He introduced God's Word in a way that no one else had. And his legacy of service through ministry is forever intertwined with the Faith-Dome. And the Dome is a standing example of what has been possible in South Los Angeles."



"A Lady Sings a Song – Amber Weekes Celebrates Nancy Wilson" is a Southern California vocalist's homage to the international singing sensation. Weekes is set to perform her tribute to Wilson on June 6, at the Catalina Jazz Club on Sunset Boulevard.

Weekes said she was born into showbiz. Both of her parents are New Yorkers who grew up in Harlem. Her grandparents owned a diner in Harlem called Weekes' Luncheonette that regularly attracted prominent Black entertainers of the period.

She said her teenaged father served fried egg sandwiches to jazz great Duke Ellington who lived around the corner.

Other musical greats including, Count Basie, Billy Strayhorn, Diahann Carroll, along with young actors Sidney Poitier and Harry Belafonte were also regular patrons of the restaurant.

"We were also around jazz musicians as children," Weekes said. "My sister and I were used to hearing live jazz in the house."

Nancy Wilson was one of Weekes and her sibling's favorite artists, and at the urgings of her mother, they would sing along to Wilson's recordings at home using the coffee table as their stage.

Weekes' playtime performances are in part the inspiration for her Nancy Wilson tribute. She also said her parents' friendship with Wilson's road manag-

er, Sparky Tavares, was another. She added, "And so we

had her recordings, so there's that." Weekes recalled being

encouraged to sing from a young age by family friends and that love of singing is still with her today. "It was something I was always going to do. I don't know if there was ever a question that I wouldn't," said Weekes.

Today, Weekes is perhaps best known for performing live on stage throughout SoCal venues, and her music discography includes the albums "Round Midnight" and "Pure Imagination" She

self-produced "Imagination" under her Amber Inn Productions label.

Weekes describes her vocal stylings as "honeydipped cashmere with a drop of sorrel." She explained, "I've never been a belter. I appreciate those who do that and can do that. I've always gravitated towards the singers who are more lyrical and who are invested in telling the story."

Weekes puts Wilson into the latter category because of her classiness, elegance, her ability to engage with the audience in a personal way, and all while wearing beautiful dresses

"She [Wilson] would almost whisper in the way that she spoke," said Weekes. "She had a great way of firmly placing her tongue inside of her cheek. Oh, she's going to be elegant about it, but she's going to have a sense of humor about certain things."

Weekes noted Wilson's song "Ten Good Years" as an example of Wilson's great wit on her "Live at the Coconut Grove" album.

She said to her knowledge, she is the only person to record that song since Wilson. "I always loved the song because she sings it straight, but the lyrics are hysterical," said Weekes.

Angela White (formerly 'Blac Chyna') Talks Mental Health at I Love Myself Festival

Actress, model and media personality Angela White, previously known as "Blac Chyna," was a special guest at the 2nd Annual I Love Myself Festival on May 18. She attended the event with her son, King, and daughter, Dream.

The festival is a lifechanging exhibition put on by the Los Angeles Department of Mental Health and Project Pit. The goal of I Love Myself is to bring attention to psychological wellness, especially in the Black community.

Project Pit is a partnership platform that brings together artists, brands, and organizations to deliver socially impactful public events.

Along with the live-stage entertainment, personalities, and vendors, the festival also provides mental health resources. There is a consismessage throughout the event that it is okay to use them.

In addition to White's attendance, special guest performers included singers Omarion and Mario.

White gained worldwide fame in the unscripted series "Keeping Up With the Kardashians" and its spinoff show "Rob and Chyna," with her then partner Rob Kardashian.

White believes it takes a

strong personality to be in a reality series, but more importantly she feels it takes the mindset of an entertainer to succeed in one.

Two years ago, she separated her "Chyna" persona from her real life. It was a therapeutic process she began after reversing several cosmetic enhancements.

"I'm just focusing on Angela," said White. "Blac Chyna the brand – she got me through the door. Thanks

girl. Angela's here." White, who also stars in the BET drama series "The Black Hamptons," said events like the I Love Myself Festival is a safe space where Black people can come together and not feel isolated when it comes to navigating their psychological well-being.

"To see all these people,

and the love, and the food, and people dancing, and good music - it feels good," said White. "It does something to the soul."

Although Black people have similar or lower rates of common mental disorders than whites, according to a 2019 Health Services Research report, their mental disorders are more severe, persistent, and disabling.

Persons of African descent are also less likely to utilize psychiatric services, and if they receive care, it is usually of lower quality than the care provided to whites. Consequently, the unmet need for mental health care is greater among Blacks than whites.

White thinks the tendency for Black people to avoid mental health care stems from seeing it as a sign of weakness that elicits shame and apprehension.

"A lot of times we don't want to admit, 'Hey, I'm going through this or I'm kind of off today," said White. "Everybody wants to make it seem as though everything is good. And it's okay to have those bad days and recognize it, so it doesn't build up even more."

She said one of her favorite ways to decompress from a bad day is a nap because it gives her a moment to step away from her problems, so that she can return to them later with a clearer mind.

And when it comes to supporting friends and family during mental crises, White said actively listening to them express their concerns is key.

"If somebody comes to you and says, 'Hey, this is what I'm going through,' just listen. A lot of times people want to say, 'Well,

you're going through this, well I'm going through this, too," said White.

She continued, "Now, I feel [emptier than] before I came to you - I should have just kept my comments to myself. I feel like people should have that open space for the next person that's spilling their most intimate details and things that are going on in their life."

White said then a concern can develop that their confidante may use their personal secrets against them. Unfortunately, sometimes these types of dramas can play out on social media.

With a strong following across many online platforms, White has learned that whenever she sends out negativity on social media,

she receives it back in return. "So, when I was putting out negative stuff," she explained, "of course I'm going to have negative comments. Of course, I'm going to get backlash. Of course, anything I do - if I blink, anybody is going to hate it, because that's the energy that I'm putting out."

Today, White concentrates on putting out good energy, not only on social media but also in her personal life. "People will see that, and that's the kind of energy I'm getting back," said White.

White said she is presently concentrating her attention on working more as an actress, the happiness of her children and family, her own health and fitness, and first and foremost, getting closer to God.


