Karen Bass Still In Hunt To Make History

The Los Angeles mayor's race remains undecided as of Los Angeles Sentinel press time. After a grueling campaign weekend with the Bass Bus Tour cruising every part of the Los Angeles and the mayoral candidate pressing hands with excited electorate, Tuesday came down to voter turnout.

When initial numbers came out at around 9 p.m., Bass held a slim lead over Caruso only to fall slightly behind him minutes later when new numbers Currently, were posted. Caruso leads Bass 51.25% to 48.75%, but the Bass campaign remains hopeful and positive.

This positivity comes on the heels of the primary election in June where Caruso came out early with about a 5% lead, but the Bass campaign surged back to ultimately win the election by over 7%.

At a campaign celebration held at the Hollywood Palladium, Karen Bass addressed the audience and remained totally optimistic, telling everyone that, "We are going to win this race," and stressing the greatness

Moore Elected Maryland's First Black Governor, Campbell Wins as Massachusetts AG

Democrat Wes Moore was elected Maryland's first Black governor Tuesday, Nov. 8, defeating Republican Dan Cox in a state where Democrats outnumber Republicans

Moore's victory flips a governor's office from Republican to Democratic. Of the 36 governor's races this year, Maryland and Massachusetts represented the best chances for Democrats to regain a governor's office at a time when the GOP holds a 28-



LA Civil Rights Dept. Launches **Discrimination Enforcement Division**

The city's Civil + Human Rights and Equity Department (LA Civil Rights) officially launched its discrimination enforcement division, allowing for city enforcement of civil rights law on Tuesday, Nov.1.

In a press conference with Mayor Eric Garcetti, Council President Paul Krekorian, and Council President Pro Tempore Curren Price, LA Civil Rights announced its authority to investigate alleged discriminatory practices in the private sector areas of commerce, education, employment and housing and enforce the city's Civil and Human Rights Law.

"Today we're doubling down on our work to build an L.A. that is more equal, more fair, and more just," said Mayor Eric Garcetti. "We're creating a place where Angelenos who have faced discrimination can seek justice — and affirming that we will always stand up for each other and put our values at the center of everything we do in this City of Angels."

"Now, more than ever, at a time when our city and our nation have suffered such pain from the actions of some to divide us, Los Angeles is proud to ensure that civil rights for all are protected. Those who have suffered from discrimination in employment or in housing, in business or in commerce, should know that the City of Los Angeles stands

"The establishment of a Discrimination Enforcement Division is vet another reminder that Los Angeles is the epicenter of equity and opportunity and there's no place for discrimination here," said Councilmember Curren Price.

LA Civil Rights can investigate discrimination against protected classes that occurred in the City of Los Angeles, within three years of a complaint being filed. After a complaint intake form is filed and an initial assessment is conducted, special investigators

other corrective actions may be implemented. All available tools, including subpoenas, will be implemented to the maximum extent possible by the City's Human Rights law. LA Civil Rights will offer outside mediation services, provided by Pepperdine University. Complaints can be filed online or via telephone at (213) 978-

The establishment of the Civil and Human Rights Law and discrimination enforcement authority is the result of a multi-year effort led by the Los Angeles Black Worker Center, Instituto de Educación Popular del Sur de California (IDEP-SCA), UCLA Labor Center and others in a multiracial coalition of workers and community organizers.

"For many years now, Black Angelenos have raised concerns about the lack of equity and opportunity at work. The LA Black Worker Center, in coalition with other marginalized workers, helped lead the fight for local enforcement of civil rights law. This is an important step forward, and I'm eager for Black workers and other marginalized workers to feel the effects of this program in their day-today lives.

Many of these organizations joined Garcetti, Krekorian and Maddox for the Employment Opportunity Commission (EEOC), the department's Commission on Civil Rights, civil rights activists and others.

State law controls the enforcement of housing and employment violations for certain protected classes, under the California Fair Employment and Housing Act (FEHA). In areas where it lacks jurisdiction, LA Civil Rights will refer cases to other agencies, including the California Department of Fair Employment and Housing and the U.S. Equal **Employment Opportunity** Commission. Filing a complaint with LA Civil Rights does not preclude anyone from seeking justice through other government agencies or through the legal system.



From the 1800s to Today: Empowering Veteran Business Owners

From his years of service in the military to his current work helping former soldiers build their own businesses through JPMorgan Chase's veteran initiatives, Alex McKindra Jr. is a veteran success story. Moreover, as we celebrate Veteran's Day this year, Alex's story is a uniquely American one that veterans and members of the military community across the country can relate to. But, as he is the first to admit, his success story, like many, has a long history tracing back through generations of his family in the small town of Union Chapel, Arkansas.

Becoming a Cornerstone of the Community

In the late 1800s, Alex's great-great grandfather, Reuben Frank McKindra, moved his family to Union Chapel, a town originally settled by freed Black slaves.




Reuben Frank McKindra helped to fund and maintain the town through private public partnerships dating back to 1920.

Working on their family farm, the McKindras made a name for themselves by demonstrating their resourcefulness and aptitude for hard work. Namely, the family utilized mentorship only start, but grow their family farm.

Amid the success of the family business, the McKindras never lost sight of the support they had been given—and the importance of passing it on to others in their community and society. Generations of McKindras have dedicated their lives to the military, including his grandfather, father, and brother (pictured right), and subsequently to their communities when they returned home.

Armed with the life experience and knowledge he gained from the service—and a freshly-minted MBA and banking internship under his belt-McKindra dove into the world of corporate finance. Quickly building a reputation for his intelligence, reliability and kindness, he rose through the ranks. Today, he works as a Managing Director for JPMorgan Chase Commercial Banking in San Francisco.

cess. He wanted to help those who—like his greatgreat-grandfather Reubenhad risked their lives for the country and were now seeking to put down roots as civilians. With that in mind, he decided to co-lead JPMorgan Chase Commercial Banking's veteran initiatives alongside Army veteran, Terry Hill. Alex, Terry and their team across the firm share a passion for mentorship and community building. Through various programming, they tap into their military backgrounds to connect with aspiring and current military-connected entrepreneurs to help them access the resources they need to be successful over the long-term.

For example, McKindra worked with JPMorgan Chase and Bunker Labs, a national nonprofit that supports the ventures of military-connected business owners, to build programs to help veteran small business owners. Together, they created CEOcircle, a 12-month mentorship program that is tailored to help mid-size, military-connected companies grow. Through this program, veteran business owners and their families gain access to the guidance and resources they need to succeed, including education, networking, and one-on-one financial mentoring. This year, CEOcircle welcomed 71 new individuals into the

Generational Impact

Less than an hour north of Little Rock, the McKindra's family farm still stands in Union Chapel. Today, the manicured green fields and trees remain a testament to the effort, determination, and community it takes to create a successful business.

"If my great-greatgrandfather were here today, I would want him to know

program nationwide, including Boyd Bishop who leads Hive Technologies in Hawthorne and Mahoney who leads Shipping Butler here in Los Angeles.

The program uplifts businesses that will support military families for generations to come—businesses like the McKindra farm.

"If I've learned one thing from my family's history, it's that hard work and preparation aren't always enough. Sometimes we need to create our own opportunities as well," Alex says. "That is what we are hoping to do with CEOcircle, to create the opportunities and that what he built didn't just support our family, it also instilled the values in us that would seed the acceleration and growth of hundreds of other veteran-owned businesses in the future," McKindra says. "I know he'd be proud of that."

The group hopes to break ground on the development, a community and economic revitalization project, late next spring, said GSUL spokesperson Laura Murrell. Murrell said Scott's financial contribution will jumpstart the development.

Although it was the lone Urban League branch in the Golden State to receive a boon from Scott, GSUL wasn't the only California organization to receive a donation from the well-heeled benefactress last month.

The Girl Scouts of the USA announced Scott gave \$4.9 million to the Girl Scouts of Greater Los Angeles. The gift was part of an overall \$84.5 million donation to the Girl Scouts of the USA.

The Girl Scouts of Greater Los Angeles, headquartered in Inglewood, serves more than 46,000 girls in partnership with 25,000 adult members and volunteers throughout the communities of Los Angeles County and parts of Kern, San Bernardino, and Ventura counties.

Sofia Chang, the Girl Scouts of the USA CEO, said in a statement that the charity is a great accelerator of efforts to give girls the tools to become the next generation of powerful leaders.

"We're excited to prove how Ms. Scott's investment in girls will change the world -- because when one girl succeeds, we all succeed," Chang said.

Several other groups across the nation also announced they received monetary aid from Scott last month.

However, no indication of the donations came from Scott, who has a net worth of \$27 billion and has given away around \$12.7 billion to more than 1,200 nonprofits since July 2020, accord-

ing to Forbes. Scott does not give media interviews or make public appearances.

Since she supercharged her charitable giving after her divorce from Bezos in 2019. Scott has at times acknowledged her gifts on the blogging site Medium. As of press time, her last post on the website was in March.

In the post titled, "Helping Any of Us Can Help Us All," Scott acknowledged 465 nonprofits she had given funds to since last June and typed, "as always, our aim has been to support the needs of underrepresented people from groups of all kinds. The cause of equity has no sides."

Murrell, the GSUL spokesperson, said the organization was shocked by Scott's charitable gift.

"She has a reputation of giving very generous donations to countless organizations across the U.S. that do incredible work. So, to have her recognize the Urban League and our Sacramento affiliate in particular was Murrell astounding," recalled.

State, Local Officials Take Action to Tackle Homelessness Crisis

California state and local officials are serious about tackling the state's growing homelessness crisis head on, as it continues to rise.

Last month, Gov. Gavin Newsom signed legislation related to solving this issue.

Over \$15.3 billion has been budgeted in housing programs aimed at curtailing California's homeless.

"State and federal resources have certainly made a difference in our communities," said Bakersfield's Mayor Karen K. Goh. "You know, going back to 2020 and 2021 with the Cares Act and then followed by the American Rescue Plan Act (ARPA), the dollars are making their way to our citizens."

Goh also pointed to Project Homekey as a program that has helped alleviate homelessness.

"Project Homekey resources are being used to transform underutilized motels and hotels, into safe shelter, and in our communities," said Goh.

The COVID-19 pandemic has played a significant role in the rise of homelessness, from 150,000 in 2019 to 161,000 in 2020, according to the U.S.

Department of Housing and Urban Development.

The African American population in California has suffered disproportionately from this phenomenon.

The California Budget and Policy Center reports that Black people are roughly 25% of the state's homeless, although they make up about 5.5 % of California's population.

Some of the funding the state provided went to the Community Assistance, Recovery and Empowerment Court — or Care Court, a program that diverts homeless people with severe mental health problems away from the criminal justice system and into mandatory treatment.

Signed into law on Sept. 14, Senate Bill 1338 (Care Court Act) by Sen. Thomas Umberg (D-Santa Ana) and Sen. Susan Talamantes Eggman (D-Stockton) focuses on untreated individuals suffering from psychotic disorders, such as schizophrenia.

Bills Newsom signed on affordable housing include Senate Bill 561 by State Sen. Bill Dodd (D-Napa), Assembly Bill (AB) 2233 Assemblymember Sharon Quirk-Silva (D-Fullerton), and AB 2592 by Assemblymember Kevin McCarty (D-Sacramento).

"This historical package will go a long way towards increasing affordable production in California," Assemblymember Quirk-Silva tweeted.

Together, these bills require the California Department of Housing and Community Development (HCD) and the California Department of General Services (DGS) to codify and expand the Excess Land for Affordable Housing program, a state initiative born from the governor's first executive order.

said Goh. Mayor Todd Gloria of San Diego speaking about work that is being done on the local level to fight homelessness said, "Our housing commission has put out over \$200 million assistance, helping roughly about 80,000 families at this point avoid homelessness, many of them seniors."

Gloria states that working against this crisis sometimes "feels like you're swimming upstream" due to the federal government raising and lowering interest rates.

He claimed that tackling minimum wage or advocating in the state capitol or DC are ways that local governments can have control over solving homelessness.

"You know, these are never satisfying answers because yes, there are a bunch of things at work. But we get up every day, and come here to try and make a difference on those matters," said Gloria.

On Oct. 3, Newsom signed AB 408 authored by Assemblymember Quirk-Silva that requires local educational agencies to have a liaison for homeless youths in order to train the agencies on how to best support them.

Newsom recently announced that he will convene local leaders in mid-November to review the state's collective approach to homelessness and identify new strategies to better address the growing homelessness crisis.

The deadline to apply for this grant is Dec. 2nd, by 5:00 p.m. Local governments that have legal dispensaries and some form of

cannabis cultivation operating within their jurisdiction are eligible to apply. Please see additional details about this grant below:

A unique feature of this grant is that nonprofits are unable to apply to this grant directly and would instead need to partner with a qualifying LPA (lead public agency), such as the city, county or other qualifying agencies.

To access these funds for youth development work, you would need to

engage your local city or county staff and work with them on the application. The local government would then subcontract with your agency for youth development work. See Instruction Packet for more information. Applicants can apply for a maximum of \$3,000,000 to expended over 5 years.



Water Replenishment District's (WRD) Board President John D. S. Allen, Director Vera Robles DeWitt, and Director Joy Langford proudly California welcomed Attorney General Rob Bonta at the Albert Robles Center (ARC). This momentous occasion celebrated the 50th anniversary of the Clean Water Act (CWA) which became law on October 18, 1972.

ARC is WRD's landmark facility that ensures a completely local sustainable source of water for groundwater replenishment. This facility produces up to 14.8 million gallons of purified water per day, which is used to replenish groundwater aquifers in the Central and basins provides 50% of County. The project also

In response to visiting ARC, Attorney General Rob Bonta shared, "To see how WRD has leveraged funding that originated from the Clean Water Act is impressive. WRD built ARC to create a local and droughtresilient water supply. This facility is a clear demonstration of how the Clean Water Act promotes environmental justice. WRD's innovative planning will curtail the challenges that climate change poses for decades to come."

"We are proud to share ARC's success with Attornev General Rob Bonta." said WRD Board President John

D. S. Allen. "This facility is the cornerstone of WRD's decades-long effort to build a sustainable water supply for the communities we serve."

Director Joy Langford was also pleased to welcome Attorney General Bonta and said "Attorney General Bonta is a champion of environmental justice. It was an honor to share with him how the legacy of the Clean Water Act has made an impact on WRD's service area and disadvantaged communities in the region."

When WRD was first established, 100% of the water supply used to replenish groundwater basins was imported. With the completion of ARC. 100% of the water used to replenish the groundwater basin at the spreading grounds is a combination of groundwater and recycled water. WRD and partner agencies produce enough locally recycled water to offset the need for imported water to replenish the basins. Not one drop of water is imported by the district to replenish the basin at the spreading grounds.

The Clean Water Act paved the way for California's Clean Drinking Water State Revolving Fund, which provided an \$80 million low-interest loan and a \$15 million grant to pay for ARC's approximately \$140 million cost of construction. WRD Board Members stated that they were delighted to celebrate the 50th Anniversary of the CWA with Attorney General Bonta.

A rainy election day is usually a bad sign for voter turnout. But, since the COVID-19 pandemic, voting has become much easier with everyone encouraged to vote by mail. Turnout at the polls was low, but that may have been because of new voter methodology rather than a willingness to vote.

Votes could have been dropped off at voter boxes spread out throughout the city or could have been mailed free of charge and all votes need to be at the county clerk's office no later than Friday, November 11, via U.S. Mail.

The propositions on the local, county and state levels received votes as projected. County Measure A, which provides authority to remove an elected sheriff, was approved 75% to 25%, along with tax on cannabis businesses in unincorporated areas, 64% to 36%.

In Los Angeles, voters approved Measure LH increasing low-income housing units in each council district, but rejected tax increases proposed in Measures ULA and SP. How ever, voters approved the L.A. Community College District improvements in Measure LA. Statewide, measure 1 securing voters are leaning towards womens'reproductive rights disapproval. However, overwhelmingly passed. However, the dueling gambling propositions -26 and 27 – both failed as

forecasted. State Measure

28, which requires funding for arts and music education in public schools, appears destined for approval, but Measure 29 requiring medical professionals a dialysis clinics in slated to fail.

As for Measure 30, which aimed to tax personal income over \$2 million, Measure 31 prohibiting sale of flavored tobacco products is sailing towards passing.

Moore Elected Maryland's First Black Governor, Campbell Wins as Massachusetts AG

Massachusetts in 2006. Democrat Stacey Abrams would have become the nation's first Black female governor if she had won her Georgia rematch against Republican Gov. Brian Kemp, but she conceded the race.

With the slogan "leave one behind," the former combat veteran and former CEO of one of the nation's largest anti-poverty organizations campaigned creating equal opportunity for Maryland residents.

"When I was an Army captain and led soldiers into combat in Afghanistan, we

told a crowd gathered in downtown Baltimore during his victory speech. "It means lifting each other up and improving each other's lives."

Moore's running mate, Aruna Miller, also made Maryland history by becoming the first immigrant to win the lieutenant governor's office. Miller, who immigrated from India, also is the first Asian-American elected statewide.

Moore, 44, defeated a first-term state legislator who was endorsed by former President Donald Trump, who only received 32% of the vote in Maryland

Democrat Andrea Campbell has become the first Black woman in Massachusetts history to be elected attorney general.

Boston The former councilor, ran unsuccessfully for mayor last year, defeated Republican candidate and trial attorney Jay McMahon. Campbell becomes the third woman to hold the seat in Massachusetts.

Campbell had won the endorsement of Attorney General Maura Healey, the Democratic candidate for governor, as well as

four prior state attorneys general, U.S. Sen. Edward Markey and U.S. Rep. Ayanna Pressley.

During her victory speech, Campbell cited her faith and her family history, including her twin brother Andre who died in state custody.

"He and so many of you have given me the courage to keep pressing forward to turn pain into purpose and my god has given me the power to make it happen," she told supporters who gathered at a downtown Boston hotel.

Campbell also ticked off a series of issues she said she plans to tackle including from targeting wage theft and defending seniors to protecting tenants and homeowners, pushing for what she called commonsense gun laws, and supporting antiviolence organizations.

"For those who have felt unseen this victory is for you. For those who have felt marginalized, this victory is for you. For those who have felt left out, left behind, and undervalued, this victory is for you," she said.

Campbell has spoken openly about her father's and brothers' involvement

criminal justice in the system.

The 40-year-old has credited a public education system in Boston with helping put her in schools, that opened doors to success while her brother's schools had few resources. She also said that as a girl she was less likely to be racially profiled by the criminal justice system.

Campbell grew up in Boston and attended Princeton University, as well as UCLA Law School and served as deputy legal counsel to former Democratic Gov. Deval Patrick.

During the campaign, Campbell said she would "look at every issue through an equity lens." She said Massachusetts residents don't all have the same access to affordable health care or housing and aren't all affected equally by the criminal justice system, crime or the climate crisis.

She added communities of color are "disproportionately policed and incarcerated," and the contrast in funding and quality of schools - when broken down by income, race, and region – is stark.

age 65 with 20-years of service before vesting; this model created significant challenges to some officers appointed later in life, and severe hardship to some who for unplanned reasons needed to leave their careers prior to vesting. The modified retirement plan under AB2443 creates options allowing judges to retire at the age of 60 with at least 15-years of service, or at 65 with at least 10-years

California Lawyers, the American Board of Trial Advocates, the Consumer Attorneys Association Angeles, the Association of Southern California Defense Counsel, Citizens for Accountable Leadership, and Kevin Johnson, the former Mayor of Sacramento. Before AB 2443 was born, we had already reached out to the decisionmakers to develop their 'buy-in.'

"I sent letters to Governor Newsom and the first African-American Director of the Department of Finance, Joe Stephenshaw. The passage of AB 2443 marks the most significant change to our pension program in 28 years!"

Judge Byrdsong notes, that the Chief Justice of California, Tani Cantil-Sakauye, was instrumental in how he approached achieving pension equity: "The Chief Justice shared perspective and historical context throughout this process as she is probably the biggest advocate for the judicial branch, the judiciary, and diversity, Judge Byrdsong and California Supreme Court Chief equity, and inclusion in the legal profession."

CJA's long lobbyists Mike Belote and Cliff Costa of California Advocates, Inc., critical in advancing the historic legislation, acknowledged Byrdsong: "We could not have obtained these changes without the professional and superb services of California Advocates. We are so grateful to have them on our team!"



Understanding Stress and Coping Mechanisms for Good Mental Health

With many families struggling to make ends meet due to higher food prices, the cost of gasoline and an uncertain job market, people are feeling overburdened and stressed, not knowing what the future may hold.

National Stress Aware-Week began Nov. 7 to raise awareness about good mental health practices and behaviors. It's important not to sweep symptoms under the rug so that you can identify potential treatments and better understand the root cause of

According to Dr. Ashley Zucker, an adult, adolescent and child psychiatrist

with Kaiser Permanente Southern California, stress is the feeling of being under too much mental or emotional pressure.

"Stress in and of itself is not a medical or mental health condition, but it can lead to medical and mental health conditions and concerns," Dr. Zucker said. "Stress can be caused by almost anything that impacts your daily life, including work and relationships. Even positive events such as having a baby or getting married can be stressful."

Dr. Zucker noted the signs of stress encompass a wide range of symptoms, including headaches, stomach problems, muscle tension, irritability, increased



worrying, making mis- too much can cause negaand more.

"Stress is your body's reaction to helping you deal with pressure," she explained. "A small amount can actually be helpful and can improve your performance and awareness, but

sleeping problems tive effects. When we are stressed, we are technically turning on our fight or flight response, and our bodies start to release stress hormones such as cortisol and adrenaline."

Typically when the stressor goes away, these hormones drop back to normal levels, Dr. Zucker explained. If stress lasts for a long time, it can impact our mood or worsen our existing mental health issues. When stressed, we may also resort to unhealthy coping mechanisms such as overeating, drinking alcohol or abusing drugs, which will negatively affect our

Dr. Zucker noted stress has been linked to many physical conditions such as heart disease, irritable bowel syndrome, increased blood sugar levels, a weaker immune system, stomach ulcers and more. That's why seeking treatment may sometimes be necessary.

"It's important to manage your stress when it's too high or going on for a long period of time," Dr. Zucker emphasized. "Things that you can do on your own to help lower your stress level include exercising, relaxation techniques, spending time with friends and family, setting aside time for hobbies or activities you enjoy, as well as getting plenty of sleep and eating well."

Dr. Zucker noted that practicing good strategies to reduce your stress levels can improve your mental and physical health overall and prevent more serious health conditions later on.

Rising from the Ashes: Billy Preston and Victory Baptist Church

Billy Preston played "the most exciting organ ever," according to the title

of his second LP.

George Harrison
agreed, remembering Preston's singularity in Ray
Charles's touring ensemble
and telling the other Beatles about it on a cold day
in January 1969. Searching
for inspiration at the beginning of the "Get Back/Let
It Be sessions," the Quiet
One anticipated the musical warmth—and skill—

Billy would bring to them.

All the Beatles soon agreed about Preston's extraordinary playing; he had, as he told them, "perfect pitch." Preston's 1969 and subsequent work with the Beatles were highlights, but his career was full of his own chart-toppers and collaborations with other mega-popstars.

Preston's musical journey started at Victory Baptist Church in Los Angeles.

Once there was a way to get back there to "Billy's organ," which is how revered elder, Ms. Johnnie Pearl Knox, described the church's instrument in 2020. Preston died in 2006, but Victory remembers him, along with his mother

and his sister, Rodena. The family of three, all musicians, found the church after moving from Houston to L.A. during the Great Migration of the 1940s when Billy was little.

Billy's organ is gone now. The Hammond B-3 he learned on and played throughout his life was destroyed by a fire that engulfed Victory in the early hours of September 11, 2022.

From the Hammond's seat, Preston had a full view of the congregation and the preacher at the pulpit, all of them bathed in an LA morning glow that filtered through beautiful stained-glass windows. To Preston's right was the choir, and behind them a stained-glass representation of Jesus's baptism.

Preston always attributed success to God and thanked collaborators, reminding stadium audiences, "God loves you," when he performed with the Rolling Stones in 1975. Preston learned the values of service—especially when it came to music—at Victory, whose story is entwined with both Preston's artistry and the broader history of popular music.

On property purchased by Victory, the gleaming white building had an el-

egant midcentury interior. In addition to the stained-glass windows, crystal chandeliers refracted light while golden accents highlighted the pulpit area, always full of lush floral arrangements. From the time it was built in 1944, the historical church at the corner of East 48th and McKinley was impeccably maintained.

It's hard to forget Victory's address because almost every service begins with a reminder about where Victory is. They welcome visitors like family, and they give to those in need, fulfilling the motto that graced the back wall in golden letters over wood paneling: "To serve the present age—my calling to fulfill."

Far more than just the site of Preston's musical and spiritual education, Victory has been a beacon

in L.A.'s Black community. The church witnessed and participated in civil rights history, whose soundtrack was gospel music. Victory functioned as a center for political action, serving, for example, as a voting registration site. The Rev. Dr. Martin Luther King, Jr., preached from its pulpit twice. And the church was a frequent destination for major gospel singers such as Mahalia Jackson.

Miraculously, the pulpit from which King preached and Jackson sang survived the fire.

In the wake of the tragedy, the current pastor, the Rev. Dr. W. Edward Jenkins has revisited Jackson's music, reminded of its worldwide appeal and "contribution to desegregation." Music, Jenkins reflected, "is part of the soul."

Once at the "center of a

Black renaissance in LA," Victory now has many elderly parishioners. Knox's presence, for instance, goes way back. She sang with Billy and his sister, Rodena, a lifelong friend. The pandemic had already taken its toll on this community before the fire. Now they are forced to hold on without a worship space.

As of the writing of this article, an arrest has been made, but the arson continues to be under investigation. Still, the history of attacks perpetuated against Black churches in America is hard to put aside when something like this happens.

As Rev. Jenkins tried to address the whys and the hows in a sermon filmed in his home, his themes echoed one of Preston's most memorable songs, "That's the Way God Planned It." The message is about holding onto God's unchanging hand, a common refrain in Jenkins's sermons. "God is real,"

said Rev. Jenkins, offering comfort to a grieving community

munity. In the days before Go-FundMe, Preston used his music to advocate for people in his community. He spearheaded a benefit for St. Elmo Village, once a haven for Black youth in need and now a thriving artists' community. The album art of "The Kids and Me" (1974) included drawings by children a listener could support, too; Preston included the address for those who wanted to help.

Rebuilding Victory will help restore the living community that houses Preston's memory.

Victory endures. They will sweep away the ashes as they rise from them, but they can't do it without help.

Regardless of the outcome of these current midterm elections, favorable results for us and others will not redeem or radically change this country or save and secure the world, though it might be said it will save the day, i.e., give us better conditions to continue and expand our struggle.

Nor will an unfavorable outcome end democracy or overturn the world, though it will bode ill for the wellbeing of the world and clearly further problematize the conditions in which we must and will continue to struggle.

So, in any case or condition, we will still need to continue and expand the struggle, keep the faith, hold the line and advance our morally compelling interest in achieving African and human good and the sustained well-being of the world whenever and wherever we can.

No matter what the outcome, let us first praise our people for all they did and endured, all the walls they broke through, all the obstacles they overcame in their struggle to vote, to make their voices heard, to exercise their rights, to express their views and values, and to resist every racist and right-wing effort to discourage and deter them. Indeed, once again, they had to overcome multiple racist and mean-spirited obstacles established all over the country to deny, prevent, disqualify and otherwise suppress their vote.

There was the racist and right-wing racial redistricting, gerrymandering, eliminating and absorbing districts largely populated by Blacks, reducing their voting power, denying them rightful representation and even daring in Louisiana to define who is Black in order to deny Black people their

Moreover, these devious disrupters also launched legal challenges to disqualify voters, made laws to make it difficult to vote, purged voter rolls, delayed mailing out early voting ballots, and falsely arrested Black voters for voter fraud and put police and vigilantes around polling places to intimidate and terrorize. And yet, we were not deterred, discouraged or defeated, and this is a narrative of defiance, determination and resistance that serves as a model and mirror worthy of the best of African and human history.

We must praise our people also to bear witness to truth to counter the customary tendency of politicians, media personalities and pundits to dismiss, diminish or divide our role when Democrats win and to blame them as a whole or Black men when the Democrats lose. There is a clear difference when they discuss other ethnic groups. Here they give Latina/os great credit if Democrats win and blame the Democrats for not adequately reaching out to them if they lose. For us there is no discussing of reaching out, asking for and responding to our agenda. It is assumed we are an ongoing gift and given. Thus, there is no similar need to reach out and the fault is ours if our inherited and unresponsive party loses.

Indeed, we must still bear witness to truth and set the scales of justice in their proper place among those who have no voice, have less voice, less power and status, less means and possibilities for the good and meaningful

life everyone deserves.

clean water for the thirsty, housing for the homeless. rent relief and moratoriums on evictions for those who need these, healthcare and quality education for all, assured income and rightful employment, security of persons and peoples, the end of police violence and massive incarceration, and a good and expansive life for everyone.

But again, elections are critical ground on which we must struggle. For they are, as we have continuously maintained, an important means that enables us to sit at the tables of power where law and policy are made, resources allocated, agendas introduced and advanced, deals and compromises put together, and alliances are built to achieve common goals. But there is more work to be done before we get fully there and represent rightly and practice politics effectively when we audaciously arrive as both per-

sons and a people. For also, as we have continuously and consistently argued, there is no substitute for an aware, organized and engaged people constantly involved in a multiplicity of activities to define, defend and advance its interests. It is and will be no easy walk or way to freedom in the fullest sense of the word or to achieve justice and equity in this

As a key moral vanguard, we must face and confront the racial and racist character, structure, power and deep-rooted practice of this country. The language "we" and "our" hides or at least obscures in plain sight the fact that White people still rule this country and will not relent or share power, wealth and status willingly without a righteous and relentless struggle to compel them.

others want to concede it or say it, when it is said this country is divided, it means White people are divided. And in this election and others, the ruling race/class is struggling over who will control state power, power to legislate, adjudicate, allocate and yes, dominate. It is a power to impose, make war and lay waste and appropriate the land and lives of people; to steal, kill and constrain under the color and camouflage of law; and to turn their hatreds and hostilities into public policy and socially sanctioned practice.

Thus, again, regardless of the outcomes and remaining contentions, the reality of race, class, gender and oppressions of these and other kinds remain and so does the urgency and necessity for ongoing righteous and relentless struggle to resist and end them. Homelessness continues to be a major problem across our country. When most of us think about the homeless, we think of those who have drinking problems or suffer from various addictions, but it is bigger than this picture.

The homeless population continues to grow because of a variety of reasons such as, but not limited to, the loss of jobs, the cost of living, having to choose between basics such as food,

transportation, and even childcare. One of the major culprits is the lack of affordable housing causing people to go from couch surfing to eventually ending up on the street.

A growing number of the homeless community are our youth. We must do what we can to get our youth and their families off of the street.

During the pandemic, a rise in homelessness grew. Homeless tents and pop-ups

When youth (especially young girls, even Transitional Aged Youth (TAY's) grow up on the streets or depend on the generosity of people letting them sleep on their couch, they become vulnerable beyond

measure. Homeless children are also more likely to suffer from hunger, and health issues. Some of their health issues can stay with them throughout their lifetime.

Affordable housing should be of concern to all of us. So many people are living paycheck to paycheck and owning their own home is a distant dream. Keeping a roof over their head and their family's is their primary concern. For those of us that live in California, the dream of owning a home is even further of a reality. However, even with all this doom we cannot give up.

When the public and private sectors can come together, there is always an opportunity to improve situations that appear bleak. Basic housing should be a right and not a privilege for everyone. We never know how close we or someone we love could be faced with these same concerns.

We must remember that no one wakes up and says they want to be homeless and live on the street. Jan Schakowsky said, "There is a lot that happens around the world we cannot control. We cannot stop earthquakes, we cannot prevent droughts, and we cannot prevent all conflict, but when we know where the hungry, the homeless, and the sick exist, then we can

We must all ask what can we do? to make an impact with helping get a youth off the streets and into some sort of positive living situation.

Pariss Chandler built a community for Black tech workers on Twitter that eventually became the foundation for her own recruitment company.

Now she's afraid it could all fall apart if Twitter becomes a haven for racist and toxic speech under the control of Elon Musk, a serial provocateur who has indicated he could loosen content rules.

With Twitter driving most of her business, Chandler sees no good alternative as she watches the uncertainty play out.

"Before Elon took over, I felt like the team was working to make Twitter a safer platform, and now they are kind of not there. I don't know what's going on internally. I have lost hope in that," said Chandler, 31, founder of Black Tech Pipeline, a jobs board and recruitment website. "I'm both sad and terrified for Twitter, both for the employees and also the users."

Those qualms weighing on many people who have come to rely on Twitter, a relatively small but mighty platform that has become a digital public square of sorts for influencers, policy makers, journalists and other thought lead-

Musk, the CEO of Tesla and SpaceX, took over billion deal, immediately making his unpredictable style felt.

Just days later, he had tweeted a link to a story from a little-known news outlet that made a dubious claim about the violent attack on Democratic House Speaker Nancy Pelosi's husband at their California home. He soon deleted it, but it was a worrying start to his tenure for those concerned about the spread of disinformation online.

Musk has also signaled his intent to loosen the guardrails on hate speech, and perhaps allow former President Donald Trump and other banned commentators to return. He tempered the thought after the deal closed, however, pledging to form a "content moderation council" and not allow anyone who has been kicked off the site to return until it sets up procedures on how to do that.

Yet the use of racial slurs quickly exploded in an apparent test of his tolerance level.

"Folks, it's getting ugly here. I am not really sure what my plan is. Stay or go?" Jennifer Taub, a law professor and author with about a quarter million followers, said Sunday, as she tweeted out a link to her Facebook page in case she leaves Twitter.

For now, Taub plans to stay, given the opportunity it provides to "laugh,

"The numbers are going down and down and down," said Taub, who has lost 5,000 followers since Musk officially took over. "The tipping point might be if I'm just not having fun there. There are too many people to block."

The debate is especially fraught for people of color who have used Twitter to network and elevate their voices, while also confronting toxicity on the platform.

"As a user of Twitter as a power user in a lot of ways — it has had a great utility and I'm very concerned about where people go to have this conversation next," said Tanzina Vega, a Latina journalist in New York who once received death threats on Twitter but

the isolation she felt in her white-dominated field when she tweeted out a question and a selfie four years ago: "What does a Black Twitter in Tech look like? Here, I'll go first!" The response was overwhelming. She now has more than 60,000 followers and her own company connecting Black tech workers with companies large and small.

She also received hate message and even some death threats from people accusing her of racism for centering Black technologists. But she also had connections with Twitter employees who were receptive to her concerns. Chandler said those employees have either left the company or are no longer active on the platform.

gram and LinkedIn but none can replicate the type of vibrant community she leads on Twitter, where people mix professional networking and light bantering.

Instagram and TikTok are fueled more by images than text exchanges. Facebook is no longer popular with younger users. LinkedIn is more formal. And although some developers are trying to rush out alternative sites on the fly, it takes times to develop a stable, user-friendly site that can handle millions of accounts.

Joan Donovan, an internet scholar who explores the threat that disinformation poses to democracy in her new book, "Meme Wars," said it's not clear if Twitter will remain a safe place for civic discourse. Yet she called the networks that people have built there invaluable — to users, to their communities and to Musk.

"This is the exact reason that Musk bought Twitter and didn't just build his own social network," Donovan said. "If you control the territory, you can control the politics, you can control the culture in many ways."

In his first few hours at the helm, Musk fired several top Twitter executives, including chief legal counsel Vijaya Gadde, who had overseen Twitter's content moderation and safety efforts around the globe. And he dissolved the board of countable, at least on paper, only to himself. On Friday, Twitter began widespread

European regulators immediately warned Musk about his duty under their digital privacy laws to police illegal speech and disinformation. The U.S. has far more lax rules governing Twitter and its 238 million daily users. But advertisers, users and perhaps lenders may rein him in if Congress does not first tighten the rules.

"If the advertisers go and the users go, it may well be that the marketplace of ideas sort of sorts itself out," said Cary Coglianese, an expert on regulatory policy at the University of Pennsylvania law school.

That could leave Twitter to be just another magnet for extremists and conspiracy theorists — a concern driving some to urge their network of friends to stay, in order to counter those narratives.

Chandler said she can only "walk on eggshells" and take a wait-and-see ap-

"I'm personally going to stay on Twitter until there is really not a reason to stay anymore. I don't know what the future holds, I'm kind of hoping for some sort of miracle," she said. "For now, I won't be going anywhere."

Tell the Supreme Court - We Still Need Affirmative Action

One of the great joys of my life is teaching. I'm fortunate to teach classes on social justice at the University of Pennsylvania, one of the most respected schools in the country. Penn has a longstanding commitment to affirmative action, and I have seen firsthand how diversity in the classroom benefits all my students.

There's just question that diversity is a core piece of a vibrant academic community and a critical part of the learning experience - for all of us. Bringing together students with different lived experiences forces students to think critically about their assumptions, which is an essential goal of a university education.

That's why I, like so many of us, am deeply concerned about two affirmative action cases argued at the Supreme Court just a few days ago. Opponents of affirmative action have been trying to destroy it for years. And now it looks like they just might get their chance.

Harvard and the University of North Carolina (UNC), defending programs admissions against opponents who them declared unconstitutional. (The university where I teach, Penn, and the organization I lead, People For the American Way, have both joined briefs supporting the universities' positions.) Considering race as one of many factors in admissions that has been upheld by the Supreme Court for decades, the Court has said repeatedly that diversity in higher education is a "compelling interest."

However, today's Supreme Court is different. It's dominated by farright justices who have made it clear they don't share this view. Chief Justice John Roberts's famous quote, "The way stop discrimination on the basis of race is to stop discriminating on the basis of race," sums it up: conservatives believe affirmative action is at best unnecessary and at worst just another type of discrimination. Some conservatives would like

to retire affirmative action because they claim it's accomplished everything it set out to do. But it hasn't. Not even close.

In Texas and Michigan, applications enrollments of Black and Latino students plunged state politicians banned the consideration of race in admission to their public universities. That's a huge red flag. Nationally, there's a big gap between the percentage of White and Black students who earn a bachelor's degree. And that perpetuates all kinds of harm and inequities in income, health, family wealth, and more. We still have a long way to go in building a fair society in which all our children can thrive.

And here's an important point that often gets lost. All students—no matter their race or color or creedbenefit from affirmative action. Having diverse

stimulating exchange of ideas and viewpoints. It prepares all students for living and working in our increasingly diverse society. The Supreme Court as a whole used to understand that. Today, I worry that only a minority of the justices do.

One of those justices is Ketanji Brown Jackson, the first Black woman on the Court and a person of profound insight and wisdom. Her questions in oral arguments got to the heart of the matter. Imagine qualified students applying to UNC, Justice Jackson suggested: a White North Carolinian student whose family members had attended the school for generations, and a Black North Carolinian whose family had historically been shut out. The White applicant might make the case that attending UNC is deeply meaningful to her because it is a family tradition. The Black applicant might the case that it is deeply meaningful because her family was so long denied.

Jackson's question made it clear what would

happen if the Court adopts the Far Right's position: the White student's appeal to family history would be allowed to help their chance of acceptance, while the Black student's would not. It would further institutionalize discrimination and the harm it has caused generations of Black Americans.

I am so grateful for Justice Jackson's voice on the Court. I also know that the six right-wing justices expressed skepticism of affirmative action at oral arguments. Many reporters are already writing its obituary. I hope for the sake of our education system and our next generation, that they will be wrong. The "compelling interest" that led the Court to uphold affirmative action in the past still exists - in fact, it may be stronger than ever.

Those bones are believed to be 14-yearold Katricia Dotson and had likely been used in at least one lesson. A short time later, the city notified family members that there was a box of remains at the medical examiner's office that had been kept after the autopsies were completed.

Philadelphia's Court Common Pleas late last week. The lawsuit says both the university and the city engaged in tortious interference with a dead body and inflicted emotional distress on him and his mother, Consuewella Africa, who died in June 2021. Katricia and Zanetta Dotson, 12, were among five children and six adults killed in the 1985 police bombing of the headquarters of MOVE, a Black Liberation group. More than 60 homes in the neighborhood burned to the ground as emergency personnel were told to stand

A spokesman for the ty and a spokesperson for the university said Monday they could not comment on pending litigation.

"Katricia and Zanetta Dotson were two children who died in the most violent way imaginable," Daniel P. Hartstein, a rights attorney representing Dotson wrote in an emailed statement. "The Philadelphia Medical Examiner's Office and the Penn Museum denied their

humanity and dignity in death. The Dotson family is irreparably scarred by this shocking lack of basic human decency."

Amid revelations of the bones being kept at the Penn Museum in 2021, the city also revealed that the Health Commissioner in 2017 had ordered the destruction of a box of remains kept after the autopsies of the bombing victims. The family had previously believed that all of the remains had been returned to them and buried in a joint funeral for the two

Thomas Farley resigned as Health Commissioner and issued an apology, but a day later the city issued another statement that the remains had not been destroyed and had been located in the medical examiner's office.

August, Dotson travelled from Carolina to receive the remains of his sisters from the medical examiner's office. But the lawsuit argues that some remains may have been lost or may still be at the university, saying Dotson's sisters were inappropriately used as props and kept as trophies.

MOVE members, led by founder John Africa. that shunned modern conveniences, preached equal rights for animals and rejected government authority. The group clashed with police and many of their practices drew complaints from neighbors.

Police seeking oust members from their headquarters used helicopter to drop a bomb on the house on May 13, 1985. A 1986 commission report called the decision to bomb an occupied row house "unconscionable." MOVE survivors were awarded a \$1.5 million judgment in a 1996 lawsuit.

arrogant?...to deny God and think they are God? This is not unusual. There are people like that today. You can see the bitter end coming for them, but they won't let go and let God be God. Because they do not believe there is the Creator, they chance it and go on to you know where.

The taskmasters beat and mistreated the people. Pharaoh wouldn't give them straw and they had to produce just as much productivity as when they had sufficient materials (Exodus 5:14) Exodus 5:18 says, "Go now and work without straw to make bricks and the quota expected must not be lessened."

And to boost Moses' confidence, I suspect that he remembered what the Lord had said earlier, "I will be with you." That's our message to everyone. Re-

mind yourself that God will be with you. He will never leave you nor forsake you. He is the Lord. He changes

'Black Panther: Wakanda Forever' Director Ryan Coogler

Nearly five years after the monumental success of "Black Panther" (2018), the highly anticipated sequel, "Black Panther: Wakanda Forever" will be released on November 11th. Director Ryan Coogler persevered through an insurmountable challenge of co-writing and directing the film following the passing of star Chadwick Boseman, who was the living embodiment of his character King T'Challa.

While the void of Boseman's presence is felt within "Wakanda Forever," the film thoroughly pays tribute to Boseman while introducing audiences to several new characters including Riri Williams/Ironheart (Dominique Thorne), as well as a new villain, Namor (Tenoch Huerta) who is the ruler of a Mayan-inspired underwater kingdom, Talokan.

gious MCU (Marvel Cinematic Universe) Livnalli's extensive resume included, "Ozark," "American Horror Story," and "NCIS: New Orleans." He shared with the Sentinel what he admired most about Coogler as a director.

"What I really love about Ryan is that he finds a way to speak to you in your own language. When I say 'language,' I don't mean Engthrough that.

"We're both basketball fans so a lot of our communication on set was through basketball analogies and that was something I really appreciated. He took the time to find this language to communicate with me and not every director does that so I'm grateful."

Cadena echoed similar sentiments of high praise for Coogler. The Mexican actress, who has over 20 acting credits, shared how "Wakanda Forever" was more than another film role. "Ryan changed my life. He changed the narrative of my own story."

Cadena spent nine months learning how to speak English, in addition to learning how to swim and free dive in preparation for the film. When asked how

the movie, he wanted to know what were my experiences as a Mexican woman and if the story made sense for us and our characters as Latino American peopl, as he built the Talokan world. I'm very thankful to Ryan for all those little things."

In discussing the importance of cultural specificity in "Wakanda Forever," Coogler told the Sentinel, "I admire things more that are specific, intentional, and respectful of cultures. There are few things worse than having your culture disrespected or feeling like your culture was used in a way that wasn't mindful or intentional.


"As a child, I remember watching 'Malcolm X' and feeling like the people responsible really respected the culture that I was a part

of. Dito with 'Boyz n the Hood.' As I got older as a filmmaker and a film consumer, I admired things that felt culturally specific even to cultures I wasn't familiar with. I think about films like 'City of God.'

"Though I had never seen Brazilian cinema before, it felt specific and authentic. I liked feeling as if I had traveled to another country in the timespan of watching the movie, I came out of it with a richer understanding, knowledge, and curiosity. So I definitely want the films that I make to have cultural specificity. We had it in the first 'Black Panther' and I think that type of attention to detail is expected of us now from our audiences."

He continued, "And speaking of the Talokanil which is the Latin American and Mezo American representation or Indigenous representation, we couldn't do all of the work we did with Wakanda and not do that same type of work with this group of people, it would have been extremely unfair so we wanted to go as deep if not deeper for the Talokanil out of love and respect."

Amidst the fanfare and promotional tour in support of the film, we asked Coogler if the production process was healing and if he's able to be happy and present in this moment? He shared, "I'm realizing that 'healing' is an interesting word, it doesn't necessarily fit. Emotional wounds are so much different than physical ones. We try to assign physi-

cal properties to emotional wounds and I don't know if it necessarily fits. I don't know if emotional wounds ever truly heal."

He added, "I feel fortunate that my career as a filmmaker brought Chadwick and me into each other's lives. [Filmmaking] gives me an outlet for how I'm feeling, a way for me to express deep emotional questions and connectedness in a very public way.

"I can communicate with people that I'll never get a chance to meet through the art that I'm blessed to be able to make. I think it made me very appreciative of the space for relationships and the outlet that being an artist gives me.

"Chadwick was very passionate about the space for artists. He was passionate about that his whole life and he spent the last years of his life making art while fighting a very formidable disease. It was less of a healing [process] and more of something I was grateful for."

Dusty Baker's Historic Run with the Los Angeles Dodgers

nothing short of historical, including the eight seasons he spent playing for the Los Angeles Dodgers in the mid-1970s and early 1980s.

World Series. Astros general manager Johnnie B. "Dusty" Baker became the third Black general manager in MLB history to earn the Commissioner's trophy. Baker's career as a general manager and as a player is

had a breakout season the following year. In 1977, he batted .291 with 155 hits and 30 homeruns in 153 games. He was one of four Dodgers players who hit at least 30 homers each, making the Dodgers the first team to complete the feat in MLB history.

After hitting his thirtieth homer, Baker took part in arguably the first-ever high five when his teammate Glenn Burke greeted him on deck with his hand in the air. Unsure of what to do, Baker hit his hand.

"It was just something that we did," Baker said in the ESPN 30 for 30 documentary "The High Five." "Sometimes, you don't know why you do some of the things you do especially when you're extremely happy, you just respond to each other."

That season, Baker had his postseason debut and ultimately became NLCS MVP. In 1978, Baker batted .262 and made 137 hits, helping the Dodgers reach the World Series for a second consecutive time.

Baker earned the Silver Slugger award in 1980 and played in his first All Star Game in 1981. That season, he made 128 hits, 49 RBIs and batted a career-high .320. The Dodgers ultimately won the World Series that year, giving Baker his first and only championship win as a player. Baker also won the Silver Slugger Award and Golden Glove Award during that season.

In 1982, Baker earned his second All Star nod and

batted .300 while hitting 23 homeruns and 88 RBIs. His final year with the Dodgers came in 1983 when he batted .260 and made 138 hits.

Baker received several

of his awards during the years that he played for the Dodgers. He played for the MLB for 19 years, making 1981 hits, 242 homeruns and 1013 RBIs.
