# TO VACCINATE OR NOT TO VACCINATE

The challenge facing Black businesses and the people who work there

There is no doubt that the COVID-19 Pandemic has been a challenge to every business. But the challenges that are facing African American-owned businesses is an even greater one. Not only for the business owner, but for the employees and the customers they serve. As of Friday, November 5, every restaurant, bar, lounge or other communal facility is required to obtain proof of vaccination for its patrons. They also are required to make sure that every employee is vaccinated. But how do you meet this goal when many of your key employees are adamant that they will not or do not want to get vaccinated. According to KFF trusted medical data, anti-Vaxxers, as they are commonly known, are roughly 45% of our community. But the severity of this decision in many ways is one of the newest forms of gentrification within our community.

The survival of Black businesses coming out of the pandemic is critical, and

while many companies and organizations have already shuttered in the wake of the pandemic, now business owners run the risk of a different form of business deterioration as the new laws restrict many of their unvaxxed patrons from entering their business; the same conflict is likelyto restrict key employees unwilling to take the vaccine, forcing them to either leave the job or the owner risk severe fines or even a complete shutdown of their business. Employers also have a

responsibility to ensure the health and safety of its employees; this should be first and foremost on the minds of every business owner. The COVID-19 virus's primary transmission is through communal spread and has already killed over

half-a-million Americans. Employers now face a critical pandemic tug of war as new requirements mandate employee vaccinations under the "general duty clause" or OSHA-imposed obligations to ensure a workplace "free from the

recognized hazards that are causing or are likely to cause death or serious physical harm to employees."

Not obeying these steps and or ignoring this




Within this hard cover read, Jenkins talks about the empowerment of women and its connection to their



More California homeowners will be eligible for up to \$3,000 in seismic retrofit grants through Earthquake Brace + Bolt (EBB), a program jointly administered by the California Earthquake Authority (CEA) and the California Governor's Office of Emergency Services. The grants

help offset the cost of seismic retrofits that brace the cripple walls of older homes, when present, and bolt houses to their foundations, making them less vulnerable to earthquake dam-

### FEMA Changing Rules That Have Historically Deprived African Americans of Crucial Aid

In the past, the Federal Emergency Management Agency (FEMA) - relied on deeds to prove that land belonged to disaster victims before sending relief

However, those guidelines proved to deny aid to many African American applicants whose homes or land were inherited informally without written wills.

But, as first reported by NBC News, the rules quietly have changed.

As floodwaters and the after-effects of Hurricane Ida ravaged Louisiana, Mississippi, and eventually wreaked havoc in the northeast, FEMA officials announced that there will be significant changes in how they verify the ownership status of disaster relief applicants, noting that the objective in making the changes is to better assist applicants whose property was inherited without a

"What we're trying to do is make sure that we understand each individual situation is unique and that we need not have a onesize-fits-all approach," **FEMA** Administrator Deanne Criswell told the

news outlet. "We're going to continue to try to improve our program and make additional changes. Some of them we can do right away, like this. Some of them will require some regulatory change," she said. "But we are really driving hard to make these changes."

African Americans, particularly those in southern states, have routinely had difficulty proving property ownership.

Even without a damaging natural disaster, the Gullah Geechee community of St. Helena Island told the Black Press last year that they were fighting to protect their lands and the legacy left by their ancestors, who toiled for lifetimes under the brutal oppression of slavery.

Local tax officials held an auction of some of the property on the island

The freed slaves were deprived of an education and were at the mercy of White men who sold the land for as little as \$1.25 per acre and never provided appropriate sale documentation.

"The heirs don't have a title in their names," said Sará Reynolds Green, an activist, and farmer who raises produce on the St. Helena plot of land passed down throughout her family's generations.

While FEMA's new rules don't necessarily apply to St. Helena, they should provide a more level playing field for African Americans affected

by hurricanes, tornadoes, earthquakes, and other dis-

"Updated guidelines will also expand the options for paperwork renters can submit to prove that they live at affected properties," the NBC News team reported.

According to the report, "in addition to a written lease or rent receipts, renters will now be able to submit documents such as their car registration and letters from local schools or nonprofits. People in mobile homes will also have the flexibility to submit a letter from the property's owner."

## LA City Policy of Full Vax Proof at Many Indoor **Spaces Begins Monday**



Monday, anyone going to a shopping mall, theater, gym or nail salon in Los Angeles must verify they are vaccinated. The mandate, among the strictest in the country, requires proof of shots for everyone entering a wide variety of businesses.

Angelenos patronizing indoor restaurants, gyms, entertainment and recreational facilities, personal care establishments and some city buildings will technically need to show proof of full vaccination against COVID-19 starting today -- though enforcement of the new law won't begin until Nov. 29.

The city's SafePassLA ordinance is one of the strictest mandates of its kind in the nation, and includes all individuals eligible for a COVID-19 vaccine.

Accepted forms of proof vate company; and

of vaccination include:

• a vaccination card issued by the U.S. Centers for Disease Control

and Prevention or similar documentation issued by another foreign governmental agency;

• photocopy of a vaccination card or a photograph stored on a phone or electronic device;

• a personal digital COVID-19 vaccination record issued by the State of California or similar documentation issued by another state, local or foreign government jurisdiction, or by a pri-

• documentation of a COVID-19 vaccination from a healthcare provider.

People who appear over the age of 18 will also be required to show identification with their proof of vac-

On Monday, officials will begin city outreach and education of the new policy, but actual enforcement will not start until Nov. 29. Businesses violating the ordinance will be issued a \$1,000 fine for a second violation, \$2,000 fine for a third violation and a \$5,000 fine for a fourth and subsequent violations.

People can be exempted from the mandate if they have medical conditions that restrict their ability to get vaccinated or a "sincerely held religious belief," according to the ordinance. Those exemptions will have to be reviewed by the location the person is trying to

People who are exempt will be able to use outdoor areas of the location, but if unavailable, they may be allowed to enter the indoor area by providing proof of a negative COVID-19 test that was conduced within 72

The ordinance also requires people to show proof of vaccination or a negative COVID-19 test to attend outdoor events with 5.000 or more people, which would be stricter than the Angeles County requirement, which applies to outdoor events with 10,000 or more people.

Los Angeles County's rules, which are less expansive than the city's, went into effect on Thursday, also requiring people patronizing or working in an indoor bar, winery, brewery, nightclub or lounge in the county to be fully vaccinated against COVID-19.

"We've spent too much time placing restrictions on people who did their part by getting vaccinated and wearing their masks. We need to both limit the transmission of the virus as well as make it inconvenient for those who are unvaccinated to access indoor venues and put lives at jeopardy. The stakes are too high," Council President Nury Martinez said during the City Council's process approving the ordinance.

Final approval of the city's ordinance was given in an 11-2 vote by council members on Oct. 6.

"Vaccinating Angelenos is our only way out of this pandemic, and we must do everything in our power to keep pushing those numbers up," Garcetti said in a statement after the council's vote.

"These new rules will encourage more people to get the shot, and make businesses safer for workers and customers -- so that we can save more lives, better protect the vulnerable and make our communities even safer as we fight this pandemic."

The Los Angeles County Department of Public Health Director Barbara Ferrer said Thursday that the county is seeing a slight uptick in COVID-19 transmission, but pandemic-tracking metrics, including the number of people hospitalized, have plateaued.

The average daily rate of people testing positive for the virus was 1.6% as of Thursday, up from 1.2% a week earlier. The county's vaccination rate remained largely unchanged last week compared to the week before, with 80% of eligible residents age 12 and over receiving at least one dose, and 72% fully vaccinated. Among all 10.3 million residents, including those not eligible for shots, 69% had received one dose, and 62% were fully vaccinated.

Children age 5-11 became eligible for shots last week, a group that

includes about 900,000 kids in Los Angeles County.

# LA Traffic, Gas Prices on the rise this Thanksgiving

Pandemic-weary Angelenos will be hitting the roads and airways in large numbers this Thanksgiving, with about 4.4 million Southern California residents expected to travel for the holiday, according to estimates released today by the Auto Club.

The anticipated number of holiday travelers marks a 16% jump from last year. According to the Automo-



The Auto Club noted that the increase in travel will come at a time when Southern California residents are paying the highest gas prices ever on the Thanksgiving holiday, with an average price of about \$4.50 per gallon.

bile Club of Southern California, this year will be the second-busiest Thanksgiving travel volume on record for the region, just 3% below the 4.5 million people who traveled for Thanksgiving in 2019.

"This is a remarkable comeback for travel, especially considering that cruises and some other modes of transportation have only recently restarted," Filomena Andre, the Auto Club's vice president for travel products and services, said in a statement. "To help meet consumer demand, AAA is hiring travel advisers. We are also strongly recommending that people not wait to book trips in 2022 because there are deals and availability that are being

offered now that will go fast."

According to the Auto Club, the top five destinations for Southern California Thanksgiving travelers will be San Diego, Las Vegas, the Grand Canyon, Yosemite and Santa Barbara/Central Coast.

Nationally, Anaheim is expected to be the secondmost popular holiday destination for travelers, thanks to Disneyland. Anaheim will be second only to another Disney hub --Orlando, Florida.

Nationwide, the Auto Club is predicting this Thanksgiving will be the third busiest on record, with 53.4 million travelers, trailing only behind the 56 million from 2019 and 53.7 million in 2018.

Of the 4.4 million anticipated Southern California travelers, 3.8 million are expected to travel by car,

PROJECT DESCRIPTION: The Inglewood Transit Connector Project (ITC Project) is a 1.6-mile, three-station, fully elevated, electrically powered light-rail transit system, including, among other things, an Automated Transit System (ATS) mass-transit line, proposed by the City to close the last-mile gap and connect passengers between the Metro K (Crenshaw/LAX) Line and Downtown Inglewood to major event and activity centers, including the Forum, the Los Angeles Sports and Entertainment District, including SoFi Stadium, and the Inglewood Basketball and Entertainment Center (Intuit Dome). Three stations are proposed: (1) The Market Street/Florence Avenue station generally located between Market Street and Locust Street; (2) The Prairie Avenue/Manchester Boulevard station located on the southwest corner of Prairie Avenue and Manchester Boulevard; and (3) The Prairie Avenue/Hardy Street station located on the northwest corner of Prairie Avenue and Hardy Street.

PROJECT LOCATION: The proposed Project is located entirely in the central portion of the City, east of the San Diego Freeway (I-405) and north of the Glen Anderson Freeway (I-105) in Los Angeles County, California. The proposed alignment for the Project would be primarily located within the public right of way along Market Street, Manchester Boulevard, and Prairie Avenue, with limited encroachments on adjacent private property

Environmental Topics Evaluated/Potentially Significant Impacts: The Draft EIR examines the potential impacts that would be generated by the ITC Project for the following environmental topics: Aesthetics, Air Quality, Biological Resources, Cultural Resources, Energy, Geology and Soils, Greenhouse Gas Emissions, Hazards and Hazardous Materials, Land Use and Planning, Noise and Vibration, Population, Employment, and Housing, Transportation, Tribal Cultural Resources, and Utilities and Service Systems. Less than significant impacts are identified for the following topics: Aesthetics, Energy, Greenhouse Gas Emissions, Hazards and Hazardous Waste, Noise and Vibration, Land Use and Planning, Population, Employment, and Housing, and Transportation. Potentially significant impacts are identified related to the following topics: Air Quality, Biological Resources, Cultural Resources, Geology and Soils, Tribal Cultural Resources, and Utilities and Service Systems. Measures are identified to mitigate all potentially significant impacts to less than significant.

Alternatives Evaluated: (1) No Project, (2) Bus Rapid Transit (BRT) System, (3) Market Street Pedestrian Promenade, (4) 4th Station Alternative, (5) Prairie Avenue Single Station Alternative and (6) Maintenance and Storage Facility Relocation Alternative.

### Black Pediatricians Discuss Vaccinations for Children

Doctors look for vaccines to further protect children and their future

Whether a parent, teacher, or family friend, you have seen at least one effect that this pandemic has had on children, including developmental issues, the widening education gap, and fewer wellness visits. In the United States, more than 5 million children have gotten COVID-19 and more than 763 have died from the disease. Since Delta, 1 in 5 new COVID-19 cases have been in children.

Vaccinating children who are ages 5 and older can help protect kids and slow the spread of COVID-19 and is another step in getting this pandemic under control.

Parents, teachers, and friends play a crucial role in getting kids back on track and giving them a real chance to experience childhood in its true sense.

With all of these jarring numbers and heartbreaking stories on the toll the pandemic has taken on children, one may ask who to turn to as a medically sound voice that can provide factual, science-based information.

As COVID-19 vaccines are now available to kids

ages 5 and older, we spoke with Black pediatricians who serve as trusted advisors for their patients' parents, and as advocates for every child that steps into their offices.

We asked these local trusted messengers to comment on expected changes if all children who are eligible are vaccinated.

We spoke with Dr. Nina Ford Johnson, MD FAAP,

who has worked in infirmary pediatrics for eight years and serves as the President of the Medical Society of Mobile County. Alabama.

"Some of the problems we're seeing in the unvaccinated children is that they're spreading the illness to parents and grandparents. We're seeing a lot of them miss school because of it. And not just the child, but their siblings

also miss out.

that [do Children become vaccinated], I think it's going to turn [things] around. We need to be able to keep kids in school. Our school system here in Mobile was already far behind.

Also, [vaccinations] will decrease the amount of infectivity among the adults and grandparents. It takes a village to raise our children, and this virus has become a village virus."

Dr. Johnson's words provide a window into the experiences of those who have been on the front lines of fighting COVID-19 in children.

Some parents also have concerns about COVID-19 vaccines that are often not addressed by trusted voices who have cared for our children from the beginning of their lives.

We spoke with pediatrician Dr. Felicia Wilson,

# Bishop Aims to Revive Woodlawn Memorial Park

Once abandoned and overrun with weeds, Compton's historic cemetery looks much better thanks to Celestina Bishop

Last year, Celestina Bishop went to visit the burial sites of her mother, sisters and grandmother on Mother's Day. Her loved ones were interred at Woodlawn Memorial Park in Compton.

However, Bishop's adoring tribute never happened because the cemetery gates were chained shut. At first undeterred, she jumped the fence and landed in garbage, debris and discarded items filling the property.

Encountering such blatant disrespect of the final remains of her relatives was emotionally devastating for Bishop. But, instead of collapsing in tears, she sprung into action to rejuvenate the site and today, she heads the nonprofit that owns the cemetery and aims to refurbish other memorial parks that have fallen into disre-

"My organization, One Section At A Time, was registered on June 12, 2020, just six weeks after I came to Woodlawn Memorial Park to visit my mother, sisters and grandmother on May 10th," said Bishop, who outlined the group's mission as "restoring honor and dignity to Woodlawn" by keeping the gates open for family members and others to visit and promote the historical value and contributions of the cemetery.

The volunteers removed all of the trash and junk cluttering the property and are working on leveling the ground, which became uneven due to lack of water and nourishing soil. On October 19, OSAAT paid off the back taxes on Woodlawn and the owner signed over the cemetery to the organization. With the deed in hand, the OSAAT team is now focused on organizing Woodlawn's official burial records, securing historical status for the cemetery and raising funds to maintain the

property. Woodlawn is full, so new internments are not possible, but the nonprofit wants to continue operating the site so people can visit the graves of loved ones or hold memorial ceremonies for relatives and friends. According to Wilson, a family from Las Vegas appeared last week and stayed for nearly three hours "singing and telling their about grandma." OSAAT will provide chairs, table and tents for gatherings

place of comfort during periods of sorrow, Woodlawn contains a lot of history, too. The oldest tombstone denotes the passing of Abigail Stockwell in 1871. The cemetery also contains the remains of many early settlers of Compton as well as prominent individuals from more recent eras.

"They include Assemblyman Carley V. Porter, called the 'father of water legislation' and an early fighter against water pollution," shared Bishop. "Also, Francis Townsend [is here], who created the Townsend Plan to address poverty among the elderly in the United States; and George Decker, known as 'Gentleman George' and considered one of the best first basemen of the 1890s."

Judy Washebeck, **OSAAT** volunteer and group historian, listed some of the notable African Americans interred at Woodlawn, which include Alprentice "Bunchy" Carter, a social activist and co-founder of the Southern California chapter of the Black Panther Party; Freeman Davis, a 1940s-50s whistling and bone playing recording artist known as 'Brother Bones,' whose playing of 'Sweet Georgia Brown' was adopted the Harlem Globetrotters' theme song; Theolic Smith, a Negro League baseball pitcher, who was nicknamed 'Fireball' for his sizzling fastball; and Paralee Coleman, a child actress who appeared in short films between 1926 and 1937 including playing the character Pleurisy in the "Our Gang" Little Rascals movies.

"Local companies like California Pest Management and RDO Equipment have contributed resources, services and equipment. Also, individual contributions through GoFundMe aided in paying the back taxes," she said. "But, we need to establish additional, stable funding sources through grants, corporate and sponsoring organizations."

While Bishop and the OSAAT team are deeply vested in revitalizing Woodlawn Memorial Park, the continued success of the project is tied to their volunteer efforts and ability to attract consistent funding to maintain the memorial park. Estimating that her family has invested about \$275,000 so far to cover cleaning, repairing and operating expenses, she hopes to implement community involvement and giveback programs for potential

Despite the challenges, Bishop remains optimistic that the goals will be achieved. "We've been successful in bringing joy to family members by restoring and transforming Woodlawn," she said. To ensure future success, Bishop said that she'll be guided by the words of Winston Churchill: "Never give up. Never give in, except to convictions of honor and good sense."

a seismic retrofit. Grants are contingent upon meeting eligibility requirements and available funds.

"EBB's growth is helping more California homeowners prepare for the next big earthquake by offsetting the cost of completing a seismic retrofit," Janiele Maffei, chief mitigation officer of CEA and executive director of EBB. "The EBB program can help Californians protect their families, their homes and their investments, and we encourage homeowners in EBB ZIP Codes to apply for funding during the registra-

tion period this fall." According to CEA, more than 1.2 million houses in high-hazard areas are particularly vulnerable to earthquakes because of the way they were constructed. These homes are typically built before 1980, are wood framed with a raised foundation and may have a cripple wall in the crawl space under the house. Since 2014 when the first EBB retrofit was completed, EBB grants have helped more than 15,500 homeowners retrofit their houses.

"Older homes are particularly vulnerable to earthquake damage, so it's important that homeowners in high-seismic-hazard areas take proactive steps to reduce the risk of their home

slipping off its foundation,"

said CEA CEO Glenn Pomeroy. "CEA is committed to supporting California homeowners through education, mitigation and insurance, and we're particularly proud to offer supplemental grants to help income-eligible Californians complete seismic retrofits."

Beginning October 27 through December 1, 2021, eligible homeowners can apply for retrofit funding at EarthquakeBraceBolt.com, where they can also find detailed program information, select a FEMAtrained, California-licensed general contractor and view the full list of eligible ZIP Codes and program areas. Once registration closes, participating homeowners will be selected through a random drawing and notified via email if they have been selected or if they have been placed on the wait list.

This year, EBB retrofit grants will be available in 395 ZIP Codes. EBB ZIP Codes are selected using following criteria weighted equally between two categories:

1. Earthquake Hazard: Higher-hazard areas were identified using the United States Geological Survey (USGS) earthquake-hazard

map for California. 2. Seismic Vulnerability of Houses: The seismic vulnerability of houses located in California's higher-hazard ZIP Codes was represented by the percentage of pre-1940 houses in each of those ZIP Codes-older houses are more likely to require seismically resistant bracing and bolting.

About Earthquake Brace + Bolt (EBB)

Established by the California Residential Mitigation Program, EBB offers up to \$3,000 to help California homeowners retrofit their house to reduce potential damage from earthquakes. A residential seismic retrofit makes a house more resistant to earthquake activity, such as ground shaking and soil failure, by bolting the house to its foundation and adding bracing around the perimeter of the crawl space. # TO VACCINATE OR NOT TO VACCINAT

The challenge facing Black businesses and the people who work there

responsibility leaves businesses open to negligence claims and workers' compensation claims relating to workplace COVID-19 transmission. Most employers want to protect their employees while at the same time weighing potential liability concerns if vaccines are not required. The owner's desire for balance is not callous—a single lawsuit arising from an employee's death after COVID-19 exposure could literally bankrupt many small or mediumsized businesses.

According to an online source, the City of Los Angeles will require proof of vaccination at indoor restaurants, bars, gyms, shopping centers, entertainment venues and personal care establishments within the city beginning on Monday, Nov. 8. The mandate was initially expected to go into effect on Nov. 4, but because the ordinance did not receive 12 votes from the city council on Oct. 6, the ordinance was unable to go into effect until one month after its publica-

Vaccines have been readily available since December 2020; yet, approximately 1,500 Americans are still dying of COVID-19 each day. To ignore this fact is not only detrimental to the health of everyone but puts those businesses not adapting or applying some sort of preventative COVID measures in place puts their business at risk.

tant to get vaccinated due to their distrust of mandated vaccinations, American government has earned the trust of most Americans. Health officials suggest that this choice, while difficult for some, is the only option. Initially, most employers have been hesitant to implement a mandatory vaccination policy, but as time progresses and as the virus lingers, businesses are finding themselves in a "no choice" position.

The EEOC has approved mandatory employee vaccinations as an acceptable path in the fight against COVID-19. And, although this option may seem risky and/or heavy handed, there are a plethora of reasons employers would consider

duce absences and a loss of productivity while avoiding potential liability. Although implementing a mandatory policy does have many risks (considering some medical issues or religious beliefs prevent some employees from being vaccinated), under applicable laws, an employer's duty and responsibility for the safety of its customers, employees, and community, outweighs any personal anti-vaccination beliefs aside from religious or medical objections.

In an article written by the Association of Corporate Counsel (ACC), in December 2020, the EEOC issued guidance related to this dichotomy. First, the EEOC announced that a vaccine is not a medical exam. Accordemployer who administers the vaccine is not seeking information about an employee's current health status or impairments. Accordingly, administering a COVID-19 vaccine is not prohibited or limited by the ADA."

With the guidance updates, one legal pitfall is therefore avoided - an employer does not have to justify a mandated vaccination policy. However, although the vaccination itself is not a "medical exam," pre-vaccination screening questionnaires may implicate the ADA's prohibition on disability-related inquiries or Title II of the Genetic Information Nondiscrimination Act (GINA), and employers must craft such inquiries to not run afoul of those laws.

For example, employers must demonstrate the disability-related screening inquiries such as any prior allergic reactions are "job-related and consistent with business necessity" to not conflict with the ADA's prohibitions on gathering medical information. Further, an employer can meet this showing only if it can demonstrate the employee is a direct threat to the health or safety to him or herself or others. This multi-step analysis can feel like navigating land mines to an employer trying to keep its employees safe.

One way to avoid this problem and still maintain a mandatory vaccination policy is to require employees to receive their vaccinations from a third party with whom the employer does not have contract with (e.g., a pharmacy or private healthcare provider).

#### Not To **Vaccinate**

The other option employers have is to do nothing and ignore the issue altogether. An employer/ business that chooses to do nothing or remain silent, while this may be the most comfortable, has the most risk. Certainly, this approach would avoid the difficulties in navigating through ADA, GINA,

Title VII, and other complicated restrictions. Further, this option would avoid potential clashes with those employees who simply do not want to be vaccinated - not for a religious or medical reason, but based on personal beliefs.

However, while employers can circumvent these hurdles by turning an eye, other risks grow exponentially. OSHA is hardening its approach to enforcement of safety measures relating to CO-VID and California which is a pro-vaccination state. They are coming down even harder than other states on those business which elect to do nothing.

Whether to vaccinate or not is not an easy question, and the answers are just as complex. But it is a choice that businesses and business owners must deal with. Employees also have to deal with this issue, and some have elected to walk away from their position in a need to stand up for their beliefs.

This is not an attempt to pass judgement on those who elect to go either way. It is however a look at the reality of choice facing those within our community for the very survival of our community businesses and those who reside within it.

### Post-Traumatic Stress Disorder in the Spotlight This Veterans Day

Up to 500,000 Veterans Who Served in Iraq and Afghanistan Have Been

Diagnosed With PTSD

On Nov. 11, we will honor the men and women who served our country, and acknowledge their heroism and sacrifices that have helped protect our freedoms since our nation's birth.

However, their patriotism and service comes at a very high price, especially for those who have been involved in military conflicts. Many of these heroes struggle long after they have been discharged with the real and daunting effects of Post Traumatic Stress Disorder.

Because of PTSD, many veterans a experience nightmares and flashbacks as they relive traumatic events they experienced on the battlefield, which have become seared in their memories and are adversely affecting their mental health.

of 60,000 Iraq and Afghanistan veterans, 13.5% screened positive for PTSD,

In one major study

while other studies show the rate to be as high as 20% to 30%. As many as 500,000 U.S. troops who served in Iraq and Afghanistan may have been diagnosed with PTSD, according to the study. And, according to the

U.S. Department of Veterans Affairs, a National Vietnam Veterans Readjustment Study found differences among African American and white Vietnam theater Veterans in terms of readjustment after military service. Black male Vietnam Veterans had higher rates of PTSD than whites. Rates of current PTSD in the study were 21% among African



Americans, and 14% among Whites.

"For those veterans who are struggling with PTSD, they are often affected in many different ways," said Dr. Luis Sandoval, a psychiatrist with Kaiser Permanente Southern California. "They all have one thing in common, however. They often experience significant challenges when it comes to handling daily activities such as going to school having healthy relationships with their spouse, children, friends and loved

KAISER PERMANENTE ONES. That can often lead

to shame, anxiety, social withdrawal, sleep disorders, or even suicide."

Dr. Sandoval noted the simplest triggers can make someone with PTSD feel like their nervous system becomes hijacked by a panic reaction, and that can cause you to fight (get anproblems with sleeping. gry), flight (avoid) or freeze (feel numb).

Certain factors increase the chances of someone

developing PTSD, Dr. Sandoval added. They include having directly witnessed or repeatedly experienced the aftermath of a very intense or long-lasting traumatic event, which is common among many veterans.

According to Dr. Sandoval, doing the following may improve a person's path to recovery from PTSD: Always attend scheduled counseling sessions and doctor's appointments.

In times of anxiety, reas-

sure and comfort yourself. Avoid alcohol, caffeine, nicotine and illegal drug use, as they can raise your anxiety level and cause

Make sure you get sufficient rest.

Exercise.

Use proven relaxation

techniques.

Get involved in your community.

Dr. Sandoval emphasized the importance of knowing when to seek help. That's because there are times when PTSD can cause severe anxiety and other challenges that require medical attention to ensure good mental health.

"If you have thoughts of hurting or injuring yourself or others, then call 911 right away," he stressed. "Also, if you feel your state of mental health isn't improving, or if your symptoms get worse, then you should contact your health care provider. Remember, there's no shame is seeking help."

# Los Angeles Unified Board of Education Approves Resolution in Response to Noxious Odor Near Dominguez Channel

The Los Angeles Unified Board of Education passed the "Keeping Schools and Communities Safe and Supported in Response to Noxious Odor Near Dominguez Channel" resolution, authored by Board Member Tanya Ortiz Franklin.

The resolution commits
Los Angeles Unified to take
all necessary steps to maintain the safety, health and
wellness for all students,
staff and schools in the Carson Community of Schools
and surrounding Communities of Schools, including
assessing and responding to
the impact of this event on
students and staff who may
have relocated or may have
missed school.

The resolution also affirms that the Board of Education stands in agreement with the decision of the City of Carson and the Los Angeles County Board of Supervisors to declare a local emergency and call on the Governor to do the same in response to the odorous nuisance near the Dominguez Channel.

"For a month, our schools and communities have been dealing with an odorous nuisance, which has impacted our health and quality of life. This is a stark reminder that our most vulnerable communities continue to be negatively impacted by environmental injustices," Board Member Ortiz Franklin said. "I invite our local and state government agencies to work collaboratively alongside us to develop a proactive and equitable approach to address climate change, starting with restoring the Dominguez Channel."

"I stand with the Los Angeles Unified School Board and other local leaders in seeking a more urgent response regarding the Dominguez Channel odor that continues to disrupt school activities in the Carson area," Interim Superintendent Megan K. Reilly said.

"All of our students and families deserve safe, clean air to breathe—and for far too long, our low-income communities of color have had to endure the effects of

environmental injustice," Board Vice President Nick Melvoin said. "We are proud to stand with the kids, families and residents of Carson and demand action to protect the health and safety of their community."

"The lack of urgency in addressing the foul stench in Carson is more than a smelly distraction for our students, employees and the greater community," Board Member Dr. George J. McKenna III said. "This environmental emergency deserves the same urgency as wildfires, earthquakes and natural gas leaks. I join the call for all levels of government agencies to speed up corrective actions and ask that Governor Gavin Newsom declare a state of emergency. The health of our students cannot wait any longer."

"We must call out environmental justice each and every time," Board Member Mónica García said. "I support Board Member Tanya Ortiz Franklin and community partners working hard to address this local emergency."


"Carson and surrounding communities, that are home to mostly low income, people of color who have historically had to cope with the effects of giant, nearby refineries and other polluting industrial sites should not be having to suffer through the sickening and health impacting foul odors from the Domin-

guez Channel," Board Member Scott M. Schmerelson said. "Local government has clearly failed the families living in this area. The one bright light in this sad story has been the Los Angeles Unified Office of Environmental Health and Safety that continues to monitor the situation and work with Los Angeles County and the South Coast Air Quality Management District to measure air quality every day, in both the community and at schools, and take proactive steps to ensure the safety of students and school staff, including keeping students indoors when most impacted by the smell."

"When community health is jeopardized there must be a sense of great urgency, no matter where it occurs. Keeping kids indoors or having them stay away from school is not any part of a good solution, even in the short term," Board Member Jackie Goldberg said. "Aggressive, proactive steps are necessary to ensure school safety in Carson and we support the decision to declare a local emergency. Governor Newsom should be quick to follow suit "

### Young, Black adults had a higher risk of heart disease, worse hospital outcomes

During a decade of study between 2007 and 2017, young, Black adults in the U.S. (mean age of 31 years) experienced increased cardiovascular disease risk factors and worsened hospital outcomes, according to preliminary research to be presented at the American Heart Association's Scientific Sessions 2021. The meeting will be fully virtual, Saturday, November 13 through Monday, November 15, 2021, and is a premier global exchange of the latest scientific advancements, research and evidence-based clinical practice updates in cardiovascular science for health care professionals worldwide.

"Many potential factors seem to be responsible for these findings, including less frequent annual wellness visits; absent or insufficient screening measures at a younger age; genetics; stress; an unhealthy diet; a lack of awareness or insight into a healthy lifestyle; and even financial constraints," said Ankit Vyas, M.B.B.S., M.D., the study's senior author and an internal medicine resident at the Baptist Hospitals of Southeast Texas in Beaumont, Texas.

Researchers also examined outcomes of hospitalizations in the two data sets that included death, hospital discharge status, and major adverse heart and brain conditions such as heart attack, heart rhythm disturbances, sudden cardiac death and stroke. Despite advancements in medications and improved

screening and diagnostic

techniques in the last decade, in-hospital outcomes worsened over the course of the 10-year study period.

Researchers found a nearly 20% increase in the risk of major adverse cardiac events among young, Black adults from 2007 to 2017, including:

a 30% increased risk of heart attack and heart rhythm disturbances;

a 90% increased risk of a blood clot in one of the big arteries (pulmonary) of

a 150% increased risk of out-of-hospital cardiac

a 200% increased risk of cardiogenic shock; and a 50% increased risk of

"Young, Black adults should be encouraged to have regular primary care visits and get annual wellness checkups so any health abnormalities may be noticed at earlier stages, before there are serious health consequences such as a heart attack or stroke," noted Vyas. "Young people must also be aware of factors that can cause heart disease and understand that heart disease can lead to disability and premature death. Prevention is an im-

portant first step." Vyas noted that incorporating regular physical exercise, sports participation and healthy food options such as fruits and vegetables into the daily lifestyle can help to prevent or control of hypertension, type 2 diabetes and obesity, while meditation and yoga may help reduce depression. Abstinence from alcohol and tobacco use should encouraged among young people.

"There should be more public awareness about the existence and availability of health counseling, health campaigns and health fairs that can be accessed through nonprofit

organizations, community service and the physician" he said. "Young people should be encouraged to work with case managers, social workers, physicians, nurses, pharmacists or other health care professionals to learn more about affordable options that may be available to them."

Limitations of the study include that it was based on data from a population at a specific time and did not include follow-up on data, medication history or lab findings. In addition, information about the burden and impact of electronic cigarettes and vaping or the use of recreational cannabis (marijuana) on the cardiovascular health of young adults was not included in the analysis.

"Future research is needed to evaluate factors responsible for increased prevalence in smoking, depression and obesity,' Vyas said. "We should also explore the impact of substance abuse, sedentary lifestyle and uncontrolled cardiac risk factors on health outcomes among young, Black adults, including all age groups starting in adolescence. It's important to develop effective strategies to manage risk factors, especially as studies are reporting an increase in unhealthy lifestyle behaviors during the COVID-19 pandemic.'





### Faith Leaders Learn to Build Communities of Wealth

USC Cecil Murray Center sponsors session for clergy and lay to outline steps to teach congregations to be financially secure

Faith leaders can play a decisive role in helping African Americans and other minorities become financially secure and the USC Cecil Murray Center for Community Engagement is preparing clergy and lay to achieve that goal.

Through online interactive sessions, the Murray Center outlines the steps that pastors and faith-based influencers can take to educate their members. The series kicked-off on November 3 with a webinar entitled, "Building Back Wealth in Communities of Color" and scores of people tuned in for the class.

The Rev. Dr. D. Na-Smith-Pollard, juma CMCCE program manager and pastor of Word of Encouragement Community Church in L.A., moderated the 90-minute event, which was co-sponsored by CIT-One West Bank.

The program also included the Rev. Frank Jackson, CEO of The Group of Village Companies in Irvine and a corporate financial executive with 20-years of experience; and the Rev. Donald Cook II, pastor of Harvest Tabernacle Bible Church in L.A. who holds Bachelor's and Master's degrees in business and management.

As part of CMCCE's ongoing effort to equip faith leaders to transform underserved areas, Smith-Pollard explained that the session would focus on "elevating your commu-

nity" through strategies on economic recovery and wealth building. The panelists also shared practical actions that could yield significant results for churches and organizations.

"Last year, the Murray Center hosted sessions around how to financially maintain [ministries] during the pandemic. Now, we want to begin to talk about building back wealth and how the faith community can take lead in teaching communities of color how to prepare for the future," she said in her introductory remarks.

"We also want to encourage you to think critically how this information can be shared with your congregation or the people you serve," added Smith-Pollard, acknowledging that nonprofit and faithbased groups could impart the strategies to their constituents as well.

"Remember, your people are your number one asset. When they are strong, the church or organization is strong," she insisted.

Following her comments, the Rev. Dr. Cecil L. "Chip" Murray delivered a brief welcome address.

Next, Jackson opened the first section of the program by discussing the state of wealth across demographic groups and the definition of wealth as perceived by different age groups and ethnicities. Emphasizing that his goal was to persuade people to be responsible stewards, he then proceeded to cite the facts and principles that assist with wealth building.

"The difference between your assets minus your liabilities equals wealth. You may want to create a survey to find out how your congregation or the people you serve and work with see wealth," said Jackson, who is also an associate minister at New Mount Pleasant Missionary Baptist Church in Inglewood.

Noting that generational wealth often evolves from inherited property such as houses or land, he said that minority groups fall often behind since they have a lower number of homeowners and less income, which leads to the disparity.

"According to the 2020 U.S. Census, the poverty rate is 23-to-25% in the Black and Hispanic/Latino communities and 9% in the White community. Highlighting this issue of concern within your congregations and then pulling resources from within your congregation [can] help you establish your wealth building ministry," he said.

Education also aids in building wealth, said Jackson, who cited that a four-year college graduate makes about \$30,000 more than a high school graduate in entry-level positions. Also, he recommended increasing finances by reducing credit card debt because "the more debt a person has, the less opportunity."

Another fact he brought up was that the nation's 48 million Black Americans have \$1.3 trillion in spending power, yet Jackson still urged, "We want our congregations or those that we're servicing to be better stewards over their resources."

Cook stressed the importance of generating income to build wealth. The added funds may be the result of employment salary, financial investments or other business activities. He also explained the distinction between bad debt and good debt.

"Bad debt is that which does not increase wealth and or is used to purchase goods and services that have no lasting value.

"Good debt is that which increases your network or helps you generate a value that allows you to manage your finances more effectively, to leverage your wealth to buy things you need and to handle unforeseen emergencies," expressed Cook.

He went on to urge attendees to consider their debt to income ratio, which will aid in securing credit worthiness. Two other acts he recommended was saving half of your income and maintaining a credit score between 742-to-799.

"Lenders determine insurance rates and set premiums for auto and home loans depending on your credit score," he said. "There are even landlords out there [who] want to know where is your job, what position you have, how much you make and what's your credit score because they want to make sure that you can afford the rent or price."

Cook advised the audience to visit creditkarma. com or freecreditreport. com to obtain credit scores. He also listed some of the pathways to wealth and named entrepreneurship or starting your own business as the first way to add in-

"The scripture says your gift will make room for you. Find out from your congregation what gifts they may have, then show them how to go into this entrepreneurial opportunity, how to properly set it up, how to get the business licenses, etc.," Cook said, adding that investments and real estate are also optional ways to increase wealth.

The session and other resources are available at crcc.usc.edu/events-andtraining/murraycenter/. "Building Back Wealth in Communities of Color" will be presented online again on Friday, December 3, at 10 a.m.

### Biddy Mason Charitable Foundation Supports Foster Youth

Supporting foster children guides the mission of the Biddy Mason Charitable Foundation. The nonprofit, founded in 2013, develops a range of programs, services and initiatives to ensure the success of young people in the L.A. County system.

Mainly comprised of First AME Church of Los Angeles congregants, the organization's volunteer team also includes members of other denominations as well. Binding them together is a deep love and concern for the well-being of foster children.

"Los Angeles County is home to the largest foster care population in the nation. We felt we were losing too many talented young people to the dreadful statistics of foster care, so we wanted to find ways to support these young people," said Executive Director Jackie Braxton, who shared some of those "dreadful statistics."

Some of the most glar-

ing numbers are 50% of foster youth never complete high school, 15% enroll in college but only 3% graduate, and 25% suffer from PTSD - post traumatic stress disease - and experience high rates of depression and extremely low self-esteem.

The Foundation strives to counter those figures by offering access to higher education and providing mentoring support. Braxton said, "We began a scholarship program in

2018 that has exceeded over \$200,000 in scholarship awards to current and former foster youth. The scholarships are for academic as well as vocational training."

The organization aims to establish a legal clinic tailored to handle issues faced by foster youth and once the COVID-19 pandemic subsides, they will resume hosting outings and events for the children. Also, the Foundation is working to open a one-stop,

walk-in center that caters to the physical, mental, emotional, and social needs of current, former and emancipated foster youth.

Although the number of foster children is large, the Foundation has chalked up some success stories in aiding youth, noted Braxton. "Recently, one of our scholarship recipients who was a senior at Cal State was faced with a car problem. She needed transportation to take her young son to school and then drive a distance to Cal State.

"We were able to work with the Department of Children and Family Services to identify funding to repair her car and ensure her on-time graduation. This is a clear example of our ability to collaborate with an agency to provide support," she recalled.

In another instance, the Foundation assisted a young lady attending college out-of-state, said Braxton.

"She was experiencing challenges in getting housing and meeting her expenses. We were able to work with the university to resolve her housing issues and provide gift cards to

meet her other needs." The Foundation operates in a similar manner as its namesake, Bridget "Biddy" Mason. A former slave, Mason was a nurse, philanthropist and real estate entrepreneur. She accumulated close to \$300,000 (the equivalent of \$9 million today) that she shared with charities and the poor.

Mason also opened a traveler's center, operated

an elementary school for Black children and was one of the first African Americans to purchase land in the city. In 1872, she donated the land to establish FAME, the oldest church in L.A. founded by Blacks. Biddy Mason Park, located at 3rd and Spring Streets, features an artistic illustration of her life.

The Biddy Mason Charitable Foundation welcomes volunteers and contributions. As Braxton vowed, "We're going the distance to make a difference for foster youth."

# 'Rethinking Reparations: A Collective Solution, Not Separate Settlements'

Even though it no longer appears as a major item of interest on the nightly news, the issue and pursuit of reparations remains a critical and urgent concern for African peoples throughout the world African community. For reparations is an ethical and social issue of justice for a people, accountability from the oppressor, and an essential part of our unfinished fight for freedom. Thus, we are compelled to re-think carefully and continuously how we conceive and approach this critical issue and struggle.

The reparations struggle and, thus our people, are at a critical juncture of decision-making and moving forward. It is always at such critical junctures in a people's history, especially at the unfolding moment of expanding victory, that a people and its liberation movement must make a decisive choice. They must decide to firmly and fearlessly forge ahead with their original goals or seek instead lesser and more attainable goals within the established order of things.

And it is at this time of both impending victory and heightened vulnerability, that the established order comes bearing strategically offered gifts of monies, artificial honor, symbolic inclusion and place and well-worded confessions of wrong done and guilt felt. But these confessions are crafted to benefit those in power, to frame and define the issues and discourse, to divert attention away from the major crimes and the more demanding requirements of reparations and to foment fracture and fragmentation and encourage separate settlements. Thus, we have almost everyone but the federal government offering monies and means, not only to repair the still debated injury, but also to reconcile with white folks, an open-end process which throughout history asks more from us, the injured, than them the injurers.

In such a system salvaging arrangement, we lack a united front and unified approach and agenda, common demands, and we find ourselves making separate settlements with cities, states churches, universities, synagogues, corporations, foundations and goodwill liberal ambassadors who thrive on reconciliation and Black declarations of forgiveness and love. This separate settlement process and practice, on one hand, is understandable, given the economic urgencies, and the current absence of a structure for the united front approach advocated here. But with a more critical look, we can see that this piece-meal approach is inadequate, deceptive and more symbolic than substantive. For the monies are mere small millions, not the trillions estimated due. and they go to groups, not to the masses of our people who need it most. And also important, the masses of our people are not participating, as they should, in the critical decisions about definitions, what's due and modes of delivery.

There is in this struggle for reparations a need, as Haji Malcolm taught us, to place this in historical context. For all real thinking requires remembering. It is here we see the larger picture, the larger struggle, the struggle not only for compensation for injuries done and continuing, but also for racial justice in a larger sense and to finish the unfinished fight for freedom. The struggle for reparations is raised and pursued soon



after the Holocaust of enslavement by Nana Callie House and her co-worker and co-combatant, Nana Isaiah Dickerson, with the founding of the Ex-Slave Mutual Relief, Bounty & Pension Association (1898). For it was and remains a burning issue of needed justice and an unfinished freedom for our people.

Thus, from its inception, reparations has been an emancipatory, a liberational project, not only a compensatory one. In other words, it is a larger project than one of money and wealth, although money and wealth are indispensable elements of it. Again, it is about justice and finishing the liberation project of our people, achieving a freedom that is real in every realm, including economics. And this is why it must not be separated from our larger struggle to free ourselves and be ourselves without penalty, prohibitions, or any form of

Reparations re-emerged as a central focus for several reasons. First, it was because of the long term and consistent organizing work and political education of the community, organizations and persons committed to it, especially the Black nationalist organizations. Among these are: the Nation of Islam-Messenger Muhammad and Haji Min. Malcolm X; N'COBRA - Dr. Imari Obadele and Oueen Mother Dorothy Lewis; and the Reparations Committee For United Slaves Descendants founded and led by the Venerable Oueen Mother Audrev Moore.

Of course, in the 60s, reparations discourse and initiatives were widespread and our organization Us participated in these initiatives. At a symposium on "Black Studies in the University" at Yale University, 1967, I had put forth three things that White people who wanted to contribute to the struggle against systemic racism could do: non-intervention—ending interference and oppression in the Black community, considered an internal colony, and conceding its self-determination; foreign aid - financial and technical aid and a civilizing committee to deal with the racist savagery believed and practiced by their fellow community and family members.

Certainly, we cannot forget or underestimate the groundwork laid by the Hon. John Conyers whose reparations bill, HR 40, put reparations on the congressional agenda since 1987 and was finally moved out of committee by Sheila Jackson Lee in 2019. Also, Atty. Randall Robinson, longtime leader of Trans-Africa, offered a groundbreaking conversation on reparations in his work The Debt: What America Owes To Blacks. It served as a key work by a professional introducing this topic on a wide scale to the middle

class of which he is a mem-

Also, building on work

and discourse already in place and in motion, the reparations discussion and movement is further expanded by the entry of a larger number and key members of the middle class - academics, writers, lawyers, legislators and influencers. The signature conversation for the entry of a larger number of the middle class is an article on reparations by the writer, Ta-Nahesi Coates, in the Atlantic, titled "The Case for Reparations." Also, important here are Atty. Charles Ogletree and economist, Dr. William Darity and others. But it is important to realize, that the rise in this reparations discourse is rooted in the development and sustaining work and struggle before it.

Finally, the discourse and activities are expanded, building on the original base, by the rising tide of anti-racist struggles, marked especially by the Ferguson Revolt and increased initiatives against police violence; the rise of Black Lives Matter during and after this; and the public murder of George Floyd and the combined and related murders of Breonna Taylor, Ahmad Arbery, Eric Garner, Amadou Diallo and numerous others and increased resistance.

As a new and expanded round of reparations discussions and discourse take place, it is vital for us to maintain control of how we define and pursue this world historical project. Indeed, it is important to look back, remember and reflect and continuously rethink our ideas and efforts and the manipulative and suppressive moves of the system which acts at all costs to salvage and save itself and to get us to join in saving the abstract "soul" of America at the expense of the people of America, especially the most vulnerable and oppressed.

Reparations, in most essential meaning, is an ethical act, repairing an injury, making right a wrong and ultimately doing justice to the injured and the world. For in our world-encompassing concept of reparation, we are to practice in our lives, work and struggle serudj ta, the ancient African Maatian ethical imperative to heal, repair, renew and remake ourselves in the process and practice of repairing, renewing and remaking the world. This means maintaining the emancipatory and liberational foundation and focus of the reparations struggle, linking it to our overall struggle to free ourselves and be ourselves, and to ensure ongoing African and human good and

### Our criminal justice system needs dramatic reform

Three current cases illustrate the need: Jelani Day in Peru, Illinois; Jacob Blake in Kenosha, Wisconsin; and Ahmaud Arbery in Brunswick, Georgia.

In the civil rights movement we were constantly reminded to keep our eyes on the prize. What's the prize? Equality of opportunity and results, which requires equity in every facet of our lives — education, housing, home ownership, job training, employment, political access and especially in the criminal justice system.

Our criminal justice system needs dramatic reform. Blacks make up more than 40% of the prison population, but only 13% of the nation's population. The geographic numerator changes - north or south — but the denominator remains the same - an unjust criminal justice system nationwide. Three current incidents illustrate: Jelani Day in Peru, Illinois; Jacob Blake in Kenosha, Wisconsin; and Ahmaud Arbery in Brunswick, Georgia.

Jelani Day, a 25-yearold Black medical student at Illinois State University, was a "bright light" in his family; he and his sister were competing to become doctors. He disappeared on Aug. 24. The family and a professor reported him missing on Aug. 25. His car was found two days later in a wooded area near where his body was later discovered in Peru, Illinois, miles from where he was last

LaSalle County law enforcement officials discovered his body on Sept. 4 "floating near the south bank of the Illinois River approximately a quarter-ofa-mile east of the Illinois Route 251 Bridge."



The parents continue to be critical of the investigation because little focus was initially put on his disappearance. It occurred in the context of the vanished and subsequent death of Gabby Petito, which was receiving national coverage.

There are inconsistencies, a high degree of incompetence and a lack of collaboration between various law enforcement agencies surrounding the case. There is still no closure about what happened to Jelani Day.

Rusten Sheskey, accompanied by two other white police officers responding to a domestic complaint by the fiancee of Jacob Blake — a Black man shot Blake seven times in the back, with his children obey the officers, so they opened his car door and reached inside. Blake was left partially paralyzed by the incident. Racial violence followed in Kenosha. Officer Sheskey was not charged with a crime.

As disturbances continued, a white 17-year-old

"We're coming together from all over the country to build a comprehensive educational program that encourages barbers to talk to their clients in the Black community about the urgent need for HIV testing, prevention, treatment, and care," said Jackson.

Black/African Americans account for 13% of the US population yet they also account for 42% of new HIV diagnoses in the United States. Forty years into the HIV pandemic, Black/ African American men are eight times more likely to have HIV than White men, and Black/African American women are seven times more likely to acquire HIV than White women. Black/ African American men are also less likely to know their HIV status, putting their own health at risk and potentially transmitting HIV to others.

Fade Out HIV aims to address these disparities by educating Los Angeles County and other barbers attending BarberCon LA, who have a high percentage

of Black patrons. Barbershops have always been an essential staple in the Black community; the Black barbershop is a safe space where the barber serves as not only a stylist, but also as a counselor. The long and trusted relationships between barbers and their clients makes barbers ideal partners for education and linking their clients to HIV testing and care.

"Giving African-American men the opportunity to address sensitive health issues with community members they trust - such as their barbers - is vitally important and when linked with trusted physicians, has been shown to improve health care outcomes." said William D. King, MD, Founder of the W. King Health Care Group and an expert advisor and faculty member for Fade Out HIV. "There is well-documented mistrust of medical professionals in the Black community, so clinician education alone is insufficient to address this issue," stated Oni Blackstock, MD, founder of Health Justice and a faculty member for Fade Out HIV.

Barbers attending BarberCon will take part in several educational initiatives featured at a special VIP session, a main stage presentation, and a specially designed booth. The education will focus on HIV in the Black population and will cover topics including racial disparities of HIV and the importance of HIV testing, HIV prevention, and treatment. The education will also cover how barbers can discuss the sensitive subject of HIV with

their clients. Following the BarberCon program, we will fan out in the community to provide individual education to local barbers along with patient education materials.

"We see BarberCon LA as a unique opportunity to launch Fade Out HIV in the Black community. This is not just an episodic moment but an opportunity to create a major movement in the Black community to end the spread of HIV once and for all," said Tony Wafford of I Choose Life Foundation

DKBmed has also created an educational program for clinicians in Los Angeles who work in the Black community and for others across the country. This educational webcast will launch in December 2021 and address issues including testing for HIV, using pre-exposure prophylaxis (PrEP) to prevent HIV, and initiating treatment for people with HIV. "We will place a special emphasis on educating Los Angeles area clinicians in order to provide a referral network for barbers," said Dean Beals, President and CEO of DK-Bmed. After completing the clinician education, Los Angeles area clinicians will be encouraged to join a referral network so that clients referred by barbers can find an educated and qualified clinician for testing, prevention, and/or treatment and care.

Barbers who attend the educational programs at Barbercon will be provided with a list of these clinicians so that they can more effectively connect their clients to clinicians who are prepared to discuss and address their specific health

To incentivize the client to visit the clinician, clients who see their health care provider will be rewarded with a coupon for a future

# Would You Pressure Your Kid's Coach to Apologize for Winning by 106-0?

Coaches push the athletes they train to put their all into mastering the mental and physical aspects of their sport, preparing them to edge out competitors and perform at the height of their abilities.

But there are real-life situations, it seems, when attaining excellence proves to be too much - or maybe just not good enough.

This seems to have been the case Oct. 29 when an impressive shutout victory for Inglewood High School in Los Angeles County ended up turning into a bitter crosstown game of guilt, blame and grievances. That day, Inglewood High football coach and former Cleveland Browns defensive back Mil'Von James led his team to a 106-0 victory over rivals Morningside high.

Since that shellacking, education authorities have blasted James and Inglewood High for being too focused on winning that they failed to exhibit a spirit of

compassion and sportsmanship.

California Interscholastic Federation -Southern Section (CIFSS), the governing body of high school athletics in the state, released a scathing statement regarding the wide margin of the game's final

"The CIF Southern Section expects that all athletic contests are to be conducted under the strictest code of good sportsmanship. "We expect coaches, players, officials, administrators and students to adhere to the Six Pillars of Character -Trustworthiness, Respect, Responsibility, Fairness, Caring and Citizenship," CIF-SS fired off in a state-

"A score of 106-0 does not represent these ideals," the statement continued. "The CIF-SS condemns, in the strongest terms, results such as these. It is our expectation that the Inglewood administration will work towards putting in

place an action plan so that an event such as this does not repeat itself."

James, 38, said it was not his intention to degrade or demoralize the Morningside High team.

"I apologized for the way things turned out," James said even though, during the game, he benched his defensive starters after the second quarter and most of his other frontline players in the second half.

But Inglewood continued to run up the score on its hapless opponent.

Anyone who knows James personally would know - and can attest to the fact -- that his intent was never to bring shame to the game that he loves.

Coaches like James who have played college and pro-football understand the fierce competitiveness it requires for young people to succeed when pursuing careers as professional athletes. They train their students to be warriors, to dominate their opponents.

Varsity sports is the highest for the Bruins from 2003level of competition in high school. Today, the advancement of training techniques and year-round coaching and development increases the likelihood that schools with the resources will outperform schools with sports programs that are underfunded or under-supported.

Since he became coach at Inglewood High three seasons ago, James has taken the team from a losing streak to being nearly undefeated. During that time, the team has moved from CIF-SS Division 13 to Division 2.

Inglewood student athletes have advantages in coaching and preparation that Morningside and many other schools do not.

James was a star on the football squad at Fremont High School in Los Angeles where he graduated in 2003. In college, he first played for the UNLV Rebels where he led the nation in passes; before transferring to UCLA and playing

2005.

After brief stints in the NFL and the Canadian Football League on the roster for the Cleveland Browns and the Vancouver Lions respectively, James began coaching high school football.

He is the founder and director of one of most successful 7 on 7 leagues in the nation, responsible for scores of future and current high school, collegiate and professional players.

Chances are, if you have served any top football program in California, you have you witnessed his impact on young players, their development and their unmatched leadership skills on the field and off it.

The Inglewood Unified School District also blasted James and Inglewood High.

"Regarding Inglewood H.S. vs. Morningside H.S. Friday night 10/29 game, we at the Inglewood Unified School District (IUSD) are saddened beyond words

by the events that transpired at the football game Friday between Inglewood and Morningside high schools," the IUSD stamen read. "We will conduct a full investigation and take whatever steps are necessary to ensure that a similar outcome never happens again under an IUSD athletic program."

High school sports, in many schools, is a training ground for college and pro athletes. Schools that have better resources will always have an edge.

It is unfortunate that this incident has placed a dark cloud over a high school sports program. Inglewood High's football program should be celebrated for its league championship and undefeated record in a school district that is still in state receivership.

## Different Summit, Same Story for the Polluters, Politicians, Privileged and Poor at Global Climate Mtg

Global negotiations kicked off this week in Glasgow, Scotland in what John Kerry, President Biden's climate envoy, described as our 'last best chance' to avoid environmental disaster. These talks matter to California - so much so that a delegation of elected and government officials led by Lt. Gov. Eleni Kounalakis made the 5,000-mile trip.

The goal is simple: agree to a plan to reduce the emissions that cause dangerous heating. To do that, governments need to end our reliance on fossil fuels, and support less-wealthy nations and communities in their decarbonization pro-

We've been here 25 times before. The 26th UN Climate Change Conference COP26 is a gathering of over 100 nations in search of a solution to the climate crisis. Sadly, since the first meeting in Berlin in 1995, global emissions have increased. By almost every measure, the climate crisis is getting worse. That's visible to Californians in the record wildfires, drought, and extreme weather that has intensified in the past two years.

The science is clear something needs to change right now, otherwise the climate will change it for us. The current businessas-usual trajectory is set to make the world somewhere between 4.5 degrees F to 5.4 degrees F hotter than it was before we started burning fossil fuels. That would mean more droughts, fire, hurricanes, famines, climate refugees, and the list

So far, Glasgow has heard a lot of talk. President Biden and other world leaders touted two 'major' agreements earlier this week. One commits to ending deforestation by 2030, and the other to cut planetheating methane emissions by 30%. But these aren't binding. They are promises, an invitation to take leaders at their word. Many of these leaders promised to halve deforestation by 2020 back at a New York summit in 2014, a promise that was quietly broken.

Despite the looming catastrophe, a tour of the COP26 premises makes it very clear that at these talks, nothing has changed. The same old faces are here - the politicians, the polluters, the big companies, and people representing privileged and largely White in-

Companies sponsoring the talks for a seat at the centre of the action include one of the world's largest plastic polluters (Unilever), a bank (NatWest) that has financed billions of dollars' worth of fossil fuel projects

goods company (Reckitt) whose suppliers included, until very recently, companies tearing down one of the world's last remaining tropical rainforests in Papua New Guinea.

One of these sponsors, SSE, is currently building a new fossil gas plant, even while hosting a friendly stall touting unproven future technologies that might eventually help reduce emissions. Reckitt, meanwhile, are organizing an official side-event titled 'Changing Consumer Behaviour', which appears aimed at deflecting responsibility onto individuals. Presumably, the main recommendation will be to steer clear of their products until they can remove deforestation from their sup-

ply chain. While companies that have had a hand in causing the crisis are overrepresented, notably underrepresented are Indigenous and BIPOC communities, or representatives from the worst affected countries. It is, as many have called it, the richest, Whitest COP

That's a problem ethically, but it's also a big problem because clearly, business as usual hasn't worked. If we want to prevent the worst of what is to come, we need to focus on the interests of people on the frontlines: those who lost their homes in wildfires this year, or who were forced off their land by agribusinesses, or whose air is being polluted by mining projects. We can no longer prioritize the narrow interests of a very noisy but destructive business com-

munity. This matters for California - the state which has long been a leader in the U.S. on climate action

but is suffering the most immediate impacts of the climate crisis right now. If Californians want this state to be liveable for future generations, we need to see through ambitious

action at home – but we also need these global negotiations to be a success.

Right now, we're on track for more warm words, more bold, unmet promises, and more degrees of global heating. Unless this COP and all future climate summits put the worst affected, most vulnerable communities first, we will continue on this disastrous path which will see California and many other parts of the globe become inhospitable for our descendants within generations.

# Black and Latina women less likely to take sick days for fear of retribution



In a new survey of 2,000 working Americans that took a close look at the perceptions and racial disparities surrounding taking sick time. While the COVID-19 pandemic has Americans taking their health more seriously than ever, half of respondents feel discouraged by their workplace to call

out to take care of themselves when feeling under the weather. This stress is felt even more so by Black and Latina women polled, who are 10% more likely than White women to say they avoid sick days for fear of being reprimanded.

Further, Black and Latina women polled reported they're often likely to avoid taking time to rest and recover because of the financial strain. The results found Black women are 14% more likely and Latina women are 8% more likely than White women to say taking an unpaid sick day causes financial strain for her family.

# Houston Astroworld Tragedy: Rapper Travis Scott **Devastated By 8 Deaths**

Fans of the multiplatinum rapper, Travis Scott (born Jacques Berman Webster II), will immediately tell you that you must experience his live show. Scott who is also aptly called by many - the master conductor and crowned king of crowd surfers, stage divers, and chief encourager of the chaotic, is reportedly devasted by the deaths of eight people and injuries to hundreds of fans who attended the latest installment of his "Astroworld" music festival at NRG Park in Houston, TX.

Local authorities stated that during the performance, attendees struggled to breathe, collapsed, and got trampled as the crowd surged toward the front of the stage.

Houston Fire Chief Sam Peña said officials started receiving reports of injured people falling unconscious shortly after the crowd surge and victims were being transported as early as 9:38 p.m. "It seemed like it happened over the course of just a few minutes," said Peña. "Suddenly, we had several people down on the ground experiencing some type of cardiac arrest

On Friday, November 5, 45 minutes after performer, SZA, ended the final set on Astroworld's second stage, a massive countdown clock heralding the arrival of Scott, a native Houstonian appeared, and as the clock moved closer to zero, according to several concert goers, - the hype, the rush, the excitement, and the chaos began. "All of sudden, people compressed up against each other and were pushing forward and backward. As the timer got closer to coming down to zero, it just - it got worse and worse," according to ICU nurse and festival attendee, Madeline Eskins. other concert goer, Niaara Goods, told the Associated Press that "as soon as he jumped out on the stage, it was like an energy took over and everything went haywire. All of a sudden, your ribs are being crushed. You have someone's arm in your neck. You're trying

"Last night was tragic and this is a very, very active investigation," Houston Mayor Sylvester Turner said. "And we'll probably be at it for quite some time to determine what exactly happened." Turner said the concert was officially stopped just after 10PM. According to city officials, eight people died, 300 people were treated at a field hospital onsite at Astroworld, 25 people were hospitalized, and as of Saturday afternoon, 13 concertgoers remained hospitalized. all." A bona fide showman, Scott is no stranger to mayhem at his concerts; in fact, he envisions his concerts as experiences where no standing around is allowed. In the 2015 Netflix documentary, "Travis Scott: Look Mom I Can Fly," the rapper said, "I have been working on this since I was about six years old. I feel like at some points in life, you have to be extreme ... all matters to the extreme."

In a 2015 GQ interview, Scott discussed his childhood fantasy of becoming a professional wrestler and his desire to make his concerts "feel like it was the WWF." "Raging and, you know, having fun and Black, White, Brown, green, purple, yellow, blue, we don't want you standing around."

In 2017, one concertgoer was partially paralyzed after Scott encouraged people to jump from a thirdfloor balcony and then had him hoisted onstage. It was commonplace to find footage of fans in wheelchairs, on stretchers, and crutches across social media platforms after attending an Astroworld event. Fans reveled in Scott's bold stunts - the more dangerous, the better, with one fan declaring "coming to Astroworld saved my life, we are fam-

### Vanessa Bryant Asks Court to Punish County for 'Destroying' Crash Photos

Attorneys for Kobe Bryant's widow today asked a judge to punish Los Angeles County for the alleged destruction of almost all evidence that sheriff's deputies snapped and shared photos taken at the site of the helicopter crash last year that killed the NBA legend, the couple's 13-year-old daughter and seven others.

According to Vanessa Bryant's pretrial motion for sanctions, members of the Los Angeles County Sheriff's Department who were among first responders at the crash on Jan. 26, 2020, improperly destroyed cellphone photos at the direction of Los Angeles County Sheriff Alex Villanueva, who knew he was required to preserve such potential evidence.

"Yet that is exactly what Sheriff Villanueva himself ordered department personnel to do after the department received a citizen's complaint that a sheriff's deputy was showing

photos of the crash site at a crash scene photos, includbar in Norwalk. That order was highly irregular -unprecedented in deputies' experience -- and out of the chain of command. When a captain complained, the sheriff demoted him."

Skip Miller, outside counsel for Los Angeles County, responded that the plaintiff's request for nonmonetary sanctions is a strategic move.

"While the county continues to have the deepest sympathy for the grief Ms. Bryant has suffered, the request by her lawyers for sanctions is an attempt to distract attention from the fact that none of the routine investigative photos taken by county employees have ever been publicly disseminated," he said in a statement provided to City News Service.

Calling the alleged destruction of the photos part of a county "coverup," Bryant's lawyers allege that, after Bryant's lawsuit was filed, nine deputies "discarded or wiped devices that they used to take, share or view"

ing human remains.

public officials deprived this court, the jury, and the community they have promised to protect the ability to learn who they texted pictures to, whether photos were uploaded to the cloud, downloaded to other devices, shared by Airdrop, sent by instant messaging, or transferred by any of the many other ways photos can be shared," the motions alleges.

to determine who else may have received and then forwarded those photos."

The plaintiffs want the judge overseeing the lawsuit to rule in Bryant's favor at summary judgment or issue an order precluding the county from presenting any theory denying that the photos were shared or disputing that the photos depicted the crash victims.

The county's response,

included in the motion, lists the personnel who had access to crash scene photos that were taken as part of the investigation and denies there was any public dissemination.

"County personnel worked tirelessly to secure a massive crash site, identify the victims, and notify the families -- and, as Bryant herself requested, to make sure none of their photos ever became public," county lawyers wrote. "And none have."

The response says that the sheriff's department was shocked when, on Jan. 29, 2020, a citizen reported that he heard a deputy trainee had shown crash site photos on his phone to someone in a bar. Sheriff Villanueva thereupon directed his personnel to begin an immediate inquiry and make sure no photos got outside the department.

"Sheriff Villanueva was keeping his promise to Bryant by making sure no photos got out. The deputies, on and before Jan. 30, 2020, deleted the photos from their phones --

months before this dispute."

The sheriff's department quickly opened an investigation and within days had interviewed 28 deputies, reserve deputies, sergeants and civilian volunteers, the county said.

"The department determined that all personnel who had taken, shared, or received crash site photos had, in fact, deleted them," according to county attorneys. "No one had sent a photo to anyone outside LASD. To this day, and despite media hyperbole about 'leaked' photos, no County crash site photos have ever been publicly disseminated."

Bryant's widow alleges she and her family suffered severe emotional distress after discovering that sheriff's deputies allegedly snapped and shared gruesome photos of the helicopter crash scene, and is seeking substantial damages.

The motion is expected to be discussed at an evidentiary hearing on Nov. 29 in Los Angeles federal

### President Biden hails Milwaukee Bucks for NBA championship, activism

President Joe Biden welcomed the NBA champion Milwaukee Bucks to the White House on Monday, praising team members not just for their achievements on the court, but also for their efforts to promote coronavirus vaccinations and for speaking out after the 2020 police shooting of Jacob Blake sparked protests in Kenosha, Wisconsin.

The Bucks were the first NBA champions to visit the White House in nearly five years, ending a Donald Trump-era hiatus.

"You took a stand for justice and peace in the wake of the Jacob Blake shooting in Kenosha, Wisconsin, and you've gotten people engaged," Biden said. The NBA postponed games in 2020 after the Bucks announced they would not participate in Game 5 of a first-round playoff series as they sought to shed light on what they said were racial injustices facing African-American communities.

The Bucks, led by Giannis Antetokounmpo, seemed genuinely excited to get back to the tradition of NBA champs visiting the White House. Antetokounmpo even posted a video on social media of him practicing his greeting for the president.

honors major league and some college sports champions with a White House ceremony, typically nonpartisan affairs in which the commander in chief pays tribute to the champs' prowess, poses for photos and comes away with a team

But the celebratory visits became highly charged during the Trump presidency as many athletes took issue with Trump's policies and rhetoric on policing, immigration and more. Trump, for his part, didn't take kindly to the criticism from athletes or their on-field expressions of political opinion.

Bucks co-owner Marc

Lasry, a billionaire hedge fund manager, is a prominent Democratic donor.

His son and the team's senior vice president, Alex Lasry, is on leave as he competes in a crowded race for the Democratic nomination for one of Wisconsin's U.S. Senate seats, vying for the chance to take on Republican Sen. Ron Johnson.

Biden didn't make any direct mention of the Lasrys' Democratic ties. But the president at the start of his remarks paid tribute to Ted Kellner, a Wisconsin businessman and philanthropist who served as an honorary chairman of the 2020 Democratic National Convention in Milwaukee, and former Bucks owner Herb Kohl, a former Democratic U.S.

senator from Wisconsin. Lasry slyly suggested he hopes that the team keeps coming back to celebrate championships as long as

Biden is president. "What the hell, why don't we come back for the next four years?" Lasry said. "Let's do it for eight years."

The last NBA team to visit the White House was the Cleveland Cavaliers, just days after Trump was elected president and while Barack Obama was still in office.

said no invitation was coming to the NBA champs before the playoffs even ended as the finals pitted Curry's Warriors against the LeBron James-led Cleveland Cavaliers. James was an outspoken critic of Trump.

The Toronto Raptors visited Canada's parliament after winning the 2019 NBA finals but players made clear they were not interested in a White House visit. The 2020

the White House had paused The next year Trump such visits because of the COVID-19 pandemic.

Trump also disinvited the NFL's Philadelphia Eagles, the 2018 Super Bowl champs, after several players said they would not attend a White House celebration with Trump.

Trump was fiercely critical of NFL players who kneeled during the National Anthem as part of an effort to spotlight the issue of police brutality impacting Black men and women.


