## Colin Kaepernick's NFL Workout Goes Awry

Former NFL quarterback Colin Kaepernick has not played in the NFL since 2017, as a result of kneeling during the national anthem in protest of this country's treatment of minorities and police brutality. There was no NFL rule in existence during the 2016-17 season that Kaepernick violated by his protests and no credible reason cited for the failure of any NFL team to sign him as a 1st, 2nd or 3rd string quarterback during the following season.

Kaepernick was both heralded and criticized for his actions. Some believed his protest had no merit, that racial profiling and discriminatory practices against people of color is a myth. While others felt that an NFL football field was not the right venue, deeming Kaepernick's explanation of his protest as a lack of patriotism, and an affront to veterans and the country.

For some, Kaepernick's actions were viewed as an act of courage and in alignment with other athletes who have used their plat-

forms to bring awareness to civil rights injustices, such as track and field gold and bronze medalists, Tommy Smith and John Carlos, when they raised their fists in protest during the 1968 Olympic Games.

After nearly three years of being away from the NFL, Kaepernick took the field at Charles Drew High School in Riverdale, Georgia, donning a Kunta Kinte T-shirt as he participated in a 40-minute on-the-field workout before seven NFL team representatives, media and members of the public on Saturday.

For what many believe was likely Kaepernick's

last and best chance to return to the NFL, there was a dramatic shift from what was billed as a workout coordinated by the NFL to take place at the Atlanta Falcons' facility in front of 26 representatives of the 32 NFL teams.

Gov. Gavin Newsom nominated Judge Teri L. Jackson, associate justice of the First District Court of Appeal, Division Three, in San Francisco.

If confirmed, Jackson, 63, a Democrat from San Mateo, will be the first African American woman in the history of the state to serve on the court. The

only other African American woman to serve on a California appellate court bench was Justice Arleigh Woods who was a justice on the 2nd District Court of Appeal in Southern California. Former Gov. Jerry Brown appointed Woods, who is now retired, in 1980 during his first governorship.

### **Patrick Joins Senators Kamala Harris** and Cory Booker in White House Race By Lauren Victoria

As doubts grow about the candidacy of former Vice President Joe Biden, other candidates have entered the race for the White House in 2020. In a surprise announcement on November 14, former Massachusetts Governor Deval Patrick, 63, tossed his hat in the ring. Only days before, former New York mayor Michael Bloomberg announced he would also join the crowded field of Democrats competing to take on President Donald Trump.

Former Governor Pat-

rick's late entry onto the presidential stage means that for the first time in history, three African Americans are running for President from one of the

two major political parties. They are Senators Kamala Harris (D-CA), Cory Booker (D-NJ) and now Patrick. The late arrivals have reignited a debate about

"electability" and who can actually win in 2020. Biden's poll numbers falling in Iowa started the debate.

The diversity of the field and Patrick's late run only 80 days before the Iowa Caucuses, have many insiders on team blue worried that a protracted primary fight may hurt the party's chances of beating Trump. Concerns from Wall Street and the "one percent" about Sen. Elizabeth Warren's "wealth tax" ideas have many Democrats, who are more corporation friendly, such as Patrick, re-thinking their

Deculus launched his start-up tech company last year and since then, individuals and businesses are using the app to create personalized emoji-like videos featuring the face of the sender. The "talking head" can deliver catchphrases, inspirational quotes, well wishes, greetings, notifica-

"We intend to offer a newfound tool for digital advertisers via micro-commercials, aka - branded Facepops featuring brand ambassadors or celebrities and internal communication services for small businesses and big box brands like the Los Angeles Rams, Carnival Cruise Line, Rolling Loud Festival, FedEx, and Netflix to impact customer and/or fan experience," added Deculus. 












# Can These Powerful Black Leaders Join Forces to Close the Achievement Gap for Black Children?

When California Superintendent of Public Instruction Tony Thurmond announced the English language arts and math results of the California Assessment of Student Performance and Progress (CAASPP) test last month, we found out that African-American students' scores lagged behind the much higher marks their White, Asian and Hispanic peers obtained.

Statewide, just over 40 percent of all public school students met or exceeded standards in math and 51 percent were proficient in English.

Of those numbers, only 21 percent of African American students were proficient in math, compared with 74 percent of Asian-American students, 54 percent of White students, and 29 percent of Hispanic students. In English, only 33 percent of African-American students were proficient. Compare that with 77 percent of Asian-American students, 64 percent of White students, and 41 percent of Hispanic students.

Five years ago, California adopted the CAASPP assessment tests. Each year since then, our African-American student scores have ranked at the bottom of the results of all racial subgroups in the state.

During that time, the achievement gap between Black students and their White and Asian peers has seen only marginal improvement, while getting wider between our children and their Hispanic counterparts.

The achievement gap between African American and White students was first acknowledged over fifty years ago in a 1966 federal government study called the Coleman Report. The United States Congress commissioned the report after it passed the 1964 Civil Rights Act.

Since then, education researchers and practitioners have been hard at work trying to identify the causes and propose what can be done to address it. Despite decades of education reform efforts and billions of dollars spent in federal, state and local funding, the achievement gap persists.

Ronald Edmonds, the late Harvard education researcher, said 40 years ago, "We can, whenever and wherever we choose, successfully teach all children whose schooling is of interest to us. We already know more than we need to do that. Whether or not we do it must finally depend on how we feel about the fact that we haven't so far."

To Edmonds and education experts like him, closing the achievement gap is absolutely solvable. The fact that little progress has been made to narrow it can be attributed more to the absence of political will than to any lack of social science research on the problem.

The social factors that contribute to the achievement gap and the actions necessary to close it have been well studied, but public policymakers tend to avoid or overlook the data and recommendations that could cost them any political capital.

For example, in 2013 California revamped education funding to provide extra money for school districts with large numbers of "high-needs" students, mostly kids from poor families or foster children and "English-learners."

The Local Control Funding Formula (LCFF) pushed expenditure decisions down from the state to local school districts because Gov. Jerry Brown and the legislature believed that those closest to the day-to-day operation of schools were best suited to identify what their students needed and would work best for them.

However, this has proven to not be the case, particularly when it comes to the performance of Black students in California.

When the California Department of Education first introduced the new public education finance system in 2013, some lawmakers warned that the LCFF did not provide mechanisms to adequately track how lo-

cal school officials would spend funds. Gov. Brown and groups representing school districts shot down attempts by legislators like Assemblymember Shirley Weber (D-San Diego) to address that concern.

This month, California State Auditor, Elaine Howle announced that her office's recent examination of LCFF spending found that the system lacked sufficient oversight and accounting controls, confirming Weber's reservations. Realizing that there has been very little progress toward closing the achievement gap despite the state having redirected billions of dollars to help solve it, may finally force lawmakers to now consider passing the kind of legislation Weber initially proposed.

Edmonds who was

Edmonds, who was African American, made the observation that progress toward resolving the achievement gap might not happen as quickly as it could because of how White policymakers viewed the issue. He did not question their sincerity about solving it, but was concerned about how they would approach it given biases they might have.

The former dean of the University of Pennsylvania Graduate School of Education, Andy Porter, who is White, validated Edmonds' concerns when he made this statement, "I would like to see the achievement gap closed, but not at the ex-

pense of my kids. I think everybody feels that way."


It is hard to assess how much the attitude Porter expressed, and the unstated biases of others like him, may have stalled progress toward closing the achievement gap, or if they have had any effect at all. But, in California right now, there is a unique opportunity if leaders in Education grow the political will to develop effective policy toward closing the achievement gap for African-American students in our state, even if attitudes like Porter's continue to exist within - and wield influence on - our education system.

Today, our key education leaders in California are African American. They are Tony Thurmond, State Superintendent of Public Instruction: Dr. Linda Darling-Hammond, President of the State Board of Education; E. Toby Boyd, president, California Teachers Association; Margaret Fortune, Board Chair, California Charter School Association; and Emma Turner, President, California School Board Association.

We need these leaders to come together to propose a functioning system that will guide those working hard to achieve results for AfricanAmerican students in our state. Working with legislators like Dr. Weber, we will begin to close the achievement gap.

## Methods Revealed for De-escalation **Among Police at 2nd Annual Community Policing Conference**

Saturday, November 16 at the St. Anne's Conference Center, gathered 250 community members, academics, and law enforcement to discuss how to redefine public safety. The objective was to share insight on communitybased strategies to combat

police escalations leading until he cracked under the to the fatality of civilian life. The format of the discussion was broken up into two parts; the shared responsibility for peace and the paradigm shifts of power between community and city government. This event was hosted by the LA County Sheriff Civilian Oversight Commission and the Department of Public

The conference started with presenting evidence of bias judgment and aggressive practice within the police force. The keynote speaker, Jerome Dixon shared his story of being arrested for a murder he did not commit. He was incarcerated for twenty-one years until the parole board acknowledged his claim of innocence. Dixon, as a scared child, was held for interrogation for 25 hours pressure and confessed to a crime he had no hand in committing. He was only a high school junior at the time of arrest and was not aware of his rights nor were those rights within investigation disclosed to him. The conference room was moved by his story, and he received a standing ovation for his accomplishments and humility post confinement. This provoked the question of how can this never happen

again? After the keynote speaker, there was a panel discussion about the significance between elected sheriffs or appointed police chiefs and their structure of power. There were countless viewpoints about the differences in their framework and which one supplied greater accountability

and oversight opportunity. Panelist Laurie L. Levenson, a professor at Loyola Law School stated that it came down to a couple of principles; how either structure was accessible to the community and the level of professionalism. She also sparked the idea of creating a new option other than the traditional appointed or elected selection. The other panelists took to that proposal and presented ways to organize a third opportunity that would be progressive. As the panelists finished their thoughts the floor opened up for questions from the audience and the meeting

became more interactive.

The assembly became communal as they moved away from the focus of the podium and divided the audience into small thinktank groups accompanied commissioners of human relations and law enforcement. Everyone shared a perspective on community peacebuilding and involvement of oversight for the city police, along with many other impactful topics to move forward with. Respectful conversations answered questions of how to institutionalize community healing after trauma and the responsibility that needs to take place after a critical event involving the officers

of the law. A few solutions offered were to continue having these open-minded conversations that include more of the community being heard, defining the role of an officer, and creating a space for a community facilitated alternatives to handle mental health-based alerts where force is not needed. Through the Oversight Commission, the call for change within the police structure is being answered. The entire community is being held accountable for developing a restorative plan for success in L.A. public safety.

## Investigation Finds California Cops With Criminal Convictions Still on the Job

A group of USA Today Network publications in California launched an investigation into how California deals with cops who commit crimes.

After six months, they made a few interesting findings. There have been about 630 current and former cops in California who have been convicted

on a range of counts, from domestic violence and animal cruelty to reckless driving and manslaughter.

More than 80 of them are still on the job.

What is not particularly interesting about this story is that there are more than 100,000 cops in California. So 80 is a really, really small percentage.

We're not defending "dirty" cops who commit crimes, and worst, get to keep their jobs, but it seems there needs to be deeper investigations into why there are any cops at all on the job who have criminal convictions. We will be following this

During the California Democratic Convention in Long Beach, Assemblymember Mike A. Gipson (D-Los Angeles) led a rally to "End Gun Violence" outside the convention Center.

During the last legislative session, Gipson sponsored a bill, AB 879, to close a legal loophole he says was responsible for "Ghost Guns," weapons anyone in California could



#### **Part 1.** The conversations and controversy surrounding the movie "Harriet" of Hollywood seems, at first sight, to be simply about Harriet Tubman, the liberator, the Harriet Tubman of history. But in a larger sense, it is about Black people, about: how we see ourselves; how we see our heroes and heroines; how we understand and honor our history, especially the history of the Holocaust of our enslavement; how we think and feel about male/female relations; and how we relate and respond to our op-

pression and our oppressor.

Moreover, before we take our respective positions on the messages and meaning of the movie, it is vital that we identify the context in which the movie emerges and in which we conduct our conversations. For movies, like the ideas and messages they produce, promote and perpetuate, don't drop from the sky, grow from the ground or float in from the sea. They are conceived, made and marketed in a given society and social context. And in every society, the ruling ideas are the ideas of those who rule, the ruling class, the ruling race or the ruling race/class. Thus, the ideas of good and right, us and them and what counts as a good movie and an acceptable cinematic rendition of Black history are in no small portion determined and often dictated by those who rule. And it is thus up to us to either accept such impositions or

reject and resist them. We know that our lives and history cannot be correctly conceived and rightly conveyed by a rac-

ist White supremacist society and its media and in this case, its movies. And even when Blacks write the script, direct and produce a movie, it does not automatically mean they will want or be able to avoid duplicating and even defending the artistically impoverished, historically inaccurate and cinematically deformed and deficient images and narratives of Black people which Hollywood is known for. Indeed, in the context of a racist and consumerist culture, there is a history of and penchant for portraying Black people in the most derogatory and degrading ways, and using our humiliation and suffering as a central source of White entertainment.

And it is passed off as market wisdom, that Black people don't want and won't attend movies which honor and dignify them and that are serious, historically grounded and accurate. Even if we became blurry-eyed for a moment of movie color, costumes and scenes, let's be clear-eyed and open-minded enough to concede that there is little about Harriet Tubman of history in the movie, Harriet of Hollywood, except the first name. The Hollywood character lacks the seriousness and powerful presence that a liberator and leader like Harriet Tubman had. She is constantly looking either confused or apprehensive, without the courage or confidence so overwhelmingly evidenced in Harriet Tubman.

Also, the movie lacks artistic achievement, narrative continuity and historical depth and is little more than a collage of random actions, images and events which bear little or no reality to Black history or Harriet Tubman. In this impoverished cinematic collage of selfies in the latest color,

Harriet, the liberator is hustled and hidden, lifted out of her own history and made a distorted footnote and foil for Hollywood's imposter. Indeed, she must be disguised, diminished and disabled so that the impostor can appear and be accepted as real.

Thus, the movie is not really about Harriet the liberator of history, but Harriet of Hollywood, that is to say, how the American mind conceives her. It does not matter that a Black woman or a Black man writes such movies, the critical question is "from what perspective and in whose image and interests"? Indeed, given the compelling force of White culture, we say we are American by habit and African by choice. In a word, we have to choose to be ourselves and free ourselves from the system and ideas imposed on us. Otherwise, we become and be, as Molefi Asante notes, simply darker versions of Europe. Or as Frantz Fanon notes, "obscene caricatures" of Europe and Europeans. In this Harriet of Hollywood version, the character is not depicted as Harriet Tubman, planning, strategizing at every turn, but fainting repeatedly, finding in her illness and visions answers she had already worked out in her reasoning. And the character is posturing behind trees and posing with guns, and seeing and saying things not representative of the reality Harriet Tubman lived and reshaped.

When we view the movie, Harriet, we must know that we are not simply viewing it in the movie house, but also in the midst of a society and system that was and remains oppressive of us and is constantly waging a war of propaganda negative to our image and interests. And in such oppressive and hostile conditions, as Paul Robeson told the writers, artists and others located in similar classes and seemingly safe and secure situations, "the battlefront is everywhere, there is no sheltered rear". This also means that as Malcolm taught, "Wherever Black people are is a battleline", in the whole country and in all its spaces of wealth, power, status, knowledge, etc.

The "image makers", as Min. Malcolm called them, attempted to do to Harriet Tubman on screen what they could not do to her in life—discredit, belittle, break, capture and kill her, in a word, mould her in the image and interests of the dominant society with caricatured conceptions and deformed misrepresentations of her. They begin in this movie by denying and reductively translating her agency, her capacity and will to act, and her awesome achievement against overwhelming odds. They ask us to believe that her seizures and visions are a substitute for her insight, knowledge, skill, strategic planning, organizing and leadership capacity.

But Harriet Tubman is not defined by her seizures, but by her courage, commitment and capacity as liberator and leader, freedom fighter and allseasoned soldier, nurse, teacher, abolitionist, lecturer, and advocate and activist for human, civil and women's rights. She is brilliant in her mastering the lay of the land, measuring the strength and weakness of the enemy, making and seizing every opportunity to out strategize the enemy in order to free herself and others without ever losing a person or being captured herself. She had to study, develop and keep current knowledge of fields and forest, the weather, waterways and pathways, places of concealment and camouflage, the rounds and placement of patrols, safe and unsafe routes, preferable trails to travel, safe houses, contacts, rest stops

and all else in the Underground Railroad and her liberational project. And this could have offered a rich and rewarding treasury of complex and compelling images of life and struggle that could have been the subject matter and material for an excellent film of Africans and any people.

For Harriet Tubman was indeed a freedom fighter who "had reasoned" that she had "the right to liberty or death" and that she would "go free or die". And she committed herself to fight for freedom "as long as (her) strength lasted", and was willing to give every drop of her blood and every measure of her strength and mind to free her people. And she continued to wage this righteous and relentless struggle even after the Holocaust of enslavement in her defense and support of the poor and vulnerable and other initiatives to secure rights and expand the realm of freedom and justice in this land marked by limitations, lies and illusions about both.

## Housing discrimination complaints reach a 24-year high, While HUD rolls back fair housing rules

As a candidate, President Donald Trump promised if elected that deregulation of the federal government would be an administration priority. Soon after taking the oath of office, he issued an executive order requiring that all departments and agencies to eliminate two existing regulations for every one new regulation proposed. In some cases, rules that were adopted prior to his term office but had not yet taken effect were either suspended or delayed.

For example, the longawaited payday rule at the Consumer Financial Protection Bureau (CFPB) was one important consumer protection that was delayed. Similarly, at the Department of Education, two rules providing protections for student loans were also delayed. More recently, this column shared how Housing and Urban Development (HUD) Secretary Ben Carson claimed that regulation was the reason for homelessness, not affordable housing.

Now new research by the National Fair Housing Alliance finds that as fair lending laws have not been aggressively enforced, a corresponding rise in hate crimes and fair housing

complaints have emerged. Defending Against Unprecedented Attacks on Fair Housing: 2019 Fair Housing Trends Report, recently released by the DC-based National Fair Housing Alliance (NFHA), tallied 31,202 discriminatory housing complaints filed in just one year - 2018. Moreover, this data point is the highest number ever reported since the National Fair Housing Alliance (NFHA) began collecting data 24 years ago. America's hate crimes jumped

14.7% last year as well.

Even when it comes to enforcing and defending legal breaches, NFHA's report documents how few government offices are upholding laws. Some 75% of last year's fair housing complaints were pursued by private, nonprofit organizations across the country. Only 25% of such cases were the result of combined government actions by state, local and federal agencies.

"All the tools and resources we have been afforded by the passage of our Fair Housing Act and fair lending laws are either under attack or being gutted," noted Lisa Rice, President and CEO of NFHA. "[W]e must concern ourselves with policies pushed by our federal, state, and local governments that are steeped in hatred and designed to inflict pain."

Instead of strengthening federal fair housing guarantees, HUD is a prime example of how regulations are trying to reverse decades of progress. One particular HUD rule, disparate impact, is at severe risk. This long-standing legal tool has helped root out discriminatory practices and policies in both housing and lending. In 2013 and under the Obama Administration, HUD set up safeguards that assured consumers could pursue related claims while businesses were protected against claims without merit.

With disparate impact, both community banks and FDIC-insured institutions have achieved net growth profits. The rule has proven to create lending that is fairer and profits that inves-

Even a 2015 landmark fair housing case that made its way to the U.S. Supreme Court upheld disparate impact as a cognizable claim under the Fair Housing Act. In Texas Department of Housing and Community Affairs v. The Inclusive Communities Project, Inc., the nation's highest court found the disparate impact rule to be an important fair housing tool to move towards a more integrated society.

So why would Secretary Carson try to roll back a rule that should be settled law?

In joint comments filed by the Center for Responsible Lending, Self-Help Credit Union, and Self-Help Federal Credit Union, the organizations advised Secretary Carson.

"Instead of creating barriers for claimants, HUD should honor its mission and work to ensure African-American, Latino, and other communities harmed by housing



## L.A. City and County Stentorians Train Firefighters in Lusaka, Zambia

In January 2019, the Los Angeles-Lusaka Sister City Committee collaborated with the LAFD, L.A. County FD and the City and County Stentorians to donate four fire apparatus two engines, a brush patrol vehicle and a brush crew carrier - to the African city of Lusaka, Zambia.

Nine months later, Dr. Mwelwa Mulenga, a 10year member of the L.A.-Lusaka Sister City Committee, led a delegation of firefighters to train Zambian Fire Safety and Rescue Services members on the use of the equipment, which further cements the long relationship between the two cities.

"Our world-class first

responders made a great and unforgettable contribution to our bond with Lusaka. The training provided by the fire specialists prepares Zambia's Fire Safety and Rescue Services team for the maximum operation and maintenance of the vehicles," said Dr. Earnestine Thomas-Robertson, chair of the L.A.- Lusaka Sister City Committee.

During a presentation at First AME Church on Nov. 17, to recognize the efforts of Mulenga and the firefighters, Thomas-Robertson said that the donated vehicles will add to Zambia's current fleet of 48 fire trucks for the entire country of 117

'We have now increased that number and we endeavor to do more in the future. Assisting in developing that infrastructure will benefit Zambia and businesses with the common goals of safety, wellness, economic development and peace," Thomas-Robertson said.

In addition to Mulenga, who is a native of Zambia, the entourage consisted of Inspector Gerald Durant, L.A. City Stentorian president; Captain Jonathan Bowers, L.A. County Stentorians; Captain Robert Hawkins, LAFD; retired Captain Kenneth D. Hon, L.A. County Fire Dept.; John Coombs, a New York firefighter and former president of NYFD Vulcan Society; Alicia Thompson, executive manager of the offices of the L.A. City and County Stentorians; and Aretha Green, a business owner who founded the Village Enrichment Program to provide life-skills to youth and a frequent traveler to Africa.

"I think the objectives of the training on the equipment were achieved. Also, there was a massive accident involving big rigs, several people injured and seven fatalities and the L.A. firefighters were part of the rescue operation," said Mulenga.

Also, he and the group were invited to the State House to attend the 55th Independence Celebration with Dr. Edgar Lungu and Mrs. Esther Lungu, the president and first lady of the Republic of Zambia, an occasion that Mulenga described as "the highlight" of the visit.

Durant was happy for the opportunity to share his expertise on an international level. Recalling the experi-

ence, he said, "We were ready to go there and contribute to the foundation and growth of their fire service. Thomas-Robertson has been an enduring supporter of L.A.'s sister city connection to Lusaka and active in securing resources for the nation of Zambia. Since her appointment as committee chair by Mayor Tom Bradley, she has continuously held the position under five successive mayors.

As for the future, Thomas-Robertson said, "I would like to see more collaborations and partnerships between Los Angeles and Lusaka that benefit Zambia in the context of infrastructure development and benefit Los Angeles in a larger context of embracing the interdependent nature of our world and leading by exam-

"We know that Africa has contributed to the development of the modern world, but many countries on the continent are underdeveloped," she noted. "Los Angeles can help change that script for the common good of development, economic and otherwise.'

## Narbonne Football Player Invited to All-American Bowl in Texas

Darion Green-Warren remembers watching the All-American Bowl on television as a youngster, and wishing one day he would be chosen for the game that features some of the top players in the country.

That day has arrived. Green-Warren, a senior from Nathaniel Narbonne High School in Harbor City, formally announced this week that he was chosen for the all-star game, played in San Antonio. He will be the sole representative from the California Interscholastic Federation's Los Angeles City Section, containing more than 150 high schools that ranks as one of the state's five largest groups of athletic teams.

A representative from the All-American Bowl game came to campus and handed the scholar-athlete a white game jersey. Green-Warren slipped it over his head, sporting No. 20. A crowd of supporters, including coaches and teammates, helped him to celebrate the moment.

He stood at a microphone, as his parents, brother and sister watched, and described his joy of playing what will be his last high school game against elite competition.

"It's a dream come true," he said. "I've been playing football since I was little, and I used to watch those All-American Bowls, and I've learned how prestigious it is to get an invitation to play," he said. "My parents have been by my side since I began playing, and they are very proud of me. I've wanted this all my life."



Facing top talent in the game gives him a dose of what to expect in college. But this season's Narbonne team also played a key role in preparing him for the next level.

Few, if any other U.S. high school team featured as many top-level receivers as the Los Angeles powerhouse. Every day, Green-Warren practiced against highly-coveted receivers like, Traeshon Holden, who has committed to Alabama; Kobe Stewart to Arizona State; Josh Jackson to USC, as well as other talented pass catchers.

Standing at 6-feet and 180 pounds, Green-Warren is a larger cornerback, who can match up against taller receivers. Coaches covet his physical presence. He also excels at one-on-one coverage, with fluid hips, and a competitive fire. But Narbonne's football coach Joe Aguirre said Green-Warren always remains composed both on and off

In the All-American-Bowl, Green-Warren will be the only cornerback of the eight nationwide picked to play-from California. "I'm sure he'll do well," Aguirre said, who plans to see the televised match. "It's a little more fun watching when one of your guys is in the game."

"24-7 Sports," which follows high school football, rates him in this year's class as the nation's 13th best cornerback. Green-Warren plans to announce during the game which full-ride scholarship he will accept, choosing among: USC, Nebraska, Michigan and Penn State.

Unlike most first year athletes who arrive to college in late summer, about a month before the college season starts, Green-Warren expects to graduate from Narbonne in January. If all goes as planned, he will enroll in college early, giving him more time to learn his team's playbook, and adjust to higher-level

For now, he relishes his last days of high school. "I'm just looking forward to having a great time at the game before going to college," Green-Warren said, who transferred his senior year to Narbonne from Mater Dei when his father began teaching as a substitute in Los Angeles Uni-

Green-Warren said he will miss his Narbonne teammates. "I had a great time," he said. "There was a great group of guys I call 'brothers,' who wanted the same goal of winning, and having fun doing it."

He is the fifth-player



### It's a Woman's World: Black Democrats Swear In All-Woman Executive Team

Black women, one of the most loyal and energized voting blocs in the Democratic Party, may not be getting their due yet at the national level. But if what's happening in California with Black women Democrats, at all levels, is a sign in the tea leaves of what's to come, then brace yourselves for a beautiful blue world of Black Women in politics.

Four Black women took control of the California Democratic Party African American Caucus (CD-PAAC) this past weekend. The group held the swearing-in ceremony of its new board during the California Democratic Party (CDP) annual convention, which took place in Long Beach this year from Nov. 15 - Nov. 17.

California U.S. Congresswomen Maxine Waters (D-CA-43) and Barbara Lee (D-CA-13) spoke at the event attended by hundreds of Black California Democrats and supporters. Other special guests included U.S. Presidential hopefuls Bernie Sanders and Tom Steyer.

Another well-known Black woman and politician, state Senator Holly Mitchell (D-Los Angeles), spoke to the audience in the crowded room at the swearing-in, too.

"Already the African American caucus is changing this party," said Taisha Brown, the new chair of the CDPAAC at the event. "We also got the Children's caucus to declare racism a public health issue for our children. We are also working with the legislative Black caucus to turn this in to legislation."

## Ruby Bridges First Day of School Changed History

The footprints of a child are small, but on November 14, 1960, six-year-old Ruby Bridges walked with purpose as she became the first African American student to integrate an elementary school in the South. This venture leads to the advancement of the Civil Rights Movement and created a pathway for further integration across the southern parts of the U.S.

Before Ruby could crawl, the monumental court ruling in Brown V. Board of Education case (1954) had transpired in favor of ending segregation in public schools. There was resistance along the southern lines. Although the Supreme Court deemed segregation in public schooling was unconstitutional, integration was not being practiced in the South. In 1959, Ruby Bridges started her educational journey at a segregated kindergarten in New Orleans. A year later, the federal court ordered

Louisiana to desegregate its public institutions of education. The school district created an entrance exam, to test if African American students were capable to withstand the same level of academics as their White counterparts. Along with five other Black students, Ruby passed the test.

Like all concerned parents, Abon and Lucille Bridges were apprehensive about the act of moving their small child into an all-White school. With the spirit of aggression and lack of understanding in the air, little Ruby's safety was of utmost importance. Her well-being was the main reason for the hesitance in

Abon's mind. It was Ruby's mother who favored the move to take place on the premise that her child will receive an education and opportunities that were once denied to her before.

The decision was made,

but there was plenty of red tape from the school district that vielded the steps towards change. At last, early Monday morning, Ruby, alongside her mother, took her first steps into victory over segregation. This was no ordinary first day of school; they were met with great adversity. Mobs of people chanted and shouted at Ruby and her mother. The only things between the rage of the people and the young girl were barricades clearing the pathway and the cops that escorted her in and surrounded the building. After Ruby entered William Frantz Elementary School. mothers of the other children barged in and ripped their children out from their classes; over 500 children walked out that day. For the first year, it was just a class of one. Ruby alone was

where they lived for 25

taught by the only teacher willing, Mrs. Barbara Henry. Ruby had perfect attendance that year.

Other complications trickled down to her family: Abon lost his job and Lucille was denied purchasing at local grocery stores. Her grandparents were evicted from their farm years. Sacrifices through generations did not alter the destined path to integration. Eventually, more African American students enrolled in the same school and Bridges' legacy still graced the hallways as Ruby's four nieces also went to William Frantz Elementary. As an adult, Mrs. Bridges continues to live in New Orleans and works in schools around the country, encouraging the youth. She inspired a great work of art by Norman Rockwell, "The problem we all live with," depicting Ruby as a little girl in midstride changing the course of history.

## Harris Resolution Affirms 150-Year-Old Federal Civil Rights Law

U.S. Senator Kamala D. Harris (D-CA) introduced a Senate resolution on Nov. 18, affirming the importance of the Civil Rights Act of 1866, Section 1981, one of the country's fundamental anti-discrimination laws.

Congresswoman Maxine Waters (D-CA), chairwoman of the House Financial Services Committee, introduced a companion resolution in the U.S. House of Representatives.

Harris' resolution follows the oral argument in the United States Supreme Court case, Comcast Corporation v. National Association of African American-Owned Media and Entertainment Studios Networks, Inc. The issue before the court is whether victims of

race discrimination must meet the burdensome "butfor" causation standard in order to proceed with claims under the oldest federal civil rights law. If successful, Comcast's arguments would narrow a key civil rights law that protects against race discrimination.

"Just one year after the end of the Civil War, Congress passed the Civil Rights Act of 1866 to remove barriers to contracting and Black economic advancement," said Harris. "It ensured that newly freed slaves enjoyed the same rights as other citizens.

"This case threatens to limit the effectiveness of our oldest civil rights law and could prevent countless victims – particularly Black people and people of color – from pursuing claims of

race discrimination in our courts. That is why I am proud to lead my Senate colleagues in a resolution to affirm the importance of upholding longstanding protections against discrimination. I thank Congresswoman Waters for her tireless leadership in the fight for justice," Harris said.

"More than a century after the passage of the Civil

Rights Act of 1866, it is absolutely outrageous that one of the largest media companies in the world would have the audacity to petition the U.S. Supreme Court to hear arguments in a case that undermines this vital law," said Waters.

"Nearly ten years ago when Comcast sought to merge with NBC Universal, both companies were forced, under pressure from my efforts in Congress and the FCC, to commit to credible diversity and inclusion initiatives as a condition for the merger. Now, they are seeking to effectively destroy one of our nation's oldest civil rights statutes dating back to Reconstruction. In doing so, Comcast is opening the floodgates to discrimination in business contracts with no legal remedy or recourse.

"Those of us who know our history, understand all too well the harmful impact this could have on future generations of entrepreneurs and creators of color. I am proud to lead my colleagues in a resolution that makes clear that any and all assaults on civil rights protections for Americans particularly people of color and other marginalized groups – will not be tolerated by the U.S. Congress."

The statute at issue in the case — 42 U.S.C. Section 1981 — was passed immediately after the Civil War as part of a broader effort to ensure that newly freed slaves enjoyed the same rights as other citizens. The Ninth Circuit interpreted Section 1981 to allow victims to allege that race was a motivating factor for a defendant's refusal to contract, rather than the "but for" cause of harm.

Comcast appealed to the U.S. Supreme Court, where it argues for a burdensome pleading standard that would greatly limit access to the courts for victims of discrimination. On September 30, Harris led an amicus brief in the United States Supreme Court in support of the Ninth Circuit's ruling, arguing that, under the statute, plaintiffs can proceed with claims where race discrimination is a motivating factor, but not the sole cause of harm.

Harris' resolution was joined by Senators Richard Blumenthal (D-CT), Cory Booker (D-NJ), Dianne Feinstein (D-CA), Mazie K. Hirono (D-HI), Elizabeth Warren (D-MA), and Ron Wyden (D-OR), and is supported by the NAACP.

Ahead of the first day of oral arguments in the Supreme Court case Comcast Corp. V. National Association of African American-Owned Media (NAAOM), Congresswoman Maxine Waters (CA-43) led her colleagues in introducing a resolution that affirms the vital role that the Civil Rights Act of 1866 – particularly Section 1981 of the Act – has played in prohibiting discrimination on the basis of race or ethnicity when making and enforcing business contracts. mitted to further expanding Wellnest's services because mental health knows no boundaries and children can be impacted which can ultimately affect their lives. When we can address this early on, the results are very positive," she insisted.

As part of their effort to reach very young children, the agency offers several Early Intervention and Community Wellness Programs. The services focus on youth under fiveyears-old with behavioral and emotional problems such as aggression, temper tantrums, inattention and hyperactivity. To assist, Wellnest provides various relationship-based services including individual and family therapy, case management, rehabilitation, and

to provide basic needs for their children. The on-site staff delivers relational support and may reach out to partners at other social service or faith-based agencies to aid primary caregivers.

"We work with the entire family in the context of the child. The key is to give that family all of the support, guidance and resources that they need to be successful in providing a nurturing and loving environment for their children," explained Dimas-Peinado.

To meet the needs of older-children, Wellnest manages outpatient mental health services through its no appointment, no fee Access and Wellness Center as well as at clinics on the campuses of 34 public and seven charter schools. Stu-

dents facing academic and delinquency problems, anger management issues or dealing with trauma like witnessing street violence can receive assistance following a referral by school personnel. The services include assessment and evaluation, individual and group therapy, and medication support for children who need psychiatric rem-

Even teens graduating from high school to college or employment can find help at Wellnest. The organization opened the Avis and Mark Ridley Thomas Life Learning Center earlier this year to aid that demographic.

"The transition from adolescence to adulthood is a very critical stage in a young person's life. They are planning for their future and may need assistant with navigating life and making good decisions," noted Dimas-Peinado.

"Many of these youth and young adults will transition into adulthood successfully, but an estimated five-to-10 percent will not due to a number of challenging life experiences. These social issues cause our young people to be vulnerable and at greater risk because they face high levels of social isolation.

"For youth who may have been in foster care or experienced adversity in their young lives, we can provide a plethora of supportive resources to help them to be successful and self-sufficient as they are planning their future."

a direct impact. Over 200 federal programs derive revenue from data gathered by the census. This list includes school lunch programs and the Women, Infants and Children Program (WIC), which provides direct monetary assistance for lowincome pregnant women and new mothers and their children. Other programs range from Section 8 Housing assistance to LIHEAP, the Low-Income Home Energy Assistance Program. LIHEAP helps families pay heating bills and assists with repairs to furnaces, in-

costs. Without these programs, the cost of living for everyone in a neighborhood, city, or county would be higher. Take LIHEAP as an example. Without the financial subsidy to those in need, other ratepayers and customers like yourself, would likely face an increase in monthly utility bills.

FAQ: Can someone find out my private census responses?

Answer: Your information is confidential and protected by Title 13, which brings heavy fines and possible imprisonment for anyone who divulges your personal information.

The Census agreement?

Answer: The Census Bureau is trying to gather data. It is not seeking to determine whether you are violating your lease or local zoning codes, but you have raised an important point. Families are often fluid -- grandparents taking care of grandchildren while parents are at work or away from home. Should you claim a student away at school in another state as a member of your household? There are many scenarios where family members should be reported, but African Americans were undercounted by 2.1 percent in the 2010 census and many of those missed were children. Why? In part, because people were unsure whether they should report a child or whether that was someone else's responsibility to do so. The best thing to do is ask the Census Bureau or one of the many organizations participating in partnership during Census2020.

chances to compete. Billionaire Bloomberg joined billionaire Tom Steyer, who literally bought his way onto the debate stage, are trying to ignite interest with the moderate wing of the Democratic Party.

To add to the challenge, White candidates in the field must build the diverse Obama-like coalition of voters and ensure excitement in the most reliable sectors of the Democratic base, while minority candidates must thread the needle of attracting White support. the current field in flux because of Biden's faltering poll numbers, Deval Patrick may have a chance to compete in a crowded field.



## Celebration of Life Vera L. Rícketts, R.Ph.,

**NEWS** 

Vera Louise Ricketts, R. Ph., passed away at her home in Los Angeles, California, surrounded by her loving family, on October 26, 2019 at the age of 97 years. She was born in Indianapolis, Indiana on October 20, 1922 to Sarah Chilton Phelps and Robert Phelps.

Growing up in Indianapolis, Vera attended Crispus Attucks High School, an all-Black school. There, her love of science blossomed into a solid interest that would guide her toward a lifelong career as a community, national and international volunteer and healthcare advocate for the underserved. She began preparing herself for her humanitarian goals by first working her way through college at Indiana University Extension, and subsequently at Butler University. She was the only Black woman who graduated from Butler in 1948 with a B.S. degree in pharmacy.

In 1950, she left Indianapolis to begin an internship in hospital pharmacy at Freedman's Hospital in Washington, D.C. (currently known as Howard University Hospital). There, she met the love of her life, the handsome and charming Dr. William Newton Ricketts, a newly graduated physician. They were married on August 26, 1951, and later moved with their first-born daughter to Durham, North Carolina. While Newton pursued his residency in surgery at Lincoln Hospital, Vera worked as chief pharmacist and a teacher of pharmacology

courses at the same hospital. In 1957, Vera made history when Duke University hired her as its first Black pharmacist.

After Newton completed his surgical residency in Durham, the couple, now the parents of a second daughter, returned to Washington, D.C. Vera worked as a Supervisor of Pharmaceutical Manufacturing at Washington D.C. General Hospital. In the early 1960s, they moved to Los Angeles, where Newton, a board certified surgeon, established a private medical practice. In Los Angeles, Vera gave birth to two more daughters. She was able now to turn much of her attention to providing a loving home for her family. As her four girls grew up, she was also able to commit more time

to her community. A firm belief in the power of education to develop young people's talent and transform their lives for the better led Vera to volunteer at local high schools and the Jenesse Center for battered women and children. Moreover, she mentored youth in careers in pharmacy, chaired and co-chaired youth enrichment programs, as well as numerous other programs. Aware that fulfilling the needs of the underserved of all ages was a critical issue of our time, she volunteered at senior citizens' homes, conducted

ed inform a

breast selfexamination and colorectal screening. Vera was an ardent supporter of United Homeowners Association II in her community. She served on the Board of Directors and as parliamentarian of the Metropolitan YWCA. She worked with Crenshaw Neighbors and its national component, National Neighbors. Other national organizations included United Way, Kel-

America, Inc. and the Congress on Racial Equality (C.O.R.E.). Notably, she served as president of the Auxiliary to the Charles R.

On a recent afternoon, under Rockefeller Plaza's food court, a small group of journalists gathered to talk shop with William Jackson Harper, the handsome man who carved a place in television history playing the character, Chidi, in NBC's hit comedy, "The Good Place," created by Mike Schur.

Not bad for a series that's only been on the air for four seasons. Yet, despite this success and dedicated fan base, creator Schur made the bold choice to wrap up the se-

Harper arrived five minutes early, which means he was on time. "Are all these mines," he says, referring to the full plate of fried calamari. "I can't eat all of this, I mean I could, but then I would be like, wow, I ate all this."

Harper is just 38. Before the hit television show, he spent most of his life living in New York, trying to make a career happen in the theater. He paid his dues being a broke actor and learned a lot from participating in readings and workshops with playwrights like Lynn Nottage.

## 'The Irishman' Brings De Niro, Pacino and Pesci Together for Iconic Mob Film

Martin Scorsese's "The Irishman" is three hours and thirty minutes long and everyone important, dies, but that's Martin Scorsese.

His latest crime epic premieres Friday in movie theaters around the country before streaming on Netflix on Nov. 27. This is a very big Mob epic about a hitman (Robert De Niro), a Mafia boss (Joe Pesci) and the never-solved death of the Teamsters leader, Jimmy Hoffa (Al Pacino).

It's a masterpiece, no question, and it's a disturbing vision of the criminal underworld that's is somewhat reminiscent of his previous films but here he goes to new and disturbing places.

The screenplay is by Steven Zaillian, who adapted the 2004 memoir, "I Heard You Paint Houses." It's the true story of Frank Sheeran (Robert De Niro), a World War II veteran and truck driver, who (in the 1950s) finds himself doing business with Russell Bufalino (Joe Pesci), a ruthless boss of the Pennsylvania-based Bufalino crime family.

Sheeran quickly gained the Mob's trust and as a soldier and hitman, he had a lot of assignments including working for Jimmy Hoffa (Al Pacino), whose Teamsters Union was connected to the underworld. For years, Sheeran served as Hoffa's right-hand and trusted solider, and then, according to Sheeran, he was the one

given the order to murder Hoffa although the labor leader's sudden disappearance (in 1975) was never solved

Under Scorsese's skillful eye, this story is bigger than "who did or did not kill" Jimmy Hoffa. He puts the spotlight on America and it's lust for violence, greed, ambition, politics and ultimately corruption. Who has the real power? Why are they pulling the strings? Do the ends even matter?

"The Irishman" presents the Mob life without romance. It's cold. It digs deep into the very heart of power. There is a lot of grisly killing along with mob mythology, shared Italian meals and a bevy of Italian men with distinctive names. These are unique businessmen who specialize in extortion and "influence" in high place but at its core is the complicated friendship between men who are part of mob life and for that reason it is poignant.

This film is long (209 minutes) a sprawling three-and-a-half-hour magnum opus which will have just enough screenings to qualify for an Oscar before it appears on Netflix. Do expect a lot of nominations this year.

Edited by Thelma Schoonmaker, "The Irishman" unfolds in such a way you don't feel the length.

The characters spring through the screen with all their drive and violence and this film never, once, glamorizes that violence.

The film presents crime as a business where dogeats-dog is how business is done. Do you want a promotion? Don't die.

Set over 30 years, the digital de-aging process which pushed the budget to \$150 million is vital to telling this story. Set in the '50s and '60s, watching a young De Niro appear is almost like turning the clock

back on your own life. The deaging process is not perfect but there are moments when it's effective.

Frank became a cold killer when he was ordered to kill German POWs after they dug their own graves.

The movie flips back in time. On the eve of Hoffa's assassination in 1975, Frank and Russell (along with their wives) are on a road trip to Detroit for a wedding, and they pull over near the Texaco gas station where Frank, after the war, first met Russell. Then the film goes back to Frank's first crime. He's delivering beef, letting them "fall off the truck" and into the hands of Felix "Skinny Razor" DiTullio (Bobby Cannavale), an associate of Russell's.

Frank is a quick learner and does whatever's he's asked, including blowing up a laundry service for a mobster named Whispers, a bad move since the Italians owned a stake in it. Frank is ordered to execute the very same gangster (Whispers) which he does without emotion or hesitation.

Then Frank meets Jimmy Hoffa and here Al Pacino's performance as the dynamic union leader brings the film to another level.

Hoffa's union speeches move men to action. They believe and their faith is the secret of Hoffman's power. He honestly wants to protect their interest and it's that sincerity (ironically) that begins to help him become powerful and therefore dangerous.

Hoffa treats the Team-

sters pension fund as his money, using it to bankroll the hotels of Las Vegas. You get a deep dive into power dynamics and the rivalry between Hoffa and New Jersey crime boss Anthony "Tony Pro" Provenzano (Stephen Graham). They despise each other, and whether they're fighting in prison or at a meeting over nonsense, you understand just how crazy the lust for power can make a person.

Scorsese makes the lines between personal and political blurry.

Frank's assignments go beyond simple murder. He's asked to assist in a weapons shipment that turns out to be for the Bay of Pigs invasion. ### 'Motherless Brooklyn' —a disappointing film — financed by African American billionaire Robert F. Smith

Edward Norton's new film "Motherless Brooklyn" is an adaptation of the Jonathan Lethem novel about a New York detective with Tourette syndrome. Norton, who also directs, stars alongside Bruce Willis, Alec Baldwin and Gugu Mbatha-Raw.

As far as the screenplay goes, I would not be surprised if the adaption gets an Oscar nomination (Best Adapted Screenplay) for Norton. He's re-imagined the novel's 1990s setting into a 1957-set with a film noir

feel. Now to the actual film which stands at two-and-a-half hours, it looks stylish and it's filled with beautiful music, jazz, but it's very, very, very hard to follow.

It opens with Norton's character, Lionel Essrog, a small-time private detective with Tourette syndrome, a unique hero, witnessing the murder of his boss, private detective Frank Minna (Bruce Willis) leaving his confused colleagues, Lionel, the aloof Tony Vermonte (Bobby Cannavale), Danny (Dallas Roberts) and Gil (Ethan Suplee) to figure out who murdered him.

There is a lot of cram-

ming of a message with a very thin plot.

Lionel's condition makes it hard to connect with people but to find out who murdered his boss, he tries following clues that lead him to a Harlem-based jazz club, The King Rooster, where he connects with Laura Rose (Gugu Mbatha-Raw), a beautiful and committed lawyer who lives, in Harlem, above a jazz club. There the music is provided by a brilliant trumpeter, played by Michael Kenneth Williams, with the music is played by Wynton Marsalis, which is simply window dressing, which is a shame because it's like the music (and the club) was added for

no real purpose.

Laura Rose is fighting racial discrimination with political activist, Gabby Horowitz (Cherry Jones) to stop the progress of New York's city planning boss

Moses Randolph (Alec Baldwin) —whose goal is to create unlivable conditions throughout New York, turning good neighborhoods into slums, evicting the tenants and then reclaiming the property. Rose is fighting this injustice and is terrified that she's being followed. As expressed by Norton it's clear that New York authorities and the U.S. government hate Black, Brown and poor people.

The longer the story stays in Harlem the fuzzier the storyline becomes. There is so much "fat" in the movie with many characters coming in and out that doesn't seem to serve the story. To wit beginning with Lionel's colleagues, as they don't add anything vital to the story serving more as atmospheric set dressing.

What's happening? We don't know. It's a mystery so it's fair we stay in the dark



## Dorsey Football Legend Shows Disparities in Justice, Mental Health System Part 2

Former Dorsey Football star Antonio Carrion was once considered to be the best wide receiver in southern California and the nation. His battle with Bipolar Paranoid Schizophrenia led him to homelessness and the Criminal Justice System, showing the lack of institutional resources put in place for people living

with mental illness. When former high school football standout went missing, Stephanie Carrion was determined to find him. For Stephanie, searching for her son consumed her.

When she did find Antonio and approach him, did not recognize Stephanie.

"The first day I found him, he did not believe I was his mother," Stephanie said. "It took a minute for him to even trust me."

She then worked to gain his trust, a process that also

would give him food, clean clothes and toiletries; she would also converse with him and eventually built a rapport.

His high school football coach, Paul Knox also chipped in to help Carrion after Stephanie contacted him for support. Carrion was living in a group home at the time.

his social security money, so I took him to social security, and we went through the process," Knox said. "I've heard by then, he had some problems, so hopefully maybe we can get his money, he can get together in some kind of way so he could have a stable life."

Antonio resided in the skid row; he was sent to jail over 40 times. The experiences and tribulations that he endured through the years shows the disparities of homelessness and mental health treatment.

The Los Angeles Homeless Services Authority

took years. Stephanie noted that the total amount homeless persons expanded from 52,765 in January 2018 to 58,936 January 2019. Los Angeles Times reported last month that 76% of individuals living with homelessness are reportedly affected by mental illness, disabilities, substance abuse and bad health.

Stephanie noted that she would be more at ease "He was trying to get when she would find out that he was in jail as opposed to living on the streets. When arrested, Antonio was sent to the mental health ward in L.A. County Jail; Los Angeles houses the biggest mental health ward in the country.

Earlier this year, Los Angeles County District Attorney Jackie Lacey implemented an expansion in her office called the Mental Health Division. Attorneys who work in this division will work with defendants who are incompetent to stand trial to help them find treatment for their mental illness instead of sending them to jail.

"We also want to make sure that jails and prisons are reserved for the most serious and violent offenders," Lacey said when she announced the expansion. "Over the past six years, my office has embraced novel approaches to helping those with mental health issues in the criminal

justice system." Antonio's story caught the attention of KCET executive producer, Karen Foshay who featured him on an episode of the show SoCal Connected. The story had a

huge impact on viewers. "Total strangers reached out to Stephanie, wanting to help Antonio, not understanding he had a court hearing three days after the first airing of the piece," Foshay said. "A dozen strangers showed up, people he didn't even know, hadn't contacted him in 20 years showed up at his hearing for him."

The end of the documentary showed how the

court assigned Antonio to go the Metropolitan State hospital, but that did not Against happen. Stephanie's wishes, the courts sent him to a pilot program. Eventually, Antonio was sent back to L.A. County jail. The airing of the documentary not only brought awareness to Antonio's plight, but gave Stephanie the resources to help him. In 2018, Antonio was facing a felony assault charge, but the charges were dropped and he was

he doesn't have an assault charge anymore, how he doesn't have a strike anymore," Stephanie said. "This documentary and the people that were put in my life because of the documentary did all this with my input."

Since Antonio has begun the program at Ala Vista Hospital, he has been excelling in the courses provided for him. While Antonio continues to improve, many of his friends from Dorsey and people who were impacted by his story continue to reach out and show their

love and support.


The Manual Arts Toilers advanced to the semifinals of the Division II CIF City Section playoffs after shutting out the Kennedy Cougars 41-0.

## A Matter of Life and Death: Group to Pull Plug on Life-Saving Aid It Gives to Nearly 4,000 California Dialysis Patients

Russell Desmond received a letter a few weeks

ago from the American Kidney Fund (AKF) that he said felt like "a smack on the face."

The organization informed Desmond, who has kidney failure and needs dialysis three times a week, that it will no longer help him pay for his private health insurance plan - to the tune of about \$800 a month.

Now, the fund, which helps about 3,700 Californians pay their premiums and out-of-pocket costs, is threatening to pull out of California because of a new state law that is expected to cut into the dialysis industry's profits - leaving patients like Desmond scrambling.

The letter portrayed the fund as helpless. "We are heartbroken at this outcome," it read. "Ending assistance in California is the last thing we want to do."

But supporters of the new law are calling the threat a scare tactic. State Assemblyman Jim Wood (D- Healdsburg), the author of AB-290, said there is nothing in the measure that prohibits the fund from continuing to provide financial assistance to patients.

"AKF has simply made a conscious decision, without merit, to leave the state despite the many accommodations I made by

What's behind this dispute, critics of AKF Say, is the tight relationship between the fund and the companies that provide dialysis, which filters the blood of people whose kidneys are no longer doing the job.

People on dialysis usually qualify for Medicare, the federal health insurance program for people 65 and older, and those with kidney failure and certain disabilities. If they're low income, they may also qualify for Medicaid, which is called Medi-Cal in California.

But dialysis companies can get higher reimbursements from private insurers than from public coverage. And one way to keep

dialysis patients on private insurance is by giving them financial assistance from AKF, which helps nearly 75,000 low-income dialysis patients across the country.

The fund gets most of its money from DaVita and Fresenius Medical Care, the two largest dialysis companies in the country. The fund does not disclose its donors, but an independent audit of its finances conducted by the accounting firm CliftonLarsenAllen, LLP, reveals that 82 percent of its funding in 2018 - nearly \$250 million came from two compa-

Insurance plans, consumer advocacy groups and unions have accused AKF of helping dialysis providers steer patients into private insurance plans in exchange for donations from the dialysis industry. Wood said his bill is intended to discourage that practice.

AKF CEO LaVarne Burton denied the accusations and said her group plays no role in patients'

coverage choices. Starting in 2022, the new law will limit the private-insurance reimbursement rate that dialysis companies receive for patients who get assistance from groups such as AKF to the rate that Medicare pays. The rate change won't apply to patients who are currently receiving assistance as long as they keep the same health plans. The bill will also address a similar dynamic in drug treatment programs.

To determine which patients receive financial aid, the law will require thirdparty groups to disclose patients' names to health insurers starting July 1, 2020.

These disclosure requirements are spurring AKF's decision to leave, Burton said. She argues that they conflict with federal rules and violate patient privacy.

"AKF has no choice but to leave or seek legal relief," Burton said.

In mid-October, the fund started sending letters to its financial aid recipients in California warning of its departure. And Nov. 1, it joined two dialysis patients in filing suit against the state, asking a U.S. District Court to rule the law unconstitutional.

Gov. Gavin Newsom cautioned against such ac-

tions when he signed the bill, and urged "both opponents and supporters to put patients first."

But as the threats and legal battle play out, patients are caught "squarely in the middle," said Bonnie Burns, a consultant with California Health Advocates, a Medicare advocacy group.

Their options may be limited, she said. Those who don't work won't have access to employer-sponsored coverage to make up the difference. And in California, Medicare recipients under age 65 are not eligible to purchase supplemental insurance known as Medigap.

The state Department of Managed Health Care offers a fact sheet for affected patients, directing them to programs such as Covered California and Medi-Cal.

Paige Hosler, vice president of insurance management at DaVita, said insurance counselors and social workers at the company's clinics are working with patients to find other options.

"We will continue to treat all patients, regardless of insurance status," she said.

Hosler noted that some patients may qualify for DaVita's

charity care program. Dialysis companies have been at the center of recent legislative and ballot-box battles, and have spent big to defend their bottom lines. Last year, they poured a record-

derstands why lawmakers targeted the dialysis industry but can't fathom why they did so at the expense of patients. Desmond was laid off

from his job as a computer programmer in Massachusetts in 2009 and moved to California to join his brother. One year later, he was diagnosed with kidney failure.

He lives off his Social Security Disability Insurance benefits, which come to about \$2,000 a month after his Medicare premiums are deducted. Medicare pays for 80 percent of his care.

He also qualifies for Medi-Cal coverage that comes with high out-of-pocket costs, so he relies instead on a private Aetna insurance plan to cover the remaining 20 percent. The American Kidney Fund has been paying the premiums for his private plan since 2015.

"What they did is take away our life raft and left us to drown," he said of lawmakers. Brian Carroll, 40, of Sacramento, has been on dialysis for five years. He moved back in with his parents in 2016 because, he said, dialysis left him too weak to work. "I am now completely depending on other people," Carroll said. AKF pays the \$270 monthly premium for his private insurance plan that covers what Medicare doesn't.

"That's an entire month of groceries and gas for me," he said. Carroll said he supported Proposition 8, even though dialysis companies argued that it would force them to cut back services and shut down clinics. In this current situation, he's not sure whom to blame - the lawmakers, who passed the law with no back-up plan for patients, or the fund, which is essentially holding patients hostage.

"What I do know is that you can't just leave dialysis patients like this," Carroll said. "It's cruel." 

Conner, a member of Crenshaw Christian Center, has plied his trade for nearly 20 years as an illustrator, animator, videographer and comic book creator. He is also experienced in writing, directing, character design and digital media and his illustrations appear in the new book by Pastor Frederick K. Price, Jr., "Behind the Seen."

In addition, Conner has worked extensively in the Arts + Entertainment industry with clients such as EA Games, IMAX, Machinima, Jerry Bruckheimer Films, Universal, MTV, Interscope Records, Reach Records, Starbucks, and Disney. Another endeavor that he recently embarked on involves privately commissioned paintings of professional athletes and notable celebrities who requested his services after seeing his exceptional

along with the comics that he co-created, "Restoration" and "The Trials of Samson." The Sentinel spoke with Conner to learn how he applies his belief in God to his work. The following is an edited version of the interview.

What insight can you share about your faithbased graphic novels?

"Revelations" is my longest-running project. It started back in college and has grown and evolved

throughout the years. I think it has always held a special place in my heart because it was the very first project where I found the perfect marriage of my faith and my art.

My art has always been labeled "edgy" or "dark," [but] once I discovered some of the amazingly rich and profound, but dark, storylines talked about in the book of Revelations, it made perfect sense for me to translate that into a graphic novel and animated project. I really created works that I personally would be excited about doing, and using them to tell some of the greatest stories ever told. I felt that if it was something that I loved, then others would come to enjoy it and be edified as well.

"The Trials of Samson," which is scheduled for release in 2020, is a collaborative endeavor between several writers, editors, pastors, researchers, and one artist.

It's a fantasy approach to a historical figure that is grounded in key historical events. We truly feel that this book will resonate with a few underserved markets; diversity within ethnicities and faiths told from a historical-fantasy approach.

In a perfect world,

#### where would like your career to be in the next fiveto-10 years?

God is constantly moving in my art. Prayer is such a big part of my life and my career, so often I don't know what I'll be working on the following week, let alone five-to-10 years later!

But, as I understand the trajectory God has me on at this point, over the next decade or so, I hope to have five-to-10 new book titles released, an animated series based on one of the Samson books, and an animated feature based on the Revelations series.

Also, I'd like to be writing and directing liveaction productions with my wife and kids.

A lot of the groundwork for all of these elements is already in play, but only

God knows the timing and doors that will need to be opened along the way to get there... and I trust Him to handle those unknowns, because they are not unknowns to Him.

#### What advice can you share with aspiring professionals?

Persistence and prayer. Too often I've seen people give up right before their blessing came and they never see it. And I've also seen those that weren't ready for their opportunity and it ended up passing them by!

First, identify the passion. Second, devote the necessary time to hone the skill and craft needed. All while submitting the path to the Lord in prayer, for guidance and for Him to open the right doors and close the wrong ones.

I have truly been blessed on my path and thankful for all of the doors that He's opened (and closed) along the way.

#### Are other projects or interests you'd like to

I have been using my YouTube channel to showcase some of my art and animation, doing art tutorials, as well as sharing my thoughts on entertainment and media through commentaries and film reviews, as well as discussions on faith, the Bible, and apologetics.

So far the response has been great! It's kind of a mix bag of all the passions



## Words of the Week - A Song of Thanksgiving

Scripture: Psalm 100:1-5

Music has been referred to as the universal language that speaks to people of all tongues, of every generation, and to every human situation.

Songs are poetry put to music. Songs speak to our ups and our downs. They speak to our joys and our pain. They speak to our love and our happiness. Our songs speak to every human situation.

In the text, the psalmist admonishes these ancient believers to sing a song of thanksgiving. His admonishment to these believers is not just one to sing, but to a behavior of thanksgiving and the rationale or reason for such behavior.

If they were truly thankful, the psalmist says, they should make a joyful noise to the Lord (v.1). They should lend their voices to their thanksgiving.

If these believers were truly thankful the psalmist says that they should serve the Lord with gladness (v.2a). Their service to one another should not to be a chore and it should not feel like an obligation. Their service to one another should be with gladness.

Then if these ancient believers were truly thankful, the psalmist says that they should come before the Lord's presence with

singing (v.2b). A behavior of thanksgiving, according to the psalmist, is one that "comes" to the house of the Lord. And when they get there, the psalmist tells them not to act like they were doing the Lord a favor to be there, but come like they were glad to be there.

That's why David says in Psalms 122:1 that he was glad when they said to him let us go to the house of the Lord. Come before His presence with singing, and enter His gates with thanksgiving, and His courts with praise (v.4). The psalmist admonished these believers to adopt a behavior of thanksgiving.

Then the psalmist gives these ancient believers the rationale or reason for their thanksgiving. Be thankful and bless the name of the Lord (v.4a). Bless the name of the Lord because the Lord was God (v.3a). The Lord was their Creator for the Lord had made them (v.3b). They were the sheep of His pasture (v.3b).

It was God's responsibility to care for them. It was God's responsibility to provide for them. It was God's responsibility to preserve them and the Lord was not slack of His responsibilities. Be thankful and bless the name of the Lord for the Lord was their God and He would be their God forever and ever

And then the psalmist admonished these be-

lievers to be thankful and bless the name of the Lord because the Lord is good (v.5a). His mercy is everlasting. His goodness and His love towards them was everlasting. His pity and compassion towards them was everlasting. His gentleness and forbearance toward them was everlasting (Baker's, Dictionary of Theology, p.348).

Be thankful and bless the name of the Lord because His truth endures to all generations (V.5a). The African theologian, Augustine, in his four senses of truth says that, "Truth is truth when it merits the name that it claims." (Baker's, p.532).

During the 2015 season of the National Basketball Association, the Los Angeles Clippers loss in the second round of the Western Conference playoffs after leading the Houston Rockets three games to one in a seven game series. They were unable to win the fourth game because,

many felt, they did not have a closer.

They did not have anybody on the team who could take control of the game in the final minutes and close out the game. As good as Blake Griffin, Chris Paul and Deandre Jordan were, neither of them was a closer.

During the off-season that year, the Clippers signed one of Doc Rivers' former players who helped him win a world championship while coaching the Boston Celtics. They signed Paul Pierce, an Inglewood High School graduate and University of Kansas alumni.

They signed him, Doc Rivers said, because he was a closer. He wants the ball in his hands at the end of the game. He wants to take the last shot, or make the last pass, or execute the last play at the end of the game. His reputation of being a closer around the National Basketball Association earned him the nickname of "The Truth" because he merited the name he claims.

That's what the psalmist is saying to these ancient believers in the text, the Lord merits the name that He claims. Be thankful and bless his holy name because He is God, His mercy is everlasting, His truth endures to all generations and He is the same, yesterday, today and tomorrow.




