Thurmond Wins Historic Race For CA Superintendent Of Public Instruction

Pledges to be a champion of public schools and a Superintendent for all California students

Assemblymember Tony Thurmond is the projected winner of the California State Superintendent of Public Instruction election. More than a week after Election Day, Thurmond has overcome an 86,000 vote deficit on Election Day to win the election. On Saturday, his opponent Marshall Tuck conceded.

"I want to thank the voters of California for electing me to serve the 6 million students of California, I intend to be a champion of public schools and a Superintendent for all California students," said Superintendent-elect Thurmond. "I ran for Superintendent of Public Instruction to deliver to all Californians the promise that public education delivered to me – that all students, no matter their background and no matter their challenges, can succeed with a great public education."

Thurmond was born in Fort Ord, California, and

overcame humble beginnings. His mother was an immigrant from Panama who came to San Jose, California to become a teacher. Thurmond's father was a Vietnam veteran who Tony met when he was almost 40 years old. After Thurmond's mother died when he was 6 years

old, Thurmond moved to Philadelphia with his sibling and was raised by a cousin whom he had never met before. With the help of the public education system and public assistance, Thurmond went on

L.A. Sentinel echo's loud and clear, there's a new sheriff in Town.

The November 2018 midterm election race for LA County sheriff left local residents on the edge of their seats as they waited to see who would declare a victory. Would it be incumbent Jim Mc-Donnell or his challenger, Alex Villanueva? As of press time, the LA County Registrar shows Villanueva has 1, 193,670 votes compared to McDonnell's However. 1,106,750. more than 261,000 ballots still need to be counted before there is an official winner.

"With a lead of nearly 58,000 votes, we can finally say that there's a #NewSheriffInTown! We owe it all to our volunteers and everyone who supported our campaign. Now the work really begins as I prepare to hit the ground running on day one as your new Los Angeles County Sheriff," said Villanueva in a Facebook post.

Although McDonnell

has more than 48.67 percent of the votes, he has not conceded because "there are too many uncounted votes."

"We were very successful. We had four years that I think if you were using a sports analogy, four championship years and to finish out that and end up in a position like this..." said McDonnell in a statement.

Villanueva who has more than three decades of experience in law enforcement, built his campaign platform on improving the



Compton Unified School District Awarded \$10 Million Dollar Grant from US Department of Education

The District will Work with College Partners to Provide Intense College Preparation and Support to 1,800 6th and 7th Graders over the Next Seven years of their Academic Careers

Compton Unified School District has been awarded two United States Department of Education Gear Up Grants for the next seven years in collaboration with university and community college partners. Through the grant, CUSD will provide intensive academic and college preparation support to 1,800 6th and 7th grade students. The grant will fund programs that will follow the same students as they journey through middle school, high school and college. CUSD is one of only 60 organizations nationwide (only 11 in California) to be awarded the prestigious grant. The district's efforts will receive almost \$10 million

trajectory of improved graduation and college going rates, it will enable us to take a huge leap toward ensuring students successfully graduate college as well," said Dr. Darin Brawley, Superintendent of CUSD.

The goal of the grants are to measurably increase students' rate of graduation, enrollment in, and completion of college. The grant will fund multiple activities and services including STEM enrichment, college readiness, professional development for teachers, counselors and staff, academic tutoring and support, economic literacy, and advanced placement/dual ment support. In addition to institutions of higher learning, this project will work collaboratively with a diverse group of community-based partners including the City of Compton, Verizon Foundation,

SNAP and Project First.

"Today is truly a great day in Compton!" said Satra Zurita, Vice President of the CUSD Board of Trustees. "In addition to the strong academic support students will receive, I am excited that this grant will help our students gain access to financial, academic and other supports that will in essence lock arms with them as they travel a path that leads them to directly to success!"

The two grant projects, award amounts, participating partners, and program

activities are: UCI, Compton College and the Compton Unified School District Gear Up were awarded \$5,440,000 for a seven-year project to increase students' academic achievement, college awareness, preparation and parents' college knowledge.

The Compton Partnership GEAR UP will

begin its intensive work at Davis, Bunche, Enterprise, and Willowbrook Middle Schools in the Compton Unified School District. The project will start by creating a cohort of 1,000 6th and 7th grade students, and will continue to serve these same 1,000 students as they move into Compton and Centennial High Schools and on to the college of their choice.

California State University Dominguez & Compton Unified School District Gear Up were awarded \$4,450,000 for a seven-year project to increase students' academic achievement, college awareness, preparation and parents' college knowl-

The California State University of Dominguez & Compton Unified School District GEAR UP will begin its intensive work at Dominguez High School, Whaley and Roosevelt Middle Schools in the Compton Unified School District. The project will start by creating a cohort of 800 students and will continue to serve the same 800 students as they move into Dominguez High School and on to the college of their choice.

fied School District, we are intently focused on partnerships and initiatives that are innovative and gamechangers for students. We are grateful to the US Department of Education and our collaborative partners for agreeing to take this bold step forward in firmly establishing a college-going and college-enabling culture in our district," said Micah Ali, President of

Dévon Johnson Creates Bleu Magazine and Bombshell Johnson creates media outlets highlighting Black professionals and creatives

Media entrepreneur Dévon Johnson celebrates Black culture with his digital and print magazines.

His first publication, Bleu Magazine, came out of some frustration in Johnson's career in the music industry. After graduating from Seton Hall University where he studied Business and communications, Johnson worked as an assistant at Def Jam Records. He worked there for seven years going from assistant to coordinator to product manager. Even though Johnson likes and listens to hiphop, he felt like the images that he was putting out didn't reflect

"I was part of a machine that put out images of artists, specifically hip-hop artist, which are usually Black of Brown. The images that we put out didn't always reflect who I thought I was as a Black man, so I created my own side hustle," said Johnson. "I think that there should be media that covers hip-hop. The magazine came out of my desire and need to add to that and show more representation of Black men in media."

One night in 2005, Johnson and a few friends got together in Harlem for drinks and decided that they would make this magazine happen. Johnson was only 29 at the time, but had built relationships with people working in entertainment and media during his years at Def Jam. The vision for Bleu Magazine was a magazine that would celebrate Black men who are entrepreneurs, creatives and professionals. There is also content on men's style, grooming and current events.

The magazine's first issue

dropped in 2006. Even though that was the only issue published that year, the year was still successful and filled with learning experiences. Johnson was serious about making sure that it would be a respectable print publication. Starting out, his writers were friends and volunteers, but they also all had English, journalism or communications degrees. Johnson, himself, went back to school midway through launching the

magazine and received a master's degree in journalism from Harvard University.

"I respect Black people working in media and especially print media. It's something about being able to touch those pages with Black and Brown faces on them," said Johnson. "I always wanted to be more than a blog. I wanted to be a respectful to journalism, so I took the time to really study the business of it and all of

my writers are people with English degrees, journalism degrees and communication degrees."

While Johnson has a passion for print media, Bleu Magazine is online and on social media outlets including Facebook, Instagram and YouTube as well. In 2016, Johnson also decided to add on an online publication that would cater to Black women. Bombshell celebrates women for being smart, creative and bold

entrepreneurs. There are aspects of beauty and style on the website, but the mission is to celebrate women for their inner-qualities and brave actions.

Johnson spreads his network further with his Connect-Us panel events. These events connect creatives with people who work behind the scenes like lawyers, marketers and branding agents. It also has a goal to connect Millennials and Generation X. Outside of media and journalism, Johnson is all about being wellgroomed. He sells a subscription box of men's grooming products, called Beauxbox. The box comes every other month with five to ten samples of grooming products made

for Black men. Sometimes, the box even includes gadgets or clothing

Bleu Magazine remains Johnson's primary business, however. The magazine publishes four times a year and is distributed all over the country as well as internationally in the United Kingdom and France. It also has advertising partnerships with Lexus and BMW and has had some celebrities on its covers including Matt Barnes, J.R. Smith, Ryan Leslie and more. Changing the people view the country of Jamaica and its rich culture, one dancehall queen is breaking cultural barriers with her organization's international Wan Move Diaspora Experience (WMDE) Conference and festival.

Cheers, whoops and applause filled the air, but it wasn't to a concert or a game. Instead, more than 400 Los Angeles-area high school students were responding to the chance to receive scholarships for college.

The educational event, held Nov. 16 at the Hyatt Regency LAX Hotel, was part of the Empower Me Tour (EMT) sponsored by the United Negro College Fund (UNCF). The free college-readiness program allowed students to obtain information and admission to the nation's historically Black colleges and universities (HBCUs).

Instant scholarships were another EMT bonus for five graduating seniors, who surprised to collect the \$2,500 awards. The recipients were Christian Dixon, Mohamad Lorenzano and Jada Salazar of Susan Miller Dorsey High School; Samad Acklin of Early College High School and Kiara Phillips of USC Media Arts High School.

Salazar, who grew up in the foster care system and hopes to attend Spelman College in Atlanta, said, "Applying for colleges and exploring opportunities help me to know that I can strive."

Exposing students to future possibilities is one of the goals on the EMT program, according to Paulette Jackson, UNCF vice president of development.

"Students will walk away from here today understanding what it takes to get into college, get financial aid and they'll be a little more empowered within themselves. They will have a chance to attend workshops that deal with self-esteem and help them to understand who they are personally and feel that confidence as they get ready to go off to college," said Jackson.

Participating in the EMT certainly boosted the confidence of Inglewood High School senior Donaja Heard, who plans to major in criminology and become

"Their (HBCU representatives) energy is really good here and helped me not to be scared. I'm usually a shy person, but they understand what I'm going through and they've experienced the things that I've experienced," said Heard. "Also, I liked being around my peers who want to be successful just like myself."

Reggie Trimble, a senior at Compton Early College High School, enjoyed the welcoming environment as well. "Everyone was really nice and real approachable. You could talk to each college [representative] and learn what you can get from each college without feeling any pressure. I'm thinking about attending a HBCU and majoring in business or finance."

In addition, the event included three interactive sessions to further aid students. "For the Culture: HBCU Experience" showcased the history and experiences at HBCUs. "My Black is Beautiful: Girl Talk" dissected barriers of beauty and shared strategies for educational and professional success. "Tied to Greatness: Guy Talk" highlighted how successful, minority men overcame struggles and obstacles during their educational pursuits.

Jackson added that EMT also features a second track, which starts in the spring, focused on career-readiness for college students. UNCF uses that platform to introduce undergraduates to representatives from graduate schools and potential employers.

"The students are able to apply for internships, screen for an opportunity for full-time employment,

"Jamaican culture is probably one of the most borrowed cultures in the Stanley said. "When you listen to music, or eat these homestyle meals, or wear these unique fashions, a lot of those origins come from Jamaica."

"Throughout history, so much has been borrowed or taken from Jamaica and yet, so little has been given back," Stanley continued. "My goal with this international festival is to bring more awareness to this magical island, to be a positive representation of our Black roots globally and to bring people together on an international level, embracing the power of Jamaican culture and overall Black heritage."

More than just a dancehall, Stanley says that the eight-day extravaganza will also include interactive workshops, contests, excursions, and special commentary from Jamaican dignitaries, and even some high profile celebrities, including famed professional dancers such as Anthony Burrell (USA), Mestre Calango (Brazil), Miriki (Australia) and even long-time reggae superstar, Beenie Man.

"This event will be a time of cultural knowledge and unity among the Black diaspora and the world," Stanley said. "It's an ode to Afro dance and will provide an opportunity to present this dance on a worldwide stage. To date, Wan Move Dance Experience has confirmed representatives from more than 41 countries, that will incite global conversations through the language of dance."

Collaborating with the Jamaican Board of Tourism, the event is also expected to bring additional awareness and revenue to the often impoverished country, where tourism generates a majority of the island's income.

Leading the way on the JBT's initiative, the Hon. Oliva Grange, the Minister of Youth & Culture, is also expected to receive WMDE participants, to the landmass that receives a minimum of one million visitors a year.

Hosting dance experiences across the globe to over 70 different countries, including Serbia, China, Thailand, India and Sri Lanka, Stanley states that her passion to re-establish the beauty of Black culture continues to serve as a pivotal drive to continue to expand her business and maybe even one day, run for congress.

"I am excited to bring together a vast array of people that will learn, grow, and experience other cultures together," Stanley said. "The love of the art of dance speaks to a bigger idea of unity that breaks the boundaries of race, class, gender, and sexual orientation and if I could apply these same principals to politics, someday I might even be able to make a big impact in congress."



Digital Boom and Tech Access Fuel Black Entrepreneurship

Nielsen Report Underscores Growing Competitive Marketplace with New Content Creators, Product Developers and Business Owners

No different than the impact industry had on America's business model of the early 20th century, new technological innovations have significantly changed all aspects of business, from the way people consume to how brands engage consumers.

"We are on the threshold of a new business paradigm," said Cheryl Grace, senior vice president, U.S. strategic community alliances and consumer engaegment at Nielsen. "The digital age is transforming not only commerce and the relationship con-

nies, but digital know-how among consumers – particularly African Americans – is fostering new levels of independence and financial freedom."

For African Americans, these milestones of innovation have played integral roles in how Black households have navigated socioeconomic status while keeping pace with an everchanging American business landscape. Innovation breeds new opportunities, fosters entrepreneurship and spurs educational advancement to meet the demand for professional specialization.

Nielsen's latest report, "From Consumers to CreBlack Consumers," makes the case that a legitimate renaissance is taking shape within the African American community. The digital age and its technologies are outpacing 20th century business practices by leaps and bounds. The byproduct? Rapid changes in the economy and society are unearthing opportunities for entrepreneurs and businesses -Black-owned businesses. The digital boom and access to tech have created a democratization of digital platforms in which African Americans are not just embracing but thriving.





critique, connect and hold brands accountable in full display on social media platforms. With a buying power of \$1.3 trillion, Black consumers are effective in supporting brands that align with their preferences and ignoring those that do not.

More importantly, the most enterprising Black consumers are transforming from Consumers to Creators and ultimately becoming the Competition to the brands or industries that have been more exclusive than inclu-

McCaskill added, "At the nexus of digital interconnection, entrepreneurship and an unyielding desire to control and share their own images and ideas, African Americans are using the media-verse as a springboard for content creators to become decision makers. Black consumers are taking a 'for us by us' approach to building new platforms and business models, thereby creating entirely new Black financial ecosystems."

Beyond Elections and Fictions of Fear: Realities of Race and Righteous Struggle

whelming, the blue wave of Democratic election victories has washed over the U.S. in an important and promising way and it is good to celebrate on one hand, but also to review and stand ready to resume, continue and expand our efforts in struggle beyond the electoral arena. For regardless of the final count of votes and the naming of those who won, the realities of race and righteous struggle remain ongoing and urgent. And thus, there is still organizing work to be done, struggle for racial and social justice and equity to be waged and a radical transformation of society to be achieved around the central and enduring issues of wealth, power and status, especially statuses of race, class and gender, as well as other identities by which people are singled out, inferiorized and oppressed.

Also, we must remember that elections are not a panacea or path to liberation, only one of the various ways to seek power, critique and make policy, build alliances and layout an agenda, vision and way forward, in a word, part of a larger goal and struggle. This is the central message and meaning of Min. Malcolm's teaching that we "are living in a country that is a battleline for all of us." Indeed, then, there remain battles to achieve racial and social justice in every area of life: to achieve food for the hungry; housing for the homeless; healthcare for the ill, aged and all; security against violence internally and externally; against systemic and police violence, massive incarceration and inferior and inequitable education; for jobs and economic security; environmental care; and

immigration and international policy.

These elections clearly gave us reasons to feel a sense of triumph and satisfaction of work welldone, of people looking up from their little and large screens, seeing the crisis facing the country, becoming concerned about the strong wind and debilitating stench of evil and injustice blowing our way and deciding to take an electoral step to halt and resist it. We were uplifted by the elections to Congress of African American women for the first time from Maine and Connecticut, a Somali Muslim woman from Minnesota, a Puerto Rican woman from New York and a Palestinian Muslim woman from Michigan. And we were reinforced by the number of women participating and being elected in general; Democrats winning back the House, 7 governorships and hundreds of legislative seats, and the strong close governor races of Stacey Abrams (GA) and Andre Gillum (FL).

But a sober assessment must also take into critical account that still the haters, howlers, wall builders and armed, angry and animusdriven persons, groups and constituencies - Trumpites and otherwise - still have a strong hold on the way this country thinks and acts. And although it is often explained and excused as fear, it is not so. Indeed, at the heart of the way they vote and act is not simply fear of us or the world, but a deeply entrenched disorder, an inability to relate rightly and give due respect to different human beings, especially Black people, unless compelled through struggle, whether we call it racism or White supremacy. The claim of fear as a mo-

tive and motivation for the mean and murderous things White people do to us and other peoples of color and those vulnerable is a fictitious fear. For it is really racial, racialized and racist hatred and hostility that is masked, manipulated and self-induced in varied personal and collective ways as fear.

By fictitious, I mean it is false, artificial and imaginary. It is a false fear in that it is not true, but rather pretended fear to justify their reckless and depraved disregard for Black lives and rights. Whether expressed through vigilante or police violence, it is a pretension and excuse to target, abuse, suppress and kill. Clearly, Zimmerman was not afraid of Trayvon Martin, but stalked and killed him, and then claimed threat and fear. Likewise, the cop that killed little Tamir Rice playing in a park couldn't possibly have feared for his life as he claimed. Nor were those police afraid who killed numerous other unarmed Black women, children and men. And neither are White people in general who control the police and the armed forces and are with the latest civilian and military grade weapons.

This fictitious fear is not only false, but also artificial, that is to say fabricated, concocted and cooked up by politicians and others to build and sustain a base of mindless minions under the banner of a white god, steel grey guns and a redneck, white-skinned and blue-eyed aggressive and predatory patriotism. We are told too often on the nightly news and in various studies, the White haters, howlers and silent ones are mean and murderous because of fear of losing and change, fear of refugees, asylum seekers, immigrants, Muslims and always Blacks of every age and every educational and economic level. And we are told Trump sends them dog whistles to rally and rouse them up and that's why they say, imagine and do

the terrible things they do. But this is a too convenient and exculpatory explanation. First, it is not a dog whistle, for if it were, we as humans couldn't hear it. And if it really is a dog whistle, what does it say about those who hear it? And second, there's no need nicknaming the truth here. It's not a dog whistle, but a White whistle, a White racist whistle, designed to prick the ears and further freeze the hearts of those already hating and hostile and those ready to be recruited into a moral and social madness they choose. Thus, talking about dog whistles is diversionary and again camouflages

and hostility that informs this fabricated fictitious fear.

Finally, this fictitious fear is not only false and artificial, it is also imaginary, that I to say, it selfinduced racial fantasy. It is a boogey man of the mind, born of self-generated illusions and insecurities about a myriad of things, especially race. It is a psychological disorder on at least two counts: taking illusions as reality and reacting to them; and embracing an irrational hatred and hostility toward others based on the specious concept of race. Like other phobias in the strictest sense, it has no basis in reality nor reason to exist. On the contrary, it is born of an imaginary threat made up in one's mind and cultivated into a mental disorder with disastrous results.

Now, it could be said that even if the basis of the claim of fear is false and unreal, the "fear" itself is real to the people who possess it. In one sense, this is so, but their claim of fear and others' claim of it for them must be seriously qualified. We must still strip away any claimed rational, moral and empathetic qualities; deny its justifying claims for doing evil and injustice; and expose it as what it is -- racist hatred and hostility that consumes, controls and increases the insecurities and irrationality of its possessors and is destructive to others.

And of course, this means setting aside all illusions about America

"great again" righteous and relentless transformative struggle. Moreover, we must remind ourselves that central to all we wish, want and work for is our regaining our self-understanding and self-assertion in the world as a moral and social vanguard whose ethical mission is defined by the ancestral and moral imperative to bring good in the world and not let any good be lost. As our foremother, Mary McLeod Bethune, ever reminds us, "Our task it to remake the world. It is nothing less than that." Indeed, as a moral and social vanguard, our role has historically been and must remain: those who are at the forefront in defining the essential moral concerns and conversations in this country; and in struggling righteously and relentlessly in alliances and coalitions to determine its political direction in the interest of an inclusive human good and

THE EASTSIDE BOYS

"We got what we wanted but lost what we had." (An Eastside boy)

Older Blacks compare conditions under lawful segregation with post-civil rights de-facto segregation that legally afforded them greater opportunities but did not eliminate the barriers that still block such opportunities.

Nowhere is this dilemma more evident than in the conversations of Los Angeles' Eastside Boys who grew up in the 1930s through the 1950s. Some were born in Los Angeles; others came with their families, mostly from the South, and found Los Angeles, in many ways, just as segregated as the cities and towns they came from. Paradoxically, segregation spawned strong individual and community bonds that significantly evaporated because the new opportunities steadily fueled a mass exo-

dus from the Eastside. (The Eastside was not East Los Angeles. boundaries were Street on the west, Alameda Street on the east, Washington Blvd on the north and Slauson Avenue on the south.) The Eastside Boys (now Eastside Boys and Girls) continue to meet every summer, a testament to their resilience and lasting affinity.

The balance of today's column consists of excerpts from Erin Aubry-Kaplan's (then Erin J. Aubry) 1997 Los Angeles Times Magazine cover story, "The Eastside Boys."

Most Blacks left the Eastside when they could, as soon as they could, starting in the early '50s; it was an onward flow that, in

retrospect, was a hemorrhage, an exodus of Black people from a place that both built them and bound them. It's an old story to all of us now: the sudden fury of flight and the broken economy left in its wake, like debris scattered in the aftermath of a storm.

Still, out in the new territory of the Westside and South Bay, of Crenshaw and Ladera Heights and Baldwin Hills, a lot of promise was realized in the form of college educations and fruitful careers—more opportunities for the Eastside Boys and their children. The Eastside Boys respected and supported one another and felt there was nothing especially noble or self-sacrificing about it; but they find themselves where they never expected to be, in the role of heroes and gatekeepers, living connections to the last era of bountiful times for many Black people. They are the flashpoints of a social upheaval that cast off segregation and laid a new course.

None offered (when interviewed) any definitive answers. Yet, in spite of a city so changed from what they knew, so disparate and willfully disconnected, their spirit was never broken. My father said, "To

me, it's more a matter of

(pause).....It's a good It was the sort of environment devoid of judgment; it didn't matter who you were, judge or janitor."

"Damn right" said Hal Miller, founding convener of the Eastside Boys, "There was no caste system.....Everybody knew everybody and they lived together. Doctors, lawyers, butchers, domestic workers. You didn't have chance to commit a crime. The old ladies would be sitting out all day on the porches, snapping string beans, yelling at each other across the street, telling each other the news. Shoot, if you did something bad in school, the message would beat you home. You'd get a whipping at school and another one would be waiting for you when you walked in the door."

Hal's uncle, Loren Miller, owned the California Eagle Newspaper and was a celebrated attorney who helped win the 1948 Shelley vs. Kramer court case that struck down restricted housing covenants. cousin, Leon Washington, launched the city's other Black newspaper, the Los Angeles Sentinel.

The Eastside Boys gettogethers were strictly male affairs, fraternizing in the tradition of '40s social clubs such as the Cosmos and the Blue Devils. A "No Women Allowed" sign hung prominently for over 20-years. "Completely sexist", my father said amicably. In 1994, the Eastside Boys organized a massive event at the Convention Center. It wasn't easy to get, but Eastside Boy Tom Bradley

intervened.

Attorney Walter Gorfeeling, a link to the past. don, Sr., (he died at age 104), recalled that in the beginning, Negro activity was concentrated downtown-first around 2nd and Los Angeles Streets and then around 12th and Central, and eventually, Vernon and Central. As a young man, Gordon was a member of the L.A. Forum, a Black civic organization where Black and white attorneys from all over town met to discuss discrimination. Block by block, year by year, Blacks expanded their boundaries southward along Central Avenue. When Gordon returned to L.A. from law school in 1936, Central Avenue was just beginning to hit its stride as a hub of Black business and a mecca for jazz. It would be the best of times for the Eastside Boys. Segregation was still virulent, ubiquitous, but its heavy hand had also compressed the brightest hopes and aspirations of Black people into a potent square of time and space made all the stronger because of the strictures placed upon it. And there was hope, passed from one generation to the next, that the barriers of segregation would finally come down.

> The Eastside Boys were part of the driving social forces that blew their history to the wind. There are no heroes or anti-heroes. The Boys may live now with their point of origin in their sights, but they do not go back. Their heroism is in recognizing the truth and going forward.

Is the FBI Underreporting the Surge in Hate Crimes?

The FBI has released it's 2017 hate crimes statistics, which revealed a 17 percent increase in incidents since 2016. In 2017 there were 8,493 victims and 6,307 known offenders. By comparison, there were 7,509 victims and 5,727 known offenders in 2016, according to the data.

"This report is a call to action – and we will heed that call," Acting Attorney General Matthew Whitaker said in a statement. "The Department of Justice's top priority is to reduce violent crime in America, and hate crimes are violent crimes."

The report contrasts with the prior year when there were 6,036 single-bias incidents, or occurrences where the perpetrator has one bias against a community or group. By comparison, in 2017, there were 7,106 single-bias incidents reported.

According to the FBI, "58.1 percent were motivated by a race/ethnicity/ancestry bias, 22.0 percent were prompted by religious bias, 15.9 percent resulted from sexual-orientation bias and 1.7 percent were motivated by gender-identity bias."

"This [report] is shocking and requires Congress's full attention," NAACP President and CEO Derrick Johnson said in a statement.

"Shouldn't this urgent crisis be the subject of the first post-recess Senate Judiciary Committee hearing today, instead of ramming through more Trump judges? Our lives are at stake," Johnson said.

Also, some organizations are skeptical of the FBI statistics and say underreporting remains a significant problem in its annual survey.

In a statement, the Arab American Institute (AAI) expressed concern and disappointment with the release of the 2017 hate crime statistics.

The organization claims that the data contained some glaring omissions, including three of the most severe acts of bias-motivated violence committed last year. And while career officials at the Department of Justice continue to demonstrate a commitment to serving communities and preventing hate crime, officials at the AAI said they remain dissatisfied with the response from this administration.

Of 34 reportable bias motivation categories, all but five reported an increase in 2017. With 2,013 incidents reported, "Anti-Black or African American" bias accounted for nearly half of all crimes motivated by race or ethnicity, which rose 18 percent according to the FBI data, while "Anti-American Indian or Alaska Native," "Anti-Multiple Races, Group," and "Anti-Hispanic or Latino" hate crimes all increased over 20 percent (251, 180, and 427 incidents, respective-"Anti-Arab" hate crime, which was reintroduced into the data collections in 201 after the category became "invalid" in 1996 and was eliminated in 2001, increased 100 percent last year, with 102

As for crimes motivated by religion, which increased 23 percent in 2017, "Anti-Jewish" hate crime surged 37 percent, representing a majority with 938 incidents report-

incidents reported.

ed. After increasing 67 percent in 2015 and 19 percent in 2016, "Anti-Islamic (Muslim)" hate crime decreased in 2017, but remained well above historical averages with 273 incidents reported.

Based on state-level hate crime statistics reported through the Uniform Crime Reporting (UCR) system, which the FBI also uses to publish its annual report, the AAI was expecting an increase of crimes motivated by sexual orientation in 2017 statistics.

While an increase was reported in the federal data, it was less significant than expected, the organization noted in a statement.

Analysis from AAI shows that in multiple states, official state-level data reported a greater number of incidents than what is reported in the FBI's statistics.

Crimes motivated by disability, gender, and gender identity, which are more recent additions to the data collections and generally produce smaller annual totals, were significantly affected by these discrepancies.

For example, the Kentucky State Police reported 41 gender-motivated hate crime incidents in official state-level statistics, whereas only 46 incidents were reported nationwide according to the FBI data.

Aside from these discrepancies, additional aspects of the 2017 federal data suggest significant underreporting, the most striking of which being the omission of three of the most severe acts of biasmotivated violence committed last year, AAI officials said.

According to FBI statistics, the city of Olathe, Kansas, reported no hate crimes, and statewide, zero hate crime murder were reported in 2017.

But on February 22, Srinivas Kuchibhotla was shot to death in an Olathe bar because of his perceived national origin, according to the AAI.

The shooter, Adam Purinton, who also wounded Kuchibhotla's friend Alok Madasani and another man named Ian Grillot, was convicted on federal hate crime charges. Similarly, neither the May 26 fatal stabbing of Ricky John Best and Taliesin Myrddin Namkai-Meche aboard a train in Portland, Oregon, nor the August 12 killing of Heather Heyer in Charlottesville, Virginia, is

reflected in the federal data. Further, over 300 jurisdictions representing populations of at least 50,000 people reported zero hate crimes in 2017.

Of these jurisdictions, 78 represent populations of at least 100,000, and research from AAI found evidence of no fewer than 10 additional major jurisdictions that did not even participate in the data collections.

The largest jurisdiction to report zero hate crimes in 2017 was the Las Vegas Metropolitan Police Department, which represents a population of over 1.6 million and is one of the nation's largest police departments in terms of population served.

The entire state of Nevada had only three agencies submit incident reports last year, with just five incidents reported statewide

tatewide.

Not including Hawaii,

which does not participate in the national hate crime statistics program, 11 additional states had fewer than 10 agencies submit incident reports in 2017.

"The reported increase in the FBI's hate crime statistics warrants concern, as do the discrepancies between state and federal hate crime data, the omission of several high-profile hate crime incidents, and the limited rate of hate crime reporting in some major jurisdictions," AAI officials said.

"The scourge of hate crime continues to harm communities in cities and states across the country. The FBI data confirms the reality we all know: hate is increasing in America," said Maya Berry, the executive director of the AAI.

"The FBI data, in what is missing from it, also demonstrates the hate crime reporting system we have in place is falling to respond adequately to hate crime, and thus inform fully the policy remedies we must make to improve our response to hate," Berry said.

Berry continued:

"While we remain grateful to the career professionals at the DOJ, it is clear the Trump Administration has largely abdicated from the stated federal interest of eradicating biasmotivated violence, and the president's rhetoric has at times appeared to exacerbate its spread. With respect to the recent data release, AAI is disappointed that despite our request, the administration made no attempt to coordinate an event with stakeholders and officials to discuss the annual FBI statistics, as was customary during previous administrations."

#Former Army Attorney Says NFL Players Have Abandoned Racial Injustice Protests

NFL players have largely abandoned both challenging the harsh reality of racial injustice in this country via protest and supporting Colin Kaepernick as the number of demonstrations during the anthem continues to dwindle, according to Kaia Wright, a highly decorated former Army attorney.

Wright, who has served on tours around the world, says that the increasing number of "living while Black" incidents — where White calling the police on Blacks who go about their daily routines—are yet another reflection of the pervasiveness of racism in America.

Over the past weeks, the silent protests, initiated by former San Francisco 49er quarterback Colin Kaepernick, become fodder for discussion when pop superstar Rihanna said she would not perform at the Super Bowl. This was followed by an astonishingly callous plea from Maroon Five for Rihanna to reconsider and join them for this year's Super Bowl performance. Comedienne Amy Schumer also announced she will not do any Super Bowl ads. Add to this the refusal by Jay-Z to perform at the Super Bowl, and it's clear that celebrities continue to show their support for Kaepernick's obvious black-

ball from the NFL.

Wright created a website,
Courage-Under-Fire.com,
which is the only site that
offers an impressive, comprehensive curation of articles and images that chronicle coverage of protests during the anthem, including all
reports of protests during the
anthem throughout the
nation. As the season enters
the second half, Wright offers
the following insights:

With more than half the 2018 NFL season completed,

I'm concerned about the significant reduction in players demonstrating during the anthem. There are two core issues two consider here. First, the proliferation of racism and White supremacy continues to permeate the lives of Black Americans. Look, we've just recognized the 50th anniversary of Tommie Smith's and John Carlos's bold protest of raising their fist during the national anthem; yet Kaepernick and the other NFL players are protesting several of same issues that Smith and Carlos protested in the 1960s. It's truly unsettling to know that despite the persistence of systemic racism in this country, to include the recent proliferation of "living while Black" incidents, we see fewer and fewer players demonstrating during the anthem.

Second, Colin Kaepernick does not have a job in the NFL despite the fact that he is far better than several quarterbacks in the league, starting and backup, a point made recently by Eagles safety Malcolm Jenkins. Nike made a bold statement by using Kaepernick in its 30th anniversary of the "Just Do It" campaign. While critics were quick to call out Nike's demise, the company's stock price - and sales rose dramatically, generating more than \$6 billion since the ad campaign ran.

Nike just introduced a Kaepernick shirt retailing at \$50, which sold out in hours. What this tells me is that Kaepernick has more supporters than the NFL and his haters want to believe. Why? Because social injustice is everywhere – from the suites to the streets and to the stadiums around this country. Kaepernick's continued exclusion from the league

remains a major point of contention. Just ask Panthers' safety Eric Reid who criticized Jenkins, a member of the NFL Players Coalition, for both agreeing to a monetary deal with the NFL that was seen as a move to stop players from protesting during the national anthem, and for not including Kaepernick's bar from the league in the negotiations. As such, Kaepernick's shameful, racist exclusion is yet another appropriate basis of player protest.

It's time for players – and America – to embrace the power of protest during the anthem as a powerful, patriotic action challenging the centuries-long failure of America to properly extend the rights and freedoms symbolized by the national anthem to its Black citizens. It's time for the critics to realize that this is not North Korea or some other totalitarian country where protest during the anthem is punishable by imprisonment or other government sanction. Further, Black Americans are autonomous citizens (courtesy of the 14th Amendment ironically) whose decisions about what to do during the anthem are not the purview of random, paternalistic white citizens.

We need to stand with Kaepernick and the other protest heroes. On behalf of Kaepernick and the systemic racism that continues in this country unabated, I ask the NFL and its players, do you have the courage to make your objections to racism/White supremacy known in this powerful way?

Does Democratic Takeover of the House Mean the ACA is Safe?

"I'm signing it for 11vear-old Marcelas Owens. who's also here. Marcelas lost his mom to an illness. And she didn't have insurance and couldn't afford the care that she needed. So in her memory he has told her story across America so that no other children have to go through what his family has experienced ... We are a nation that faces its challenges and accepts its responsibilities. We are a nation that does what is hard. What is necessary. What is right. Here, in this country, we shape our own destiny. That is what we do. That is who we are. That is what makes us the United States of America." President Barack Obama, March 23, 2010, on signing the Affordable Care Act

The Affordable Care Act of 2010, also known as "Obamacare," is one of the most consequential acts of Congress in the 21st Century, especially for African Americans. The ACA slashed the Black uninsured rate by 40 percent. According to the National Urban League's annual report on the social and economic status of African Americans, State of Black America, racial health disparities began to narrow as a result of the law.

The U.S. House of Representatives has voted to repeal the ACA more than 50 times since 2011, only to have the repeal blocked by the Senate. While the Administration may have succeeded in chipping away

at the law through executive action, the Democratic takeover of the House at least will put an end to attempts at full repeal.

The 2018 midterm campaign season saw candidates across the political spectrum campaigning on promises to retain the ACA's provisions barring insurers from denying coverage to people with preexisting conditions or charging sick people more. Even candidates who previously voted to repeal the ACA adopted the rhetoric.

Voters in Idaho, Nebraska and Utah even passed ballot initiatives that will expand Medicaid to more than 330,000 low-income adults, an option made possible by the Affordable Care Act.

Recent polling and the results of the election make it clear: the vast majority of Americans support the ACA and rely on its protections.

And the incoming Congress has vowed to strengthen it.

To be sure, there is work

to be done. The very first executive order issued by the current Administration was a vague directive to "to waive, defer, grant exemptions from, or delay the implementation of any provision or requirement of the Affordable Care Act" that imposes a cost, fee or "regulatory burden."

Since then, the Administration and the Congress have taken dozens of steps to sabotage the law, the most significant being the repeal of the individual mandate requiring most Americans to carry health insurance. According to the Congressional Budget Office, the repeal is estimated to leave 13 million more Americans uninsured by 2027, and to cause premiums to spike 10 percent. A pending lawsuit by 20 states, with support

from the Administration, challenges provisions of the Affordable Care Act, including the protections for people with pre-existing conditions.

Reversing this sabotage must be a top priority for the incoming Congress. The individual mandate, which is a key factor in keeping premiums affordable, must be restored. Prescription drug prices remain too high.

One of the Urban League Movement's core goals is that every American has access to quality and affordable health care solutions. It's why we fought so hard for the passage of the Affordable Care Act, and why we continue to fight so hard to protect it. A majority of the members of the 116th Congress, which convenes in January, have vowed to protect it, too, and we will hold them to that promise.

In his campaign for Superintendent of Public Instruction, Thurmond was supported by Senator Kamala Harris, the California Democratic Party, and Cali-

relationship between the department and the commu-

how to] contain it and prevent anyone else from being impacted by it. This will improve the odds for a better outcome."

During the interview, the LA County sheriff challenger also discussed his plans for increasing African American enrollment for both men and women at LASD.

If Villanueva wins the LA County sheriff race, he will make history as the first Democrat to do in 138 years and will be the first person to replace an incumbent in 100 years.

Rapper Snoop Dogg, a 16-time Grammy nominee, received a star on the Hollywood Walk of Fame today, four days before the 25th anniversary of the release of his debut album ``Doggystyle."

Talk show host Jimmy Kimmel, record producer Quincy Jones and the rapper Dr. Dre were among those attending the ceremony in front of the El Capitan Entertainment Center on Hollywood Boulevard where Kimmel's show is taped.

After thanking friends and family, Snoop Dogg ended his acceptance speech by quipping, "I want to thank me."

"I want to thank me for believing in me," he said. "I want to thank me for doing all this hard work. I want to thank me for having no

days off. I want to thank me for never quitting. I want to thank me for always being a giver, and trying to give more than I receive. I want to thank me for trying to do more right than wrong. I want to thank me for just being me at all times."

His star is the 2,651st on the famed walk.

Born Calvin Broadus on Oct. 20, 1971 in Long Beach, he got his stage name from his mother Beverly who joked he looked like the Peanuts character Snoopy.

Snoop Dogg's rap career began by making mixtapes with his cousins Nate Dogg and Lil 1/2 Dead and friend Warren G. One tape was heard by Dr. Dre, who invited him to audition.

"Doggystyle," released on Nov. 23, 1993, debuted at No. 1 on the Billboard 200 and sold more than 11

clude "Gin & Juice," "Who Am I? (What's My Snoop Dogg's other Name?)," "Nuthin' But A memorable works 'G' Thang," "Next Episode," "Beautiful," "Drop It Like It's Hot," "Signs," "Sensual Seduction" and "I Wanna Rock."

Snoop Dogg's 16th and most recent studio album, "Snoop Dogg Presents Bible Of Love," was released March 16, debuted at No. 1 on the Billboard charts and stayed there for eight weeks. It was his first foray into the gospel music genre.

Snoop Dogg and lifestyle guru Martha Stewart have co-hosted the VH1 variety series, "Martha & Snoop's Potluck Dinner Party" since 2016. His other television projects have included the 2002-03 MTV sketch comedy series "Doggy Fizzle Televizzle," the 2009 MTV talk show, "Dogg After Dark" and the 2007-09 E! Entertainment Television documentary series, "Snoop Dogg's Father Hood."

Snoop Dogg has had supporting and cameo roles in such films as "Training Day," "Starsky & Hutch" and "Bruno." He has appeared on such scripted television series as "One Life to Live," "Empire," "Monk" and "Las Vegas," and has been a voice actor on episodes of "The Simpsons" and "King of the Hill."

Snoop Dogg established the Snoop Youth Football League in 2005.

Snoop Dogg's brushes with the law began as a teenager and include the 1996 acquittal with his bodyguard of first- and second-degree charges in the 1993 shooting death of a gang member at a Palms park.



"Throughout my career the diversity was close to nil, it's very slowly grown," remarked Isaacs. "I strongly believe that people who have any kind of power should hire, mentor and promote."

The other Pat Tobin honorees of 2018 were Ellene V. Miles, senior vice president of intersectional marketing at Sony Pictures Entertainment; Lindsay Wagner, vice president at Ketchum; Michael Lewellen, vice president of corporate communications for APR; Tosha Whitten-Griggs, TV One's senior vice president of public relations; and Shawn Smith, director of public relations and brand partnerships with MGA Entertainment.

All of the recipients mirrored the sentiments that there is a need for inclusion particularly of Blacks in their respective positions and fields, which is consistent with the vision of the founding members of the BPRSLA, which is an affiliate chapter of the NBPRS.

The NBPRS was cofounded by Tobin in 1998 with a mission to serve as "an advocate for Black professionals in public relations, media relations, corporate communications, investor relations, government affairs, community relations, and related fields" by providing peer-to-peer supports, mentorship, networking, job opportunities, and career advancement strate-

Tobin's firm, Tobin & Associates, is one of the most prominent minority, female-owned public relations firms in the nation. In 2008, she lost her battle to cancer at the age of 65. Her impact has left a lasting impression on the world of public relations, especially in the greater Los Angeles area. Many of the honorees shared their personal connection to this public relations juggernaut, including longtime news anchor and reporter Beverly White.

"Pat was the glue," recalled White, who was honored with the Power Press award. When White became a local news reporter in Los Angeles 26 years ago, she shared that Tobin sent her a Varnette Honeywood greeting card with a personal written

In Defeat, Abrams Emerges as Leading Voting Rights Advocate

Stacey Abrams broke the rules of politics until the very end.

The Georgia Democrat who came about 60,000 votes shy of becoming America's first black female governor refused to follow the traditional script for defeated politicians who offer gracious congratulations to their victorious competitor and gently exit the stage. Instead, Abrams took an unapologetically indignant tone that established her as a leading voting rights advocate.

"I acknowledge that former Secretary of State Brian Kemp will be certified as the victor in the 2018 gubernatorial election," Abrams said in a fiery 12-minute address. "But to watch an elected official ... baldly pin his hopes for election on the suppression of the people's democratic right to vote has been truly appalling."

"So let's be clear," Abrams concluded, "this is not a speech of concession."

Pointedly refusing to concede would typically risk drawing a "sore loser" label that would be impossible to shake in any future political campaign. But Democrats and even some Republicans say she is likely to emerge from the closely fought governor's race with her political future on solid ground.

"There was a time when this may have been a bad look, but I'm not sure that's where we are in politics anymore," said Jen Palmieri, who served as communications director for President Barack Obama's White House and for Hillary Clinton's 2016 presidential cam-

"For many years, people have been too concerned about the optics of their actions as opposed to the impact of their actions," Palmieri added, saying that addressing some voters' lack of faith in the system is "more important than worrying what might offend people who may or may not vote for you four years from

Republican Rick Tyler, a top adviser to Sen. Ted Cruz's 2016 presidential campaign, said "botched concessions have hurt people before," but he said it's too simple to say Abrams "botched" anything because some of her criticism has

"I wish we could all have faith in the system and the process," Tyler said. "Then we could count votes, listen to gracious concession speeches and all just move on. That's not where we

Abrams cited a litany of problems that she said add up to systemic voter suppression. She specifically

pointed to absentee ballots thrown out by what she called "the handwriting police," a shortage of paper ballots to back up brokendown voting machines and Georgia's so-called "exact match" voter registration rules that require information on voter applications to precisely match state and federal files.

While state law allows "no viable remedy," she said she plans to file federal legal action challenging various aspects of the electoral system Kemp oversaw until he resigned as secretary of state two days after the Nov. 6 election. She also launched the new nonprofit group "Fair Fight Georgia" to advocate for changes.

In an interview Sunday, she confirmed the federal lawsuit would be filed this week. "We are going to ask the court to use all the legal remedies possible to force reform in our electoral system," she told The Associated Press.

Republicans Some rebuked her approach.

"She seems to think there are only two branches of government: executive and iudicial," said Debbie Dooley, a Georgia-based activist who was among the early national tea party leaders. "I'm just disappointed that her immediate adversarial response is to file lawsuits when there are a lot of people on the Republican side who see a need for some of the reforms she wants."

For starters, Dooley cited an absentee ballot process that varies from county to county and Georgia's reliance on electronic voting machines with no paper trail, a system a federal judge already has harshly criticized in a separate case.

"If they try to do it all through the federal courts, it's going to end up with people resenting her," Dooley predicted.

In her speech Friday, Abrams said "pundits and hyper-partisans" would object to her flouting "normal order" for losing candidates. "I should be stoic in my outrage and silent in my rebuke," she said of conventional expectations. "But stoicism is a luxury and silence is a weapon for those who would quiet the voices of the people.'

She told AP her goal with Fair Fight Georgia "is to make sure that when the next campaign happens, there is a clear understanding of what occurred" in her loss to Kemp.

Georgia Democrats said Abrams has little choice but to continue highlighting problems.

"The middle ground here is simple: 'Count every vote," said Allegra Lawrence-Hardy, Abrams' campaign chairman.

Buddy Darden, a former congressman who chaired the campaign of Abrams' Democratic primary rival, agreed. Darden, who is White, said Abrams proved wrong the "old dinosaurs like me" who thought a Black woman couldn't compete in a general election in the Deep South. "She did it by getting folks out that no one else could," Darden said. "Now she has their back, and that's a good thing for the party, a good thing for the state.'

Palmieri, the former Obama and Clinton adviser, said Abrams can fill an important national void. Republicans, she said, have spent a generation focused on passing GOP-friendly voting rules, redrawing district boundaries and electing like-minded secretaries of state like Kemp. The left has answered with a lesseffective patchwork of lawyers and think tanks. "She would be a formidable force on that front," Palmieri said.

Abrams did not say

what her next bid for public office would be, but makes clear she's not bowing out. Her next chance in Georgia would be to challenge for Republican Sen. David Perdue's seat in 2020.

"My mission is to take a little bit of time to decompress, and then No. 1, file this lawsuit, get this organization off the ground, get a little bit of rest and then get to work figuring out what we can do to not only help Georgia but help the United States," she told the AP.

History offers some parallels.

Democrat Al Gore fell just short of the presidency in 2000 after a U.S. Supreme Court ruling that affirmed Republican George W. Bush's victory in Florida. Gore never returned to politics, but he established himself as a leading advocate addressing climate change.

Republican Richard Nixon lost a bitter presidential election to John Kennedy in 1960, then followed with a loss in the 1962 California governor's election, prompting a bitter concession speech in which he declared himself done with politics. Six years later, he was elected presicapitalizing dent. Democrats' Vietnam-era disarray.

Cruz found himself in Republican crosshairs in 2016, when he spoke at the Republican convention but notably refused to endorse nominee Donald Trump for president. Weeks ago, Trump and Cruz embraced on a Texas campaign stage, helping Cruz to a hardfought re-election victory to the Senate.

The lesson, Palmieri said, is that "voters let these things play out."

First Black Democratic Nominee for Florida Governor Concedes

Andrew Gillum, who tried to energize Florida's young and minority voters through a Democratic coalition seeking to end two decades of Republican control of the governor's office, ended his hardfought campaign Saturday as the state's first black

nominee for the post. Gillum, whose refrain had been "bring it home" as he recounted stories of growing up poor in the state, concluded his campaign with a Facebook video he recorded alongside his wife in a park.

In his four-minute plus video, Gillum congratulated Republican Ron DeSantis and also vowed to remain politically active even though his term as mayor of the Florida capital of Tallahassee ends next week. Of his future plans, Gillum said: "stay tuned."

Gillum, just 39 years old, earned national attention and financial backing from well-known liberal billionaires with his first bid for statewide office. He ran on a liberal platform that included expanding Medicaid and raising taxes to spend more on education even though both ideas would have been hard to pass through the GOP-controlled Legislature.

His final act as a candidate was less confrontational than that of another prominent African American candidate in this year's midterm elections: Stacy Abrams in neighboring Georgia ended her campaign for governor on Friday, ceding to a Republican with an unapologetically indignant tone establishing herself as a leading voting rights advocate.

Gillum says he is ending his hard-fought race for Florida governor and has congratulated Republican Ron DeSantis (Nov. 17)


"This has been the journey of our lives," said Gillum, appearing in the video with his wife, R. Jai Gillum. "Although nobody wanted to be governor more than me that this was not just about an election cycle. This was about creating the type of change in this state that really allows for the voices of everyday people to show up again in our government, in our state, and in our communities. We know that this

fight continues." Gillum's concession came hours before Florida's counties must turn in their official results at noon Sunday after tense days of recounting ballots in both the gubernatorial and a U.S. Senate contest — two nationally watched midterm elections that have keep the presidential swing state on edge since Election

Gillum's brief remarks came hours after President Donald Trump, who at one point in the campaign had sharply criticized Gillum, praised him for running a

"He will be a strong Democrat warrior long into the future - a force to reckon with!" said Trump in a Twitter post.

Gillum had initially conceded to DeSantis on election night, but he retracted it as the razor-thin margin between the two candidates narrowed. But he still trailed DeSantis by more than 30,000 votes following a legally required machine recount. Counties are wrapping up a hand recount this weekend and must submit their official

results by noon Sunday.

Gillum's concession assures Florida Republicans will retain their grasp on the governor's office since Jeb Bush's term starting in 1999.

DeSantis, 40, was considered an underdog before Trump tweeted his support for DeSantis in December, a month before DeSantis even entered the race. Trump campaigned to help push DeSantis to a primary victory in August and visited Florida two more times to help the Republican in the final days of the elec-

DeSantis's campaign did not respond to Gillum's remarks, pointing instead to a statement the former congressman put out two days ago.

"Campaigns are meant to be vigorously debated contests of ideas and competing visions for the future," DeSantis said. "The campaign for governor achieved this objective as evidenced by historic voter turnout from people

of all parties across our state. But campaigns of ideas must give way to governing and bringing people together to secure Florida's future. With the campaign now over, that's where all

of my focus will be." DeSantis stumbled out of the gate after winning the Aug. 28 primary, telling Fox News that voters shouldn't "monkey this up" by electing Gillum.

Despite implications that DeSantis is racially insensitive — an idea he angrily disputed during a debate — he is poised to officially win the state that Trump carried in 2016. He has promised to keep intact many of the same policies on education and health care that have been in place by previous Republican governors.

DeSantis ran as a political outsider despite serving three terms in Congress and running for the U.S. Senate in 2016, before dropping out of the race when Republican Sen. Marco Rubio decided to

run for re-election.

DeSantis is a former Navy officer who graduated from Yale University before getting his law degree at Harvard University.

He gained name recognition during the primary with more than 100 appearances on Fox News, often to defend the president.

DeSantis ran a largely negative campaign, calling Gillum a socialist and saying he oversaw one of the most corrupt and crime-ridden cities in the state. Trump joined in on the criticism, tweeting similar messages. The corruption allegation stemmed from a continuing FBI investigation into City Hall that Gillum has said he is not a target of and is cooperating with; the charge that Tallahassee had the state's highest crime rate was false.

portrayed Gillum DeSantis as racially divisive, repeatedly pointing out his "monkey this up"

"I'm not calling Mr.

DeSantis a racist. I'm simply saying the racists believe he's a racist," Gillum said previously.

Gillum's announcement came as most Florida counties were winding down their hand recount in the state's contentious U.S. Senate race. The smattering of results publicly posted Saturday showed that Democratic U.S. Sen. Bill Nelson was only gaining a few hundred votes in his bitter contest with outgoing Gov. Rick Scott, a Republican.

State officials ordered a manual recount earlier in the week after a legally required machine recount showed that Scott led incumbent Democrat Bill Nelson by about 12,600 votes. More than eight million voters cast ballots in the race.

Nelson and Democrats filed several lawsuits following the close election, challenging everything from the state's signature mismatch law to deadlines for mail-in ballots.

If the 76-year-old Nelson loses, it would likely spell an end to a lengthy political career that stretches back four decades. Nelson was first elected to the U.S. Senate in 2000. A win for Scott would mark his third victory since the multimillionaire businessman launched his political career in 2010. In each race, Scott has barely edged his Democratic opponent.

State law requires a machine recount in races where the margin is 0.5 percentage points or less. Once that recount was complete, if the differences in any of the races are 0.25 percentage points or less, a hand recount is ordered. Local canvassing boards only review ballots where a vote was not recorded by voting machines.

Mississippi Senate Race May be Defining Moment for Black Voters

Mississippi Senator Cindy Hyde-Smith's remark to a colleague that "If he invited me to a public hanging, I'd be on the front row" puts the Magnolia State at center stage for Black voters in the 2018 mid-term elections.

Mississippi had the highest number of lynchings in the United States between 1882 and 1968, according to NAACP records.

Hyde-Smith's explanation that her phrase "was an 'exaggerated expression of regard' drew outrage from Dr. Maya R. Cummings, president and CEO of Global Policy Solutions, veteran Capitol Hill staffer and former vice president of research and programs at the Congressional Black Caucus Foundation.

"[It] shows how little regard her forebears had for Blacks they murdered and mutilated and how their atrocities are still accepted in

her culture," Cummings said. In the Nov. 6 mid-terms, Hyde-Smith finished in a dead heat with former Mississippi congressman Mike Espy, an African American who was the Clinton administration Secretary of Agri-

The two now will face each other in a runoff special election on Nov. 27. Hyde-Smith was appointed by Mississippi's governor to fill the remaining two years of the Senate seat when Thad Cochran vacated it due to ill-

culture, in a four-way Senate

As a Trump-endorsed candidate, she is in lockstep with the president's agenda, one Cummings finds polar-

According to initial Pew Research data, in the 2018 mid-terms, African Americans voted at 90 percent for Democratic candidates: nine percent for Republicans.

"African Americans and other people of color were motivated to turn out in

record numbers for mid-term elections due to the desire to see Trump's power curbed," Cummings observed.

"African Americans know exactly what Trump is and what he means for our future. Indeed, he has made no effort to hide his disdain for African Americans and other historically marginalized groups."

Some black analysts argue that a tax-cut-driven bump in personal income should prompt African

Americans to vote Republi-

But in Mississippi, in precincts where well-to-do and middle-class African Americans reside, Trump's tax cuts had no measurable impact in the mid-terms, according to Charles Taylor, principal and founder of Peyton Strategies, LLC, based in Jackson, Miss. Though he has provided consulting services for the Espy campaign, he is not a spokesperson.

"Precinct 83 is an affluent Black precinct in Jackson. Espy got 97.67 percent of the vote," Taylor said. "In Precinct 84, 95 percent. Precinct 85, predominantly Black middle class, 97.2 per-

Raynard Jackson, a Black Republican, is president and CEO of a government affairs and public relations firm in Washington. D.C. who has worked on numerous Republican campaigns, including Ron DeSantis' gubernatorial campaign in Florida against the Democratic candidate, Andrew Gillum, mayor of Tallahassee.

Though not an ardent Trump fan, Jackson criticizes the Democratic party for failing to deliver policies that enable African Americans to reach economic independence.

"I carried this message across the state to Black communities, 'how much are you willing to pay to make history?" Jackson explained.

He says Gillum's vow to increase the minimum wage and raise taxes to accomplish policy objectives make Florida's costs for electing its first African American governor too high.

"I'd ask a Black businessman, 'Which of your employees are you going to lay off?' They'd stop and say, 'I hadn't thought of it like that."

Jackson derides African American candidates he claims are fearful of being openly vocal advocates for their own people.

"Obama said he was going to be president of all

the people. We hear it over and over from Black candidates, Gillum included. But if you speak to a Latino candidate, he will tell you exactly what he will do for the Latino community.'

Kevin McNeir, editor of the Miami Times during the hanging chad controversy in the Bush-Gore 2010 election and now editor of the Washington Informer, finds some truth in Jackson's assertions, but takes each candidate on his or her own merits.

"I'm an independent. Democrats haven't done a damn thing for me, including Barack Obama. I've been Black all my life, so I don't care about your color. I'm not going to vote for you just because you're Black."

Regardless of African American voters' views on Trump, McNeir attributes the Democrats' success in the mid-terms to their expansive field of qualified candi-

"From women, to Muslims, to Native Americans, to transgender, to veterans -all those numbers went up. The result is the most significant increase in Democratic House members since Watergate. That's truly noteworthy. Now, Trump can spin it all he wants to.

But McNeir does believe Trump's influence in Florida was significant because he elevated DeSantis's visibility by "giving him a shoulder to lean on, much like with Supreme Court Judge Kavanaugh.

"Had Gillum been White, he would have won by 99 percent, he's that much more qualified than DeSantis.

"He was too progressive. And he was going to raise taxes. It was honest for him to say, but you don't talk about raising taxes with White folk. He should have done what White folks do, lie; raise taxes once he got in.'

Tax cuts were also in play in the predominantly Democratic state of Maryland, where Democratic gubernatorial candidate Ben Jealous, African American and a former NAACP president, was defeated by Republican incumbent Larry Hogan, who won a second term.

African American Democrats crossed party lines. not en masse but in significant numbers, in part because they felt Hogan's tax reduction initiatives had improved their personal finances.

Yet, as The Baltimore Sun noted the day after the election, "No coattails: Maryland voters backed Republican Gov. Hogan, but also showed their disdain for Trump.'

In exit polling, and across racial lines, voters rejected what they perceived as Trump's divisiveness, apparently despite whatever personal gain they may have derived from his tax cuts.

Charles Taylor described this year's mid-terms in Mississippi as historic. "In the 2014 mid-terms, for all voters, we had 631,000 voters; in this one, close to 900,000.

Indeed, the Hyde-Smith versus Espy contest may be the defining moment for how black voters view the political landscape in 2020.

Echoing Cummings, McNeir said, "The hatred that has been under the radar in America has gotten an invitation from Trump to express yourself.'

After Midterms, Democratic Hopefuls Eye Early-Voting States

Democrats pondering 2020 presidential bids in the aftermath of the midterm elections are pivoting from campaigning for other candidates across the country to refocusing on their own efforts, including moves in early-voting states like South Carolina.

On Friday, former Massachusetts Gov. Deval Patrick is set to deliver a keynote address at an Urban League fundraiser in Charleston. It's the latest visit to the state for Patrick. Massachusetts' first black governor. He is among the more than two dozen Democrats whose names are being mentioned as potential White House contenders.

Many of them, including U.S. Sens. Cory Booker, Kamala Harris and Jeff Merkley, have already begun to visit South Carolina. Home to the first-inthe-South primary, South Carolina provides the first real opportunity for potential White House contenders to see how their messages play to a significant population of minority

Ahead of the 2018 midterms, former Vice President Joe Biden stumped in the state with Democratic gubernatorial nominee James Smith. Independent Vermont Sen. Bernie Sanders spoke at a "Medicare for All" rally, organized by the South Carolina arm of Our Revolution, an offshoot of Sanders' 2016 White House bid. Celebrity lawyer Michael Avenatti campaigned with Democratic congressional candidate Sean Carrigan, telling AP he got a warm reception from voters, who see him "as a fighter, someone who could potentially take down Donald Trump." Former U.S. Attorney General Eric Holder spoke at a Charleston NAACP gathering.

Some potential candidates are making staff moves in the early state, too.

On Wednesday, an adviser to Los Angeles Mayor Eric Garcetti confirmed to The Associated

Press that South Carolina strategist Phil Chambers had been hired by a political action committee aligned with the mayor, Democratic Victory Fund. Chambers served as an adviser on Smith's gubernatorial campaign, as well as chief of staff to the South Carolina Democratic Party.

Saloni Sharma, a former staffer to Massachusetts Sen. Elizabeth Warren, came to South Carolina earlier this year to take over communications for the state party. Other Warren staffers are working with state parties in other earlyvoting states including Nevada and New Hamp-

Booker and Garcetti are expected to return to South Carolina in the coming weeks. Booker made his initial visit in October, speaking at a rally in the Democratic stronghold of Orangeburg and addressing voters in Charleston. Garcetti has already hosted a fundraiser for state Democrats, bringing in \$100,000 for the



National Trust Raises Over \$10 Million to Preserve **Historic Black Sites**

The National Trust for Historic Preservation announced that one year after the launch of the African American Cultural Heritage Action Fund the organization has hit a funding milestone, raising more than \$10 million for this \$25 million initiative.

The Action Fund aims to uplift stories of African American achievement, activism, and community, crafting a narrative that expands a view of history, and that helps to reconstruct our national identity while inspiring a new generation of activists to advocate for diverse historic places, according to the announcement.

"We are proud of how over this past year we've helped to broaden the conversation about the places that matter," Stephanie Meeks, president and CEO of the National Trust for Historic Preservation, said in a news release.

"Since the launch of the Action Fund, we have seen overwhelming support across the country in saving spaces that tell the full American story."

Launched in partnership with national foundations, and with support from a National Advisory Council, including co-chairs Darren Walker, president of the

Ford Foundation, and actress and director Phylicia Rashad, the Action Fund has changed the landscape of African American pres-

In year one, the Action Fund empowered youth through a hands-on preservation experience, modeled innovative approaches to interpreting and preserving African American cultural heritage at historic sites, continued on-the-ground work protecting significant historic places, and launched a national grant

"The African American Cultural Heritage Action Fund has seen remarkable grassroots engagement, in the more than 800 grant applications asking for help protecting African American historic places, and in the tremendous community support at newly-launched National Treasures like the John and Alice Coltrane Home," said Brent Leggs, director of the African American Cultural Heritage Action Fund.

"As we embark on year two of the Action Fund, we will continue working to foster a national landscape where every person can see themselves, their history, and their potential in our collective story," Leggs

In this inaugural year, the Action Fund was able to award 16 grants, total-

The historic home of John and Alice Coltrane/National Trust for Historic Preservation.

ing more than \$1millon to preservation organizations across the country, with funding going to support the preservation of sites and stories of Black history.

The grants, presented at Essence Festival this July, covered work in communities from Birmingham to the South Side of Chicago, including sites of struggle and strength, according to the announcement.

"The Action Fund grant enabled us to move forward with the goal of transforming the August Wilson House into a community space, a hub of art, memory, and interpretation that will support young artists

in Pittsburgh and across the country, and celebrate August Wilson's legacy," said Paul A. Ellis, Jr., Executive Director of the August Wilson House, an inaugural grant recipient.

Ellis, an attorney, is also Wilson's nephew and the founder of the Daisy Wilson Artist Community, named after Wilson's mother, Daisy.

"This house and this community are more than just a place where August lived – they are the inspiration for his plays, and the physical representation of what he was able to accomplish," he said.

In addition to grant fordability.

funding, the National Trust through its Action Fund has supported four new National Treasure designations, including the childhood home of singer Nina Simone, and Memphis-based Clayborn Temple, famed for its role in the Sanitation Workers' Strike of 1968.

In the coming year, the National Trust has pledged to continue work on key preservation efforts, including conducting research exploring the impact that preservation has on contemporary urban issues that disproportionately affect communities of color - equity, displacement and af-

Additionally, support for Historically Black Colleges and Universities (HB-CUs) will continue, from celebrating their history to advocating for the reauthorization of the HBCU Historic Preservation Program which ensures that their histories and legacies are preserved.

"The Action Fund draws support from a renowned group of leaders in academic, business, government, arts, and philanthropy, as well as the continued support of first-year lead funders Ford Foundation, The JPB Foundation, and others," Leggs said.

Los Angeles improves to 7-1 at home; Victorious over Spurs

The Los Angeles Clippers are quickly becoming one of the most underrated teams in the NBA and have now improved to 7-1 at home. Lou Williams poured in 23 points off the bench, Danilo Gallinari and Tobias Harris added 19 and 18 points respectively, to give the Clippers (9-5) a 116-111 victory over the San Antonio Spurs (7-7) Thursday night at Staples Center.

"This was a gritty win," Clippers coach Doc Rivers said. "We talked about this before the year. We're gonna have a lot of close games. I think we can beat anybody and we can lose to anybody if we

don't play right."

Once again, Williams was the hero for Los Angeles, draining a huge goahead three-pointer with 41.4 seconds (110-107).

DeMar DeRozan finished with 34 points for the Spurs and ultimately got San Antonio within one, (109-110), but Los Angeles then closed the game with

"We feel like we're a good basketball team despite what people are talking about," Williams after Los Angeles escaped with another home win, third in a row.

Even with a starless roster, Los Angeles has taken down the Milwaukee Bucks, Golden State Warriors and now Spurs in consecutive games.

Montrezl Harrell kept his impressive play going, chipping in with 14 points, six rebounds and five assists, while Patrick Beverley added 10 points, seven boards and four

Los Angeles opened the second quarter with a 15-2 run that ballooned to their largest lead at 44-30.

However, the Spurs answered with a 31-17 run, including 10 points alone

by DeRozan. The Spurs had chanceafter-chance in the second half to close out the game, but the Clippers made bigger plays in the crunch

Los Angeles shot 47 percent from the field and held San Antonio to 40 percent, making things tough for the Spurs key players.

Rudy Gay finished with 19 points off the bench, making 8 of 12 shots. LaMarcus Aldridge struggled from the field, making only three of 15 shots for 10 points.

"It sucks to lose these games but it's still early in the season," DeRozan said. "We'd rather go through it now than later. Everybody in the league is right there. Once we catch our stride, we'll be fine.'

LeBron James Becomes 5th All-Time Scorer in NBA History

Lakers' star LeBron James became the fifth alltime scorer in NBA history with a 44-point performance surpassing Chamberlain in the team's second straight victory against the Portland Trail Blazers on Nov. 14.

"Any time my name is mentioned with some of the greats that have played this game, I always think back to my hometown, where I come from and how far I've come," declared James.

James scored his 31,425 point on an and-one play with 3:55 left in the fourth quarter of the contest against the Trail Blazers. He finished with 10 rebounds and and nine assists to accompany his 44-points, the most points scored by a Laker since Kobe Bryant's 60-point performance in Bryant's final game of his career.

Once more, James made history by eclipsing Allen Iverson to become the sixth-most player with 50-point games in league history. It is James' twelfth 50-point performance with his third NBA franchise.

"I've played for three very, very historic franchises in the time that I played," James said of his career with the Cavaliers, Heat, and Lakers. "Obviously, in Miami we did some historical things. In Cleveland, we was able to do some historical [things]. And obviously the Lakers [name] speaks for itself, what they've been able to do."

James is averaging 26.7 points on 51.2 percent 45.5 percent from the three-point line including eight double-doubles and a triple-double.

James led the Heat to two NBA championships.

"It's always great to be here," James said. "We had some not-so-good times, we had more great times, so it's always a respect factor and a love for the people in Miami and especially the people who work here."

After the game, he broke it down simply as, "Well the environment is a basketball and a hoop; that's my environment."

In just his first season of a four-year contract James signed this offseason, he is already making waves towards bringing the Lakers back to relevance all while continuing to etch his place in the history books. The Lakers will return to Staples Center to face the Jazz on Friday, Nov. 23, following their three-game road trip.



Bill Duke - 40 Years on Screen and Behind the Camera

Many aspiring actors move to Los Angeles in hopes to find success. Some of them imagine themselves on red carpets, while others envision receiving their own Hollywood Walk of Fame star.


What happens when that illusion breaks and vou have no idea what you should do?

That's the question legendary actor Bill Duke answered in his new book. "Bill Duke: 40 Years on Screen and Behind the Camera."

"One of my purposes for writing the book is, hopefully, that it is helpful for other people coming into the industry. A lot of kids have the passion but don't understand the business," said Duke.

His business mind was what propelled his career. Known for his roles in popular films such as "Predator," "Commando," and currently "Black Lightning," Duke digs deeper into why he loves being an actor.

His family played a large role in providing him motivation. They devel-

oped his work ethic since childhood.

"They worked relentlessly. My mother had two jobs and my father had three.

"Sometimes they worked seven days a week. They didn't let anything stop them," Duke said over the phone.

Though his parents gave him courage, it was seeing popular Black actors on-screen that changed his life.

"Sidney Poitier was such a profound influence.

He wasn't just an actor, but he stood for things that mattered," said Duke.

"He stood up for his pride, himself, and his family. That inspired me."

Though he was shining on screen, his personal life was dark. He doesn't hold back speaking about his past drug habits in his book. Some of those habits hindered his career. It wasn't until a good friend introduced him to transcendental meditation that his life changed.

"A friend of mine saw

me tumbling down. My head was not right. She told me about transcendental meditation. At first it was okay. After about a month it changed my life. I was higher than any drug I took at the time," Duke

Years later, Duke is drug free and continues to motivate incoming actors about the art of filmmaking. He stresses the importance of finding your own path and not waiting on anyone.

explosion of The mainstream media further proves why building your own brand is important, according to the actor.

"There has been a paradigm shift from television to media. Look at Issa Rae. She had a show online, then HBO came after her. Same thing happened to 'It's Always Sunny In Philadelphia.' It started online. You can discover vourself," Duke asserted.

Though artists are succeeding in the industry, Duke advises to deny the fame hungry mindset. He explains why enjoying the craft should outweigh any recognition you may receive.

"I understand people


that want recognition but its all momentary fame. There should be more attention to the business. It's called show business.

Strolling down Brooklyn's Malcolm X Blvd, past a row of small storefronts with Afro-centric markings; alongside abandoned brownstones and apartment buildings with smashed windows, all painted over by street artists, here is a Black neighborhood in the midst of gentrification (again) and sitting on the corner is Juices for Life, a healthy alternative juice bar that's owned by DJ Envy, Angela Yee, and Styles P.

The reason for my adventure was to find an answer to the question— Who's Got The Juice? and to witness a competition between cast members from BET's new reality series, "Hustle In Brooklyn" and Breakfast Club hosts DJ Envy and Angela Yee at Juices for Life, the delicious, Black-owned juice

The rules of engagement were simple. Cast members Azia, Randy, Baggy Large, Perks, Danny, Marco, and TP were divided into two teams, "Team Envy" (DJ Envy, Azia, Baggy Large, Perks)

and "Team Yee"(Angela Yee, Danny, Marco, and TP).

Customers lined up to buy custom-made juices and the objective was to see which group could hustle up the most money in an hour through juice sales, tips, and online donations. The juice bar regulars didn't miss a beat and helped the cast spread the word about the great causes they were benefitting. Team Envy was playing to donate money to the Make-A-Wish Foundation. Team Yee was playing to donate money to the Amer-

ican Foundation for the University of West Indies (AFUWI).

Team Yee went first. "I'm from Brooklyn. This is my home," said juice bar owner and DJ Angela Yee. "To be able to give back in my own community firstit means a lot....we plan to bring more [Juices or Life] of these healthy alternatives into the Black community."

Juices for Life's menu is large with selections ranging from A to Z with interesting names to match the exotic mixes like B.K. (Pomegranate, Strawberry, Peach, Mango, and Apple), Future (Peanut Butter, Beet, Pear, and Strawberry), Lady Tonic (Orange, Beets, and Carrots) and the list goes on.

"The selection is a little intimating but it's all about giving back," said Team Yee member Marco Maldonado. "I love being healthy. I love the Black community. If we win our donation will go to We are The American Foundation for the University of the West Indies (AFUWI), Angela [Yee] is on the board of the charity. They provide scholarships, grants, and fund special projects for West Indian people."

Good news travels fast. It didn't take long before the juice bar was packed. The Brooklyn community is deeply affected by the store and they take a great sense of pride even more because it's Black-owned. Monica Torres, the manager of Juices for Life, who recently became a vegan made it clear that the sense

of community and the feeling of belonging is exactly what owners DJ Envy, Angela Yee, and Styles P wanted.

"The goal was always to make something more healthy and affordable in our community," said manager Torres. "We only use fruit and fresh vegetables, nothing [artfical] added. It's a great alternative to the unhealthy choices that are found in our communities."

You can't argue with facts. The sense of unfairness is felt viscerally throughout Black communities in the United States, a place steeped in racism and denial. Diabetes. Heart disease. High blood pressure. Preventable and manageable diseases with healthy food choices. The existence of Juices for Life, a healthy place, is, in fact, an act of defiance.

"This [Juice for Life] is like a family," shared Torres. "Besides the fact that a lot of us are family here, we are welcoming. Angela [Yee] is hands on. Our slogan is Love is Love. That's what we run by. That's what we go by. That's who we are and the regulars that come by here every day, they feel it."

When it comes to learning, Torres says that all of the owners have inspired her and it might surprise some that Styles P makes everyone around him feel empowered.

"Styles [P] goes out of his way to make sure that the people that come into the store feel good, " confides Torres. "He's like 'sis your hair is beautiful today,

I love your outfit; sincere compliments. I watched the customers reaction and how it makes them feel better about themselves. It makes everyone feel good. Our juice bar is a whole, positive vibe."

In the end, it was "Team Envy" that took home the win, raising a sizable donation which was then generously matched by BET Networks.

"We all won," said "Hustle In Brooklyn" cast members Azia, Randy, Baggy Large, Perks, Danny, Marco, and TP.

"When you take care of one of us, you take care of all of us," summed up Torres. "BET's "Hustle In Brooklyn" cast took the friendly competition—seriously—because being healthy and helping others is not a joke."



ing issues too. Collectively, all of these were signals it was time to move. And so we did.



The Rev. Mark E. Whitlock, Jr., pastor of Christ Our Redeemer AME Church, invites the faith community to join him in fasting for spiritual renewal and an end to gun violence.

Through the fast, which started Nov. 11 and continues until Jan. 21, Whitlock believes God will heal "our lives, our land, our churches, our communities, our nation and world."

Among the incidents spurring Whitlock to action are the mass killings in Pittsburgh and Thousand Oaks as well as the recent murder in Las Vegas of the 25-year-old son of the Rev. Dr. Najuma Smith-Pollard, a close friend of Whitlock's.

"Fasting is one of the most powerful spiritual disciplines of all the Christian disciplines. Through fasting and prayer, the Holy Spirit can transform your life, transform family problems, and gain new power. According to scripture, personal experience and observation, fasting and prayer can also effect change on a much grander scale," in-

sisted Whitlock, a doctoral candidate who also serves as executive director of the USC Cecil Murray Center for Community Engage-

ment.

"I am convinced that when God's people fast with a proper biblical motive – seeking God's face – with a broken, repentant and contrite spirit, God will hear from heaven. God will heal our lives, our land, our churches, our communities, our nation and world. Fasting and prayer can bring about a change in the direction of our nation, the nations of earth and


the fulfillment of the Great Commission - this is powerful motivation in today's unsettled world," he noted.

"For those who desire both inward and outward impact, humbling yourself before God through fasting is a good place to start. God's power can be released in and through you by the enabling of the Holy Spirit."

Whitlock, who has completed five 40-day fasts in the past, encouraged believers to support the campaign through a one-day, multiple days or an extended 40-year fast. Ac-

knowledging the fast as an "exciting step of faith," he added that he is available to share the knowledge and fulfillment that he gained through the experience.
