Domestic Terrorism Hits the State of Texas After Mass Shooting

Just months after Texas was hit by the devastation of Hurricane Harvey, a deadly mass shooting rocked the state leaving 26 dead and around 20 injured.

On Sunday, November 5, a man dressed in black tactical-style gear opened fire inside First Baptist Church in Sutherland Springs, Texas making the event the deadliest mass

shooting in the state's history. Those who passed away range from ages 5-to-72- years- old.

The shooter, identified as Devin Kelley, 26-yearold white male, crossed the street and began firing a Ruger AR rifle at the church and continued firing as he entered where the church's 11 a.m. service was underway.

"You've got your pews on either side. He just

If you're a Black businesswoman, artist or creative, this read is for you! The 6th Annual Black Business Women Rock (BBWR) Conference & Expo is approaching and Black businesswomen everywhere are making plans to attend. Founded in 2011 by Natalyn Randle, BBWR has grown exponentially, boasting hundreds of attendees during last year's expo and connecting thousands more.

This year, attendees can expect a two-day extravaganza, the first day designed specifically for specialized workshops, and the second day dedicated to panel discussions, networking opportunities, vendors,

entertainment and a plethora of business resources for attendees.

The theme for this year's expo is "Mind Your Temple, Build Your Empire", and Randle says she wanted the experience to be transformative for each woman from the inside out. "I'm focusing this year not just on the outer appearance and what we're doing with our businesses, it's pretty much the inner connect," Randle said.

"What are we doing to these temples? What are we saying to ourselves? What are we feeding ourselves? Are we committing to ourselves? First, I want you to commit to you, because if you commit to you, then you can commit to me," Randle declared.

"If you can commit to you, then you'll be able to commit fully to your business. If you can commit to you and take care of yourself, then you'll be able to serve others. The inner will take care of the outer," Randle continued.

Randle says that adding

a second day to the expo was essential to ensure women walked away with the tools needed to build their businesses. "I noticed that they wanted more; they said it wasn't enough time, we wanted more." And more time is exactly what has been granted, with more than 20 workshops, including "Money Right: Body Tight" and "Are You Chasing Money, Like You Chase a Man?" taking place on the first

day. "We're tapping into both, the inner and outer for two days, and then after that, we celebrate at the after party," Randle stated.

BBWR also has an online business directory that connects business owners in different industries. "If you want to start, grow or expand your business, the resources are there," Randle said.

Personally, Randle recently released her first book, "Behind the Scenes to Greatness: Lessons and Blessings on My Purpose Journey", which she says is an opportunity to share the brokenness she experienced at a young age and her journey to reaching success. Los Angeles Community College District Signs Agreement with Loyola Marymount

The agreement will enable students attending the district's nine community colleges access to guaranteed fall admission to LMU once they meet specific enrollment requirements.

LACCD (Los Angeles Community College District) President Sydney Kamlager-Dove and LMU (Loyola Marymount University) President Timothy Law Snyder, Ph.D., led a conversation about the academic partnership before a signing ceremony on Wednesday, Nov. 1, 2017, at Los Angeles Harbor College in Wilmington.

Joining Dove and Snyder on the stage of the college's Music Recital Hall were Chancellor Francisco Rodriguez; Tom Gutto, LMU's director of Transfer Enrollment Services; and Robert Walsh, S.J., executive director of LMU's Center for Catholic Education and transfer student Darlene Zarazu.

The agreement reads,

"The purpose of this agreement is to strengthen the academic ties between Los Angeles Community College District and Loyola Marymount University in order to develop greater curricular continuity between the two institutions; to encourage more well-prepared students to transfer from Los Angeles Community College District to Loyola Marymount University; and to alleviate the concerns of students about course transferability and admission feasibility, as they prepare to transfer to and enroll at Loyola Marymount University."

Dove shared more insight to the agreement by sharing, "often times many of the students that are attending community college are going because of financial reasons. They can't afford to pay full cost to go to a four-year private university. This agreement affirms our commitment to making sure our students can transfer to any institution that they want to go to." She continued, "it also

shows LMU's commitment making its educational experience available and accessible to the students that go to a community col-

LACCD is the largest community college district in the nation, serving more than 250,000 students every year across a district that spans nearly 900 square miles. To guarantee admission to LMU, prospective students must meet GPA and unit requirements by the end of the fall term, and maintain that performance through the spring term of the application year. Some majors will have additional requirements, such as specific coursework or a higher GPA.

In addition to the fall admission guarantee, the agreement will allow LMU to provide to LACCD students access to campus tours and workshops, information on financial aid and scholarships, and transfer/ pre-admission advisement.

LMU's three- part mission includes the encouragement of learning, the education of the whole person, and the service of faith and the promotion of justice. During the conversation Snyder championed how the transfer admissions agreement aligns with the mission.

In reminiscent fashion of the State of the Black Union, Tavis Smiley partners with the Bill and Milanda Gates Foundation and Enterprise to discuss *U.S. education equity.*

Tavis Smiley has recently been traveling the country with the support of the Bill and Melinda Gates Foundation talking about the future of higher education. He recently hosted one of those talks at California State University, Long Beach (CSULB), Beach Auditorium. Sponsors included the Bill and Melinda Gates Foundation and Enterprise. The event was presented by the Tavis Smiley Foundation.

Participating panelists in the Long Beach town hall included: CSULB President Jane Close Conoley;

California Community Colleges Chancellor Eloy Ortiz Oakley; Long Beach Unified School District Superintendent Christopher J. Steinhauser; CSULB student Kyari Cail and the Campaign for College Opportunity President Michele Siqueiros.

The discussion entitled, "The Future of Higher Education", aimed to inspire communities to help reshape the college experience; so, it prepares every student for success in college, career, and life. It's an open call to rethink and design American colleges to work at their best.

While the topic for the need for more diversity in Cal State and UC institutions, Campaign for College Opportunity President Michele Siqueiros challenged the panel and audience by saying "we keep defending diversity; may-

be it's time to start speaking of the lack of diversity."

It was also noted that institutions have seen a rise in counseling, discipline issues, safety and hate crimes with the current Trump administration.

Before the town hall started, we caught up with Smiley to discuss the "State of Black America" with three names we wanted his thoughts on:

Los Angeles Sentinel: Donald Trump?

Tavis Smiley: An embarrassment. An embarrassment to the country. He's destroying our democracy. At some point, he has to be stopped. I'm not sure impeachment is the strategy to stop him. That takes time but there is no way we can continue to

endure this nightmare. LAS: Barack Obama?

Smiley: The jury's still out on his legacy. I certainly voted for him twice like every other Black person I know. I still celebrate the fact that he was the first African American president. What I'm having difficulty with is the data with the legacy. The data indicates that in every leading economic category, Black people lost ground with this presidency. So, I'm having difficulty [justifying] the symbolism with the substance. This is what I was talking about eight years ago. I never hated Barack Obama, I just love Black people, and be-

cause I love Black people, I knew if we didn't hold him accountable, if we just sat back and rejoiced and be happy because we had a Black president, but didn't make any demands, it wouldn't lead to anything.

LAS: Tom Joyner?

Smiley: I love Tom. I just heard he announced his retirement. So, I wish him all the best on that. Tom Joyner has been good for America. Tom Joyner has been good certainly for African American people. Before Steve Harvey, before Rickey Smiley, before Russ Parr, Tom Joyner was the first African American to be syndicated in radio across the country. That town hall meeting that Tom allowed us to have every morning, that entertained us but also empowered us was beautiful. I think his legacy ... it's going to be great, it's going to be grand and years from now, they'll appreciate what Tom did for as long

Mayor Garcetti joins Cal State LA, YMCA officials to announce Achieve LA college-readiness initiative

Los Angeles Mayor Eric Garcetti joined California State University, Los Angeles and YMCA officials last Wednesday to launch Achieve LA, an initiative to create pathways to higher education for local youth in South Los Angeles and surrounding areas.

Achieve LA will leverage existing Cradle to Career Success Initiative programs at four YMCA of Metropolitan Los Angeles locations, including the Weingart YMCA Wellness and Aquatic Center in South L.A. and the Southeast-Rio Vista YMCA, to inform youth about the college admissions process and prepare them to enroll at a university. Youth who participate in the initiative and meet minimum university requirements will be guaranteed admission to Cal State L.A.

The program is the first of its kind at any YMCA, according to officials with the association.

"We believe that a child growing up in Boyle Heights or South L.A. should have the same access to programs and support as kids in Brentwood or Encino," Garcetti said at the Nov. 1 news conference at the Weingart East Los Angeles YMCA. "There's no limit – if you believe, you can achieve."

The mayor was joined Assemblymember Miguel Santiago, whose 53rd District includes ar-

eas that will be served by the initiative. Cal State LA Executive Vice President Jose A. Gomez and YMCA of Metropolitan Los Angeles President and Chief Executive Officer Alan C. Hostrup.

Jaren Savage shared how he benefitted from the programs he participated in at the Weingart YMCA Wellness and Aquatic Center as a child growing up in Compton. Savage, who recently graduated from high school, plans to study car design in Torino, Italy, next

"Thanks to this historic partnership between the

Los Angeles and Cal State LA, thousands of youth just like me will have the chance to attend Cal State LA and become Golden Eagles," Savage said.

Under the partnership, Cal State LA students will mentor and advise youth in the YMCA programs. These students, some of whom attended the news conference, are part of the university's #IServeLA initiative, which provides thousands of volunteers who serve communitybased organizations across Los Angeles.

Achieve LA will be offered at the Weingart YMCA of Metropolitan East Los Angeles YMCA location, as well as the Crenshaw Family YMCA, Southeast-Rio Vista YMCA and Weingart YMCA Wellness and Aquatic Center in South Los Angeles.

"Achieve LA is about dreams – the dreams of our community, the dreams of our youth and the dreams of our families," Gomez said. "Working with Mayor Garcetti, Assemblymember Santiago and the YMCA family, we will make those dreams a reality through higher education."

Hostrup, who officially announced the initiative, said the YMCA was honored to launch the partnership with Cal State LA.

"The program will offer teens in our city's most under-resourced communities, the tools, the support and guidance needed to reach their potential by providing a clear pathway to college," Hostrup said.

Santiago praised the new initiative and thanked the YMCA and Cal State LA for their commitment to serving Los Angeles youth. Santiago is the author of Assembly Bill 19, which was signed into law last month and waives fees for first-time community college students for one year.

"We know, out of this program, we will ensure that every student that goes through these doors will get a college diploma. Right, kids?" Santiago said to dozens of students decked out in bright gold and blue Achieve LA T-shirts.

The fifth graders from KIPP LA Prep, next door to the Weingart East Los Angeles YMCA, responded to Santiago with a resounding, "Yeah!"

Gomez noted that Achieve LA aligns with the mayor's L.A. College Promise and College Corners initiatives, which are creating pathways to higher education and fostering a greater understanding of the college admissions process for all Angelino fami-

Garcetti applauded the new Achieve LA partnership and Cal State LA's success in transforming

students' lives. "Cal State Los Angeles is not just a great university in the greatest city on the face of the earth, they're No. 1 – they're No. 1 for social mobility and economic mobility in the United States of America," Garcetti said. "They beat Harvard, they beat Princeton, they beat Stanford, they beat UCLA, they beat USC, they beat Cal. In other words, taking folks who grew up in the bottom quintile and move into the top quintile in this country. In a moment when we are looking for those escalators, we're looking for those staircases, we're looking for those opportunities, Cal State LA does that each and every day."



Rethinking Gentrification and Racial Justice: Resisting the Return of the Plantation


It is not over-reaching or misreading the signs and tendencies of the time to conceive and confront the ongoing process of what is currently called gentrification as the return of the plantation. Indeed, it fits well within the context of the social "thunderdome" and moral wilderness that the dominant group, especially under the current mad regime, is establishing here and trying to impose on the world. It is particularly associated with the South before and immediately after the civil war, but it was always a part of America itself as a political and social system socially schizophrenic in its Jekylllike pretensions and pronouncements of freedom and justice and its hideous Hyde-like impositions of domination, deprivation

and degradation on others. The plantation was established by colonizers, newcomers who imposed themselves on the original residents and owners dispossessing them, disrupting their lives and degrading them. The original residents and those brought in as objects of cheap labor, behind the scenes sex and self-degrading entertainment are seen as disposable populations with only derived relevance, a relevance granted by their relationship with and use to the colonizers and newcomers. There is no human concern for the awesome suffering imposed on the victimized others, only a ruthless pursuit of profit for some, pleasure for others, and the shared satisfaction of power to realize their racial and class will, protect their interests and promote their way of life and death dealing in the world.

Clearly, one of the greatest problems of dealing with gentrification as the moral and social problem it is, is that it is camouflaged and cuddled in a narrative and mythology that pose it as a good and desirable process and practice, hiding the real suffering it causes. It is called a benefit, an improvement, and a process of renewal, and a revitalization and beautification project, but for whom and what about the life-taking and ugliness of human suffering it causes and leaves in its wake?

Gentrification is rooted

in and reflective of a masking mythology by interlocking practices, policies, propaganda and interest of banks, developers, corporations, government (politicians) and media. And it is based on the capitalist philosophy and practice of neo-liberalism marked by several defining assumptions and contentions. From the outset, everything is reduced to the economics of profit and loss and the market posed as the mother and matrix of human life and human good. Thus, humans are posed as objects of calculation of profit and loss without due consideration of harm to the vulnerable: the less powerful, less wealthy and less favored. Competition and consumption are key to defining human life and human development. Ethics are separated from economics. Moral reflection and public discussion

over issues that matter are diminished. And in their place, a market mentality emerges and exalts conversations of likes and dislikes

Thus, the false and misleading narrative is that gentrification comes with no costs, only good, i.e., economic prosperity, new amenities like dog parks, coffee shops, art colonies, new imposed transportation lines, sports stadiums, new housing and new residents ugly, aging and distressed neighborhoods to be seized and forcibly reformed. And we are not to ask where are the people that originally occupied these spaces, who are now targeted, disrupted and diminished without consideration of what it will do to them?

Any serious ethical understanding and approach to social change and social development, would include how it will affect their lives, especially their capacity to live lives of digconsumer preferences and capacities. There is no serious questioning and concerns for what benefit and harm this will bring to the peoples of color or to the poor and working class. Thus, it is a mockery of meaning and an irrational reasoning to claim that gentrification's so-called renewal benefits the neighborhood and the people in it, if they can't afford it, access it or enjoy it. As our honored teacher, Malcolm X taught, we can't righteously call ourselves diners, even if we are sitting at the table if there's nothing on our plates.

Gentrification with human costs and human casualties, not simply displacement, but also race and ethnic erasure and class cleansing. It is racial erasure because it denies us the right of presence, the capacity to be present in our own historical communities. We are pushed out, rendered suspect in a newly constituted community with little or no place for those with more color and less means. And it is racial erasure because it undermines and dissolves community as a site of culture and its institutions that house and advance its legacies, interests and aspirations. And in their place rise the institutions of the newcomers and their pets

And it is class cleansing

because it seeks to clean the area of the dirty, diseased, and deficient things and people that go counter to the newcomers' conceptions of clean, healthy, beauty and security. Those who cannot afford the new rents or leases, or buy a condo or house of high-end costs are deemed unworthy of presence and removed.

Thus, stripped of all its high-priced camouflage is a process and practice of displacement, removal of real people from long held space central to concepts of community, with no place to go. It is acts of dispossession and the loss of property, housing, sites and structures of gathering, exchange and reaffirmation in community. Moreover, dispossession and displacement are followed by replacement, replacement in race and class terms. It, again, points not only to class issues of wealth and poverty, profit and loss in economic terms, but also to benefit and harm in racial terms. Again, it demonstrates the racial injustice and oppression imposed on Black people and other people of color from the beginning of this country. That is why talks and programs of social justice are less, little or no use to African Americans if racial justice is not taken into consideration on

HISTORY OF BLACK AMERICANS IN AMERICA

The classic work, "A Pictorial History of Black Americans" (5th Edition), by Langston Hughes, Milton Meltzer and C. Eric Lincoln became the most widely used book on the civil rights era. First published in 1956, it is a compact but meticulously researched history of Black Americans. Words are important, and since its beginning, America has used different words, at different times, to describe Black people. However, no matter which term was used, none changed society's perception and treatment of Blacks as lesser human beings. (Even more important, is what Blacks call themselves, which reflects not only our personal feelings but how we treat one

another.) The analysis of the term "Negro" and other descriptive words for Black Americans in the book's Introduction is just as illuminating and applicable in the 21st century. Although written in 1956, a careful reading helps clarify "colored," "Negro," "Black," etc. Unfortunately, countless Blacks fail to acknowledge that fundamentally, nothing has changed no matter what we are called. Excerpts from the book's introduction follow:

"Who or what is a Negro? For America, the issue has never been settled with finality, for at various times, Black people have been known as "colored people," "people of color," "Negroes," "Afro-Amer-"Aframericans," icans," "Black Anglo-Saxons," "Black Americans" and by a number of other appellations.. The United States Bureau of Census declared: A person of mixed white and Negro blood should be called a Negro, no matter how small the percentage of Negro blood. Black and mulatto persons are to be called Negroes, without

distinction...."

The problem is the reasoning behind the state and federal pronouncements about Negroes seems to imply that somewhere, at some time, there existed a race or a nation of "Negroes," and that all of the people in the United States who are not 100% white and who are not distinctively Indian belong to the Negro race or nationality......Many Americans who are called "Negroes" are "whiter" than tens of thousands of other Americans who are classified as "white." The Black American of pure African descent is quite rare and recent computer studies show millions of "white" Americans have, to varying

degrees, African ancestry. Who then is a "Negro" and what difference does it make? It is far easier to answer the second question then the first. In 1819, the South Carolina courts held that a Negro was a slave, or subject to becoming a slave, and that a slave was ipso facto a Negro. The Mississippi Supreme Court said that, in the eyes of the law, "a Negro is, prima facie, a slave." The courts seemed to be trying to provide a simple rule-

of- thumb for the complex

problem of deciding who should have what rights in a society in which all men are held "created equal," but some, by common agreement by their (white) fellows, were to be treated as though they were not.

Since slavery was officially abolished more than 100 years ago, it would seem that our efforts to get on with making this a free and equal society could be enhanced by avoiding the use of words which, because of past associations, are likely to be weighted with meanings we no longer intend to convey. The problem is that in their subconscious understanding, most Americans still associate "Negroes" with cotton fields and cakewalks and a debased status in society. It is probable that all Americans are descendants of slaves at some point in their history, but "Negroes" and "slaves" still have such a vivid association with our recent past that the use of the word Negro is not now an effective way to express the highest level of appreciation for people who consider themselves the equals of any other.

The Black people of America are African by derivation, American by nationality and Black rich, distinctive subculture they have developed here in the West. As Malcolm X said, "We are all Black, different shades of Black." Some Black Americans have fair skin and blonde hair. Some are as black as the African night their fathers knew. But being Black in the contemporary world is not so much a matter of skin color as it is a state of mind-an attitude about the value of persons and their rights as human beings without regard to such physical accidents as color. To be "Black" is to adopt a cultural response which denies and negates the traditional implications of being "white" or "non-white" or "Negro," as the case may be. It is an assertion that we are what we are without reference to what others may name us or name themselves.

Black people consider themselves American, not because national status was conferred upon them gratuitously, but because they were here in the beginning-before there was an America, and because their blood and sweat and tears are forever mingled with those others whose struggles and triumphs made this country great. Blacks cleared the forest and dug the canals and laid the tracks and fought to keep the country free, shoulderto-shoulder and back-toback with other Americans who happened to be white. They are Black Americans, proud of their heritage and confident of their future. And wherever you look, you will find them working, playing, worshiping, dreaming, creating and expressing their cherished freedom in the spirit of the country they would like to help make a model for democratic peoples everywhere."

Don't Bring a 'Gun Fight' to a Discussion About Safety

The Time I Considered Buying a Gun

"Texas The tragic Church Massacre" raises the issue of gun control yet again. It's time to reexamine what we're doing here. Here are some quick statistics. Did you know that the rate of gun deaths in the United States rose in 2016 to about 12 per 100,000 people according to the Centers for Disease Control? That was up from a rate of about 11 for every 100,000 people in 2015, and it reflected the second consecutive year that the mortality rate in that category rose in the United States. More than 33,000 people die in firearm-related deaths in the United States every year, nearly two thirds of which are suicides. Suicides account for about 60 percent of firearmrelated deaths, and homicides about 36 percent. Unintentional firearm deaths and those related to law enforcement officials account for about 1.3 percent each.

We've all heard the saying "People kill people, not guns" which is true, however people can kill people much quicker and with greater precision with a gun than without. Guns are designed to kill and yet I believe that we should all have the option to carry one, for protection, if we so choose.

A few years ago, when I lived alone, a man attempted to climb through my first floor apartment window, after having already come an hour earlier and stared through it for almost one minute, which woke me up. It was completely dark in my place so he could not see me looking at him while I laid there, frozen, devising a plan. As I watched his silhouette, framed by the street lights falling around his head and shoulders, peer into my room and then examine the window, I knew he'd come back. He did, about an hour later, around 2:00am. As he proceeded to tamper with my window, I rushed over and kicked the window in the part opposite his head and yelled in my deepest uncle Rodney voice, "What the f@*k are you doing?!", like I've heard and imitated so many times. The man immediately ran off.

After that encounter, and one other, I put some serious thought into what it would be like to own a gun. I asked myself tons of questions and thought of several scenarios...

What if everyone had a gun? What if everyone had the ability to kill at the first sign of danger or when they become insane with rage and anger, for whatever reason? What if a person became so depressed one day, and full of pain that they'd just as soon take their own life with a gun than go on?... How many of us, even the most mentally sound, have been able to identify with one or more of those feelings at some time or another?

From a practical standpoint, would everyone carrying guns prevent a truly desperate person from attempting to steal/get what they need to survive? No.

After wrestling with these and other questions for a few weeks, I came to the conclusion that I and others are less safe with a gun in my possession. I came to the conclusion that it's possible to make errors in my perception of people and their intentions. I came to the conclusion that such a weapon could be stolen and fall into some very dangerous hands and also, that I do not want to take another person's life just as I would not want mine taken. Lastly I came to the conclusion that I do not want to perpetuate violence of any kind.

That man who attempted to break into my apartment is alive and I'm glad about that. He has another opportunity to make better decisions and work to improve the quality of his life. If I had had a gun that night, as scared as I was, I'm not sure the outcome would have been the same. If he had had a gun it's possible that the outcome would have been different but neither he nor I did and we are both alive.

At this point in my life, the best way to protect myself is by being responsible with my daily decisions regarding safety, including how I treat people. However that was the "right" decision for me. 
But the problems consumers face in personal finance is not a game. By their actions, those entrusted with leadership in the federal government betrayed their oaths of office to serve the public. Instead, they are serving private interests and profiteers who exploit consumers with deceptive and unfair practices.

Before the President's signing of the ill-advised resolution, Richard Cordray, the ever-embattled director of the Consumer Financial Protection Bureau (CFPB), made a personal appeal on behalf of America's consumers.

"This letter is not about charts or graphs or studies," wrote Director Cordray to President Trump. "Instead it is simply a personal appeal to you, asking you to uphold this rule...[T]his rule is all about protecting people who simply want to be able to take action together to right the wrongs done to them."

"When people are wronged or cheated, they deserve the chance to pursue their legal rights," added Cordray.

An arbitration study by the CFPB found that arbi-

trators rule in favor of the company more than 9 times out of 10. For years, creditors and financial institutions buried forced arbitration clauses in the fine print of agreements. If a consumer could not resolve a financial dispute directly with the company, the only alternative was to take the dispute to arbitration.

With forced arbitration, consumers forfeit their right to seek legal redress. And as the financial institution or creditor selects and pays the arbitrator, the deck is stacked against consumers.

It is also noteworthy that every major bank supported repealing the arbitration rule, as did the U.S. Chamber of Congress.

In addition to the CFPB, the American Legion, the Military Coalition, AARP, civil rights groups, some elected officials and others stood with and for consumers.

In the aftermath of the President's actions, consumer advocates let loose their wrath

"President Trump had a clear choice to make today, between Wall Street and the rest of us,' said Amanda Werner on behalf of Public Citizen and Americans for Financial Reform. "He chose Wall Street."

"This law lets companies force consumers into a secret arbitration system rigged against them - discouraging claims and allowing companies like

Wells Fargo and Equifax to hide widespread consumer abuse," added Melissa Stegman, a Senior Policy Counsel with the Center for Responsible Lending."

There is nothing great about shafting consumers who only want to be treated fairly in the marketplace. This latest Washington scenario blatantly ignores why the CFPB was authorized in the Dodd-Frank Wall Street Reform Act.

At a time when millions of people lost their homes and family wealth to foreclosures, the CFPB was created to be the nation's first-ever federal agency pledged to financial fairness in a range of lending and credit concerns. For Blacks and Latinos who are frequently targeted by deceptive and predatory lending, CFPB's creation was a particularly important development: people of color bore the brunt of the foreclosure crisis' lost wealth.

People who filed complaints with CFPB about deceptive and illegal financial practices found financial relief with their government's support: over the last six years, more than 29 million Americans have received nearly \$12 billion, thanks to efforts of Director Cordray and his staff.

These figures are not just a sign; they are proof that efforts to right the many financial wrongs suffered by everyday people have delivered real relief. Considering how complicated financial transactions can be, CFPB's existence has reassured the nation that the pursuit of financial fairness is at work.

The story of forced arbitration highlights the importance of the CFPB and why it must remain a champion for consumers.

"One of the most challenging periods in a young person's life is the transition from adolescence to adulthood," said Avis Ridley-Thomas.

"We know what they've gone through and it's really been a work of love," said actor and WACO board member, Glynn Turman. "A work of love is not without challenges; many naysayers and many obstacles and red tape to overcome through undying fortitude and commitment, we have stuck with it as a board because we know the importance of it."

The cast of Detroit, longtime family friend and artist Kelly Rowland were among the family, friends and supporters of the initiative.

"I think kids will learn more about themselves, come into themselves and it's going to be beautiful to watch," said Rowland.


The mission is to provide a space and outlet for young people to explore their artistic gifts, especially at a time where arts in formal education is being reduced more and more.

walked down the center aisle, turned around and from my understanding, was shooting on his way back out," said Wilson County Sherriff Joe D. Tackitt Jr.

"It's unbelievable to see children, men and women, laying there. Defenseless people. I guess it was seeing the children that were killed. It's one thing to see an adult, but to see a 5-yearold ..."

As Kelley left the church, he was confronted by an armed local resident, which later led to the two engaging in gunfire.

When Texas police responded to the scene, a car chase began. Later, Kelley was reported dead due to a self-inflicted gunshot wound.

According to official records, the shooter was a former U.S. Air Force member who served from 2010 to 2014. However, the Air Force veteran had a history of abuse. In 2012, he was court-martialed for two counts of assault on his then-wife Danielle Shields and their child.

The New York Times (NYT) reported that Kelley escaped from a psychiatric hospital while in the Air Force, after making death threats against his superiors and attempting to smuggle weapons onto the base where he was stationed. He was sent to Peak Behavioral Health Services in Santa Teresa, New Mexico, after pleading guilty to the assault charges.

NYT said that after the escape, El Paso officers filed a report stating that the person reporting Kelley missing said he "suffered from mental disorders" and "was a danger to himself and others..."

As of press time, no motive for the shooter has been released, however, Kelley's ex-wife Shields and her parents attended the church from time-to-time. It has not been released whether or not members of the family were at the church during the historic shooting.

As a response to the domestic terrorism, President Donald Trump stated that he believes the shooting was caused by a "mental health problem," instead of addressing the gun law issues in the United States.

"This isn't a guns situation, this is a mental health problem at the highest level...it's a very, very sad event," said Trump.

"This act of evil occurred as the victims and their families were in their place of sacred worship. We cannot put into words the pain and grief we all feel and we cannot begin to imagine the suffering of those who lost the ones they love. We pull together. We join hands, we lock arms and through the tears and through the sadness we stand strong, oh so strong."

Offering his condolences to the victims of the horrific tragedy, Bishop Charles E. Blake, presiding prelate of the Church of God in Christ,

Inc., and pastor of West Angeles COGIC, said, "With heavy hearts, we earnestly pray for the families and loved ones of the 26 people killed at a house of worship in Sutherland Springs, Texas from another futile act of violence and disregard for precious human life.

"While we may never comprehend the evils among us, may we be ever comforted in knowing that the Creator surely bears our griefs and our sorrows. We pray that a supernatural outpouring of peace, tolerance and love would cover our nation and the world, even now. God be with us all."

Due to the recent and past shootings, religious leaders and congregations across the U.S. are preparing and discussing safety plans and protocols.

Unfortunately, church shootings are becoming a 'norm.' In June of 2015, a white man opened fire at the Emanuel African Methodist Episcopal

(AME) Church in Charleston, South Carolina killing nine people, including the pastor during a prayer meeting.

The suspect, Dylann Roof, was arrested and charged with nine counts of murder and one count possession of a firearm during the commission of a violent crime.

"You get up to go to church in the morning and you're in heaven by the end of the day. That's scary," said Bishop Kenneth C. Ulmer, the pastor of Faithful Central Bible Church in Inglewood.

The Los Angeles Sentinel spoke with Ulmer on the recent shooting and the steps the congregation can take to prepare themselves.

"I think churches must first realize the times in which we live," he said.

"These really are troublesome times. These are tough times, but they are opportunity times. What should the church do? I think we ought to prepare our children for the reality

of the world that your mind has to be reprogrammed to think higher. How do I serve others? How do I get my life in a position to help others? How do I look beyond myself to help someone else?"

Bishop Ulmer went on to say that certain laws that "accommodate certain violence and certain attitudes that are contradictory to the very liberties that we say we fight for" need to be addressed.

"I think it comes down to our homes and our families. There's a generation that's in jeopardy and yet a generation that can change this world," he said.

"We've got to raise up more political leaders, community leaders and fathers in the homes. We must raise a generation of boys to prepare our young men as fathers, leaders and as change agents in our community."

The Inglewood pastor also touched on church security.

"I don't know of very many churches that don't have some level of security. That's the reality of the times. We must recognize that our life is lived not just in the church," he said.

Although Trump's stance on the Texas shooting stands firm on being mental health related, political figures, church leaders and organization's believe otherwise.

Recently, the National Association of County and City Health Officials (NACCHO) released a statement addressing the

First Baptist Church Massacre and the gun violence epidemic. The statement urges Congress to allow the U.S. Centers for Disease Control and Prevention (CDC) to conduct gun violence and prevention research, and suicide prevention.

"At the federal and/or state level, where applicable, NACCHO supports common- sense approaches to stem the tide of violence, including conducting background checks on all gun purchases, preventing individuals most at risk of violence from purchasing guns, banning assault weapons and large ammunition magazines, and engaging in research about how to effectively address violence," said Laura Hanen, spokesperson for NAACHO and interim executive director and chief of government affairs.

"Moreover, health officials, government leaders, law enforcement, faith communities, and concerned citizens, including lawful gun owners, must come together to address the social and cultural issues that cause individuals to, far too often, resort to violence. Indeed, we need a public health approach to the violence epidemic. While none of these steps will stop all gun violence or prevent all mass shootings, they will be a significant step in turning the tide."

owned newspapers and a national civil rights organization," said NNPA President and CEO Dr. Benjamin F. Chavis Jr. "The First Amendment is a civil right and the NNPA is leading this dual charge across the nation."

Chavis received an invitation to the meeting from New York City Mayor Bill de Blasio to participate in the conference held at the historic Gracie Mansion. The theme of the conference was "Finding Unity Through Local Leadership: A Convening of Mayors and Civil Rights Leaders."

New Orleans Mayor Mitch Landrieu, who serves as president of the United States Conference of Mayors, joined de Blasio, Baltimore's Mayor Catherine Pugh, Louisville's Mayor Greg Fischer and other mayors at the daylong conference in the Big Apple.

National Action Network founder Rev. Al Sharpton, National Urban League President Marc Morial, and U.S. Black Chambers, Inc., President Ronald Busby also attended the meeting.

"The purpose of the

meeting was to develop a national agenda and strategy to improve the quality of life of people in U.S. cities represented by the United States Conference of Mayors and to find unity on national issues of mutual concern by all of the attendees," Chavis said.

In a joint statement issued by the National Urban League and U.S. Conference of Mayors, the groups said they believe in the power of their collective voices to address the inequities that now exist in America.

"Today, too many American families are unable to reach their full potential and are losing faith, because of the divisive political climate and the inability of the federal government to advance smart policy solutions...leadership at the local level is more important than ever before," the groups said in the statement.

Together, the parties vowed to come together to chart the course for the country's future and ensure prosperity for all Ameri-

The meeting counted

as the beginning of a very powerful relationship between America's mayors and the civil rights community, de Blasio said.

De Blasio continued: "We are ready to work in common cause to address the issues and the reality is that we understand that we have to speak with one voice if we are going to have an impact, especially with what's going on nationally."

The New York City mayor noted that one of the immediate issues the group will tackle is the 2020 Census, which he said is of utmost importance.

"You think something as innocuous as the Census can do little harm," de Blasio said. "But, it's the kind of thing that often gets overlooked and major decisions are made about power and money and the difference can be billions of dollars."

The group will push the Trump Administration on ensuring an accurate Census count, de Blasio and Morial both promised.

"This was a historic gathering to bring leaders together to confront the challenges that we face, as a nation, and to look for shared solutions," Morial said.

The tax plan passed by the House paving the way for an unprecedented tax code reform is as troublesome as it is damaging to working, middle-class, and poor Americans, he said.

"The tax plan is lopsided," Morial said. "We will resist and work for a better plan. Also, we will not shirk our responsibility and, as far as the 2020 Census, I want to join Mayor de Blasio in saying that we want to ensure that the 2020 Census is accurate."



Ex-Compton Deputy City Treasurer Sentenced for \$3.72 Million Theft

Former Compton Deputy Treasurer Salvador Galvan was sentenced last Friday to 6 1/2 years in federal prison for stealing more than \$3.7 million in city funds in a scheme that also involved his wife, who was ordered to perform 800 hours of community service and serve one year of home confinement.

Galvan, 47, and his wife, who both pleaded guilty in July to one federal count of theft from an organization receiving federal funds, apologized for their crimes.

"I deeply and sincerely regret my actions," he said, adding that his crimes "weigh heavily on my conscience ... It pains me that I disappointed myself, my family and everyone who put me in a position of trust"

Galvan said he has been picking up new computer skills in jail classes so he can better his chances of landing a job when he's released from prison and pay \$3.72 million in restitution.

Assistant U.S. Attorney Dan O'Brien had advocated for a 46-month sentence

for Galvan and 10 months home confinement for his wife, Rosa Maria, noting the two quickly pleaded guilty, cooperated fully in attempts to track down the money and have tried their best to pay back the stolen funds.

Galvan's former boss, Compton Treasurer Douglas Sanders, said he forgave the Galvans, but he argued that they needed to be held to a higher standard and deserved tougher punishments than recommended by O'Brien.

Sanders noted multiple cases of corruption in the city that he had a hand in

uncovering and said in each case, he would gather together his staff, including the Galvans, and remind them of their "fiduciary responsibility."

"It's a betrayal of our city," Sanders said. "It's a betrayal of staff that looked up to Sal, and it's a betrayal to me."

U.S. District Judge Josephine L. Staton agreed. She said a stricter punishment was in order for Salvador Galvan because he had more than one technical victim -- the city of Compton -- when factoring in all of the constituents who paid cash for a fee or

citation to the city and for those who were denied services because of a lack of funds.

Galvan engaged in virtually daily criminal behavior for a six-year period, the judge said.

"Defendant's crime first and foremost is a crime of greed," Staton said.

Rosa Galvan struggled to hold back tears as she apologized for her crimes.

"I would just like to apologize to the city of Compton," she said, then turned to Sanders and said, "I'm sorry, Mr. Sanders."

Staton initially told the defendant that she, like her

husband, deserved time behind bars and appeared unconvinced by arguments from O'Brien and the defendant's attorney, Carrie Heleck, who said her client is a primary caregiver for her paraplegic son and the sole breadwinner for her own family, which includes a 13-year-old.

Staton noted that the defendant is paid by the state for the caregiver work and that her son is 30 years old, married and has three children of his own, and said the woman's extended family, who benefited from the thefts, could "step up" and care for the teen.

O'Brien argued that Rosa Galvan "was put in this position by her husband. She had the option of turning him in or accepting the money and spending it on her family."

Staton replied, "There was a third option -- she could have said, 'I know this is illegal activity, stop this and I won't participate." But the judge also acknowledged unspecified "health issues" Rosa Galvan is dealing with.

Salvador Galvan, who worked in the Compton Treasurer's Office for more than 20 years, was respon-

sible for tallying the cash received by the city as payment for parking tickets, business licenses and other fees. After the cash was counted, he prepared the money for deposit into a city bank account.

According to court documents, he skimmed cash from City Hall over a six- year period, taking anywhere from \$200 to \$8,000 a day. The losses were small enough that they didn't trigger alarm, but fellow employees said they wondered how Galvan could afford a new Audi and other expenses on a \$60,000 annual salary.

Rosa Galvan, who agreed to hand over the keys to a 2013 Nissan Frontier and a 2012 Honda Pilot to the government as part of her plea deal, received "hundreds of thousands of dollars" in either cash or money orders from her husband, according to court papers. She used stolen money to pay \$14,000 in cash for the Honda on Oct. 14, 2015, at an Irvine dealership.

Court documents show that she made cash deposits of \$211,044 into her account from February 2012 through August of last year.

City of Carson Files Countersuit Against Oil Company

The city of Carson last Thursday filed a countersuit against Tesoro/Andeavor over the oil company's challenge to a proposed manufacturing project that the city says will generate more than 350 jobs for local residents.

The project is located

on a 5.5-acre site adjacent to the Tesoro/Andeavor refinery on land owned by the Carson Successor Agency.

The city maintains that Tesoro/Andeavor's last-minute legal objections to the Panattoni Development Co. project interfered with a deal that would have brought high-tech jobs to Carson and generated tax

dollars for public services.

The Panattoni project

underwent extensive review throughout the past eight months, which included several public meetings, review and approval by the planning commission and was ready for city council consideration, according to the city.

On the day in Febru-

ary the project was scheduled for review by the city council, Tesoro/Andeavor submitted a letter of protest and provided oral testimony opposing the deal.

Until then, the company never attended any of the meetings nor did it ever indicate any objection, according to the city.

The council approved

the project, and Tesoro/ Andeavor filed a petition against the city on March 16, alleging the Pannatoni project would have attracted hundreds of cars and big rigs to the area that would be hazards to pedestrians.

The company further alleges that the city ignored Tesoro/Andeavor's environmental concerns about

the project.

The close of escrow to the property Panattoni seeks to develop has been delayed by the filing of Tesoro/Andeavor's petition and the further passage of time could discourage other developers from pursuing projects in the city, according to the city's countersuit.

Los Angeles County Files Amicus Brief in Support of DACA

Los Angeles County took the lead in filing an amicus brief to oppose the Trump Administration's repeal of the Deferred Action for Childhood Arrivals (DACA) program, arguing the move would harm its economy and public safety programs.

The brief, called a "friend of the court" brief, was in response to a mo-

tion by Board of Supervisors Chairman Mark Ridley-Thomas. "Los Angeles County is home to the nation's largest concentration of DACA recipients," he said. "We cannot turn our backs on them, as they are part of the fabric of our society, making significant contributions to our culture and economy."

Nine counties in California and Maryland, as well as the Ramsey County Attorney in Minnesota, signed the brief, which is in support of lawsuits filed by the State of California and the University of California.

Housing Affordability in State Hits New Low

California's housing affordability hit a 10-year low in the third quarter, with tight housing inventory driving home prices higher and reducing purchasing power for homebuyers, primarily in previously more affordable regions, such as the Inland Empire and Central Valley, the California Association of Realtors said last Thursday.

But housing affordability also slipped in Los Angeles County, CAR said in a statement.

The percentage of home buyers who could afford to purchase a median- priced existing single-family home in California in the third quarter fell to 28 percent, down from 29 percent in the second quarter of 2017 and down from 31 percent in the third quarter a year ago, according to CAR's Traditional Housing Affordability Index.

This is the 18th consecutive quarter that the index has been below 40 percent and the lowest since third-quarter 2015, CAR said. California's housing affordability index hit a peak of 56 percent in the first quarter of 2012.

CAR's housing affordability index measures the percentage of all households that can afford to purchase a median-priced, single-family home in California. The index is considered the most fundamental measure of housing well-being for homebuyers in the state.

A minimum annual income of \$112,100 was needed to qualify for the purchase of a \$555.680 statewide median-priced existing single-family home in the third quarter of 2017, CAR said. The monthly payment, including taxes and insurance on a 30-year fixed-rate loan, would be \$2,800, assuming a 20 percent down payment and an effective composite interest rate of 4.16 percent. The effective composite interest rate in second-quarter 2017 was 4.09 percent and 3.76 percent in

Housing affordability in Los Angeles County dropped 6 points from an index of 28 in the second quarter to an index of 22 in the third quarter as the area's median home price jumped \$81,000 in one quarter to reach nearly \$600,000. Meanwhile, affordability improved in the Bay Area.

the third quarter of 2016.

The affordability of condominiums and townhomes dipped in thirdquarter 2017 compared to the previous quarter with 38 percent of California households earning the minimum income to qualify for the purchase of a \$440,000 median- priced condominium/townhome, down from 39 in the second quarter. An annual income of \$88,770 was required to make monthly payments of \$2,220. Thirty-eight percent of households could afford to purchase the \$443,400 priced condo or townhome in second-quarter 2017.

WHAT YOU SHOULD KNOW ABOUT HOME IMPROVEMENT CONTRACTS

- Make sure your contractor is licensed, insured and bonded. Ask to see the documents
 proving these conditions. Under the law, you <u>must</u> have a written agreement signed by all
 parties and the agreement <u>must</u> be legible.
- The costs, payment schedule, start date, job description, completion date and process for mailing changes should all be clearly spelled out in the agreement. The California Contractors State Licensing Board has a good sample home improvement contract for your reference. (www.cslb.ca.gov)
- Make sure your agreement has a termination provision that allows you to terminate the contract if you are dissatisfied with the contractor's performance
- Check your contractor's references and complaint history with the California Contractors State Licensing Board. If possible, go see the contractor's work at other locations.
- 5. The down payment cannot exceed \$1,000 or 10% of the contract price, whichever is less. Except for the down payment, a contractor cannot demand or accept payment for work or materials until the work is actually done or the materials are delivered.
- 6. Require the contractor to identify the laborers, material suppliers and subcontractors he will use on your property.
- 7. Require the contractor to give you a release of lien from any laborers, material men or suppliers that work on your property.

After DA Fails to Schedule Promised Community Meeting, **Black Lives Matter Los Angeles Starts Weekly Protest**

The Los Angeles chapter of Black Lives Matter (BLMLA) has vowed to stand outside of District Attorney Jackie Lacey's office protesting every week until she makes good on a promise to schedule a community meeting with the families of those killed by the police and those who have died while in-custody. This comes after the group was refused entrance into the Hall of Justice recently to deliver over 10,000 petitions calling on the district attorney to prosecute officers who are involved in fatal shootings.

On Oct. 25, Special Assistant Cheryl Gaines failed to make good on a public promise to call and schedule a community meeting. Gaines, in front of dozens of protesters and grieving family members and in an effort to dismiss the group that surrounded the front door to the Hall of Justice

in downtown Los Angeles promised to call Black Lives Matter Los Angeles organizer Dr. Melina Abdullah that she would call to set up the meeting.

"Cheryl Gaines promised the families and the community that she would call me to set up a community meeting to address the petition," said Abdullah.

"We were explicit in saying that we wanted her to meet with the families and community to address the specific demands of the petition."

"Cheryl Gaines is playing games," Abdullah continued. "She called me and said, 'I'm a woman of my word. I said I'd call.' I waited for more, but she said nothing.

"Then I said, 'Okay. Do you have any information for us? You said you'd call to confirm a date when Jackie Lacey will meet with the families and community to talk about the petition demand.' She said 'I said I'd call' and then hung up the phone on me."

Helen Jones, the mother of John Thomas Horton III who died at Men's Central Jail in 2009, spoke passionately to Special Assistant Gaines.

Showing an emotionless Gaines pictures of her son's battered, bruised and bloodied body she decried, "You know this isn't no suicide! You know this isn't no suicide! Handcuffed to his wrist to where they done left a mark and his meat is showing. You know this isn't suicide. So when can we have a meeting with Jackie Lacey? That's what we want to know as moth-

During the confrontation Gaines tried to single out Jones for meeting but Jones refused saying that she was a part of a larger group of parents and loved ones who wanted to meet with Lacey and refused to accept a private meeting without the rest of the

parents or the community there

called " 'We've Abdullah Dr. plained. "We've sent numerous emails. We've sent letters. We've tried to make an appointment and go about doing things Lacey's way but we haven't

gotten anywhere. "We're barred from the building. Black Lives Matter is barred from entering the Hall of Justice. So basically, unless you've got an appoint you can get in and we can't get an appointment. We've actually been told that we're not allowed to make an appointment."

Dr Abdullah continued, "We're going keep showing up. We're going to keep demanding to meet with Jackie Lacey--who is an elected official, who is supposed to represent the People--quite literally. She is considered the People. We're going to demand that she represent the People and that she prosecutes the police who

kill our People. She can't test until she meets with the pick and choose who criminals are. When police behave criminally, they must be charged."

"She's a liar," said Tritobia Ford whose son Ezell Ford was killed in 2014 in South Los Angeles by officers from the Los Angeles Police Department. "She told me that the way I conducted myself with her and the way that I handled mvself that it made her decide to change the way she dealt with families. She promised me that she would make it her business to meet with all of the mothers in the future. So now I see that she's not doing that. She's not a woman of her word. She told me to my face that I had made such an impact that she was going to change the way she was going to deal with future families in my same

situation. She's a liar." Black Lives Matter vows to return to Lacey's office once a week in procommunity regarding their petition.

Since Lacey's election in 2012, over 300 residents of Los Angeles County have been killed by the police or died while in-custody. The district attorney's office has not filed charges against any officer in an onduty shooting in more than 15 years.

Lacey hasn't held a community meeting in South Los Angeles in all of 2017. The last community meeting she held in October of 2016, Lacey walked out of the meeting after things got heated between her and community members from various groups and people whose loved ones were shot and killed by police after they voiced their anger and frustration with her.

Lacey is the first woman, and first African-American, to serve as L.A. District Attorney since the office was created in 1850.



NAACP Set to Change Tax Status to Engage Politically

After being eclipsed in recent years by Color of Change, Black Lives Matter and other younger, more tech savvy and politically-pointed groups, the nation's oldest and largest civil rights organization will change its tax

The group's leaders said that the new tax status would allow them to be more aggressive politically.

During a call with reporters, NAACP officials announced that the civil rights group will transition from a 501(c)(3) to a 501(c)(4) designation. The change will allow the organization to be more partisan and politically focused. However, the tax designation does not allow political work to be the "primary activity" of the organization.

Even though the NAACP is 108 years-old, the organization is struggling to modernize and stay relevant in a rapidly-evolving, social media-driven landscape that re-

quires speed and strategic communications skills.

In October, the NAACP named Derrick Johnson as its president; Johnson was elected by the NAACP's board to serve for three

In a statement announcing Johnson as the new president, Leon Russell, the board chairman of the NAACP said, "As both a longtime member of the NAACP, and a veteran activist in his own right—having worked on the ground to advocate for the victims of Hurricane Katrina, along with championing countless other issues—Derrick also intimately understands the strengths of the Association, our challenges and the

many obstacles facing Black Americans of all generations, today. I look forward to continuing to work with him in this new role."

Russell continued: "In his time serving as our interim president and CEO, Derrick has proven himself as the strong, decisive leader we need to guide us through both our internal transition, as well as a crucial moment in our nation's history. With new threats to communities of color emerging daily and attacks on our democracy, the NAACP must be more steadfast than ever before."

Johnson is a native of Detroit, Michigan who lives in Jackson, Mississippi. He is a long-time member of the NAACP, who was elected Vice Chair earlier this year and served as the interim president after Cornell Brooks was forced out. Johnson attended Tougaloo College before earning a juris doctor degree from South Texas College of Law in Houston.

The **NAACP** ousted Brooks in the spring of this year, a few months before the group's annual convention in Baltimore.



Black Students in the Nation's Capital Deserve Better

In my role as the pro-

gram assistant for the National Newspaper Publishers Association's (NNPA) Every Student Succeeds Act (ESSA) Public Awareness Campaign, I closely process for the District of Columbia's ESSA plan. I have to admit, I was disappointed by the final version of the plan submitted to the U.S. Department of Education. Overall, D.C.'s ESSA plan is, at best, an incomplete assignment. The 'to be continued' tone of the plan could be partly due to the discontent expressed by many community members during the final stakeholder meetings. Parents and educators alike expressed concern about the lack of resources and implementation strategies to support the Office of the State Superintendent of Education's (OSSE) aggressive goals for academic proficiency and high school graduation. The participants at the meetings noted the glaring socioeconomic disparities throughout the district and the unique resources required to increase achievement in each ward. One could conclude that OSSE's aggressive academic goals are mirroring the affects of

a rapidly gentrifying city

that continues to marginalize the needs of its majority Black residents.

According to District of Columbia Public Schools (DCPS), 71 percent of their student population is Black and 70 percent of the entire student population qualifies for free or reduced lunch. In August, DCPS released the latest scores for tests under the Partnership for Assessment of Readiness for College and Career (PARCC). Black students showed the smallest improvements with a 4.8 percent increase in English Language Arts proficiency and a 2.1 percent increase in math proficiency. In both categories, less than 20 percent of Black students achieved proficiency in reading and math. This increase is compared to a 6.2 percent increase in English Language Arts proficiency for Hispanic students in the district and a 9.6 percent increase by their White counterparts. Similarly, Hispanic students showed a 5 percent increase in math proficiency while White

students increased their proficiency by 4.8 percent. According to the PARCC assessment, less than 30 percent of Hispanic students are proficient in reading and math. While more than 80 percent of White students, according to PARRC, exhibit proficiency. White students make up just 10 percent of the DCPS student population.

DCPS needs to try harder to raise the test scores of its Black students. DCPS should also quickly work to reaffirm their commitment to expanding college and career support for students, especially Black students.

At a recent town hall meeting hosted by the National Newspaper Publishers Association in Atlanta, Ga., Vickie B. Turner, a school board member for District 5 in the DeKalb County School District, encouraged participants to reach out to parents, who were not present at the town hall and who are not engaged, declaring "we are preaching to the choir."


Charles R. Drew Recognized as One of Most Ethnically Diverse Colleges in U.S.

Charles R. Drew University of Medicine and Science here in South Los Angeles, was recently listed as the number two most diverse non-profit college in the United States. The finding was released among a list compiled by the Almanac of Higher Education, published annually by the Chronicles of Higher Education. The high-ranking ushers the University into a class of institutions that includes the University of San Francisco, Hawaii Pacific University and others. These rankings were determined by analyzing fall 2015 enrollment data from the U.S. Department of Education, said CDU officials.

"CDU has grown and evolved, shaped by the needs of the community it serves," they said.

"The University benefits from its location within the Watts-Willowbrook community and the corresponding diversity and complexities of its population by creating an academic environment unlike any other."

The U.S. Office of Civil Rights designated the private college as a minority serving institution in 1966, while the U.S. Department of Education recognized CDU's College of Medicine as a Historically Black Graduate Institution. CDU is also a charter member of Hispanic Serving Health Professions schools.

"CDU's mission and historically significant location provide us a very unique, yet pertinent role within the nation of training practitioners, to deliver culturally appropriate care," said Dr. David M. Carlisle, president of Charles R. Drew.

"As the nation's demographics become more diverse and disparities become more apparent, so does the need for excellent care delivered by diverse and culturally competent professionals. Our University's mission is to cultivate diverse health professionals who are dedicated to social justice and health equity for underserved populations. This ranking further substantiates our commitment to developing diverse health professional leaders who are equipped with skills relevant to the rapidly developing health care priorities of the 21st century.'

More than 70% of CDU graduates since the year 2000 are from underrepresented backgrounds, and over 80% of alumni report serving in under-resourced communities following graduation.

"The University continues to rebuild and rebrand as a comprehensive midsize university of excellence, while also never forgetting its historic legacy of enhancing the diversity of the health profession," Carlisle said.

"This ranking further substantiates our commitment to cultivating diverse health professional leaders who are equipped with skills relevant to the rapidly developing health care priorities of the 21st centu-

The success of CTTT led to additional funding from Los Angeles County Fourth District Supervisor, Janice Hahn, to bring the workshop to South Whittier Library.



Serra Cavalier boys' basketball player Jaylan Slaughter is preparing for his senior season and third varsity season. With a 3.143 GPA, Slaughter has dreams of playing college basketball.

To balance the rigors of athletics and academics, Slaughter uses his time off court wisely by studying.

"At the time I'm not doing basketball or we're not doing anything that revolves around basketball, I would do my work and sit alone," Slaughter said. "If I need help, I would go to somebody that's in my class and help me with something I don't understand."

The team is under Bernard McCrumby, who acted as an interim head coach last season. Then, Serra had a competitive edge with a 16-12 overall record and a 6-2 record in


the Del Ray league.

"We had our ups-anddowns," Slaughter said. "Midway through the season, we found our way from [our] problems."

Slaughter considered the Cavaliers 31-70 loss against the Bishop Montgomery Knights as a memorable moment from last season. The Knights were a top-ranked team in the state and third in the nation.

"We [were] all injured and I was injured at the time but at the same time, we [were] all hyped about the game, thinking we [were] gonna win the game," Slaughter said. "Then, in the first quarter, we [were] tied up with Bishop and then that was pretty exciting."

Serra qualified for the Southern Section Division 1AA playoffs. They defeated Lynwood 71-60 in the first round. The Cavaliers had their playoffs run cut

During his sophomore year, Slaughter helped the Cavaliers to a CIF Southern Section Division 4AA Championship after defeating Notre Dame (Sherman Oakes) 53-50. In the tournament, Serra defeated Desert Hot Springs and Nipomo in the first and second rounds, respectively.

"We [were] having a lit-

tle rough time," Slaughter said. "As the season got on, we started to figure out what was really missing on the team and then everybody figured out what was their role."

He mentioned how the players finding their role were a major factor in their success. Serra was 19-15 overall and 4-4 in the Del Ray League during their championship season.

Slaughter has been familiar with the teachers of Serra long before enrolling, including late basketball coach Dwan Hurt.

"Hurt, he was a really good coach and I was always around Serra," Slaughter said. "I felt like why should I go anywhere else if I knew the people here?

As Slaughter tried to adjust to varsity play as a sophomore, Hurt fed him advice that would stick with him to this day.

"Hurt was always yelling at me at one practice," Slaughter said. "At the end of practice, he pulled me to the side and told me ... 'don't worry about how I say it, but what I say."

Since his senior year started, Slaughter has enjoyed his English class; he mentioned that his favorite book is the John Steinbeck classic "Of Mice and Men."

"My favorite class is English because the teacher would relate what we're doing in class to what's going on now and at the same time make us laugh," he said.

The CIF City Section football playoffs begin this Thursday with a modified format, introducing the

open division tournament. In July, the Los Angeles City Section announced the new playoff format that allows all 24 division I programs to compete in the postseason. Eight teams with the best in-season record will ascend to Open Division competition. Among those eight are Narbonne, Crenshaw and Car-

The Open Division playoffs begin on November 17, the title matchup will commence on December 2 in El Camino College at 7:00pm.

Narbonne clinched a three peat when they won the Division I City Section title last season. In 2015, the Gauchos defeated Clayton Valley Charter 28-14 to win the Division I-A State Championship. After earning a 7-3 overall record and going undefeated in the Marine League, Narbonne is top seeded in the Open Division. The Gauchos battle San Pedro in the first round.

In the past decade, Crenshaw High School collected three championships out of five title game appearances, defeating Narbonne in the three bouts. The Cougars reached the Open Division CIF State Championships in 2009 and lost 14-28 to De Le Salle. Crenshaw, with a 9-2 overall record and no losses in Coliseum League play, earned the second seed. The Cougars will face the Banning Pilots in their first playoff game this season.

Division I playoffs start on November 9 with the championship game on December 1 at 7:00pm at El Camino College.

Dorsey high school, hailing a 4-6 overall and 4-1 Coliseum League record, has the sixth seed and will

For the first time this season, the Clippers hosted back-to-back matinee games over the weekend at Staples Center, overcoming a 25-point deficit in the fourth quarter, where they took the lead with under three minutes to play, only to surrender it right back, as L.A. lost a 104-101 thriller to the Miami Heat Sunday afternoon.

"We've got to carry this over," guard Austin Rivers said. "That feeling that we had as a team that last quarter, we've got to feel that. And understand that if we play like that, we give ourselves a good chance every night."

L.A. started the fourth quarter on a 16-0 run, holding Miami scoreless until the seven minute mark, swinging momentum the Clippers way entirely.

Under immense pressure, Rivers missed both free throws giving the Heat possession, as James Johnson was then sent to the charity stripe, by a costly Blake Griffin foul with 8.7 seconds to play.





"This movie is about me pledging [into] a white fraternity, and at first, I go into there with my perception of these people, but when I get to really know who they are, I realize that there's not difference races. There's one race, and that race is humanity," Bachelor declared.

Bachelor, who has built a massive community of online followers, including 14.5 million Instagram followers and more than 1.5 million YouTube subscribers, says using his talents as a writer and producer helped him transition from social media stardom to acting in film and television. "I learned from everybody, I learned from the acting, I learned from the producing, I learned set etiquette, and it was a great learning experience," Bachelor said.

In terms of on-camera chemistry, the duo said that it was a breeze working together on-set, shooting the entire movie in all of 16 days. "It was so great to be able to figure out who these characters were and what they meant to each other and genuinely be friends, I think that's important for this film to work, specifically for my character," Graham said. Graham also says that it was "a breath of fresh air" to act in a comedy role, having been accustomed to working in more dramatic roles.

Bachelor and Graham also spoke to the Sentinel about the challenges they sometimes face as Black actors. Graham says that

when she encounters actors her age who aren't Black, she doesn't see the same plight to acquire secure major opportunities in film and television. "Being Black in this industry, you have to be able to do it all, you are like required almost," she

"As a Black actress, I feel like I've had to work twice as hard as maybe someone else who isn't Black. You have to write and you have to create and you have to produce and you have to kind of know the ins-and-the-outs. You have to find every single way to succeed, even if you have create it yourself, which a lot of us have to," Graham continued.

Bachelor shared that he's always had his mind set on creating and telling his own stories, paving the way for his success. "I've always been a creative type, so I never had to really go through the process of reaching out; I was always my own employer. I would create, I would write, I would produce and I guess that's why I'm successful in


where I am," Bachelor said. In terms of advice for Black artists and entrepreneurs, Bachelor and Graham says it's critical to make

smart investments into your

future. "We invest into our-

selves on so many levels. I think that a lot of people wait on other people to get things going. You shouldn't wait on anyone. If they give it to you, they're quick to take it back and take away your credit," Graham said. "Don't stop building just because somebody doesn't want to recognize your Black excellence," she con-

Ulmer preaches in Castle Church, Home of Protestant Reformation

Bishop also shares plan to open Skid Row church and update on The Ulmer Institute

A lot is happening in the world of Bishop Kenneth C. Ulmer and it's all part of his mission to serve others by making a difference in their lives.

In concert with that goal, Ulmer, the pastor of Faithful Central Bible Church (FCBC) in Inglewood, traveled to Germany to participate in the Wittenburg Congress from Oct. 30 to November.

He, along with Leonard Sweet of Drew Theological School and James O. Davis of Billion Soul Network, hosted the event to celebrate the 500th anniversary of the Protestant Reformation and persuade attendees to fulfill the Great Commission Christ that commanded in Matt. 28:19-20.

More than 1,500 ecumenical leaders attended the congress, which was held at Castle Church – the site where Martin Luther nailed up 95 theses on Oct. 31, 1517, that questioned the authority of the Roman Catholic Church to institute various practices that had no foundation in the Bible.

"What happened then resulted in who we are now in the church today. The churches in the west and the U.S. are all the result of the Protestant Reformation," explained Ulmer.

"The key to the Protestant Reformation was centralizing the word of God and the pulpit versus the tradition of the church and the liturgy of the church – a major shift. There was a spiritual shift from the traditions of the church to the word of God."

Ulmer, the only African American speaker at the congress, preached in the ornate pulpit from Psalm 118:17 and referred to the experience as "humbling." During his sermon, he outlined how "that one man changed the world" and connected Luther's action to today.


"I think the lesson for us is that each one has some particular position in our communities and neighborhoods. We have a voice and we have the ability to share that voice and make a difference," he said.

"There are things happening in our world today that you can't be silent about just because it's always happening," said Ul-

He added that the congress concluded with attendees pledging to commit to biblical authority and share this belief with their communities.

New Church Plant

Continuing his commitment to serve others, Ulmer announced a new

church plant on Skid Row in downtown Los Angeles. The ministry, set to open in early 2018, is named COR - Champions on the Road and will be housed in the Union Rescue Mission's chapel.

The pastor was hired last week and a full-time staff will be employed. Worship services and Bible Study will be offered as well as a range of outreach programs for men, women, youth and seniors.

"We are going down there to establish an ongoing presence of a spiritual community. We want it to be on the level of quality as in Inglewood," said Ulmer.

The Ulmer Institute

Providing an update on The Ulmer Institute (TUI), the bishop reported that the nonprofit is making steady progress. Last year, he launched TUI to help people who cannot access affordable counseling services move beyond urban trauma to hope and recov-

The project is a part-

nership between centers of faith, the Israeli psychological community, the Jewish community, Los Angelesbased clinics, hospitals and research universities.

"We have trained nearly 200 students at Inglewood High School in our technique we call pre-TSD (traumatic stress disorder). We train people to reprogram their mind to process trauma before it happens," said Ulmer.

"Every school has fire, earthquake drills and now they have active shooter drills. My premise is that we have children in urban areas who are more likely to see a drive-by shooting, gang violence or drugs before the earthquake ever

"We want to prepare them when and if this happens and teach them how to navigate through the process," he said and added that plans are underway to expand the training to more school groups, youth groups and eventually, the military.

Legacy Vision

Reflecting about his legacy, Ulmer noted, "I'll soon be 70-years-old, married 40 years, at Faithful Central for 35 years and I'm thinking, 'What now? What am I leaving behind that will be here when I fall?"

Based on his past endeavors, he will likely continue his original mission to serve others.

"I hope to touch lives in a manner that what they received will be released to someone else and passed on to the next generation," said Ulmer.





The church

building has stood at this corner since its dedication on June 23, 1929. Many who worship here remember those early days and see today's church to be as vibrant as ever in fresh ways."

Several current parishioners can trace their lineage in the church back 50 years or more.

One of the oldest members, Clelie Talamon, who was recently honored as Mother of the Year, said, "We're very proud of our church and its history. I hope many who haven't been here for awhile will come back and be amazed by what we do."

The church carries out active ministries to meet the

I'm Going To Eat You Up!

Life is similar to the "Three Little Pigs" children's story. The old mother pig had three little pigs, but not enough food for them. As they matured and became old enough to work, she sent them out into the world to seek their fortunes. The first little pig was very lazy and didn't want to work at all and built a house of straw. The second little pig worked a little bit harder, but he was somewhat lazy too and built his house out of sticks. As they kept company with each other after the house was built, they happily danced and sang and played together the rest of the day. The third little pig worked hard all day and built his house with bricks. It was a sturdy house complete with a [luxury] fireplace and chimney and it looked like it could withstand the strongest winds. [The old greedy wolf couldn't stand to see others progress without attacking them and wanting to destroy their work and their lives.] [It was his practice to ravage wherever he could.] So, as he was passing by he saw some new structural things in the neighborhood. He saw the straw house and the pig inside and with his greedy ol' self designed how he could devour the pig inside, thinking the pig would make a fine meal.

His mouth began to wa-

ter-salivate. He knocked on the door and demanded that the pig let him in. He was kind of stupid too, because why would a pig let him, knowing his bad reputation for eating up little pigs and he saw his big paws too! The pig was wise enough to say, "No! No! No! The wolf became more angry and showed his teeth, saying "I'll blow down your house." Sure enough he did blow down his house, but the little pig escaped being eaten and ran to the second pig's house who had built a house of sticks! Seeing the second pig's house and having a strong sense of smell, he knew the pigs were in the house of sticks. [Keep reading. There is value in this. His mind was always on his stomach and how he could trick these pigs seeing that the first pig had escaped him. He makes his threat again knocking on the door: "I'll huff and puff and blow down your house!" This time they saw his pointy ears through the keyhole, a giveaway of his true identity! Again, they said, "No!No!No! You cannot come in! [What do you think, we're a bunch of dummies to let you in after you already tried to eat us before??] He did huff and puff and blew down the stick house. [By this time, they were so afraid, but the smartest pig who

had a place of safety refuge for them; a brick house.] The wolf was throwing a fit by now with angry rage, having not eaten all day! The smell of the pigs was more than he could bear. His thinking became blurred as he could think only about his gluttonous appetite.] Fortunately, the pigs didn't give in to the wolf's anger and ran away, the wolf chasing them, seeking to destroy them! He figured, "Now, I've got them cornered in one house and my feast is waiting for me. I'm going to eat them up! He used his same strategy, knocking on the door, demanding entry. Notice of intent to **Adopt a Mitigated Negative Declaration** 99[™] Street Filtration Plant Project

An Initial Study/Mitigated Negative Declaration (IS/MND) has been prepared by the City of Los Angeles Department of Water and Power (LADWP) for the proposed 99th Street Wells Filtration Plant Project. LADWP is the California Environmental Quality Act (CEQA) Lead Agency for this project.

LADWP proposes to construct an iron and manganese (Fe/Mn) treatment facility adjacent to the existing 99th Street Wells Pumping Station in the Watts community of the City of Los Angeles. The proposed project is part of LADWP's program to ensure LADWP meets the USEPA National Secondary Drinking Water Regulations for Fe/Mn and maintain LADWP's reliability to serve groundwater. The proposed project would remove naturally occurring iron and manganese from the groundwater wells.

The proposed project would be located at 9880 Wadsworth Avenue, adjacent to the existing 99th Street Wells Pumping Station Complex within the LADWP Power System Transmission Line Right-of-Way, in the City of Los Angeles. The proposed project area would generally be bound by Wadsworth Avenue to the west, Century Boulevard to the south, Clovis Avenue to the east, and 98th Street to the north.


Due to power line clearance requirements, the proposed project would require the relocation of existing 34.5 kilovolt (kV) overhead power lines to be buried underground near the project site on 98th Street between Wadsworth Ave. and Clovis Ave. The undergrounding of the power lines is estimated to occur during summer when the elementary school is out of session between May 2018 and September 2018. The Fe/Mn treatment system installation is anticipated to begin in December 2018 and end in February 2020.
