Is it Safe for Children to 'Trick or Treat' This Halloween?

As children of all ages prepare for and look forward to "trick or treating" this Halloween, many parents are rightfully asking themselves how they can ensure that their little ghosts and goblins will be safe and sound during this upcoming festive holiday.

Dr. Lisa P. Luu, a pediatrician with Kaiser Permanente Downey, encourages parents to make last-

ing memories with their children. However, she notes it's also important to remember there are important avoidable safety hazards lurking that can result in injury and ill-

A good start is to make sure your children are up to date with their COVID-19 and flu vaccines, she said. Additionally, Dr. Luu addressed several scary health issues parents should be

aware of to ensure their little munchkins have a safe and happy Hal-

Examine Treats

Before your child eats any treat, Dr. Luu advised parents to look at the label if their children suffer from allergies. "I would advise against eating any treats without labels," she said. "The Centers for Disease Control and Prevention tells us food allergies account

for 35% to 50% of all cases of severe, potentially life-threatening allergic reactions such as against peanuts. It's also a good idea that in case your child suffers a severe allergic reaction, it's a good idea to have easy access to an epinephrine auto-injector if prescribed." If labels are not available or allergen information is not readily available online, consider substituting with known safe treats or non-food items.

Avoid Hand Injuries

For many parents, carving a pumpkin for Halloween is a treasured family tradition shared with their children. However, many children suffer from carving knife injuries each year that can lead to severe, but preventable, injuries. To avoid an unwanted and scary visit to the emergency room, Dr. Luu advises parents to have young children draw the pattern on the pumpkin, clean out the inside pulp and seeds with a spoon, but leave the knife work to the adults. Another tip for parents is to consider using a cookie cutter instead.

Beware of Fire hazards

Many parents and children love decorating their home for Halloween with spooky decorations that also may include lit ornaments. Unfortunately, this can result in some truly scary fire safety hazards. As such, to be safe, Dr. Luu advises that it's better to light up your jack-o-lantern with glow

sticks or electric candles instead of candles. "This is advisable because many decorations are very flammable and can result in injury and property damage," she notes. According to FEMA, the top five causes of most Halloween fires include careless actions and electrical malfunctions.

Selecting Safe Costumes

On Halloween, every child wants to wear a costume that's second to none. But some costumes can pose a hazard, so it's important to follow some guidelines. For instance, if a mask is worn, it should have large enough eye holes for a child see clearly, Dr. Luu says. She also advised that children wear bright and reflective costumes so that they are more visible. Parents should also be on the lookout for small parts on costumes that could cause young children to choke. Lastly, costumes should not be too big or too long as that may result in a child tripping and inuring themselves.

Face paint/Costume contact lenses

Before you apply makeup near your child's eyes, it's important to know it could contain harmful chemicals, according to the American Academy of Ophthalmology. If makeup is applied, it should be applied in small amounts to the arm or back of the person who will be wearing it to test safety. The appearance of a rash, redness, swelling or other signs of irritation could indicate an allergic reaction and should be avoided. Additionally, the American Academy of Ophthalmology warns that though wearing costume contact lenses on Halloween can be a real scream, the scare from non-prescription contact lenses can be all too real when chemical exposure or potentially blinding infections take place. As such, they should be

avoided. Pedestrian safety

Since trick-or-treating can take place when it's dark, Dr. Luu encourages parents to provide children with flashlights or glowsticks for lighting and greater visibility, which can be incorporated into the costumes. Another option is sticking reflective arm bands or reflective tape to bags or costumes to ensure your child can be seen. It's recommended that parents review street safety ahead of time with their chil-

COVID-19 safety

Last, but not least, although COVID-19 may not be as much on the minds of parents this Halloween, Dr. Luu encourages children to wear a mask as part of their costume, when possible, to maximize protection.

Also, children should always wash their hands with soap upon returning from trick-or-treating. It's also critically important to only eat factorywrapped treats and candy, as that is a safer practice.

Greater Los Angeles African American Chamber of Commerce has connected small and medium-sized Blackowned businesses to Fortune 500 CFOs, CEOs, investment bankers, and provided access to billions of dollars in contracts through its many programs, networking events, workshops and educational seminars.

In October, GLAAACC kicked off its 25th Business Evolution Program. Each year, a cohort of business owners is mentored through a nine-month business boot camp that provides sessions on setting up a back office system, certification, contracting, developing a capability statement, how to access capital, financial management, marketing, branding, and harnessing the power of technology and artificial intelligence.

GLAAACC Chairman Gene Hale is the founder and president of a multi-million dollar corporation, G&C Corporation, an equipment sales and leasing business. Hale started G&C Corporation over 40 years ago and is a nationally recognized leader in the procurement and sale of construction materials and supplies. At the kick-off session of GLAAACC's 2024 - 25 Business Evolution Program, Hale spoke about what it takes to operate a successful business.

"As business owners, we not only need to be focused on getting the business, but after we get the business, we need to understand how to retain the business," Hale said. "As you grow, it's also important to know how to network properly to connect with leaders in business and politics – people that can

"Bylaws, articles of incorporation those things are needed to apply for grants and for government contracts and for loans and that sort of thing, so I need to have it all organ-

Dowd has already had her first one-on-one meeting with one of the business development coaches provided to the cohort as a part of BEP and has developed tasks to meet her goals. "I've got my little hit list and I'm knocking things out."

Keidrick Cole applied for BEP to become a part of a community of like-minded Black business owners. His company, Elite Auto Source, specializes in luxury black car service where clients can

A serial entrepreneur, Cole founded Elite Auto Source in response to numerous clients requests from his concierge and real estate businesses. Starting in a new industry after being in business for 20 years, Cole felt he needed to widen his network to get the word out.

Cole said he is looking forward to new collaborathrough BEP. tions "Nobody can succeed alone. If I learn something new, I don't want to keep it within my own brain," Cole said. "I want to spread it to as many people as possible so that we all can win. And then, of course, I'm sure knowledge and wisdom will come back to me as well."

At the inaugural meeting, BEP chairperson Lily Otieno reminded the group of the variety of upcoming events and capital investments that can benefit small businesses. Otieno is the director of the supply chain and diverse business enterprises for SoCal Gas Com-



pany. She previously headed her own consulting firm, Infinity Business Solutions, where she assisted businesses reach their goals.



L.A. Care Commits \$1.2 Million+ to Reduce Barriers to Dental Care for Angelenos

Oral health diseases such as cavities and gum disease are largely preventable. However, factors such as chronic medical conditions, access to care, cultural norms and attitudes, and socioeconomic status can influence these outcomes and create additional barriers to care. Addressing these barriers is essential to ensuring that community members have the necessary access to maintain and improve their oral health. Today, L.A. Care Health Plan is announcing a new \$1.22 million commitment to its Oral Health Initiative to support 10 organizations that are addressing the barriers to oral health care in low-income communities

"Oral health is critical to

overall health. Poor oral health in children can have a devastating impact on quality of life and their performance in school, which ultimately can impact their success as an adult," said John Baackes, L.A. Care CEO. "In adults, poor oral health can lead to complications for those with cardiovascular disease, diabetes, or even those who are pregnant, so it is extremely important that we take steps to improve oral health."

The Center for Disease Control and Prevention (CDC) reports tooth decay in children aged 2 to 5 from low-income households is about three times higher than that of children from higher income households. And 33% of Latino children and 28% Black children aged 2 to 5 have had cavities

in their primary teeth, compared with just 18% of non-Hispanic White children.

The L.A. Care funding will help the 10 awardees implement strategies that address the barriers contributing to oral health disparities. Since 2003, L.A. Care, through its Oral Health Initiative, has awarded more than more than \$19 million for 195 projects that provide oral health infrastructure, education, prevention, and treatment services to low-income communities.

Between 39th and Coliseum, Medical Tent Station #2 was occupied by InnovAge, a neighborhood center for senior healthcare at 3760 Degnan Blvd. InnovAge provides a myriad of benefits to ensure the health of its members: specialty care (dental, vision, physical therapy, and behavioral

health), social engagement through activities, meals, exercise, and group outings, transportation to medical appointments and centers, connected healthcare for primary, emergency, hospital coverage and in-home assistance.

Further south toward Stocker Avenue, W. King HealthCare Group's tent was an incredible resource for Taste of Soul attendees to learn more their options in choosing a Black-owned medical practice. 

United foundation. He also had fashion designs and paintings that featured his iconic character Powerful Paul, who can be seen in several of his projects.


"I wanted a character that people resonate with and they recognize as me," Norris said. "Taste of Soul means culture. Black culture to me, food, good ener-

CBM Special Interview: Rep. Barbara Lee Discusses Kamala Harris' Plan for Black Men

Last week, the Kamala Harris campaign released its Opportunity Agenda for Black Men.

On Oct. 16, California Black Media (CBM) spoke with Harris-Walz campaign surrogate, Congresswoman Barbara Lee (D-CA-12), who shared more insights on Harris' agenda and the importance of securing the Black Male vote.

"She has said very clearly that she wants to earn the vote of everyone. And that means earning the vote of Black men," said Lee of Harris.

"She understands the systemic and historic challenges that Black men have. You haven't heard of a presidential candidate coming up with a concrete actual plan and policy agenda."

The plan's release came after a string of podcast and interview appearances during which Harris shared her plans to tackle several issues that Black men specifically face if elected President.

The agenda includes five focus areas based on insights she gleaned from hosting discussions with Black men during her Economic Opportunity Tour:

1. Provide one million loans that are fully forgivable to Black entrepreneurs and others disadvantaged groups to start businesses.

2. Champion education, training and mentorship programs that help Black men get good-paying jobs in high-demand industries It will also develop more accessible pathways for Black men to become teachers.

3. Support a regulatory framework for cryptocurrency and other digital assets so Black men who invest in and own these assets are protected.

4. Launch a National Health Equity Initiative focused on Black men that addresses sickle cell disease, diabetes, mental health, prostate cancer and other health challenges that disproportionately impact them.

Legalize recreational marijuana and creating opportunities for Black Americans to succeed in this new industry.

"[Vice President Harris] knows that Black men have long felt that too often their voice in our political process has gone unheard and that there is so much untapped ambition and

leadership within the Black male community," the language in the agenda states. "Black men and boys deserve a president who will provide the opportunity to unleash this talent and potential by removing historic barriers to wealth creation, education, employment, earnings, health and improving the criminal jus-

cial. In the 90's, she established the first California Commission on African American males through which she pressured the state to address urgent economic, health and social challenges specific to Black men.

Harris' agenda was released after some Black men criticized a recent campaign speech by former President Barack Obama. They accused him of 'scolding' Black men because of their hesitancy to support Harris, suggesting that sexism played a role in their disinterest. The fallout from the former President's comment has left some wondering if the Harris campaign is rolling out the agenda as a response.

"No group of people are a monolithic group of people," said Lee when asked about Obama's speech.

"There were different points of views and different feedback. She stated very clearly that she does not expect anyone to vote for her. She's not taking any vote for granted. I've known her over three decades and I believe she is being herself. She's authentic and she cares about making sure that people, I say not only survive, but thrive," Lee added.

Each of the fivwe key points addressed in the Harris Campaign's agenda, Lee says, has additional clauses that can potentially help Black men and their families thrive. includes lowering rent; up

to \$25,000 in downpayment help for first time homebuyers; and cutting taxes for Black men in lower-wage jobs increasing the Earned Income Tax Credit maximum to \$1,500.

Lee says the goal of the Harris-Walz campaign is for more Black men to become "trusted messengers" for the Vice President, explaining her intentions to the community and leverage their own experiences to hold Harris to task for what they are looking for politically.

"I think the messages is one of empowerment for Black men -- regardless of whether they' re a blue-collar worker, if they' re not working, if they' re in business, if they' re an entrepreneur, whatever background or whatever they' re doing or experiencing life. I think the authenticity of their experience can only be articulated through them," said Lee.

"I think it's important that they be out there talking about what it means to be a Black man in America and how this can be connected to political empowerment," Lee added.

Gov. Newsom Signs Bill to Ensure Refineries Have Enough Fuel to **Avoid Gas Shortages**

Gov. Gavin Newsom signed a law on Oct. 14 written to help prevent gas prices from spiking to protect consumers. Democrats in the Legislature introduced ABX2-1 to push back on the increasing cost of energy prices and the impacts of climate change by the oil industry.

With this new law, big companies are now responsible for stabilizing

increases when refineries go offline for maintenance.

Newsom said the State Legislature is "not waiting around for the industry to do the right thing.

"We're taking action to prevent these price spikes and save consumers money at the pump. Now, the state has the tools to make sure they backfill supplies and plan ahead for maintenance so there aren't shortages that drive up prices," Newsom said.

Democrats criticized the oil industry for trying to keep the legislation from passing. Lawmakers said prices at the pump," said that price spikes have cost

Newsom signed the law. According to the American Automobile Association (AAA), California residents pay the highest prices for gas in the U.S. as a result of taxes and added costs resulting from environmental regulations. The average price for unleaded gas in California was approximately \$4.68 per gallon this month, compared to the national average of \$3.20 per gallon.

The bills authors, Assemblymembers Gregg Hart (D-Santa Barbara) and Cecilia Aguiar-Curry (D-Winters) and Sen. Nancy Skinner (D-Berkeley) introduced the legislation after the state's Division of Petroleum Market Oversight revealed that gas price spikes are primarily caused by increases in global crude oil prices and unplanned refinery outages. State law allows energy regulators to require that refineries keep certain amounts of fuel on hand to prevent sudden residents billions of dollars over the years.

Opponents of ABX2-1 argued that the law could unintentionally raise overall gas prices and threaten the safety of workers by giving the state more oversight over refinery maintenance schedules, and a delay in maintenance could lead to accidents.

Catherine Reheis-Boyd, president of the Western States Petroleum Association said policymakers do not understand the oil industry and what drives gas prices.

"Regulators remain fixated on controlling businesses with more taxes, fees, and costly demands," said Reheis-Boyd in a statement.

Following Gov. Newsom's decision to enact the bill, Phillips 66 announced that it will shut down its refinery in Wilmington next year. The state is projected to lose more than 8% of its crude oil processing capacity as a result of the company's costsaving move to close its refinery.

United Health Foundation Is Offering \$3,200 Scholarships for Health Care **Professionals**

The United Health Foundation (UHF) announced the Diversity in Health Care Scholarship program, an initiative offering \$3,200 scholarships to underrepresented healthcare professionals.

The program is part of the foundation's commitment to making the healthcare system work better for students, professionals, and people from diverse back-

According to UHF, the initiative is designed to help underrepresented health professionals advance their clinical degrees and credentials. The scholarship provides funding for professionals from various clinical fields such as nursing, mental health, physical therapy, dentistry, pharmacy, and medicine. Previous scholarship recipients stated that they are motivated by the desire to serve patients within their respective communities by providing culturally responsive care.

"Experience shows that when patients receive care from health providers who speak their language or understand their cultural needs, they are more responsive and engaged," said Anne Yau, UHF President, in a statement.

"This can lead to better health outcomes, as patients feel safe and trust their health care providers," Yau

Since the program launched in 2022, the foundation has provided scholarships to approximately 2,000 students and professionals who want to make a difference in health care. The initiative aims to sponsor 10,000 clinicians by 2033.

California Increase Wages for Health Care Workers

California has increased wages for some of the lowest-paid healthcare workers in the state.

According to the University of California, Berkeley Labor Center, the new minimum-wage increase to \$25 an hour over the next

decade will affect approximately 460,00 workers in the health care industry. Under the new law, which took effect Oct. 16, professionals working at rural independent healthcare facilities will earn a minimum of \$18 an hour immediately. Hospitals with at least 10,000 employees will now have a minimum wage floor of at least \$23 an hour.

Gov. Gavin Newsom signed the law last year, and the wage increase was supposed to take effect on June 1. However, the state budget deficit of nearly \$46 billion at the time caused a delay in implementing the pay increase for some months.

John Logan, professor of Labor and Employment at San Francisco State University, said that the wage increase will help the health care industry retain and recruit workers in an interview with ABC News.

"It's a way of providing something approaching a living wage for hundreds of thousands of workers that didn't have it before," said Logan.

The minimum wage for most workers in California is \$16 and voters will decide in November to increase the rate to \$18 an hour by 2026. Increasing the wage would make the rate the highest statewide minimum wage in the country.

Toks Omishakin, Secretary of CalSTA said that the **Equity Advisory Committee** is making a difference through valuable recommendations to the state's transportation system.

The committee has experts from various backgrounds including tribal and indigenous communities. The group also has advocates from community organizations such as climate and air quality, housing justice, as well as environmental justice and equity. The committee will address accessibility disability advocacy and rural area concerns.

Members serve up to two years on the committee and are eligible for a \$100 per diem for their service. Applicants must be residents of California and have experience in developing and implementing community-derived policies in partnership with the government or similar institutions.

Secretary of State Weber **Urges Californians to** Take Advantage of **Early Voting**

Last week, California Secretary of State (SOS) Shirley N. Weber encouraged voters to submit their ballots early for the upcoming general elections in November.

The SOS's office listed a step-by-step process that voters can follow to complete and return their vote-

by-mail ballot. "California voters are no longer limited to a single day of voting. Why wait in line on Election Day when you have early voting options?" said Secretary Weber. "Once you receive your ballot, complete it, sign the back of the envelope, and then you can return it by mail, drop box, or at any early voting location."

Voters can visit the Secretary of State's official website to view the full list of drop box locations, where they can drop off their voteby-mail ballot

Eligible citizens can register to vote or update their voter registration online. The last day to register for the Nov. 5 General Election is Oct. 21.

Other important dates for the upcoming elections are listed below:

- Ballot drop-off locations opened on Oct. 8.
- Vote centers open for early in-person voting in all Voter's Choice Act counties beginning on Oct 26. 2024.
- Mailed vote-by-mail ballots must be postmarked on or before Election Day and received by Nov. 12.

California Expands Access to Culturally **Based Treatment For** Substance Abuse

Gov. Gavin Newsom announced that the state is expanding access to culturally based treatment services for people struggling with substance use disorder.

Recently, the state expanded Medi-Cal coverage to include traditional healthcare practices that help improve the health outcomes of individuals with substance disorders. State data showed that Native Americans are disproportionately impacted by the opioid epidemic with higher death rates caused by overdoses compared to other racial and ethnic groups in the country.

Newsom said that the State wants to help heal the historical wounds inflicted on tribes, including the alarming health disparities between Native communities and other groups.

"By supporting greater access to traditional

Prop 3 Aims to Remove Same-Sex Marriage Ban From Calif. Constitution

Prop 3 would remove the ban on same-sex marriage from the California Constitution. The ban (Prop 8) was added by voters in 2008; however, the United States Supreme Court has blocked the enforcement of the ban since 2013.

The amendment would remove current language in the state constitution stating that marriage "is only between a man and a woman" and change it to "the right to marry is a fundamental right."

State Sen. Scott Wiener (D-San Francisco) and Assemblymember Evan Low (D-Campbell), both members of the Legislative LGBTQ Caucus, introduced the constitutional amendment as a preemptive protection after the U.S. Supreme Court overturned federal abortion protections in 2022. Justice Clarence Thomas, a conservative, said that the court should also reconsider the constitutionality of same-sex marriage, but other conservatives on the bench disagreed.

California is currently the home of the nation's largest LGBTQ+ population.

Supporters of the proposition believe the removal of the language in the state constitution would be guaranteed protection against any future attacks on a freedom that is already recognized by the Supreme Court.

Gov. Gavin Newsom is an outspoken supporter of the proposition. Newsom grabbed national attention in 2004 during his tenure as Mayor of San Francisco when he issued marriage licenses to same sex couples, defying a federal ban on gay marriage.

"Same sex marriage is the law of the land and Prop. 8 has no place in our constitution. It's time that our laws affirm marriage equality regardless of who you are or who you love. California stands with the LGBTQ+ community and their right to live freely."



Assemblymember Evan Low, who is part of the team who presented the amendment is on record stating: "California is ready for love, and these protections will protect against any future attempts to restrict marriage rights for same-sex and interracial couples."

Opponents the of proposition argue that Prop 3 is the beginning of a "slippery slope" that could serve as a precedent for other types of non-traditional unions, endangering youth, families and society in general. They also lean on Christian religious text that states marriage is a union between a man and a woman.

Jonathan Keller, president of California Family Council is on record stating: "In a society like ours, you never can count on what people are willing to do for legal and financial and political reasons. And ACA 3, again, eliminates

any of those safeguards, and it opens up Pandora's Box. You could have siblings getting married. You could have nephews and nieces marrying uncles and aunts. You could have, potentially even mothers and fathers marrying each other, or mothers and children, or fathers and children marrying each other."

A "yes" vote supports this constitutional amendment to:

 repeal Proposition 8 (2008), which defined marriage as a union between one man and one woman,

• declare that a "right to marry is a fundamental right" in the California Constitution.

A "no" vote opposes this constitutional amendment, thus keeping Proposition 8 (2008), which defined marriage as a union between one man and one woman, in the California Constitution. However, there would be no change to who can currently get married under current Califor-

Seven Tips to Prepare You and Your Family for an Earthquake

This year's International ShakeOut Day was Oct. 17, when millions of people worldwide participated in earthquake drills at work, school or home. October also marks the 35th anniversary of the 1989 Loma Prieta earthquake, which devastated the Bay Area. That 6.9 magnitude shock was responsible for 63 deaths and nearly 4,000 injuries.

In the aftermath of disastrous storms on the East Coast and with wildfires still raging here in the West. Listos California, the state's disaster preparedness program, partnered with Ethnic Media Services and California Black Media in partnership to provide vital information to help Californians be prepared in the event of an earthquake.

"Preparing can be about securing your space, having an emergency plan, minimizing your hardship after the fact by having important documents organized and in place," said Amy Palmer, Deputy Director of Crisis

Communications and Public Affairs at the California Governor's Office of Emergency Services (Cal OES).

While earthquakes remain unpredictable, within the next 30 years, scientists predict there is a 60% chance of a 6.7 magnitude quake hitting the Los Angeles region and a 72% chance for the San Francisco Bay region.

The experts say there are seven key safety steps to take to make sure you and your family are prepared for an earthquake:

- Secure your space by identifying hazards and securing movable items.
- Plan to be safe by creating an emergency plan.
- Organize emergency supplies in convenient loca-
- Minimize financial hardship by considering insurance and organizing important documents.
- Drop, Cover and Hold On when shaking begins.
- Improve Safety after earthquakes by evacuating if necessary or helping oth-



"We've had a number of quakes this year where our system of statewide sensors is giving people a significant number of seconds before the shaking starts," said Palmer. "The key for everyone in California is to make sure that you know the phrase: 'drop, cover, and hold on' so that you can take action when you get an alert on your phone, or you feel the very first indications of

To further educate and prepare Californians for earthquakes, Cal OES hosted a tour focused on providing life-saving earthquake preparedness tips including a simulator that can demonstrate the power of up to a 7.0 magnitude quake.

"You need to take action upon feeling shaking or receiving an earthquake early warning alert and that means truly drop, cover, hold on," said Jose Lara, Chief of the Seismic Hazards Branch at Cal OES. "We really encourage you to practice that on your own with your all types of setmuscle memory when shak-

to stay safe." There are also several 'myths' about earthquake safe measure during an earthquake. This is NOT a safe measure due to modern building codes that have strengthened other areas in homes and commercial

buildings. Another myth is that running outside is safer during an earthquake. Due to the danger of falling objects that could strike you on the way out, running outside is not encouraged.

"I think that is the human instinct to get out from a building that you may think is collapsing. But the scientists would say, don't run outside, stay where you are, drop, cover and hold on," said Palmer.

If you find yourself driving during an earthquake, best practice is to pull over safely if you can and wait out the shaking inside of your vehicle while looking out for debris falling onto roadways in mountainous areas.

The MyShake App is another pivotal tool in the state's effort to prepare individuals for an earthquake. The app connects users with the Earthquake Early Warning System designed to give residents warnings seconds before shaking starts.

Some individuals receive alerts up to 20 seconds before shaking begins.

The Centers for Medicare and Medicaid Services (CMS) approved medical coverage for two new categories of interventions under state law in partnership with tribal partners. The first intervention will be provided by traditional healers using methods such as spiritual ceremonies, music therapy and herbal remedies. The second intervention works with natural helpers offering navigational support, psychological skill building, self-management and trauma support.

Tyler Sadwith, California State Medicaid Director, said Indigenous people, "now have access to culturally based traditional healing practices through Medi-Cal, marking a historic step toward health equity and honoring the rich traditions of our diverse Native communities.'

A study by the National Council of Urban Indian

Health showed that culturally centered approaches help enhance engagement and recovery outcomes.

Black and Latino Men Lag in Developmental **Education, Study Reveals**

Black and Latino men have the lowest educational attainment in the state, according to a report on developmental education reform by the Public Policy Institute of California (PPIC). Recent state data shows that only 13% of Latino and 16% of Black men between the ages of 22 and 27 have at least a bachelor's degree, according to the report.

The level of educational attainment of Black and Latino women is nearly double that of their male counterparts.

When it comes to college enrollment and completion, "persistence may be the biggest challenge for Latino and Black men," with more than half of them leaving college without a degree or transferring.

The State Legislature

implemented Assembly Bill 705, a law that mandated reforms in developmental education. The reforms allowed historically underrepresented students such as Black and Latino Men to use community colleges as a primary gateway to higher education. The data also revealed that Black and Latino men lag in educational attainment compared to White and Asian students.

"The implications of the growing racial gap in bachelor's degree attainment are significant, considering that a growing share of California's future labor force will come from these groups," the report stated regarding the future contributions of Black and Latino men.

In California, community colleges are the primary access point to higher education for Black and Latino students. Most underrepresented students transfer to a four-year institution to attain a bachelor's degree. However, state data shows that transfer rates remain low among Black and Latino male students, and few students succeed in their goal to transfer and pursue a bache-

lor's degree. Despite the low college graduation rates among Black and Latino students, AB705 has helped reform developmental education. The study recommended that institutions of higher learning create and implement initiatives that help connect students to academic and student services, including resources that cultivate a broader sense of belonging for men of color.

Conservative Group Targets LAUSD Program for Black Students

A conservative group in Virginia filed a federal civil rights complaint against the Los Angeles Unified School District, demanding that it end racial preferences in a program aimed at helping low-performing Black stu-

Supporters of the Black Student Achievement Plan have condemned this political move and insist that the program to be preserved in

its original form.

However, under pressure, the LAUSD has decided to overhaul the \$120 million academic program for Black students by removing race as a factor that determines which children will get help in public schools.

The Virginia-based group, Parents Defending Education, wants to overhaul the program, alleging that it violates the Constitution and the Civil Rights Act of 1964 by providing additional education services based on a student's race. The group filed the complaint in July 2023, arguing that its mission is to oppose "destructive practices" in schools regarding policies related to race, sexual orientation and gender identity.

"The Los Angeles Unified School District is offering race-based programming for some students that is not open to all," stated the group in an online post.

However, the U.S. Department of Education Office for Civil Rights dismissed the complaint on

July 11. The department stated that that the LAUSD revised the criteria for the program from being centered on race to basing it on achievement, school environment survey, and absenteeism.

Supporters of the academic program, such as Ebony Batiste, a teacher at 74th Street Elementary School in South L.A., argued that the program is a form of restorative justice.

"There's a lot of historical and systemic inequities that, if we're not going to address them, Black children are going to continue to fail," said Batiste to the LA. Times "Sometimes I feel like every time we try, our hands are tied behind our back, and we're not being allowed to help the children that need help."

Following the dismissal of the complaint, the LAUSD intends to continue working with Black students and support other students with similar academneeds under ic revamped program.



Panel Discussion Highlights Power of Black Women in Politics at "Respect My Crown" Screening

At the recent screening of "Respect My Crown: The Rise of African American Women in California

Politics," an engaging panel discussion unfolded, spotlighting the untold stories of Black women who have shaped the state's political landscape.

The event, held at the crowd eager to hear from

historic Wilshire Ebell Theatre, was co-hosted by the California Black Women's Collective Empowerment Institute and The Ebell of Los Angeles, drawing a

the filmmakers and political leaders featured in the documentary.

The panel, moderated by Kellie Todd Griffin, President and CEO of the California Black Women's Collective Empowerment Institute, featured Producer Alisa Covington and Producer/Director Pamela Bright-Moon. They were joined by Los Angeles County Supervisor Holly Mitchell, who appears in the film. The discussion centered on the critical role Black women have played in California politics, their challenges, and the importance of mentorship and

community support. Pamela Bright-Moon explained the inspiration behind the documentary, stating, "These stories have not been told, particularly about Black women and what it took to get them into office. We wanted to highlight the sacrifices and determination of these women who not only broke barriers but continue to uplift others as they navigate the political land-

scape." Mitchell, whose journey in public service is featured in the film, emphasized the significance of Black women's presence in

political spaces. "If you are not in the room, your voice is not heard," Mitchell said, recalling her own experiences as a trailblazer in the California State Legislature. She highlighted the critical need for Black women to occupy leadership roles, ensuring that policies reflect the needs of the communities they rep-

"We could never allow

ourselves to be absent from these spaces again," she added, noting how the absence of Black women in the legislature had a direct impact on policymaking.

Mitchell also touched on the importance of mentorship in her career, saying, "I am a beneficiary of Black female mentorship. These women were the firsts, and they pulled me into rooms where I could learn and grow." Her reflections underscored the documentary's theme of sisterhood and the importance of lifting each other up.

The panelists also discussed the historical context of the documentary, which chronicles 170 years of struggle by African American women in California for political representation. Covington pointed out that California was not always seen as a progressive state.

"It was a very conservative state with strict laws and redlining," she said, adding that the women featured in the documentary fought against these barri-

ers to create pathways for themselves and others.

Bright-Moon highlighted the ongoing efforts to preserve these stories for future generations. "We are in conversations to ensure that these interviews and stories are archived in the California archives and

state libraries," she said. "It's important that these women's voices live on, inspiring young people to step into leadership

As the event concluded, the conversation turned toward the future of the documentary. "Respect My Crown" is set to make its mark at the 6th Annual Micheaux Film Festival, held at the Culver Theater in Culver City from October 21-27. The film's selection for the prestigious festival marks an important milestone in amplifying the voices of Black women leaders in California.

The Micheaux Film Festival will feature a diverse lineup of over 300 projects, showcasing both in-person and online. As the festival celebrates its sixth year, "Respect My Crown" promises to continue inspiring audiences and shining a light on the powerful contributions of African American women in politics.



Shawn Jones-Murray: Dancing Through Life

Forget

counseling, Shawn Jones-Murray lets his feet do the talking. Born in Minneapolis and raised

in Chicago, he grew up in a family where dance was not just a hobby, it was a way to end arguments and keep the peace. When the music dropped, the bickering stopped, and Shawn

learned early on that movement speaks louder than words ever could.

"Dance is a conversation, it's a love language, it's therapy," Shawn explains, clearly not here for your average twostep. What started as a kid mimicking music video moves turned into a way for him to process life's wild rollercoaster, from joy to rage. Dance became more than just steps, but words in movement.

As a dance teacher, one of Shawn's first gigs was at Let's Dance Studio in North Dakota. Eventually, his passion led him to Los Angeles, where he aimed to turn that love into a full-blown career. But L.A. isn't easy, it is packed with dreamers, and Shawn found himself facing a familiar enemy: self-doubt. 'Sometimes I forget who I am,' he admits. Even the most talented among us have those 'what am I doing here?' moments.

Shawn's ultimate goal is to book a major music video or tour; an opportunity he believes would be truly life changing. "That would just build my confidence," he admits, echoing the sentiments of many in his position. People around him constantly tell him he is a star, but that belief is something he is still working on fully embracing. At home, he is dancing freely, telling stories with his body, feeling free. But the moment he steps into a class, something shifts.

"I get so caught up in perfecting the choreography, I forget who I am," Shawn says. Being booked for something major is validation and trust. "I feel like I would walk into rooms different, with my head held higher," he shares. It would mean a nice paycheck and a feeling of finally arriving and belonging.

Despite any lingering doubts, dance remains Shawn's greatest strength. Whether teaching jazz funk to teenagers or engaging in spontaneous sessions with friends, dance is where his passion truly lies. His journey of self-discovery, however, is still unfolding.

"For me, I feel like I am someone who is just finding out who I am as an artist,' he reflects, acknowledging the evolving nature of his identity. Shawn resists being confined by labels or defined by a single role.

"I wanted to be a choreographer, a rapper, and then I wanted to sing," he says with a laugh, illustrating his belief that creative boundaries simply do not apply to him. Instead, he absorbs inspiration from the world around him and expresses it in whatever form feels most authentic. For Shawn, labels irrelevant; artistic expression knows no limits.

In the end, Shawn's advice is both practical and powerful: 'Believe in yourself more than the next person believes in you.' For him, it all starts with the little thingsthe discipline of waking up early, making your bed, and tackling those small, everyday tasks.

"It's the little things that build the confidence within yourself and the discipline within yourself," he says. Those small habits create the



foundation for bigger achievements.

And when it comes to growth, Shawn insists, "Do the things you don't want to do. Do not get comfortable. Make yourself very, very uncomfortable." Whether it's showing up to the toughest classes or mastering the basics, he believes that embracing the uncomfortable is where real progress happens. As Shawn puts it, "Those hard classes are where you're going to grow."



Haji Malcolm, Palestine and the Meaning of Martyrs: Defiant of Death, Unalterably Dedicated to Life

The fast-paced, fierce and falsehood generating times in which we live and struggle leaves us precious little time to relax and reflect deeply on what's happening and to be hoped for in the world. And such reflection is vitally important as we continue to struggle to stop the Israeli genocidal campaign in Palestine; end the awesome suffering of the Palestinian people; bring the Palestinian and Israeli hostages/prisoners home; end the occupation; renew and increase the urgently needed aid; rebuild the country of Palestine; and help achieve a Palestinian state for the Palestinian people that is free, sovereign and secure.

And this need for reflection is also true regarding the Palestinian people's incredible resilience and inalienable right to resistance, distorted and denied by the media's masking and marketing Israel's savagery as selfdefense, and White peoples claimed racist right to do as they please with the different and vulnerable.

And I seek to bring again this critical issue in the immediate arc of our moral vision, as our ethical tradition would have us do, as Israel and its co-imperialists do an early man dance over the assassination and martyrdom of numerous Palestinian leaders, intellectuals, journalists, doctors et al and the people as a whole and moves to repeat this in Lebanon. Yet everyone, including Israelis in more rational moments, knows this will not break the will to be free of the Palestinian people and their resistance movement, and that eventually and inevitably Palestine and the Palestinian people will be free.


And I want to bring Haji Malcolm in this conversation who stood in solidarity with the Palestine Liberation Organization and the Palestinian people in the early 1960s and taught us lessons of solidarity in struggle and self-sacrifice for freedom and justice in our lives and the world.

In the midst of the Black Freedom Movement of the 1960s, Haji Malcolm defiantly declared that "It is a time for martyrs, now." And by this he meant it was time for all those who want freedom and are willing to defy imprisonment and death and to unalterably dedicate themselves to life, their people and their liberation struggle, to stand up and offer their life and death in irreversible active commitment.

I thought of Haji Malcolm as the number of Palestinian people continue to grow by the tens of thousands in Israel's genocidal campaign against them and how the Palestinian people call every person killed, even babies, murdered in this cruel and inhuman total war against them, martyrs. For in Islam, martyrs are not only those who die in righteous struggle for liberation, justice and other good in the world, but also those who die undeserved and horrible deaths, like babies asphyxiated in disconnected incubators, children deliberately shot in the head, and blown to bits and burned alive in indiscriminate bombing, and all tens of thousands unarmed and innocent civilians mangled and murdered in this savage, sadistic and total war against the Palestinian peo-

But as we always see and say, where there is oppression, there is also resistance. And there is righteous and relentless resistance among the Palestinian people, who daily and in countless ways reaffirm their radical refusal to be defeated. I speak here not only of the people as a whole, but especially of those who chose to be martyrs, to offer their life and their death in the liberation struggle of their people. Indeed, these martyrs know with Haji Malcolm that in the virulent, victimizing and pathological context of a demonstration of their love oppression, freedom is not free.

And as Nana Harriet Tubman said with struggle

heart and weapon in her hand, "we must go free or die." For her, both freedom and offering our lives and death to achieve it were a right and responsibility, and we must always remember freedom comes with high costs and heavy casualties. Or as she taught, "freedom ain't bought with dust."

Thus, Haji Malcolm, a martyr, himself, and Nana Harriet, who daily risked her life and a horrible death promised by the enslavers for the liberation of our people, and the Palestinian resistance which cannot be defeated, all demonstrate a resolute defiance of death and an unalterable dedication to life.

Indeed, the resistance movement chooses the selfsacrifice of martyrdom, not because they want to die, but in defiance of the threat of death by the enemy oppressor, and because it is of life, their love of their people, their commitment to the liberation struggle and a radical refusal to be defeated or to be deprived of the right to freedom and a life of dignity, possibility and promise. And as Haji Malcolm taught, it is to affirm and secure "our right on this earth...to be a human being, to be respected as a human being, to be given the rights of a human being...on this earth, in this day..."

And for Haji Malcolm, after life, freedom is the most fundamental and inalienable right. In fact, he argues that "Freedom is essential to life itself. Freedom is essential to the development of the human being. If we don't have freedom, we can never expect justice and equality. Only after we have freedom do justice and equality become a reality." Moreover, he rightly and repeatedly contends that a just and real peace cannot be separated from the right and practice

of freedom. He states, "You can't separate peace from freedom, because no one can be at peace unless he has his freedom." It is this essentiality, indeed, indispensability of freedom to a good and meaningful life that morally compels freedom fighters to offer their life and death to achieve and secure it.

Haji Malcolm, then, is a martyr, a shahid, one who bears witness to the world in service to his faith, his people and their righteous and relentless liberation struggle. Here, to bear witness is not only to speak the truth, but also, to serve in life and death as evidence of what is real and right, true, good and beautiful. Thus, Haji Malcolm tells us in his Autobiography that he hoped that his "life's account, read objectively. . .might prove to be a testimony of some social value."

And as I have stated elsewhere, "surely, it is a testimony of great social value. Indeed, it is both testimony and testament, righteous witness and a sacred will, awesome evidence and instruction on how we can live our lives, and if need be, give them up with the unwavering commitment and uncompromising courage Haji Malcolm modelled and mirrored for us."

Haji Malcolm speaks a liberating truth to the people and a courageous critical condemnatory and uncompromising truth to the oppressor, having "pledged on (his) knees to Allah to tell the white man about his crimes and the Black man (and woman) the true teachings" of Islam as he knew and continued to learn them. And he taught this truth as he said, "without hesitation or fear."

Seba Malcolm in speaking truth to power sees himself not only as a self-conscious severe critic of society, but also understands and exposes the American oppressive society as selfcondemning and anti-itself, generating its own selfdestruction by its oppressive, unjust and evil ways.

The essential point is that he is compelled to speak the truth of America's oppression of Black people and the Dark peoples of the world.

Haji Malcolm suggests at the end of his autobiography that in spite of the obvious threat to his life for teaching and standing up for truth and justice, he is compelled to continue. Thus, he states, "if I can die, having brought any light, having exposed any meaningful truth that will help . . .," to end racism and bring freedom and justice, then, "all praise is due to Allah, only the mistakes are mine."

It is this morality of selfsacrifice, the willingness to give up one's freedom and one's life in the cause of the liberation of one's people and in the cause of a better society and world is at the heart of Haji Malcolm's liberation ethics. And it is the upward and forward way of the freedom fighter and resistance movement which opposes the oppressor, affirms the people and aspires in struggle for a new world and good ways for every person and people. Absalom attempted a coup to take over the kingdom. It was unsuccessful. David led a very challenging life. One jealous revengeful person was Saul, the first king of Israel. His jealousy might be termed close to insane jealousy. He persisted in pursuing David to take his life.

These lessons learned from the scriptures offer valuable ways to view life and profit from the ancient wisdom of the prophets which can help us today through life's difficulties. These things might have happened hundreds of years ago; however, their teachings are the wisdom over the ages that we can learn from.

One act can happen, but the results and consequences of the act usually extend far beyond and cannot be counted.

South Carolina is preparing to put up its first individual statue for an African American on its Statehouse lawn, honoring a man who put on Confederate clothes in order to steal a slaveholder's ship and sail his family and a dozen others to freedom during the Civil War.

But Robert Smalls isn't just being honored for his audacious escape. He spent a decade in the U.S. House, helped rewrite South Carolina's constitution to allow Black men equality after the Civil War and then put up a valiant but doomed fight when racists returned to power and eliminated nearly all of the gains Smalls fought for.

Rep. Jermaine Johnson can't wait to bring his children to the Statehouse to finally see someone who is Black like them being honored.

"The man has done so many great things, it's just a travesty he has not been honored until now. Heck, it's also a travesty there isn't some big Hollywood movie out there about his life," said Johnson, a Democrat from a district just a few miles from the Statehouse.

The idea for a statue to Smalls has been percolating for years. But there was always quiet opposition preventing a bill from getting a hearing. That changed in 2024 as the proposal made it unanimously through the state House and Senate on the back of Republican Rep. Brandon Cox of Goose Creek.

"South Carolina is a great state. We've got a lot of history, good and bad. This is our good history," Cox said.

What will the Robert Smalls memorial look like?

The bill created a special committee that has until Jan. 15 to come up with a design, a location on the Statehouse lawn and the money to pay for whatever memorial they choose.

But supporters face a challenging question: What best honors Smalls?

If it's just one statue, is it best to honor the steelnerved ship pilot who waited for all the white crew to leave, then mimicked hand signals and whistle toots to get through Confederate checkpoints, while hoping Confederate soldiers didn't notice a Black man under the hat in the pale moonlight in May 1862?

Or would a more fitting tribute to Smalls be to recognize the statesman who served in the South Carolina House and Senate and the U.S. House after the Civil War? Smalls bought his master's house in Beaufort in part with money made for turning the Confederate ship over to Union forces, then allowed the man's penniless wife to live there when she was widowed.


Or is the elder Smalls who fought for education for all and to keep the gains African Americans made during the Civil War the man most worth publicly memorializing? Smalls would see a new constitution in 1895 wipe out African Americans' right to vote. He was fired from his federal customs collector job in 1913 when then President Woodrow Wilson purged a large number of Black men out of government jobs.

Or would it be best to combine them all in some way? That's how Republican Rep. Chip Campsen, an occasional ship pilot himself, sees honoring one of his favorite South Carolinians.



Some supporters have suggested Smalls' statue could stand nearby and be taller and more prominent than Tillman's to give Smalls a triumph some 130 years in the making.

Once design and location are determined, organizers hope raising the money gets easier with a concept in mind.

"The best way to sum up Robert Smalls' life is it was a fight for freedom as a slave, as a pilot and as a statesman," Campsen said.

Robert Smalls' monumental life

Robert Smalls was born in 1839 in Beaufort and died in 1915 in his hometown a free, but somewhat forgotten man who lived a life unimaginable to a woman holding her son born into slavery. Supporters now have a chance to make sure he never fades into obscurity.

"Robert Smalls writes a new future for this county that in the moment no one can see is happening," said Chris Barr, the Chief of Interpretation for the Reconstruction Era National Historic Park in Beaufort as he stood beside the a bust of Smalls near his grave in his hometown.

Driving a Confederate boat to freedom is what captures the most attention in that remarkable life, Barr said.

"If you're an enslaved person working on one of these boats around the Charleston Harbor like Robert Smalls, you've got the tools, you've got the talent, you've got the boat and you know how to drive it," Barr said "And you can literally see freedom floating in the form of the United States Navy just a few miles offshore. All you need is an opportunity."

Black Small Business Owners Urged to Seize Opportunities from Major Sporting Events in L.A.

Los Angeles is on the verge of hosting a series of world-class sporting events, including the 2026 FIFA World Cup and the 2028 Olympic and Paralympic Games, which present significant opportunities for local businesses, especially Black-owned small businesses.

In a major announcement at the city's first-ever Sports and Entertainment Summit, Mayor Karen Bass introduced ProcureLA, a new program designed to help small businesses prepare for and secure contracts associated with these mega-events.

alongside Speaking entertainment industry powerhouse Jessica Alba and BMO Vice Chairman Eric Smith at the Los Angeles Convention Center, Mayor Bass emphasized the importance of ensuring that these events benefit Angelenos, particularly through business opportunities that can drive long-term economic growth.

Through ProcureLA, businesses will receive comprehensive assistance, including one-on-one consultation, training in proposal development, certification assistance, and access to procurement portals to ensure they are "contract ready" for the millions of dollars in opportunities these events will generate.

"This city has become too expensive to live in, and if we want to close the economic gap, we need to strengthen our small business sector," said Bass.

"Small businesses are where the majority of Angelenos work. My goal is to make sure that all of you are successful and prepared to compete for these opportunities."

The upcoming events like the 2026 FIFA World Cup, the 2027 U.S. Open Golf Tournament, and the Olympics—are 2028 expected to inject billions into the local economy. However, as Mayor Bass pointed out, many contracts historically go to businesses outside the region.

This time, through ProcureLA and targeted initiatives, the focus is on keeping the money within Los Angeles by equipping local and diverse businesses with the tools they need to secure contracts.

We know that a lot of the businesses we work with aren't necessarily from Los Angeles or even California," Bass said.

"I want to change that. We have to push forward to make sure that small and local businesses are at the

forefront of these opportunities."

Jessica Alba, actress, producer, and member of the LA28 Board of Directors, echoed the mayor's sentiments, urging local entrepreneurs to stay focused, proactive and keep their eyes on the prize. "One of the models I live by, is I am a risk taker. I consider myself a constructive disrupter because sometimes you disrupt," Bass explained.

For Black-owned businesses in Los Angeles, this influx of sporting events offers an unprecedented opportunity to grow. The ProcureLA program provides vital resources such as access to city contracts and training on how to navigate procurement processesareas that can be challenging for businesses unfamiliar with the intricacies of government contracting.

Erikk Aldridge, Vice President of Impact for LA28, emphasized the importance of readiness, stating, "We've identified 10 key spending categories related to the games—operations, marketing, communications, facilities, and event management, among others. Local and diverse businesses must be prepared to compete in these areas." He stressed that the majority of contract spending will occur in the two years leading up to the 2028 Olympics, making early preparation crucial.

Erikk Aldridge added further motivation, stating, "We've only got one shot to get this right. We need to make sure our communication and preparation are strong. The majority of spending related to the

small businesses secure over \$18 million in support since Mayor Bass took office. The goal is to build on this momentum, ensuring that Black-owned businesses benefit from both the shortand long-term opportunities presented by the city's upcoming major events.

The summit featured multiple panels, including a ProcureLA! session, where city leaders provided actionable insights into becoming "contract ready." Panelists such as Rosa Penaloza from the L.A. City Economic & Workforce Development Department and John Reamer, grams like ProcureLA, they can ensure their companies are positioned for success when contract bids are released. Additionally, with support from communitybased organizations like the Pacific Asian Consortium in Employment (PACE) and the LA Sports & Entertainment Commission, business owners can receive the guidance and mentorship needed to navigate this complex space.

Mayor Bass closed the summit by urging the local business community to stay engaged and proactive. "We must fight to make sure that opportunities are



For the first time since 2020, the Los Angeles Dodgers will compete in the World Series. The Boys in

Blue secured a 10-5 victory over the New York Mets in Game Six of the NLCS. The Dodgers earned their 25th national league pennant in franchise history.

themselves how tough they are. When you get in a position that we were in, against the division rivals," said Dodgers head coach Dave Roberts. "That's what got us over, talking [NLDS] and also ... allowed us to finish [the Mets] off in six games."

Although the Mets secured a 1-0 lead at the top of the first inning, NLCS MVP Tommy Edman hit a 2RBI double when the Dodgers were at bat. The Boys in Blue took a commanding lead in the third inning. Both Edman and Will Smith slugged tworun home runs, putting the Dodgers up 6-1.

A two-run homer by Mark Vientos in the fourth put the Mets within three runs. An RBI single by Shohei Ohtani in the sixth

nudged the Dodgers to a 7-3 lead.

The runs kept coming for the Dodgers in the eighth with Mookie Betts, Teoscar Hernández, and Kiké Hernández scoring on hits.

"We had really good at bats throughout the series our whole line up was really good," Edman said. "Any number of guys who could have won MVP."

The Dodgers will host the ALCS champion New York Yankees for Game One on October 25 at 5:08 p.m. This will be the 12th time the two franchises have met in the Fall Classic, the most in MLB history.

The World Series rivalry between the two legendary clubs dates back to when the Dodgers were in Brooklyn. Their first meeting was in 1941, six years before Jackie Robinson broke the color barrier.

While the Dodgers have a 3-8 record against the Yankees in World Series titles, the Dodgers were victorious in their last meeting, defeating the Yankees in six games back in 1981.

The Dodgers flaunt designated hitter Ohtani who made 12 runs and 10 RBI during the postseason. They also have Betts, who had a .289 batting average and 75 RBI during the 2024 season. Teoscar is second on the team during this season in several categories, including runs (84), hits (160), and RBI (99).

The face of the Bronx Bombers is their 32 overall pick in the 2013 MLB Draft: Aaron Judge. He made 58 home runs and 144 RBI during this season. ALCS MVP Giancarlo Stanton had a batting average of .294 and had 11 RBI during this postseason. In his first season with the Yankees, Juan Soto has a .333

batting average and 11 hits.

The new chapter of this historic showdown is bound to be a showcase of power hitters and exciting plays bound to thrill baseball fans.

"The world kinda wants this, it'll be fun, I'm sure it's gonna be filled with emotions," Betts said. "This is the goal, it's the reason why we play, to win a World Series."
