Blake II and his wife, DeAndra

succeed his parents, Bishop Charles E. Blake, Sr. and Lady Mae L. Blake, as the spiritual leaders of the huge congregation, which exceeds 25,000 During the members. Bishop's 53-years tenure, West Angeles expanded to operate more than 80 community programs and become one of the largest affordable housing developers in South L.A.

In recognition of the ministerial achievements Blake Sr. simultaneously welcoming new pastor, the membership hosted several events during its Honor and Celebration Weekend. Activities kicked-off on Oct. 21, with a Tribute Concert saluting the legacy

of Bishop Blake.

The program, under the direction of Dr. Judith McAllister, featured leading gospel artists including Donnie McClurkin, Dorinda Clark Cole, Smokie Norful and Doc Powell. Also performing were David Daughtry, Jesse Campbell and the West Angeles Mass



Theatre Director Sheldon Epps' New Book Celebrates and Encourages Self-Direction


Bold choices. Strong choices. Brave choices. These, according to Sheldon Epps, are essential to the alchemical creation of great theatre. A credible source to say the least, Epps has found, over the course of forty plus illustrious years as a director in the field, that this trinity has not only guided him in crafting the kinds of productions that changed the artistic and fiscal face of a once heralded theatre fallen from grace, but it has also been key to the navigation of his own career as a Black man in a space occupied predominantly by others who would often aim to box him in.


The boldness, strength and bravery of the Black Lives Matter movement at the dawn of the pandemic inspired him—and the quarantine afforded him the contemplative space—to chronicle his auspicious, if occasionally turbulent, ascension in a new book, entitled "MY OWN DIRECTIONS: A Black Man's Journey in the American Theatre."

"In 2020, when racial issues that I actually have been talking about for many, many years sort of erupted in the American theater...it just seemed like the propitious time for me to tell my story and some of the challenges that I have faced as a Black artistic director," Epps recalled. "Some of the triumphs as well, but

certainly the challenges and frustrations."

Among these is the painful memory of a brief period when the Pasadena





Sheldon Epps was Artistic Director of the Pasadena Playhouse from 1997 to 2017. As such, he was one of the first Black artistic directors in American regional theatre.

Playhouse (the theatre Epps revitalized and led as artistic director for twenty years) had to shut down to resolve some longstanding financial issues that predated his arrival. As diversity was one of his hallmarks, a rumor circulated that the shutdown was due to him forcing his Black agenda on the community there, bringing in Black playwrights and artists that the theatre did not want.

"There's kind of no way to answer it without sounding defensive," Epps reflected. "Plus, we were in a process in which I wasn't supposed to say anything knowing how untrue they were and not being able to respond."

However, this fueled Epps' fire. Reasoning that the best way to prove his case was to get the theatre reopened promptly, he and his team fought to raise the necessary funds and reopened faster than anyone thought possible at the time.

Subsequently, a onewoman show starring Leslie Uggams, a one-man show featuring Ed Asner as FDR, a production of Pearl Cleage's "Blues for an Alabama Sky," and a musical adaptation of "Oliver Twist" directed by Debbie Allen each met with terrific reception, and the Pasadena Playhouse, under Epps' direction, was again off to the races, with new grants and favorable reviews. Epps reflected, "It was hard to argue with success."

This is but one of his many victories. Epps has been honored with numerous awards, including Tony Award nominations for conceiving and directing the Duke Ellington-inspired musical "Play On", as well as the musical revue "Blues in the Night," which went to London following its run on Broadway.


Epps has enjoyed impactful collaborations with acclaimed actors and actresses such as Phylicia Rashad, Diahann Carroll, Orlando Jones, and Robin Givens. He has seen tremendous success with a string of box office pleasers at Pasadena Playhouse, including August Wilson's "Fences" starring Angela Bassett, Laurence Fishburne and Wendell Pierce.

Never one to balk at a challenge (as a young actor, he chose for his directorial debut, in a modest 70-seat theatre, Shakespeare's "A Midsummer Night's Dream"), Epps upped the ante for himself, spending many years juggling his position at Pasadena Playhouse directing episodic television for such popular series as "Girlfriends," "Friends" and "Frasier." In these realms, his knack for working well with actors

was lauded, a gift cultivated through years in the theatre.

Even later into his tenure at the Pasadena Playhouse, Epps' ambitions would find him venturing out into bold, uncharted territory, directing a particularly tense adaptation of Reginald Rose's "Twelve Angry Men," with a cast that included six white actors and six Black.

"I am very, very proud of being a Black man, but I never wanted to be classified and/or restricted to being a Black director," Epps emphasized. "I want-

ed the freedom to cover any territory that I wanted to cover. And at the time that I began my freelancing career, once I came to Pasadena Playhouse, the desire to do that was kind of revolutionary. It often took my saying no to things. It took my explaining that to people. It took being accused of being

arrogant and ambitious. It took fighting against being boxed in, boxed in by my color, rather than celebrated for it."


Celebrations came in due time and Epps' new book, which details the events shared here and many more, itself a celebration of the life of an artist operating on his own terms.

Epps has just recently wrapped his first feature film for BET, a holiday movie entitled "Christmas Party Crashers," which airs next month. He recently directed a new period play, "Miss Maude," for A.D. Players at the George Theatre in Houston, Texas. He is the Senior Artistic Advisor for the Ford Theatre in Washington, D.C., and more of his directorial work can be seen on the Netflix series, Upshaws."

Reflecting on breadth of experiences, he wishes to inspire others to approach their own pursuits with the same fire. "[For] people of color and artists of color in this country, there's always going to be people who say, 'no, you can't do that, no, you can't go that down that road. That's not possible for you.' And you just have to walk that road. Be ready to walk it. Have the talent and ability and passion, and follow your own directions, make your own journey."

Prop 1 Aims to Amend State Constitution to Protect Abortion Rights

California voters are being asked to decide on whether or not language in the California Constitution should be changed to explicitly ensure the right to reproductive health.

Proposition 1, proposed by Senate President Pro Tempore Toni Atkins (D-San Diego), amends the California constitution to prohibit the state from interfering with one's right to choose to have an abortion or refuse contraceptives.

The Reproductive Privacy Act passed in 2002 guarantees these protections, however Prop 1 supporters are concerned that the act could be interpreted in a way that would put them at risk of misinterpretation and new limitations could be placed on reproductive freedom.

If Prop 1 fails to pass, the constitution won't change and the Reproductive Privacy Act would continue to guarantee one's right to an abortion up to the point of viability.

"We are on the precipice of a U.S. Supreme Court decision that could topple Roe v. Wade and erode the right to abortion that was secured nearly 50 years ago -- altering reproas we know it," said Atkins in a statement made before the Supreme Court decided in Dobbs v. Jackson Women's Health Organization that the Constitution

does not confer the right to abortion, overturning Roe v Wade and a half-century of legal precedent.

According to Akins, "[Proposition 1] would make it undeniably clear that in California, abortion and contraception are health care and are a private matter between a patient and their medical provider.

"I have seen what is at stake when people don't have access to abortion the real lives and real families that are at risk. In California, we are resolute in our determination to pro-

tions. California courts have interpreted the right to privacy so that the state can only restrict abortions when needed to meet certain state interests such as public health and safety. For example, California requires abortion providers to be licensed.

Abortions can only be performed on a viable fetus if the pregnancy puts the health or life of the person who is pregnant at risk. Under state law, a fetus is considered viable if the fetus likely would be able to survive outside of the

"The health system we have in the US isn't functioning well for Black and Brown communities. But it's a more nuanced discussion; there are a whole lot of other things that can go wrong than just death," she said.

"When we talk about maternal mortality, we

the 50,000 near misses, [the women of all races who had] serious pregnancy-related complications, like a hemorrhage, an infection, a c-section wound coming apart," McLemore continued. "We're not talking about people like Serena Williams and Beyonce who live, but had trauma. Black women are less likely to be believed by their healthcare providers, and they are undertreated and underdiagnosed."

Opponents of Prop 1 believe that it is unnecessary and written so broadly that it could face years of protracted court battles to clear up the language, costing the state millions of dollars in legal fees. They raise particular concern that the measure would override state regulations that now limit abortions after the point when a fetus is viable on its own outside of the womb, at about 24 weeks of pregnancy. These late-term abortions are currently only legal if the health or life of the mother is threatened.

Catherine Hadro, Media Relations Director for the No on Proposition 1 Campaign, spoke with California Black Media about the cost that could come from Prop 1.

"Everyone knows that abortion is and will remain legal in the state of California. The California Legislature has already set aside \$220 million to expand abortion access in the state of California. \$20 million of that is specifically to pay for women coming from out of state into California to get abortions. The California Legislature has said they expect it's going to cost an additional \$100 million dollars within the next 5 years to pay for women coming into California for abortions. This is only going to increase and cost California taxpayers even more if abortion is legalized up till the point of birth ... This is just another example of politicians throwing money at another problem

Gov. Gavin Newsom has begun airing ads supporting Prop 1 using at least \$2 million of his own campaign funds to pay for them.

California's Investments May Not Be Enough to Aid Youth Mental Health Care

In August, The Children's Partnership hosted a mental health panel centered around the voices of young girls and women of color. The session was organized as part of the organization's Youth of Color initiative.

"I had never been surrounded by a group of people with the same experiences and the same struggles regarding mental health, regarding being a person of color," said Samantha Giles.

teenager, is one of the Children's Partnership's youth panelists.

"I even got to go into a breakout room where we talked about how our parents don't necessarily recognize our mental health struggles and I never really talked with someone else my age about my personal experience and their personal experience," the teenager intimated.

Giles described the interactions she had with her peers as "eye opening."

That same month, Cali-Giles, a California fornia Gov. Gavin Newsom announced his "Master Plan for Kids' Mental Health," an initiative that pumps \$4.7 billion into the super-system providing mental health services to the state's youth.

the under-treated and oftenoverlooked challenges that youth like Giles are trying to overcome.

According to the California Health Care Foundation (CHCF), one in 14 children have experienced a mental or emotional disturbance that disrupts their day-to-day life.

Of the California adolescents who experienced major depressive episodes, 63.6 % did not receive treatment for those incidents.

Newsom touts California's response to the national mental health crisis over that of other states.

"As other states take away resources to support kids' mental health, California is doubling down with the most significant oversystem in state history," Newsom said. "We're investing billions of dollars to ensure every California child has better access to comprehensive mental health and substance abuse services."

Some notable organizations have praised the state's commitment to children's and young adults' mental health.

"The state has made some incredible and historic investments in children and youth mental health and well-being - both with the \$4 billion Children and Youth Behavioral Health Initiative and with the \$3 billion Community Schools Initiative," Angela M. Vázquez, Policy Director at the Children's Partnership, stated.

However, Vázquez raised concerns about many of these funds being onetime investments that might not fully address the needs of children of color.

Vázquez's concerns, which mirror those of several mental health advocates in communities of color, extend to Newsom's pledge to add 40,000 more mental health workers to Califor-

"Still, the reality is that the clinical workforce is and will likely remain for some time largely White and middle-class - not at all reflective of the diversity of our state's children," Vázquez stated.

"Peer support is an essential evidence-based strategy for young people's mental health that has the potential to build interest and foundational professional skills that lead to future opportunities for mental health career paths for more students of color."

Contributing to the state's youth mental health crisis are other factors like the COVID-19 pandemic, experts say.

According to research published by the Journal of Racial and Ethnic Health Disparities, the state of mental health among Black people worsened during the COVID-19 pandemic, with anxiety and depression being the main issues.

"These recent events have layered on additional psychological and emotional stress on children and youth of color, particularly Black youth," Vázquez stated "In considering what serves young people well, it is imperative that we address the systemic barriers that have contributed to historic mental health disparities in youth, and develop innovative strategies, leaving space for healing outside of and in tandem with the traditional mental health system."

The CHCF found that Black people had the hardest time amongst all other ethnic groups finding a doctor, especially a specialist.

In 2019, Black children in California were the most likely to experience serious emotional disturbances amongst children of all other racial groups, at a rate of nearly 8%.


These trends are not just color to connect and heal documented among today's Black children. African American adults are reported to have experienced more adverse childhood experiences that negatively impact their mental health more than any other ethnic group that self-reported, according to the CHCF.

In August, Newsom signed Assembly Bill (AB) 2508, authored by Assemblymember Sharon Quirk-Silva (D-Fullerton). The new state law, Newsom's office says, reimagines youth mental health services by strengthening care systems in schools and focusing on intervention and prevention instead of crisis care.

The governor says the legislation will "better define the role of school counselors." However, Vázquez has some reservations about that bill, too. She feels it does not fully address the mental health needs of all of the state's children.

"One thing that AB 2508 does not address is the urgent need for greater investments in California's youngest learners' mental health – children ages 0-5," Vázquez stated. "The state needs to invest significantly more resources in community-based infant and early childhood mental health services, such as early childhood mental health consultations - an evidencebased model that reduces the number of preschool suspensions and expulsions, an issue that has significant disproportionate impacts on young Black children."



As a young girl, Tamarra Crandall wanted to become a doctor, aspiring to help cure patients suffering from illnesses that cause so much pain and discomfort, especially among minority

populations. As fate would have it, Crandall didn't pursue a medical degree. But, as she will tell you, she pursued the next best thing, which was a career in nursing, and she has no regrets.

"The most rewarding aspect of being a nurse is delivering care to people in their most vulnerable moment," said Crandall, a registered nurse at Kaiser Permanente Southern California. "Being in the hospital is very hard for people. Being there for them and advocating on their behalf for safe and equitable care is very rewarding to me. I wouldn't trade it for anything."

Crandall, who African American, adds another reason for her pursuit of a nursing career is wanting to care for patients in the Black community, believing in the importance of diversity and equity. She wanted to also pursue nursing to represent the African American community in a profession in which only 6.7% are African American nurses, according to the American Association of Colleges of Nursing.

"Minority representation is extremely important," notes Crandall, who has a doctorate of nursing

force - especially in healthcare – is so critical because patients are more comfortable with people who look like them. Being African American, it's extremely important to me that our community is well-represented in the workforce. A very important part of nursing is cultural competence. You have to make sure you have representation for all communities, especially when you provide care to a

minority population." As a nurse, Crandall is aware of the severe shortage of registered nurses locally and across the nation. She encourages young Black women to study nursing, as well as other qualified candidates to enter the field that she describes as very fulfilling.

Jerry Spicer, regional chief nurse executive and vice president of patient care services for Kaiser Permanente Southern California and Hawaii, noted health care organizations are always looking to hire registered nurses due to a shortage. At Kaiser Permanente Southern California. open nursing positions fluctuate between 350 and 450 at any given time.

Because of the short supply of registered nurses, especially in specialty positions. Kaiser Permanente offers sign-on bonuses ranging from \$4,000 to \$6,000 for full-time positions, and \$2,000 to \$3,000 for part-time positions.

"Not only is being a nurse a noble profession, but it's also a good-paying job that's very satisfying," he said. "The need for registered nurses is very high, and health care organizations across-the-board are doing everything they can to attract candidates."

Although nursing involves hard work and can be challenging, Crandall notes the rewards outweigh the challenges associated with the profession.

"This is the best job I can think of," explained. "Nursing is so well-rounded. Nursing is also such a broad profession that allows for nurses to use their skills in various fields. The real joy of being a nurse is providing compassionate care and making a difference. Believe me when I say there are few jobs where you will truly make a difference in people's lives for the better. As a nurse, my relationship with my patients is what keeps me going."



Dr. Laura Farach, a pediatrician with Kaiser Permanente Southern California, notes although parents may feel more at ease having their children trick-or-treat this Halloween, there are important safety precautions they need to follow to

ally, she describes seven scary health hazards parents should know about to ensure families have a safe and Happy Halloween this

Food allergies

When it comes to candy, peanuts and other foods, it's always important to read labels and avoid treats without labels. For parents whose children have severe allergic reactions to certain foods, it's important to carry an epinephrine auto-injector if prescribed. According to the Centers for Disease Control and Prevention, food allergies account for

35% to 50% of all cases of severe, potentially lifethreatening allergic reactions that can occur within seconds or minutes of exposure to something you're allergic to, such as peanuts.

Hand injury

Pumpkin carving is a cherished Halloween tradition many families enjoy each year. However, pumpkin-related carving knife injuries can lead to nerve, tendon and artery injuries and they are preventable, Dr. Farach notes. Understanding the risks and being careful can save you and vour child a costly and traumatic visit to the emergency room. To avoid injuries, Dr. Farach encourages children to draw the pattern on the pumpkin, clean out the inside pulp and seeds with a spoon, but leave the knife work to mom and dad.

Fire hazards

What's a Halloween without decorating your home with spooky decorations and in many cases lit check the length of cos-

ornaments? However. Dr. Farach warns this can present some truly scary fire safety hazards. Lighting up your jack-o-lantern with glow sticks or electric candles is the safest option, she says. Caution should always be exercised if using a real candle, however. Some decorations are also very flammable, Dr. Farach notes. These include cornstalks, dried flowers, crepe paper and plastic banners. The top-5 causes of most Halloween fires include careless actions and electrical malfunctions, according to fire data tracked by FEMA.

Costumes

It's important for parents to ensure that their child's mask has large enough eve holes for them to see clearly, Dr. Farach says. Children should wear bright and reflective coson costumes, on which a child could choke. Also,

tumes to make sure they don't cause your child to

Face paint/Costume contact lenses

Before you apply makeup near your child's eyes, beware since it could contain harmful chemicals, according to the American Academy of Ophthalmology. If makeup is applied, it should be applied in small amounts to the arm of the person who will be wearing it. The appearance of a rash, redness, swelling or other signs of irritation could indicate an allergic reaction.

Additionally, the American Academy of Ophthalmology warns that wearing costume contact lenses on Halloween can be a real scream, the scare from nonprescription contact lenses can be all too real when chemical exposure or potenbeware of any small parts take place. As such, they should be avoided.

Pedestrian safety

Since trick-or-treating

can take place when it's dark, Dr. Fararch encourages parents to provide children with flashlights or glowsticks for lighting and greater visibility, which can be incorporated onto the costumes. Another option is sticking reflective arm bands or reflective tape to bags or costumes that can ensure your child can be seen. It's recommended that parents should review street safety ahead of time with their children.

COVID-19 safety

Last, but not least, although COVID-19 may not be on the minds of parents this Halloween, Dr. Farach encourages children to wear a mask as a part of their costumes, when possible, to maximize protection. Also, children should always wash their hands with soap upon returning tumes and parents should tially blinding infections from trick-or-treating. It's also important to only eat factory-wrapped treats and candy, as that is a safer practice.

Improving Community Health Outcomes Through Community Health Workers

Community health workers (CHWs), known in Latino communities as promotoras, are community members who provide health education and linkage to health services in their communities. CHWs deliver these services through a cultural lens, representative of their community. They help to bridge

the gap between the medical providers and communities suffering from poor health outcomes.

To provide a brief history of community health workers or promotoras, during the mid-20th century, promotoras in Latin America helped expand healthcare access to the poor. This model was replicated in the United States during the 1980s, focusing on the migrant farm working communities. Since

then, promotoras (community health workers) have provided health education and health services navigation to disadvantaged communities throughout the country.

They have provided health education and navigation to medical services for many needs, including, but not limited to, chronic disease, health maintenance, infectious diseases, and maternal health. These are many issues of concern

for disadvantaged communities in Los Angeles.

Over the past decade, many Los Angeles residents have experienced a series of health challenges that not only affect an individual's well-being, but also can place an avoidable strain on their families, friends, and communities. For example, Los Angeles residents are experiencing poor health outcomes in three categories: sexually transmitted diseases/infections, chronic health conditions, and substance use disorders. Leading up to 2020, Los Angeles-born infants experienced a significant increase in exposure to syphilis. Further, Los Angeles adult residents have experienced increased diagnoses of syphilis, chlamydia, and gonorrhea.

Concerning chronic disease, we have observed increased deaths due to diabetes, with obesity in 27.4% of the adult population in 2020. Also, teen obesity has increased from 13.2% in 2016 to 20.8% in 2022.

Finally, concerning substance abuse, opioid deaths increased from 3.51 per 100,000 residents in 2016 to 10.9 per 100,000 residents in 2022. Overall, drug overdose deaths have increased from 8.88% to 18.28% of all deaths in the same period.

in three ways: health education, preventative services or health maintenance, and linkage to emergency services. CHWs can use health education as the foundation for improving community health outcomes. Through health education, CHWs can build trust in communities, help families make healthier lifestyle choices, and increase awareness regarding crucial health topics such as the environmental impact on health.

Organizations such as SHIELDS for Families, which has been working to improve the health of infants and families in South Los Angeles for over 30 years, are important community resources. For example, the Iris Cantor UCLA Women's Health Center runs a California

For this program, the health center and their partner Worksite Wellness LA are training Latina women in disadvantaged communities on environmental toxins and their impact on breast cancer and maternal health. Through these education topics, women in the program can teach their communities about environmental toxins that negatively influence breast cancer and maternal health

Further, preventative or health maintenance services influence positive lifestyle choices and improve health outcomes through screenings such as mammograms and routine blood work. Focusing on screenings and health maintenance can help individuals reduce poor lifestyle choices that, over time, lead to chronic illness and reduce the risk of individuals receiving a late diagnosis for diseases such as breast cancer and sexually transmitted infections

Finally, CHWs can have a substantial impact on linking community members to emergency health services. For example, CHWs can become a bridge between an individual suffering from a substance use disorder and the inpatient or residential treatment provider that will help put them on track to living a drug-free life.

CHWs are crucial figures that can help build trust with community members weary of medical providers, helping people make better lifestyle choices and obtain services that can improve health out-

The Federal Transit Administration (FTA) in coordination with the City of Inglewood and with the financial and technical support of the Los Angeles County Metropolitan Transportation Authority (LACMTA), are proposing to construct the Inglewood Transit Connector Project (proposed Project) to address projected future congestion, improve overall mobility and levels of service, and advance the City's sustainability goals. The FTA is the federal lead agency pursuant to the National Environmental Policy Act (NEPA). The Environmental Assessment (EA) was prepared at the direction and under the supervision of the City of Inglewood as the local lead agency. Based on information contained in this EA and any comments submitted, the FTA will determine whether environmental effects are substantial to warrant preparation of an Environmental Impact Statement. If the FTA decides there are no adverse effects, it will prepare and sign a Finding of No Significant Impact. The determination will be made available to the general public and all who have commented on this EA.

Project Location: The proposed Project is located entirely in the central portion of the City of Inglewood, east of the San Diego Freeway (Interstate 405) and north of the Glen Anderson Freeway (Interstate 105) in Los Angeles County, California. As shown in Figure 1, the alignment would be primarily located within the public right-of-way along Market Street, Manchester Boulevard, and Prairie Avenue, with limited encroachments on adjacent private property.

Project Description: The proposed Automated Transit System, which is the Build Alternative, would include an approximately 1.6-mile long, elevated, guideway primarily located within the public right-of-way along Market Street, Manchester Boulevard, and Prairie Avenue. Three stations are proposed adjacent to the guideway on privately owned land that would be acquired as part of the proposed Project. The three stations include: (1) The Market Street/Florence Avenue station generally located between Market Street and Locust Street; (2) The Prairie Avenue/Pincay Drive; and (3) The Prairie Avenue/Pincay Drive; and (3) The Prairie Avenue and Pincay Drive; and (3) The Prairie Avenue/Hardy Street station located just north of the intersection of Prairie Avenue and Hardy Street. The proposed Project also includes a maintenance and storage facility (MSF) for the transit vehicles, two traction power substations for providing power to the system, and surface parking facilities at the Market Street/Florence Avenue station, the MSF, and at 150 Market Street. The proposed Project is planned to operate from 6:00 AM to 12:00 AM during the week and on weekends, with the possibility of extending operation hours as needed during special events. The proposed Project would open in time to operate for the 2028 Olympics.

The EA also addresses a No Build Alternative. The No Build Alternative provides the background transportation network, against which the Build Alternatives' impacts are identified and evaluated under the NEPA. The No Build Alternative does not include the proposed Automated Transit System. Specifically, the No Build Alternative reflects the reasonably foreseeable transportation network in 2027 and 2045 and includes the existing transportation network and planned transportation improvements that have been committed to and identified in the constrained LACMTA Metro Long Range Transportation Plan and the Southern California Association of Governments 2020-2045 Regional Transportation Plan/Sustainable Communities Strategy, as well as additional projects funded by Measure M, a sales tax initiative in Los Angeles County approved by voters in November 2016.

Public Review Period: The EA is being made available for public review beginning on October 14, 2022 and closing on November 14, 2022. Public comments on the EA will be received during this period, and must be received or postmarked on or before November 14, 2022. The City has created a virtual meeting room to describe the proposed Project and EA contents in lieu of a public meeting. The virtual meeting room can be viewed at https://inglewoodtransitconnector.com/. The website includes Spanish translations and the ability to submit comments on the EA.



Derek Smith: My mom, Ann, began selling her pecan candy (pralines) in 1993. Our name is an adaptation of her original business name, Lauren's Kreole Kandies, which was named after my younger sister. When my father passed away in 2011, it led me to learn the recipe because it was a reality check that my mother's time in this world was finite too. She has so many great recipes, however, no one in our family ever learned the praline recipe. We've traced this recipe back several generations. It would have been tragic to let a recipe that's over 100years-old perish.

LAS: You recently began national distribution as well as having products available in brick & mortar locations, did this experience prepare you for Taste of Soul?

DS: To my surprise, we've had a lot of interest from customers nationwide. We are constantly shipping pralines back to hometown (New Orleans). Most recently, we had the opportunity to have our products placed in Fluffy's Sno-Balls in Long Beach and are working on another placement in Chicago.

I don't think anything we've done thus far could for Taste of Soul. When I see how well sampling applied to be a vendor, I didn't expect to be selected, I just wanted Ann's to be on their radar. However, our approval was met with both excitement and trepidation as TOS brings out all of Los Angeles!

LAS: How did you prepare for TOS? How many pralines did you make?

DS: I set an ambitious goal of 1,000 pieces for the gy from the moment you event. One thing I didn't anticipate was the number of online orders that were

Reimagining and Reordering L.A. City Governance: An Ethics of Shared Power and Shared Good

elation of the scathing and scandalous racist sentiments and proposals harbored and hawked by three Latino city council members and a labor leader, there has been a virtually unanimous call and demand for them to do the right thing and resign.

Reeking with artificial, exaggerated and misplaced grievances, especially against African Americans and Native Americans, it resembled and recalled the cheap and chalky kind hawked and hustled at Trump and Trumpite rallies and racial reserves and legislative and public gatherings, viciously void of any human considerations of the dignity, rights, and rightful interests of different and vulnerable others.

And so, it shook and shocked us, especially those of us who saw them as actual or potential allies and have worked and struggled together with Latinos since the Sixties to transform, rebuild and govern the city and the larger society in new and more just, equitable and inclusive ways.

But, as important as it is for us to rightfully demand the resignation of these persons, this is only a beginning step in terms of what is to be done. For again, it is important to realize and respond adequately to the fact that it is not just they who pose the real problem, but rather the system itself which produces, approves and supports such thought, speech and behavior.

We talk about systemic racism, but like Americans in general, many of us tend to focus more on persons rather than the system and its structures, policies and practices of oppression. And thus, the criticism, condemnation and removal of problematic people become an end in itself, a satisfaction ly reimaging and reordering the racist system itself.

Therefore, there is a lot of cooperative energy and allyship around demanding the rightful resignation of these offending persons but clearly not enough of the same to actually change the structures and policies of the system in which racism and its grotesqueries take root, grow and restrict and ruin our lives. There is a steady stream of texting and talking about our Latino and other allies who have appeared at press conferences, rallies, demonstrations, campouts and confrontations at City Hall.

But, there is less, even little, texting and talk about open and insistent joint and separate demands and actions by these allies and requests by us for them to work and struggle with us at this critical juncture to deal structurally with the problem revealed once again, but which is ongoing and pervasive in the system of governance itself. And this holds true, not only in L.A., but also in the country as a whole, that is to say, the pervasiveness of the problem of racist oppression and the inadequate cooperative and allied approach to confronting and correcting it.

But, in order not to seem to overreach or divert focus from the issues at hand in L.A., let's explore what is be done at this critical juncture or as Nana Dr, Martin Luther King Jr. asked, where do we go from here: community or chaos?" My sense - both politically and ethically - is that we are already in the midst of chaos to a significant degree, and the only rightful way forward for us as a people, our allies and their people, as well as others so inclined and committed, is to struggle to reconceive and re-

construct a just, equitable, inclusive and good society based on an ethics of shared power and shared good for each and all of us.

There is a burning need for a new politics, new policies and practices and new ways of thinking about power, place, public security and public good. Power must be seen as an ethical imperative and existential good for each community and its members, and thus the concept and practice of zero-sum power, so rooted in the political practice of American society since its inception must be set aside.

And in its place, we must institute the concept and practice of "power with" instead of "power over," expanding the number of seats at the table, rather than seizing them from the most vulnerable and leaving the powerful in place and untouched. For again, power is an ethical imperative and existential good in its meaning of the capacity to satisfy needs and aspirations critical to human life and development. And thus, it should be embraced and distributed as a shared and inclusive good.

In the rightful pursuit and possession of community power, then, we must not find ourselves enabling, supporting and praising others' agendas and achievements and neglecting and not advancing our own.

This is especially important at this critical time of turning and reckoning, when thought and talk about this vicious and vintage expression of racism reminds us all of the horridness, hurt and harm it represents and imposes and urgently calls us to action.

Thus, we must, without arrogance, apprehension or timidity, carefully and selfconsciously map out and mark off the critical fields of our needs and interests and develop and put forth a community agenda which we ask our allies to support as we have supported and continue to support theirs in rightful reciprocity. And we are to pursue our rightful interests and aspirations as a community, not as junior brothers and sisters, deferring to numbers rather than to justice, equity and need, but as equals in dignity and rights, rejecting the tyranny of the existing and emerging majorities.

Indeed, we are to call for a new politics and new and renewed alliances based on the principles of mutual respect, mutual support and mutual benefit, and the collective and cooperative work and struggle needed to achieve these reciprocal relations and practices of shared power and shared good.

For Us, the demand and struggle for community power, power of the people over their destiny and daily lives, was in the Sixties and remains now an existential and ethical necessity in its role of creating conditions for a people that are dignity-affirming, life-sustaining and life-enhancing. Indeed, there is no justice or right in disempowering a people, rendering it incapable of meeting its basic needs, living a good life and pursuing self-fulling aspirations.

We argued during the Black Freedom Movement and argue now that Black Power, community power means conditions and capacities of self-determination, self-respect and self-defense. And these goals and practices remain a moral imperative for our community, especially selfdetermination which is a critical basis for both selfrespect and self-defense.

To talk of self-determination means we must control the space we occupy, participate politically in decisions that affect our destiny and daily lives and have space and place in governance that enables us to achieve this. In the context of city governance, it means not only adequate, equitable and effective representation on the city council, but also equitable leadership and employment in the Mayor's office and on various commissions central to city governance.

And it means also, adequate, equitable and effective leadership and representation in the Democratic Party, which our people has removed off political lifesupport, saved and sustained for so long without reciprocal reward and recognition due them.

Self-determination requires also an adequate, equitable and effective share of the resources of the city for its various constituent groups and communities. And here, as everywhere, adequacy, equity and effectiveness must be determined not simply by numbers, but especially by need, human need. Indeed, in this moral and human conception, one person needs adequate food and water as much as one hundred persons. And so, it is with other vital human needs of housing, healthcare, education and income,

Clearly, economic security achieved through continuous income in varied forms and from various

sources is essential to any real concept and practice of self-determination. And in addition to equitable leadership and employment in governance, there must be similar policies and practices in unions. Here our Brown allies must work with us to achieve equity in leadership, employment and contract acquisition, honestly confronting employer racial preference for them and others over us and the development and entrenchment of Latino and other ethnic networks that perpetuate and expand themselves and deprive, deny and diminish us.

There is here an irony too, that we who have been so loyal to unions and opened space in unions for Latinos and others, find ourselves slowly losing space, blocked from entry and equitable sharing of both jobs and leadership. And of course, we cannot in good faith and self-respect accept this.

For the defining of selfrespect and self-defense as goals and practices of Black community power speaks to our achieving, defending and living a life free of domination, deprivation and degradation and free to live a good and meaningful life and come into the fullness of ourselves as persons and a people.



Moses lived a life of privilege and luxury - the Egyptian lifestyle - for about 40 years. He had seen firsthand how the Egyptian culture worked where he learned science, mathematics and other highly cultural ethics and intelligences. A Russian court on Tuesday rejected an appeal by U.S. basketball star Brittney Griner of her nine-year prison sentence for drug possession, a step that could move her closer to a possible high-stakes prisoner swap between Moscow and Washington.

The eight-time all-star center with the WNBA's Phoenix Mercury and a two-time Olympic gold medalist was convicted Aug. 4, after police said they found vape canisters containing cannabis oil in her luggage at Moscow's Sheremetyevo Airport.

Griner, 32, was not at the Moscow Regional Court hearing, but appeared via video link from a penal colony outside the capital where she is held.

At her trial, Griner admitted to having the canisters in her luggage but testified she packed them inadvertently in her haste to make her flight and had no criminal intent. Her defense team presented written statements saying she had

been prescribed cannabis to treat chronic pain.

The nine-year sentence was close to the maximum of 10 years and Griner's lawyers argued after the conviction that the punishment was excessive. They said in similar cases defendants have received an average sentence of about five years, with about a third of them granted

While upholding the sentence, the court said Griner's prison time will be recalculated to reflect what she has already served in pre-trial detention. One day in pre-trial detention will be counted as 1 1/2 days in prison, so she still will have to serve about eight years in

Griner's lawyers Maria Blagovolina and Alexander Boykov said in an email that they were "very disappointed" with the decision because they still believe "the punishment is excessive and contradicts to the existing court practice."

"Brittney's biggest fear is that she is not exchanged and will have to serve the whole sentence in Russia," they said. "She had hopes for today, as each month, each day away from her family and friends matters to her."

They said they had to discuss with Griner what legal steps they should take

Griner's arrest in February came at a time of heightened tensions between Moscow and Washington, just days before Russia sent troops into Ukraine. At the time, Griner was returning

to play for a Russian team during the WNBA's offsea-

U.S. Secretary of State Antony Blinken called the decision "another failure of justice, compounding the injustice of her detention," adding that "securing her release is our priority."

President Joe Biden told reporters that his administration is in "constant contact" with Russian authorities on Griner and other Americans who are detained there. While there has not been progress on bringing her back to the U.S., Biden said, "We're not stopping."

Before her conviction, the U.S. State Department declared Griner to be "wrongfully detained" — a charge that Russia has sharply rejected.

U.S. National Security Advisor Jake Sullivan said in a statement that Biden "is willing to go to extraordinary lengths and make tough decisions to bring Americans home."

WNBA Commissioner Cathy Engelbert said the decision "while unfortunate, was not unexpected. ... It is time to bring this case to an end and bring BG home." The WNBA Players Association said the ruling was "further verification that BG is not just wrongfully detained - she is very clearly a hostage."

Because of the growing pressure on the Biden administration to do more to bring Griner home, Blinken took the unusual step of revealing in July that Washington had made a "substantial proposal" to get Griner

Blinken didn't elaborate, but The Associated Press and other news organizations have reported that Washington has offered to exchange Griner and Whelan for Viktor Bout, a Russian arms dealer who is serving a 25-year sentence in the U.S. and once earned the nickname the "merchant of death."

The White House said it has not yet received a productive response from Russia to the offer.

Washington to discuss the matter in confidential talks, avoiding public statements. Some Russian officials have said a deal is more likely once appeals have been exhausted.

In September, Biden met with Cherelle Griner, the player's wife, as well as her agent, Lindsay Colas. Biden also sat down separately with Elizabeth Whelan, Paul Whelan's sister.

The White House said that the president stressed to the families his "continued commitment to working through all available avenues to bring Brittney and Paul home safely."

The U.S. and Russia carried out a prisoner swap in April. Moscow released U.S. Marines veteran Trevor Reed in exchange for the U.S. releasing a Russian pilot, Konstantin Yaroshenko, who was convicted in a drug trafficking conspiracy.

Moscow also has pushed for the release of other Russians in U.S. custody.

One of them is Alexan-Vinnik, who was accused of laundering billions of dollars through an cryptocurrency exchange. Vinnik was arrested in Greece in 2017 and extradited to the U.S. in

Vinnik's French lawyer, Frederic Belot, told Russian newspaper Izvestia last month that his client hoped to be part of a possible swap.

The newspaper speculated that another possible candidate was Roman Seleznev, the son of a Russian lawmaker. He was sentenced in 2017 to 27 years in prison on charges from a hacking and credit card fraud scheme.



Joe Dumars might have been destined for this job.

He played with the "Bad Boys," those Detroit Pistons teams that were physical, aggressive and intimidating. And even in those rough-and-tumble times, he wound up becoming the first recipient of the NBA's sportsmanship award — now called the Joe Dumars Trophy.

He's now tasked with ensuring that players don't act like his old teammates often did. Dumars became Executive Vice President and Head of Basketball Operations for the NBA in May, making him a major decider in all things related to player discipline for oncourt actions.

His first big decisions, related to player discipline, came earlier this week, when the NBA suspended Miami Heat teammates Caleb Martin and Nikola Jovic for their roles in a scuffle during a game against the Toronto Rap-

"You want to do something where you really feel like you're contributing," Dumars said. "Basically, this is the only place I haven't contributed to in this game."

At 59, with two championships as a player and another as an executive and a lifetime within the game, he doesn't have to be working. He could be spending his days playing and watching tennis, which is the sport he started playing as a 10-year-old and has loved ever since. Instead, he's moved to New York, with office views from a high-rise not far from Rockefeller Center and Radio City Music Hall, smack in the middle of

"I tell people that we are stewards of the game," Dumars said. "And people go, 'What does that mean?' Well, we make sure that the trains are taking off on time. We make sure that the game stays clean. We make sure that there's any time there's any disruption or things that should not be, we are here to clean this up and make sure we are presenting a great product and presenting it the right way."

seats — thankfully unoccupied at the time - and Jovic, even though he didn't really appear to do much to add fuel to the fire, clearly left the bench area and therefore broke one of the NBA's absolute no-

Martin missed Monday's game against the Raptors and will lose roughly \$45,000 in salary.

"I definitely don't disagree with it," a contrite Martin, who reached out to

Jovic also had to sit out Monday, meaning the Heat rookie has now been suspended for more games (one) than he has played

What happened Saturday could have been much worse, since Martin, Koloko and about a dozen other people all wound up where fans were. Martin ended up next to a woman in the second row; her halftime acquisition of a large popcorn, somehow, was

But things didn't escalate, Dumars acted swiftly, and case closed.

Not everything has been that easy for the league in recent weeks — Phoenix owner Robert Sarver will likely sell his NBA and WNBA franchises before his one-year suspension for boorish behavior Boston coach Ime Udoka will miss this entire season because of an inappropriate workplace relationship, Golden State had to deal with Draymond Green punching teammate Jordan Poole in practice and video of that exchange leaking, and Detroit assistant general manager Rob Murphy was placed on leave following allegations of misconduct made by a former female team employee.

Sarver was suspended by NBA Commissioner Adam Silver. The other incidents have been handled at the team level. Oncourt matters, rise to Dumars' desk, high above Manhattan.

"I'm super excited to work with him, and to learn from him, and to collaborate with him," said Monty McCutchen, the NBA vice president overseeing referee operations. "The best collaborations are collaborations that both people, both groups, both departments benefit from. Additionally, as a Pistons executive, he was once fined \$500,000 for leaking memos to a reporter.

He thinks having been on all sides of the NBA will only help him in this new

"If I didn't have the career I had, maybe my mentality would be different," Dumars said. "But when you've done stuff at the highest level in this in this business, that's kind of where you want to live."

Crump Files Lawsuit on Behalf of User of Chemical Hair Straightening Products

Researchers discovered that hair products used predominately by Black women are likely contain hazardous chemicals with endocrinedisrupting and carcinogenic properties.

Armed with information and research by the Journal of the National Cancer Institute, civil rights attorney Ben Crump joined forces with lawyer Diandra Debrosse Zimmermann to file a lawsuit against beauty products giant L' Oréal USA.

Crump Zimmermann filed the suit on behalf of Jenny Mitchell,

history of cancer but who received a uterine cancer diagnosis after years of using L' Oréal products.

The lawyers declared that the defendants also would include "entities that assisted in the development, marketing, and sale of the defective products including Motions, Dark & Lovely, Olive Oil Relaxer, and Organic Root Stimulator."

"Black women have long been told they must use chemical hair straightening products to meet society's standards," Crump declared. "Companies took advantage of this and marketed their dangerous products to women without any regard for the serious health risks. We need justice."

Crump said Mitchell

started using the products around 2000 and continued until 2022. In August 2018, Mitchell – with no family history of uterine or other cancer - was diagnosed with uterine cancer and underwent a complete hysterectomy, Crump noted.

Mitchell attended mandatory medical appointments every three months for two years and has appointments scheduled every six months.

Crump cited a new study published in the Journal of the National Cancer Institute this week. The study concluded that frequent users of chemical hair straightening products, defined in the study as more than four uses a year, were more than twice as likely to develop uterine

cancer than those who didn't use those products. The National Institute of Health's National Institute of Environmental Health Sciences conducted the

Uterine cancer rates and deaths are reportedly on the rise in the U.S. Death rates are highest among non-Hispanic Black women, who are more likely than other populations to be afflicted with aggressive subtypes of uterine cancer, according to the National Institutes of Health, which tracked data from 34,000 women in the Sister Study for more than a decade.

"Black women have long been the victims of dangerous products specifically marketed to them," said Crump. "Black

•••••• will be beautiful, but Black women have been told they have to use these products to meet society's standards. Unfortunately, we will likely discover that Ms. Mitchell's tragic case is one of the countless cases in which companies aggressively misled black women to increase their profits."

Chemical straighteners typically contain products associated with higher cancer risk, including formaldehyde, metals, phthalates, and parabens, which may be

hair has been and always more easily absorbed by the body through scalp burns and abrasions often caused by chemical straighteners, study authors determined.

Zimmermann added that companies like L' Oréal "targeted Black and Latin women for their own profit motive and without regard to the serious health risks that these hairstraightening products cause is a serious wrong that needs to be corrected."

"We have commenced this important litigation to seek and obtain justice for those women and their

Slavery on Ballot for Voters in 5 U.S. States

More than 150 years after slaves were freed in the U.S., voters in five states will soon decide whether to close loopholes that led to the proliferation of a different form of slavery — forced labor by people convicted of certain crimes.

None of the proposals would force immediate changes inside the states' prisons, though they could lead to legal challenges related to how they use prison labor, a lasting imprint of slavery's legacy on the entire United States.

The effort is part of a national push to amend the 13th Amendment to the U.S. Constitution that banned enslavement or involuntary servitude except as a form of criminal punishment. That exception has long permitted the exploitation of labor by convicted felons.

"The idea that you could ever finish the sentence 'slavery's okay when...' has to rip out your soul, and I think it's what makes this a fight that ignores political lines and brings us together, because it feels so clear," said Bianca Tylek, executive director of Worth Rises, a criminal justice advocacy group pushing to remove the amendment' convict labor clause.

Nearly 20 states have constitutions that include language permitting slavery and involuntary servitude as criminal punishments. In 2018, Colorado was the first to remove the language from its founding frameworks by ballot measure, followed by Nebraska and Utah two years later.

This November, versions of the question go before voters in Alabama, Louisiana, Oregon, Tennessee and Vermont.

Sen. Raumesh Akbari, a Democrat from Memphis, was shocked when a fellow lawmaker told her about the slavery exception in the Tennessee Constitution and immediately began working to replace the language.

"When I found out that this exception existed, I thought, 'We have got to fix this and we've got to fix this right away," she said. "Our constitution should reflect the values and the beliefs of our state."

Constitutions require lengthy and technically tricky steps before they can be tweaked. Akbari first proposed changes in 2019; the GOP-dominant General Assembly then had to pass the changes by a majority vote in one two-year legislative period and

then pass it again with at least two-thirds approval in the next. The amendment could then go on the ballot in the year of the next gubernatorial election.

Akbari also had to work with the state Department of Correction to ensure that inmate labor wouldn't be prohibited under her proposal.

The proposed language going before Tennessean voters more clearly distinguishes between the two: "Slavery and involuntary servitude are forever prohibited. Nothing in this section shall prohibit an inmate from working when the inmate has been duly convicted of a crime."

"We understand that those who are incarcerated cannot be forced to work without pay, but we should not create a situation where they won't be able to work at all," Akbari said.

Similar concerns over the financial impact of prison labor led California's Democratic-led Legislature to reject an amendment eliminating indentured servitude as a possible punishment for crime after Gov. Gavin Newsom's administration predicted it could require the state to pay billions of dollars at minimum wage to prison inmates.

Scrutiny prison labor has existed for decades, but the Amendment's loophole in particular encouraged former Confederate states after the Civil War to devise new ways to maintain the dynamics of slavery. They used restrictive measures, known as the "Black codes" because they nearly always targeted Black people, to criminalize benign interactions such as talking too loudly or not yielding on the sidewalk. Those targeted would end up in custody for

minor actions, effectively enslaving them again.

Alabama is asking voters to delete all racist language from its constitution and to remove and replace a section on convict labor that's similar to what Tennessee has had in its constitution.

Vermont often boasts of being the first state in the nation to ban slavery in 1777, but its constitution still allows involuntary servitude in a handful of circumstances. Its proposed change would replace the current exception clause with language saying "slavery and indentured servitude in any form are prohibited."

Oregon's proposed change repeals its exception clause while adding language allowing a court or probation or parole agency to order alternatives to incarceration as part of sentencing.

Louisiana is the only state so far to have its proposed amendment draw organized opposition, over concerns that the replacement language may make matters worse. Even one of its original sponsors has second thoughts — Democratic Rep. Edmond Jordan told The Times-Picayune/The New Orleans Advocate last week that he's urging voters to reject it

The nonprofit Council

for a Better Louisiana warned that the wording could technically permit slavery again, as well as continue involuntary servitude.

Louisiana's Constitution now says: "Slavery and involuntary servitude are prohibited, except in the latter case as punishment for a crime." The amendment would change that to: "Slavery and involuntary servitude are prohibited, (but this) does not apply to the otherwise lawful administration of criminal justice."

"This amendment is an example of why it is so important to get the language right when presenting constitutional amendments to voters," the nonprofit group said in a statement urging voters to choose "No" and lawmakers to try again, pointing to Tennessee's ballot language as a possible template.

Supporters of the amendment say such criticisms are part of a campaign to keep exception clauses in place.

"If this doesn't pass, it will be used as a weapon against us," said Max Parthas, state operations director for the Abolish Slavery National Network.

The question stands as a reminder of how slavery continues to bedevil Americans, and Parthas says that's reason enough to vote yes.

"We've never seen a single day in the United States where slavery was not legal," he said. "We want to see what that looks like and I think that's worth it."


Nowhere in the theory or practice of restorative justice (or common sense) does it say that the offender dictates how they will make amends to those who were harmed.



No on HC Campaign Spends 7 Figures Paying MAGA Republican Consulting Firm

If you have been in or around Inglewood lately you've probably noticed advertisements everywhere for and against Measure HC - a ballot measure that would raise the healthcare worker minimum wage to \$25 per hour. The measure - backed by local healthcare workers unions, including SEIU-United Healthcare Workers West, has faced strong opposition by the hospital industry. Recent documents obtained by the LA Sentinel show just how strong and expensive that opposition has been.

According to campaign finance documents filed Inglewood City Clerk, the No on Measure HC campaign spent \$1,732,327 in the period from January 1st to U.S. Senate, September 24th. This puts the campaign on pace to be one of the biggest-spending campaigns Inglewood has ever seen.

Notably, the No on HC campaign's two highestpaid consulting firms are two Republican firms with a history of working for some of the most conservative politicians in the country. BASK Digital Media, based in San Diego, was paid over \$500,000 by the No on HC campaign, while Target Enterprises LLC was paid over \$700,000 by the campaign in the same period.

This is not the first time BASK and Target Enterprises have teamed up on a campaign. In 2018, they were the two largest vendors for Don Blankenship for almost \$3 million from a campaign famed for racist and bizarre advertising.

During his run for a U.S. Senate seat in West Virginia, Blankenship famously produced an ad in which he referred to Asian Americans as "China people" and referred to himself as "Trumpier than Trump."

Target Enterprises additionally received nearly \$8 million from former U.S. Senator David Perdue, who was defeated in 2020 after being accused of using insider information to profit off of the pandemic.

BASK Digital and Target Enterprises have been paid millions over the years to elect anti-choice and pro-Trump Republicans. Hiring these firms to manage a





Los Angeles has had its share of race relations issues in the past: such as The Watts Riots. The Rodney King beating and the subsequent unrest after the police verdicts. The George Floyd murder. the City Council scandal that has rocked the Los Angeles political scene is different in that it has the potential to disrupt what has otherwise been beneficial relations between the Black and

Latino communities. Watching the council meetings days after the recording of unhinged racist remarks by the three Latino councilmembers and Ron Herrera from the Los Angeles County Federation of Labor showed the anger and frustration of the public towards morally corrupt

The key here is public

outrage. Every community was equally horrified by the remarks and the inactions not taken to stop

the defamatory comments. Latinos were just as incensed as members of the Black community - voicing their angst in front of city hall, lambasting the four Latino leaders on social media, and calling for their resignations. The phrases "Ya Basta!" and "Fuera!" could be heard as loud and as frequently as "Hey, hey, yo, you have to go" in crowds across Los Angeles.

Each community found the remarks reprehensible but in different ways.

Many Latinos were vexed that their champions would talk negatively about the Oaxacan community living in Korea Town. It was intolerant, insensitive, and far from the purpose of political discussion. The inward turn was perplexing to Latinos across the region.

The Black community was outraged, and rightly so, by the racist remarks and attacks toward a toddler, which they should have never mentioned in their meeting on redistricting. Even then, their primary purpose of disenfranchising Black voters and elected officials must never be tolerated.

But racism exists in every culture. And with variations.

Stereotypes' perpetual push helps keep negative and false impressions of cultures and individuals alive. For some, it is purely the color of your skin. For others, it is your national origin or ethnic background.

Fear lives in bigotry. Celebration lives diversity.

In those recordings, we heard the fear of losing power, authority, and identity. Historic themes that have existed primarily in quiet discussions around the world for millennia.

course. persecution has also existed out in the open throughout the dark portions of human

Their actions are why there is an urgent need to have all three individuals resign immediately - we must not allow this to become a dark period in our city's history. By leaving their seats, the remaining council members permit Angelenos to focus on the brightness of our

communities and start the healing process.

We must espouse one

another's cultures or run the risk of implosion. Combating racism requires interaction and hyper-local

multicultural events to experience one another's worlds. exchange The culture has a significant and immediate positive

impact. Example: the rapper Snoop Dogg recorded Que Maldicion, a substantial hit with Mexican mega group

Banda MS with crossover appeal to Latino, Black, hip-hop, and banda music lovers worldwide.

The lesson here is that racism is a learned ignorance and can come from anyone of any background. The teachable moment is we should strive to educate ourselves on the similarities and differences we have in such a rich and diverse community like that of Los Angeles.

As we enter the season of thanks, praise, giving, and rejoicing, let us take

a moment to greet one another, dine at places we have never been before in a neighborhood where other cultures thrive, and show respect and gratitude as we break bread.

Measure HC is Unfair and Unequal for Health Care Workers

The pandemic put into light how critical our health care workers are in our local communities. These frontline workers should be adequately compensated for their heroic efforts, not just during the pandemic, but every day. This is why the Greater Los Angeles African American Chamber of Commerce is urging a No on Inglewood's Measure HC this November.

The measure purports to benefit health care workers via a mandatory wage increase. In truth, the measure actually excludes workers at 73% of health care facilities in the city, including thousands of workers at Inglewood's community clinics, public hospitals, nursing homes, urgent care centers, mental health facilities and more. clinical workers like janitors, housekeepers and landscapers at hospital-based facilities, creating winners and losers but excludes clinical workers nursing assistants, medical technicians, and other workers in non-covered facilities. That's unequal and

equal pay for equal work. But under Measure HC, workers who are doing the exact same job every day are completely excluded simply based on their employer of choice. It adds insult to injury for hardworking health care workers who are left out, The measure applies to non- excluded and totally left behind.

What's more, beyond among our health care workforce, the measure will have broader negative impacts that will be felt by the entire community of Inglewood and beyond.

Measure HC will deepen

inequities in our healthcare system. It mandates higher wages for certain workers at private hospitals, excludes workers community clinics, urgent care Planned centers. Parenthoods, providers that primarily serve uninsured, low-income underserved communities. This will lead to workforce

shortages at smaller clinics and public health facilities. For a workforce still reeling and recovering from the pandemic, creating unfair compensation system for some, but not all, jeopardizes access and quality of care for our most disadvantaged communities and patients.

Measure HC will also substantially increase costs for patients already struggling with the high cost of living in Southern California. It could risk facility closures or cutbacks in services-- putting patient access to care at risk and forcing patients to travel

further for vital services like maternity behavioral health, cancer care and more.

Measure HC is opposed by the very health care workers it claims to help because it is deeply unfair. Excluding 73% of our local health care workers is not the way to show them we support their sacrifices. We all want to pay healthcare workers a fair wage. But this flawed, poorly written and unequal measure is the wrong way to do it.

Inglewood's Mayor

and City Council also questions this measure when they debated its merits prior to determining it was best for voters to decide and placing it on the ballot. They noted how important it is to honor health care workers and to pay what they deserve, but they also questioned the impacts to the workers excluded from the measure, creating a who's in and who's out economy that the Mayor, in particular, seemed to have concerns over.

We agree with these

concerns and believe we need a better way to help our healthcare workers. Please join the Greater Los Angeles African American Chamber of commerce, local health care workers and health care providers in sending a clear message that we stand with ALL health care workers and are not fooled by this inequitable and unequal measure. Please vote No on HC.

Later that day, the West Angeles Women's Affairs Organization sponsored "An Afternoon with Lady Mae and Lady DeAndra." In addition to members attending, special guests included Dr. Betty R. Allyson Bowels.

Price, wife of the late Apostle Frederick K.C. Price and a longtime friend of Lady Mae, shared how impressed she was with the gathering. "What I loved about today is that the saints were unified and on one accord. All of them exhibited an attitude of cooperation and had a mind to work in support of the new pastor," she noted.

"I love how our new first lady (DeAndra Blake) gave and bestowed honor upon First Lady Mae Lawrence

The work is great, but I believe the God will continue to guide and strengthen me, as I seek to serve Him and His people" he replied.



State As Assemblymember from 1988 to 1996, Murray advocated for the people by emphasizing education, economic development and healthcare. He later served 10 years each on the Water Replenishment District of Southern California and Metropolitan Water District of Southern California.

All of Murray's actions were motivated by his desire to help people, which likely influenced his creation of the California Democrat Voter Guide in 1961. According to family members, the dedicated public servant considered the publication "as a vehicle for providing information about candidates and ballot measures to voters in the



community."

The California Democrat Guide remains the longest continuously published voter guide addressing the needs of the African American community and it is an enduring, tangible symbol of Willard's desire to uplift Black Americans

California Black Media Campaign Unveiled at Los Angeles Taste of Soul

in South Los Angeles to celebrate the Black cultural experience – as well as the traditions of other ethnic groups -- through food, music, and art.

Brandon Brooks, CBM's campaign project manager, said attending the festival was a good way to familiarize people with Stop the Hate and organizations that are geared toward combatting hate incidents and hate crimes in the Golden State.

"We brought together a lot of partners to give information to combat and address hate — outside of law enforcement," Brooks said.

Representatives from local and state government departments including the City of Los Angeles' Civil + Human Relations & Equity Department, the California Secretary of State, the California Department of Social Services, and the California Civil Rights Department were at the three-table booth with Brooks and CBM Executive Director Regina Wilson.

"Having those representatives on hand was a must," Brooks said. "If you or I experience hate we might not be comfortable with calling the LAPD or sheriff's department, so who can we actually really call," Brooks asked rhetorically, speaking to

"You can actually call the civil rights department; you can call social services. A lot of people don't know that. These organizations are there to be a resource or an olive branch to start that dialogue. You may need some help. That's these organizations' job."

A report released by California Attorney General Rob Bonta in June revealed hate crimes inspired by racism and homophobia resulted in a 33% uptick in reported incidents in the state in 2021. Hate crimes against Blacks were the most prevalent, according to the report. There were 513 crimes committed against Blacks in 2021,

13% more than the 456 in 2020.

Becky L. Monroe, the California Civil Rights Department's deputy director strategic initiative and external affairs, said working to eliminate hate crimes and the attitudes and circumstances contribute to them is about saving lives.

"It is critical that people know what their options are if they are targeted for hate and know that we can take action and that we can stop hate and spread love," Monroe said.

CBM is in the early stages of its Stop the Hate public information campaign. The media and

organization's goal is to publish a series of stories that educate Black Californians and state residents from other backgrounds about each other's lives, cultures and traditions as it promotes an appreciation for diversity and fosters deeper interethnic understanding.

CBM has four events or festivals planned within the next year that promote the message of the Stop the Hate campaign.

"Regina's goal is to really break bread and bring people together," said Brooks, referring to CBM's executive editor.

The initiative funded by a joint venture of the California State Library and the California Commission on Asian and Pacific Islander American Affairs. The Ethnic Media Grant Project has awarded nearly \$6 million in grants to 50 ethnic media outlets and organizations serving communities that are historically vulnerable to hate crimes and hate

The program's aim is to enhance public awareness of the Stop the Hate Program being run by the state's social services department.

incidents.

Festival attendees who visited the Stop the Hate booth were able to meet representatives from media publications Al Enteshar, Carib Press, Ethnic Media Services, Impulso News, and Indian Voices.

The booth sponsored by CBM, Ethnic Media Services, the Civil + Human Relations & Equity, the NAACP, and the California Civil Rights Department.

Brooks said CBM's Taste of Soul booth was because it successful introduced people to the Stop the Hate initiative and individuals gained more information about fighting hate crimes and reporting hate incidents.

"When you say hate crimes or hate incidents, we as a collective really need to figure out how to address this topic," he said. "We really wanted to bring resources and information to the community."

Los Angeles Sentinel Executive Editor Danny J. Bakewell Jr., whose newspaper organizes Taste the Soul and is a CBM partner, said the festival aligns with "Stop the Hate. Spread the Love."

"That is what Taste of Soul is all about," Bakewell said to CBM's videographer. "Spreading the love, right here in our own community on Crenshaw Boulevard."

The front-runner also weighed in on the turmoil Councilmembers Gil Cedillo and Kevin de León caused by joining former Council President Nury Martinez and former L.A. County Fed President Ron Herrera in maligning colleagues with racist language and plotting to strip assets and political power from districts represented by African American councilmembers. The L.A. Times first reported and released the audiotape revealing the statements made by the four in Oct. 2021.

Three days after the audio was leaked, Bass convened a session with Black, Latino and other civic leaders to outline strategies to maintain the trust and unity developed through decades coalition building between the various communities.

Aiming to go beyond simply discussing the issues, Bass said she hopes the group will lead to "raising issues such as structural inequity in our city" – a situation she attributes to the City Council dividing resources in 15 districts. "We need to use this conflict as an opportunity to solve some structural problems with in our city," said Bass.

On the issue of homelessness, the candidate cited her news conference on Oct. 24, with Councilmember Curren Price, which highlighted the potential of constructing affordable housing on vacant city land. conjunction with Southwest Carpenters and the firm, Urban Awnings, Bass and Price displayed a prototype of a unit, which she said, "could be built cheaply and

very rapidly."

kitchen, bathroom and a loft area and you could build 20 units on this property. They said it would take eight months from beginning to end and each unit would be under \$200,000. This is housing that could be built very quickly with unionpaid jobs," insisted Bass.

Earlier this month, Senator Sanders endorsed Rep. Bass, saying: "At a time when Los Angeles and cities across the country are facing major challenges, we need bold leaders who will stand up to big money interests and put the priorities of working people first. For that reason Karen Bass, a long-time leader in the struggle for economic, social and racial justice, is the clear choice for mayor of Los Angeles.

"She is taking on a billionaire developer who is way out of touch with the challenges facing low-income and working families. Karen will work housing more affordable, create good paying jobs, lower the crime rate and
