# Seventh Annual United Against Hate Week Launches from Watts

The Watts Historic Train Station was the center stage for the commencement of the Seventh Annual United Against Hate Week (UAHW) on Sept. 20.

In a vibrant setting at the "Unity Under the Sun" mural, LA vs Hate along

with its partners CA vs Hate, Stop the Hate, and Not in Our Town, united to amplify their commitment to combating hate across Los Angeles.

UAHW, a week-long Sept. 21 to 27, focuses on rallying community and governmental forces to counter the concerning rise

in hate crimes and discrimination that plague diverse neighborhoods and cities. With hate crimes nearly doubling statewide from 1,015 in 2019 to 1,970 in 2023, and an alarming 63% initiative spanning from increase in Los Angeles County alone during the same period, the call for unity and action is more pressing than ever.

The press conference munity against hate and the shined a spotlight on the power of community and leadership in the fight against hate. Prominent speakers included Los Angeles County District Attorney George Gascón and Supervisor Holly J. Mitchell, who both emphathe historical sized resilience of the Watts com-

ongoing efforts to foster a more inclusive society.

District Attorney Gascón shared his personal connection to Watts from his days with the LAPD and discussed the dual approach of his office in combating hate through aggressive prosecution and educational initiatives. "We recognize

that education is critical to getting rid of this cancer that we call hate," Gascón stated, underscoring the importance of both legal action and community engagement in these efforts.

# **Local Health Providers Offer** Free Medical Services at Taste of Soul

Community health matters at the 19th Annual Taste of Soul Family Festival. On Saturday, Oct. 19, from 10 a.m. to 7 p.m., guests can receive free top medical assistance for flu shots, glucose tests, blood pressure checks, and more. First aid cooling stations will be available for medical and safety issues throughout the festival.

Free services from Kaiser Permanente, Watts Health, MLK Community Healthcare, UCLA Health, American Heart Association AHA, Charles R. Drew

University, and Cedar-Sinai will inform residents and answer their questions about any concerning areas regarding their health.

Kaiser Permanente will be administering flu shots, massages, glucose tests, and blood pressure checks. The W. King Healthcare Group will be providing blood pressure testing, glucose finger checks, and HIV and Hepatitis C testing. Watts Health will be assisting with Mammograms, A1C, dental, cholesterol, and HIV testing.

The MLK Community Healthcare will be educating guests about Medicare, other health insurance options, outpatient service offerings, blood pressure checks, blood sugar tests and screenings for diabetes, flu vaccines and health consulting with nurses.

UCLA Health will be conducting eye and dental exams, and general health testing. The American Heart Association AHA will be demonstrating hands-on CPR procedures, free blood pressure screenings and providing resources for healthy living.

Cedars-Sinai will be giving flu shots, community resources for food, housbenefits, public

# Billie Green Appointed to L.A. Taxicab Commission

The Los Angeles City Council confirmed Billie J. Green as a member of the Board of Taxicab Commission on Sept. 20 following her the appointment to the post by Mayor Karen Bass.

"I certify that in my opinion, Ms. Green is especially qualified by reason of training and experience for the work and I make the appointment solely in the interest of the City," said the mayor in a letter to the City Council.

In this capacity, Green will join four fellow commissioners in performing several duties including awarding and revoking taxi franchise permits, setting taxicab operating rules and procedures, and investigating driver and company

Also, the misconduct. board approves taxicab franchises and sets taxicab rates, both subject to City Council approval.

A retired City of L.A. employee, Green served 15 years as a deputy for former Council President Herb J. Wesson where she

managed the district council office as well as assisted 10th District residents with resolving housing related

Green is also a veteran community activist who has consistently volunteered her expertise to many nonprofit organizations. From 1994 to 2000, she served as president of the NAACP Beverly Hills/Hollywood Branch. Other positions she has held include vice-president of the United Neighborhoods Neighbor Council, director of Youth Program/Film Festival for the Black Hollywood Education and Resource Center, and chair of Ward AME Church adoption program, Room for One More.

Currently, Green is the president of Inside Outside Communications Foundation, a nonprofit she founded in 2003. A youthfocused organization, the foundation awards scholarships to college or trade school-bound young people, conducts a warm coat giveaway in conjunction with retired LAPD Officer

Jerome Divinity, and collaborates with Erin Ashley to expose youth to gaming along with providing free equipment.

A native of Strong, Arkansas, Green has resided in Los Angeles for more than 60 years.

# Satra Zurita and Compton Residents to Walk For A Cure This October

Breast cancer is an illness that affects many women and men year after year. A disease that

313,000 Americans have been diagnosed with this year alone, unfortunately, according to the American Cancer Society. Yet, Compton Unified School District member Satra Zurita and some residents of the city of Compton are looking to fight those odds and numbers by donating their time walking for a cure.

On Saturday, Oct. 5, Zurita and others will participate in the 13th annual Compton Walk For A Cure at Centennial High School in the city of Compton. The yearly event began after Zurita, who worked in

Compton City Hall at the time, noticed a woman upset over the fact her daughter was unable to graduate high school at the

"So this lady came to my job and she was really, really upset. Like, what is this about," recalled Zurita. The CUSD board member learned of a deeper, more serious matter that was affecting the young girl and her schooling.

"She told me that her daughter had been in and out of the hospital for the past year, and that she had missed the high school exit exam, the math portion, by one point. So, she had passed the other portions of the exit exam, but the math, she missed by one point," Zurita said.

"So as a result, me and my sister said, 'Well, we gotta do something about this.' A lot of women, Black and Brown women, are dying from breast cancer, and a lot of times it's just that they are afraid, you know, they're paralyzed by fear. They can't move. They know something's wrong, but they don't want to know what is wrong."

The event highlights breast cancer awareness, prevention, and care while getting the neighborhood out and about for a healthy

While the first Compton Walk For A Cure included 350 participants, the event has seen up to 3,500 participants take part in the occasion. Even during COVID, the walk still took place because according to her, "COVID doesn't stop cancer."

"So we did a hybrid during COVID. Everybody was so afraid of everything. So, we had a drive-thru. And we had an on- site, small group. Then, we broadcasted, and did a virtual walk next year," Zurita said.

walk at the same time. "We talk about early detection, the benefits of early detection, that's what our walk focuses on," Zurita explained.

"Early detection, right? That's how we started it. It was a collaboration between me and my sister, the city and the school district. My sister had gotten elected, and she had only been there for three months. and so we had three months to plan the first one."

"Then, we came back in year three, and we've been building back again. You know, not as many people were coming out and, you know, had a really detrimental impact on this community and most marginalized communities."

The event is in partnership with various vendors such as St. John's Community Health, who will hand out waterproof self-exam cards, and shipping company UPS, who will contribute

their doctors to see what's going on," Zurita said. "So last year they did 78 ultrasounds, 58 breast exams and 236 people were examined. So, yeah, it's truly a lifesaving event."



"I really like to volunteer with kids because kids are very impressionable and I really want them to see that they can go out and do things especially because I came from a lowincome background," said Ja'Nea James, a UC Irvine School of Medicine student studying to get her medical degree.

"You have to have that motivation and that drive to be self-sufficient and it's very possible for you to do it."

Co-founders of WLC-CMS, Eugene Fisher and his wife, Sandra Fisher watched the festivities of Step Forward Day. They shared about how proud they are of how far the school has come since its inception in September 1997 and seeing their students engaged.

"It's absolutely wonderful," said Eugene. "We start-

ed with two children and now we have about 750, that's the elementary and the middle school.

"It was a joy and a delight to see that kind of award ceremony with the kids moving forward. Today is the first day of the beginlow, but look at it now."

"I never saw a PhD student, a D1 basketball player, a Stanford woman's basketball college coach, final four ring holder, Google employee for five years and resigned—all of that is in me as a Black woman," said



# John Amos of 'Good Times,' 'Roots' Fame Dies at 84

John Amos – the athlete-turned-actor who played the strong father figure on the early seasons of the TV sitcom "Good Times" in the mid-1970s, and later the adult version of Kunta Kinte on the groundbreaking 1977 miniseries "Roots" – has died at the age of 84, his family said on Oct. 1.

Amos died on Aug. 21 in Los Angeles of natural causes.


"It is with heartfelt sadness that I share with you that my father has transitioned," his son Kelly Christopher Amos said in a statement provided to multiple trade publications.

"He was a man with the kindest heart and a heart of gold, and he was loved the world over. Many fans consider him their TV father. He lived a good life. His legacy will live on in his outstanding works in television and film as an actor.

"... He was my dad, my best friend, and my hero. Thank you for your prayers and support at this time."

Born in Newark, New Jersey, Amos attended Long Beach City College before graduating from Colorado State University, where he also played football. A onetime Golden Gloves boxing champion, he tried out for the AFL's Denver Broncos and Kansas City Chiefs in the late 1960s but failed to catch on.

Amos turned to acting, getting his big break when he was hired for a recurring role as weatherman

"Gordy" Howard on "The Mary Tyler Moore Show." He parlayed that into the role of James Evans on producer Norman Lear's CBS sitcom "Good Times," which premiered in 1974.

"Good Times" was a significant advance in the portrayal of Black life in America on network television, dramatizing the daily struggles of a working class family living paycheck to paycheck in a Chicago tenement. Its emotional realism was anchored by Amos' portrayal of the gruff, hardworking patriarch, who was a tough disciplinarian but clearly loved his family and pushed them to stay in school and avoid the pitfalls of ghetto life.

popularity, however, Amos frequently clashed with Lear and the show's writers, and chafed under the ascendance of castmate Jimmie Walker, who played his son James Evans Jr., or "JJ." Walker's catch phrase, "Dyn-o-mite!" had caught on in a big way, and "Good Times" was increasingly tailored to make him the star.

As the show gained

Amos left the show after the third season in 1976, and the next year he starred in "Roots," based on Alex Haley's best-selling book.

The show examined America's history of slavery and was a ratings phenomenon, drawing over 130 million viewers. Amos played the adult version of Kunta Kinte, the story's main protagonist whose younger version was played by Levar Burton. Amos was nominated for an Emmy for his performance.

Amos made dozens of appearances on television shows over the next few decades, including recurring roles as Admiral Percy Fitzwallace on ABC's "The West Wing" and as Ed on CBS' "Two and a Half Men."

His big-screen appearances include "Vanishing Point" (1971), "The World's Greatest Athlete" (1973), "Let's Do It Again" (1975), "Touched by Love" (1980), "American Flyers" (1985), "Coming to America" (1988), "Die Hard 2" (1990), "Ricochet" (1991), "The Players Club" (1998), "My Baby's Daddy" (2004) and "Dr. Dolittle 3" (2006).

In December 2019, Amos appeared on a live televised version of one of the original "Good Times" episodes in ABC's "Live in Front of a Studio Audience," produced by Lear and Jimmy Kimmel.

He was married twice, to artist Noel Mickelson from 1965 to 1975, and to actress Lillian Lehman from 1978 to 1979.

to combat hate, not just during UAHW but throughout the year. She passionately expressed the collective responsibility to stand up against hate and the importance of inclusivity in policymaking.

"It feels sophomoric for me to say any form of hate is unacceptable in LA County. What's important is for all of us to figure out how we show up every day," Mitchell remarked, highlighting the everyday actions that contribute to larger societal change.

Capri Maddox, executive director of the Civil + Human

Rights and Equity (LA Civil Rights) Department, underscored the comprehensive approach Los Angeles is taking to combat hate.

"Hate has no home in Los Angeles," Maddox declared, emphasizing the city and county's unified stand against discrimination. She praised the LA vs Hate initiative and the broader network of 211 resources, acknowledging their crucial role in making a tangible difference for Angelenos.

Maddox's message was clear: the whole of government and the community must collaborate to ensure that every facet of public life is safeguarded against hate, reinforcing the ethos that if you target one of us, you face all of us. Her commitment reflects a powerful call to action for all residents to participate actively in fostering an inclusive community where diversity is not just accepted but celebrated.

The event also featured remarks from Robin Toma, executive director of the L.A. County Commission on Human Relations, who discussed the significance of the "Unity Under the Sun" mural as a symbol of resilience against division.

Toma praised the collective efforts of various community partners and stressed the need for increased civic engagement, particularly through voting, to oppose hate and division.

The celebration of UAHW not only marks a significant moment of reflection and action but also serves as a reminder of the power of unity and the critical role of community participation in eradicating hate. With a host of planned activities including webinars, community dialogues, and art projects, UAHW is set to foster increased

engagement and solidarity across neighborhoods, striving to create a more respectful and resilient community.

Residents of Los Angeles County are encouraged to participate in UAHW activities and to use the resources available for reporting hate incidents. By visiting LAvsHate.org or calling 2-1-1, community members can report hate crimes anonymously and access support services, contributing to a broader effort to track, address, and prevent hate in our communities.

members of CLBC in the State Capitol Annex Swing Spaces' press room. The bills address key issues such as housing disparities, maternal health, economic inequality, and educational access -issues that have long disproportionately impacted Black Californi-

"Today's bill signing represents a promise for the future based on years of hard work and dedication from the CLBC and our allies," stated Assemblymember Lori Wilson (D-Suisun City). "Together with Gov. Newsom, we are sending a powerful message that California is leading the way in repairing the harm done to Black communities. Today marks a victory, but only the first in the continued fight for justice."

AB 3089 passed the Legislature with unanimous bipartisan support. It acknowledges California's historical role in the perpetuation of slavery and its enduring legacy.

A Sept. 26 statement issued by Newsom states that the "signing event marks a significant milestone in California's ongoing efforts to promote healing and advance justice."

"As we confront the lasting legacy of slavery, I'm profoundly grateful for the efforts put forward by Chair Assemblymember Lori D. Wilson and the members of the California Legislative Black Caucus," Newsom stated. "The State of California accepts responsibility for the role we played in promoting, facilitating, and permitting the institution of slavery, as well as its enduring legacy of persistent racial disparities."

Authored by Assemblymember Reggie Jones-Sawyer (D-Los Angeles), AB 3089 requires the state to install a plaque memorializing the apology in the State Capitol.

Additionally, the bill imposes different duties on the Department of General Services (DGS) and the

Joint Rules Committee (JRC) relating to the installation and maintenance of the plaque. Both entities will receive money from grants and private donations to finance the upkeep of the plaque.

The Coalition for a Just and Equitable California (CJEC) – a statewide grassroots advocates, organizers, and mobilizers for reparations and reparative justice – say they do not recognize AB 3089 as reparations.

AB 3089 as reparations.

On Sept. 27, the organization's members posted their thoughts about the bill on the X platform formerly called Twitter. CJEC members describe the reparations package as "racial equity bills."

"An apology is not #Reparations, nor is it a first step toward Reparations. It's a step backward. We don't need any more words. We demand action. We demand Reparations," CJEC posted.

The following bills in the package were also signed by Newsom:

• AB 3131, Assemblymember Kevin McCarty (D-Sacramento) – Provides Equity Multiplier funding to school districts funding for education.

• AB 1815, Assemblymember Akilah Weber (D-La Mesa) – Prohibits discrimination based on natural and protective hairstyles.

• AB 1896, Assemblymember Issac Bryan (D-Ladera Heights) – Eliminates banning books without oversight and review in prisons.

• Senate Bill (SB) 1089, Sen. Lola Smallwood-Cuevas (DLos Angeles) – Addresses grocery stores and pharmacy closures.

Other reparations bills signed into law are SB 1348, Sen. Steven Bradford (D-Inglewood) designating specific public universities as California Black-serving institutions; AB 1984 (Weber), requires systematically review of pupils' suspensions and expulsions data; and AB 51, Assembly-Mia member Bonta (DAlameda), which supports Early Childcare and Education: California State Preschool.

Assembly Constitutional Amendment (ACA) 8 was part of the package, but it will be on the ballot as Prop. 6. The ballot measure would amend the state constitution to prohibit slavery and involuntary servitude as punishment for a crime if passed by voters.

Two reparations bills were vetoed by Newsom.

The first, Bonta's AB 1975 would have required the Department of Health Care Services to make medically supportive food and nutrition interventions a permanent benefit under the Medi-Cal program. Newsom stated that the bill would result in important and continuous General Fund costs for the program.

"I encourage the Legislature to explore this policy next year as part of the annual budget," Newsom stated on Sept. 26.

Bradford's SB 1050 was also vetoed. The bill would have addressed racially motivated eminent domain and restore property taken from its original owners or provide another effective remedy where appropriate, such as restitution or compensation.

Newsom said he did not sign SB 1050 because the bill "tasks a nonexistent state agency to carry out its various provisions and requirements."

That "nonexistent agency," the California African American Freedmen Affairs Agency (CAAFAA), would have been created by SB 1403, a bill introduced by Bradford. However, the Legislature did not bring that bill up for a vote on the Assembly floor during the last legislative session.

"I thank the author for his commitment to redressing past racial injustices," Newsom said in a Sept. 25 statement. "However, this bill tasks nonexistent state agency to carry out its various provisions and requirements, making it impossible to implement."

# State Leaders Urge Employers to Address Racial and Gender Pay Gaps

State leaders concerned about the persisting gap between the incomes of Black and White Californians are urging the state to take steps to address the problem.

On Sept. 18, International Equal Pay Day, the California Civil Rights Department (CRD) released new pay and demographic data that show Black workers are more likely to be found in the lowest pay range in the state, earning, on average, \$32,239 a year or less.

"While I am proud that California has one of lowest gender pay gaps in the nation, pay for women and communities of color remains among the state's lowest for paid workers," said California Business, Consumer Services and Housing Secretary Tomiquia Moss at a news briefing in Sacramento organized to share the data.

"The latest employee pay data show we still have work to do and, more importantly, shows exactly where employers can focus their efforts to realize opportunity and success for all Californians." Moss added.

The CRD research is based on data collected from large employers in 2022, covering about 8.3 million workers across the state.

While the state presents some of the nation's strongest equal pay laws and one of the smallest gender-pay gaps in the nation, its third annual report of large employer pay data shine a light on the fact there needs to be more equity when it comes to the income of women and communities of color.

The CRD is the state agency charged with enforcing California's civil rights laws. Its mission is to protect Californians from unlawful discrimination in employment, housing, businesses, and state-funded programs, and from racialmotivated violence and human trafficking.

According to the CRD's data, Black (45%), multiracial (45%), Latino (44%), and Native American (43%) workers were among those in the lowest pay range. In contrast, about a quarter of White workers (25%) and close to one-fifth of Asian workers (19%) were in the lowest pay range.

In addition, the report explains that less than 1 in 20 Latinos, and 1 in 10 Black and Native American workers were in the topearning positions, whereas nearly 1 in 4 White workers and 1 in 3 Asian workers were employed in the highest pay range.

White workers were almost twice as likely to be senior executives (62%) as compared to workers of color. California ranks third in the country for difference between men's and women

pay (13.3%), according to the report.

CRD Director Kevin Kish stated that gender pay gaps can have an ongoing effect "over the course of a single person's lifetime," and that difference in income can add up to hundreds of thousands of dollars in lost

"The data underscores the need for action. "We all need to do our part to build on our hard-won progress," Kish stated. "From corporate boardrooms to small, family-owned businesses, I urge employers to look at their hired through labor contractors is not included, the CRD points out. The findings in the report do not reflect California's entire employed workforce, which the U.S. Bureau of Labor Statistics estimated to be 18.4 million at the end of 2022.

Under state law, private job creators of 100 or more employees or workers hired through labor contractors are required to report pay, demographic, and other workforce data annually.

"We all share the responsibility to address the persistent inequality that affects communities up and down our state," Moss emphasized

Kellie Todd Griffin, President and CEO of the California Black Women's Collective Institute Empowerment Institute (CBWCEI),

reveals that Black women's labor force participation rate (LFPR) fell three percentage points between October and December of 2023. Although, Black women's LFPR remains higher than the LFPR of women of other races, the decrease points to job insecurity and instability in the labor market. It is also a sign that conditions could get worse for the Black women overall.

"Several economic factors contribute to the fluctuations and potential decline in Black women's labor force participation rates," CBWCEI report stated. "Structural issues such as persistent wage gaps, limited access to quality education and job training programs, along with systemic barriers to career advancement disproportionately affect Black women."

As a result of the passage of Senate Bill (SB) 973 in 2020, the state collects pay data to encourage employers to conduct selfassessments of pay disparities in their organizations, promote self-policing around equal pay compliance and support meaningful state and private enforcement of civil rights and antidiscrimination laws in the workplace.

On June 19, the CRD announced that it reached a \$15 million settlement with Snapchat to resolve a more than three-year investigation over claims of employment discrimination, equal pay violations, and sexual harassment and retaliation.

CRD alleged that despite its growth from 50 employees in 2015 to over 5,000 in 2022, Snap Inc., Snapchat's parent company, failed to set up measures to create an environment to ensure that women were paid or promoted equally. Instead, women were held under a glass ceiling and were told to wait in line.

"The gender wage gap is not just a statistic, it's a lifetime of missed opportunities for women — especially women of color — who face the compounded impacts of gender racial and inequities," stated California First Partner Jennifer Siebel Newsom

"The wage and wealth gaps rob women and their families of financial security, career advancement, and the ability to build wealth for future generations. In California, we're working through our Equal Pay Pledge to close the gap and normalize pay equity."

# Prop 33 Will Allow Cities and Counties to Enact Rent Control

Landlords across Caliare currently allowed to set their own rental rates when new tenants move in. Prop 33 would repeal the state law (the Costa-Hawkins Rental Housing Act) prohibiting cities and counties from capping rents on singlefamily homes, condominiums and apartments built after 1995.

By repealing the act, the initiative would allow cities and counties to limit annual rent increases on any residential housing and limit the initial rent for a first-time tenant. Any local laws currently inoperative Costa-Hawkins under would take effect upon its repeal.

The initiative would also add language to California's Civil Code prohibiting the state from limiting "the right of any city, county, or city and county to maintain, enact or expand residential rent control."

Justice for Renters, which is sponsored by the AIDS Healthcare Foundation, is leading the camother state except Florida and Louisiana.

Representatives from the Yes on Proposition 33 campaign could not be reached for direct comment. However, Presidential candidate Kamala Harris recently showed her support for the proposition in an ad earlier in August.

"We applaud Vice President Harris's support of rent control. Here in her home state, voters have a golden opportunity to expand rent control by voting Yes on 33 this November," said Susie Shannon, campaign director for the Hawkins Rental Housing Yes on Proposition 33 campaign in a press release. "Kamala joins the California Democratic Party and over a hundred California elected officials in the movement for relief for renters. Her embrace of rent control definitely increases the momentum for Prop. 33."

Opponents of Prop 33 argue that rent control would worsen the state's housing crisis by lowering property values and disincentivizing developers from building new housing.

This would also drive

prices up for existing rental units, they point out. California Black Media (CBM) spoke to Nathan Click of Click Strategies on why he opposes the proposition.

"We're in a housing crisis as a state, and this is the exact wrong way that we should go about addressing it. Prop 33 has already been rejected twice by California voters, by nearly 60% in 2018 and 2020. They've rejected nearly identical measures. Non-partisan researchers at MIT have shown that measures like Prop 33 will result in an average reduction of home values of up to 25%."

NAACP California/ Hawaii State Conference President Rick L. Callender also opposes the proposition due to the impact he believes it will have to communities of color.

"Proposition 33 will hurt communities of color and exacerbate our homeless and housing crisis," said Callender in a release.

"Homeownership has been an essential path to wealth generation for Black and Brown families, and Proposition 33 will simply hurt individual homeowners, making it harder for Black and Brown families to build generational wealth."

A "yes" vote supports:

· Repealing the Costa-Act (1995), thereby allowing cities and counties to limit rent on any housing and limit the rent for firsttime tenants and

· Adding language to state housing law to prohibit the state from limiting "the right of any city, county, or city and county to maintain, enact or expand residential rent control."

A "no" vote opposes repealing Costa-Hawkins Rental Housing Act, which prohibits rent control on single-family homes and houses completed after February 1, 1995.







#### State Controller Malia **Cohen Releases Report** Providing "Best Practices" for Charter **Schools**

On Sept. 25, State Controller Malia Cohen released the Multi-Agency Charter School Audits Task Force (Task Force) report listing recommendations that reflect best practices to be adhered to – and implemented by - charter schools and local education agencies (LEAs).

The report titled "Audit Best Practices for Detecting and Curtailing Charter School Fraud" includes 20 recommendations applicable to school districts and

#### California Sues Exxon-Mobil for Dishonest **Recycling Claims**

Last week, California filed a lawsuit against Exxon Mobil.

On Sept. 23, Attorney General Rob Bonta accused the company of deceiving the public for decades, claiming that the plastic it produced was being recycled to reduce its impact on the environment.

ExxonMobil is the world's largest producer of chemical compounds that make plastic.

In the complaint filed in the San Francisco County Superior Court, the Departthe Bay, and Baykeeper filed a separate lawsuit regarding ExxonMobil's role in causing the global plastics pollution crisis.

#### Climate Week 2024: **Newsom Announces** New California *Initiative*

Gov. Gavin Newsom announced an environmental campaign at Climate Week NYC to encourage 1 million state residents to take daily actions to help tackle climate change.

The campaign urges residents to pledge that they will fight global warming with "everyday actions" such as composting, using public transit instead of driving, and planting trees or native plants. State officials launched the campaign at reduce gun violence and save lives. The agenda aligns with Gov. Gavin Newsom's goal to strengthen gun laws and prevent traumatic incidents of mass violence. Two days before the White House announcement, Newsom signed 24 bipartisan bills enacting new measures that increase protections against gun violence and domestic violence, as well as mass shootings.

"California won't wait until the next school shooting or mass shooting to act," said Newsom.

"Data shows that California's gun safety laws are effective in preventing gun-related deaths - which makes the ongoing inaction and obstruction by politicians in the pocket of the gun lobby even more reprehensible," he said.

The executive order stated that President Biden is establishing an Emerging Firearms Threats Task Force that consists of federal leaders from key departments and agencies. The task force is required to issue a 90-day report assessing the threats posed by unserialized 3-D guns and machinegun conversion devices and the capacity of federal agencies to detect and intercept the creation of these devices. The task force will provide an interagency plan to combat the threats. Congress will grant funding and authority to federal agencies to help the task force achieve the mandated objectives.

Biden-Harris The administration says, "Congress must act" and acknowledges that there is more work to do regarding gun violence prevention actions that can save lives.

Newsom commended the Biden-Harris Administration's "leadership in advancing - yet again life-saving policies to make up for Congress's continued failure to protect our communities from gun violence.'


#### New California Law Will Protect Students **During Extreme** Weather

On Sept. 22, Gov. Gavin Newsom signed a bill that will protect students from extreme weather conditions by requiring the California Department of Education to develop guidelines for school districts to implement during weather patterns harmful to student health.

Authored by Sen. Hurtado Melissa (D-"Yahushua's Sanger), Law" or Senate Bill 1248 addresses an extreme heatrelated fatality in Lake Elsinore. During the summer of 2023, a student died after participating in physical education suffered extreme heat-related ill-

"No student should ever lose their life on campus to extreme weather when we can take steps to protect them by preparing statewide plans to minimize exposure to the most harmful elements of exposure," Sen. Hurtado stated last Spring. "I commend the family of Yahushua Robinson, the twelve-year student who lost his life due to heat related illness during on-campus physical education, for lending their emotional strength and compassion for others in order to help ensure that no other student loses their life this way."

"It is an actionable promise to prioritize student wellbeing, honor the life of Yahushua, and prevent future tragedies."

#### More Than 1.2 Million Youth Pre-Registered to Vote, Secretary of State Weber Announced

Secretary of State Shirley Weber announced on Sept. 26 that more than 1.2 million young people between the ages of 16 and 17-yearsold have pre-registered to vote since the state launched the initiative in September 2016. The state program automatically activates voter registration for pre-registered youth when they turn 18 years of

Weber, who has visited dozens of high schools across the state to promote voting initiatives, said that students are eager to vote and look forward to casting their first ballot, and "the numbers back them up."

"Young Californians want to be engaged, active participants in our democracy and they can position themselves to do so by preregistering to vote," said Weber.

Weber said that she is committed to encouraging young people to pre-register to vote, adding that she looks forward to partnering with the California Department of Education, State Superintendent of Public

Instruction Tony Thurmond, school officials, and leaders of communitybased organizations to expand this effort.

According to Weber's office, approximately 42% of young voters are registered Democrats, while over 13% are registered Republicans. Another 35% of young voters registered as having "no party prefer-

"I was surprised to learn, although charter schools brought us to this work and brought us to this table, a majority of the recommendations apply to all public schools. So, there is an added benefit to every-

There are 1,300 charter schools operating in the state, according to Cohen.

The Task Force was assembled by a court order after 11 individuals affiliated with charter schools charged by the San Diego District Attorney were convicted of multiple counts of fraud. The case turned out to be the largest fraud scheme committed against California since the state adopted public charter school legislation in 1992, according to San Diego District Attorney Summer Stephan.

'Controller Cohen didn't hesitate to take action to seal the cracks that were exposed by our successful prosecution of this widespread charter school Stephan scam," said. "Thanks to the task force, we are ensuring that moving forward, criminals will not be able to perpetrate large-scale scams that previously took advantage of California taxpayers, parents, and students."

The task force report is broken down into four categories. Cohen and task force members recommended a Certified Public Accountant (CPA) authorization, qualifications, training, and K-12 Audit Guide Compliance; rotation of CPAs and notifications of late audit reports; K-12 audit guide; and disclosures of audit reports.

As the chief fiscal officer of California, Cohen is responsible for accountability and disbursement of the state's financial resources. The Controller has independent auditing authority over government agencies that spend state funds.

This accomplishment and the next actions that be taken ensure accountability, transparenand the significant

ment of Justice (DOJ) alleged that ExxonMobil caused and worsened the global plastic pollution crisis. For decades ExxonMobil created marketing campaigns and public statements promising that recvcling would address the large amount of plastic waste the company pro-

Bonta aims to stop the company's deceptive practices that threaten the environment and the public. He also seeks to secure an abatement fund, disgorgement, and civil penalties for the harmful impact of plastic pollution on the environment and communities statewide.

"Plastics are everywhere, from the deepest parts of our oceans, the highest peaks on earth, and even in our bodies, causing irreversible damage - in ways known and unknown - to our environment and potentially our health," said

Bonta argued that ExxonMobil lied to the public to further its recordbreaking profits at the expense of the planet and jeopardize people's health. The state claims that only 5% of plastic waste was recycled nationwide, and the company's recycling rate has never exceeded 9%. In the lawsuit, the state urges the court to hold ExxonMobil accountable for its role in actively

harming the environment. Lauren Kight, spokesperson for Exxon-Mobil, argued that the state is responsible for harming the environment and is looking to pass on the blame.

"For decades, California officials have known their recycling system isn't effective," said in a state-

"They failed to act, and now they seek to blame others. Instead of suing us, they could have worked with us to fix the problem and keep plastic out of landfills," she said.

In addition to the DOJ's lawsuit, non-profit organizations such as Sierra Club, Surfrider Foundation, Heal Climate Week in New York City, a gathering of climate leaders from government, industry, as well as activists that seek to promote solutions to conserving the environment.

The climate pledge aims to motivate residents to live sustainable lives, reduce their reliance on fossil fuels, and overcome the feeling of anxiety and helplessness due to the impact of climate change.

The campaign is based on the California Climate Action Corps, a climate change volunteer program that the state launched four vears ago. Over the years, the program has grown to 400 members and helped model American Climate Corps across various states and the White House.

Josh Fryday, the chief service officer with the governor's office, stated the campaign has mobilized thousands of volunteers to have a real impact on the environment. The Governor's office also plans to partner with local organizations in various communities statewide to expand the climate change campaign.

"Together, we can create collective impact," said Fryday, "and our partners, by organizing people on campuses and in the workplace and in their cities, are going to demonstrate that we can do this."

State officials serving in the governor's administration stated that they have shifted their focus from discussing environmental issues to inspiring action that tackles climate change in communities statewide.



# Martha Blanding Reveals 'A Black Woman's Journey Through the Happiest Place on Earth'

Exceptional character and special talent make for an extraordinary person. Martha Blanding is the first Black woman to retire with 50 years of service with The Walt Disney Company.

The South-Central native became a Disney Legend at D23 2024, among stars like Angela Bassett, Jamie Lee Curtis, and more. Blanding is the very definition of a trailblazer who defied the odds to become Disney's first Black VIP Tour Guide in the early 1970s. On October 1, her new book, "Groundbreaking Magic: A Black Woman's Journey Through The Happiest Place on Earth," will explore her personal journey through a changing America.

Blanding grew up in the Compton/Watts area with her twin sister and two

Diana Ross, Cher, Elton John, Cary Grant, and Rock Hudson. She was promoted to VIP Tour Hostess in less than a year, touring legendary entertainment notables and numerous domestic and international dignitaries.

Blanding became the first Black female in management at Disneyland, eventually becoming the senior manager of Disneyland Resort Merchandise Special Events, where she worked with worldrenowned artisans, celebrities, and Disney Legends. Along the way, she helped pioneer and produce the Official Disneyana Convention, a forerunner of today's D23: The Ultimate Disney Fan Experience.

After a few years, Blanding was asked to enter a program to help promote employees, which launched a long portion of her career as a merchandise buyer for the park. She

She wants to continue to inspire those looking to break barriers and extend their reach in the industry. While explaining her excitement and reminiscing about her credentials, Blanding said "I feel excited; the whole experience is amazing, and I am honored. Looking back over 50 years, I had no idea I was the first of anything! Somebody must have been keeping tabs because the next thing I knew, I had been the first permanent Black tour guide and VIP Hostess at Disneyland, along with being the first Black female buyer, the first Black woman in management at the park [and of the first in the entire Walt Disney Company], and the first Black employee in the entire company to retire with a half-century of serv-

ice." "My journey is a great American success story, not just for me but for my family as well. My parents were good, hardworking, high school sweethearts who grew up in North Carolina during the Great Depression. Eventually, they came to California, hoping for a better life, and started a family. This was during the 1940s, 50s, and 60s, so the book reflects much of what we experienced here in L.A. [lots of good and bad]. And, of course, there is my unbelievable Disney career that includes lots of fun and misadventures celebrities, artists, authors, and athletes. Now, after being designated a Disney Legend, I want people to be inspired by my story. If a little girl from Watts (who was told by her high school counselor that I would never make it in corporate America) indeed make it, so can you! You'll laugh, cry, and be reminded that you have the magic to make your own

dream come true." Upon her retirement in 2022, Blanding has been honored by Disney and her story will be told all over the nation with GROUND-BREAKING MAGIC: A Black Woman's Journey Through The Happiest Place on Earth, available in stores and online on Tuesday, October 1, 2024.

Blanding became the first Black American to retire with a half-century-long career with The Walt Disney Company and was named a Disney Legend in 2024. As the first full-time Black tour guide at Disneyland Resort, the first full-time Black VIP Hostess at Disneyland Resort, the first Black female in management at Disneyland Resort overseeing multi-million dollar-generating merchandise-based special events, many featuring globally acclaimed artists, authors, and celebrities, including Thomas Kincade, Shag, Noah, Mickey Mantle, Kurt Russell, Annette Funicello, James Earl Jones, Marie Osmond, and Julie Andrews. She was also acknowledged for being the first Black female merchandise buyer at Disneyland Resort, which also made her the first Black female merchandise buyer in the Disney Parks division of The Walt Disney Company, and the co-founder of the first Black diversity group, called PULSE, at the Disneyland Resort, along with being its chair/co-chair of PULSE for its inaugural six years with Freda Hardison.

Amongst all her inaugural accomplishments, Blanding co-founded PULSE, a Business Employee Resource Group (BERG) for Black cast members and employees. PULSE stands for People United to Lead





This may seem like great news for the state, but the city of Los Angeles has seen rather different results when it comes to maternal health.

According to the National Institutes of Health, the best way to raise awareness is to: "Listen to women and their family members' concerns before, during, and after delivery, engage the family in creating a supportive environment, discuss and make available options for traditional practices that may vary by culture and personal preferences, educate about warning signs during pregnancy and the postpartum period, use culturally acceptable and easily understandable methods of communication, and link women with a substance use disorder to family-centered treatment approaches.


Ms. Morris delivers the same sentiment of helping the goals of the neighborhood youth. 



#### Remembering and Recounting Seasons of Righteous Struggle: More Notes on Resistance From a 1960s Lecture

As we started the month of September with remembering and marking the 59th year and 236 seasons of work, service, struggle, and institution building by the organization Us with notes on revolution from a 1960s lecture, we end the month with more notes as follow up to our Sunday Soul Session, with a Saidi and Simba Roundtable on "Us, Keeping the Legacy Alive: Continuing the Struggle, Keeping the Faith and Holding the Line.'

We really have to watch our language when we talk and interpret history and current realities and always interpret things and speak from a Black frame of reference. Even people who are supposed to be conscious sometimes slip into a white way of conceiving and saying things. But if we are constantly attentive to how we understand and interpret things from a Black frame of reference, a Black perspective, we won't make such self-diminishing and undermining mistakes.

Therefore, a Black day is a good day for us; it's a "white day" when things are really bad. The point here, as (Haji) Malcolm taught, is that the logic of the oppressed cannot be the logic of the oppressor if they want liberation. And likewise, a language of liberation must inform that logic, so that it is a radical and liberated way of thinking and speaking.

Like (Frantz) Fanon, we want to bring into being a new history and people, a decolonized and liberated people. And that means, as Malcolm taught, learning the lessons of history and building on that knowledge to work and struggle for a radically improved present and a more promising future. We of Us have created a calendar of history which is both a marking and remembering of the past, an agenda for the present and a mission for the future. It is a seven-year calendar and cycle of things done, things being done, and things to do.

The year 1965 is the Year of Revolt and represents a new consciousness, a new commitment to struggle and a new turning in our history. In fact, the moment we stood up, and massively resisted in self-defense our oppression, we began to bring into being a new history for ourselves, this country and, in a real sense, the world. It was a new phase of the Black Freedom Movement, the end of the integrationist civil rights period and the beginning of the nationalist Black Power period.


Last year, 1966 was the Year of Black Power, the year Black people begin to think in terms of power. It was now a concern with power to define ourselves, to defend ourselves, and to develop ourselves. And we of Us define Black Power as our collective struggle to achieve three major goals: self-determination, respect and self-defense.

By self-determination we mean as the Second Principle of the Nguzo Saba (The Seven Principles) teaches us, "to define ourselves, name ourselves, create for ourselves and speak for ourselves." And we also mean controlling our destiny and daily lives, controlling the space we occupy and defining, defending and developing our interests everywhere in this country and the world.

By self-respect, we mean a struggle to always affirm and reaffirm the beauty and good of our Blackness, the beautiful soulfulness of ourselves, our Africanness, our lives and our culture, the special way we think, feel and act in the world. And by self-defense we mean standing up to defend ourselves against attacks and oppression, demonstrating our deep valuing of ourselves and demanding recognition and respect for our human rights as Black people, as Malcolm

We cannot fantasize about a chariot coming to carry us to freedom; we must fight our way all the

way to this essential goal. There is no alternative, Fanon says, to a people taking responsibility for its own life, its own liberation, its own way forward. And he

states that it's our responsibility as leaders, activists, teachers and organizers to get the masses to see and accept that "everything depends on them; that if we stagnate, it is their responsibility and if we go forward, it is due to them also." This, Fanon says, is at the heart of any real political education of the masses.

This is the Year of the Simba Wachanga (The Young Lions). This is the year that young people boldly showed their continued commitment to struggle, to revolt. It is young people especially who made the Revolt here in '65 in L.A., and this year in Detroit and Newark. It is especially young people here and those there that rushed into the streets to confront the police who are seen as an occupying army. It is they who set the cities on fire with struggle, shut down the streets, and demanded a new way for whites to relate to us, in fact, demanding that they respect us as a people, that they respect our rights, our human rights as Malcolm taught us.

We of Us recognized the role youth must play and would play in the struggle, if they were mobilized, educated and organized. So, when we decided to celebrate Malcolm's birthday, which we call Kuzaliwa, we called on Black people to stay home from work and school. But we knew people at work would be reluctant to do this for several rea-

So we focused on calling students out of school, passing out leaflets, using phone trees and personal contacts, going to the schools and talking with them as they went in and came out, and assigning Simba inside the different schools the task of talking with them about the issues and urging them to walk out and come to celebrate Malcolm. And the students, the young people, like us, dared to defy the rules, to go against policy, and to dismiss any laws that would prevent their celebration of their saint and sacred hero, Min. Malcolm X.

This is why we of Us teach that it is especially when you are young that you must act for the good of your people, that you must join the struggle, and dare to confront and defeat the enemy and oppressor. It is at this time of life, you are most free of fear and apprehension about the loss of freedom, the loss of jobs or the loss of things important to older married and settled people and parents. For as people become older and possessors of things, things can begin to possess them. And many will not want to risk losing these things. Also, it is important for me to say that not all older people will sit on the side, guarding their gains and possessions. In our own organization Us, we have older people who, like our first Simba commander, Ngao Damu and others, who are as radical and revolu-

tionary as anyone. As Malcolm taught again, it is not age in itself that determines whether you will be revolutionary or not; it is your will to act. It is for Malcolm your readiness and willingness to act in revolutionary ways that determines whether you are young or not. Therefore, youthfulness is determined not by how many years you have, but how much heart vou have.

For if you don't have the heart, the heart to struggle, to serve our people, to defy and defeat our oppressor, you are, for Malcolm and Us, already old. That's why Malcolm says, 'If you're really for some action you're not old. I don't care how old you are. But if you're not ready for some action, I don't care how young you are, you're old."

Certainly, it takes a young mind and heart to practice and push the Us program: to educate, mobilize and organize our people into a self-conscious freedom fighting force, to defend the people and work and struggle with them to better their lives and liberate themselves. Therefore, we of Us, following Malcolm, call for and need the young at heart, the young in mind, regardless of age in years, who are willing to learn, to work, to serve, to build and to struggle strongly and resolutely for a new community, a new people and a new world.


Brothers, we can't get caught up in everything we see and hear coming out in mainstream media. Let me give you an example. I read the Los Angeles Times every day, and every Thursday, I read the Los Angeles Sentinel. I read the Times to find out what's going on, and I read the Los Angeles Sentinel for the truth — through the

# Let's All Support National Bullying Awareness Month

**Bullying Awareness Month** and during this time we should all acknowledge and bring awareness to the subject of bullying especially because of the devasting and ongoing negative impact that is has not only amongst our youth, but in our society as a whole. Bullying is an extremely serious matter that continues to disrupt the lives of our children. Many children suffer in silence, harboring inner pain that stemmed from being bullied. Most children won't tell anyone about the negative experiences that they have with other children which will ultimately lead them to finding harmful ways to release their suppressed, dark emotions. We have seen on countless occasions various acts of violence within our schools that leave parents questioning if schools are still con-

their children that they once were. And with pediatric suicide on the rise, it's even more paramount that the subject of bullying is brought to the forefront.

Statistics researched by the American Society for the Positive Care of Children showed that 70.6% of young people said that they have been bulled in their schools. 70.4% of school staff have witnessed bullying and 62% have witnessed bullying two or more times a week or more. Their research also showed that when bystanders intervene, the bullying stops within 10 seconds 57% of the time.

The worst possible result from being bullied is when a child takes their own life because they predict that the bullying will never end. Research from the Children's Hospital Association showed that suicide and self-injury have become the most common

mental health conditions seen in the children hospitals' emergency departments. Data from the Children's Hospital Association's Pediatric Health Information showed that between 2016 and 2022. children's hospitals saw a 166% increase in emergency department visits for suicide attempts and selfinjury amongst children from ages 5-18. Think for a moment how low a child must feel to build enough courage to not only formulate a plan, but to take action, ensuring that the self-harm they inflict will end in death.

Our goal as a community should always be to make certain that a child feels safe in any environment. Will every day in a child's life be easy? No. Will there be lessons to learn? Absolutely. However, the lessons should never make a child feel unsafe or cause them to be harmed

physically or emotionally. We can all help put a stop to bullying by constantly talking to our children. Ask them how they feel, ask them if anyone is bothering them, and make sure they know that they can always tell someone if they ever feel afraid. We also want to make certain that our own children are not bullying other children. Pay close attention to your child's behavior when they are at home. Do they seem angry often, do they play well with their siblings, do they show signs of defiance, are they disrespectful towards you or other adults? Remember a small issue will eventually turn into a big issue if not addressed immediately. Correction starts within the home first, so parents please do your diligence in addressing your child's behavior. If you feel that your child's behavior has become unmanageable, seek help.



Latrice Slaughter It takes a village to raise a child and there are plenty of resources available to assist in areas such as behavior management. Contact your local child therapist and set an appointment to address any behavioral concerns you may have. You can also contact the Children's Hospital of Los Angeles as they have various resources and programs that can assist with mental health and bullying. Also, be advised that

a child becomes a bully because they are hurting inside, and the easiest outlet is to bully another child. So again, communicate with your child, spend time with them, monitor what they watch on television and on social media. Remind them of how special they are and assure them that their feelings matter. Above all, remind your child that they are loved!

#### The 2023 Assessment Roll

I come before you this month to let you know we are in the final stages of fulfilling our Constitutional mandate and probably the most significant item I do as your Assessor: The Assessment Roll.

sidered the safe haven for

As I visited with you last year about this same time, some of you were scratching your head and wondering: What is the Assessment Roll? Others are more than familiar with the comprehensive tally that values more than 2.5 million real estate parcels in Los Angeles County that results in the very tax dollars that goes to pay for our vital public services, such as police, fire, schools, and even libraries, to name just a few.

In the meantime, I have announced the May 15 forecast for the 2023 Assessment Roll to the Board of Supervisors that taxable property values are anticipated to increase approximately 5% over 2022, marking 13 years of continuous growth. Our fiscal year runs from July 1 to June 30. Assessments are based on the value of property as of the lien date of January 1, 2023.

The May Forecast projects the anticipated growth rate for the annual Assessment Roll which closes in early July. The forecast is an important tool for local governments as they prepare their annual budgets in anticipation of property tax revenues. The Annual Assessment Roll is the inventory for all taxable property in the County and can provide insight into the state of the real estate market and the local economy.

As an example, the Assessment Roll last year grew by a record \$122 bil-

lion, which is almost 7% in growth over the previous vear's Assessment Roll and is approximately \$1.89 trillion in total net value. The total net value translated to nearly \$19 billion in property tax dollars.

The Roll, as it is known, contains the assessed value of all real estate and business personal property in

the County's 88 cities along with the unincorporated areas. It also breaks down the number of single-family residential homes, apartments and commercialindustrial parcels.

The 2022 Roll was comprised of 2,589,521 million real estate parcels and business assessments, including 1,889,000 singlefamily homes, 250,000 apartment complexes, 248,000 commercial and industrial properties and more than 165,000 business property assessments.

The Roll also is driven in large measure by real property sales, and that added \$69.6 billion to the Roll last year; the CPI adjustment mandated by Prop. 13 reached its full potential of 2%, adding an additional \$34.2 billion; and new construction added another \$6.3 billion.

I always like to remind the readers that although the Roll grows in assessed value, that doesn't necessarily correlate to an increase in the property tax bill. Most property owners last year only saw a 2% adjustment prescribed by Proposition 13.

All this exhaustive effort goes into the Assessment Roll because it is the very foundation of Los Angeles County's property tax system. If the Roll is not thorough and accurate, the County might not receive the necessary funding for the year and critical government services are left wanting. Others cannot do their job until we do ours.

The 2023 Assessment Roll will be released in early summer and, yes, you can expect it will still be affected by this past pandemic, even though the requirements are now lifted. The economy may be sluggish while it reacquires its footing. We will know more as the details are finalized.

Deborah Riley Draper is an award-winning filmmaker and storyteller notable for advancing the untold truths of Black people and their culture.

Known for documentaries like "Olympic Pride, American Prejudice," and "The Legacy of Black Wall Street," Draper brings vigor, compassion, and brilliance to the screen.

Draper's latest film, "Ratified," is a documentary that chronicles the century-long struggle for constitutional gender equality focusing on Virginia's role in ratifying the Equal Rights Amendment (ERA) as the 38th and final state.



Praising Mohamed's screenwriting of such compelling monologues, Chestnut said, "Another thing that I love about working with Raamla is the depth of the messaging. It's not only just the depth of the characters, but it's the depth of the messaging.

"To have not just a woman speak for a woman, but a man speak for a woman, they're both equal, but to have a different type of voice to say, 'Hey, we support you, we see you and we're here for you.' In the show, Jax and her girlfriends

are always there for each other, so to also have another man be there, that imaging and that messaging was needed, and it's very real."

Chestnut and Corinealdi previously worked together on the medical drama "Rosewood." Chestnut shared his endearing experience behind the scenes of "Reasonable Doubt."

"I love going to Emayatzy's set, it was really a breath of fresh air to see Kerry Washington, who's the executive producer, Raamla Mohamed, who's the creator, writer, and showrunner, and Emayatzy as the star. It was literally one of the best sets that I've ever been on.

"The tone for the show and how the set is run is conveyed by those three people and it was such a pleasure. I was so happy to be there, everything ran like a well-oiled machine."

The Cerritos native

went on to say that he and Mohamed both being from the Los Angeles area, helped to add another level of "relatability" to his character and his experience working on the show.

While the season finale for "Reasonable Doubt" is near, Chestnut has a new series for fans to enjoy. He's currently shooting the CBS medical drama "Watson" based on the Sherlock Holmes stories. Chestnut plays the leading role of Dr. John Watson, a physician and former consulting detective.

To dream is to resist. For poet, writer, and publisher Camari Carter Hawkins, dreaming is more than personal ambition—it's a form of survival.

From her earliest days of journaling to the founding of Mama's Kitchen Press, Camari's dreams have always been an act of rebellion against the limitations placed on Black women. As she writes in her poem "Dreams:"

are child-like and fragile guard them with bubblewrapped prayers

secure them from shattering falls and thieves.

These lines encapsulate the tenderness and vulnerability of dreams but also the fierce protection they require. Camari knows that dreams are fragile—easily shattered by the harsh realipoetry seriously, experimenting with form and exploring the depths of her identity. In

2019, Hawkins birthed a bold new dream: to create a literary space dedicated to amplifying Black voices. Two years later, Mama's Kitchen Press was born. This press, founded on the need for writers, has since grown into a powerful force for underrepresented voices.

This realization fueled her desire to fill the gap and ensure that Black writers had a platform to share their stories with the world.

Hawkins's personal journey of finding her voice mirrors the struggles of generations of Black women who have fought to preserve their dreams. In founding Mama's Kitchen Press, Camari not only honors the legacy of her mother and grandmother but also creates a space where future generations of Black women can dream freely, without the fear of being silenced.

Yet, even as she limps forward, Camari refuses to stop running. Her belief, though fragile at times, continues to propel her toward a future where her dreams—and those of others—become reality.





At times, Brown will be in professional settings where she is the only Blackowned sports agency owner. Yet, that does not deter her from providing for her clients and being an advocate for athletes.

"My approach is very unique because it is publicity driven into sponsorship," Brown said. "I'm looking at the clients that I've worked with more than 10-15 years later and some of them are serving on LA2028 Athletes Advisory Committee."
