A plethora of bullets rained down on 22,000 country music festivalgoers during the "Route 91 Harvest Festival" in Las Vegas, Nevada, leaving at least 59 people dead and 527 injured. The Sunday night attack will be reThe White male gunman, identified as 64-year-old retiree Stephen Craig Paddock, used a hammer-like tool to smash out the windows in his hotel room located on the 32nd floor of the Las Vegas Mandalay Bay Hotel and Casino.

Concert goers fled, hid under cars, and ducked behind concession stands while Paddock opened fire for over 10 minutes.

During the chaos, SWAT teams used explosives to enter the gunman's hotel room where

Beauty and Brains: Scientist and Miss USA Titleholder Kára McCullough Encourages Young Women to Pursue STEM Education

Now that Kára Mc-Cullough has gotten settled into her role as Miss USA 2017, the 26-year-old retired Navy veteran and STEM research scientist currently spends her days inspiring young girls and women around the world. Check out our exclusive interview with McCullough below, as we go deeper into her life and passion for science education.

Los Angeles Sentinel - How did growing up in several countries around the world shape your perspective on life?

Kára McCullough -Growing up in several countries exposed me to diversity and inclusion at a very young age. My mother was a chief petty officer in the United States Navy, allowing our family to live in different countries as well as experience and appreciate new cultures. My childhood friends all came from different ethnic and religious backgrounds, and I'm so happy to be connected with them to this day.

LAS - What advice do you have for women of color who find it difficult to embrace their natural beauty?

KM - I encourage women of color – and all women – to embrace what makes them whole and happy. The positive support Deshauna and I received after walking across the Miss USA stage with our natural hair went beyond my expectation. I hope that the women watching were inspired and empowered to walk into work or school that next day, embracing their natural beauty.

LAS - What challenges have you experienced in your role as Miss USA?

KM - I believe one of the most important traits of growth is acknowledging that there will be challenges along your path to success. What solidifies growth is the pragmatic approach to solving them. Challenges

exist, but I remind myself that I am in this position to carry out my mission to encourage STEM education in young women.

LAS - What is the most gratifying part about being a scientist? As a woman of color, have you faced any adversity in this field?

KM - The most gratifying part about being a scientist would be sharing my passion with students and seeing the growth and excitement that comes from STEM education. When it comes to the adversity women face in the workplace, there's still so much more to accomplish. I've learned to counter adversity by confiding in mentors who may have experienced the same

for Kids.

KM - SE4K is a 501(c) (3) geared toward youth Science, Technology, Engineering, and Math (STEM) enrichment that begins with our youth. We offer specific interactive science programs for participants in grades K-5, 6-8, and 9-12. Our program focuses on teamwork, selfconfidence, fun, and career exposure. Most recently, I worked with the NYC Department of Education to speak to students during summer programs. I am also working throughout the District of Columbia, where I continue to empower students to explore career fields in STEM.

LAS - In what ways has your life changed since becoming Miss USA? How

have you responded to the spotlight?

KM - I hold my title as Miss USA with pride. I love every moment of having a busy schedule, especially knowing that I'm making an impact in someone's life. I have a lot of long days and long nights, yet every day is different. My influence is on a larger platform now, but I've always been aware of my choices so that I could become a successful person.

LAS - You competed twice to win Miss District of Columbia USA, in 2015 and 2016, finally earning your crown this year for Miss USA. Describe what motivated you to continue competing. Why is it important that women and young girls around the world continue to persevere?

KM - After competing twice and getting second runner up each time, I decided to give it one more try and put all my resources into preparing. I figured if I could make it that far, there is something within me that I need to awaken. It's important for women and young girls to have qualities of perseverance and persistence because failure is often the greatest feedback for success. Talent can exist, but perseverance and persistence will always take precedence.

Michael Jordan, Oprah Winfrey, Sheryl Sandberg, and Brian Acton are a few examples of people who persevered and persisted.

LAS - We hear that cooking is a favorite past time of yours; will we ever see you take to the big screen with your cooking skills?

KM - I would love to! I've always been interested in attending culinary school and sharing my passion with a bigger audience.

LAS - What do you hope to accomplish in your term as Miss USA and what is the legacy you want to leave?

KM - In my term, I will expand my science program and encourage young women in underrepresented areas to find interest in STEM. It will make my heart full if my STEM enrichment program leaves a legacy to the young women I've met. I want those students to find excitement in science and consider themselves in a future STEM career.

Rep. Karen Bass hosts Africa Braintrust at 47th Congressional Black Caucus Foundation Annual Legislative Conference in Washington, D.C., to focus on renewing commitment and engagement with Africa

Recently, Rep. Karen Bass hosted the Africa Braintrust at the 47th Congressional Black Caucus Foundation Annual Legislative Conference in Washington, D.C.

This year's forum was highlighted by Liberian President Ellen Johnson Sirleaf and Ambassador Linda Thomas-Greenfield, former Assistant Secretary of State for the Bureau of African Affairs.

The forum focused on ways to renew commitment and engagement with Africa.

"Encouraging commitment and engagement with Africa is important now more than ever because we have an administration that has yet to lay out what our policy will be," Rep. Bass said.

"An Assistant Secretary for African Affairs has yet to be appointed and the budget put forward by the White House has called for deep cuts to the Department of State and USAID. Given the long history of U.S.-Africa relations, this is a good time to illustrate our continuing commitment to engaging with African nations."

The event consisted of three panels discussing security and insecurity in Africa, encouraging prosperity across Africa, and developing meaningful partnerships with African

communities and nations.

"Africa currently has a population of more than one billion people, a rapidly expanding middle class and dozens of economies that are rapidly growing," Rep. Bass continued.

"The opportunities for U.S. business are immense,

in sectors ranging from consumer goods and manufacturing to agriculture and energy.

"As the prosperity of Africa's citizens increases, a social and economic opportunity arises. The continent needs more than patrons; it needs partners who

help build up the capacity to grow," said Bass."

President Sirleaf is stepping down at the end of 12 years serving as the President of Liberia, during which she has ushered in a new era of peace never before seen in the country. "Only a woman could

do it," President Sirleaf said to a roaring crowd.

Many countries in Africa are facing potential great opportunities in the coming decades, including a vastly growing youth population, new infrastructure, and increasing investments that will contribute to continuing economic growth across the continent.

Despite existing and new challenges with political unrest, food insecurity, and other economic uncertainty, Braintrust panelists encouraged strong engagement with diaspora communities and new partnerships between governments, businesses, and communities.

"We have to make sure to continue the work discussed here today," Rep. Bass concluded.

"I look forward to seeing the initiatives that come to fruition because of the discussions had here today in the year to come."

After the forum, Rep. Bass awarded the Congressional Black Caucus Foundation Phoenix Leadership Award to Ambassador Thomas-Greenfield for her extensive work on the continent throughout her professional career.

"When my mom used to walk me to school when I was young, we never imagined I'd be where I am today," Ambassador Thomas-Greenfield said.

The reception was attended by Ambassador of Cote d'Ivoire to the United States, His Excellency Daouda Diabate and former U.S. Assistant Secretary of State for African Affairs Johnnie Carson along with many former coworkers from the State Department.

Following Our Foremother Fannie Lou Hamer: Courageously Questioning America

In these uncertain and unsettling times of the selfsilencing of the lambs, the fearful and fatigued surrender of summer soldiers, and the out-of-control hatefilled howling of ice age winter wolves, lessons and models of struggle and resistance from the sacred narrative of our history are both appropriate and compelling. Certainly, in this month of October, which is the month of her birth, the revered freedom fighter and human rights activist, Fannie Lou Hamer, wife and companion in struggle of Perry "Pap" Hamer and daughter of James Lee and Lou Ella Townsend, stands out as an excellent and instructive model for us all. For she challenges us to a constant courageous questioning of things.

Mrs. Hamer begins with constant and courageous questioning of her social situation, the conditions of racial oppression and racism, and the social savagery that this embodied and expressed. She questions America's self-congratulatory self-depiction as the "land of the free and the home of the brave". Thus, she says, "Now the question I raise: is this America, the land of the free and the home of the brave? Where people are being murdered, lynched, killed, because we want to register to vote"? and again "because we want to live as decent human beings"? She tells us, "I've heard several comments from people that was talking about 'with the people, for the people and by the people' when they describe this country and its government". But she asserts, "Being a Black woman from Mississippi I've learned that long ago that's not true; it's with the handful, for a handful, by a handful. But we going to change that".

And what shall we say about the claims of bravery in the face of a history of murderous terrorism against the unarmed and defenseless, the demonstrators, marchers, activists-young, middle aged and old; the imprisoned women beaten into bad health and in sexualized ways as she was herself; children attacked with dogs and high-power fire hoses; shootings, killings, lynchings and burnings of all, in the name and need of something White in its most ghastly and ghoulish forms? Mrs. Hamer also raises question about the sanity and humanity of a country and people who would kill without moral conscience or social constraint innocent Africans for "reasons" of racial hatred and dominance and also kill their own White sons and daughters who denounced this racist barbarism and found common cause with the oppressed African Americans in rejection and resistance.

Based on the level and extent of violence and hatred which infect the American body politic, Mrs. Hamer offered what might seem to be a startling assertion to those nurtured on decades of self-deceptive and self-congratulatory accounts of what America has

done for its people and the world without recognition of what it has also done to its people and the world. She states that "America is a sick place and man is on the critical list". It is, we learn from her lectures, a social, moral and spiritual sickness America suffers, self-generated by a daily diet of lies and illusions about race, class, gender and the world in which we live and die; about our choice to practice peace or drop bombs from drones; and to send soldiers to war and youth to prison or to improve education, feed the hungry, heal the sick, house the homeless, and do justice in and for the world.

She asked then, "How can we in good faith celebrate America's bicentennial of vaunted progress; how do you think Black people, Indian people and any other oppressed folks feel celebrating something...that destroyed over twenty-five million of my people...wiped out our heritage and taking our name" and continues to oppress us in varied dignity-denying and disabling ways? It is a mockery of truth and a compounding of tragedy for us and other oppressed people to over claim progress for America when still the majority of our people lack the basic requirements they need and are denied an equitable share in the abundance they helped create and deserve.

Like her contemporaries, Dr. Martin King, Min. Malcolm X and others, she questioned, criticized and condemned the war in Vietnam, upheld the right of self-determination for the Vietnamese people and argued that the urgent need of real peace and real democracy depended on bringing the soldiers home. And she said, "When we bring them home, some of the billions of dollars that's being spent in Vietnam can go into rural areas like Mississippi" as well as in the impoverished and needy urban areas. She called for a multiracial coalition of millions, not only to end the war, but also build a new America and a new world. Once we end the war, she reasoned, "We'll be able to stand and fight together for things that are rightfully deserved, not in Vietnam... but right here in the United States to make democracy a reality for all of the people of the world regardless of race or color".

Mrs. Hamer was deeply rooted in the Christian tra-

dition and she demands that Christians, especially preachers and leaders, live the best of their faith and see and feel God present in the divine cause of freedom and justice. Thus, she says of the socially unconscious and other-world oriented preachers, "You know, they like to rear back in the corners and over the rostrum and say what God has done for Meshach, Shadrack and Abednego". But, she continues, what they did not know or failed to see is that "God has done the same thing for Fannie Lou Hamer, Annelle Ponder and Lawrence Guyot" and other freedom fighters, who being thrown in the hell fires and furnaces of a savage segregation and bestial racism, refused to be cowered or consumed by raging fire or racist fiends.

And Mrs. Hamer calls for an open and active struggle, not simply money thru the mail or social network signing and blogging, but also an active on-the-ground engagement in building the good society and world we all want and deserve. Therefore, she makes an important distinction between being behind freedom fighters and being with them. She says that in the midst of the struggle, "I don't' want to hear you say " 'Honey, I'm behind you'. Well, move; I don't want you back there. Because you could be two hundred miles behind. I want you to say 'I'm with you'.

And we'll go up this freedom road together". Mrs. Hamer tells us there is so much injury, injustice, unfreedom and unnecessary suffering in this society and an inability to honestly, earnestly and openly question society. But she says, "When you take a close look at American society, it's time to question these things". Indeed, she says, "There is so much hypocrisy in society. And if we want a free society, we have to stop lying", lying about who we are as a society and the terrible things society is doing to vulnerable peoples in this country and around the world. And then, we can honestly and audaciously advance together without the self-deception, illusion and lies, and selfconsciously and relentlessly struggle to free, renew, and remake ourselves and the world.

Black folks have always believed education is the key to success even though America has failed to provide a quality education for Black children for as long as most people can remember. And these days, under the Donald Trump's administration, the prognosis for improving outcomes for African American students is arguably, bleaker than ever. For example, Trump's Secretary of Education, Betsy DeVos, is the wrong person for the job. Among other disturbing indicators, she argues for the promotion of alternatives to traditional public schools, advocating for policies that would give parents an option that would divert funding from these schools that are attended by most Black students. Former Secretary Arne Duncan denounced the inequities in America's schools cited in a U.S. Department of Education's survey, "Data Collection." Duncan: "The inequities are socially divisive, educationally unsound, morally bankrupt and economically self-destructive, (adding), this must compel us to act." This is an apt description of continuing race-based (racist) disparities in schools, but neither Duncan nor the report offered an explanation for the stark disparities between Black students and practically all other students. I suggest, the fundamental reason is racism. One of the report's findings surprised even hardened pundits: Most of the nation's schools offer only part-time pre-school programs. And even though Black students account for less than a fifth of those in pre-school, they make up almost h almost half of the students suspended from pre-school multiple times! Most Black people

are aware of the race-based derivation of education dis-



failure of decades of legal and political efforts to ensure equal rights in education. The Supreme Court's landmark Brown v. Board of Education ruling banned school segregation and affirmed the right to quality education for all children. The 1964 Civil Rights Act guarantees equal access to education. Neither has lived up to its promise.

initiative that focuses on young Black men and boys, but also includes Latinos and Asians. —which means funding and other resources must be equitable, not Black students receive the same amount of funding as all others. Since their needs are frequently substantially greater than other students, funding should be commensurate with those needs. The Local Control Funding Formula is a California legislative initiative that enables school districts, rather than the state, to receive and allocate funds to those schools most in need. Again, the concern is equity, i.e., school boards must allocate funds so that schools most in need actually receive more funds than others in order to meet their needs. (Schools with substantially Black student population in the Los Angeles Unified School District are, without question, first among those most in need; Black parents and their local school communities must constantly demand equitable funding for their schools. A recent lawsuit won by the Community Coalition addresses this equity issue.) Race-based (racist) inequities are clear and solutions must relate directly to the needs of Blacks especially, because they are the most victimized. Remember, public education was not designed to address their needs. Therefore, a major goal is for the Black community and its leaders to work with their allies to exert political pressure sufficient to change policies and practices that improve outcomes for Black students. This is a daunting but inescapable imperative.

parities and are tired of endless research that confirms the obvious. But they must insist research takes into full account causal factors and that proposed solutions first identify the barriers to Black student's receiving a proper education.

Here are some factors that contribute to racebased inequities in public education: Black students nationwide are expelled at triple the rate of their white peers. Five-percent of whites were suspended compared to 16% of Black students. Black girls are suspended at the rate of twelve-percent-far greater than girls of any other race or ethnicity. Students of color have less access to experienced teachers. Most of these students are stuck in schools with mostly new teachers and many Black students attend schools where as many as twentypercent of teachers do not meet license or certification requirements. One in four school districts pay teachers in less-diverse high schools substantially more than teachers in schools with higher Black and Latino enrollment.

Such discrimination lowers academic performance for minority students, especially Blacks, putting them at greater risk of becoming drop outs. Research also shows the

Daria Hall, former K-12 policy director at Education Trust said the Collection Data survey confirmed that students of color get less than their fair share of access to in-school factors that matter for achievement. She said also said, "Students of color get less access to high-level courses. Black students, in particular, get less instructional time because they are far more likely to receive suspensions or expulsions." Although 16% of America's public school students are Black, they represent 27% of students referred by schools to law enforcement and 31% of students arrested for an offense committed in school.

The following are three efforts to address a host of well-known racebased inequities: Common Core standards, the Local Control Funding Formula (LCFF) and My Brother's Keeper.

Common Core is a nationwide initiative to standardize curriculum and instruction in mathematics and language arts in public schools. I described Common Core in a previous column as both a challenge and promise; unless Black students receive proper focus and equitable resources, Common Core could actually widen not eliminate or reduce the achievement gap.

My Brother's Keeper was President Obama's

WHILE ROME BURNED

Historic references are frequently used to comparatively illuminate the character of current persons and/or events. Recently I have been reminded of the saying, "Nero fiddled while Rome burned!" In truth, Nero didn't fiddle He, in greatest likelihood, played a lyre, a stringed instrument best described as a handheld harp. Important in this reference is not the description of a lyre. What is important is the lack of action of the Emperor Nero.

Nero's rule is associated with tyranny, corruption, extravagance, debauchery and emotional instability. He is most infamous for the executions of Agrippina, his mother, and Octavia, his wife. Several executions that he ordered were justified by false revisions of the truth, and yes, he was a known liar. Although some question its accuracy, many Romans are said to have believed that Nero started the Great Fire of Rome to clear space for his planned palatial complex his Golden House. To remove suspicion from himself, it is said that he blamed Christians for setting the fire and began brutally executing many of them. Whatever the truth of the matter is, contemporarily, Nero is dramatically depicted as a self-absorbed, narcissistic maniac.

Now fate presents another catastrophe of the magnitude of the Great Fire of Rome - Hurricane Maria. This storm, with strength and size rarely seen in this hemisphere, has devastated and fundamentally changed the history of Caribbean

islands for decades. My heart and prayers go out to all affected by Hurricane Maria (and Hurricane Irma). Specific to current concerns are the 3.5 million plus Americans on the islands of Puerto Rico, Vieques and the US Virgin Islands that have been overwhelmed in the aftermath of Maria and who lack the immediate support and recovery assistance afforded hurricane victims in the Houston area and in Florida.

Maria made landfall on Puerto Rico on September 21st. In its wake, the entire electrical grid was disabled and water service was cutoff to 75% of the island. Widespread flooding and/or wind-blown debris disrupted access to towns and cities throughout the island. Cell towers were knocked-down and communication on the island is severely disabled. Hundreds of people crowd the San Juan airport, where temperatures soar above 100 degrees, in hopes of securing a seat on an outbound airplane to relative safety. Of over 60 hospitals on the island, only 11 are operational. Others lack the electrical power necessary to provide adequate services. People line-up before dawn

to get the limited supplies of ice to preserve their food and fuel to power generators and other machinery. Yet, it has taken #45 seven days to relieve Puerto Rico from the Jones Act and eight days to direct enhanced support from the US military.

Lieutenant General Russell Honore, who directed Katrina relief and recovery, has publicly criticized current relief efforts. It did not take General Honore to address the fact that the US military was the only single entity with the personnel resourced and trained to manage a catastrophe of this magnitude. He compares the 60,000 active duty and reserve soldiers assigned to the Katrina response to the inadequacy of the 5,000 assigned to relieve Puerto Rico.

For over a week, broadcasters have suggested that it was not widely known that Puerto Ricans were Americans, too. That may be true, but I add that they are mostly Americans of color and speakers of the Spanish language. History has proven a standard of disparate treatment for persons so situated.

Considering the lackluster response of #45's administration to the tragedy in Puerto Rico, it is easy to draw parallels between Nero and #45. In the midst of suffering, #45 has belatedly cast a blind eye on the needs of our island kin. We must not continue to accept or tolerate his neglect.

Hill lawmakers seek end to triple-digit interest on payday and car-title loans

We're 42 Years Apart But **Our Mission Is the Same:** Change Education for the **Black** Community

We are two Black men separated by 42 years in age. But we are bound by our collective rage about what is happening to our people. We are focused on education where there is more than enough to be angry about. Every day countless numbers of our children do not receive the quality education they must have in order to have even a modicum of a chance to live a decent life in today's world.

Yet, when some of us raise our voices and pursue more options for our children, we are accused of supporting "privatization" or doing the bidding of rich "hedge fund" owners or supporting "segregation."

But we will not be deterred. As long as educational atrocities keep happening to our children we will seek whatever options there are to help families navigate existing education systems and create new ones that will enable their children to engage in the "practice of freedom." We support any type of school, educational environment or policy initiative that meets the needs and interests of our children. In the same vein we will oppose any policies or learning environments that are hurting our children-whether they are traditional public schools, charter schools or private schools.

LET'S BE CLEAR ABOUT THE WHY

As we write this, only 17 percent of Black students are considered college- and career-ready. According to the NAEP (National Association of

A group of Capitol Hill lawmakers are combining efforts and influence to legislatively crack down on predatory lending nationwide. Seventeen Members of the U.S. House and eight U.S. Senators are supporting companion bills that would slash the cost of paydav and car-title loans from their typical 300 percent annual interest rate to no more than 36 percent – the same rate protection that Congress first provided military families in 2006.

Today 90 million Americans living in 15 states and D.C. benefit from enacted rate caps of 36 percent or lower. But in the other 35 states, residents remain vulnerable to triple-digit interest rates that average 400 percent nationwide on an average loan of only \$350. When consumers use their car titles as collateral for a larger and equally costly loan, a loss of personal transportation occurs when borrowers can no longer keep up with the spiraling high costs.

If enacted, the legislation is expected to have an immediate impact on payday and car-title loans; but would ensure that all consumer financial services would end cycles of debt that trick and trap unsuspecting consumers into long-term debt. The bicameral effort is led in the U.S. Senate by Senators Dick Durbin of Illinois and Jeff Merkley of Oregon. Their leadership counterparts in the House of Representatives are Matt Cartwright of Scranton, Pennsylvania and Steve Cohen of Memphis, Tennessee.

"Predatory lending dis-



proportionately harms people who are already struggling financially," noted Rep. Cartwright where in Pennsylvania these types of predatory and high-cost loans are already banned by state law. "This consumerfriendly legislation would provide relief from exorbitant fees for many lowincome consumers across the country."

Rep. Cohen, Cartwright's House colleague felt similarly.

"Throughout my career, I have always worked to shield people from those who would take advantage of them through predatory lending practices that can wreak havoc on people's lives and perpetuate a cycle of indebtedness," said Rep. Cohen. "Both justice and morality dictate that reasonable caps on interest be enacted to protect borrowers from devious lenders."

From the Deep South, to the Pacific Coast, and westward to the mid-Atlantic and Midwest states, state payday interest rates range as high as 662 percent in Texas to California's 460 percent, and Virginia's 601 percent. Likewise in the Midwest, the

states of Illinois, Missouri, Ohio and Wisconsin have comparable high interest rates that all exceed 400 percent. In Alabama and Mississippi, two of the nation's poorest states when it comes to per capita incomes, payday interest rates are respectfully 521 percent and 456 percent.

"What we have encountered across the country," said Yana Miles, Senior Legislative Counsel with the Center for Responsible Lending, "is that when voters are given the chance to support a rate cap, large majorities consistently say no to debt-trap lending. Conversely, when it comes to state legislatures, reform efforts are often thwarted by the industry.

Already more than 40 national, state and local organizations have jointly written their Members of Congress in support of the legislation. Signers of the correspondence include civil rights organizations, labor, consumer advocates, and research institutes.

In part the letter states, "Veterans, seniors, women, and communities of color are most often targeted for exploitation by these unafEducational Progress), Black fourth-graders represent the largest percentage of students below basic at 49 percent and the lowest percentage proficient at 18 percent and the story gets worse for eighth-graders too. More than half (53 percent) of Black eighthgraders nationally are below basic in math.

The consequence isn't merely poor test scores for our people, it is about what it represents. When we have drastic low achievement our risk of dying grows. We have both buried students and friends that couldn't read. When the link between low achievement and poor

fordable high-cost loans. . . .While the Consumer Financial Protection Bureau is expressly prohibited from setting a rate cap, Congress is not and should do so. A federal rate cap puts all creditors on a level playing field without undermining any additional consumer protections in the states."

"Despite the economic gains we have made as a nation in recent years, many working families continue to struggle," noted Illinois' Sen. Durbin. "For some, payday lenders offer a quick way to make ends meet, but their outrageous interest rate caps and hidden fees can have crippling effects on the people who can least afford it."

"This bill's simple, straightforward approach will protect consumers and ensure that families aren't bankrupted by high interest rates and hidden fees," noted Sen. Merkley.



According to Simpson's parole release plan he will reside in Las Vegas, Nevada. However, it is rumored that Simpson has plans to move to Florida where two of his children live.

"He's not going to hide," said longtime friend Tom Scotto, who attended Simpson's parole hearing this summer. "He's going to focus on kids, friends, his family, and golf. Maybe not the first day or second, but he is going to go out."

When Florida Attorney General Pam Bondi caught wind of Simpson's plans to

move to Florida, she wrote a letter to the state's Department of Corrections, stating that she did not want Simpson to move to her state. Attorney General Bondi went on to ask the Department of Corrections to "notify all appropriate authorities of the State of Nevada that the State of Florida objects to the granting of such permission."

According to Simpson's Malcolm lawyer, LaVergne, Bondi does not have the jurisdiction to stop Simpson from coming into the state of Florida. With

newfound freedom, came the launch of a renewed effort to collect from him a 1997 civil jury award that held him liable in the deaths of his estranged wife, Nicole Brown Simpson and her friend, Ron Goldman.

According to attorney David Cook, who represents the father of Goldman, said in a statement to CNN, that the \$33.5 million Simpson was ordered to pay the victims' families has since increased to nearly \$70 million with interest.

Simpson's attorney, LaVergne told CNN his client will be considered a retiree and won't have any assets for the victim's family to collect.

In regards to Simpson's release, the Goldman family had this to say, "Now that Simpson has been released from prison, we, the Goldman family will continue our quest in securing the only form of justice for Ron we have available; the rights to our Civil Court case judgment, where Simpson was found to have willfully and wrongfully caused the deaths of Ron and Nicole. We anticipate that the Nevada Board of Parole will uphold the conditions of Simpson's parole and not provide leniency."

they found he had taken his own life. Aside from discovering Paddock's body, authorities found 23 guns with some scopes in his hotel room, and two gun stocks which allowed the shooter to replicate fully automatic fire.

In Paddock's home, authorities found 19 guns, explosives, and thousands of rounds of ammunition. Additionally, several pounds of ammonium nitrate, a fertilizer that can be turned into explosives, were found in his vehicle.

FBI agent, Aaron Rouse, who handles the Las Vegas division, stated that investigators saw no immediate evidence connecting the attack to an act of terrorism.

According to NBC News, "[Eric Paddock], the brother of the Las Vegas gunman Stephen Paddock, was stunned to learn that one of his relatives had committed such a heinous crime. Paddock, who lives in Orlando, said his brother [the Las Vegas gunman] has retired to Mesquite, Nevada and spent his time at the hotels, going to shows and gambling."

Donald President Trump described the attack as "an act of pure evil" and stated that he would visit the city.

"In times such as these I know we are searching for some kind of meaning in the chaos, some kind of light in the darkness," he said. "The answers do not come easy. But we can take solace knowing that even the darkest space can be brightened by a single light, and even the most terrible despair can be illuminated by a single ray of hope. My warmest condolences and sympathies to the victims and families of the terrible Las Vegas shooting. God bless you!"

Recently, political figures and celebrities took to social media and other platforms to discuss the mass shooting.

"This kind of tragedy has become too routine in America. As a nation, we are weary. We've lost far too many of our classmates,

friends, family members, and children to gun violence," said Senator Kamala Harris. "That's why as we pray for those recovering; we also must commit ourselves to action. Another moment of silence won't suffice. Ninety Americans are killed, on average, every day by guns. We cannot simply throw up our hands or continue to justify the presence of weapons of war whose primary purpose is to kill the largest number of human beings in the shortest amount of time possible. We must honestly acknowledge the epidemic of gun violence and work together, now, to curb it."

Congresswoman Maxine Waters called the attack "senseless violence", stating her thoughts and prayers are with the victims and their families.

"There are so many questions surrounding this latest mass shooting, which now has the unfortunate distinction of being the deadliest in modern U.S. history, surpassing the devastating Sandy Hook, and Pulse Nightclub massacres," said Waters. "We are still learning more facts about this shooter and his motivations; however, we cannot ignore how deeply disturbing it is to learn that an individual with an apparent capacity for extreme violence was able to gain access to a large number of deadly weapons. When will our society gain the strength and courage to finally face up to the constant threat and danger of guns?"

Many of the people who attended the concert were California residents. In fact, several off-duty members from the Los Angeles County Fire Department

gun-fire and sustained nonlife threatening injuries.

Other victims, included couples celebrating anniversaries, friends celebrating birthdays, school personnel, a member from the Manhattan Beach Police Department, a Manhattan Beach special education teacher, a Disneyland employee, high school graduates, fathers, mothers, brothers, sisters, cousins and many more.

The historic shooting has raised some concerns regarding mental health and gun laws and causing the U.S. and other countries to reflect on past incidents. In June of 2016, a gunman who

extremist groups opened fire at a gay nightclub in Orlando, Florida killing 49 people. Prior to that, a suicide bombing took place at an Ariana Grande concert in Manchester, England killing 22 people in May. In 2015, almost 90 people were killed during a concert in Paris by Islamic State inspired gunmen.

"There are two things we should all care about: never to forget where we came from and always praise the bridges that carried us over," stated Mrs. Fannie Lou Hamer (1917-1977), a towering figure in the Black Freedom Movement of the 60s.

In celebration and commemoration of the 100th birthday of Hamer, freedom fighter and a giant in a generation of great Black leaders, such as Malcolm X, Ella Baker, Martin Luther King, Jr., Rosa Parks and others, the African American Cultural Center (Us) will host a community celebration in honor and praise of this enduring bridge on Sunday, October 8, at 3 p.m., at 3018 West 48th Street in Los Angeles.

The program will include speeches from various community leaders as of America, and to expand the realm of freedom and justice in this country.

A member of the Student Non-Violent Coordinating Committee (SNCC), Hamer was also co-founder of the Mississippi Freedom Democratic Party and founder of the Freedom Farm Cooperative and numerous other institutions she established to benefit Black and other poor people of Mississippi.

She made international headlines with her testimony at the 1964 Democratic National Convention before the credentials committee where she challenged the seating of the all-White segregated Mississippi delegation and exposed the racist brutality and hypocrisy of America to the world.

CSUDH President Hagan Announces Retirement



Fifteen Recently Signed Bills to Help End Homelessness

Los Angeles Mayor Eric Garcetti was among the officials in San Francisco last Friday as Gov. Jerry Brown signed 15 bills into law aimed at increasing the supply of affordable housing in the state.

"These new laws will help cut red tape and encourage more and affordable housing, including shelter for the growing number of homeless in California," Brown said.

The bills include a mea-

sure to create a permanent funding source for affordable housing through a real estate fee, the placement a \$4 billion housing bond on a future ballot, and other measures to promote development and the construction of low-and-moderateincome housing.

Brown signed the bills at Hunters View, an affordable housing project located in the Bayview Hunters Point neighborhood.

Garcetti has been advocating for local legislation to help affordable housing, including the creation of a "linkage fee" on developers.

Garcetti said that "the California dream is in danger" because of the housing crisis, according to the *Orange County Register*.

"We saw it on our way here," Garcetti said at the signing, the *Register* reported.



Atlanta Makes Marijuana Possession Non-Arrestable Offense

The Atlanta City Council voted unanimously and on October 2, City Councilman Kwanza Hall signed into legislation, to eliminate jail time for anyone caught with less than an ounce of marijuana. Previously, according to reporters in Atlanta, the penalty for possession of marijuana in the city was a fine of up to \$1,000 and up to six months' imprisonment, but under the new ordinance, possessing less than an ounce of the drug would result in no prison time and a maximum fine of \$75. Proponents are calling the legislation "historical", and

are thanking Mayor Kasim Reed for supporting it. "Today we stand with

every parent of Atlanta who is fearful of or has seen their children's lives destroyed, or careers ruined because of a racist policy that unjustly incarcerated minorities by more than ninety percent," said Hall, who is also a mayoral candidate.

The legislation was one in a series of justice reform policies Hall has introduced, including "Ban the Box" which passed in 2014, the creation of the Pre-Arrest Diversion Pilot Program in 2015, a law enforcement transparency and accountability measure and legislation to end broken windows policing in 2016, according to a spokesperson for the councilman.

"A key fact presented during the debate is that in Atlanta, the overwhelming number of arrests for marijuana-related offenses are African Americans (92%), even though studies have determined usage is at similar levels across racial demographics."

The city's police department also supported the measure, saying the new law would be handled with a citation similar to a traffic ticket.

The change only applies within the Atlanta city limits. Georgia state law still requires jail time, said Atlanta reporters.

ICE: Southland Immigration Sweep Nets 100 'Criminal Aliens'

About 100 people were arrested in the Los Angeles area during a four-day nationwide immigration sweep targeting so-called sanctuary jurisdictions, federal authorities announced last Thursday.

U.S. Immigration and Customs Enforcement officials said "Operation Safe City," which ended Wednesday, targeted people who have "violated U.S. immigration laws, prioritizing aliens with criminal convictions, pending criminal charges, known gang members and affiliates, immigration fugitives and those who re-entered the U.S. after deportation."

Agents targeted regions "where ICE deportation officers are denied access to jails and prisons to interview suspected immigration violators or jurisdictions where ICE detainers are not honored," according to the agency.

"Sanctuary jurisdictions that do not honor detainers or allow us access to jails and prisons are shielding criminal aliens from immigration enforcement and creating a magnet for illegal immigration," ICE Acting Director Tom Homan said. "As a result, ICE is forced to dedicate more resources to conduct at-large arrests in these communities."

No one who is registered under the Deferred Action for Childhood Arrivals program -- which provides protection from deportation for people brought to the country illegally as children by their parents -- were targeted in the operation, officials said. Angelica Salas, executive director of the Coalition for Humane Immigrant Rights, called the raids a politically motivated action by a "rogue agency."

"We have a hard time believing anything ICE has to tell us about those it arrested this week in this dastardly operation," Salas said. "But we are very clear that ICE's actions make our cities unsafe and inflict terror on millions in communities that just want to live with security and liberty.

We are deeply troubled by this politically motivated and cruel form of immigration enforcement and call on Congress to investigate who exactly is being targeted and why," she said.

A total of 498 people

were arrested nationally. The most arrests, 107, were made in Philadelphia, followed by Los Angeles with 101.

Other raids were conducted in Santa Clara County; Baltimore; Cook County, Illinois; Denver; New York; Portland, Oregon; Washington, D.C.; and the state of Massachusetts.

According to ICE, among those arrested in Los Angeles was a documented gang member who entered the country illegally and rammed multiple law enforcement vehicles while trying to evade authorities. He was found to be in possession of a loaded handgun, and is facing charges including assault with a deadly weapon and carrying a concealed firearm.

The 498 people arrested in the operation came from 42 countries, according to ICE.

Matthew Albence, ICE executive associate director for enforcement and removal operations, said that despite "resistance" in some communities, ICE will carry out its duties.

"We are never going to stop enforcing the laws (as) we are authorized and required to do," Albence said. "And if we need to go into these communities every week, we will."

A civilian commission overseeing the Los Angeles County Sheriff's Department voted Thursday September 28 to end the agency's use of a drone during law enforcement operations.

The Civilian Oversight Commission voted 5-4 to ground the drone program, which began in January.

There was no immediate comment from the sheriff's department.

Sheriff Jim McDonnell said in January the \$10,000 drone would be used only for search-andrescue operations, bomb detection, hostage situations and other critical incidents.

The drone has been used by sheriff's deputies about a half-dozen times. Critics have decried

the use of the drone, fear-

ing possible "mission creep," suggesting the drone could be used for spying and could one day be armed or be deployed as a weapon.

Members of the Stop LAPD Spying Coalition were among those attending the oversight commission meeting to express concerns about the drone.

"We definitely are feeling good that the Sheriff's Civilian Oversight Commission did the right thing," the coalition's Hamid Khan told KNX Newsradio after the panel's vote.

The Los Angeles Police Department acquired two drones in 2014 but never launched them after protests about potential surveillance uses. LAPD Chief Charlie Beck has said he was unwilling to trade public confidence for the advantages of drones.



I must say that I didn't know much about the Watts Towers other than its' role as back drop of an epic brawl against Nick Styles and Earl Talbot Blake in Denzel Washington and John Lithgow's 1991 crime thriller "Ricochet". However, I was quickly schooled to the real relevance of the Watts Towers' contribution to immigration history here in California. This past weekend, Saturday, September 30, and Sunday, October 1st, the Watts Towers Art Center campus celebrated over 30+ years in the community with their 36th Annual Day of the Drum and 41st Annual Simon Rodia Watts Tower Jazz Festival. Largely produced by the Los Angeles

ries of the hey-day of jazz. "Each picture tells a story and each story connects to us as a people," reveals Howard. "Use these images as inspiration and create your own work of art."

Alongside the "jazz great's" necklace activities, sat a long table where original small drums were handmade with noisevibrating tubing and added strappings of black and brown leather in all hues and colored ribbon for piz-

Next door to the homemade drum, sat one of the most popular tables, where artistic mosaics created of colorful broken tile crafted by veteran Watts's artist Carlos Spivey, known for his classes on mosaic masterpieces. Spivey has been an artist-in-residence at the Watts Tower Arts Center since 2010, where he handcrafted the mosaic tile for the inner walls of the turtle pond inside the Arts Center Garden Studio. "You have to fill in all of the spaces and use as many colors [as]possible," instructs Carlos before laying in the dirt colored grout to formulate our mosaic stainless steel masterpieces. "Every piece is different and as beautiful as the person that made it." Several vendors aligned the main stage area were Yoruba ground-blessing drum greats opened up the day with libations and blessings to the ancestors. Lovely drum sets ensued from 12 noon until 4:30 p.m. with groups that included Nonosina Polynesian drummers with accompanying Tabatian dancers, celebrating over 50 years in the Watts community. Also performing the all Queen ensemble, Batuque-Bloco Bate. Obini, The Drum Apostles and an exciting West African drum troupe, Kouman Kele West and Rhythm Roulette, who performed to popular audience engagement. Saturday evening ended to a successful first day, as vendors packed up for day two of the festival.

The spirit of the festival on Sunday was all about growth and planting new seeds. Included in Sundays schedule was a tour of the Watts Tower and its relevance and tenacity, when telling the story of how Italian immigrant construction worker and tile mason, Sabato "Simon" Rodia built the towers with his bare hands; an undertaking that took him over 30 painstaking years to complete. "The infamous structure was created by Simon's own concoction of a type of concrete, wrapped with wire mesh," said a tour guide. "He built the structures with only his hands and his small tools with pieces of broken glass, pottery, mirror, even sea shell collected by local children." The Watts Towers are truly considered one of Southern California's most recognized works of You couldn't attend the Watts Drum and Jazz festival without visiting Watts Arts Center, a facility that opened in 1970, built and staffed by the non-profit Committee for Simon Rodia's Towers. Opened for the committee, the center holds art classes, and displays contemporary art. It also houses the Garden Studio, a community garden that houses the turtle pond where turtles both big and small, young and old, call home. With plants and medicinal herbs available for purchase, the Garden Studio is both functional and an incredible habitat to two huge red-eared slider turtles, Shelly and Sheldon. The festival wouldn't be complete without the smooth Jazz of Sunday afternoon; headlining such greats as Heaven, Dee Dee McNeil's Jazz band, Roy Gaines and his orchestra of Tuxedo Blues, Danny Cortez and Tony Harris band, Tai Chi Chuan, The Bennie Maupin, and the JMP All Stars featuring Patrice Rushen, Reggie Hamilton, and Justo Almaria who performed their greatest hits to an enthusiastic audience who were on their feet giving thunderous applause.

The principles of reconciliation, sustainability, and social equity play a critical role in core values that guide the CDC's priorities, project selection, and design and strategies.

"I am so proud of the work of the West Angeles CDC and those who have led it and worked so diligently for its success," said Bishop Blake.







In his season debut against the View Park Knights, Beime made two touchdown passes, ulti-


mately winning the game 22-0. This was the start of a shutout, not only did the Saints win their first three games; their opponents were unable to score.

The National Basketball Wives Association (NBWA) held their annual conference recently in Los Angeles with this year's theme of "Building A Living Legacy". The conference kicked off with 30 members of the association meeting with the Coalition to Abolish Slavery and Trafficking (CAST), a Los Angeles based nonprofit, at one of its sites, located at the Los Angeles Regional Taskforce on Human Trafficking.

"My heart and stomach are still clenching," Mia Wright, president of the NBWA, told the Los Angeles Sentinel after leaving the taskforce site. She spoke to the dichotomy of the meeting between the wives and girlfriends of NBA players, and the survivors of human trafficking.

"It is polar opposite," said Wright, the wife of NBA Champion Dorell Wright. "We are in this cocoon of the NBA lifestyle, so being able to have that experience with women who are literally living a polar opposite journey than we are and being able to connect with them, just based on the fact that at the end of the day we are all women, means a lot."

The members gathered in a room and heard the stories of three survivors who are a part of the Survivor Advisory Caucus. As each survivor candidly shared vivid accounts of their experiences, Kay Buck, CEO of CAST said, "There were a lot of tears in people's eyes because it was hard to hear about the violence and trauma." Buck described the day as, "a meeting of sisterhood."

CAST has supported thousands of survivors through their journey to freedom by offering, counseling, legal resources, housing, educational and leadership training and mentorship. One of the first items a survivor receives is an emergency response backpack, stocked with basic essentials. The NBWA members assembled 100 emergency response backpacks while gaining perspective and education on how to bring awareness to this global issue.

"The [survivors] have directly impacted our members and motivated us to be more vocal on what's happening, using our public appeal," Wright said. "No one is focused on what another person is wearing and material things, we are compassionate women who want to see people thrive."

The partnership with

CAST originated in the Spring, as the young ladies who went missing in the Washington D.C. area outraged members of the NBWA executive board. It was then, that the NBWA leadership decided it was important to bring public awareness to human trafficking. Jada Paul, wife of Rocket's point guard Chris Paul, and an active member of the NBWA, attended the CAST's 19th Annual Slavery to Freedom Gala in May, which honors change agents who have committed themselves to putting an end to modern slavery.


"It's a dark epidemic in the states that isn't really advocated for," said Wright, who grew up in Inglewood, CA. "I have childhood friends [who've] walked into prostitution."

As the president of the NBWA, she said it is important for her to convey a message to young women, "you are important just as you are and your uniqueness to this world matters."

In a time when athletes are utilizing their platforms to bring awareness to issues they deem important, Buck shared how meaningful it has been for the wives and girlfriends of professional athletes to also use their social media networks and resources to take a stand against human trafficking.

0 Advance Care Plan

Advance care planning (ACP) involves making decisions and plans about your future health care before you reach a time when you are no longer able to make those decisions or communicate those decisions well. Advance care planning involves reflecting on your life goals and values, selecting someone who can make decisions for you when you are unable to, and talking about your wishes with that person. Once you have had that conversation, a form can be filled out with signatures from two witnesses or a notary and given to your physician to keep in your medical record.

Advance care planning has been shown to improve the last years of your life, decrease health care costs at the end of life, and reduce the stress, anxiety, and depression experienced by the family and caregivers. Despite the benefits that come with advance care planning, only a small number of people complete these forms and research shows that African Americans and Latinos have lower rates of advance care planning than the general population. There are many

possible reasons for this. including but not limited to: institutional and cultural barriers, mistrust of the medical system, language barriers, hesitancy for religious and spiritual reasons, low health literacy, and an emphasis on the family unit as the primary caretaker for a patient throughout the course of their disease.

In the Los Angeles County Department of Health Services (L.A. County DHS), there is a large and diverse population consisting of Latinos, African-Americans. and Asians, representing 2/3 of the population, and 12% of the population is over the age of 65. There is a growing need to spread awareness about the benefits of advance care planning and to make it easier to understand for our aging, diverse population in Los Angeles. Dr. Jessica Kaltman, a research fellow and physician affiliated with UCLA, believes that advance care planning is not just for the elderly. She states that "Advance care planning is a spectrum and should be discussed with a patient from a younger age, and as people age the conversation can change." Fortunately, there are already programs underway that are trying



to address the problem of low completion rates of advance care directives.

Dr. Jessica Kaltman and Dr. Arpan Patel are trying to change the taboo around advance care planning through a pilot program started in collaboration with doctors at Martin Luther King (MLK) Jr Outpatient Center. The pilot program has a novel approach to make advance care directives a simpler, more fluid process that is incorporated into a doctor's visit. First, medical assistants educate patients about what advance care planning is during the clinic visit. Patients also receive educational pamphlets that

explain advance care planning in a culturally sensitive manner. Finally, the team has simplified the process of uploading advance directives into electronic medical records. They hope in conjunction these three approaches will increase the number of completed advance care directives in L.A. County DHS and change the way people view advance care planning.

At Olive View-UCLA Medical Center in the L.A.

County DHS, Dr. Heather Schickedanz, a geriatrician and UCLA assistant professor, is also increasing awareness about advance care planning and

directives. Her program also has three phases of implementation. The first phase involves offering eligible patients a 4-minute video that introduces advance care planning and advance directives on a tablet, while they are waiting to be seen by a primary care provider. Once patients have seen the video, a medical assistant provides an easyto-read advance directive to discuss with their provider. This video based-education approach provides an avenue for both patients and the care team to feel more comfortable talking about goals of care. The second component involves group visits between a small

group of eligible patients who have not completed an advance directive, their primary care provider, and a social worker. The group visits allow patients to ask questions and talk together about the sensitive issues that may come with advance care planning. It also provides space and time for this important topic, for the patient as well as the provider. As at the MLK clinic, the third phase integrates documentation of the advance care plan and advance directive into the electronic health record, making it easily accessible whether the patient is in the emergency room, hospital or in the clinic. Dr. Schickedanz's goal is to improve the process and communication of advance care planning for our patients, so that their families and care teams will know and respect their wishes.


