# First Black Woman Honored with Lifetime Achievement Award from League of Calif. Cities

For the first time in history, a Black woman, Sedalia Sanders, was honored by the League of California Cities Past Presidents Council with its 2022 Past Presidents Lifetime Achievement Award.

Sanders has had a lifetime of firsts, pushing boundaries in local politics. As a past President of the California League of Cities, elected in 1995, she was given the President's Council's highest honor at the opening of the organization's three-day conference last Wednesday, at the Long Beach Convention Center.

On stage were some of the past winners — but no African Americans. Cheryl Viegas Walker, also a past President of the League, presented the award.

"Today we recognize a true champion of local government," Viegas Walker said, voice wavering. "One of my dearest friends and mentors who has been, not only a champion of local government, but a champion of quality-of-life issues, making our cities better places to live, to work, and to raise our families."

Sanders delivered her acceptance speech with a combination of wit and humor. Thanking the audience for coming, she asked those who did not come to see her to "refrain from saying so." Her speech recalled events of the last 80 years of her life, and how they contributed to making her "part of the greatest generation."

Sanders described her accomplishments as those of a "small town gal" from a "rural community" acknowledging the difficult job of governing, particularly with the recent pandemic. She emphasized the importance of a diverse, fair representation in government.

"So those who look like me, meaning of the same gender, those who may look like me, meaning the same ethnicity, and those who may look like me, because you're my age or more," said Sanders, "know that if you live long enough, work hard enough, all things can be accomplished."

In a moment of reflection

backstage, Sanders recalled how her political career

began. The mayor of El Centro wanted her on the Board of Trustees of El Centro Community Hospital in 1982

Leaders that were inspirational to Sanders at the time included former Los Mayor, Angeles Bradley. She remembers meeting him and being asked how she was able to do it. She answered. "it wasn't easy," to which Bradley responded, "tell me about it."

Bradley was the first African American to win the Lifetime Achievement

Sanders has achieved a long list of accomplishments and received several awards over 30 years in California politics. She has been Mayor of El Centro, the President of the League of California Cities, a twoyear member of the Board of Directors of the National League of Cities, a member of the Taskforce on Rural Competitiveness appointed by Gov. Pete Wilson, and the Vice-Chair of the Rural Development Council.

Hard work and faith were what Sanders says got her

but he warned her that she would need to be appointed to the position.

"This is 20 years after Martin Luther King, Jr. marched on Washington," said Sanders. "He was killed in '63 and people were still worried about whether we (African Americans) have the knowledge, understanding or know-how and education to do this."

But she persisted. Sanders said she won them over with her willingness to work hard and her tenacity. She went on to win, and defend a seat as a city councilwoman, and later Mayor, of El Centro, in Southern California from

through some of the most contentious parts of her political career. Now in her eighties, she is not done yet. She has been reappointed by Gov. Newsom to the Executive Committee of the California Commission on Aging Commission, where she has been serving since 2016.

For Sanders, the message is clear- no one should be told they are not as good as someone else. Everyone should be able to participate in the governing process.

"What I'm hopeful for is that the presentation I made today in my acceptance speech will inspire someone so that they can see that they can do this."


"Veils" will open Thursday, September 15 at 8 p.m., at the Nate Holden Performing Arts Center in Los Angeles.

## Newsom Signs Legislation Funding Nation's First Black Women's Think Tank

Last week, Gov. Gavin Newsom signed a budget trailer bill approving \$5 million in funding to the California State University at Dominguez Hills (CSUDH) to house the California Black Women's Think Tank.

The California Black Women's Collective (CBWC) Empowerment Institute will be a founding partner in the development of the policy research institution.

The legislation, Assembly Bill (AB) 179, authored by Assemblymember Phillip Ting (D-San Francisco), paves the way for establishing a policy institute that will focus on improving structures and practices that impact the lives of Black women and girls across the state.

"The California Black Women's Collective has diligently worked hard over the last year to make the California Black Women's Think Tank, the first of its kind in

the nation, happen," Kellie Todd Griffin, speaking for CBWC, told California Black Media.

CBWC in partnership with Black Women Organized for Political Action (BWOPA), is a coalition of more than 1,500 Black Women leaders throughout California.

The coalition utilizes Black women's expertise and collaboration skills in political, community, and social justice activism to amplify their voices, knowledge, and issues throughout

budget that helps address rising costs for Californians, tackles the state's most pressing needs, builds reserves, and invests in the state's future.

AB 179, the Budget Act of 2022, implements funding for key priorities established by the California Black Legislative Caucus (CLBC) for this legislative session, including CBWC's Think Tank.

"We are thankful to the California Legislative Black Caucus (CLBC) that included it as a priority-budget ask and CSUDH for partnering with

"relevant and accessible" in providing an "independent, academic, research entity that provides a "rigorous analysis approach to policy," CBWC explained in a written overview.

The state and CLBC are in support of addressing the need to expand work that drives systematic change, brought forth by CBWC. The Think Tank is an effort to serve as a research institution and resource for lawmakers, elected officials, business leaders, and advocating organizations willing to impact sustainable and scalable change.

"There are approximately 1.1 million Black females in California. However, there are 75% of Black households headed by single Black mothers and 80% of Black households have Black women breadwinners. There are economic, educational, health, and electoral barriers confronting Black women every day. In California, 23% of Black women live in poverty, according to the Women's Well-Being Index from the California Budget and Policy Center," CBWC stated.

According to the Status of Black Women report from the Women's Policy Research (WPR) and information provided by CBWC, the median income for Black women in California is \$43,000 a yearcompared to \$52,000 for White women and \$69,000 for White men. The report by WPR also shared that the average cost of childcare for an infant makes up 28% of a Black woman's average income in the state.

CBWC's Think Tank intends to approach its work in a data-driven, strategic, and collaborative manner. Based on current information concerning Black women and girls in the state, the collective specifically aims to provide actionable policy solutions, remove persistent barriers that this group of women faces on a daily basis, and achieve racial and gender equity.

The CBWC Empowerment Institute falls in line with these initiatives to help Black women, Todd Griffin asserts.

"The magnitude of this funding allocation will be transformative as we continue the work to improve the quality of life of Black women and girls throughout California," Todd Griffin said.



# AI-Generated Rapper Controversy Spotlights the Need for More Blacks in Tech

Almost as quickly as it began, the music industry may have seen the end of the infamous Artificial Intelligence (A.I.) rapper referred to as "FN Meka," a computer-generated character being widely condemned for appropriating Black culture and saying the N-word.

The A.I. rapper was developed by Anthony Martini and Brandon Le, cofounders of Factory New, a Metaverse media company. Some critics claim that the creators who are not Black are trivializing Black art and the Black experience, tantamount to what some are calling "digital blackface."

"In many ways, digital blackface is an example of ... the 'digital afterlife of slavery' and Jim Crow, where you have real people and virtual characters engaging in a kind of machine-automated minstrelsy that disrespects and disregards the artistry and production value that goes into the creation of Black culture," Dr. Faithe J. Day, Assistant Professor of Black Studies at the University of California Santa Barbara (UCSB), told California Black Media.

Media watchers say FN Meka is modeled after rap artists like Lil Pump and Travis Scott and was voiced by real-life rap artist Kyle the Hooligan.

Kyle the Hooligan says that he will be suing the company responsible for the A.I. rapper. The Houston-based artist says he had not been paid for his work and he wasn't aware that his voice had been sold to Capitol Music Group (CMG) until he saw it in the news.

CMG terminated its contract with Factory New less than two weeks after they signed it amid the controversy surrounding the A.I. artist's lyrical content and depiction of rap culture.

One of the A.I. rapper's questionable lyrics is in the song "Moonwalkin." It says "boom, police on my back, hot pursuit (Skrr)/ Know that they mad that this A.I. gettin' [inaudible]," along with several uses of the N-word.

The A.I. project attracted more criticism when Factory New posted on its Instagram account an animated video depicting the program's avatar on the ground being assaulted by police.

The post's caption read: "POLICE BRUTALITY?? What Should I Do ?!?! This Guard keeps beating me w/ his BATON because I won't snitch. I ain't no RAT. Life in Prison is so Depressing.... I wish I could get out so I could start making music again."

CMG issued a formal apology for its involvement with Factory New saying, "CMG has severed ties with

the FN Meka project, effective immediately. We offer our deepest apologies to the Black community for our insensitivity in signing this project without asking enough questions about equity and the creative process behind it."

Martini suggested that critics of his A.I. rapper have taken a hypocritical stance.

"If you're mad about the lyrical content because it supposedly was A.I., why not be mad about the lyrical content in general?" Martini was quoted saying to the New York Times.

Prof. Day found that

comparing what an A.I. (character) does to what an artist does is a false equivalency and misses the point of why so many people are upset about the representation of this A.I. rapper," Day said. "The real issue is that FN Meka is an example of what Adam Clayton Powell called 'high-tech blackface' and what more recently has been called 'Digital blackface,' a phenomenon that we have seen for decades in video games, chat rooms,

Day said there is an extensive history in music and entertainment of appro-

and social media."

priating Black culture without compensating the African American originators of various art forms.

"Due to the fact that within America and the Western world, there is a history of those in power freely benefiting from the cultural and material production of BIPOC individuals, it only makes sense that the same ethos would continue in the digital realm," Day said.

"And, in this case, the popularity of FN Meka and other virtual artists might make it easier for creative industries to forgo actually increasing the diversity and inclusion of their artists' roster and production teams in favor of creating their own caricatures of Blackness, or any other combination of identities," Day continued.

Martini is no longer associated with the FN Meka project and Factory New. In his announcement, he sided with Kyle the Hooligan.

"In the past few days, I've learned of Kyle the Hooligan's experience with Meka which is deeply at odds with my core values. I believe that artists must always be at the center of the creative process and must be compensated fairly," Martini stated.

While AI technology is making massive strides, it is

still limited to processing massive amounts of data based on parameters set by the programmer, according to Josh Lovejoy at Google's Privacy and Data Protection Office. Consequently, AI is not an independent entity but an extension of its creators and thus inherits their biases.

"In addition, while it is important to stay aware of racist AI, we also have to think about intersectionality and the fact that AI isn't just racist, it can also be sexist, homophobic, transphobic, classist, and many other things that speak to the fact that oppression acts in a matrix," Day said.

Day is still optimistic about the future of artificial intelligence as more Black and other minority-led projects become a reality, such as NeuroSpeculative AfroFeminism (NSAF) from Hyphen Labs, a global team of women of color doing pioneering work encompassing art, technology, and science.

"By drawing on both speculative and liberatory approaches to art and design, I believe that there are many artists that are poised to build a more diverse and justice-oriented future within, and outside of, the creative industries by using technology and artificial intelligence for social good," Day emphasized.

### New Bivalent Boosters Adds Protection from Omicron Variant Ahead of Predicted Surge

California has started administering updated COVID-19 booster shots after the Centers for Disease Control and Prevention (CDC) approved the use of new versions of boosters of the vaccine for people aged 12 and older.

The Western State Scientific Safety Review Workgroup independently reviewed the boosters and

recommended that they be given to people who have already received primary vaccinations, regardless of the booster status.

The updated boosters will be "bivalent," offering protection against the original

coronavirus strains, as well as improved immunity to the currently dominant BA.4 and BA.5 strains, also known as the Omicron variants.

The Pfizer/BioNTech bivalent booster is available for people 12 years and older, while the Moderna bivalent booster is approved for those 18 years and older. The bivalent boosters have not been authorized for children under the age of 12.

"We are getting closer to an analogy with the flu vaccines," Dr. Gil Chavez, Senior Medical Officer, Office of the State Epidemiologist, California Department of Public Health, said during a recent ethnic media sponsored COVID-19 panel discussion with other medical doctors and public health officials: Dr. Maggie Park, County Public Health Officer, San Joaquin County Public Health Services; Dr. Oliver Brooks, Chief Medical Officer, Watts Healthcare; and Dr. Eva Smith, Medical Director, K'ima:w Medical

According to Chavez, "Whereas you know every year we have to get an influenza vaccine to ensure that we get the updated vaccine ... with COVID-19, we are moving in the same direction where we believe that it will be important to have at least an annual booster."

"The goal, and our hope, is to continue on a path of a low number of cases and prevent a surge in COVID cases this winter. That is why public health officials urge individuals to get the updated booster," Chavez said.

Officials reiterate that, though boosters will prevent disease for some people, they are critically important to prevent people who contract COVID from getting seriously ill, to the point where they may be hospitalized and potentially die.

The vaccines are also an important tool for preventing "long COVID," where symptoms such as headaches, brain fog, and fatigue can be prolonged for more than six months.

In July, a surge in infections driven by the highly transmissible BA.5 subvariant almost pushed Los Ange-

les County, for example, to reinstitute a universal indoor mask mandate.

"BA.5 has been the predominant circulating variant since July and is still and now accounts for about 87% of all newly diagnosed cases of COVID, with BA.4 pretty much accounting for the rest," said Park. "I want to say that the rollout of this new booster is actually quite timely, as many models are predicting that we're facing another COVID-19 surge this fall or winter and we need to be ready."

While scientists believe many people infected in the most recent COVID surge will have natural immunity for some time, this type of protection begins to wane after around 90 days. So, even people who have had COVID in the past should consider getting a booster around 3 months after being infected.

In California, vaccine hesitancy persists. Seventy-two percent of all people have received primary vaccinations, but only 58.8% of people eligible for boosters have received a booster.

This is worrisome because, according to Dr. Brooks, "unvaccinated people [account for] 2.4 times more cases, 4.6 times more hospitalizations, eight times more deaths."

Brooks shared a concept to combat vaccine hesitancy by responding to the common points of resistance in his patients, called the three C's - complacency, confidence and convenience

C's - complacency, confidence, and convenience.

Complacency afflicts those who think that COVID

is over -- or are fatigued and


overwhelmed by the fact that, for the past couple of years, the virus has dominated many facets of life. Yet, it is still evolving to become more highly transmissible and more evasive of immunity from infection or vaccination. According to statistics from the Los Angeles County of Public Health, the Omicron variant killed people in all age groups at a higher rate than motor vehicle crashes.

People are concerned about the safety of the vaccines because of "misinformation that's being perpetuated in our communities," according to Park. "But with all the millions of doses that have been given in the United States and around the world today, we have so much information about them, and we do know that they're safe," she said.

Many in the community have expressed concerns that the vaccine was created too fast to be safe and reliable," Brooks said, "The mRNA platform... that's been around for 11 years or so; it was developed when we had SARS CoV-1 so a lot of people forget because it didn't go pandemic and then MERS, which was Middle Eastern Respiratory Syndrome, which similar, so we use that mRNA platform."

Many people are also contending that the shots don't work, as they are still getting infected. Park said, "People say[ing] 'My friend is fully vaccinated and boosted but she's still got COVID,' and to that, I say yes, but is she still alive? And yes, of course, she is. We never promised that the vaccinations would mean you wouldn't get COVID... What we know is that your chance of getting COVID decreases with vaccines, but the decrease is even greater when it comes to your chance of being hospitalized or dying."

As for convenience, vaccines are now available at locations across the state with relative ease of access and at no charge. There are no anticipated supply constraints. So, there are no groups that are being given priority. Those seeking vaccines or boosters can book an appointment at Myturn.ca.gov.

The most recent three gatherings authorized by the Task Force took place last month.

what reparations look like for Vallejo. We are here to listen to one another's stories and record these testimonies."

Vallejo is one of the cities in the state with a modest population of Black people who are fighting for recognition during the reparations proceeding. It does have an abundance of Black history to be shared.

Home of the former Mare Island Naval Shipyard, Vallejo is 32 miles north of San Francisco. The 2020 United States Census says the East Bay Area city had a population of 22,416 Black people (18.48%) out of a total of 121,275. Statewide, Blacks are 5.4% of the population.

The third listening session hosted by CJEC was held in Sacramento. Task Force member and Bay Area attorney Don T. Tamaki participated virtually in the session that was held in Sacramento's Oak Park neighborhood.

At the Sacramento listening session, the community testified about how to south to the west coast, how the Freedman's Bureau model can be used to determine reparations, and Black pioneer's presence during the Gold Rush.

The community listening sessions are being conducted across the state by Reparations Task Force's seven "anchor organizations."

The seven, Afrikan Black Coalition, Black Equity Collective, Black Equity Initiative, California Black Power Network, Coalition for a Just and Equitable California, Othering and Belonging Institute (University of California Berkeley) and Repaired Nations began conducting community gatherings in March.

The listening sessions are designed to ensure certain communities around the state have the opportunity to provide their thoughts and concerns about the work the task force is doing.

On June 1, 2022, the Task Force issued a 483page interim report to the experienced by African Americans as a result of slavery and its lingering effects on American society today.

"It's a sweeping indictment," Tamaki said of the report during the Sacramento community listening session. "It connects the harms of the past and follows the consequences that we face today. There have to be legislative remedies."

The interim report also includes a set of preliminary recommendations for policies that the California Legislature could adopt to remedy those harms. A final report will be issued before July 1, 2023.

The Task Force's inperson meetings will reconvene in Los Angeles at the Paradise Baptist Church on Friday, Sept. 23, at 9:00 a.m. and Saturday, Sept.24, 2022, at 9:00 a.m. The church is located at 5100 S. Broadway.





remembers, Hervey "Rick was just one of many artists. Prince, Michael Jackson, all of the big names at that time weren't getting played.

"I found out there was going to be a Billboard music panel about the state of music videos, and Gail Sparrow, who was program director at MTV, was going to be on the panel," recalls Hervey.

He understood that the execs at MTV were trying to protect themselves, but they also didn't have an artist on the panel. He recalls proposing a thought to James, "I suggested the idea to Rick, and asked him if he would be interested. This would be a chance for him to be an ambassador for Black music."

The idea was to force Sparrow to make a statement as to why MTV does not play "Black videos by Black artists," and how it could "begin an even wider discus-

"Well, we had a script of how we were going to handle everything, and as soon as it was his [James] turn to speak, he attacked MTV for not playing his videos," says Her-

Although James received much media attention from the hoopla, the plan was for James to be a spokesperson for all Black musicians. "The whole deal backfired," says Hervey. "To me, not all press is good press.

"He (Rick) got on ABC's Nightline, and the L.A. Times did a story on him, but it was him whining over his videos

MTV would ban all Rick James' music videos until his collaboration with Eddie Murphy on the hit song, "Party All The Time," in

"The thing about disappointment is it's natural. We don't live in a perfect world and there are no perfect people," notes Hervey. "We're all fallible and we all have flaws. When you must confront disappointment, it helps you to self-access, and try to figure out what you can do

In addition to his own illustrious accomplishments in entertainment, Hervey is also famous for his relationship with world-renowned performer Vanessa Williams.

The couple married in 1987, and had three children, Melanie, Jillian, and Devin. They have been divorced since 1997. Hervey and Williams met when he was hired to revitalize her career after an infamous scandal. The controversy involved the release of salacious photos in the adult magazine, Penthouse, which resulted in Williams, resigning as the reigning Miss America in 1984.

Many media sources would site Hervey as the genius who saved her career by suggesting Williams capitalize on her talents as a musical artist. Hervey had this to say about their relationship.

"It's hard juggling being someone's everything. I was a husband, father, protector, and manager," he says. He now remembers fondly the many ways the "love and partnership" with Williams forever changed his life. "I don't regret anything about it, and I would do it again."

American Airlines Captain, Dr. Gerald A. 


Also, Higginbotham created The Captain's Millionaires program, to enlighten, educate and empower students in the areas of personal and business growth and development.

preparation pathways, and delivering quality special education instruction and IEP services.

According to the PUSD website, its geographic service area encompasses Altadena, Pasadena and Sierra Madre. There are about 18.500 students enrolled in the district, and when compared to those of the general population, "reveal a community sharply divided along economic, geographic and ethnic lines. For example, while officially 12% of the 200,000 residents in the district service area live below the poverty line (source: US Census), 66% of PUSD's students qualify for the federal free/reducedprice meals program.

"Sixteen of the District's elementary schools receive Title I funding based on the socioeconomic characteristics of their students, and more than 66% of all students qualify for the free and reduced lunch program. 59% of students are Latino, 13% are African-American, 18% are Caucasian, 7% are Asian/Pacific Islander and

3% are multiracial/other. 20% are English learners, and 11% of students are served for special needs. Almost 2% of PUSD students are in foster care, one of the highest rates among all districts in Los Angeles County..."

the district, she was well prepared, she said, to enter UC Berkeley. There, she studied critical pedagody and African American studies. She also holds a Master's Degree in Public Administration from the Marxe School of Public and International Affairs at Baruch College of New

comprised of nine members of scholars, psychologists, elected officials, professors, and academics - will turn over to the California State Legislature," said Moore, an attorney who resides in the Leimert Park neighborhood. Other local task force members Senator Steven Bradford (D-Gardena) and Assemblymember Reggie Jones-Sawyer (D-Los Angeles).

"We are passionate about reparations and our task, as a collective, is to not only study the clear claim for reparations for African Americans, but also we're advising the legislature on the types of reparation proposals they should implement. We want to make sure that the community continues to have a voice in terms of developing what reparations will look like," she noted.

The in-person hearing, held at Paradise's campus at 5100 S. Broadway in South L.A., will feature an extensive agenda. In addition to public comment, force members will offer reflections on completing the first half of a two-year process, discuss community engagement strategies, and review specific criteria to include in the final report.

"Day 2 will be dedicated to discussions on human law/international

frameworks reparations where we will hear from expert scholars, as well as from our retained economists/experts potential compensation formulas for specific statesanctioned atrocities against the California African American community," explained Moore.

While the two-day schedule appears full, the task force is expected to approach it with the usual efficiency that they've applied to previous gatherings. The group has already held nine hearings with each session highlighting topics such as gentrification, culture, health, education technology. In addition, the task force hosted several listening sessions with members of the public throughout the state.

This past June, the Task Force released a 500-page interim report described as "the first governmental report hyper-focused on addressing the unique needs of the African American community since the 1968 Commission." Scholars "as well as laity" commended the group for its careful examination of the 12 major areas of systemic discrimination that negatively effectthe African American community.

The report cites those factors as enslavement, terror, political disenfranchisement, separate unequal education, housing segregation, racism environment infrastructure, pathologizing the Black family, control over creative cultural and intellectual life, stolen labor and hindered opportunity, an unjust legal system, mental and physical harm and neglect, and the wealth gap.

"It has been an honor and a privilege to supervise the release of this monumental interim report. A year-long effort, this 500+ page report chronicles the harms against the African American community, starting with the transatlantic slave trade, the institution of U.S. chattel Emancipation and the broken promise of Reconstruction, genocidal Jim Crow, to contemporary harms," Moore when the document was issued.

"Thus, it is my hope that people in California and across the United States utilize this report as an educational and organizing tool, as this interim report exceeds expectations in substantiating the claim for reparations for the African American/American Freedmen community on the municipal, state and federal level," she stressed.

As for the future, Moore and the California Reparations Task Force members are committed to involving the community as much as possible over

the next year. And that involvement includes urging the public to participate in the upcoming hearings at Paradise Baptist Church.

"A lot of black folks believe that we're owed reparations, but a lot of us don't think that it'll happen 1960s," said Moore. in our lifetimes. But, as my mom said, many of our ancestors didn't think we were going to be free from slavery and if you go even further, many ancestors didn't think they were going get civil rights in the

"It's okay pessimistic, but you have to also continue to work because reparations is so important and it's needed!"





# FLAMES ENGULF HISTORIC VICTORY BAPTIST CHURCH IN SOUTH L.A

STAFF AND WIRE REPORT

More than 100 firefighters battled a major emergency fire consuming Victory Baptist Church in the South Park area of Los Angeles on Sunday, Sept. 11.

Firefighters were expected to remain on the scene for some time to pour water on hot spots and smoldering debris, said the Los Angeles Fire Department's Nicholas Prange. The fire was reported at

2:22 a.m. at the church, located at 4802 S. McKinlev Ave., Prange said.

Firefighters ended the offensive battle and took up defensive positions outside the building after the interior structure collapsed, trapping multiple firefighters, he said.

One firefighter was taken to a hospital by paramedics with moderate injuries while another injured firefighter was in fair condition and would seek

follow-up treatment later. The defensive fight was aimed at putting out the flames and protecting structures near the burning building.

Arson investigators are closely examining the remains of the building to determine the cause of the fire. Also, the L.A. Times reported the involvement of the House of Worship Task Force, which is comprised of multiple agencies focused on identifying and convicting people who target churches in Los Ange-

Victory Baptist has played an integral and historic role in South L.A. Many famous gospel artists appeared at the church and the Rev. Dr. Martin Luther King, Jr. preached during a service in the 1960s.

Victory Baptist Pastor W. Edward Jenkins has vowed that the ministry will continue despite the burning of the edifice.



# The Seven-Fold Path of Blackness: Color, Culture and Self-Conscious Practice

of Us have understood. engaged and embraced Blackness as a very serious and sacred way of being and becoming in the world, an African way, a unique and equally valid and valuable way of being human with all its rich and varied possibilities and worthy of the highest respect.

Indeed, we maintain that as Africans, as human beings and possessors of dignity and divinity, as our ancient sacred texts teach us, there is no people more chosen, elect, appointed or otherwise specially designated than we are. This means there are no lives more sacred than our own, no historical narrative more holy or worthy of being taught or told than our own, and no culture richer in lessons of life, excellence and struggle for us than our own.

Unlike our oppressor, saw no need or reason to ruthlessly seek dominance or irrationally immorally superiority over others. On the contrary, our centuries sustained righteous relentless struggle has been to reclaim an identity and culture brutally distorted and degraded, to regain a freedom savagely subverted and suppressed, and to return to and resume history interrupted and highjacked for the oppressor's radically evil purposes and practices.

To speak righteously and usefully of Blackness as a serious and sacred way of being and becoming in the world is to rightfully define it. We said in the Sixties that the defining features of Blackness in the context and concerns of our times as a people in oppression and resistance were: color, culture and consciousness.

By color is meant the

people of color, beautifully Black in all its variations and meanings; culture is the totality of thought and practice by which a people creates itself, celebrates, sustains and develops itself and introduces itself to history and humanity; and consciousness is the self-conscious ways we act and struggle to create the conditions for the people to be themselves, free themselves and live good and meaningful lives. This is clearly a call for rightful and useful paths to pursue, ground our lives, achieve our goals and come into the fullness of ourselves.

Thus, when we defiantly declared in the Sixties "Liberation is coming from a Black thing," it was a declaration that we were and are our own liberators, and that the path we pursue will come from our own hearts, minds and making. Clearly at the heart of our striving ad struggle and the foundational and overarching set of principles and practices that undergird, inform and inspire all we do are the Nguzo Saba, the Seven Principles: Umoja (Unity); Kujichagulia (Selfdetermination); Ujima (Collective Work and Responsibility); Ujamaa (Cooperative Economics); Nia (Purpose); Kuumba (Creativity); and Imani (Faith).

But as a reinforcing reminder of the centrality of Blackness as a selfconscious practice, as an active self-knowledge, the Seven-Fold Path of Blackness still holds a special meaning and source of motivation for the way we live our lives, do our work and wage our struggles to rightfully remake ourselves and radically transform the context and conditions of our lives. These seven

fullest sense of the words. Moreover, it is to think ethically, to think the good, to be concerned, as our honored ancestors taught about bringing, increasing and sustaining good in the world and engaging the critical issues of our time with the best of our moral sensitivities and moral reasoning.

Thus, thinking Black also means and requires thinking relationally, seeing ourselves always in relationship with reciprocal responsibilities to our people, each other, others and indeed the world. And it also means thinking deep, critically and creatively and caringly about life and bringing and doing good in the world.

To talk Black is to speak truth, speak in gentle and caring ways, avoid lies and language that hurts and harms, and always speak the good. Moreover, to speak Black is to speak truth to the people and to power; to speak a liberated and liberating truth to our people and a defiant, critical, condemning and demanding truth to oppressive power.

It is to talk freedom to the people, telling them things that free their hearts and minds and encourages excellence, and righteous and relentless resistance

of oppression. And it is to talk an uplifting reaffirming truth to our people, reminding them of their beauty, creativity, sacredness and soulfulness, and their capacity to wage and win their liberation struggle.

To act Black is to practice and pursue good in the world. It is to be conscious, caring and rightfully motivated and informed in all we do. It is to be selfconsciously and actively committed to achieving and sustaining African and human good and the wellbeing of the world. Acting, showing agency or practice permeates and makes possible following the other paths. For in the final analysis, we say practice proves and makes possible everything.

Thinking, talking, creating, buying, voting and living are all practices requiring agency, capacity, choice and will to act. And we are to act in ways that embody and express the good we seek to achieve and share in the world.

To create Black is to create good in the world, and as always, the principle and practice of Kuumba teaches us, to always do all we can in the way we can to leave our community better and more beautiful than we inherited it. It is to create spaces and possibilities for beauty, meaning and love and reciprocal caring and concern in our local and national communities and in the global African community.

Indeed, to create Black is to be our soulful selves, to imagine beauty and bring it into being, to strive for excellence in all we do and achieve it, and make artful – skilled, creative and engaging – the way we live

even in the way we wage our struggles for good in our lives, the lives of our loved ones and in the world.

To buy Black is to support community economic institutions, projects, efforts and interests. It is to self-consciously be attentive to how economic practices and systems in and outside the community help or harm us, provides space for us to work, have incomes, make decisions and live lives of dignity and decency. And to buy Black is also to be conscious of how our income and monies are spent and used by businesses to preserve and protect the environment or contribute to its progressive degradation.

In a word, it is to be conscientious consumers rather than mindless ones collaborating in our own and the world's devastation. Indeed, we must be more than buyers or consumers and dare to be constantly concerned with the world, its well-being and our own. For they are inseparably linked.

To vote Black is to vote in the rightful interests of our people, the world and all in it. For we must always be concerned, not with ourselves in isolation, but as a people in and of the world in both the social and natural sense. Also, we must remember that in spite of the established order's attempt to hide and deny it, we are a key moral and social vanguard in this country, with an expansive agency of inclusive good, waging struggles and winning victories with our allies that have not only expanded the realm of freedom and justice in this country, but serves as a world-encompassing model of the struggle for human rights and liberation to

Furthermore, to vote Black is to accept and practice the responsibility to vote for several interrelated reasons: it is a hard-won gain and legacy; a central site for participating in policy making; another field of resistance in a country whose entire land is a battleground for each and all of us; and it is way of clearing the ground, not so much for a special candidate, but to create the best conditions for our continued struggle after the election.

Finally, to live Black is to live in dignity-affirming, life-enhancing and worldpreserving ways. It is to wage and win the struggle to be ourselves and free ourselves, flourish and come into the fullness of ourselves. It is experiencing a sense of wholeness, genuineness and joy in our lives, profoundly satisfied with the unique and equally valid and valuable African way of our being human in the world.

It is to live rightfully, respectfully and reciprocal relations with others in freedom, security of person, peace with justice, material security, health and wholeness, and always rightly concerned with the well-being of the world.

Even more than that, we have not listened to your servants the prophets, who spoke in your name to our kings, our leaders, our fathers, and all the people of the land."

What does this say to us? This prayer teaches us "how" to approach the throne of the one and only Holy God! Daniel honors God and prays to Him reverently, humbly. He prays for all his people near and far.

"Righteousness belongs to you, Lord, but to us open shame, as it is this day to the men of Judah, the inhabitants of Jerusalem, and all Israel, those who are nearby and those who are far away in all the countries to which you have driven them, because of their unfaithful deeds which they have committed against you.

"Open shame belongs to us, LORD, to our kings, our leaders, and our fathers, because we have sinned against you. To the Lord, our God, belong compassion and forgiveness, because we have rebelled against Him; and we have not obeyed the voice of the LORD our God, to walk in His [f]teachings which He (O) set before us through His servants the prophets."

Although he is praying for all Israel; this is a prayer we need to pray for our own people and our country! By not obeying the voice of Jesus Christ and accepting Him, aren't we building up problems upon ourselves?

I ask you...Daniel is saying that because of disobedience, "The curse has gushed forth on us, along with the oath which is written in the Law of Moses the servant of God, because we have sinned against Him."

Daniel goes on praying. "So He has confirmed His words which He had spoken against us and against our rulers who ruled us, to bring on us great disaster; for under the entire heaven there has not been done anything like what was done in Jerusalem."

In other words, the Lord has not forgotten what Jeremiah wrote and has not forgotten what would happen if they would not obey. Daniel continues in his prayer, telling the Lord, "You who brought your people out of the land of Egypt with a mighty hand and made a name for Yourself, as it is this day—we have sinned, we have

been wicked."

Daniel pleads to the Lord on the basis of His righteousness to turn away the wrath He promised as reward for disobedience. "Lord, in accordance with all your righteous acts, let now your anger and your wrath turn away from your city Jerusalem, your holy mountain; for because of our sins and the wrongdoings of our fathers, Jerusalem and your people have become an object of taunting to all those around us. So now, our God, listen to the prayer of your servant and to his pleas, My God, incline your ear and hear! Open your eyes and see!

"We are not presenting our pleas before you based on any merits of our own, but based on your great compassion. Lord, hear! Lord, forgive! Lord, listen and take action! For Your own sake, my God, do not delay, because your city and Your people are called by Your name."

Gabriel Brings an Answer: "While I was still speaking and praying, and confessing my sin and the sin of my people Israel, and presenting my plea before the LORD my God in behalf of the holy mountain of my God, while I was still speaking in prayer, the man Gabriel, whom I had seen in the vision previously, came to me in my extreme weariness about the time of the (AO) evening offering.

"And he instructed me

# Rapper PnB Rock Slain in South Los **Angeles Restaurant**

A search was continuing on Tuesday, Sept. 13, for the person who gunned down rapper PnB Rock inside a well-known South Los Angeles restaurant, with police saying a social media post apparently led the attacker to the eatery to rob the singer of his jewelry.

shooting was reported at 1:23 p.m. Monday at Roscoe's Chicken & Waffles at 106 W. Manchester Ave., where the rapper was eating lunch with his girlfriend when a man walked up to the couple, drew a handgun and demanded PnB Rock's jewelry, according to police.

"The suspect shot the victim multiples times, removed property and then left the location in a getaway car," LAPD Capt. Kelly Muniz told reporters.

Witnesses said the suspect and the victim argued during the shooting, which was captured on

surveillance system. The rapper was taken to a hospital where he was pronounced dead, Muniz

Born Rakim Hasheem Allen in Philadelphia, PnB Rock, 30, was based in Los Angeles at the time of his death. Police closed Manchester Avenue in the vicinity of the shooting after the shooting and searched the immediate area for evidence and the getaway car.

PnB Rock had been at the restaurant with his girlfriend, who had posted a location-tagged photo in a since-deleted Instagram post, LAPD Chief Michel Moore said.

The rapper "apparently with girlfriend or a friend of his and as they're there enjoying a simple meal was brutally attacked by an individual who apparently ... came to the location after a social media posting of the

artist and his (companion) on Instagram a picture of accompanying him, posting a meal at a location that the Police Commission Tuesday morning.

Moore said the assailant went to the restaurant in a car, "entered the location, attacked PnB Rock demanding his property, (who) had an extensive amount of jewelry and other valuables."

``A struggle ensued and PnB Rock was shot and killed. Lost his life there, simply over the jewelry and valuables he had on his person." Investigators were examining security video from inside the restaurant to identify the shooter, Moore

On its official Instagram page, Roscoe's Chicken & Waffles posted a statement saying, "We are deeply saddened by the death of Rakim Hasheem Allen, also known as PnB Rock, an incredible artist in Los Angeles and everywhere. His passing represents an enormous loss to each and every one of us. Our most

condolences, thoughts and prayers go to the Allen family at this difficult time. The safety of our employees and guests are our utmost priority. We have and will continue to keep our place of business as safe as possible."

The shooting its apparent link an Instagram post reminiscent of the 2020 killing of rapper Pop Smoke in the Hollywood Hills. In that case, the rapper had made a series of social media posts revealing his location and valuables he had in his possession.

On Twitter, singer Nicki Minaj lamented PnB Rock's killing, writing, "After Pop Smoke there's no way we as rappers or our loved ones are still posting locations to our whereabouts. To show waffles & some fried chicken????! He was such a pleasure to work with. Condolences to his mom & family. This makes me feel so sick. Jesus."

# Iowa Teen Who Killed Rapist Sentenced, Ordered to Pay \$150K

A teenage human trafficking victim who was initially charged with firstdegree murder after she stabbed her accused rapist to death was sentenced on Tuesday, Sept. 13, in an Iowa court to five years closely supervised probation and ordered to pay \$150,000 restitution to the man's family.

Pieper Lewis, 17, was sentenced Tuesday after she pleaded last year to involuntary manslaughter and willful injury in the June 2020 killing of 37-yearold Zachary Brooks of Des Moines. Both charges were punishable by up to 10 years in prison.

Polk County District judge David M. Porter on Tuesday deferred those prison sentences, meaning that if Lewis violates any portion of her probation, she could be sent to prison to serve that 20-year term.

As for being required to pay the estate of her rapist, "this court is presented with no other option," Porter said, noting the restitution is mandatory under Iowa law that has been upheld by the Iowa Supreme Court.

Lewis was 15 when she stabbed Brooks more than 30 times in a Des Moines

apartment. Officials have said Lewis was a runaway who was seeking to escape an abusive life with her adopted mother and was sleeping in the hallways of a Des Moines apartment building when a 28-yearold man took her in before forcibly trafficking her to other men for sex.

Lewis said one of those men was Brooks and that he had raped her multiple times in the weeks before his death. She recounted being forced at knifepoint by the 28-year-old man does not typically name to go with Brooks to his victims of sexual assault, apartment for sex. She told officials that after Brooks had raped her yet again, she grabbed a knife from a bedside table and stabbed Brooks in a fit of rage.

Police and prosecutors have not disputed that Lewis was sexually assaulted and trafficked. But prosecutors have argued that Brooks was asleep at the time he was stabbed and not an immediate danger to Lewis.

Iowa is not among the dozens of states that have a so-called safe harbor law that gives trafficking victims at least some level of criminal immunity.

Lewis, who earned her GED while being held in juvenile detention, acknowledged in a statement prior to her sentencing that

she struggled with the structure of her detention, including "why I was treated like fragile glass" or wasn't allowed to communicate with her friends or family.

"My spirit has been burned, but still glows through the flames," she read from a statement she had prepared. "Hear me roar, see me glow, and watch me grow."

"I am a survivor," she

The Associated Press but Lewis agreed to have her name used previously in stories about her case.

Prosecutors issue with Lewis calling herself a victim in the case and said she failed to take responsibility for stabbing Brooks and a father."

The judge peppered with repeated requests to explain what poor choices she made that led up to Brooks' stabbing and expressed concern that she sometimes did not want to follow rules set for her in juvenile lockup.

"The next five years of your life will be full of rules you disagree with, I'm sure of it," Porter said. He later added, "This is the second

compulsion by another's threat of serious injury, provided that the defendant reasonably believed that such injury was imminent."

Prosecutors argued Tuesday that Lewis waived that affirmative defense when she pleaded guilty to manslaughter and willful injury.

# 'Walking Alone' Celebrates the Legacy of Kenny Washington

The memoir "Walking Alone: The Untold Journey of Football Pioneer Kenny Washington" descriptively tells the story of Washington and his accomplishments on and off the football field. Washington is known for breaking the color barrier in the NFL when he signed with the Los Angeles Rams in 1946.

What allured author Dan Taylor to write the memoir was stories he heard from people who witnessed his athleticism firsthand. In those stories, they noted how Washington was a better football and baseball player than his UCLA teammate, MLB icon Jackie Robinson.

"When I got in there and really started reading about [Washington] in the Sentinel and other resources, I was amazed; this may have been the greatest football player

of all time who obviously didn't get the opportunity to showcase those skills," Taylor said. "There were three different times when he was the central figure in attempts to integrate professional baseball."

To research Washington, Taylor relied on articles from several periodicals, including the L.A. Times, the Pittsburgh Courier, the Oakland Tribune, UCLA's Daily Bruin, the California Eagle, and the L.A. Sentinel. Accessing the library and sports information office at Washington's alma mater, UCLA, was a challenge for Taylor during the Quarantine of 2020.

Another challenge was finding subjects to interview. If Washington were alive, he would be 104. His son, Kenny Washington Jr., along with teammate, Woody Strode, and his children have passed away. However, Washington's daughter, Karin Cohen, and grandson, Kirk Washington,

helped him.


Taylor also interviewed the daughters of Babe Horrell, who coached both Washington and Robinson along with the son-in-law and wife of Washington's UCLA teammate, Ned Mathews. Taylor noted that Horrell's daughters had "wonderful stories" about Washington.

"They just idolized [Washington]," Taylor said. "Their dad would have the team to the house, and they had some wonderful memories of that."

Along with recounting Washington's football and baseball games in vivid detail, "Walking Alone" touches upon his career as an actor.

"The movie opportunity "While Thousands Cheer," it was clearly based on his popularity and it was written for him to star in," Taylor said.

The book also highlights Washington's relationship with Robinson. Due to word limitations, Taylor was unable to share how Washington would attend Robin-

son's football games when he attended Pasadena City College.

"[Washington] was a guy who would go and watch [Robinson] play and come back and tell the UCLA coaches "We have to have him, this is the guy we have to have,"" Taylor said.

Washington still holds the Rams record for the longest touchdown run from scrimmage, with a 92-yard carry, which was set back in 1947. Researching Sentinel articles gave Taylor proof that UCLA had five African American football players in 1939 when other publications only recorded four.

"In 1939, I mentioned only 12 schools had integrated football teams and almost all of them had just a single African American player, but UCLA had five," Taylor said. "The Sentinel was a key part of nailing down that they had five, as there was a picture the Sentinel had."

# UCLA Dominates in Historic Battle Against Alabama State

The UCLA Bruins football team defeated Alabama State University 45-7 to earn their second consecutive victory. This is the first time the UCLA Bruins battled the Alabama State Hornets.

Quarterback Ethan Garbers stepped in for starter Dorian Thompson-Robinson to make 14 passes for 164 yards, Thompson-Robinson gained 101 yards from nine passes and one touchdown before being

sidelined with an injury.

"I prepared this week as if I was gonna play and you gotta go into it with the mindset of you're here right now ... you just got to do your job," Garbers said.

Alabama State quarterback Myles Crawley slung 15 passes for 177 yards and scored one touchdown.

"We could compete at a high level," Crawley said. "I feel like we could have done a lot of things better, but I like where we at right now."

UCLA struck early, scoring twice in the first

quarter. Crawley advanced the field through passes and a 21-yard target to Jeremiah Hixon would put the Hornets on the scoreboard.

The Hornets showed flashes of strong defense throughout the contest. Midway through the second quarter, Garbers targeted freshman running back Carsen Ryan for a 26-yard play and a first and goal at the three-yard line. Alabama state denied the endzone from the Bruins three times, forcing them to kick a field goal.

By halftime, UCLA was up 31-7. Although their football team struggled, the Alabama State Mighty Marching Hornets put on a halftime show that received a standing ovation from the 33,727 fans that were in attendance.

In the third quarter, Garbers was at Alabama State's six-yard line when he was picked off by freshman defensive back Adrian Maddox.
