Another victory for prominent Los Angeles law firm Ivie, McNiell, Wyatt, Percell, and Diggs (IMW) came recently in a case

Unified School District (PUSD). The firm obtained a jury verdict of more than \$887,000 against PUSD on September 11, 2019, after a one-week trial in Van Nuys. The jurors voted 11-1 in favor of the plaintiff, who had been a 14-year-old Pasadena High School student when she was pressured

The two discussed Bunch's timely new book, "A Fool's Errand: Creating the National Museum of African American History and Culture in the Age of Bush, Obama, and Trump."

"I [initially] saw this journey to build a museum that could help bridge the chasms that divide us as a 'fool's' errand,'" Dr. Bunch


The book outlines the multitude of challenges Bunch faced when pursuing the construction of the historical museum.

Those challenges included choosing the location; architec, design team, and the collection of unique pieces of African American artifacts.

He added that the museum was "an errand worthy of the burdens."

Speaker, Author Cheron Griffin is on a Mission to Stem Epidemic of Suicide Among Black Youth With New Book

Shocked and saddened by what she was hearing in her classrooms when she worked as a substitute teacher a few years ago, freedom coach, lifestyle hacker, dating consultant, divorce guru, and author Cheron Griffin, felt she had to do something about it. "When I asked the children what was on their hearts, they started to tell me some of their parents and other family members had tried to commit suicide and how it affected them." Some of the children had themselves contemplated suicide citing low self-esteem, bullying, or abuse or not feeling loved in the home as reasons.

Griffin clarifies that though when she says she wrote the book for our children, she means ALL of society's children, she does want people to be aware that suicide has started to have an enormous impact on the Black community. "Black children between the ages of eight to twelve are number on in that age range, who are committing suicide. In the Houston school system, over a thousand children committed suicide last year."

The irrepressible Philadelphia native (she's currently based in Houston) thought it best to come up with a way to prevent people from giving in to the dark thoughts and emotions that lead to suicide. Griffin decided to write her own



book, "I SEE YOU: Igniting Hope & Preventing Suicide," her own way.

one is at the point of contemplating suicide they often don't even have the energy to get out of bed. Reading a book full of certainly also out of the Freedom," which is avail-

punctuated by the threesyllable refrain, "I see you," as its passionate, hopeful motif, and ends with the phone number for the National Suicide Hotline. That particular phrase is important because, Griffin says, "Not enough people know that someone really does see them. We communicate so much about the negatives in our society that a lot of people get lost. I see you and you are loved really is the gist of the book."

Per her bio, Griffin is a published author, radio talk show personality, internationally known speaker, and entrepreneur with a 12year tenure in philanthropy. She is also the CEO of Grow a Girl Network Inc. a non-profit organization that addresses multiple issues affecting our youth. "I've had the desire to encourage people all of my adult life.

Though it was media reports that finally prompted Griffin, the mother (and grandmother of three also has personal experience with suicide, revealing that her god-daughter recently attempted suicide. "Thank God, she's okay now but she is still dealing with anxiety and depression," states Griffin.


Griffin isn't done yet. Creating a comprehensive creative protocol to combat suicide, she has also composed an ode to faith, hope and the rewards of carrying complicated ideas then, is on, entitled "I See You

"Traveling for me is self-care. That's when I really get the time to talk with God about my issues and press the restart button on my life. Traveling allows you to experience other cultures if you really take the time to. You get an appreciation of your own blessings."

Griffin is also a former First Lady, an experience she pulled on for her most recent book, "3PM: The Preacher, The Power, The Penis, and Me" and her reality series "Preacher's Exes." She indicates that the experience for many First Ladies, is far from what we would assume. "I wouldn't wish it on anyone. I hate the term, 'First' Lady. It means that there weren't others," laughs. She also witnessed a lack of accountability, opportunism, and rampant hypocrisy that got in the way of the true mission. On a less bittersweet note, she explained, "It has helped me in what I'm doing now as far as my faith. Being in ministry allowed me to acquire that."

The first human beatbox in the rap world, Doug E. Fresh amazed audiences with his mouthed imitations of drum machines. effects, and samples of hip-hop classics. He made his first appearance as an artist in 1983 on a single for Spotlight called "Pass the Budda," with Spoonie Gee and DJ Spivey. His introduction to most hip-hop fans was with his performance in Beat Street behind the Treacherous Three. His first solo feature came in 1984, with "Just Having Fun," waxed for Enjoy, and "Original Human Beatbox" for Vinentertainment. In 1985, he was one of the biggest names in rap music, and his first single for Reality, "The Show/La Di Da Di," became a hip-hop classic. His first LP, 1987's "Oh, My God!" featured most of his showpieces, like "Play This Only at Night" and "All the Way to Heaven," along with nods to reggae and even gospel. In 1988, he released his second album, "The World's Greatest Entertainer," which reached the Billboard thanks to single, "Keep Risin' to the Top."

Johnny Gill



Johnny Gill is a singer, songwriter, producer and Grammy-nominated, multiplatinum artist. Discovered at the age of 16, he released two albums through Atlantic Records. He later joined iconic boy band, New Edition and they released timeless classics such as "If It Isn't Love" and "Can You Stand the Rain." In the 90s, Gill launched a solo career and created major hits working with producers Jimmy Jam & Terry Lewis like "Rub You the Right Way" and with L.A. Reid & Babyface on "My, My, My." He also formed another supergroup, Heads of State, with New Edition peers, Bobby Brown and Ralph Tresvant. In 2014, Gill's "Game Changer" with record label, J Skillz, received much acclaim. Gill recently released "Game Changer II" also with J Skillz Records/ Kalvary. Like its predecessor, 2014's "Game Changer," Gill's eighth solo studio album arrives packed with an avalanche of hits.

Following Sola Impact's mission statement, "doing well by doing good," Muoto is excited to bring The Beehive to South Los Angeles with intentions of "pollinating" the economic sector.

"We hope that the next Snapchat, Spotify, or Lyft comes from South LA," Muoto said. "We want to ensure that the companies that make this their home, also make this their community as well. We want to make sure that our commercial tenants reflect the true commitment to South LA."

Located in the historic Goodyear District, The Beehive will make history as a co-working space and creative office with shared amenities designed to help boost innovative entrepreneurs, local businesses and startups. Near both Downtown Los Angeles and multiple historic intersections and landmarks of South Central, the campus will bridge the gap and connect both worlds.

Along with Muoto, Secretary of Housing and Urban Development, Ben Carson, Sola Impact co-founder, Gray Lusk, executive director of the White House Opportunity and Revitalization Council, Scott Turner, Councilmember Price, and former NBA player and philanthropist, Baron Davis were in attendance to uphold the promise put forth by Sola Impact and The Beehive..

Dr. Carson spoke of his excitement surrounding the arrival and launch of The Beehive, stating Sola Impact is changing lives and thinking of the people.

"It's wonderful to be in South Central this morning and witness the incredible growth and development that is taking place here," Dr. Carson stated.

"Collective impact' is certainly an appropriate word for today. When a community is able to come together and produce great works, bold ambition recognizing that the whole is better than some," Dr. Carson added. sciousness which resists and rejects any feelings of despair or fears of defeat.

Talk freedom to the people. Speak a liberating truth to the people. As Mari Evans, poet of deep vision and struggle said, "Speak truth to the people Free the mind of the people." Indeed, "Free them with honesty. Free the people with Love and Courage of their Being." And then, they will be ready to unite, build and struggle. "Talk sense to the people," she told us. There is no need for lies, illusions, halftruths and mind-dulling mystification.

We must speak the truth of oppression and the human suffering it causes and sustains, speaking of our own and yet linking it to and finding common cause with other peoples. For it is a central and enduring ethical teaching of our honored ancestors that we are to "bear witness to truth and

set the scales of justice in their proper place among those who have no voice," the vulnerable and devalued, the poor, the less powerful and the oppressed.

Talk freedom to the people, then, speak to them about Haiti, the hidden and hushed subject; about Palestine, the prohibited subject; and about the Rohingya of Burma, the Uighurs of China and the Yemeni, a subject deemed irrelevant by the daily and nightly news. Talk of the savage and inhumane occupations of the people's land and lives, the totalitarian violence on every level including against children, ethnic cleansing campaigns and the refusal of the right to return, the imprisonment of millions and deculturization concentration camps, and the criminal indiscriminate genocidal bombing against the peoples.

Talk freedom to the people. Tell them, where there is oppression, there is resistance, and thus these peoples and all the oppressed of the world are in various forms of resistance and struggles for freedom. Convince them that the oppressor can never have the same moral status of the oppressed in any moral system, no matter who the oppressor is and that neither race, religion or ruling fantasies about being elect and elite, superior, chosen or champions for their grossly flawed notions of civilization can override the human rights of persons and peoples to be free, to practice self-determination and pursue their own notion of the good.

Talk freedom to the people. Tell them that the denial of climate change is not a life-preserving option. For the forests are on fire more often with greater intensity; the glaciers are melting; the seas are rising, erasing coastlines and sinking islands; droughts and flooding happen simultaneously; extreme weather is occurring everywhere and the seasons seem less distinct. Tell them to resist talk that people will adjust or are adjusting. For they are not adjusting, but coping. To talk of adjustment in the face of such devastation and decline is to minimize the severity of the problem, the suffering of the people, the urgency of the situation and the requirements nec-

essary to correct it. Speak freedom to the people. Remind them of the words of wisdom and righteous struggle of Harriet Tubman on the life and death struggle that must be waged for freedom when it is denied or threatened with loss or unjust limitations. She tells and teaches us, "we must go free or die, and freedom is not bought with dust." That is to say, it

cannot be bought with little cost and no casualties. And, of course, it will not come from the self-corrected conscience or change of heart of the oppressors and the unrepentant and rapacious rulers and ruiners of human lives. It will only come from the righteous and relentless struggle of the people, themselves.

Malcolm said it; we heard it and dared to live it. He said that "wherever Black people are is a battleline." And we turned this teaching into a battle cry and commitment to struggle, saying "Everywhere a battleline, every day a call to struggle." So, here we are still in righteous and relentless struggle to free ourselves and be ourselves, to make our way in the world as African persons and people, and with others similarly committed, to break the back of all forms of oppression, hidden, disguised or arrogantly open. In this way, we dare to frame and forge our future in struggle and in the most ethical, effective and expansive ways.

Debt collectors target consumers of color, people making less than \$50K

Consumer survey finds bipartisan support for effective debt collection regulation

A new survey asked likely voters across the country what they thought of a proposed debt collection rule. The response was strong and broad opposi-

Proposed earlier this year by Consumer Financial Protection Bureau (CFPB) Director Kathleen Kraninger, the rule would authorize debt collectors to expand how often consumers could be contacted as well as the ways such contacts could be made: email, text messages, and more.

Conducted by Lake Research Partners and Chesapeake Beach Consulting, the poll was jointly commissioned by the Americans for Financial Reform (AFR) and the Center for Responsible Lending (CRL). The results, released on September 11, found stark opposition by consumers to regulatory reforms announced by the CFPB. Consumers are strongly united in wanting more and better protection in this area of financial regulation.

One in five poll participants were contacted by a debt collector in the past 12 months for different types of debt - including medical. Consumers of color, lower-income consumers and military families were contacted at higher rates. More than one in three Black consumers (34%) or consumers with incomes less than \$50,000 (33%), were contacted. Among Latinx consumers, nearly half or 48% were contacted.

Likely voters were most concerned about three specific changes included in the CFPB debt collection proposal:

76% opposed allowing debt collectors to leave messages for people in places that are not private;

74% opposed al-

lowing debt collectors to contact consumers by private direct messaging on social media platforms like Facebook or Twitter; and

73% opposed allowing debt collectors to phone people as often as seven times a week for each debt in collection.

"It should not surprise any of us that Americans don't support governmentsanctioned harassment by debt collectors via phone, email, or text," said AFR Senior Policy Counsel Linda Jun. "And yet that's exactly what the Kraninger CFPB is proposing. The agency needs to withdraw this plan and come up with one that actually protects consumers."

The real irony with CFPB is that for six years, consumers benefitted from a series of actions that helped 29 million consumers to receive nearly \$12 billion in restitution and/ or forgiveness. Additionally, multiple public forums held across the country on a variety of issues gave consumers and all stakeholder interests meaningful opportunities to help shape pub-

lic policy developments. Research released by the CFPB have documented the harm of abusive debt collection practices and shown the rippling consequences of financial services practices as large as mortgages and as small as payday loans.

Under the Trump Administration, a consistent and focused deregulation effort has been underway to turn CFPB into a toothless tiger. It's almost as if CFPB now stands for Corporate Financial Protection Bureau. Rather than living up to its name, CFPB eschews consumers and defers to companies and their preferences as to what financial regulation should look like.

The Administration has also repeatedly emphasized consumer information and education while predatory lenders pick the pockets of unsuspecting consumers. The error in this approach is that being aware of what should occur will not and cannot change punitive practices that earn billions of dollars for the corporations abusing consumers.

These actions are particularly suspect when one considers that debt collection complaints have been among the chief consumer complaints filed at both the CFPB and the Federal Trade Commission. Under CFPB's first director, the agency filed more than 25 federal enforcement actions against debt collectors and creditors that deliver \$300 million in restitution and another \$100 million in civil penalties due to deceptive and abusive debt collection prac-

AKA Raises \$1 Million for HBCUs in One Day, Announces Collaboration with the Black Press of America

For the second year in a row, Alpha Kappa Alpha Sorority, Incorporated, the oldest Greek-letter organization established by African American college-educated women, raised \$1 million in just 24 hours during this month's HBCU Impact Day. The AKA Sorority, Inc. also has agreed to collaborate in the planning for the upcoming 80th-anniversary celebration of the National Newspaper Publishers Asso-

ciation (NNPA) in 2020. Dr. Glenda Glover, international president of Alpha Kappa Alpha, Inc., said the sorority would work with NNPA chair Karen Carter Richards and NNPA president and CEO Dr. Benjamin F. Chavis, Jr., during the NNPA's annual convention June 23-25, 2020 in New

Orleans. "When you need to know the positive stories the real stories - about African Americans, then you understand our dependence on the Black Press for our news," said Dr. Glover, the international president of AKA and president of the historically-Black

nessee State University.

"It is my honor to be a part of this. Alpha Kappa Alpha has been a partner to the Black Press even right here in Nashville with the Tennessee Tribune," she

While the first African American-owned newspaper was founded 192 years ago, the establishment of the NNPA took place in 1940 during a meeting in

Since its founding, the NNPA has advocated for the Black Press of America and delivering news to millions of people daily and weekly from the African American perspective. The NNPA is the national trade association that currently represents a vast conglomerate of more than 223 Black-owned newspapers throughout the country that comprise the Black Press of America.

For her part, Dr. Glover and the AKAs have steadfastly continued to promote support of HBCUs across the nation.

Dr. Glover has led that challenge for contributions as part of a four-year \$10 million fundraising goal to benefit HBCUs.

"As a college president, I need to recognize the

need for HBCUs. I need to recognize the operating needs, and the financial needs because we need funds to survive," Dr.

Glover said. "I asked my membership to support this initiative. We galvanized members, individuals, and corporate sponsors. We kept going back again, and again," she said.

"It's a tremendous feat to raise \$1 million in one day, but we knew HBCUs needed to have funding,

sustainability, and we have to make sure to secure the endowments of each university," she said.

In February, AKA gifted \$1.6 million from their AKA-HBCU Endowment Fund to 32 HBCUs.

As an HBCU graduate, Glover said she has dedicated her life's work to the HBCU community.

"I understand the impact personally that establishing an endowment has on a student's enrollment and graduation prospects,"

Dr. Glover said.

"The actions of Alpha Kappa Alpha Sorority, Inc. will go a long way toward ensuring that HBCUs remain open and able to encourage the best Black students to choose them as a first option," she said.

AKA began on the campus of Howard University in Washington, D.C., in 1908. Today, nearly 300,000 members make up the sorority in approximately 1,018 graduate and undergraduate chapters in

the U.S., the U.S. Virgin Islands, Liberia, Bahamas, Bermuda, Canada, Dubai, Germany, Japan, and South Korea.

For her four-year tenure as president, Dr. Glover has implemented a five-point plan for AKA which includes the HBCU initia-

The other four plan points include a women's healthcare and wellness plan; building your economic legacy; the Arts; and global impact.

"We try to make sure that we handle certain national and international issues," Dr. Glover said. "We have a program of wellness and health. We have a breast cancer mobile unit that travels around the country giving free mammograms to African American women," she said.

"We know that breast cancer tends not to be found in Black women until it reaches stage 4," Dr. Glover said.

"With all of our initiatives, we want to make sure that African Americans don't get lost in the shuffle. That is why we have programs and services that benefit the community," Dr. Glover said.

"Angela Davis is a revolutionary who has fought tirelessly for causes of equity and social justice. Her induction into the National Women's Hall of Fame is well-deserved," Karine Jean-Pierre, a lecturer at Columbia University and spokeswoman for MoveOn. org, wrote on Twitter.

An activist, author, and professor, Davis was born in Birmingham, Alabama, on January 26, 1944.

She is the daughter of two teachers, according to her biography from The HistoryMakers.

Active at an early age in the Black Panthers and the Communist Party, Davis also formed an interracial study group and volunteered for the Student Nonviolent Coordinating Committee while still in high school.

At 15, after earning a scholarship, Davis traveled to New York to complete high school, according to The HistoryMakers.

In 1960, Davis traveled to Germany to study for two years and then to the University of Paris for another year.

After returning to the United States, Davis attended Brandeis University, where she graduated magna cum laude in 1965. Davis then returned to Germany for further study before enrolling in the University of California, San Diego,

"The Black Press is alive and well, and we will continue to be the daily recorders of our history across the globe. Although we've seen many changes within our industry; these changes are bringing better opportunities for the Black Press," Richards said.

"So, we are honored that Dr. Lonnie Bunch has chosen to include us as a part of this important national media event," she said.

While in graduate school, Bunch desired to write a dissertation about the Black Press, he said.

However, naysayers told him the Black Press was unimportant.

He said that theory quickly was proven wrong. "I knew it was," Bunch

"I think the Black Press has always been the guardian of our community. It's always been the place where facts are found that are not told in other places. It's a place where you can understand the richness of the community.


"What I love about the Black Press today is that it's a place that reminds people of the power of the African American community... the Black Press is critically important.

"What [The Black Press] does is it reminds us that there are many different lenses to understand a story. If you don't have the lens to the African American community, where are you going to find your story? For me, the Black Press is crucial not for the past, but for the future," Bunch said.

The Smithsonian national leader also marveled over the enduring legacy of Baldwin, whose works explored racial, sexual, and class distinctions in North America.

"As a 17-year-old freshman at Howard, the first book I picked up was 'Go Tell It on the Mountain,'" Bunch said.

"I was so moved by [Baldwin's] writings. I read everything that he wrote because, in some ways,

what Baldwin did is that he captured the trueness of the community in an unvarnished way. He also inspired us to demand fairness," he said.

Bunch said he sought out to obtain a building that would reference the spirituality, resilience, and hope that have been key elements within the African American community.

Elements he said that have shaped America's

identity in ways most Americans do not understand.

He said the revolution in South Africa reinforced his belief that history is an effective tool to change a country by embracing the truth of a painful past.

The museum opened three years ago to much fanfare, with former presidents Barack Obama and George W. Bush, among others, in attendance. "To some, visiting the museum allows them to find hope ... that the current poisonous political partisanship and racial antipathy will one day be overcome," Bunch said.

A historian, author, educator, and curator, Bunch has enjoyed a career of near unapparelled success.

Bunch has held numerous teaching positions, including American University in Washington, D.C. (Bunch's Alma Mater); the University of Massachusetts, Dartmouth; and the George Washington University in Washington, D.C.

Bunch was elected in 2017 to become a member of the American Academy of Arts and Sciences.

He's also the recipient of the President's Award from the NAACP, and the Impact Leader Award from the Greater Washington Urban League.

Last year, the Phi Beta Kappa Society presented Bunch with the Phi Betta Kappa Award for Distinguished Service to the Humanities and the National Education Association honored him with the Award for Distinguished Service to Education.

Earlier this year, Bunch was appointed Secretary of the Smithsonian Institution, the first African American to hold that position in the organization's 173-year history.

He oversees 19 museums, 21 libraries, the National Zoo, numerous research centers, and several education units and centers.

Now, with "A Fool's Errand," Bunch said he has a simple message to convey.

"History matters," he told Chavis.

"You can't understand yourself or the future without looking back. History is an amazing tool to live your life. More than anything else, it challenges you to be accurate,"

arrangements with the school security officer to get the plaintiff out of class, and bring her to him in the school auditorium. The school security officer had a reputation for facilitating inappropriate conduct by students.

"Kids go to school and parents expect them to be supervised and led in the right direction. But if you have supervision personnel that are encouraging inappropriate activity, then the whole system breaks down," says IMW partner, Keith Wyatt,

who conducted the case along with Kristen Wyatt of IMW.

This case involved claims negligence by Pasadena School District personnel in the supervision of its students, campus, and employees. According to the case summary, defendant (PUSD) admitted that it negligently caused the plaintiff student's damages that were sustained as a result of the incident and that the plaintiff was not at fault and had no responsibility or causation for her damages. As a result of the incident, both students were suspended from school. However, the plaintiff became the victim of threats, bullying, and slander from other students —so much that she feared returning to a regular high school environment and had to complete her high school education at an alternative school.

Due to this result, IMW contended that the plaintiff lost four years of the important social interaction and maturity which come from having a normal, four-year high school experience. IMW also contended that the plaintiff experienced a loss of trust

from the institutional betrayal which caused the incident. The jury awarded plaintiff damages for past, present, and future emotional distress.

"The school administrators, and the police, did not seem to place much value on supervising and protecting our client, a 14-year-old high school

freshman girl, from being pressured into a sexual encounter, while at school, by an adult school security officer and a young man, who was a high school senior. Our client deserved better supervision and protection. The jury agreed with us, and their verdict for \$887,416 was indicative of the val-

From weakening the Bureau's Office of Fair Lending, to rewriting the long-awaited payday lending rule that required lenders to ensure that borrowers can afford to repay these small-dollar loans that come with big costs, businesses and corporations are being coddled while consumers remain caught in harassing debt collection practices and debt trap loans.

"Bad policies from Washington are often the brainchild of people who aren't personally impacted by them," said Jeremy Funk, spokesman for Allied Progress, a consumer advocacy organization. "Maybe spanning the spammer-in-chief at the CFPB will help them realize the massive invasion of privacy that are inviting with this plan...Congress should get prepared to hold them accountable."

Speaking for the Center for Responsible Lending, Melissa Stegman, a Senior Policy Counsel said:

"The poll is clear – Americans don't want CFPB Di-

rector Kathy Kraninger to give debt collectors a license to harass and intimidate consumers," said Stegman. "A consumer-first debt collection rule should protect people – and particularly people of color and active duty military members, veterans and their families – from time-barred 'zombie debt."

House Speaker Nancy Pelosi launched a formal impeachment inquiry against President Donald Trump on Tuesday, acquiescing to mounting pressure from fellow Democrats and plunging a deeply divided nation into an election year clash between Congress and the commander-in-chief.

The probe centers on whether Trump abused his presidential powers and sought help from a foreign government to undermine Democratic foe Joe Biden and help his own reelection. Pelosi said such actions would mark a "betrayal of his oath of office" and declared: "No one is above the law."

Pelosi's brief statement, historic yet presented without dramatic flourish,

capped a frenetic stretch on Capitol Hill as details of a classified whistleblower complaint about Trump have burst into the open and momentum has shifted swiftly toward an impeachment probe. The charge was led by several moderate Democratic lawmakers from political swing districts, many of them with national security backgrounds and serving in

Congress for the first time.

After more than two and one-half years of sharp Democratic criticism of Trump, the formal impeachment quest sets up the party's most urgent and consequential confrontation with a president who thrives on combat — and injects deep uncertainty in the 2020 White House race. Trump has all but dared Democrats to take this step, confident that the specter of impeachment led by the opposition party would bolster his political support.

Pelosi Orders Impeachment Probe: 'No One is Above the Law'

Trump, who was meeting with world leaders at the United Nations, previewed his defense in an all-caps tweet: "PRESI-DENTIAL HARRASS-

Pelosi had barely finished speaking as he began a mini-blizzard of tweets assailing her announce-

At issue are Trump's actions with Ukraine. In a summer phone call with Ukrainian President Volodymyr Zelenskiy, he is said to have asked for help investigating former Vice President Biden and his son Hunter. In the days before the call, Trump ordered advisers to freeze \$400 million in military aid for Ukraine — prompting speculation that he was holding out the money as leverage for information on the Bidens. Trump has denied that charge, but acknowledged he blocked the funds, later released.

Biden said Tuesday, before Pelosi's announcement, that if Trump doesn't cooperate with lawmakers' demands for documents and testimony in its investigations the president "will leave Congress ... with no choice but to initiate impeachment." He said that would be a tragedy of Trump's "own making."

Trump-Ukraine

phone call is part of the whistleblower's complaint, though the administration has blocked Congress from getting other details of the report, citing presidential privilege. Trump has authorized the release of a transcript of the call, which is to be made public on Wednesday.

"You will see it was a very friendly and totally appropriate call," Trump

While the possibility of impeachment has hung over Trump for many months, the likelihood of a probe had faded after specounsel Robert Mueller's investigation ended without a clear directive for lawmakers. Democratic House committees launched new inquiries into Trump's

businesses and a variety of administration scandals, but all seemed likely to drag on for months.

But details of Trump's dealings with Ukraine prompted Democrats to quickly shift course. By the time Pelosi addressed the nation on Tuesday, about two-thirds of House Democrats had announced moving toward impeachment probes.

After Pelosi's Tuesday announcement, the president and his campaign team quickly released a series of tweets attacking Democrats, including a video of presidential critics like the speaker and Rep. Ilhan Omar discussing impeachment. It concluded with a message for the Trump faithful: "While Democrats 'Sole Focus' is fighting Trump, President Trump is fighting for you."

Pelosi has for months resisted calls for impeachment from her restive caucus, warning that it would backfire against the party unless there was groundswell of public support. That groundswell hasn't occurred, but Pelosi suggested in comments earlier Tuesday that this new episode — examining whether a president abused his power for personal political gain — would be easier to explain to Americans than some of the issues that arose during the Mueller investigation and other congressional probes.

The speaker put the matter in stark terms on Tuesday: "The actions of the Trump presidency revealed dishonorable facts of the president's betrayal of his oath of office, betrayal of his national security and betrayal of the integrity of our elections.'

CBCF officials added that the goal of the Sojourner Truth Town Hall was to increase the significance of

Black women in leadership. It's also aimed at building a strong infrastructure of support for Black women candidates and their role in bridging gender equity, voter participation, economic empowerment, access to

health care, and criminal

justice reform as they look

to 2020 and beyond.

Among the highlights were discussions on closing the racial wealth gap; the state of housing in Black America; Black money matters; a financial services brain trust; and a national town hall that focused on the possibilities in the Black community as well as the

challenges. "We cannot give up hope because every time we fight, we win," said NAACP President and CEO Derrick Johnson, who served as a panelist on a two-part national townhall that explored the possibilities and challenges facing African Americans.



Public Safety Program Helps Youth Find Positive Alternatives

The initiative includes four creative intervention strategies designed to disrupt, prevent and respond to gun violence in our communities.

Following historic lows in gun violence, the month of May saw an alarming spike in violent crime. Unwilling to accept the rise in violence, including the murder of South Los Angeles' beloved Nipsey Hussle, Counclimember Marqueece Harris-Dawson launched a robust effort to address the root causes and effects of gun violence in South L.A. Traditionally, the summer tends to display an increase in violence. This summer program meets residents where they are with the resources they need to deal with trauma and intervenes to prevent youth from joining gangs and continuing cycles of violence.

The Community Safety Initiative is an innovative \$1 million public safety program designed to disrupt and prevent gun violence in South Los An-Councilmember Marqueece Harris Dawson brought this program to life in the form of prevention and intervention strategies that leverage existing programs and create new ones to support our communities as they deal with gun violence. The initiative includes four creative intervention strategies designed to disrupt, prevent and respond to gun violence in our communities. Over the next few weeks, we will revisit the Initiative and highlight different aspects of the strategy.

The Youth Workshops produce hour long presentations that introduce students to creative forms of entrepreneurship and

teach STEM skills. All of the workshops are designed to give students practical life-skills that promote self-esteem, empathy, stress reduction, anger management, academic improvement, and civic leadership. The councilmember began this program to expose young people to outlets for expression and entrepreneurship in the hopes of expanding their opportunities for the future.

"I believe in creative solutions to shared community challenges," said Harris-Dawson. "The Community Safety initiative is an opportunity to pilot creative new approaches proven to combat the root causes of gun violence. Our neighborhoods deserve more robust strategies to reduce gun violence and I am proud to partner with individuals and organizations who see the value of this opportunity.

"My thanks go out to the Ballmer Foundation, the California Wellness Foundation and the Weingart Foundation for believing in this holistic proactive approach to investing in our youth."

The initiative uses creative presentations to teach youth entrepreneurship. Baron Jay Littleton, founder of the Baron Jay Foundation, a nonprofit that prepares youth to become responsible, civic-minded, respectful, and productive citizens leads each presentation.

At middle schools and high schools across South L.A., students ages 10-18 learn about social entrepreneurship. Each workshop begins with Littleton introducing basic business principles and quizzing the students on terms like ecommerce and profit. The students display extraordinary focus for their age and after a few minutes, Littleton transitions from the traditional portion of the workshop and something unexpected happens: a magician, entertainer, or entrepreneur enters and after showcasing their skills, the students are given the opportunity to explore their

own talents.

While students imple-

ment what they recently learned, Littleton crystal-lizes the connection and expounds on how the skills learned through creative practice also improve academic progress. Workshops like these have been happening all summer, across South Los Angeles at schools like Johnnie Co-

chran Middle School.

"Young people need training and career guidance to fully realize their potential and overcome challenges," said Littleton.

"We're here to provide these opportunities to moti-

vate and empower economically disadvantaged youth to become productive and empowered members of society."

Students receive the opportunity to learn a new skill and explore aspects of their creativity while also learning business skills. Some have gone on to audition for acting roles while others are exploring starting their own businesses. Additionally, students improve their confidence by learning a new skill then demonstrating it for the class to see.

The Community Safety Initiative workshops conclude in October with a recognition ceremony for over 170 student participants. These workshops were inspired by Nipsey Hussle's legacy of social entrepreneurship and community investment. This innovative partnership was made possible by Ballmer Foundation, the California Wellness Foundation and the Weingart Foundation who all believe in holistic efforts to create safe and healthy communities.

'Legal Drug Dealers' Stronghold on Opioid Market Effects Young Gifted'


Dr. Willam H. Lee dies

He was tireless in the fight for access and respect for Black journalists and relentless in championing for Blacks to have a seat at the proverbial table.

Sacramento OB-**SERVER** publisher emeritus Dr. William H. Lee went on to his glory, having passed away on Sunday, September 22. Dr. Lee was 83 years old.

Dr. Lee was born on May 29, 1936, in Austin, Texas. His parents (Rev. Charles R. Lee, father, and Carrie Lee, mother), with sons William and James R. Lee, moved to California, first to San Francisco and then to Sacramento, in the early 1940s. Dr. Lee attended Sacramento State University (1953-1955) and went on to earn a B.A. (Accounting) from UC Berkeley in 1957. He was awarded an Honorary Ph.D. from Southeastern University in 1970.

After graduating from UC Berkeley, Lee had short, but fruitful, employment stays with both Aerojet and IBM Corporations. His dream to establish his own firm, however, led him to open his own

real estate and land development company in 1960. The success he had in real estate allowed him to invest in the much-needed community newspaper publishing business. He along with local radio connoisseur Geno Gladden and businessman John W. Cole, launched The Sacramento Observer on November 22, 1962.

A short time after starting the paper, Gladden passed away. And, in 1965, Lee and his wife, Kathryn, became sole owners of the paper, also starting at the time the Lee Publishing Company. The publishing company grew during the 1970s and 80s, to publishing at one point, six distinct publications in California and Nevada — including Los Angeles, San Francisco, Stockton, Solano County, Reno, Nevada and Sacramento.

Dr. Lee took on local, state and national leadership roles. From 1970 to board of directors and as an officer of the National Newspapers Publisher's Association (NNPA), the Black Press of America. He was co-founder and a long-time president of the West Coast Black Association (WCBPA). Lee was

Active in the field of journalism and the newspaper industry, Lee's publications, along with his call for quality and excellence in the industry, gave him a national reputation. He was a member of the jury, judging for Pulitzer Prize winners in Journalism in 1987.

Lee's The Sacramento Observer, has been named the nation's No. 1 Black newspaper six times; being awarded the coveted John B. Russwurm trophy, the nation's top newspaper publishing honor given by the National Newspaper Publisher's Association.

A recognized business leader, Lee served on the board of directors of a number of national and local companies, including Blue Cross of California; Methodist Hospital (Sacramento); the Superior Valley Small Business Development merce and the Sacramento

1989, he served on the Corporation; the advisory board of Wells Fargo Bank; and, the advisory board of the former Home Savings financial institution.

Dr. Lee's commitment to serve others kept him active in civic and educational circles. He was named Alumnus of the Year (1993), by UC Berkeley's named "Publisher of the Black Alumni Association. Year" by the WCBPA in He was appointed by California Governor George Deukmejain to chair the statewide Dr. Martin Luther King, Jr. Holiday committee, leading to the state's observance of the MLK holiday. Years later, in January 2014, Dr. Lee would serve as the Grand Marshal of the annual Dr. Martin Luther King Holiday March in Sacramento.

In Sacramento, the newspaper, prestigious Sacramento Magazine named Dr. Lee as one of the "50 Most Powerful Leaders" in the City (2006). He was a cofounder and former President of the Men's Civic League; co-founder of the Sacramento Urban League; as well as co-founder of the Sacramento Area Black Caucus.

> Dr. Lee has been honored by a large number of groups and organizations for his long and dedicated community service and leadership. He received Lifetime Achievement Awards from the California Black Chamber of Com-

Chapter of the Links and the OBSERVER was inducted into the Sacramento Metro Chamber of Commerce's Hall of Fame in 2012.

Dr. Lee has also been saluted by Sacramento 100 Black Men, Inc; the Sacramento Branch of the NAACP (D.D. Mattocks Award); the American Leadership Forum (Exemplary Leader Award) and was a recipient of the Congressman Bob Matsui Award (for Distinguished Community Service); The Greater Sacramento Urban League's Co-Founder Award; the California State University, Sacramento Alumni Association's Distinguished Service Award; and many others.

In 2012, Fortune School of Education named an elementary school, William H. Lee College Prep, in honor of Dr. Lee. The school's computer lab is named after Dr. Lee's late wife.

In January 2015, Kevin Johnson, Sacramento's first African American mayor, awarded Dr. Lee with the Mort Friedman Legacy Award, which honors an outstanding individual who has made notable civic and community contributions within the Sacramento city and region.

A memorial service has been tentatively set for Sacramento on Tuesday, October 1. Details to follow.

STUDENT ATHLETE OF THE WEEK: Q'MARR ALLEN

Senior linebacker Q'marr Allen is using his voice to create change at Los Angeles High School. Not only is Allen a captain of the football team, but he is a leader in different ways on campus.

"I'm well-known around here," Allen said. "I'm all about academics, so my grades are good."

Allen aspires to get both an athletic and academic scholarship, using football as a vehicle to access a free education. Along with playing football, Allen is involved in three different student organizations. One of the organizations is called Students Deserve, a coalition of students, teachers and parents who fight against human injustices.

A recent project, Students Deserve, fought against random searches in the Los Angeles Unified School District. This allows school administrators to randomly search a student's backpack during school hours.

Allen said a speech to a panel of teachers about how the practice was dehumanizing and how the searches disrupt class time.

"[There were] 300 teachers there," Allen said, "I practiced all night on what I wanted to say, practiced all the questions."

Since his speech, teachers approached Allen to speak about the Students Deserve group at their respective schools. Allen is also involved in Black Student Union and Leadership on his campus. He is even on the panel to interview and choose their new prin-

"I have things on my record, my transcripts and so I look good in college, do good in college, be successful," Allen said.

On Tuesdays and Thursdays, Allen gives sports reports via P.A. system; one of many duties he has being the school's sports commissioner. He also stays in touch with different coaches and put up posters for sporting events.

After three games, Allen is averaging 6.8 yards per carry as a running back. He has a season high of 104 rushing yards in the Los Angeles Romans' game against the Hawkins Hawks. On defense, he makes 10.3 tackles per game and has 21 solo tackles this season

The Romans are young, but they are cultivating a family bond. Being one of seven brothers, Allen appreciates a sense of brotherhood among his teammates

"We ask each other if they need help with their homework, we work together [to make] sure everybody gets their work done," he said. "Before and after practice, we pray. We're on a family-type scale."



The Los Angeles Sparks could not overcome the speed and accuracy of the Connecticut Sun in the WNBA Semifinals. In the Walter Pyramid at California State University Long Beach, the Sparks lost 56-78 and were out of Playoff contention.

The young Sun squad showed flashes of greatness in previous seasons,

but head coach Curt Miller planned for the 2019 sea-

son to be a special year. "You can see what happens when a core group plays together for four years," he said. "It's just amazing that that group has allowed the vision that we had all come together."

Connecticut shut down the Sparks backcourt offense throughout the series, making it nearly impossible for guards Riquna Williams and Chelsea Gray to

averages. Meanwhile, the Sun landed more shots and that was no different in Game Three. Connecticut went for 32 percent from behind the arc compared to the Sparks' 10 percent. The Sun also shot at 43 percent in field goals, the Sparks shot at 30.7 percent.

"I feel like we were just doing what we do, it's not really a magic potion to it," Sun guard Courtney Williams said.

Sparks forward Nneka Ogwumike led the team with 17 points, despite running a fever the night before. Sun guard Jasmine Thomas led her team with 29 points and guard Courtney Williams secured 13 rebounds with 17 points.

"They're both great players." Sparks guard Tierra Ruffin-Pratt said about Williams and Thomas. "I think for us it was just being able to play team defense, it's not really a one-on-one thing."

The first quarter started slowly for the Sparks as they struggled to get shots. The Sun kept the ball in their hands, with guard Courtney Williams leading in scoring with nine points. Guard Alana Beard initiated a 7-4 run to help the Sparks going into the second quarter.

Alexis Jones threepointer gave the Sparks their first lead of the game, guard Jasmine Thomas quickly responded with a three-pointer. The Sun battled for rebounds and had few problems scoring from any part of the floor. The Sparks struggled with turnovers and missing shots.

When L.A. would close the deficit, Connecticut would break away to score. The Sparks' offense dried up in the third period, the team was shooting at 19 percent from field and the Sun's lead expanded.

The Sparks, a team with great depth who defended home court throughout the season, where out of sorts on Sunday. Could the change of homecourt have affected L.A.? Despite their 15-2 home record, the Sparks had a 7-10 record in away games. Travel eats up practice time, and the strength and conditioning and player development coaches don't travel, according to Sparks head coach Derek Fisher.

Chargers Squander First Half Lead, Fall to Texans 27-20 at Home

The Los Angeles Chargers were clinging onto a 10-point first half lead, clicking on all cylinders on both sides of the ball, but were ultimately unable to sustain it, allowing the Houston Texans to come from behind and steal a 27-20 victory, Sunday afternoon at Dignity Health Sports Park.

Houston quarterback Deshaun Watson threw for 351 yards and three touchdowns with a 135.8 quarterback rating, helping the Texans (2-1) outscore the Chargers (1-2) 20-3 in the final 30 minutes of play.

During their two-game losing streak, Los Angeles has scored three points, total, in its last two second halves, which has led to frustration from coaches and players.

"We're putting ourselves in position to win these football games, but we're not finishing," Chargers head coach Anthony Lynn said. "We have a lot of football left, a lot of character in that locker room... but we have to find a way to finish football games."

Los Angeles Wide receiver Keenan Allen had 13 receptions for a career-high 183 yards and two touchdowns, while signal caller, Philip Rivers passed for 318 yards and two touchdowns on 31 of 46 completions.

Chargers Running backs Austin Ekeler and Justin Jackson combined for 62 rushing yards on 14 total carries, as the Texans packed the box up front for a large duration of the

"We keep shooting ourselves in the foot," Allen said. "Coming out in the second half, we're not moving the ball. Penalties every time we make a play. Score a touchdown, we get a penalty. Interception, penalty. We've got to find a way to get over that."

The Chargers are no strangers when it comes to getting off to slow starts, marking their fifth consecutive season with a losing record through the first three games of the season.

"That was a year ago," Anthony Lynn said on the teams 2018 (1-2) start. "This is 2019. I have no idea ... well, let me correct myself. I do have an idea how I think this team is going to respond, but right now I can't say we're going to do what we did last year. We're a different team."

Los Angeles scored the first points of the game on a seven-yard touchdown pass from Rivers to Allen in the first quarter.

In the second quarter, Rivers connected with Allen again for a 12-yard touchdown, capping an eight-play 89-yard drive to give L.A. a 17-7 halftime

In the third quarter, Texans tailback Carlos Hyde scored a three-yard rushing touchdown, cutting their deficit to three, 17-14. Seven minutes later, Watson connected with Jordan Akins for a 15-yard score, giving Houston its first lead of the game at 21-17.

The Chargers committed seven penalties that resulted in 69 yards, with some being more crucial than the others.

Defensive back Rayshawn Jenkins intercepted Watson in the fourth quarter only for it to be nullified by offsetting penalties, where a holding penalty on the Texans' Nick Martin and a facemask on the Chargers' Desmond King resulted in a replay of down.

"Was it a facemask? I don't know," frustratingly said Lynn. "But that's what they called."

A few plays later, Watson then dazzled and escaped the pocket, hitting Akins for a 53-yard catch and run for a touchdown, giving the Texans a com-

manding 27-17 lead.

"I was just going out there playing ball, having fun, trying to make things happen," Watson said with a humble smile.

The Chargers had one final chance late, when Rivers connected with Mike Williams for a long completion near the goal line with 24 seconds left, but a costly holding penalty on tackle Trent Scott was called seemingly ending the game with L.A. unable to overcome a 27-20 deficit.

After the game, Watson mentioned how much it meant to him beating a vet-

eran and All-Pro Quarterback like Rivers in a headto-head road matchup.

"To come in his house and compete with him is special," Watson said on Rivers.

"He called my name and said, 'Great job. Continue to grow and have a bright future.' And he said he'll see me in January, so I'm looking forward to

The Chargers will travel to Miami next, looking to pick up some momentum against the winless Dolphins (0-3) on Sept. 29, at 10 a.m., at Hard Rock Stadium.

Former Pro Basketball Player Andre Emmett Shot and Killed

Former Texas Tech star and NBA player Andre Emmett, 37, was shot and killed in the early morning on Sept. 23, in Dallas and authorities are investigating his death as a homicide.

Playing four years for the Red Raiders under head coach Bob Knight, Emmett was selected as the 35th overall pick by the Seattle Supersonics in the 2004 NBA draft, and was then traded to the Grizzlies.

Emmett played all four years at Texas Tech and finished a stellar collegiate career with 2,256 points according to ESPN's Fran Fraschilla.

Most recently, Emmett played professionally in the 3-on-3 league, BIG3 for 3's Company, being regarded as one of the top

players in the league.

According to Dallas police, Emmett was in his vehicle in front of his Dallas home when two unknown

suspects approached. Police say the suspects showed a gun, an altercation took place, and Emmett was shot as he tried to

run away.

Emmett's body was found at 2:30 in the morning on Sept. 23, in Dallas by a person walking past

his house; he was taken to the hospital where medics observed he had a single gunshot wound and later died according to CBS Local News in Dallas.

Dallas police say the two suspects are still on the

"This is a senseless tragedy, and we do not want it to go unsolved... if anyone knows anything, we're asking that they reach out to the police," said Emmett's Aunt, Karen Oliver.

Once news broke of the devastating shooting, the Ice Cubes basketball league released the following statement:

"The BIG3 is in a state of shock over the sudden and tragic death of Andre Emmett. Andre was a member of the BIG3 family for two seasons and never without a smile on his face. His kindness towards others and easy-going demeanor made him a joy to be around," the BIG3 said in a statement.

"Off the court, Dre was passionate about helping young people through his Dreams Really Exist foundation. We are simply heartbroken by this devastating loss. Our thoughts are with Andre's family and friends during this difficult time."

Emmett, who was a father of two young daughters was not known to have any enemies that would lead to such a horrific act.

"That's why we're so shocked, we don't know anybody that would want to hurt him. He wasn't like that. He wasn't involved in anything like that, he was strictly about basketball, family, business, that was it," said Emmett's sister, Sasha.

Daniel Krikke's Documentary 'Scared of Revolution' — a look at the life of former addict Umar Bin Hassan of The Last Poets

In the 12 Steps Program of Narcotics Anonymous (NA), the fourth step is described as "We made a searching and fearless moral inventory of our-

selves,"— I was reminded of this while watching Daniel Krikke's deeply moving documentary "Scared of Revolution" because it's a searing portrait of Umar Bin Hassan, a former addict, and member of the highly influential

spoken-word group The Last Poets. From the marketing

materials, one would expect to walk away from the film knowing more about the history and importance of The Last Poets and how they shook up music and spoken-word in the 1970s, this is not the case. For the record, The Last Poets have been credited by many insiders as being one of the fundamental building blocks of rap. What the director decided to do is take us on a journey of one of the more prominent members, Umar Bin Hassan, who was born Jerome Huling.

In New York, Hassan achieved a measure of success along with critical acclaim with the release of







Why is Suicide a Growing Problem in the Black Community?

The NNPA is taking a closer look at the stigma of mental illness in the African American community. This is part II in the series.

"There is nothing glamourous about suicide. The one common-denominator shared by all who cut, contemplate or attempt suicide is that they feel emotionally alone in their families," said Dr. Fran Walfish, the author of "The Self-Aware Parent," and who appears regularly as an expert child psychologist on the CBS Television series, "The Doctors."

It's no secret that African Americans – particularly teens – are committing suicide at record levels. According to the Centers for Disease Control and Prevention, suicide rates have increased by 30 percent since 1999 and nearly 45,000 lives were lost to suicide in 2016 alone.

A June 2019 study conducted by the Journal of Community Health revealed that suicide deaths among Black females aged 13 to 19 rose 182 percent between 2001 and 2017, while the rate among Black teen males rose 60 percent during that same period.

From 2015 to 2017, 52 percent of Black teen males who died from suicide used firearms, a method with a fatality rate of nearly 90 percent. Another 34 percent used strangulation or suffocation, which has a fatality

rate of about 60 percent.

Among the 204 Black teen females who died by suicide from 2015 to 2017, 56 percent used strangulation or suffocation and 21 percent used firearms, according to the study.

the study.

Experts and others have tried to determine why African Americans increasingly are choosing to end their lives. Theories have run the gamut – from the lack of strong father-figures to racism and social media and even the increase in Black wealth.

Whatever the reason, the CDC said it's important to note that suicidal thoughts or behaviors are both damaging and dangerous and should be

treated as a psychiatric emer-

CDC officials also caution that those who have suicidal thoughts should understand that it doesn't make one weak or flawed.

"Why are we killing ourselves? The lack of treatment of mental illness is the key factor to why suicide is on the rise in the Black community," said Clarence McFerren, a mental health advocate and author who admits to previously having suicidal thoughts as a teenager.

"Throughout my life, I've been faced with difficult situations which festered into five mental illness diagnosis – ADHD, PTSD, severe depression, bipolar tendencies and anxieties – and I did not understand what was going on until I took the steps to get help," McFerren said.

Famed Beverly Hills family and relationship psychotherapist and author, Dr. Fran Walfish said she's treated hundreds of thousands of children and teens each year and recently she's seen the number of troubled teenagers who are cutters and dealing with suicidal thoughts, feelings, ideas, plans, and even attempts of spiride.

attempts of suicide.

"There is nothing glamourous about suicide. The one common-denominator shared by all who cut, contemplate or attempt suicide is that they feel emotionally alone in their families," said Walfish, the author of "The Self-Aware Parent," and who appears regularly as an expert child psychologist on the CBS Television series, "The Doctors."

"They feel there is no one person they can talk to about

their pain who will listen, validate, understand, and be a safe warmly attuned place for comfort," she said.

Sam Gertsmann, the founder of Opinion-Lounge, a website for discussing politics, said he's had extensive experience working suicide hotlines.

"While suicide is a complicated topic, it's clear that the rise of social media is one of the main causes of the recent jump in suicide rates," Gertsmann said.

"Social media show users pictures and videos of everyone living better lives than they are; even though these pictures are often staged and paint an inaccurate picture, the brain isn't able to differentiate and simply sees that everyone else is better off," he said.

"Social media also puts numbers on your popularity – your followers, your likes, your replies. And, no matter how many you have, you'll always want more," Gertsmann said.

Kevin Darné, the author of "My Cat Won't Bark! (A Relationship Epiphany)," believes that the suicide rate among young African Americans is due to the growing list of Black millionaires and billionaires.

"Today, we have Oprah owning a TV network, Tyler Perry owning his own studios, Shonda Rhimes owning her night of television on ABC, Jay-Z becoming a billionaire, Dr. Dre selling 'Beats' to Apple for \$3 billion, and a few Fortune 500 Black CEOS, Black doctors, lawyers, and entrepreneurs," Darné said.

"Although racism is still alive, it's impossible to deny the fact that the rise of a Black upper middle class and an increase in Black millionaires [contributes to others having lower self-esteem]," he said.

"The irony is the more Black success that someone sees in various industries could make a person start to wonder about what's wrong with themselves. Depression and lack of fulfillment can cause people in a rich country to consider suicide ... when there's a huge gap between one's expectations and their reality, life can seem miserable," Darné said.

DWP Board Votes to Expand Program Paying People for Renewable Energy

The Los Angeles Board of Water and Power Commissioners today recommended expanding the Feed-in Tariff program, which pays people for feeding renewable energy to the department's grid.

The FiT program allows customers, solar companies and others to develop solar or other eligible renewable energy projects within the DWP's service territory and sell the power to the department at a set price. The power is redistributed to the DWP's power grid.

"The FiT program has been enormously wellreceived, as it provides dependable guidelines and set pricing to give customers and businesses the confidence to invest in renewable energy," DWP general manager and chief engineer, Martin Adams said. "This expansion will allow even bigger projects, incorporating new, innovative technology to participate throughout the locations we serve."

The expansion proposal allows for another 300 megawatts of capacity and includes changes to the program to increase resident participation.

To allow larger projects to apply for FiT, the maximum individual project size has been increased from three megawatts to 10 megwatts. Additional renewable energy technologies can now be incor-

porated into FiT projects,

including wind, geothermal and small or conduit hydroelectric, according to DWP.

As of Tuesday, the program included 96 projects with 66.2 megawatts in service, producing enough energy to supply about 18,000 homes, according to DWP.

DWP said FiT is a big part of the city's Green New Deal to achieve 100 percent renewable energy by 2045. The board authorized 50 megawatts of the 300 megawatts to be implemented in the next year.


The proposal must receive Los Angeles City Council approval to move forward.

In 2020, LADWP plans to introduce a FiT+ program to support local solar storage projects.
